new design;

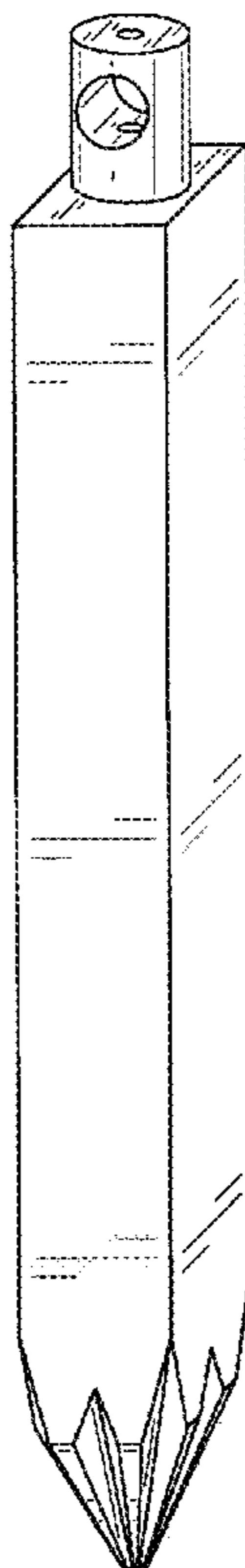
FIG. 2 is side view thereof;

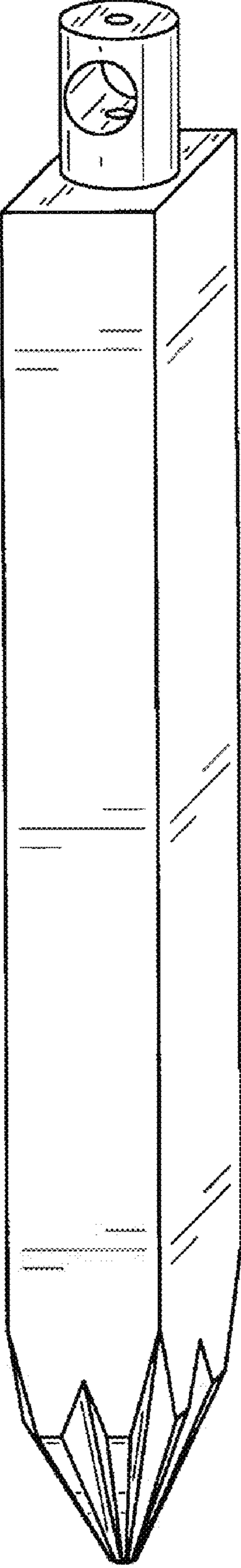

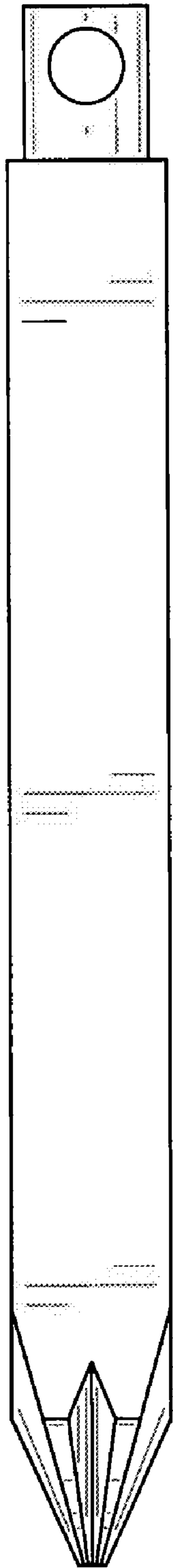

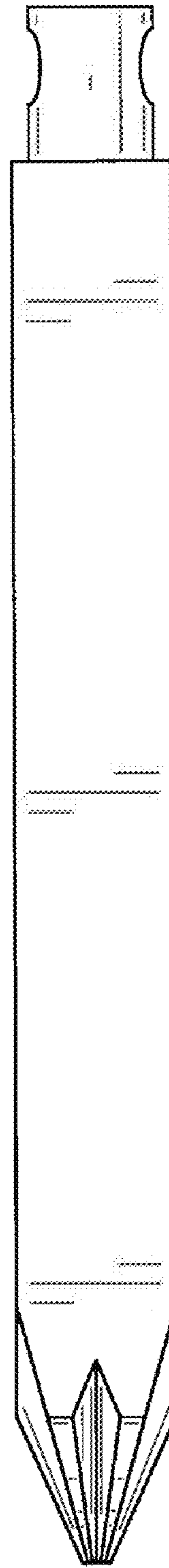

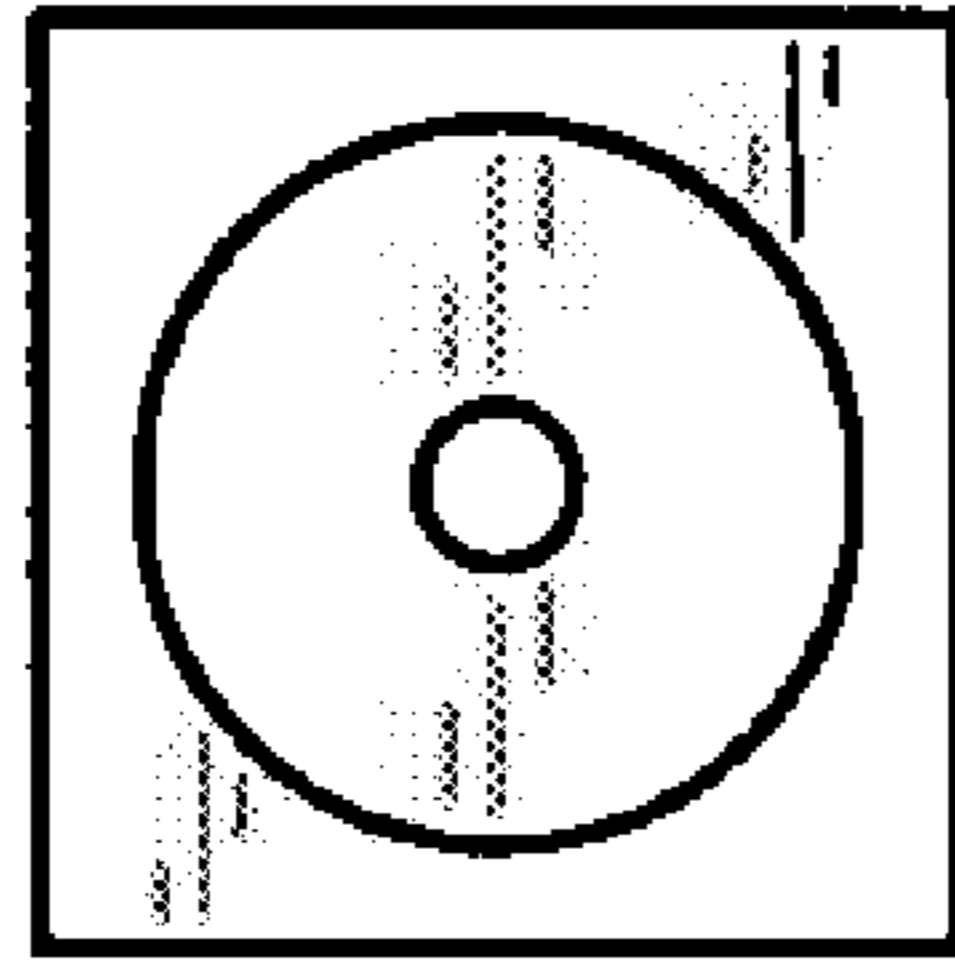

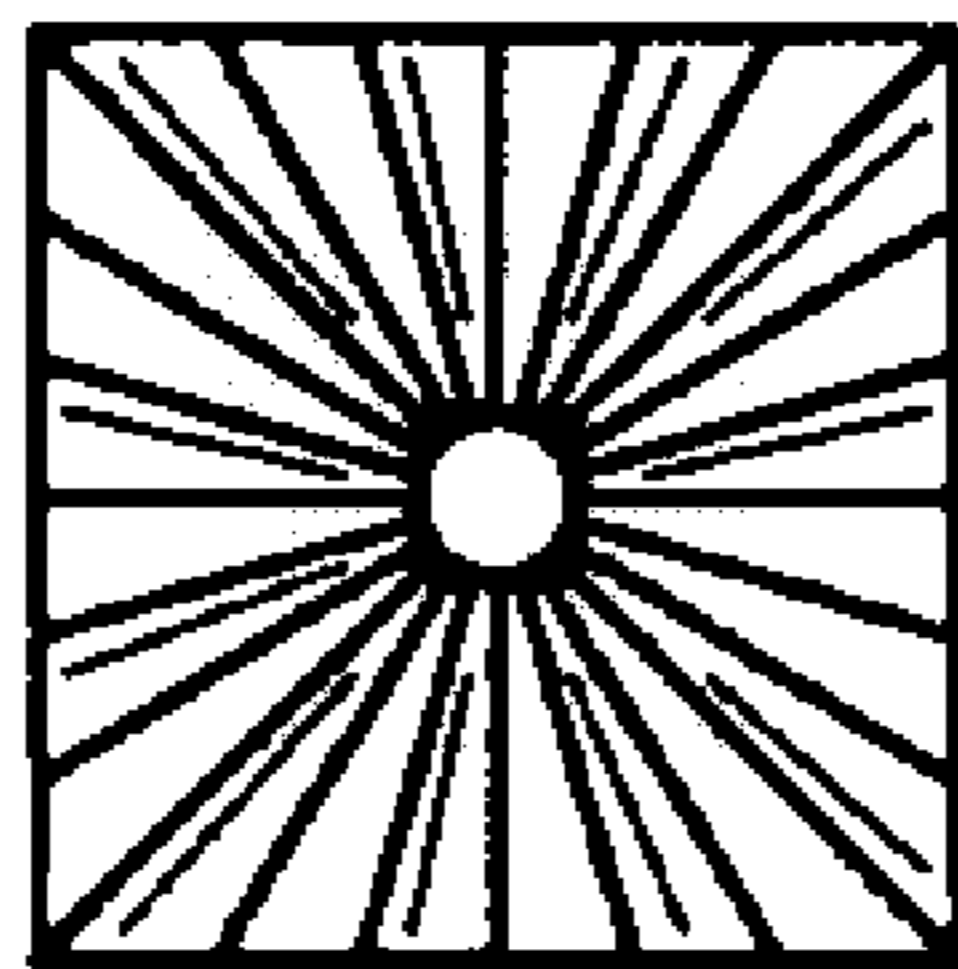
