I claim the ornamental design for a canopy frame, as shown and described.

DESCRIPTION

FIG. 1 is an end view of a canopy frame according to the subject matter disclosed herein;

FIG. 2 is an isometric view of a canopy frame according to the subject matter disclosed herein;

FIG. 3 is a side view of a canopy frame according to the subject matter disclosed herein;

FIG. 4 is a top view of a canopy frame according to the subject matter disclosed herein;

FIG. 5 is an enlarged end view of a lower section of a canopy frame shown in FIG. 1 according to the subject matter disclosed herein;

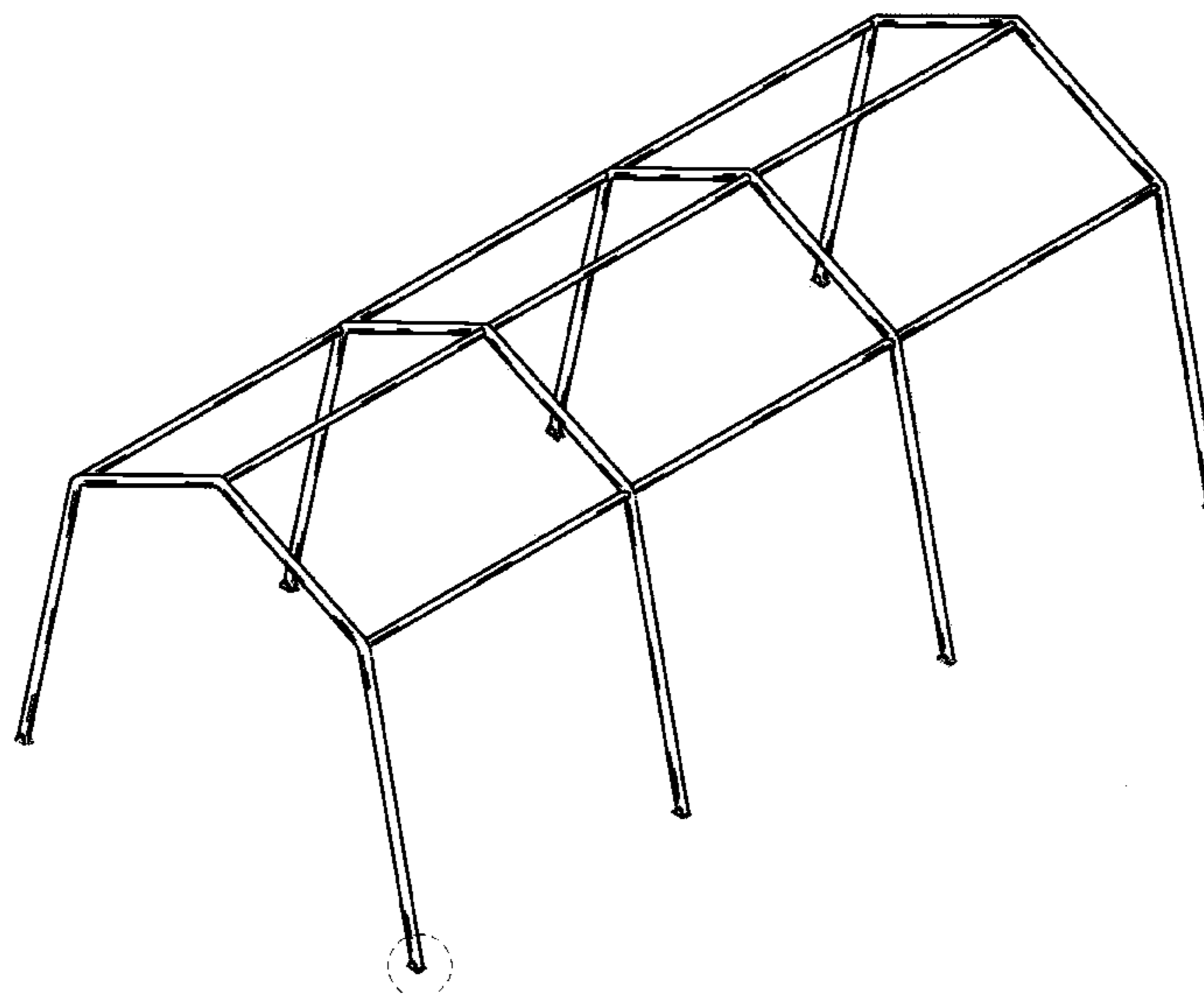
FIG. 6 is an enlarged isometric view of a lower section of a canopy frame shown in FIG. 2 according to the subject matter disclosed herein;

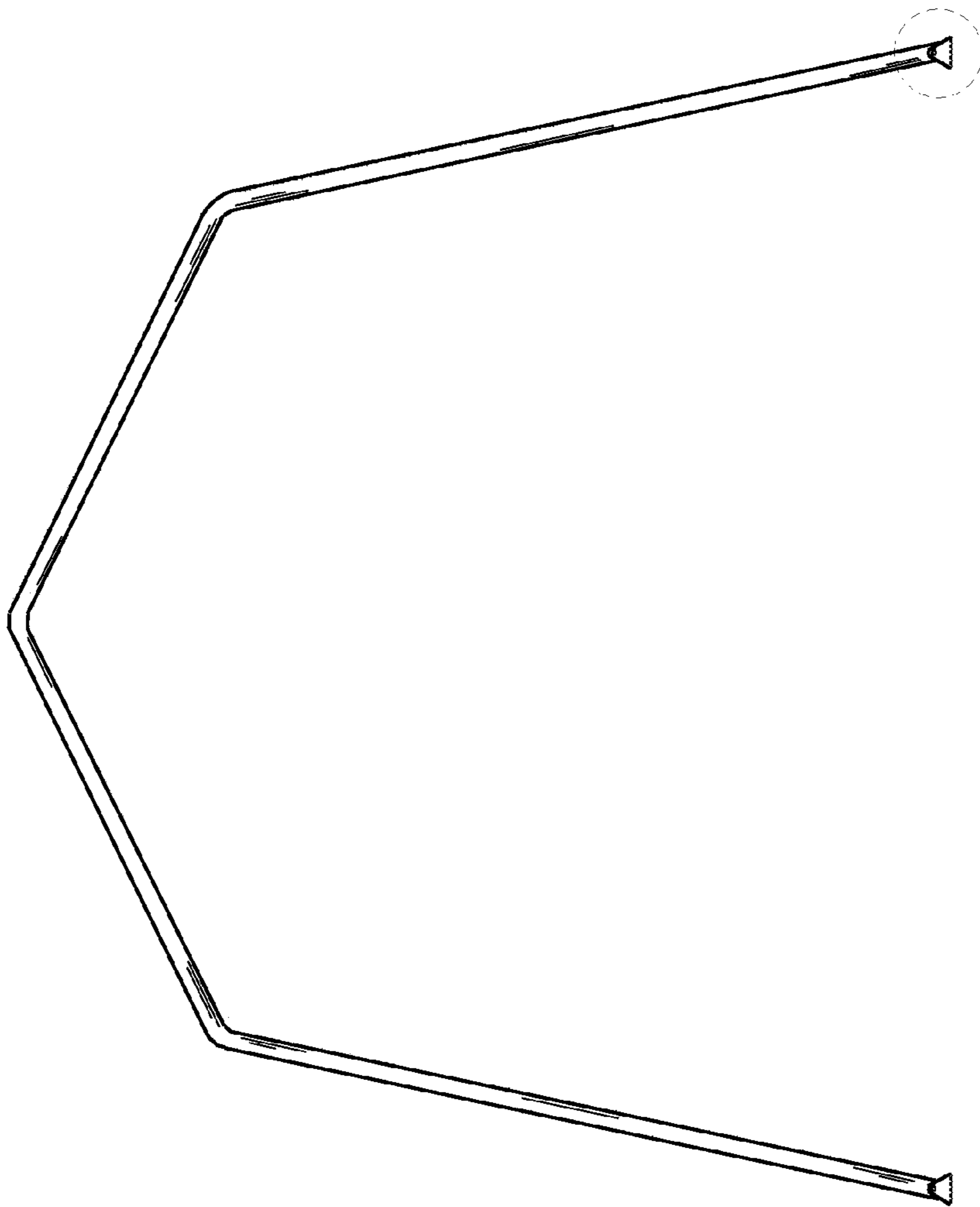

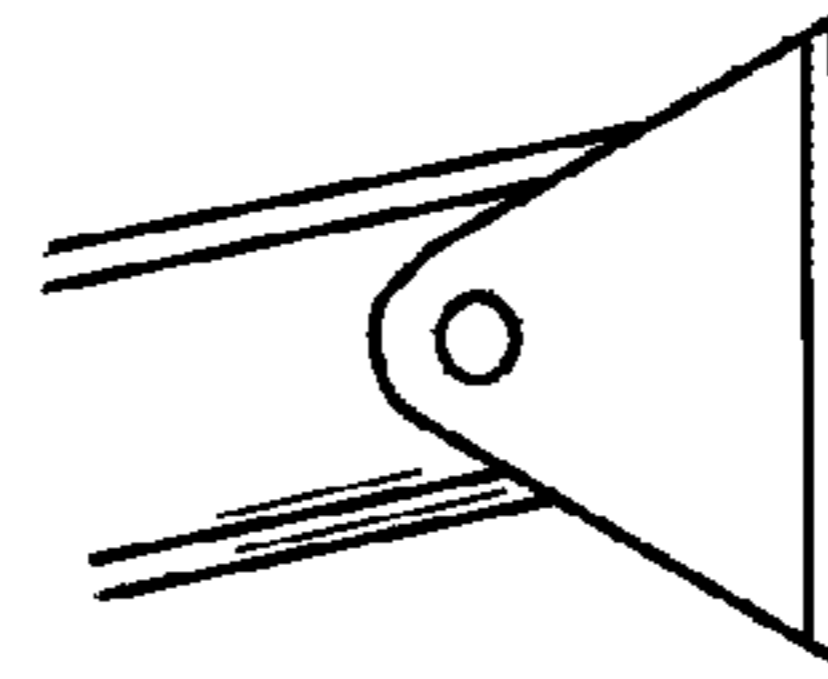

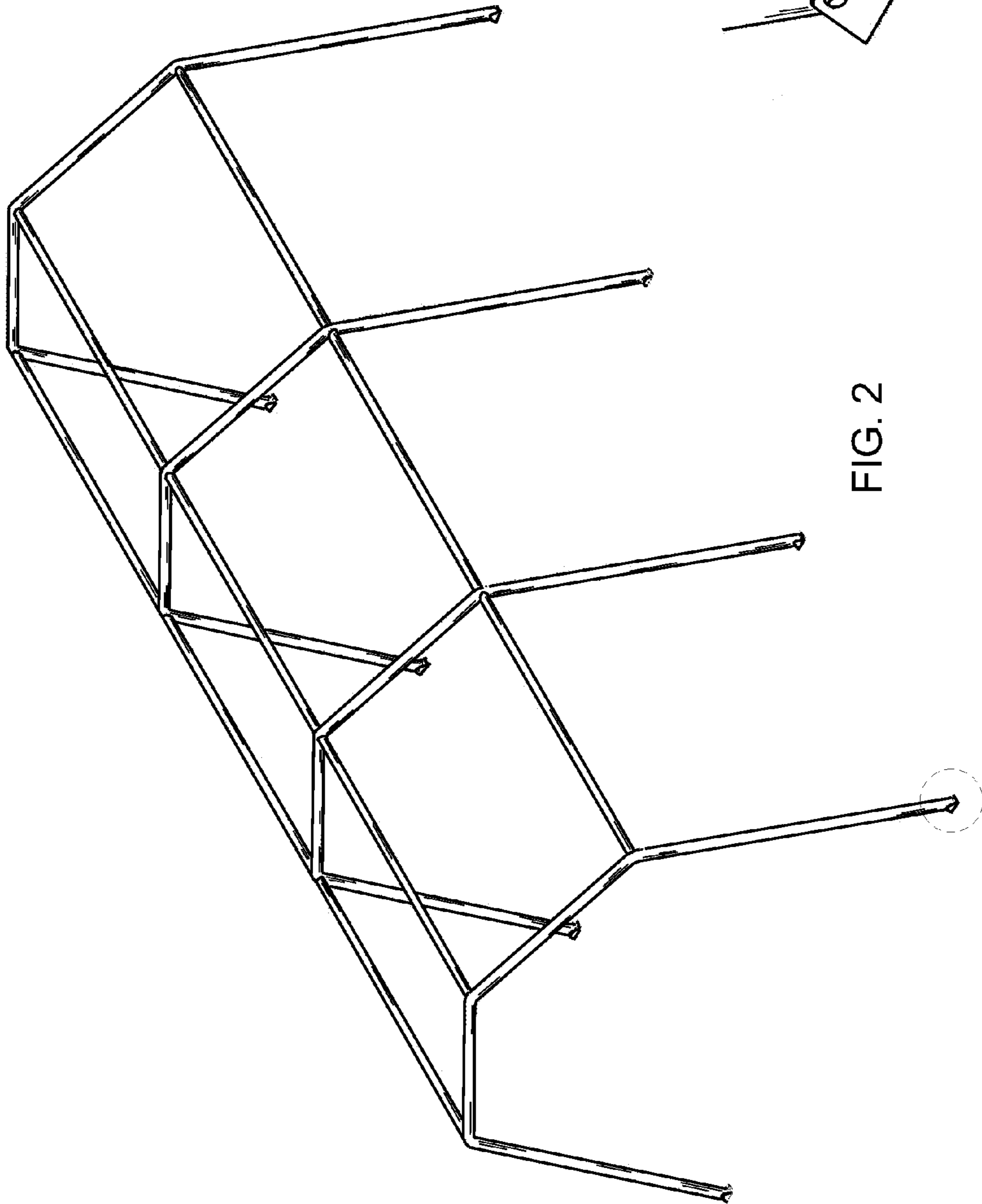

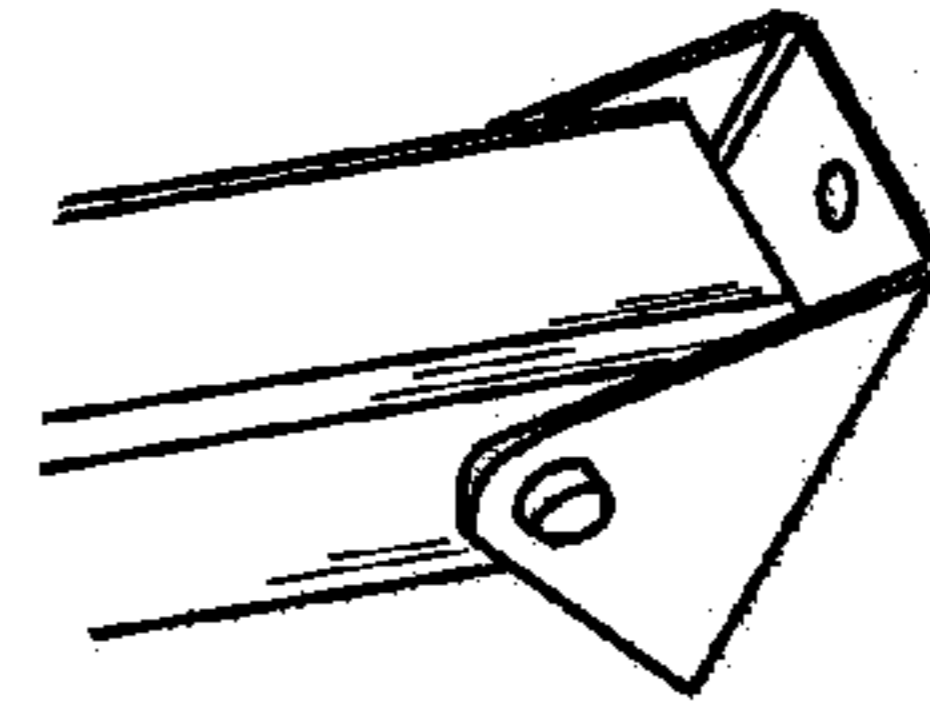

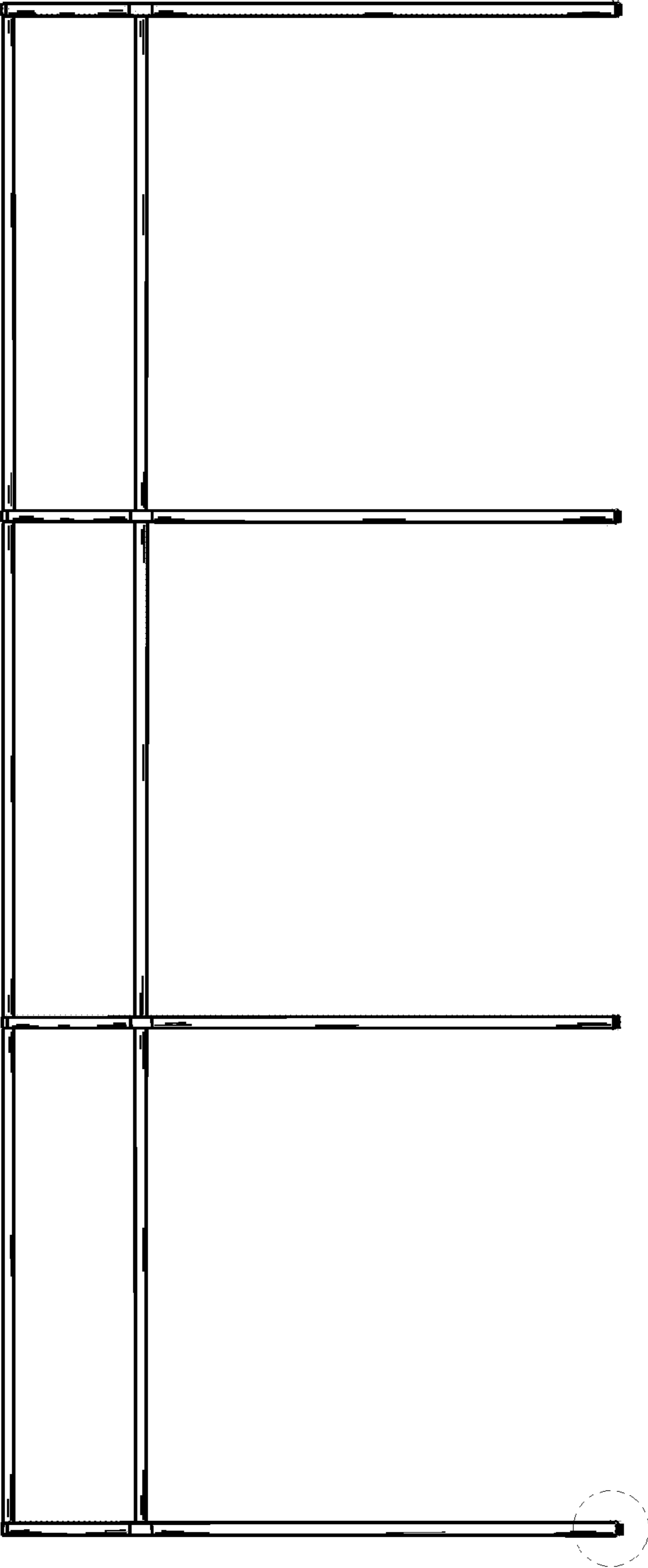

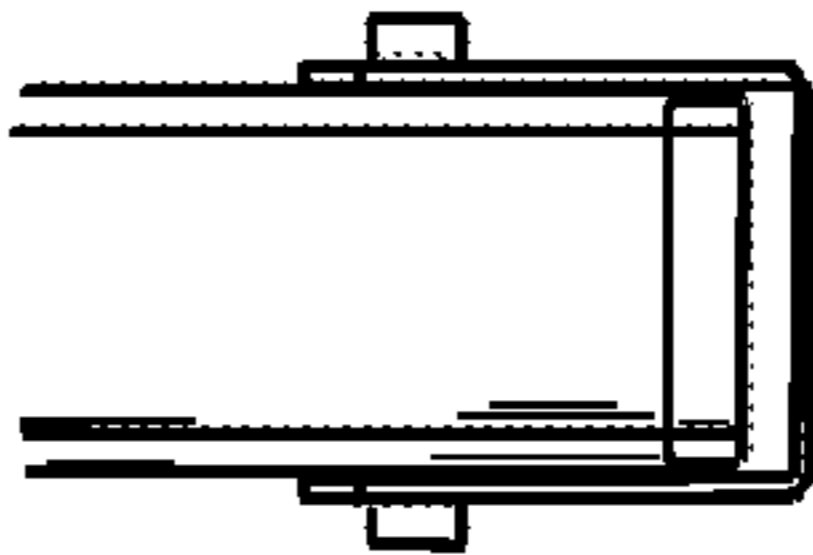

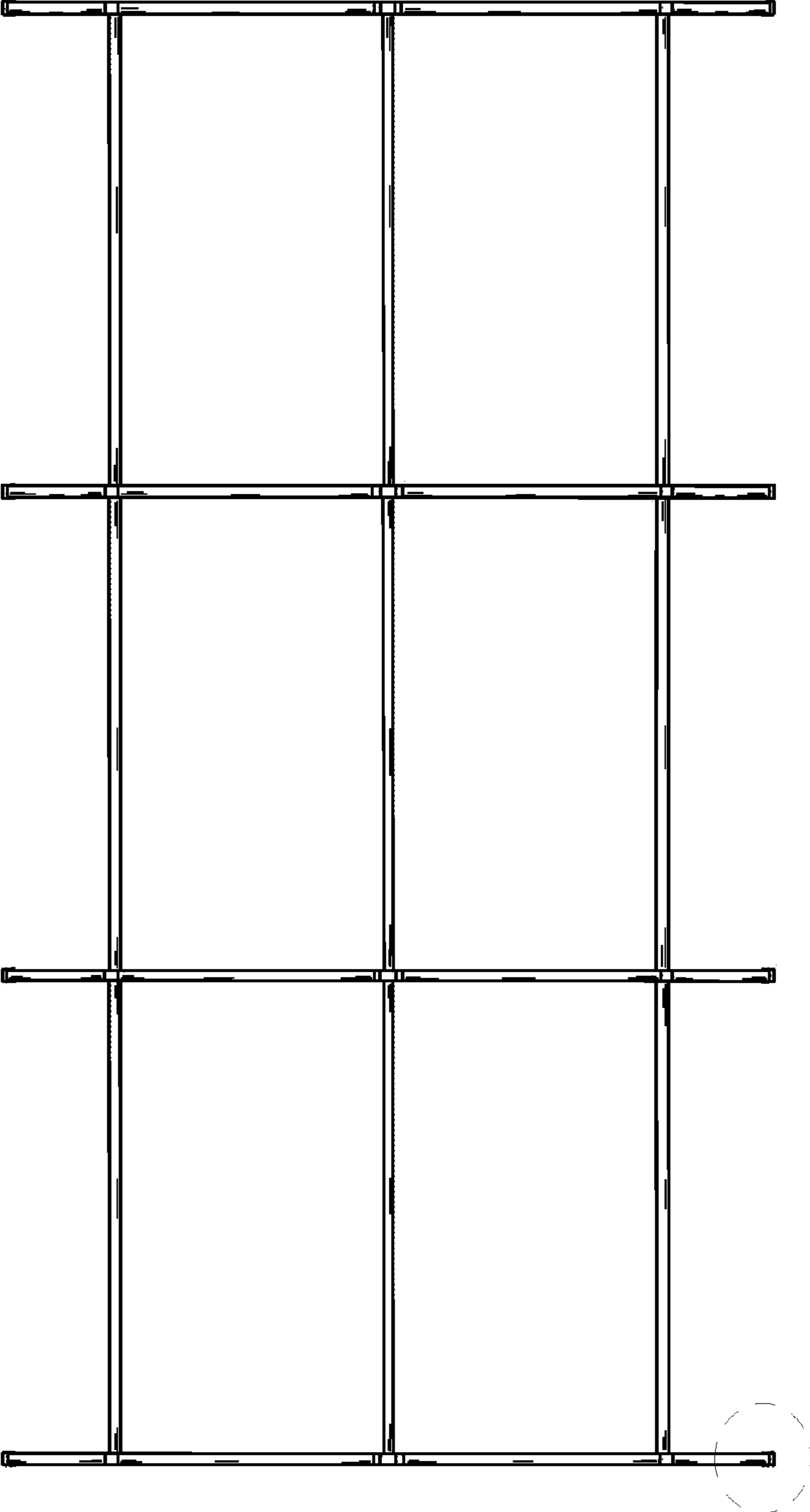

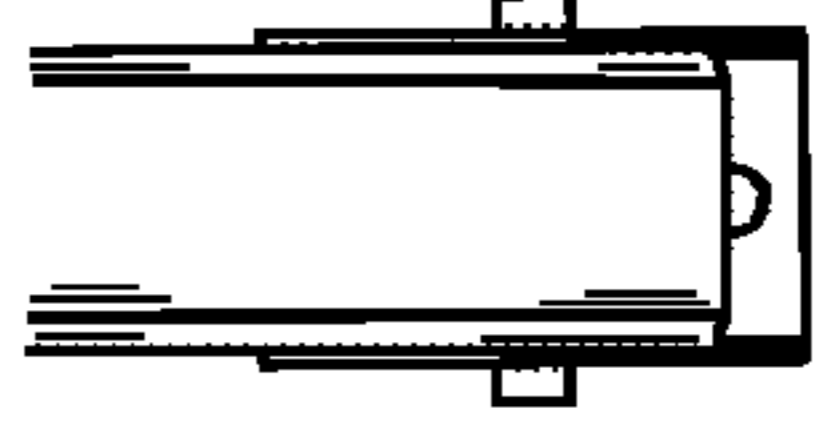
