The ornamental design for daytime running light fixtures of an automobile, as shown and described.

DESCRIPTION

FIG. 1 is a front view of one embodiment a daytime running light fixture of an automobile, showing my new design;

FIG. 9 is a right side view thereof;

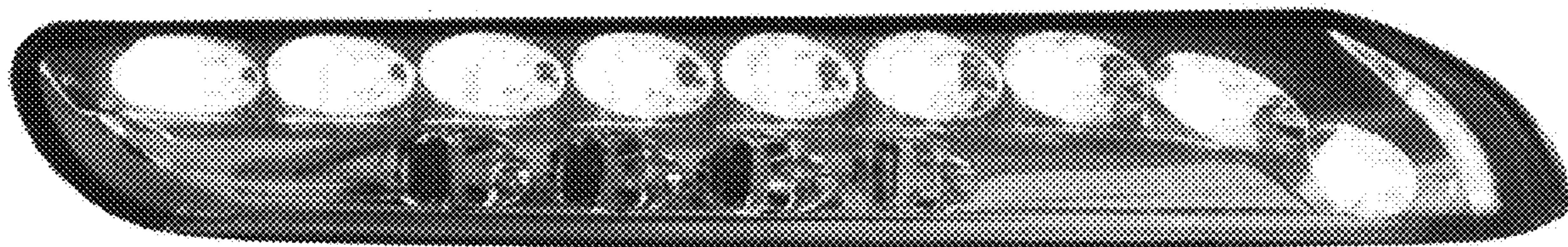
FIG. 10 is a top view thereof;

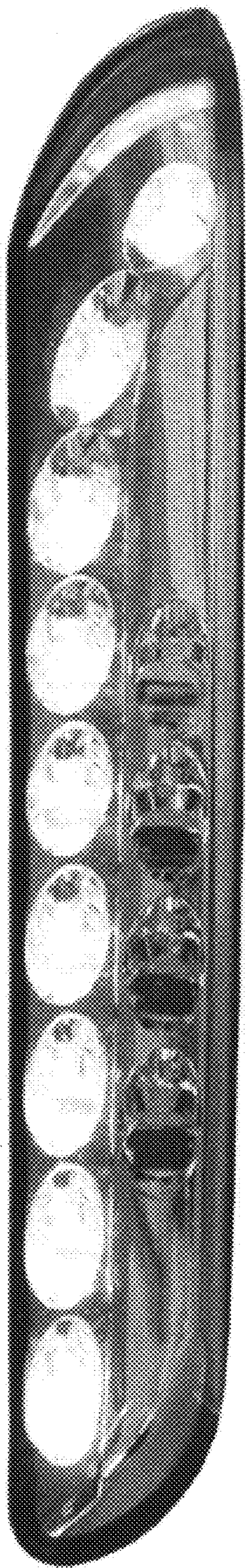

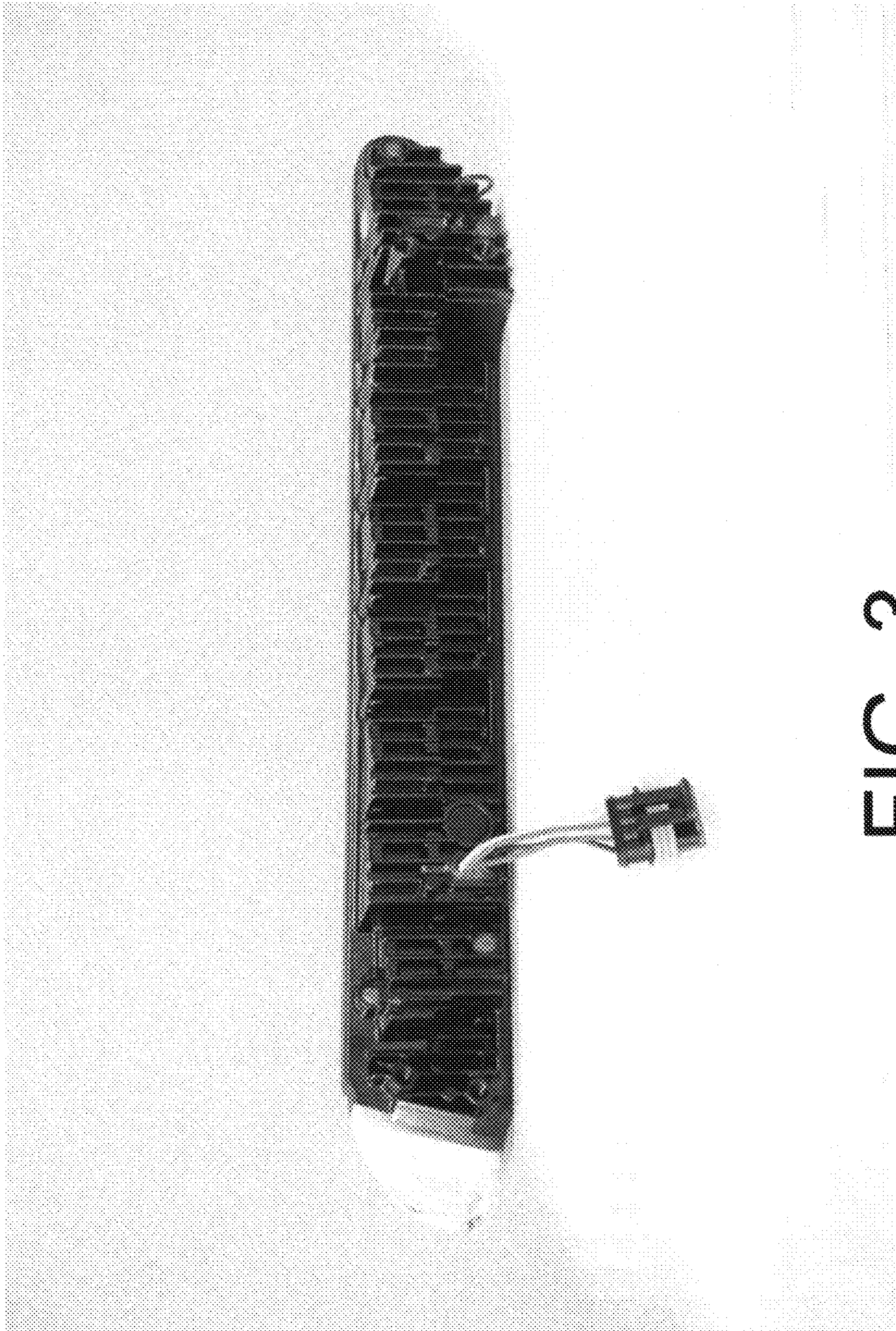

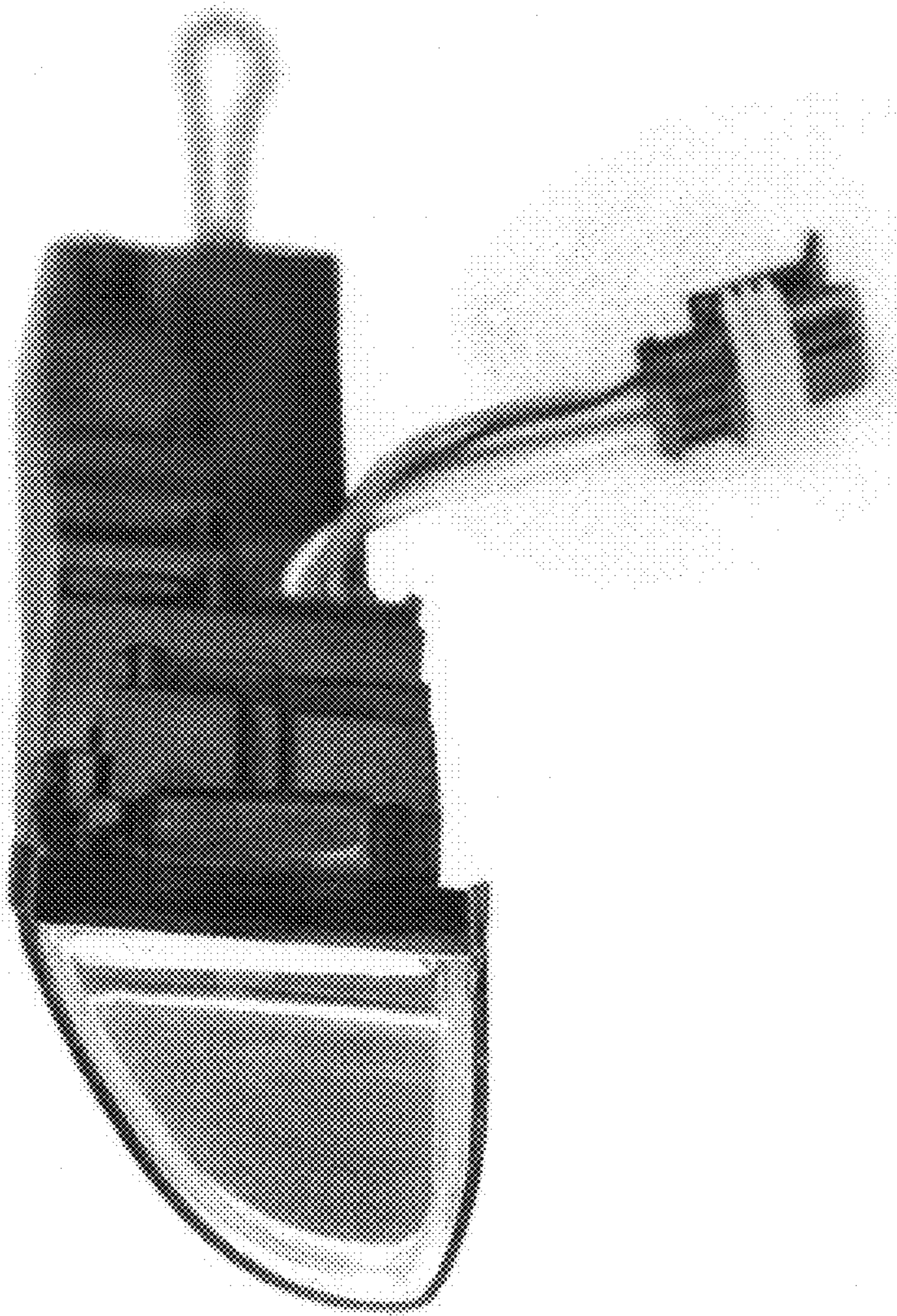

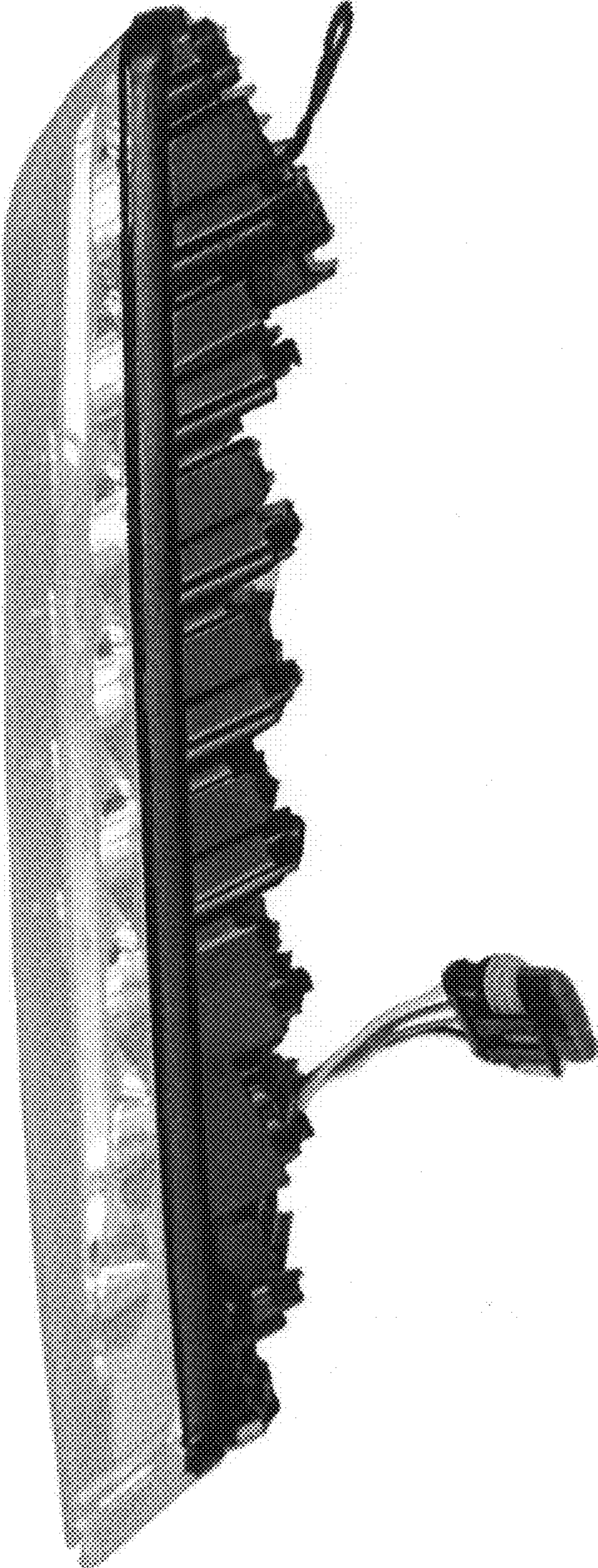

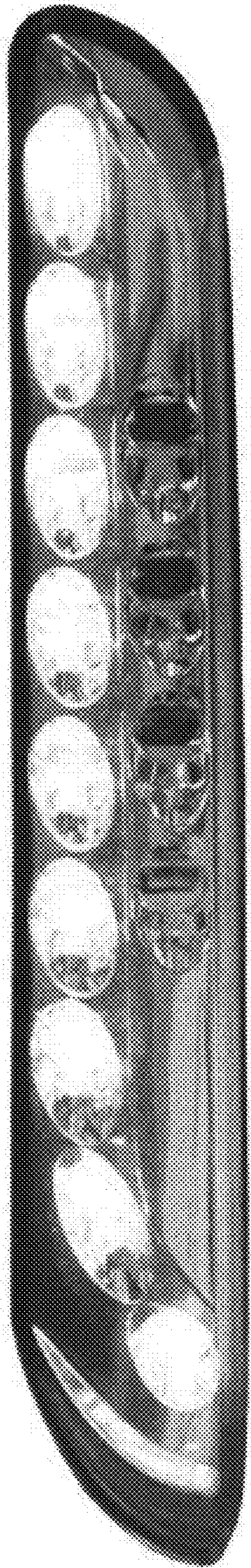

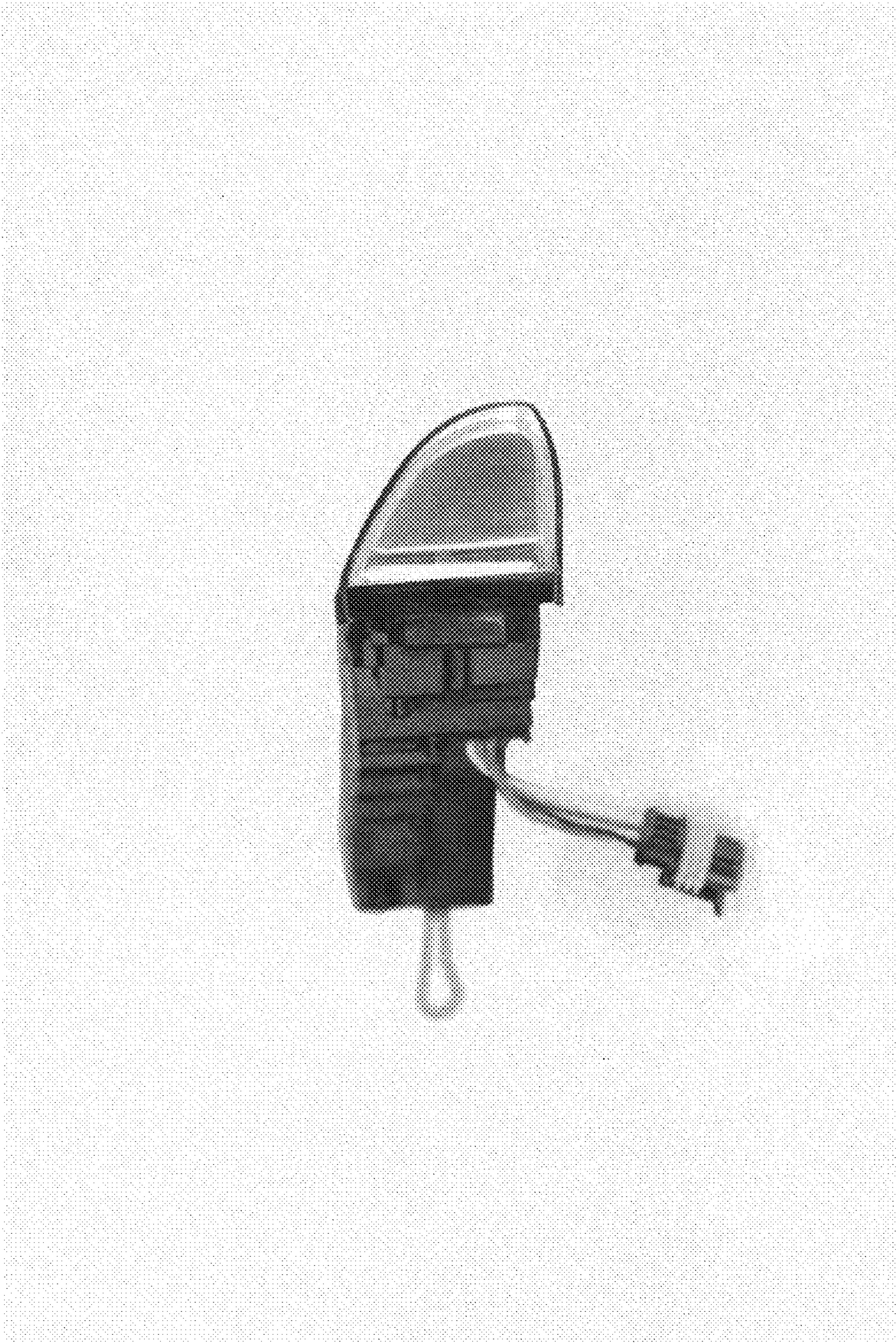

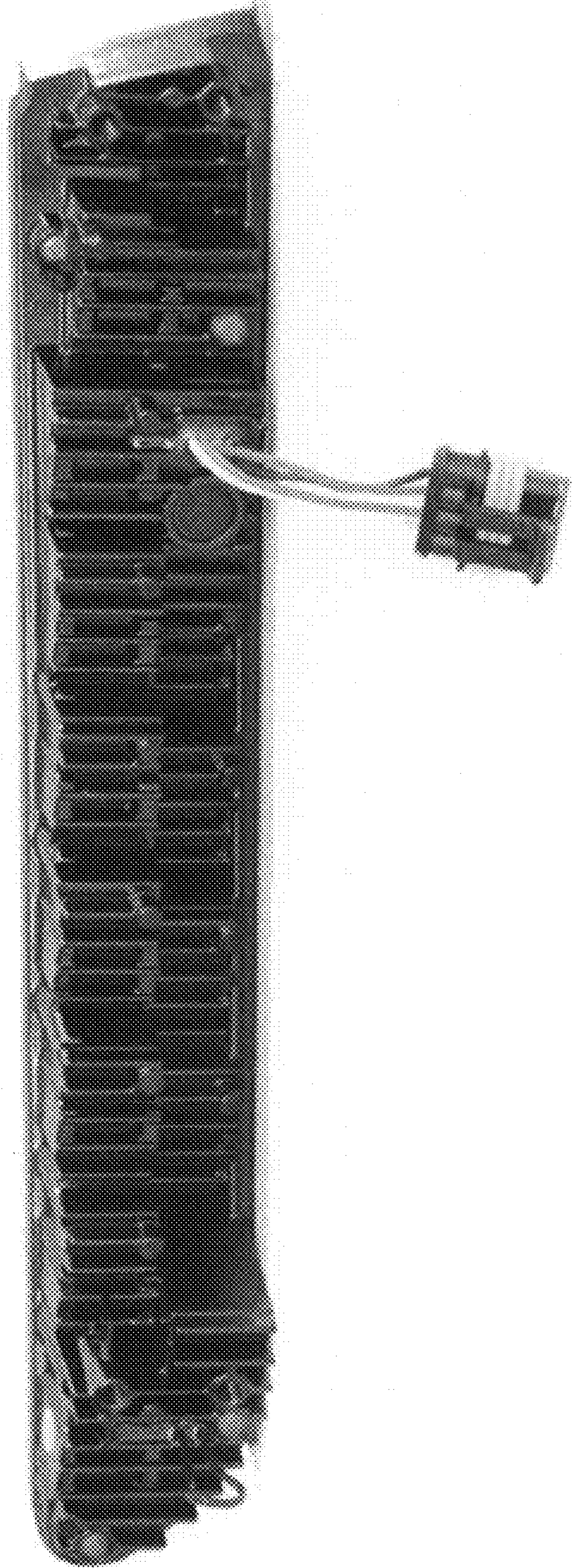

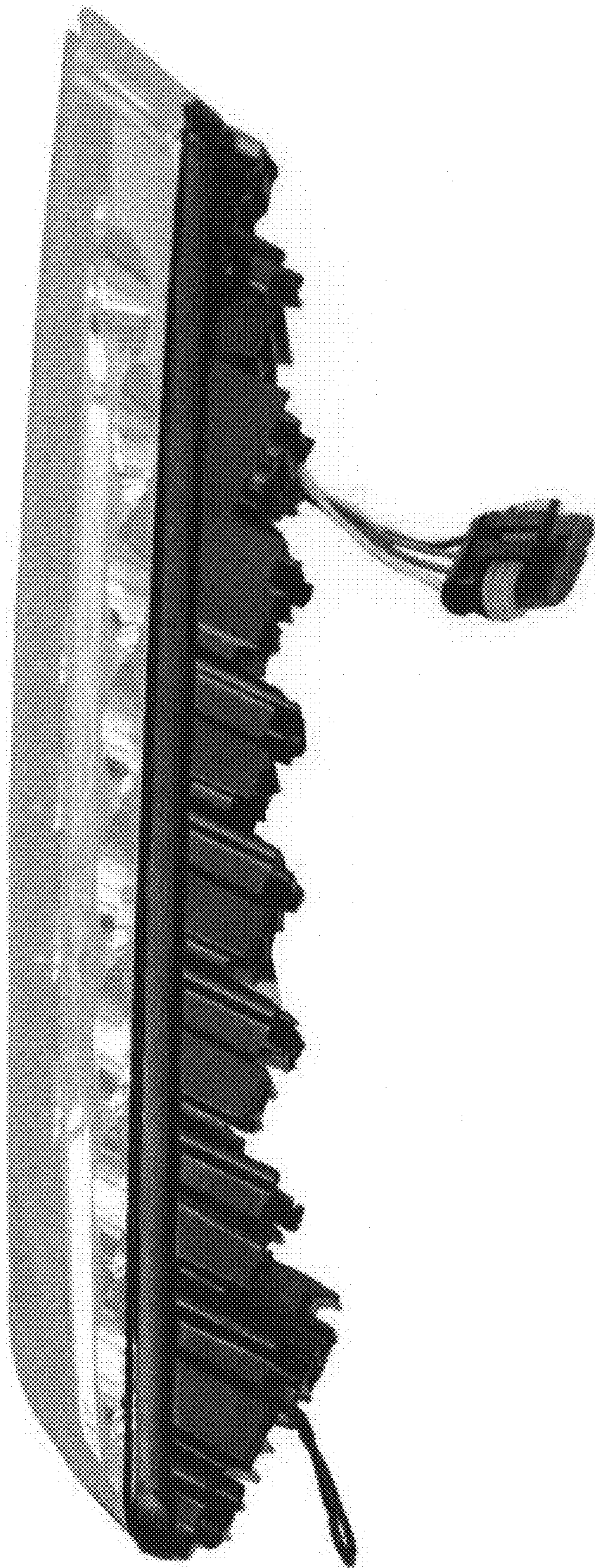

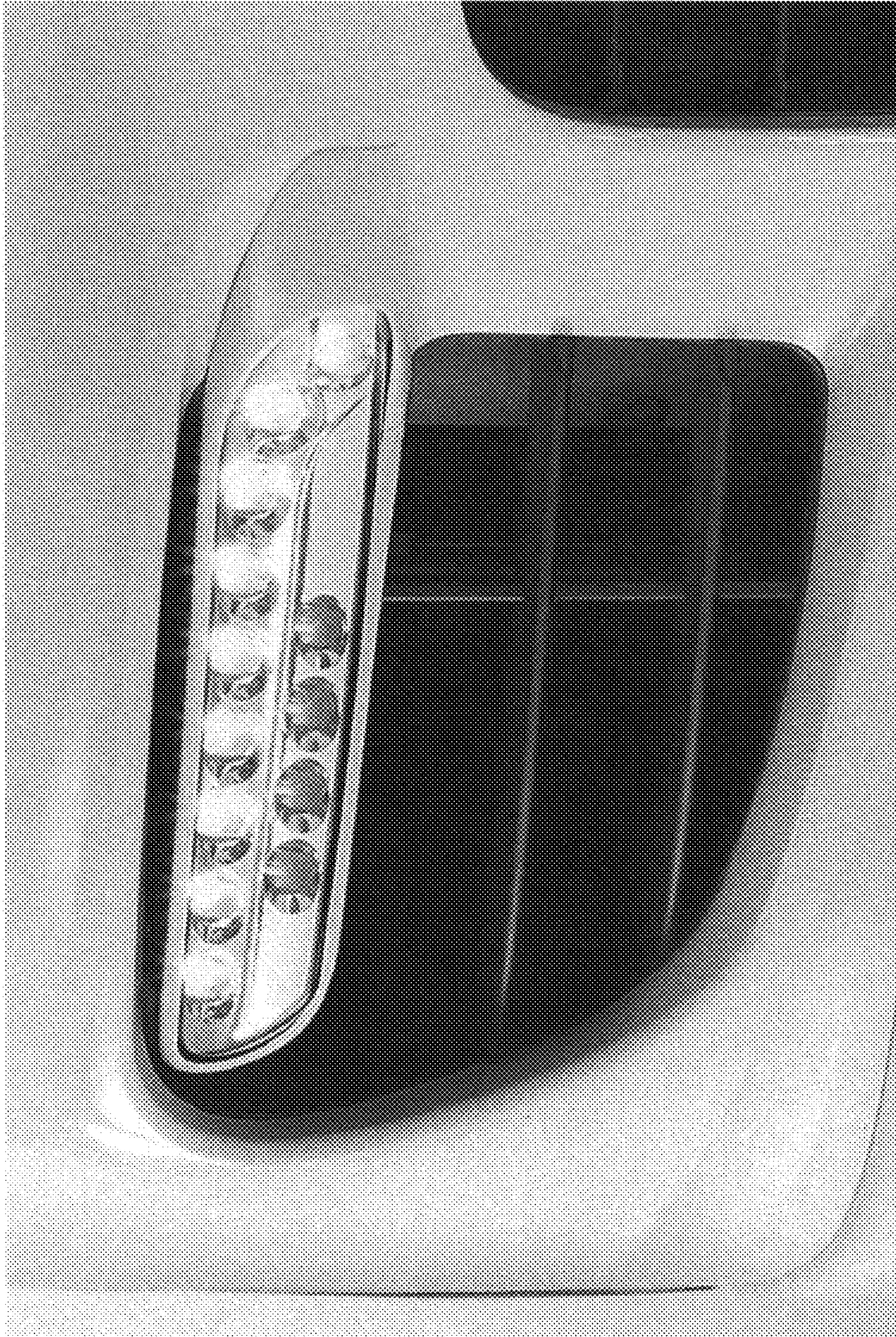
