The ornamental design for an automatic teller, as shown and described.

DESCRIPTION

FIG. 1 is a left front upper perspective view of an automatic teller of minute designs;

FIG. 2 is a front elevational view of the design of FIG. 1;

FIG. 3 is a right side view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a left side view thereof;

FIG. 6 is a top view thereof; and,

FIG. 7 is a bottom view thereof.

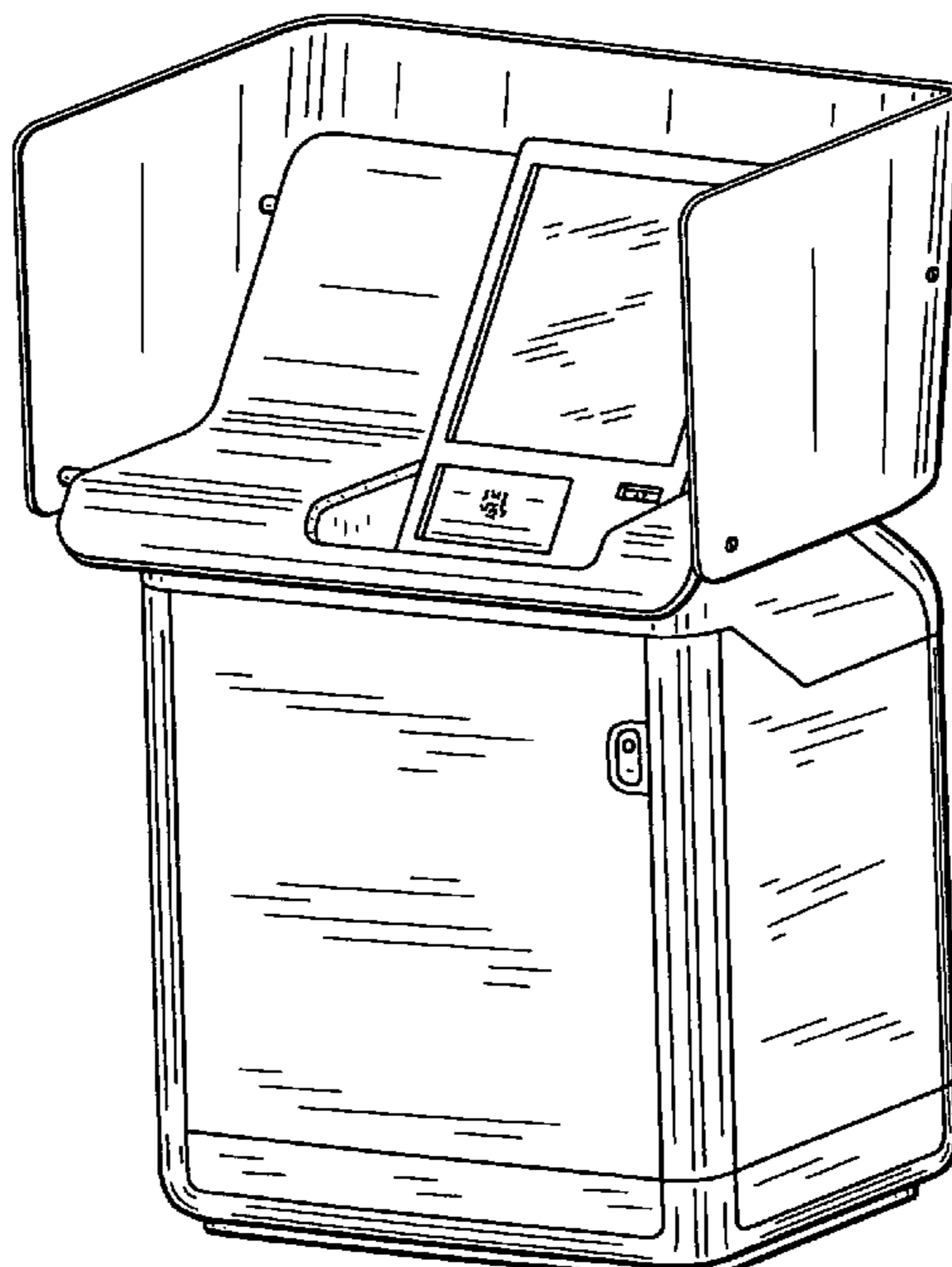

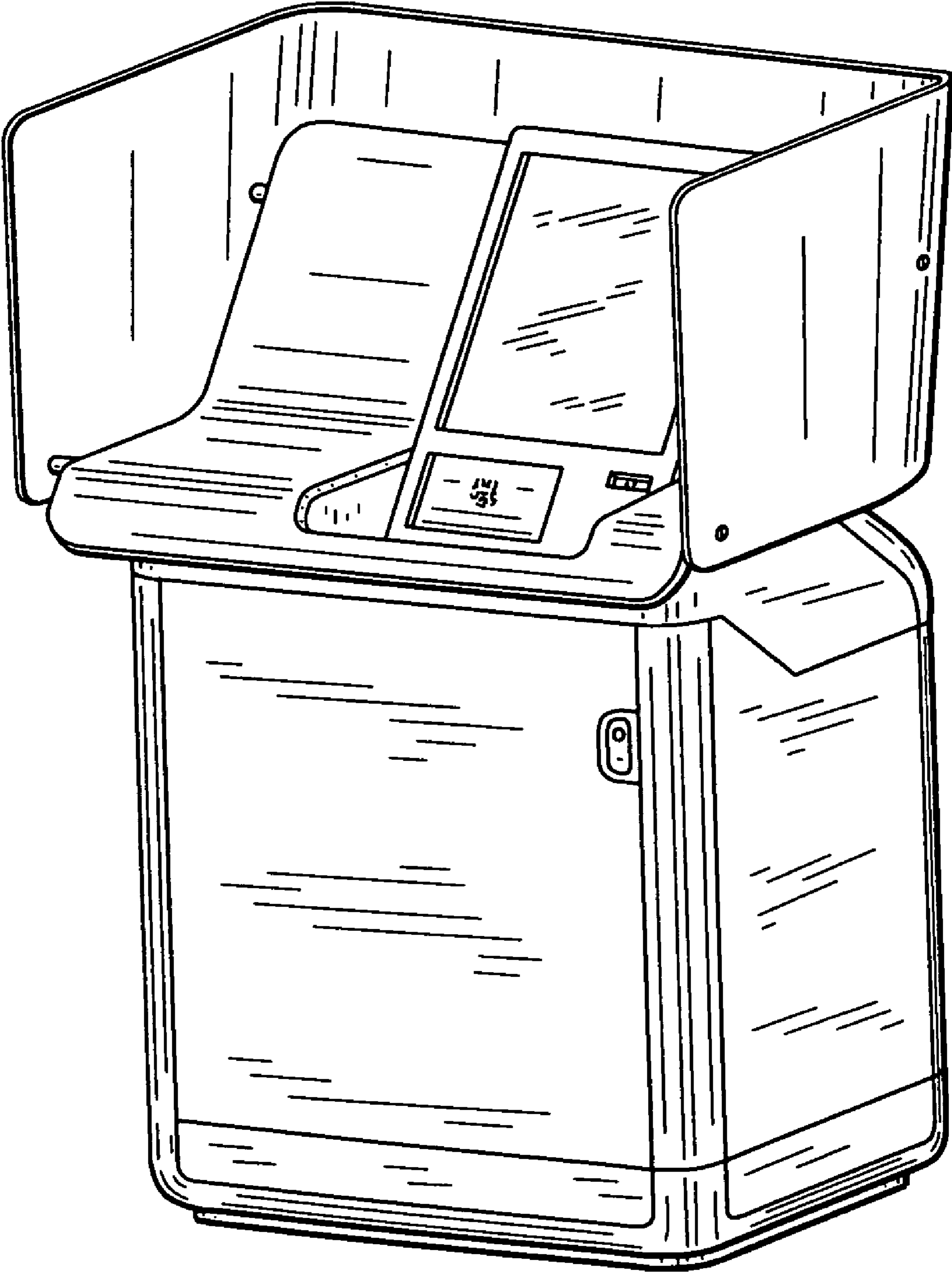

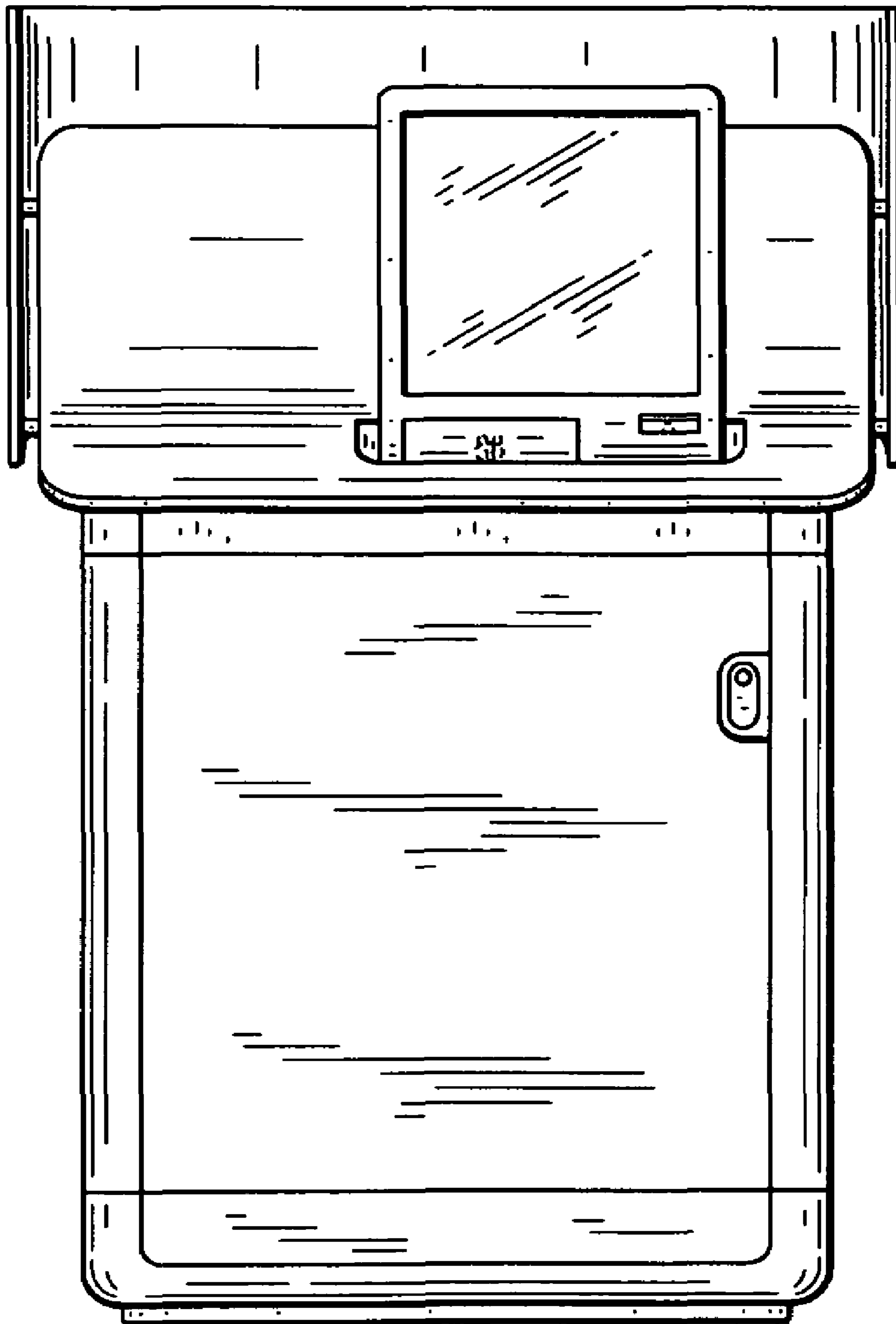

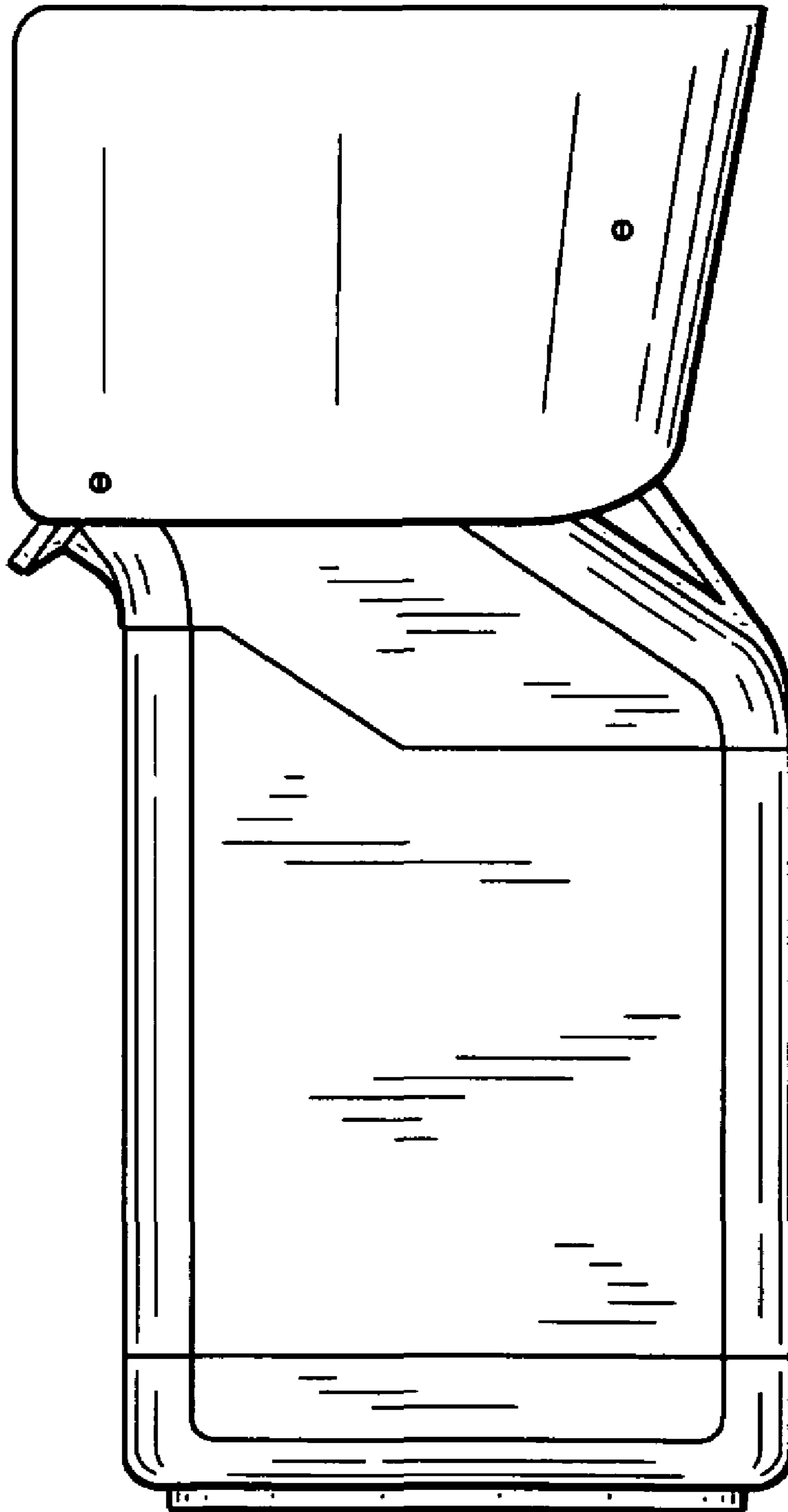

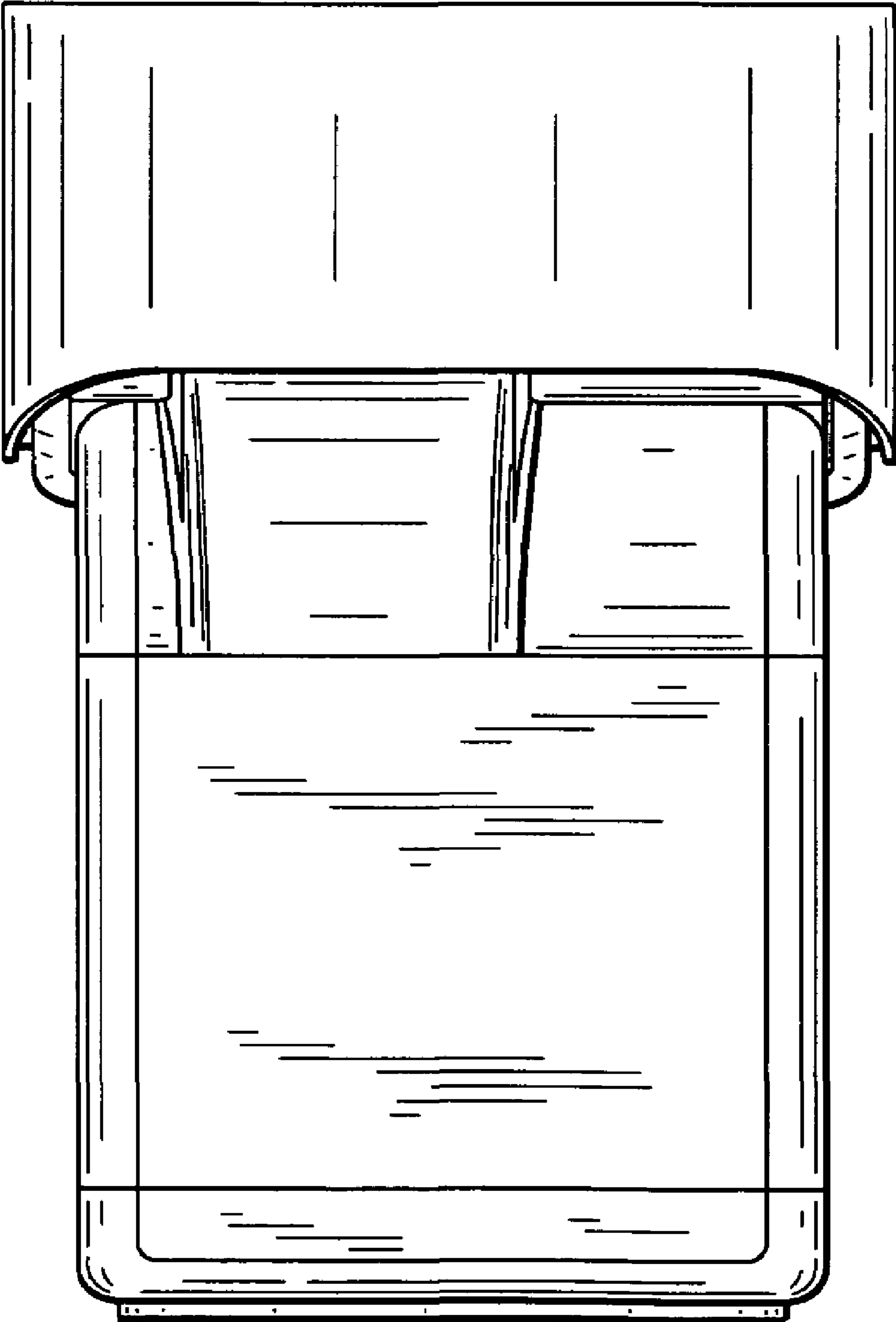

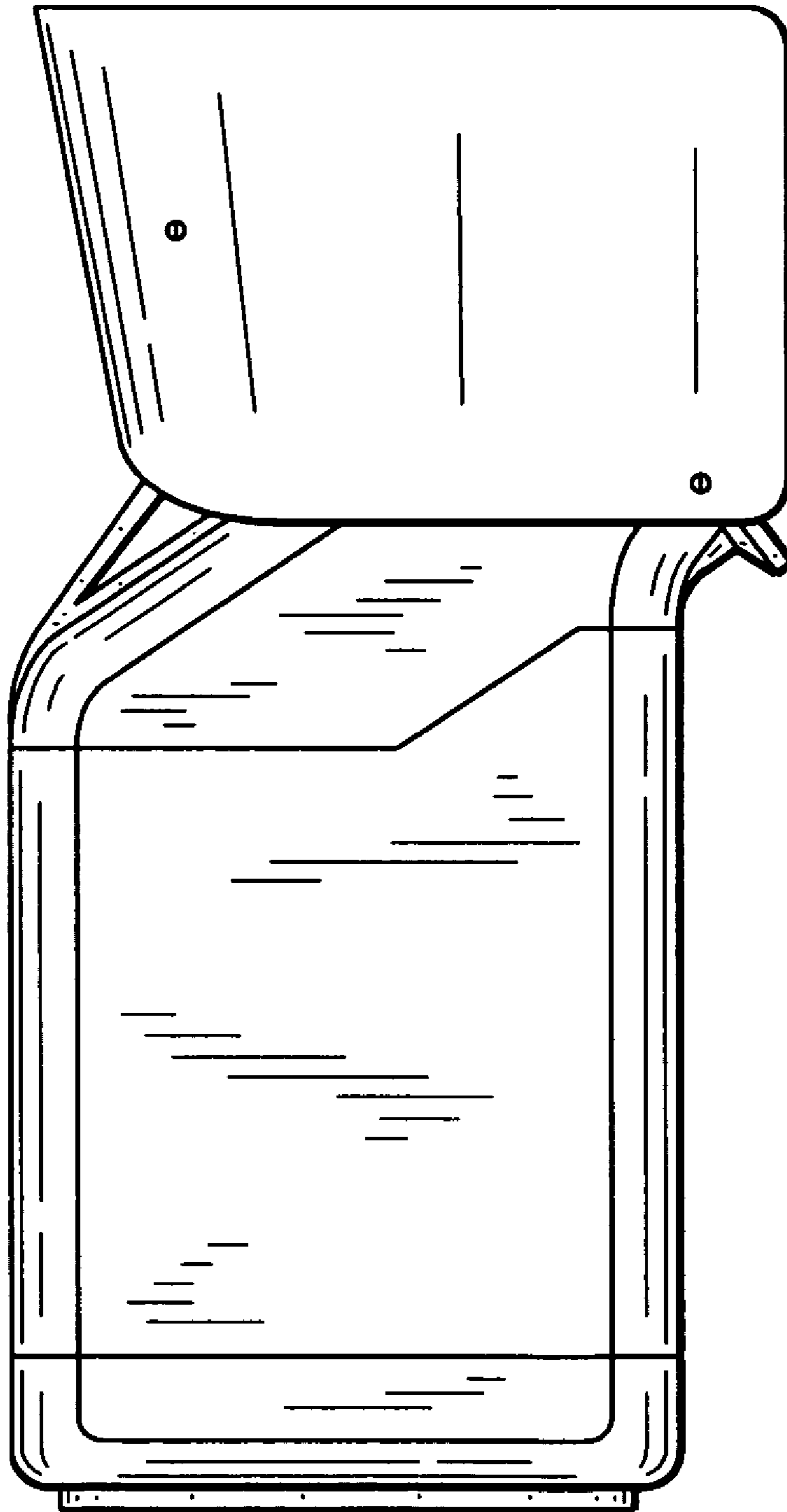

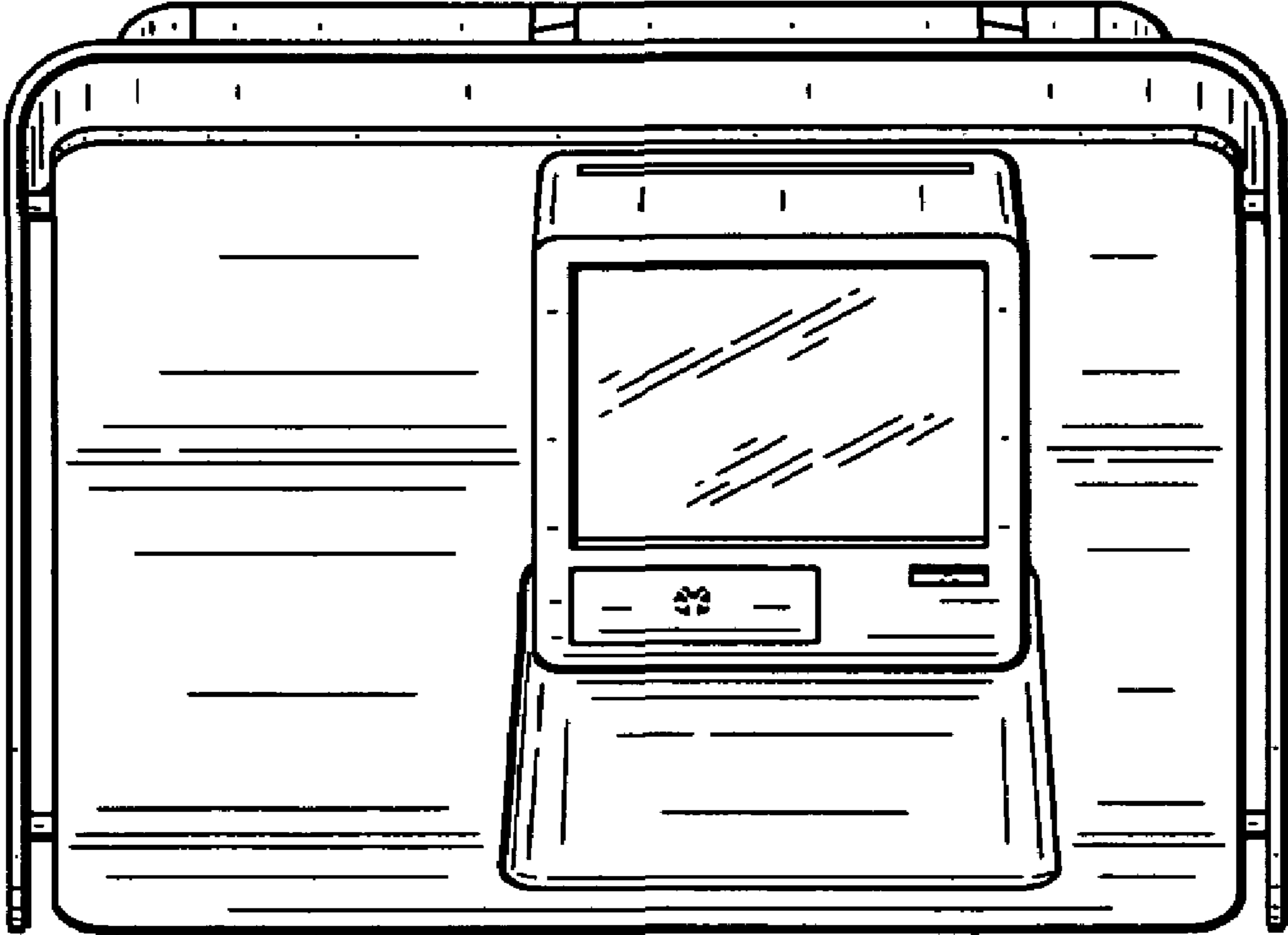
