**DESCRIPTION**

FIG. 31 is a first side elevational view of the fifth variant;

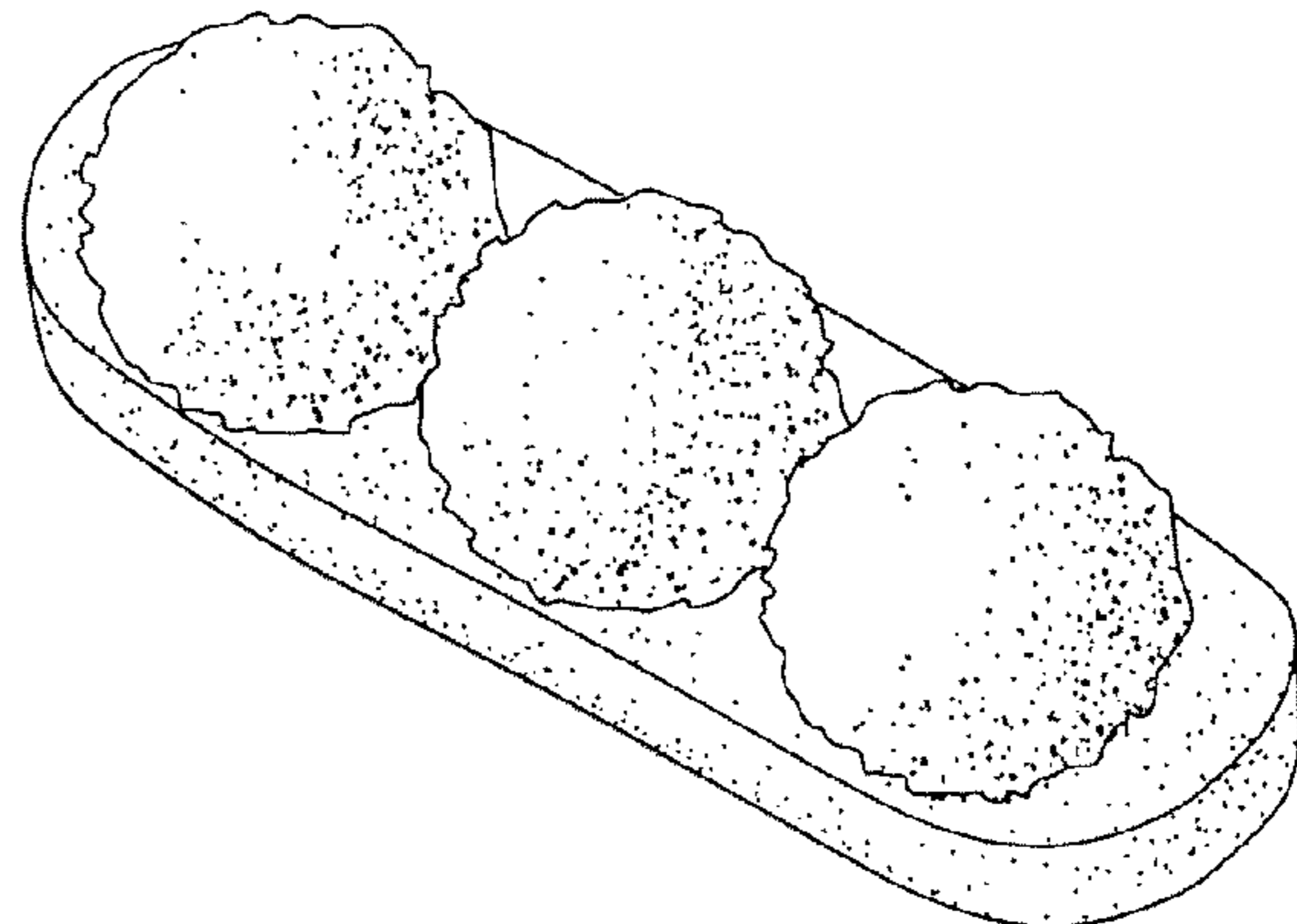
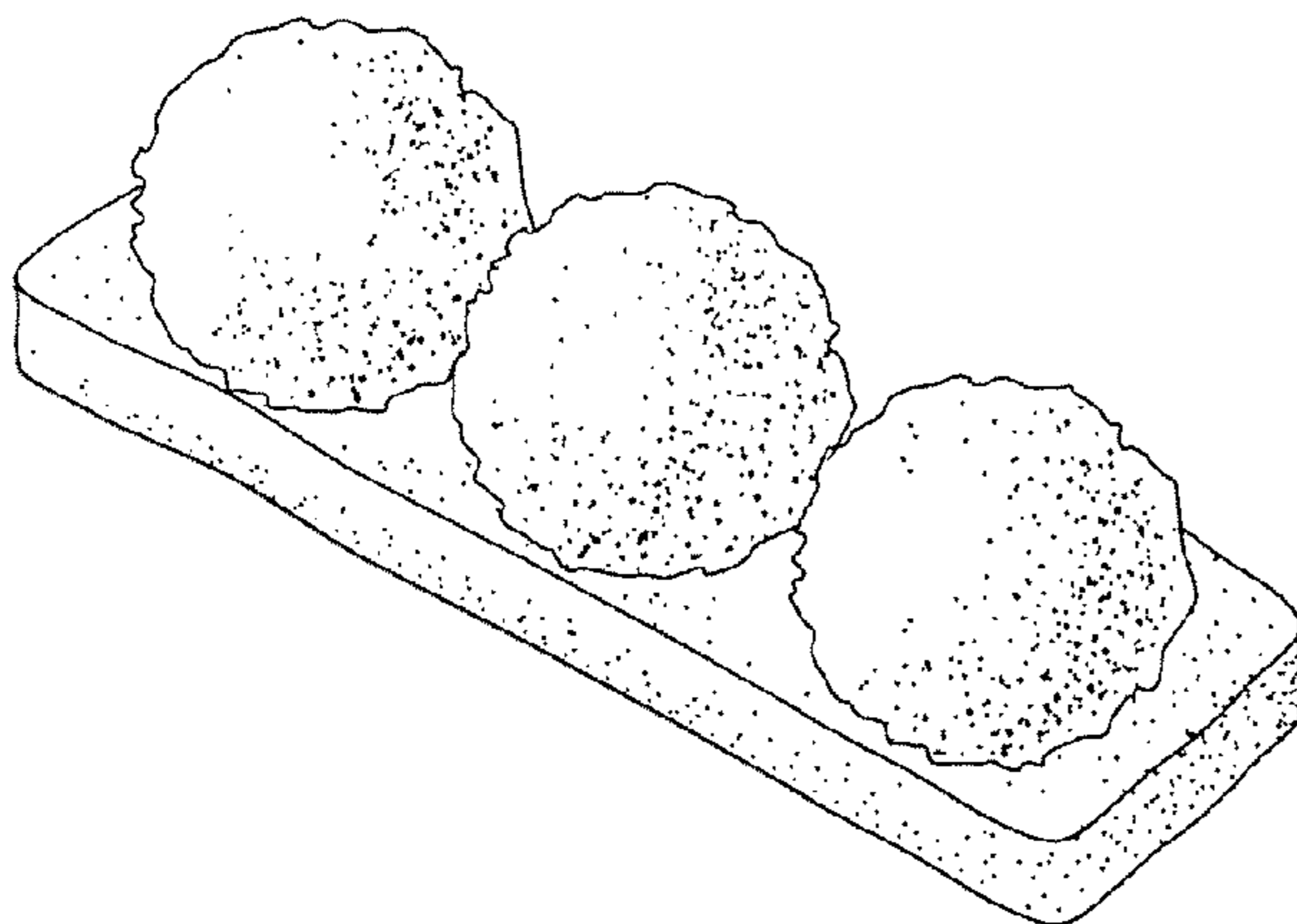
FIG. 32 is a second side elevational view, opposed to the side view of FIG. 31;

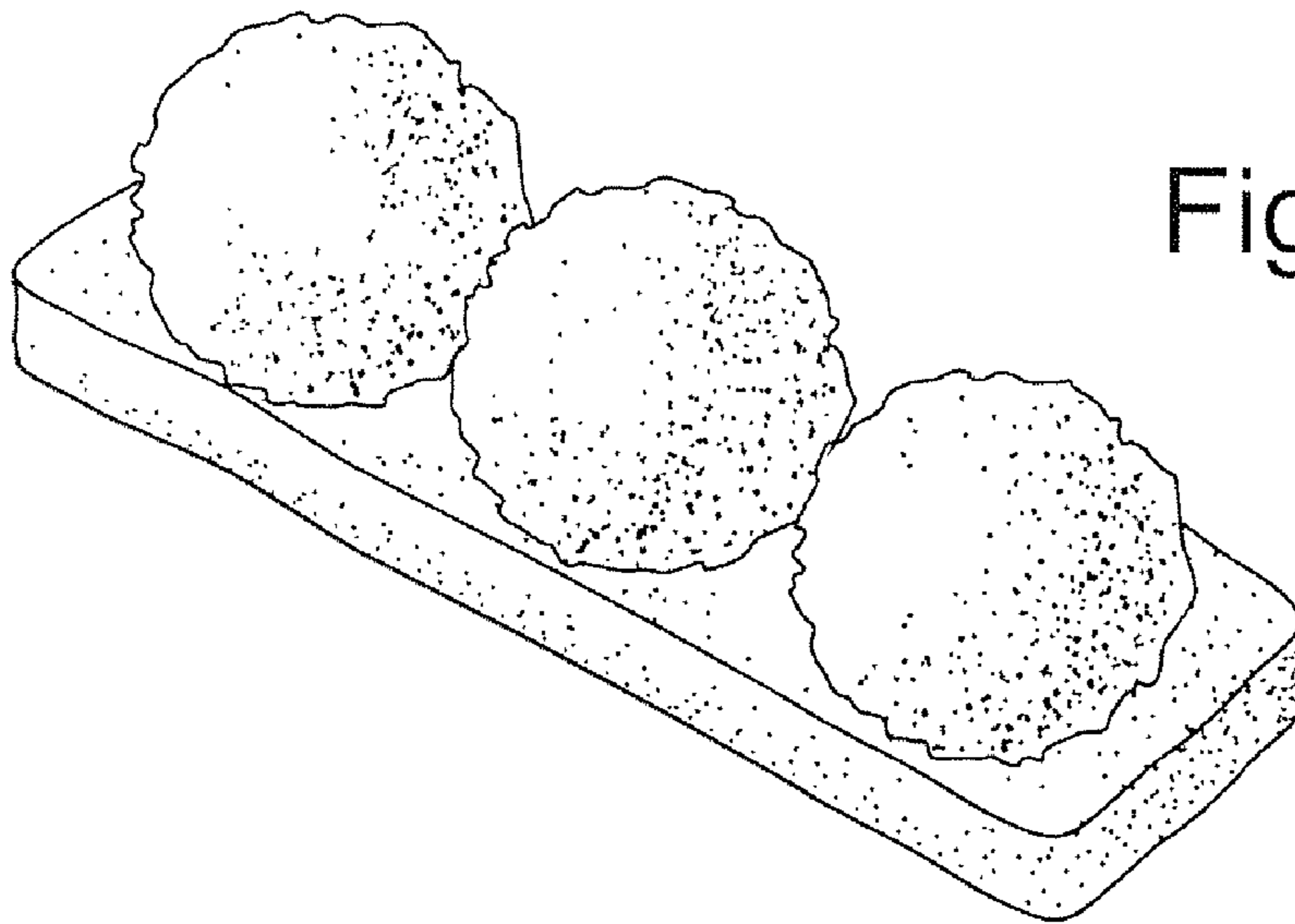

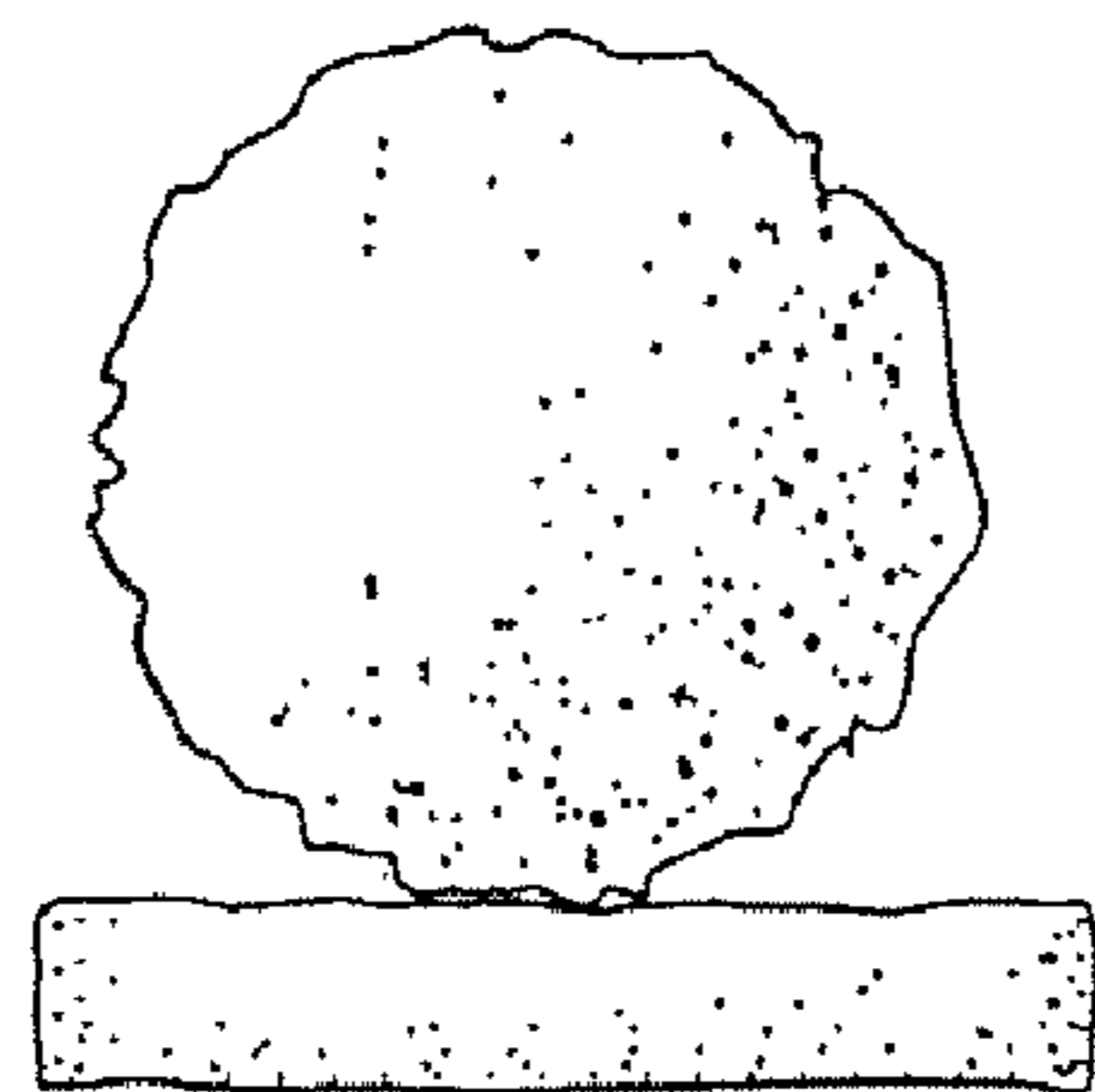

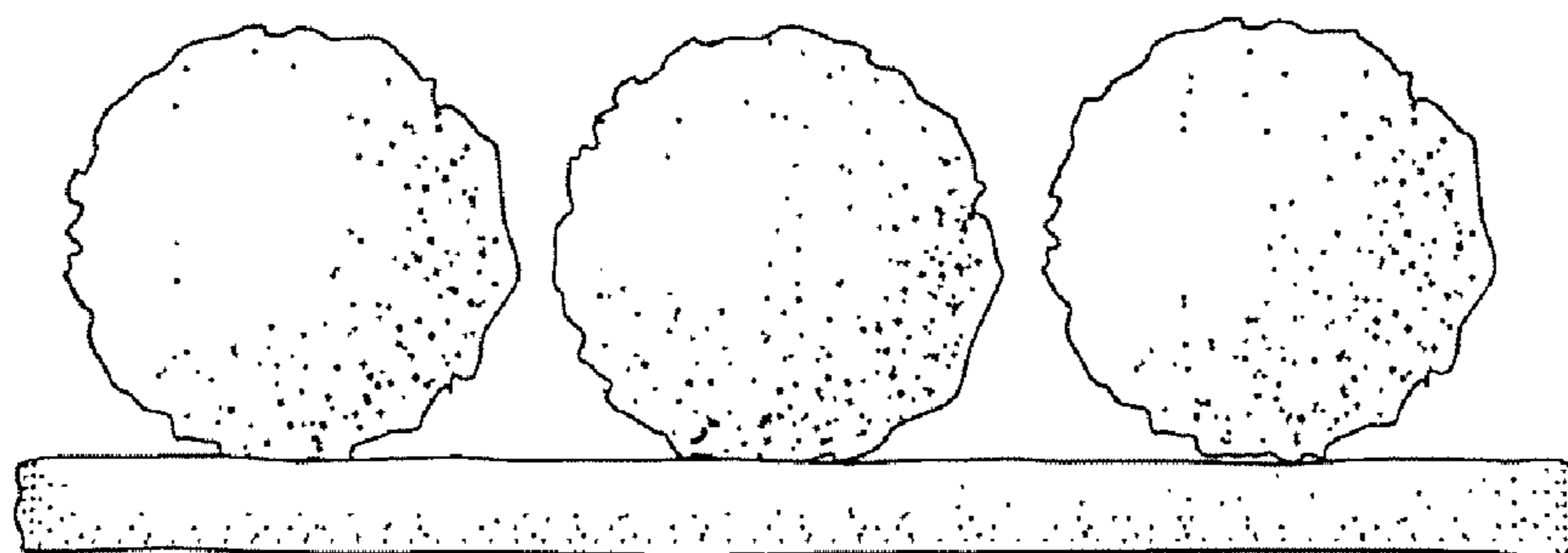

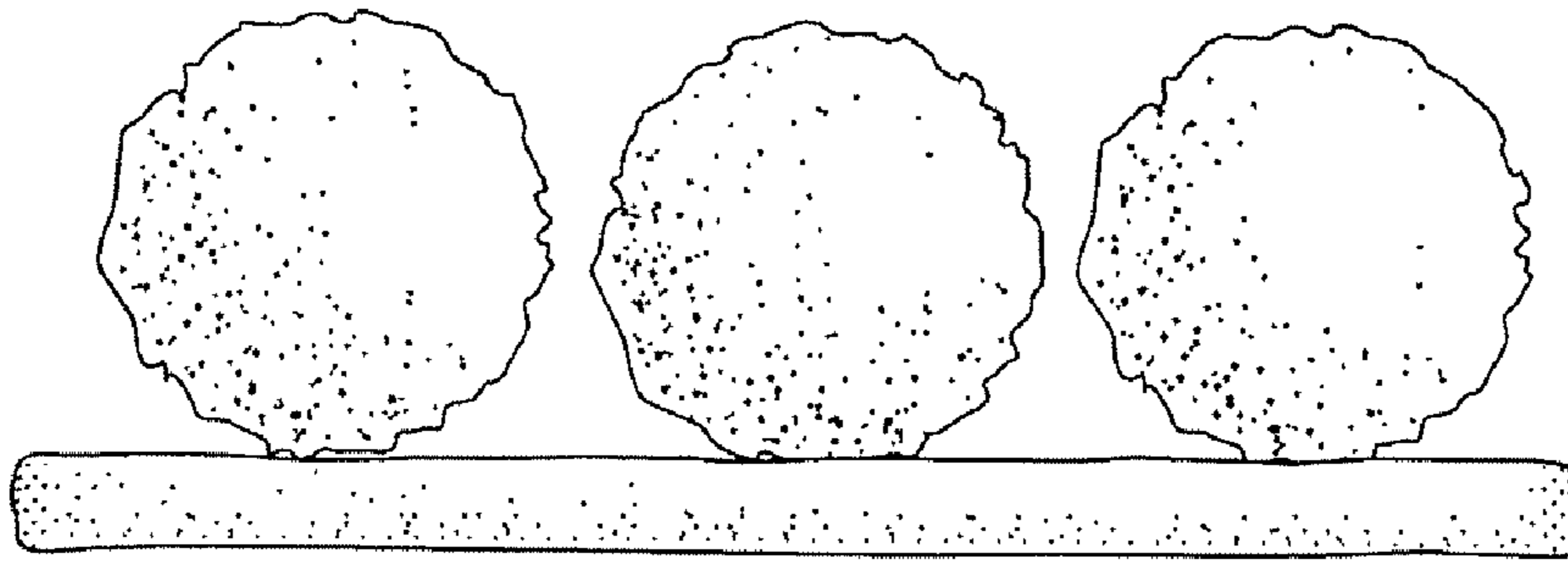

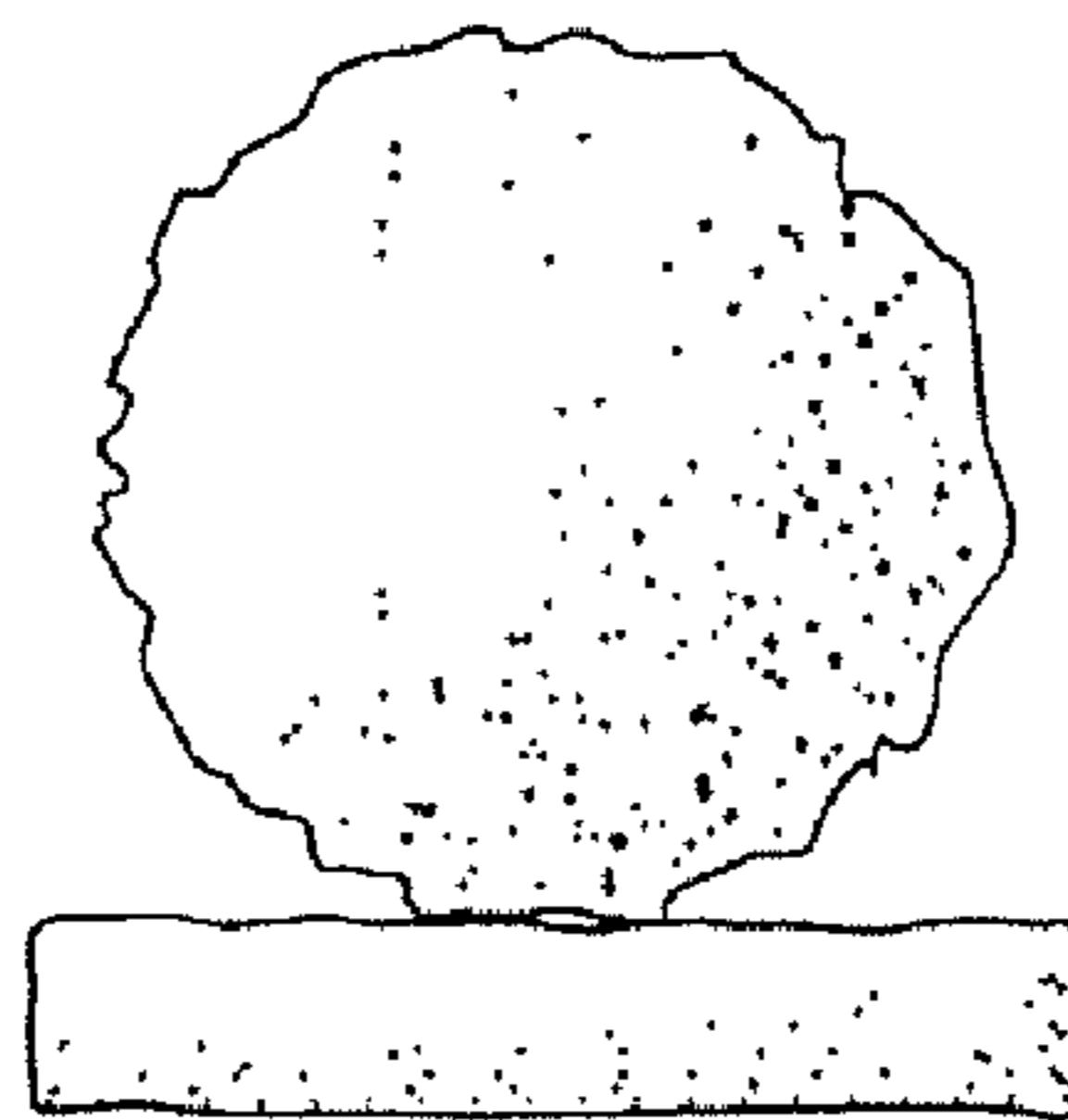

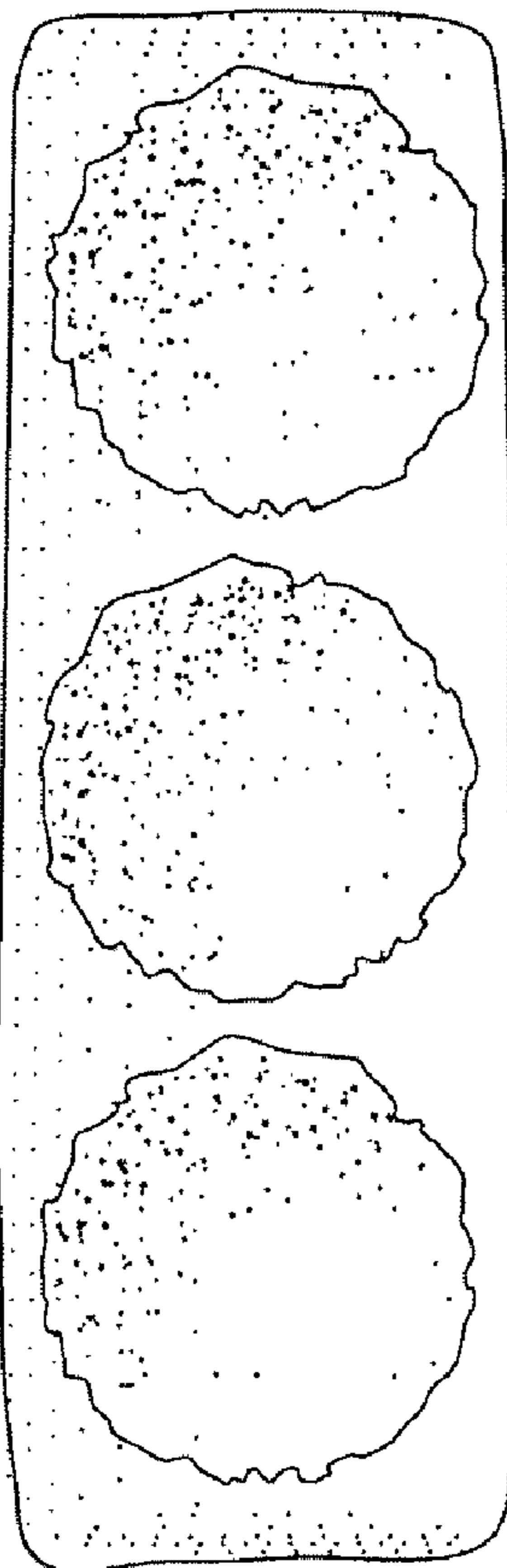

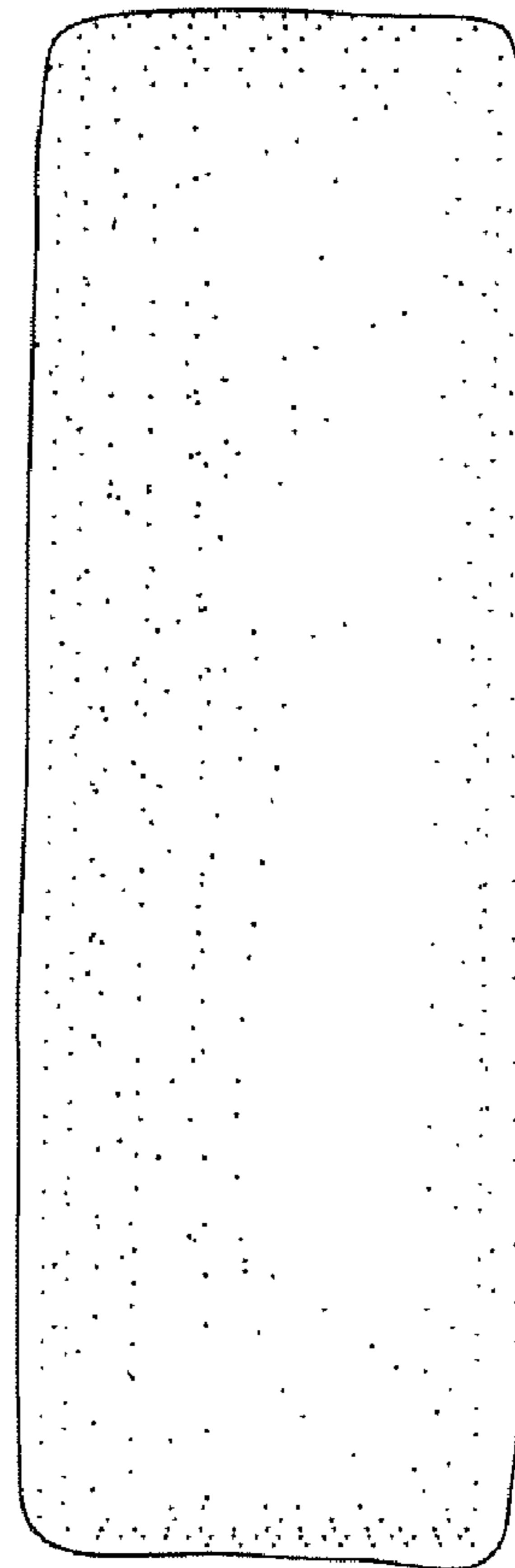

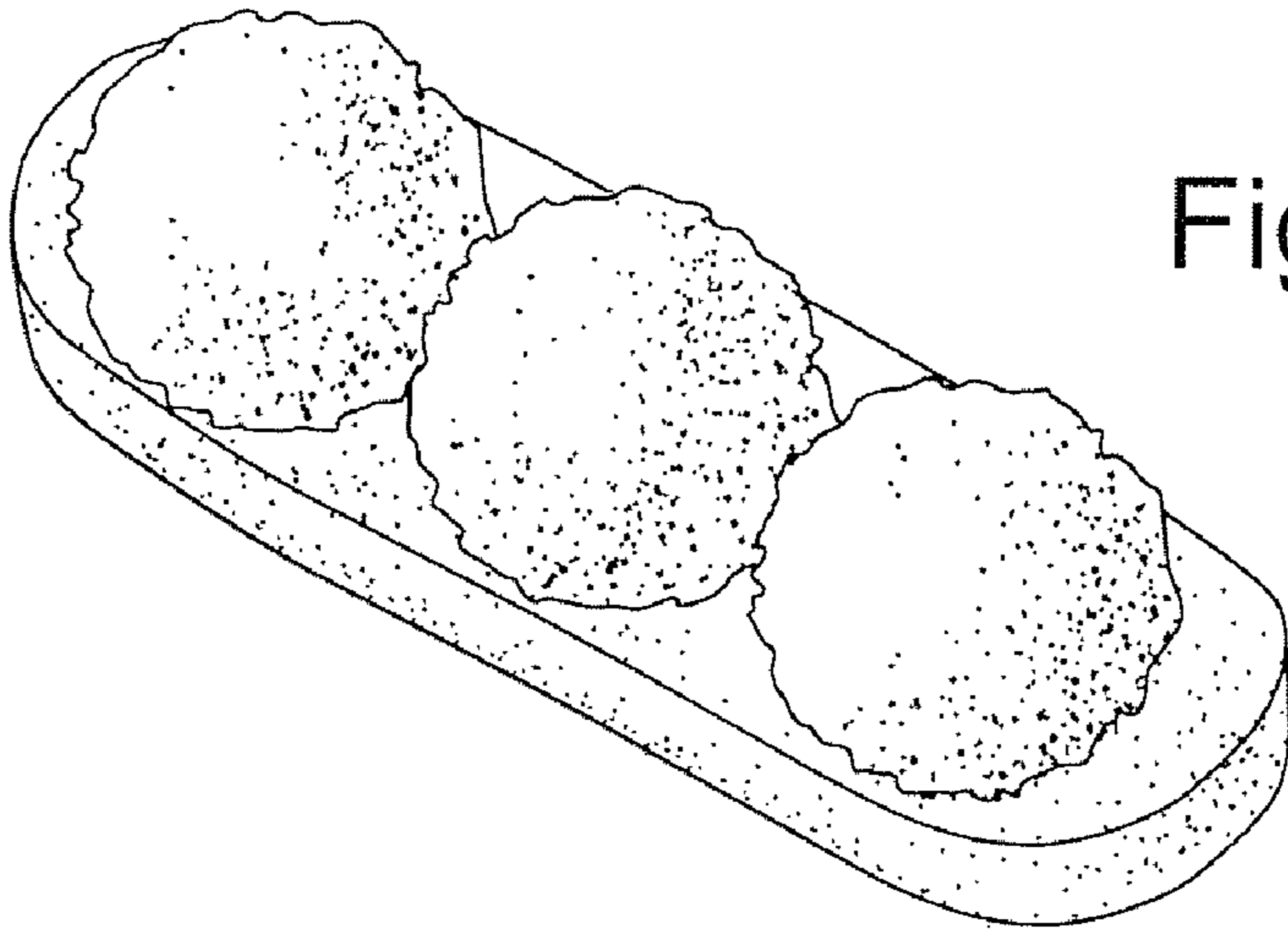

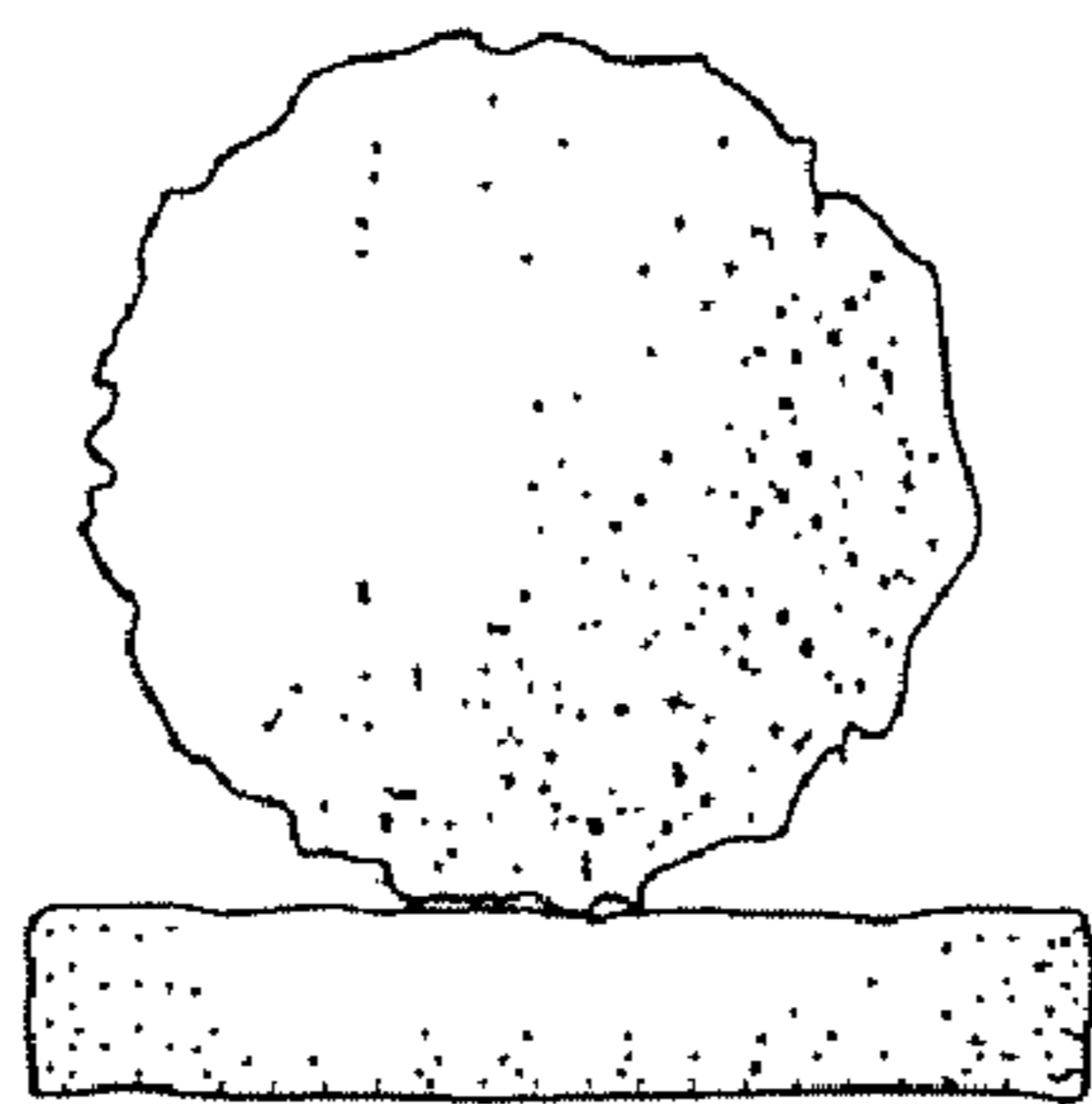

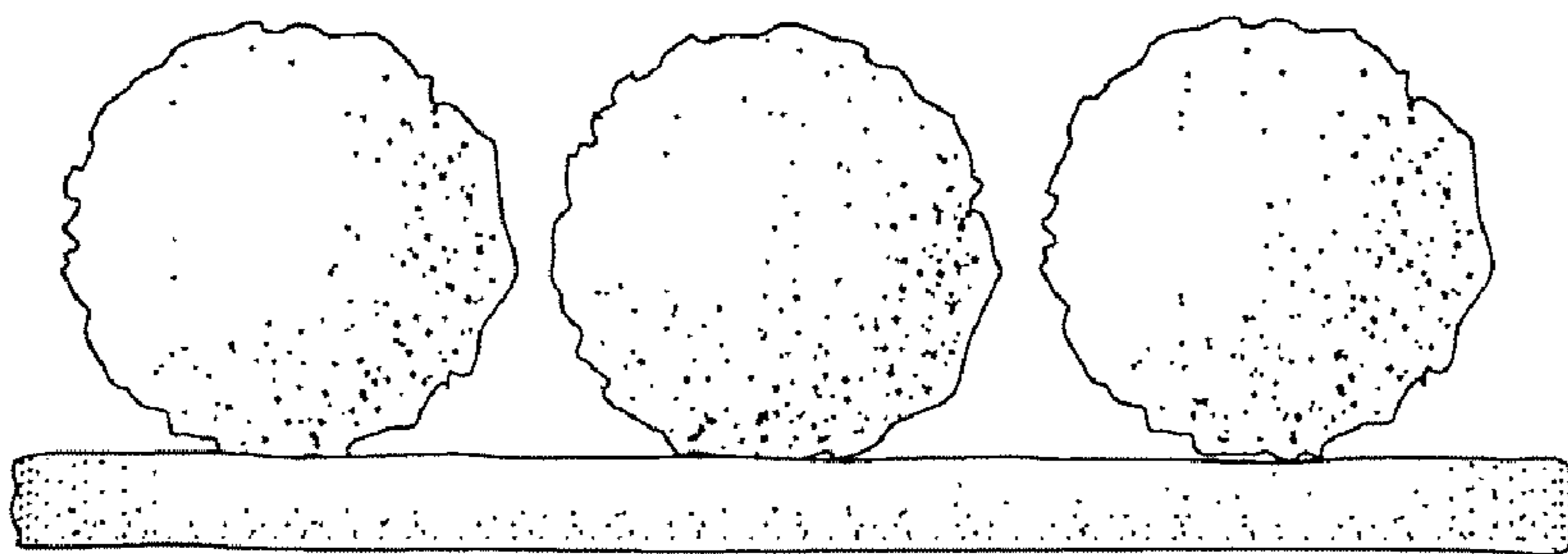

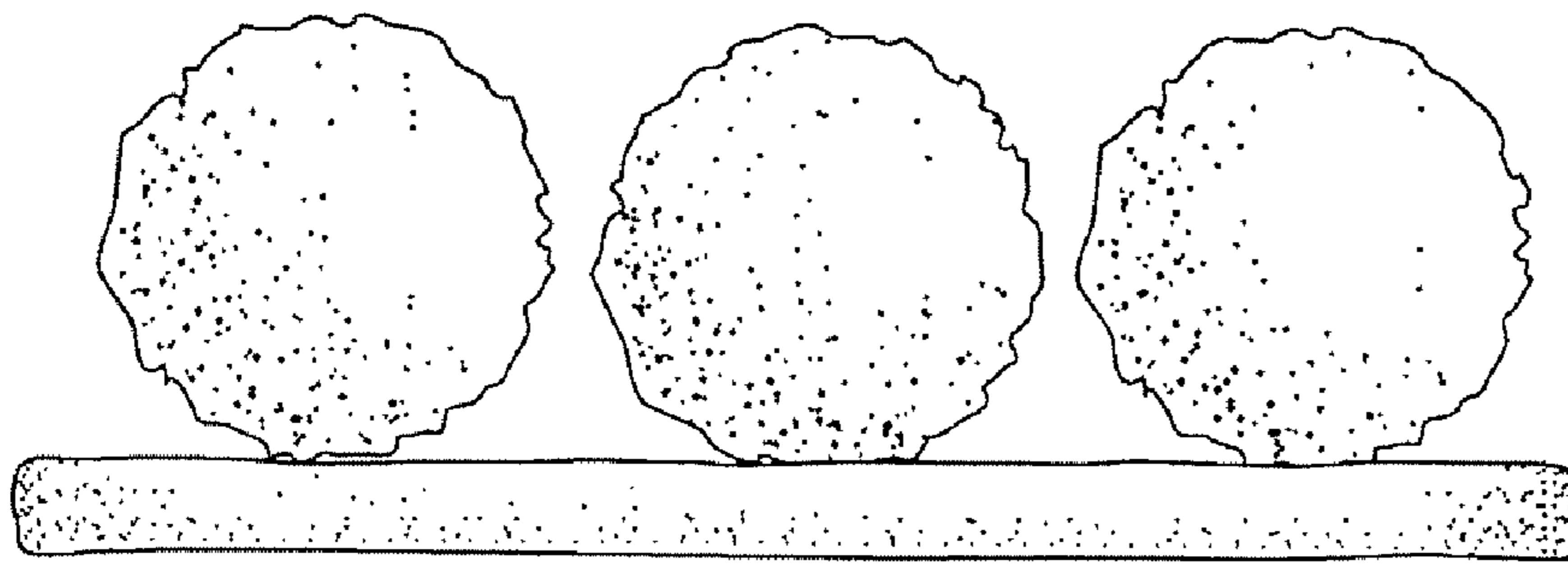

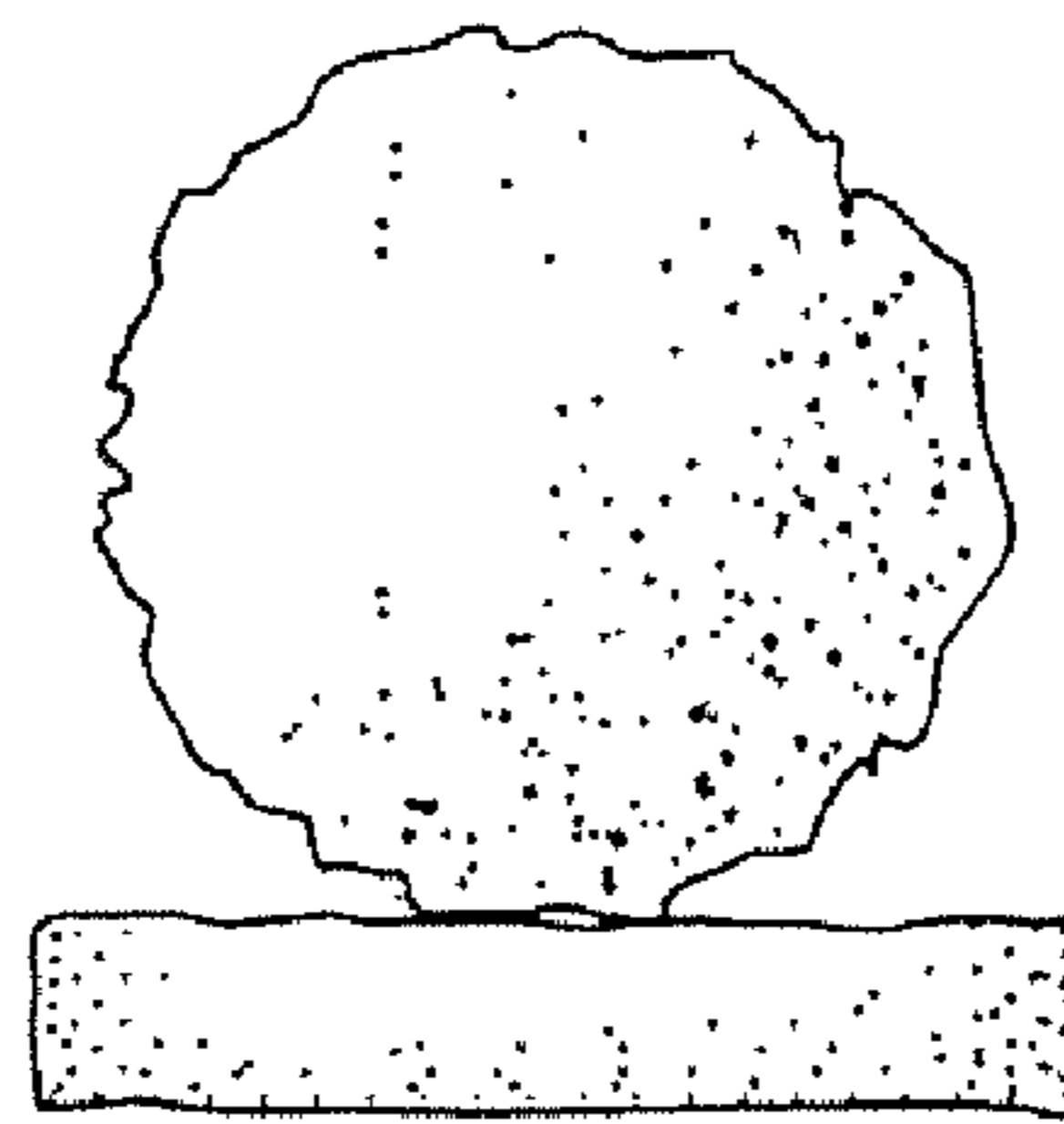

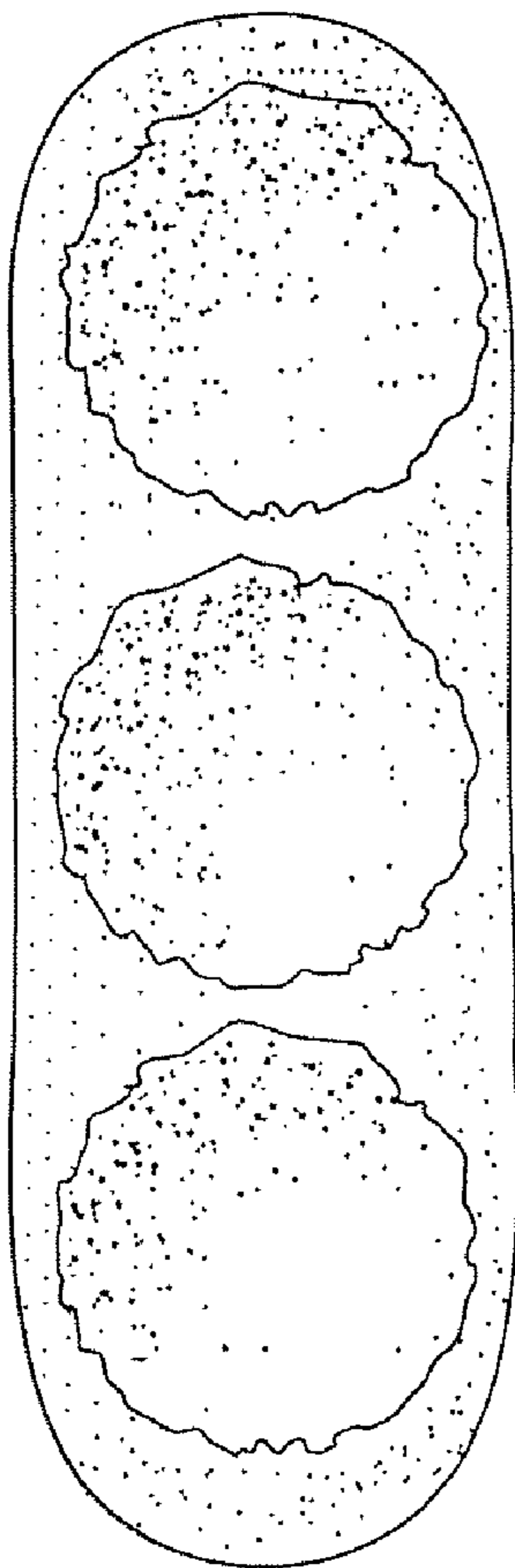

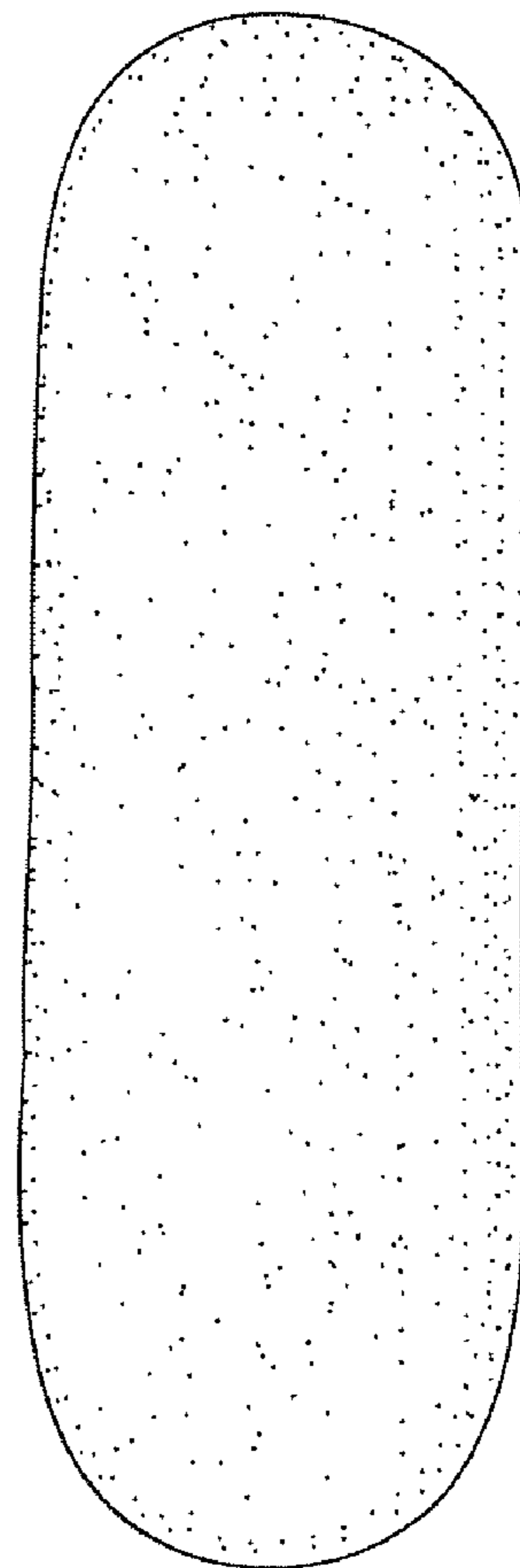

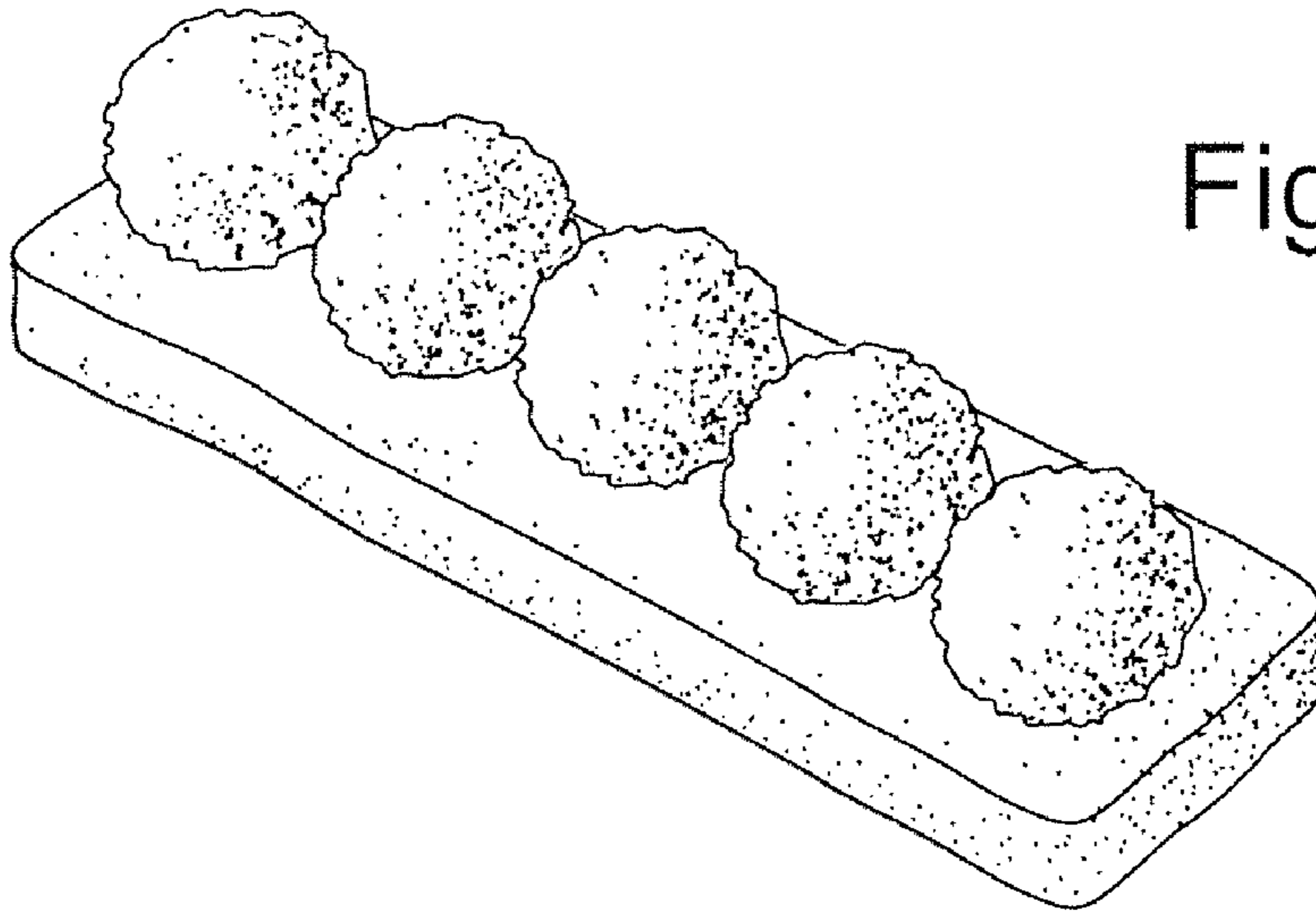

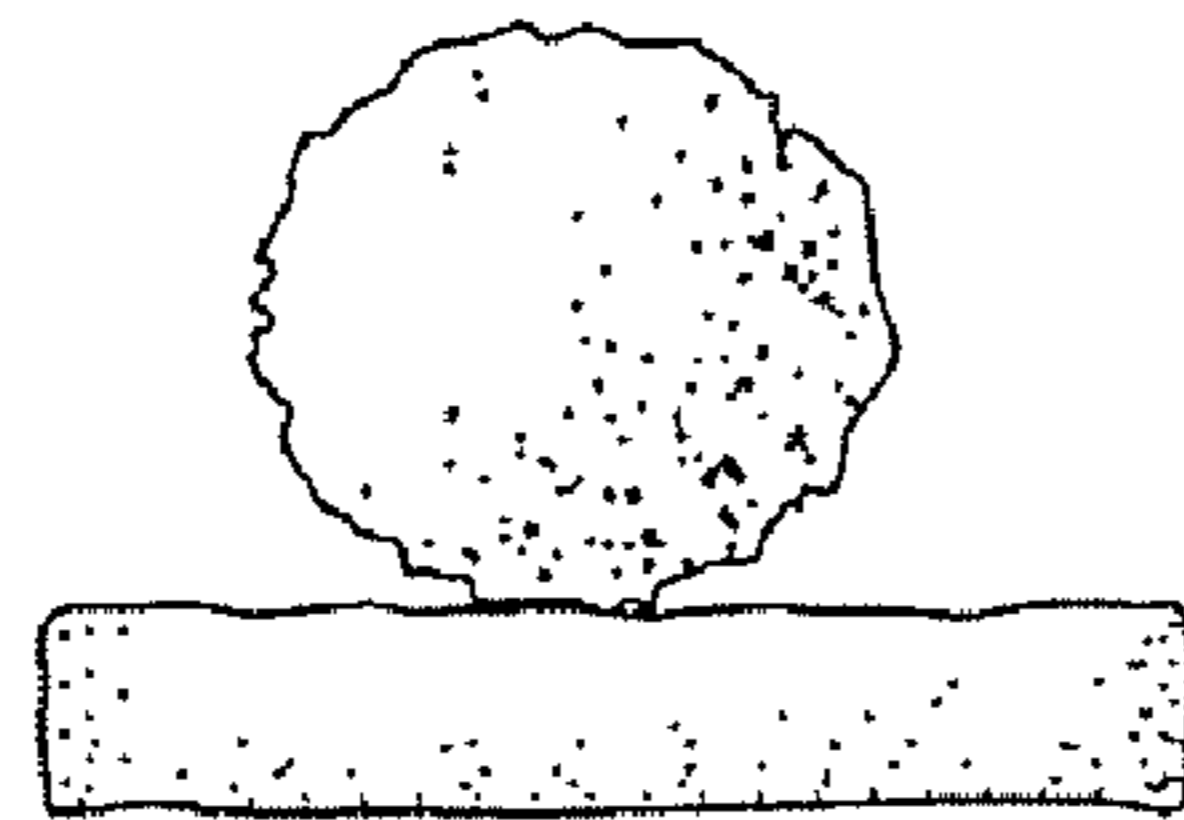

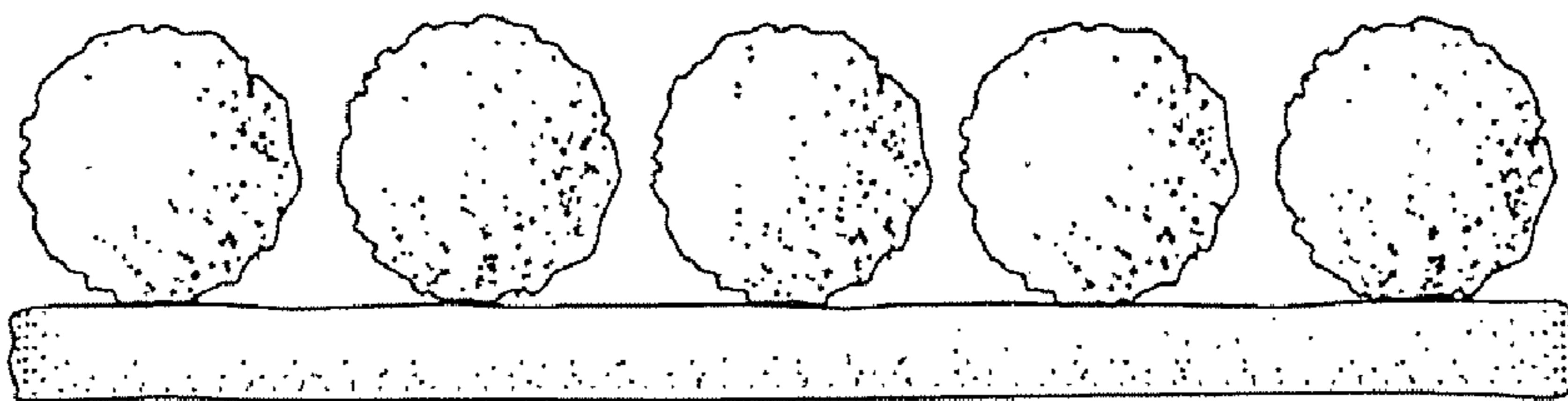

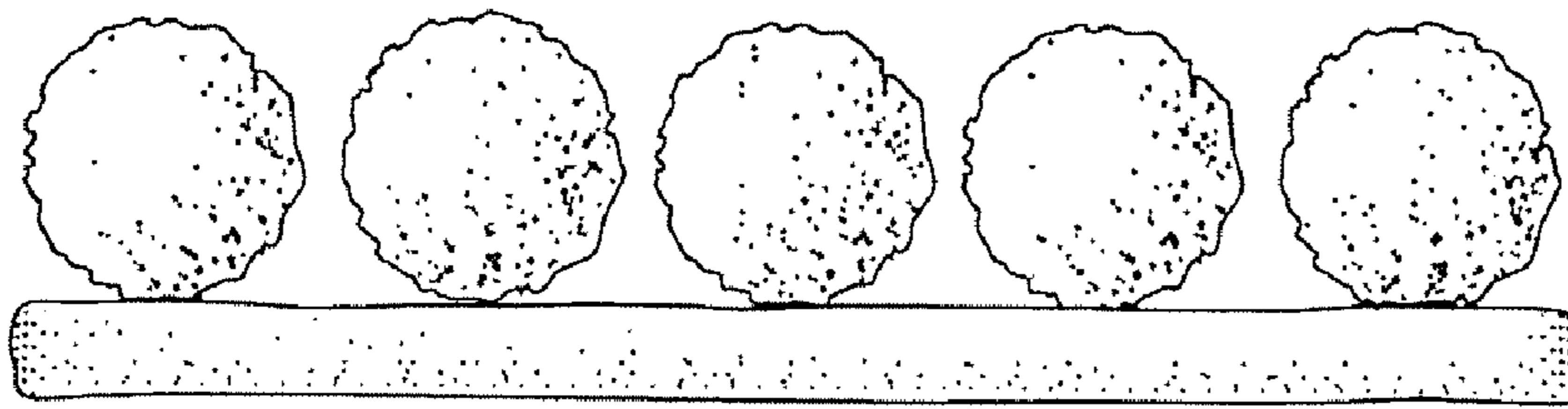

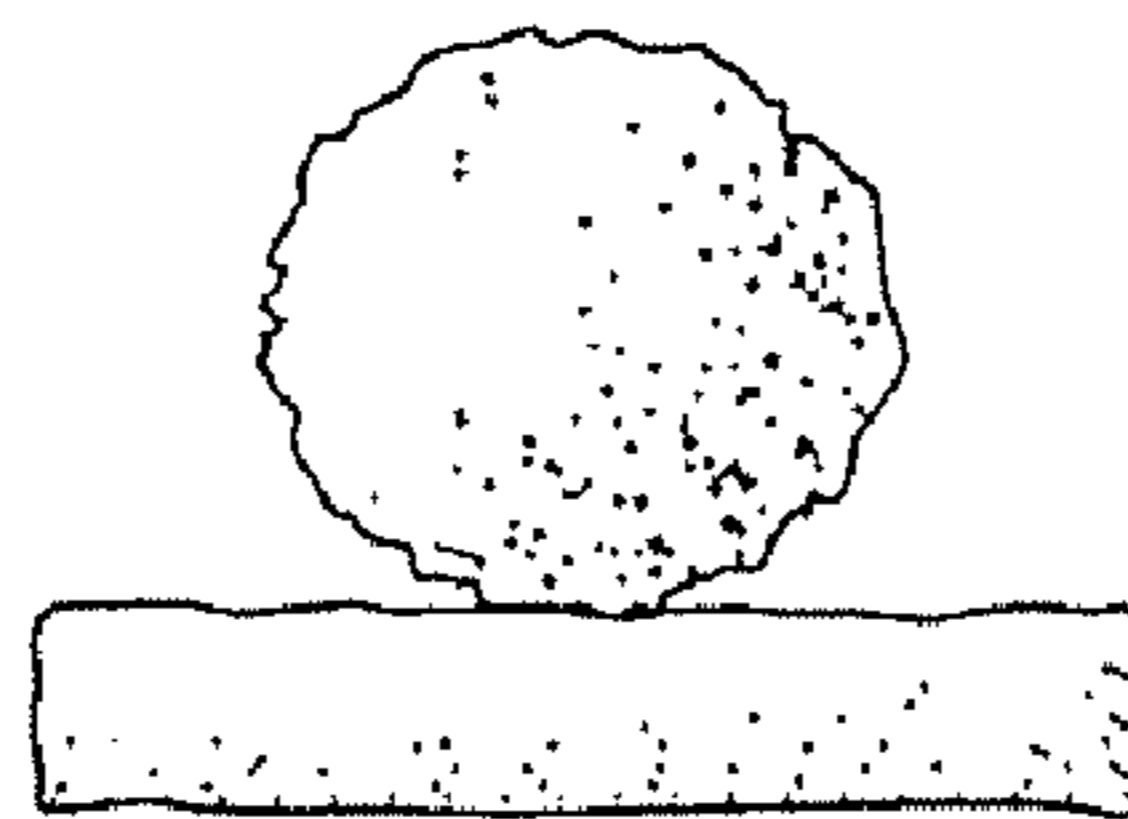

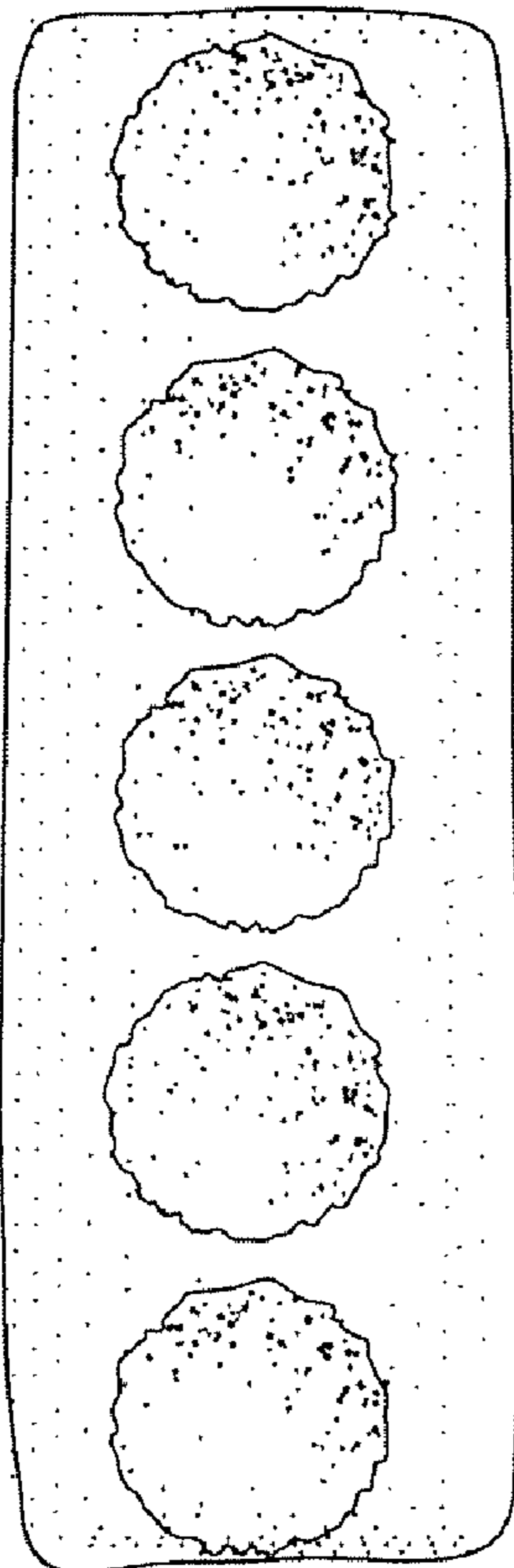

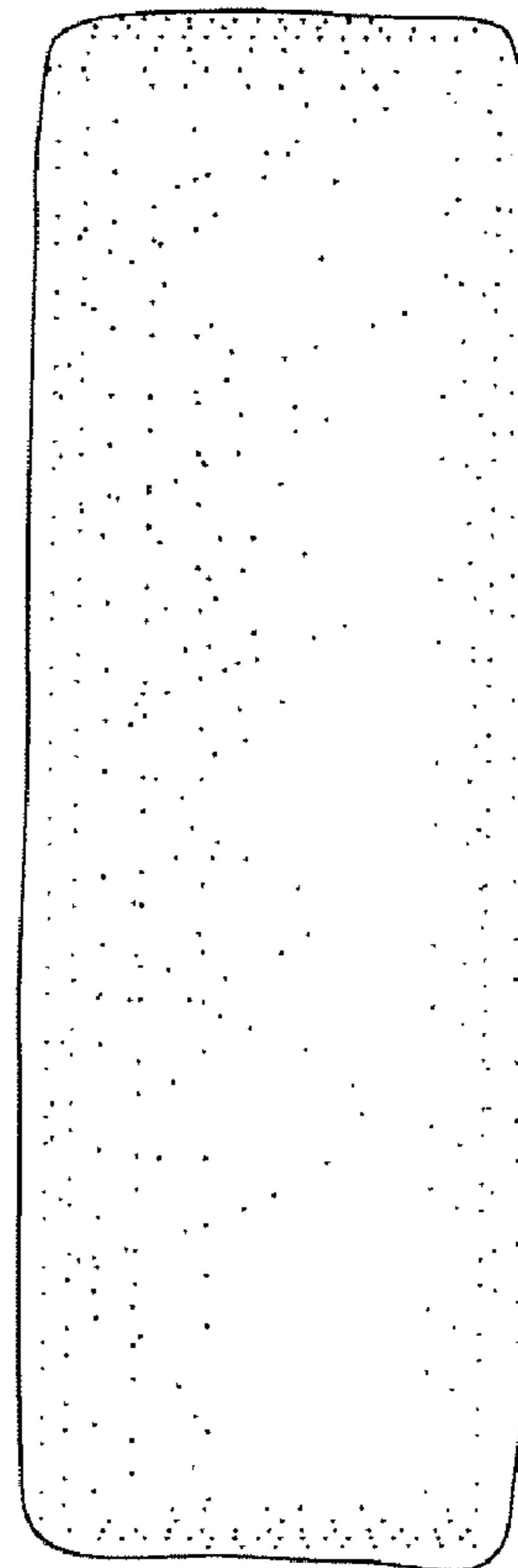

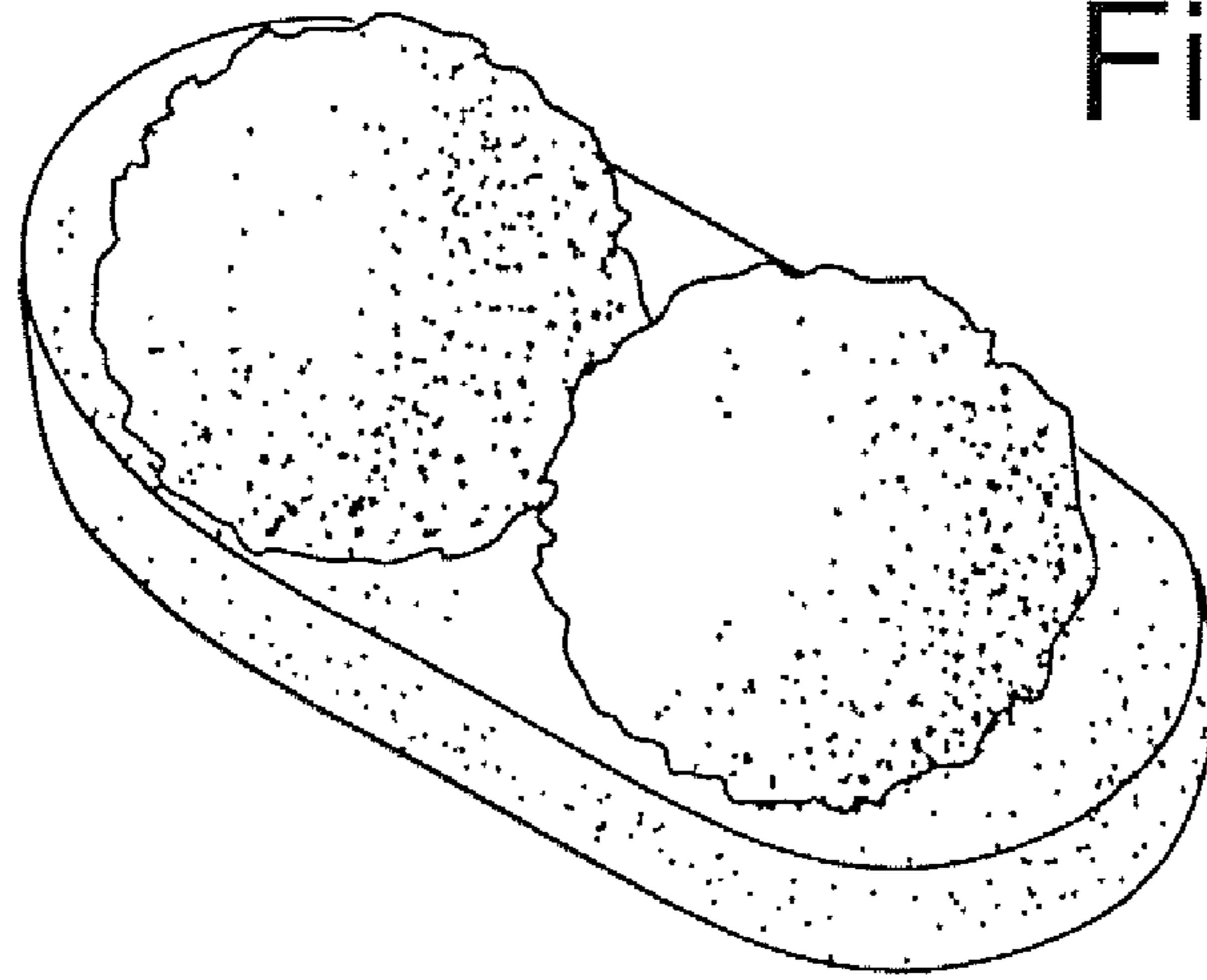

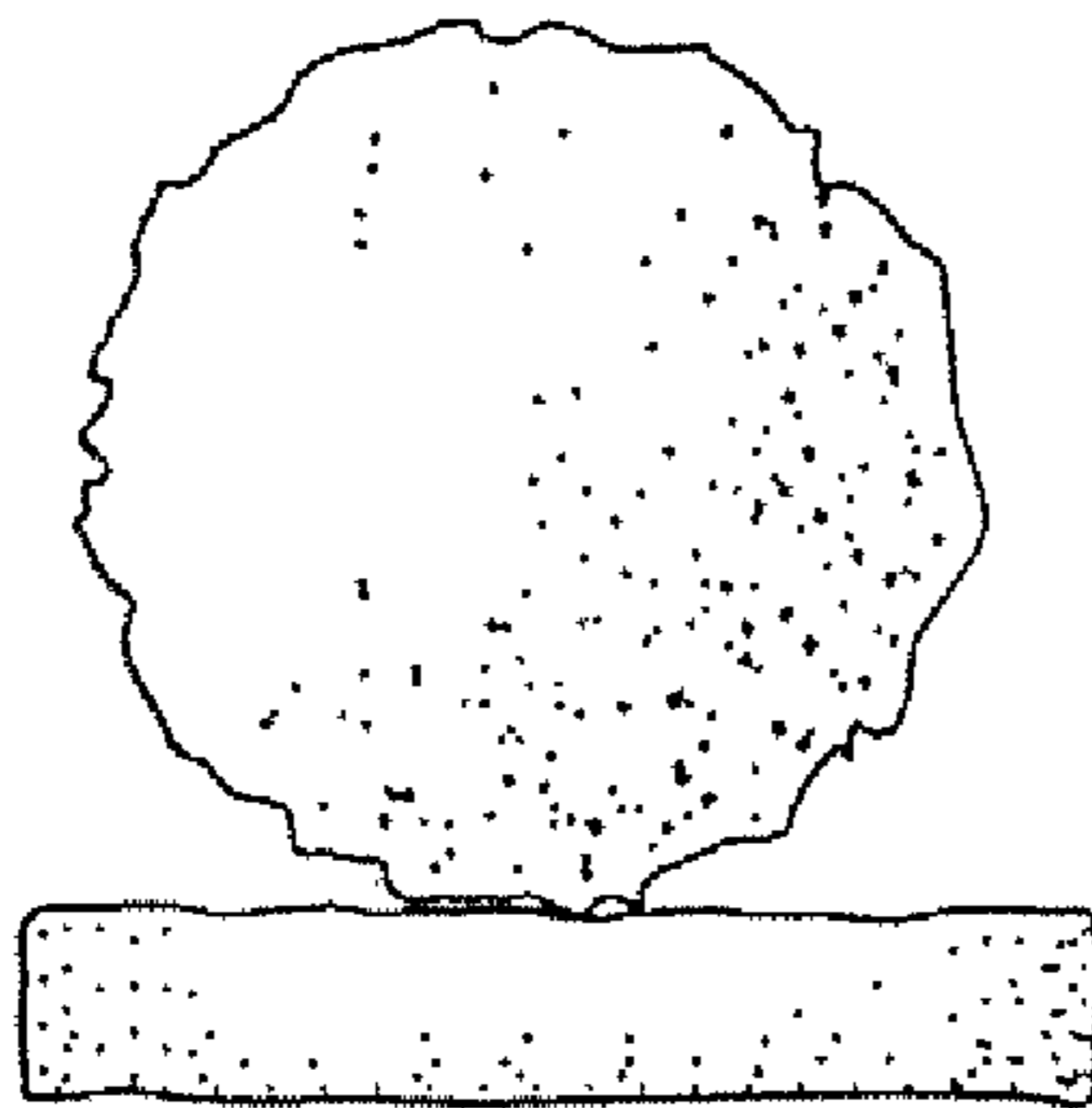
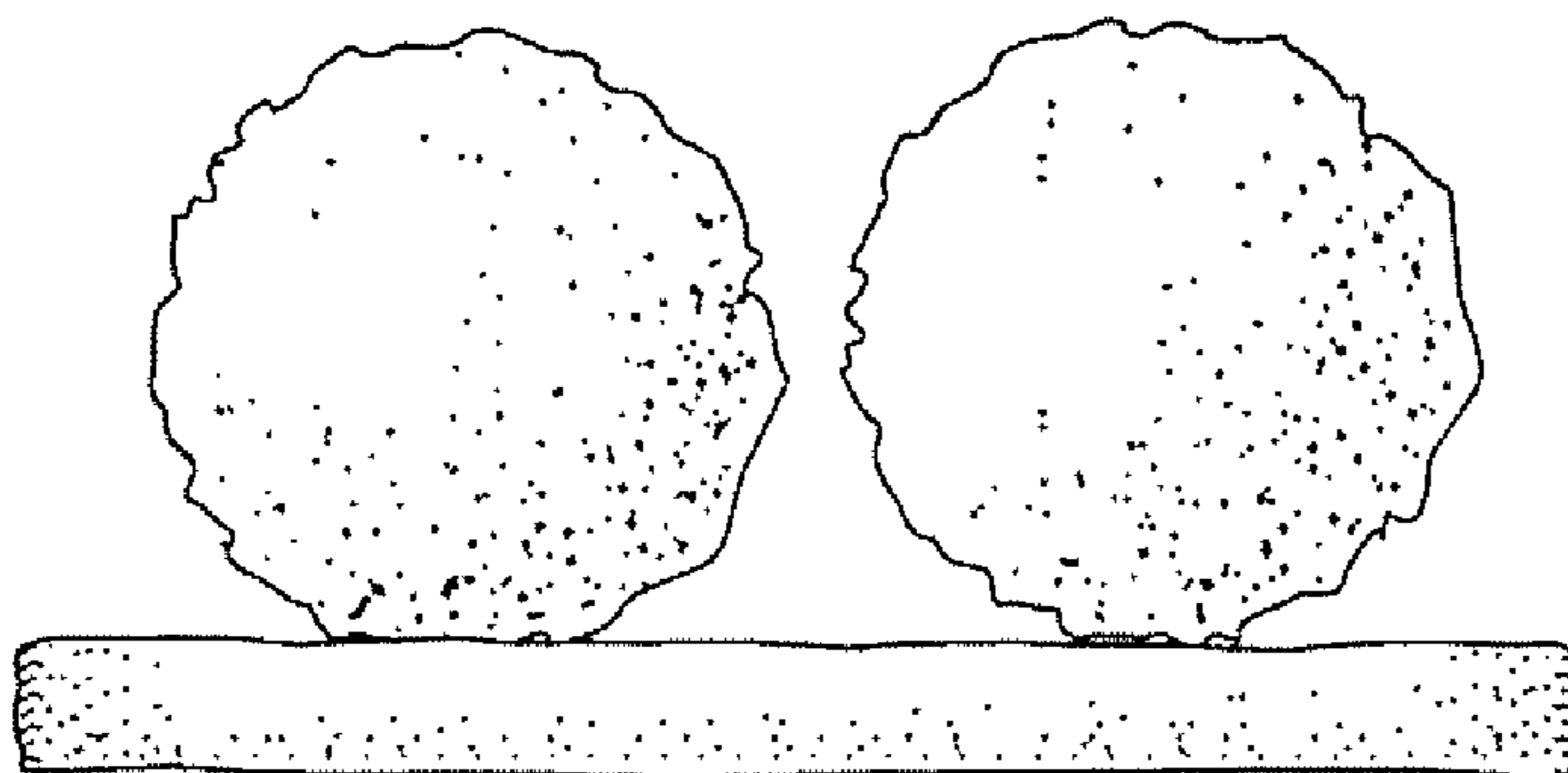

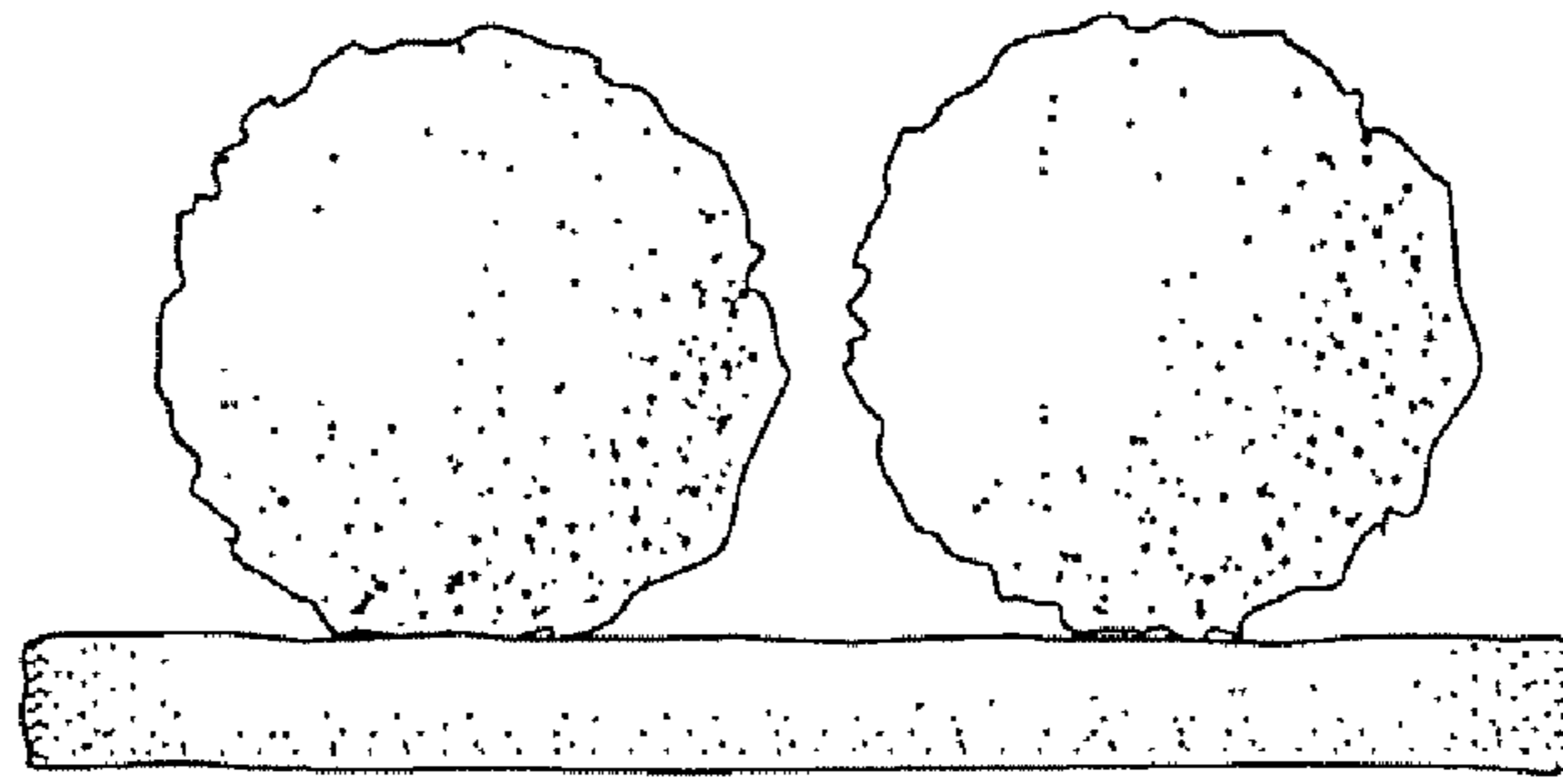

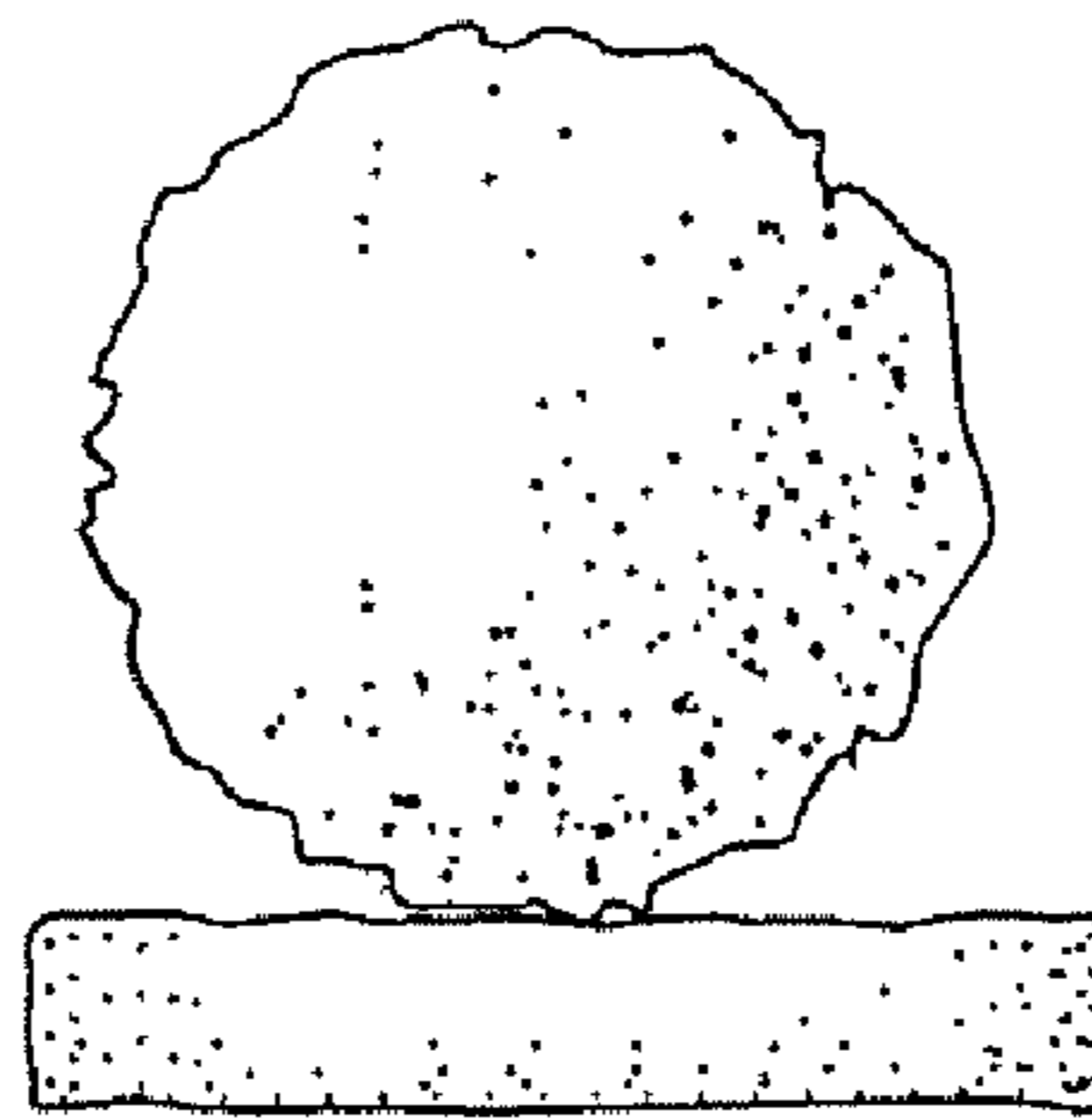

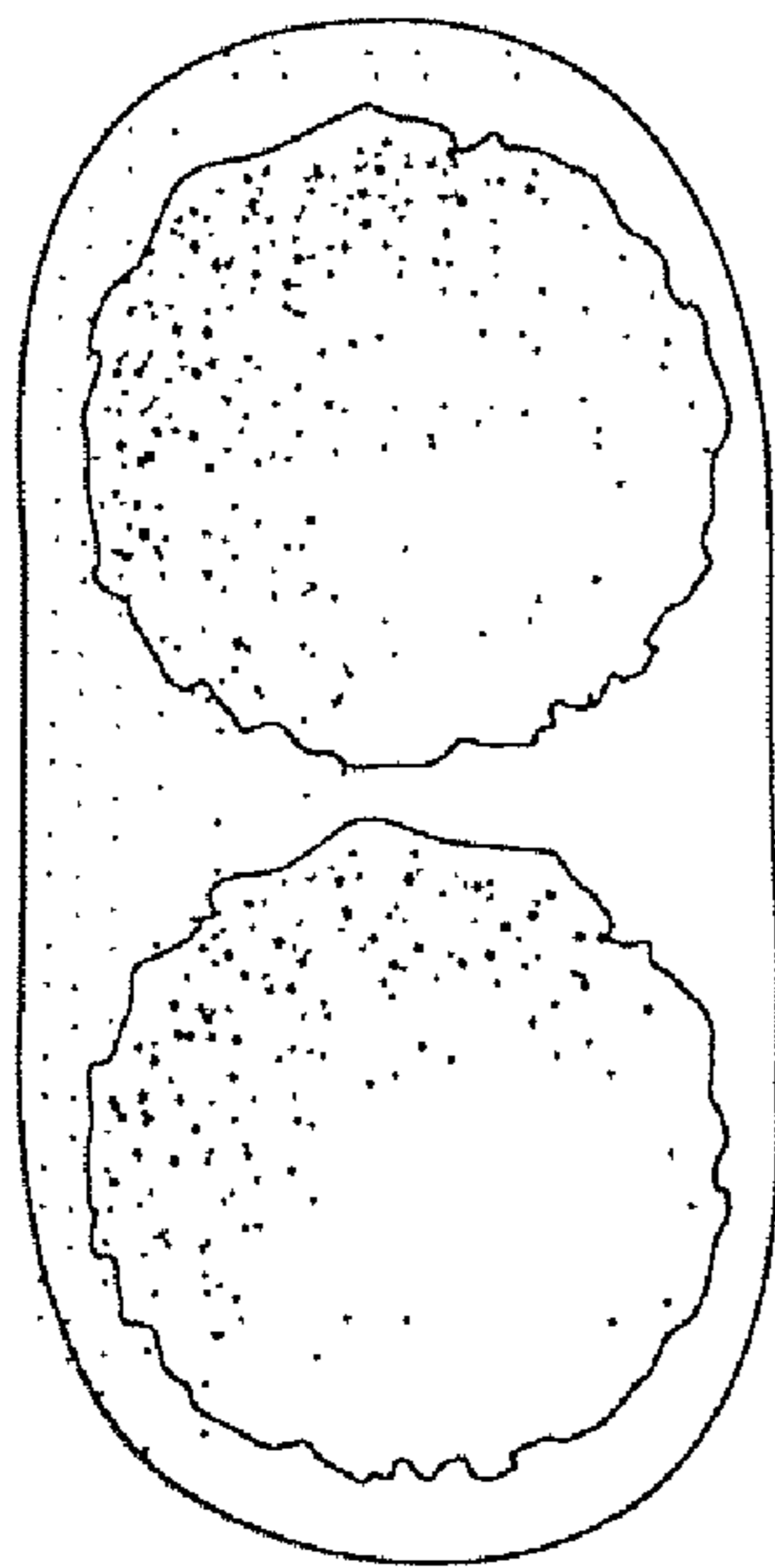

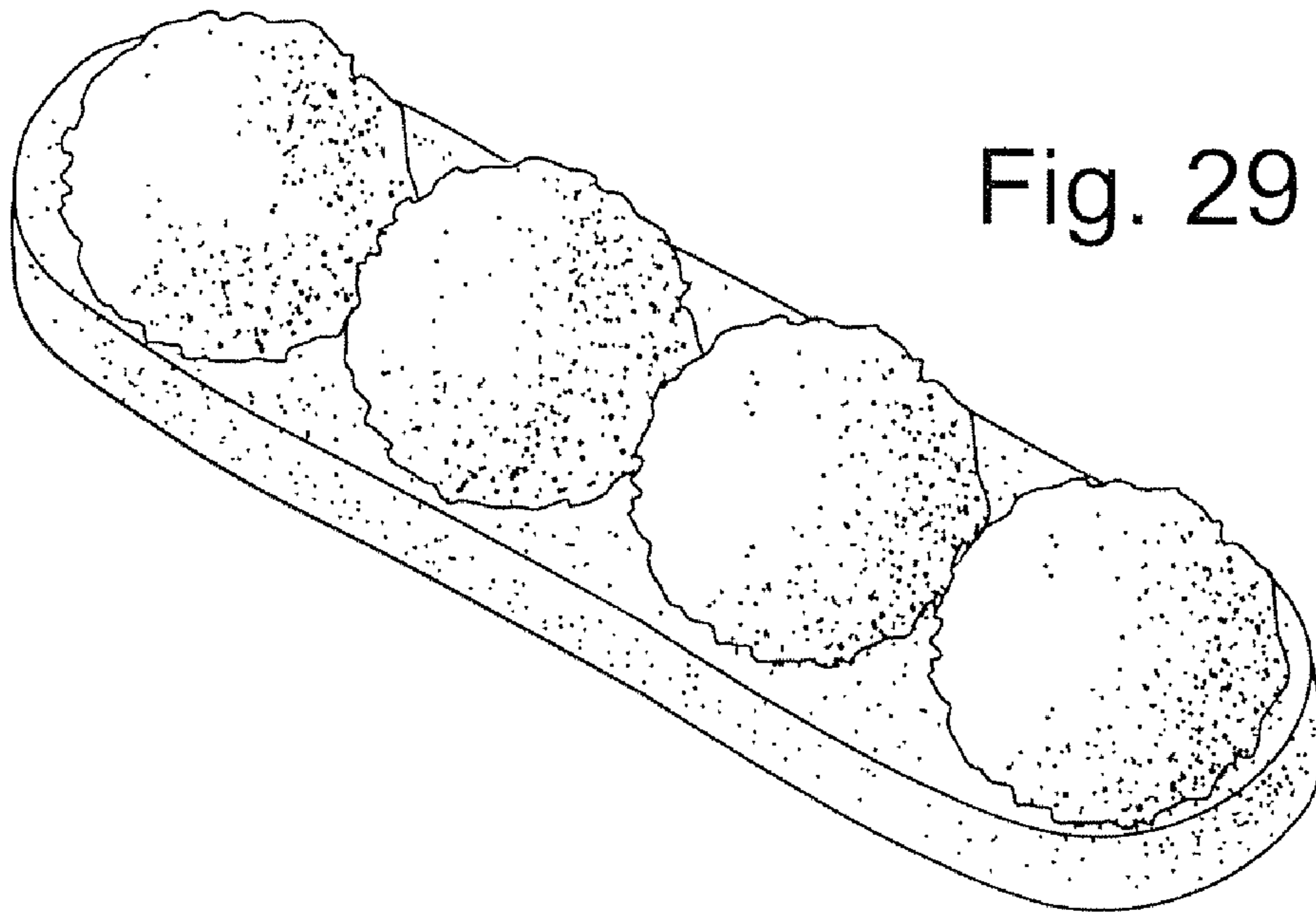

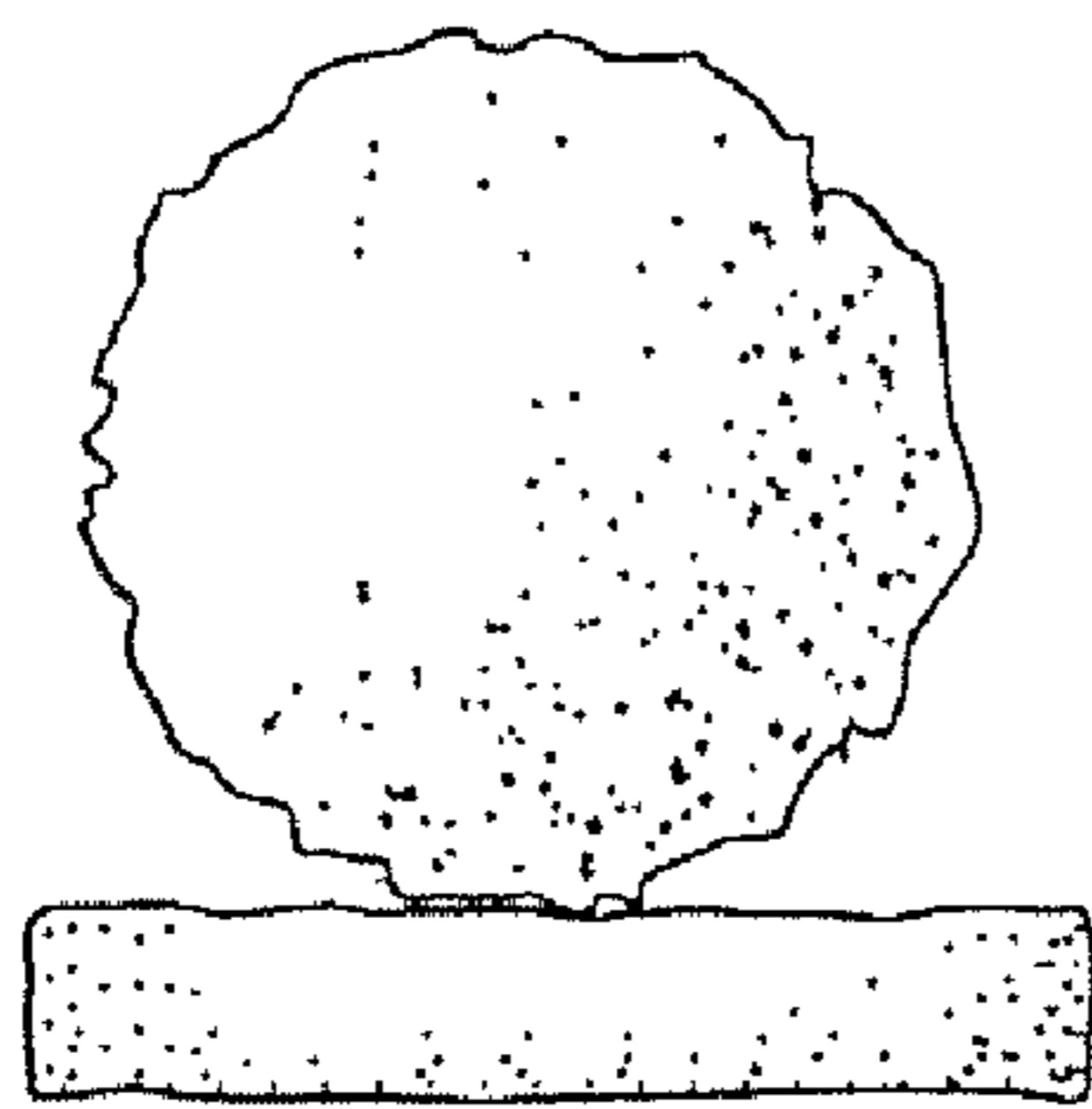

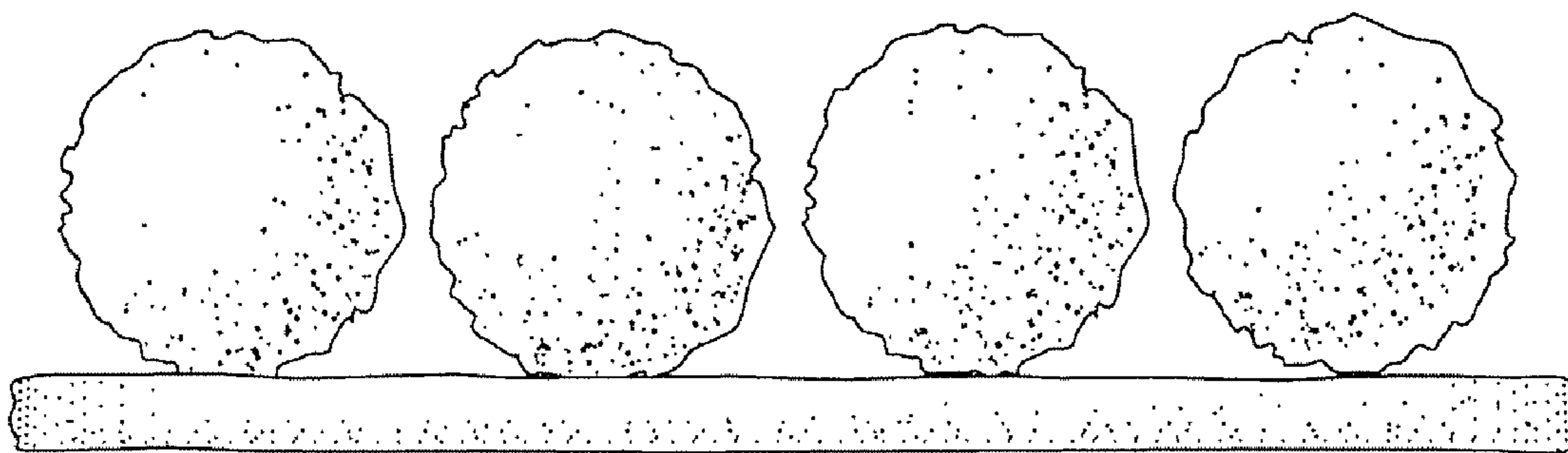

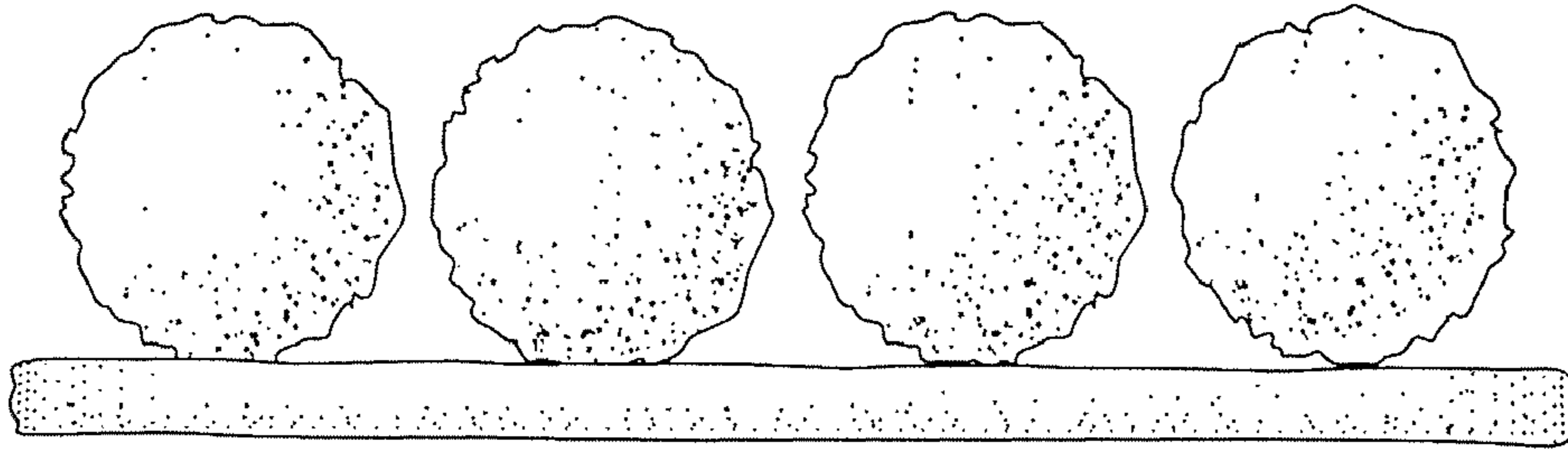

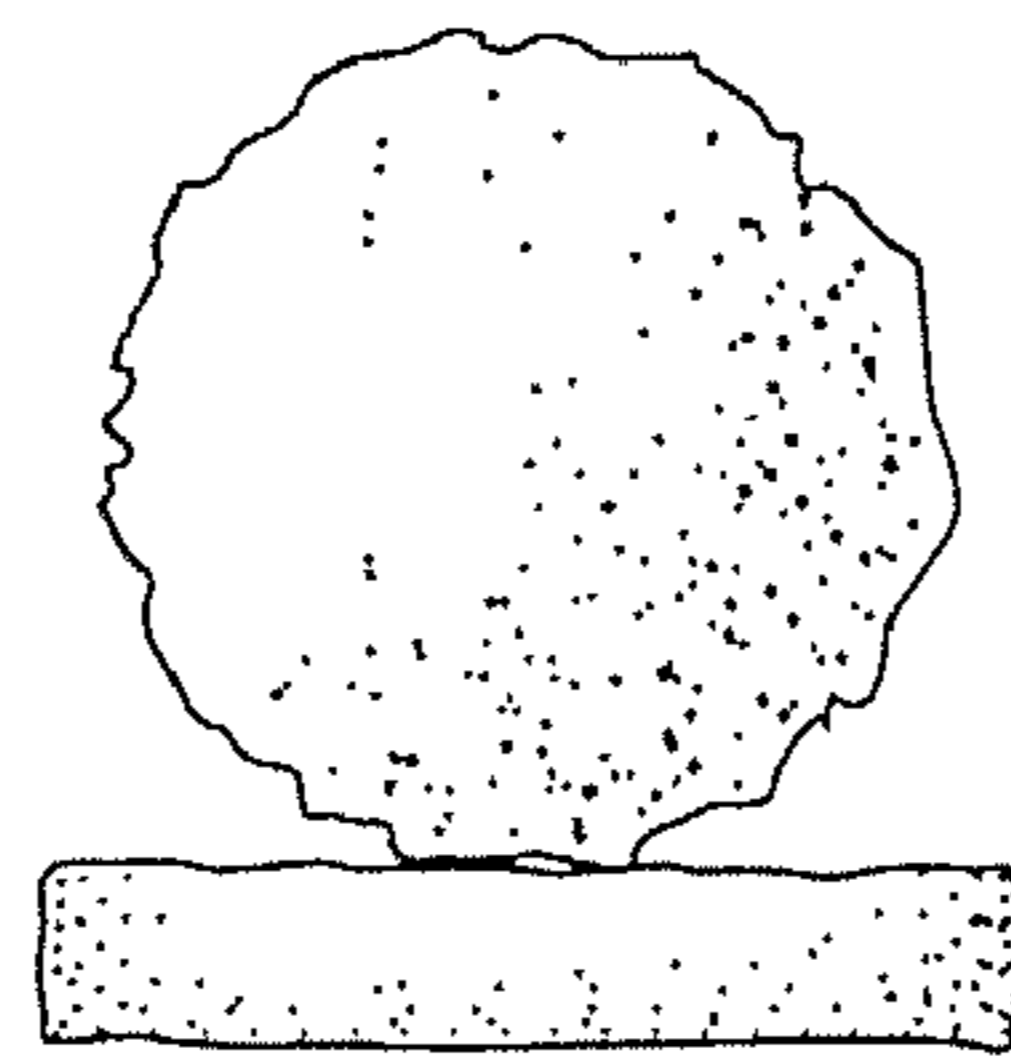

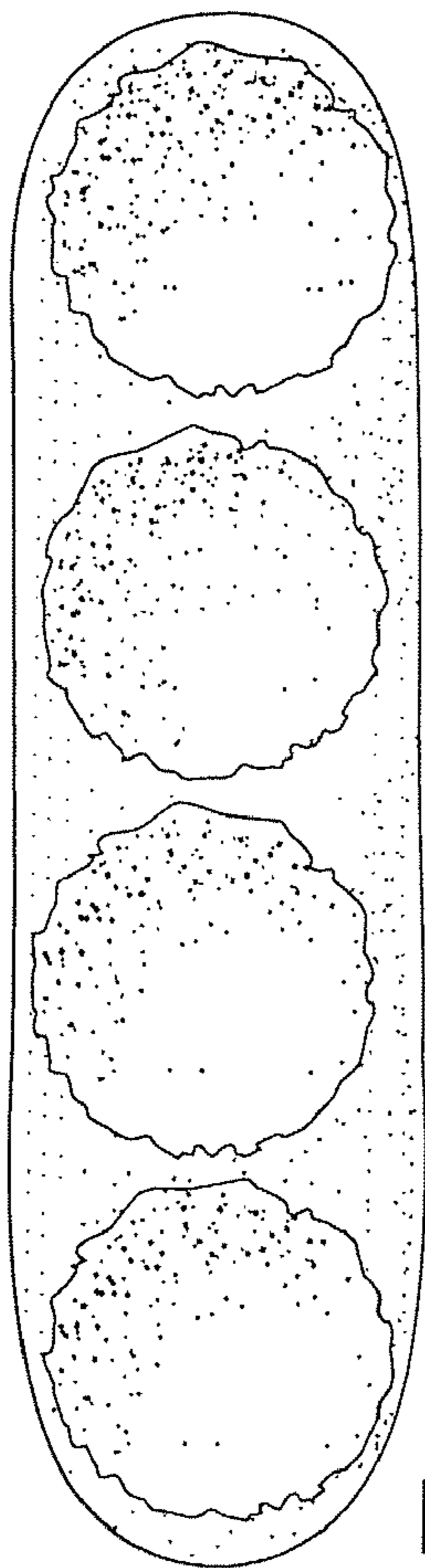

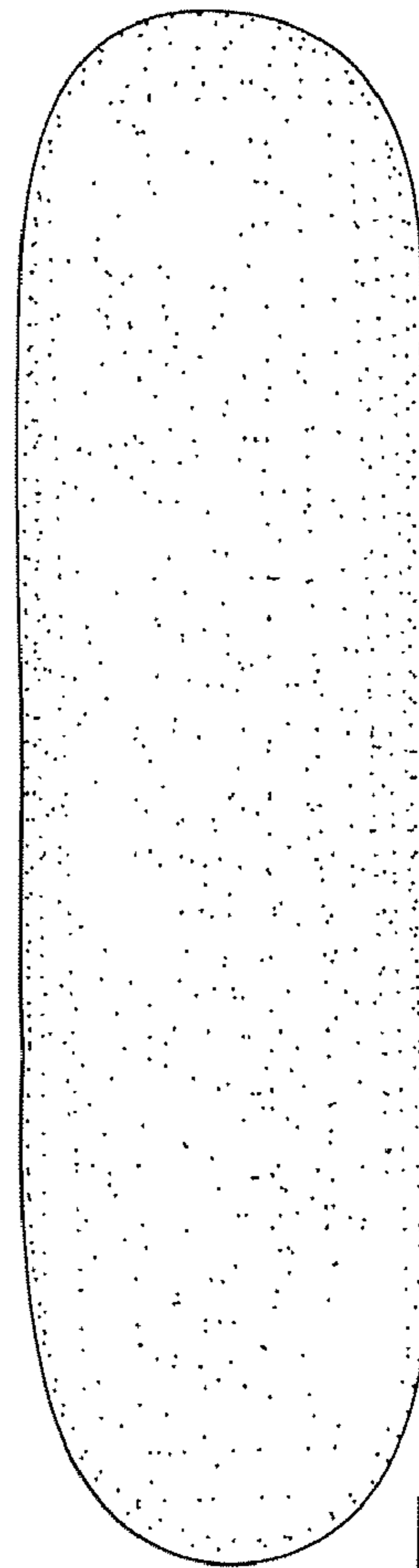
