(57) **CLAIM**

The ornamental design for a protective garment, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the protective garment as would be worn by a small child, wherein the broken line showing the child is for the purpose of illustrating environmental structure and forms no part of the claimed design;

FIG. 2 is a side perspective view of the protective garment as would be worn by a small child, wherein the broken line showing the child is for the purpose of illustrating environmental structure and forms no part of the claimed design;

FIG. 3 is a top plan view of the protective garment;

FIG. 4 is a bottom plan view of the protective garment;

FIG. 5 is a left side view of the protective garment;

FIG. 6 is a right side view of the protective garment;

FIG. 7 is a front view of the protective garment; and,

FIG. 8 is a rear view of the protective garment.

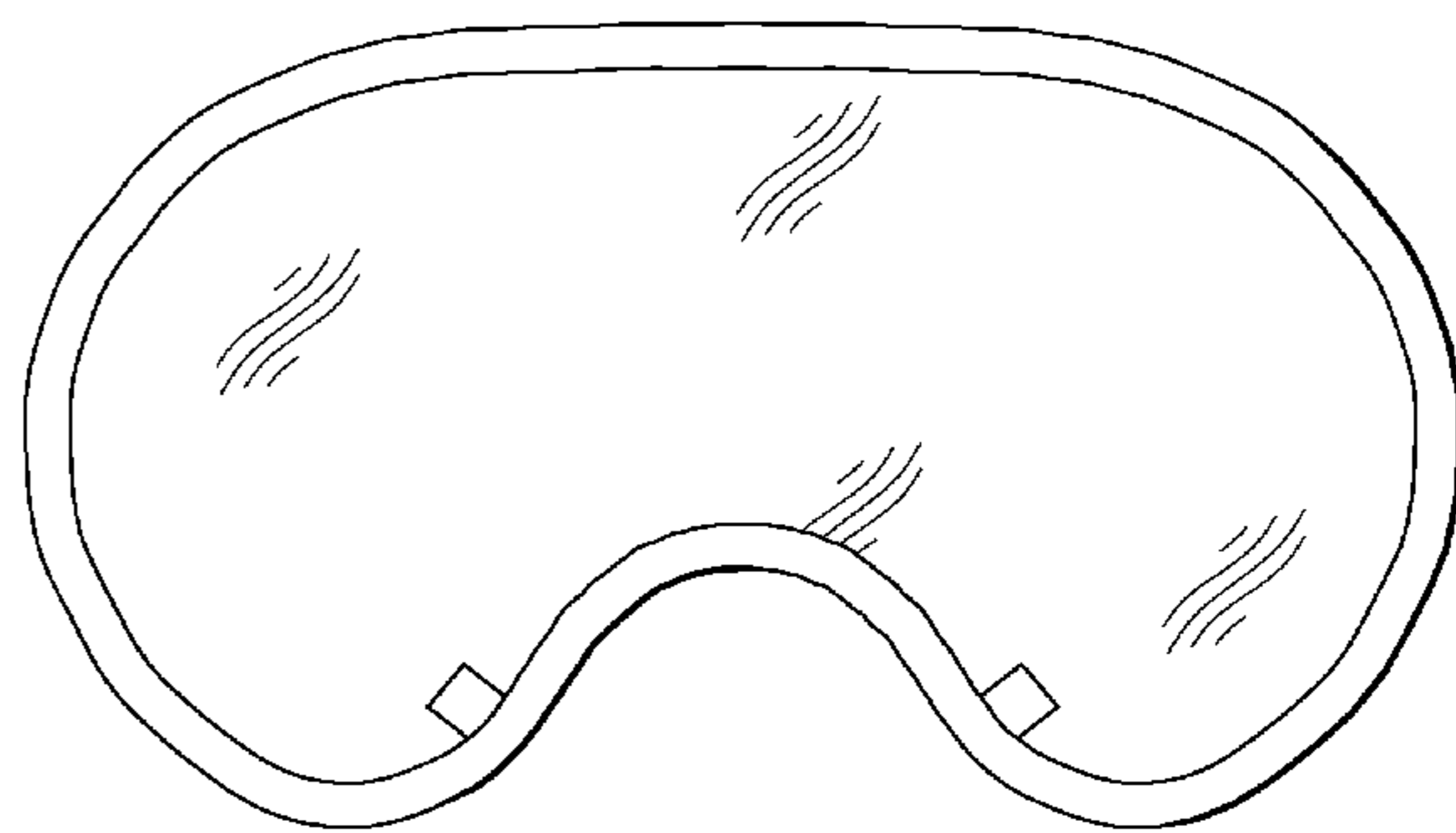
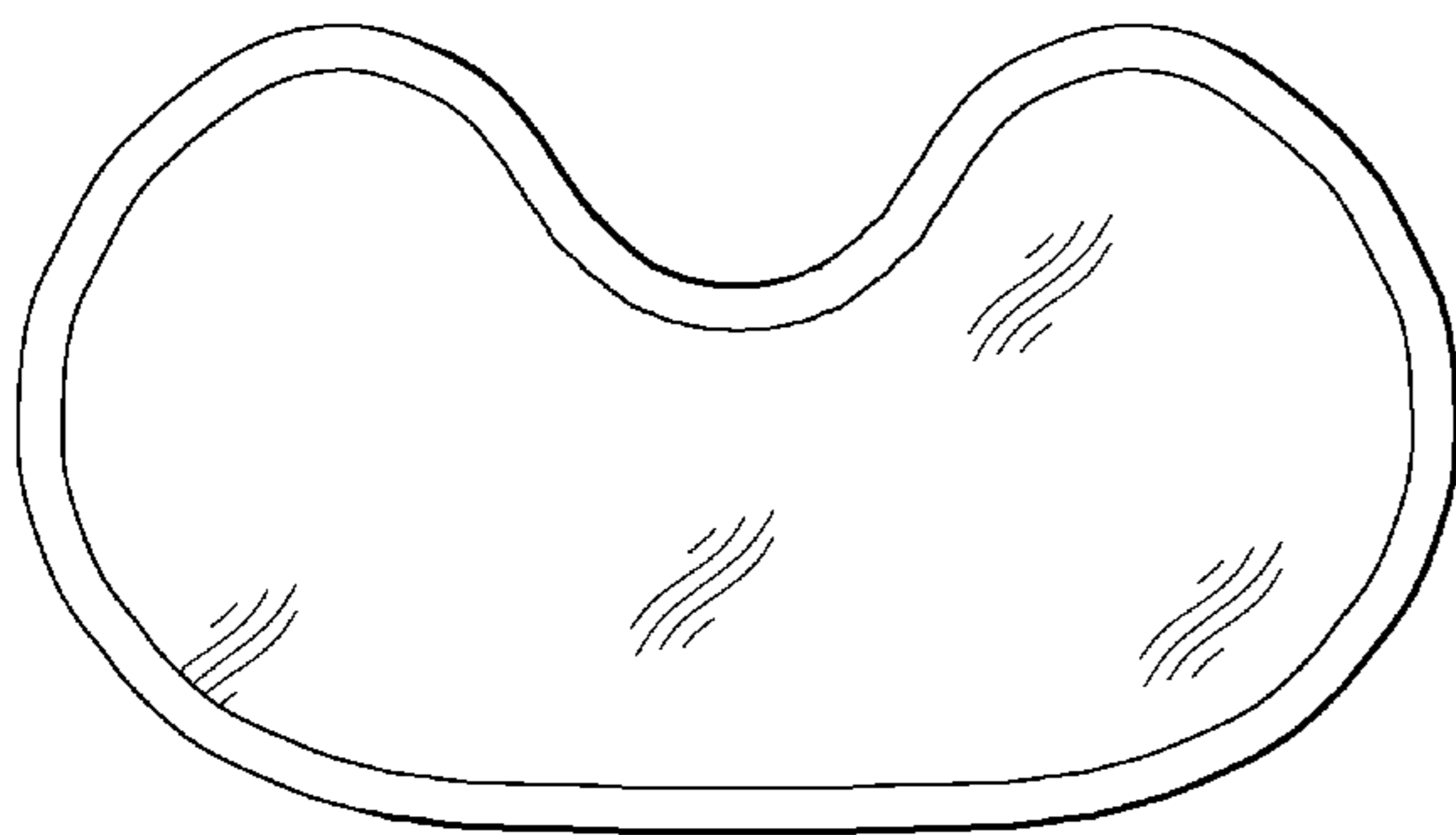

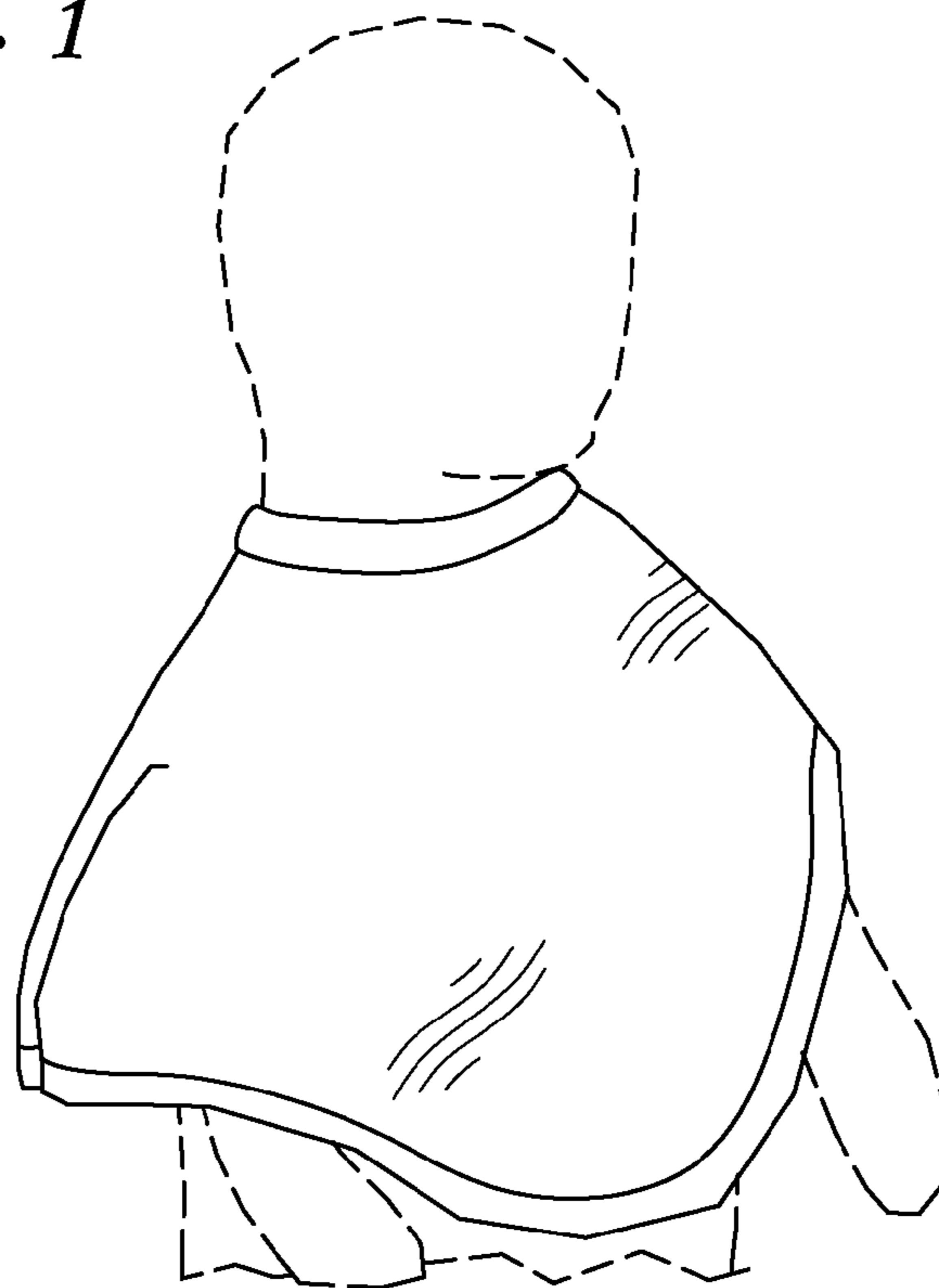

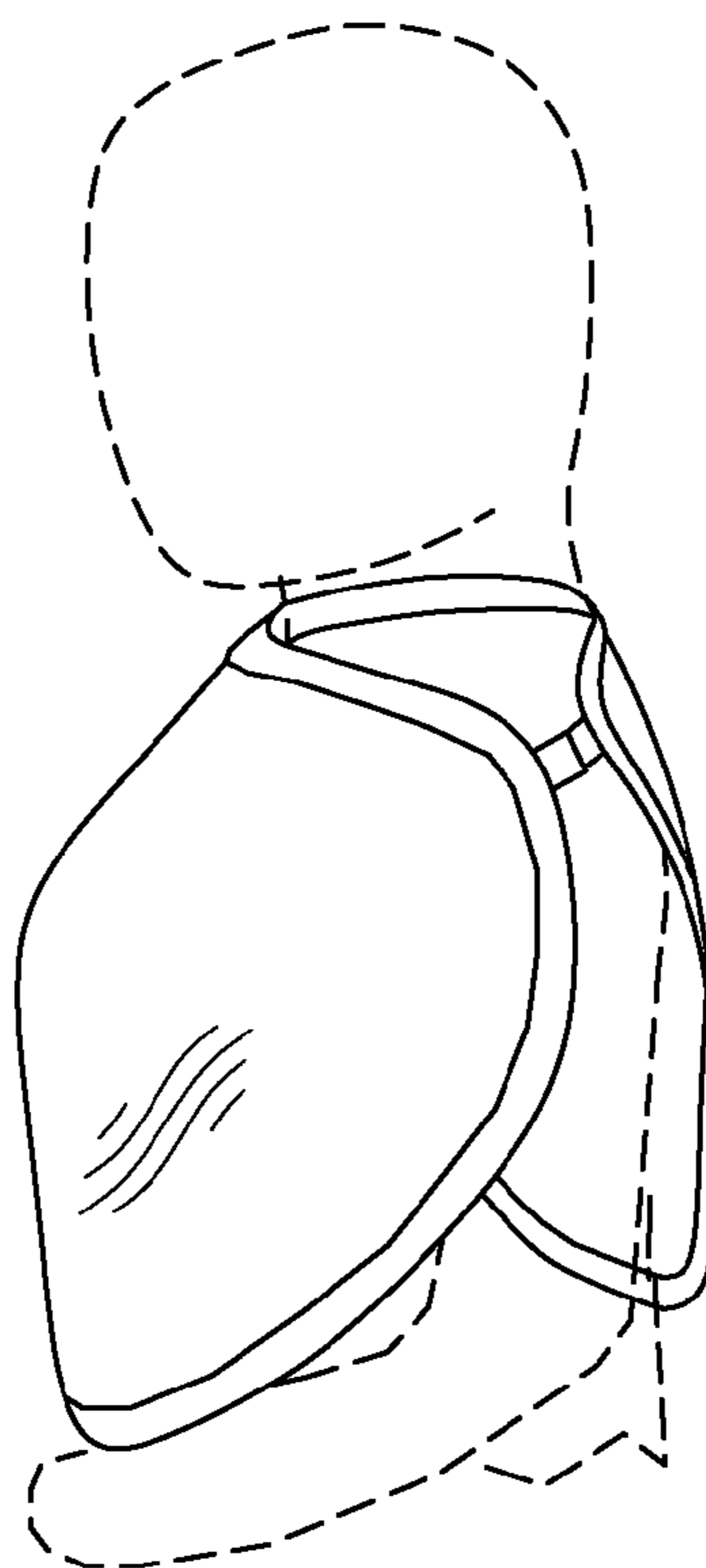

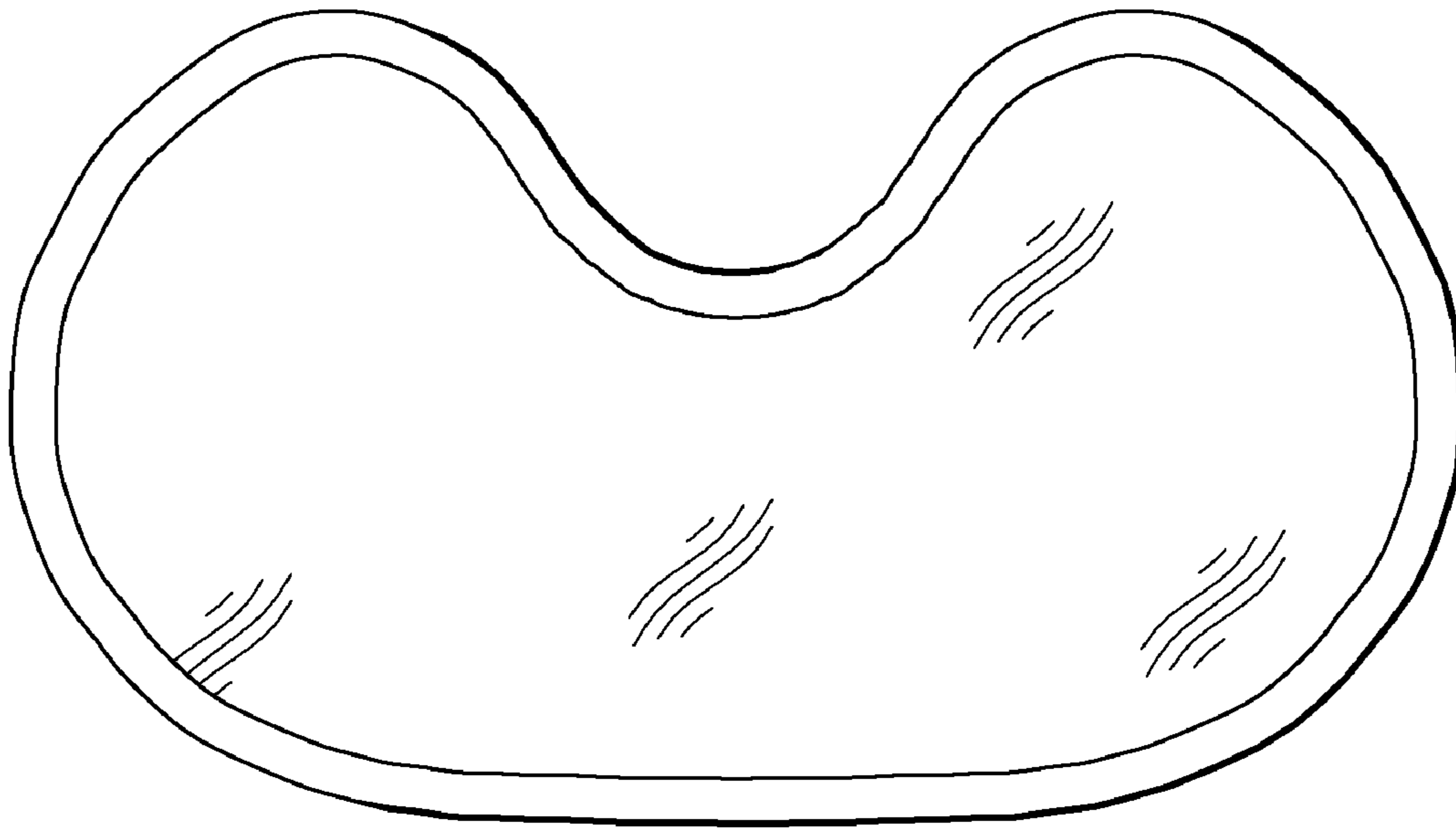

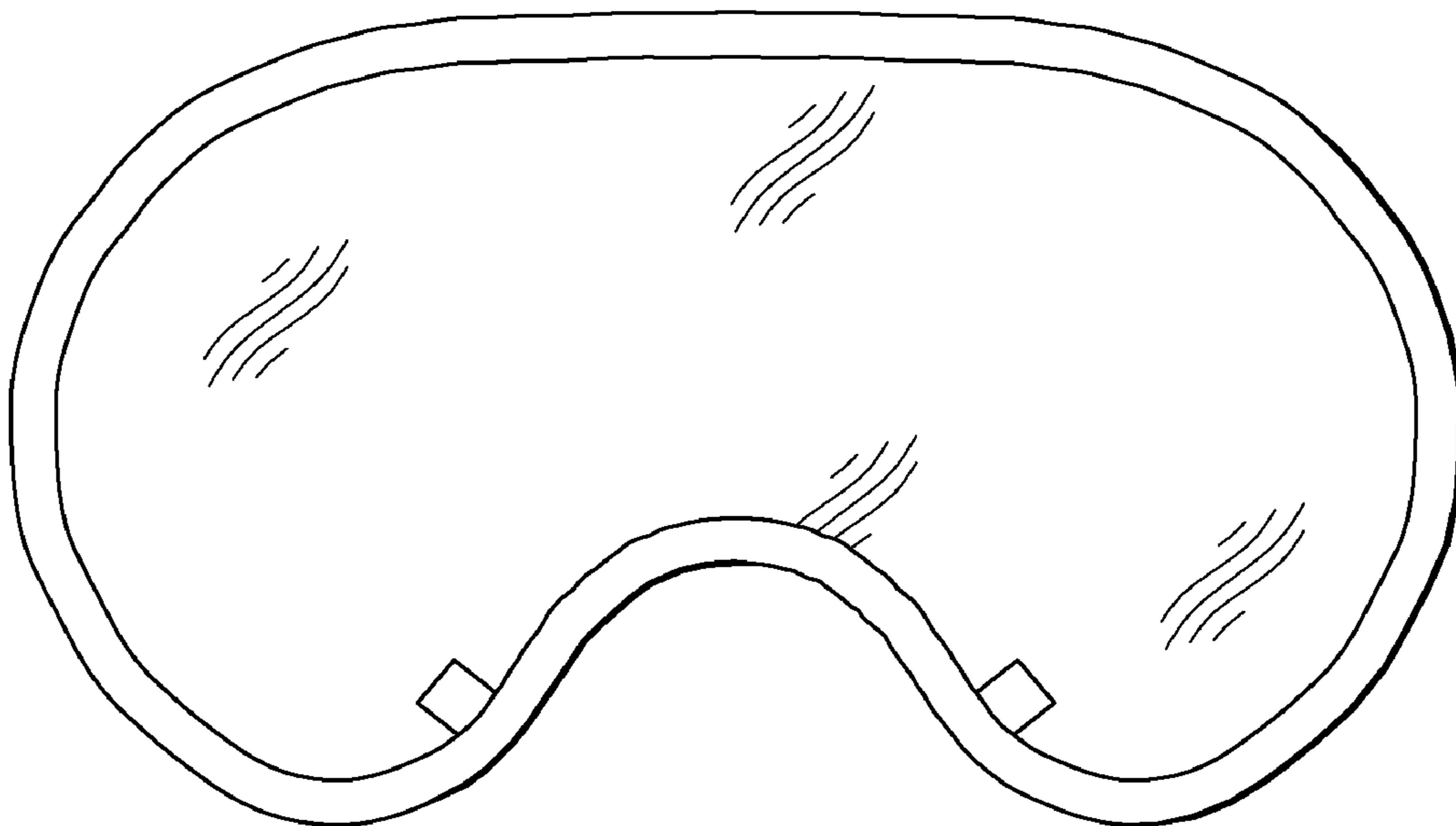

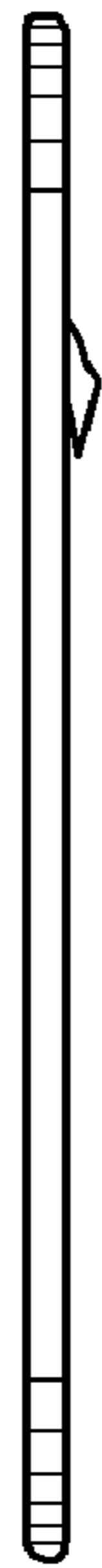

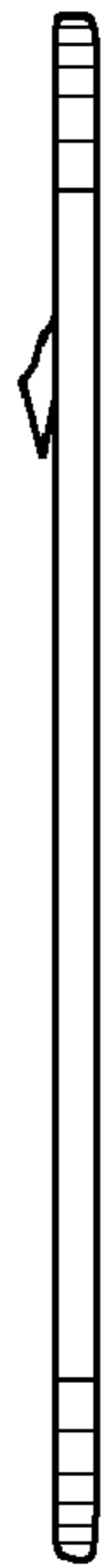

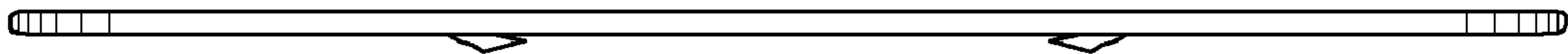
