DESCRIPTION

FIG. 1 is a front perspective view of a combination security pack and cover, shown in the combined condition, showing my new design;

FIG. 11 is a right side elevational view thereof;

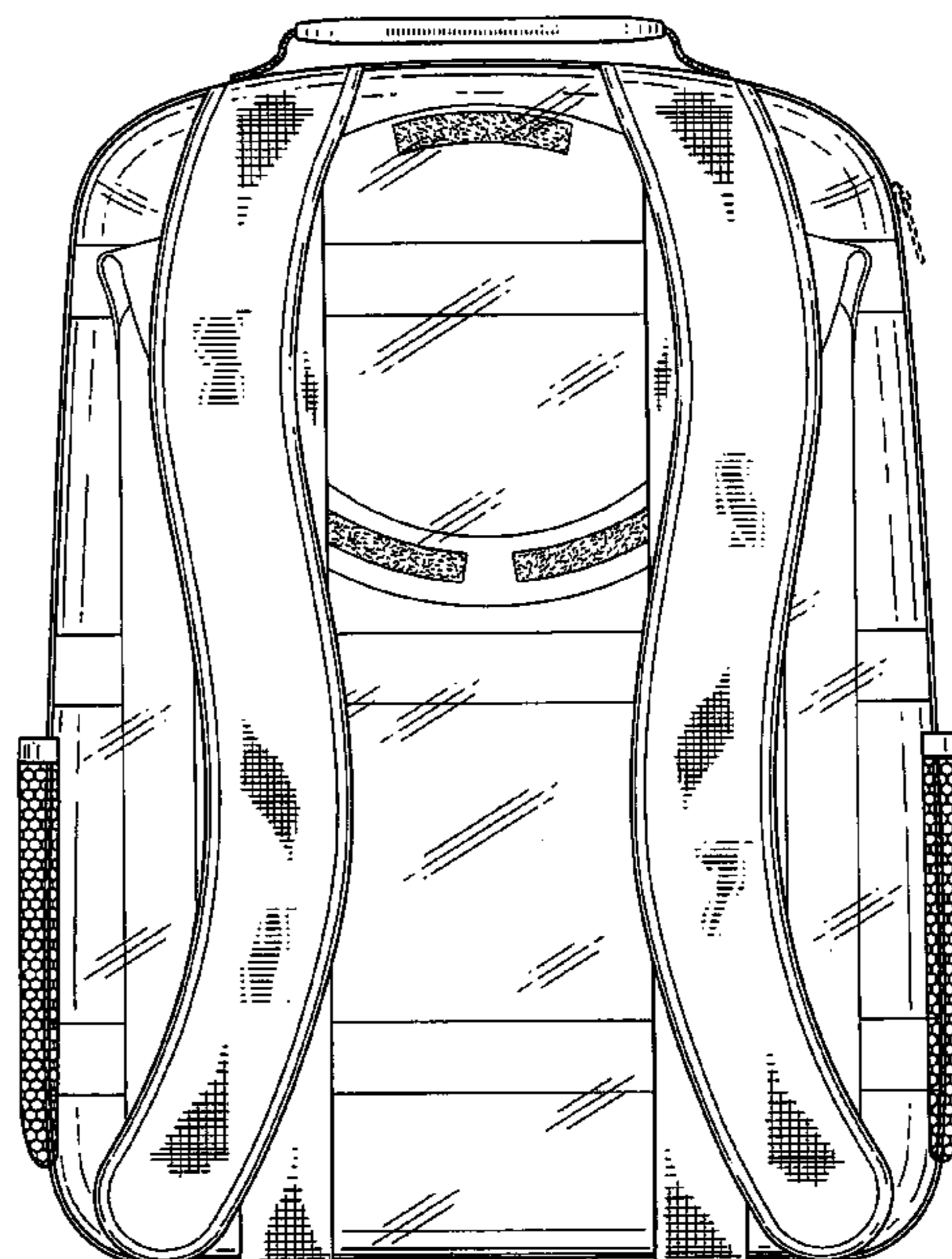
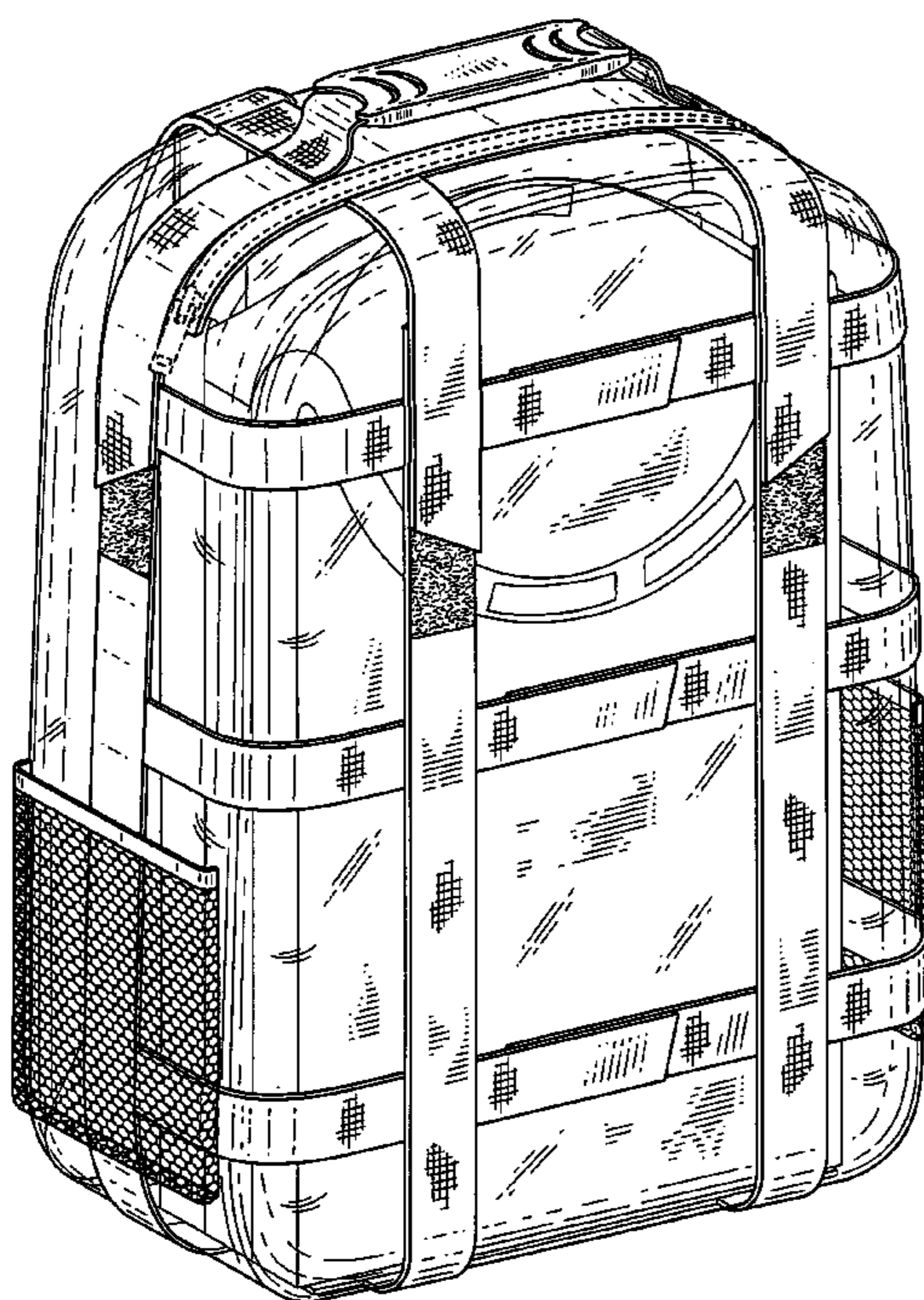
FIG. 12 is a left side elevational view thereof;

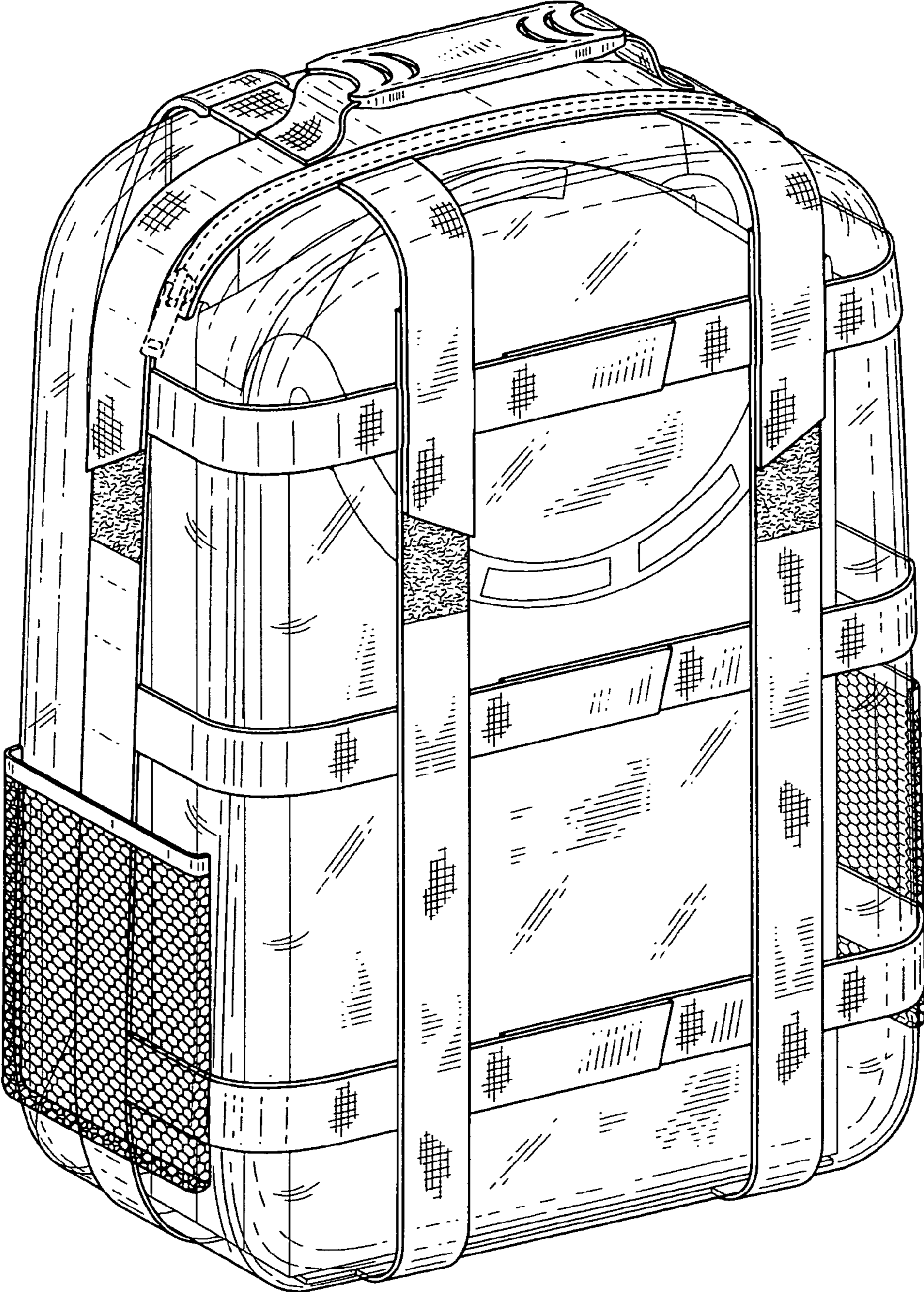

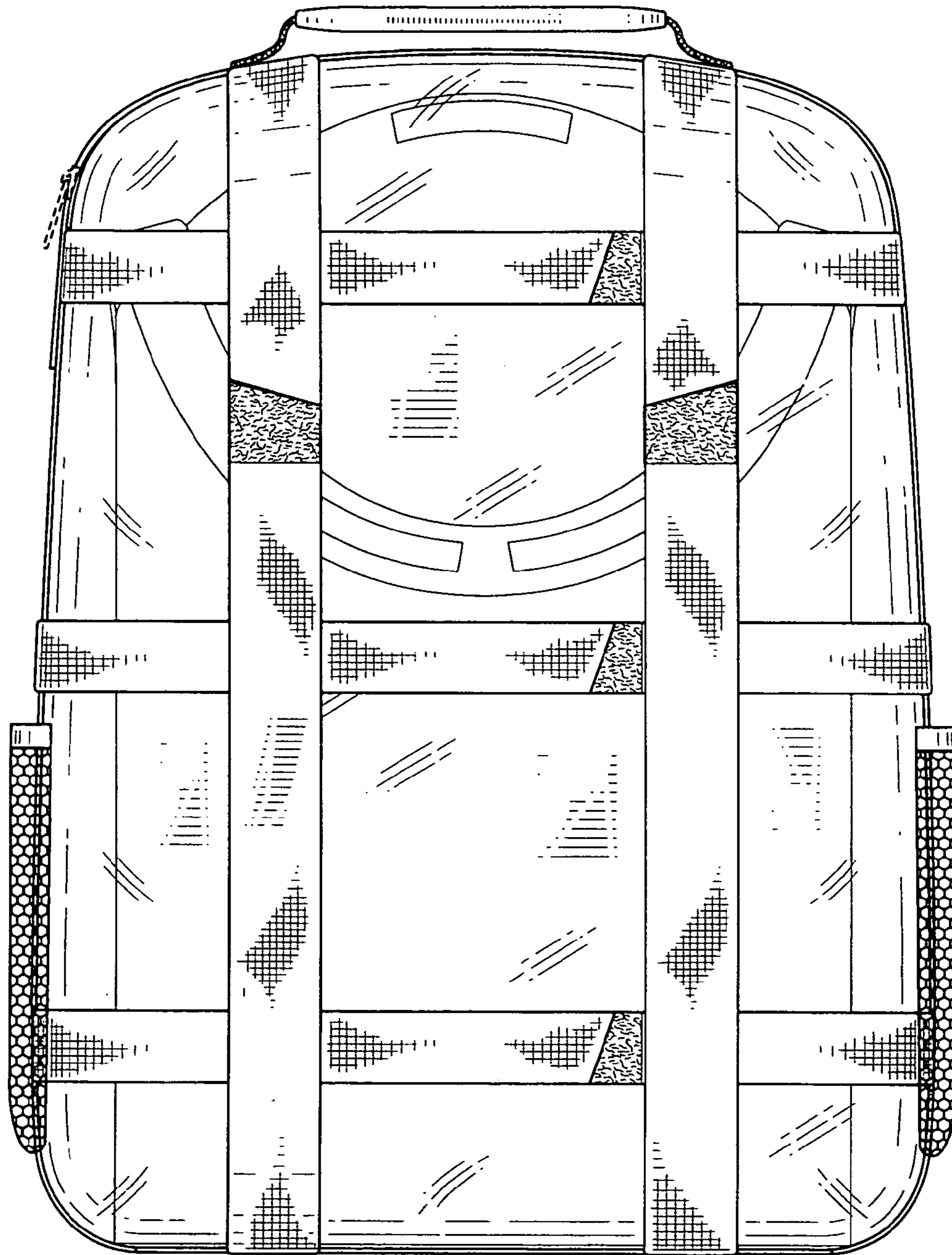

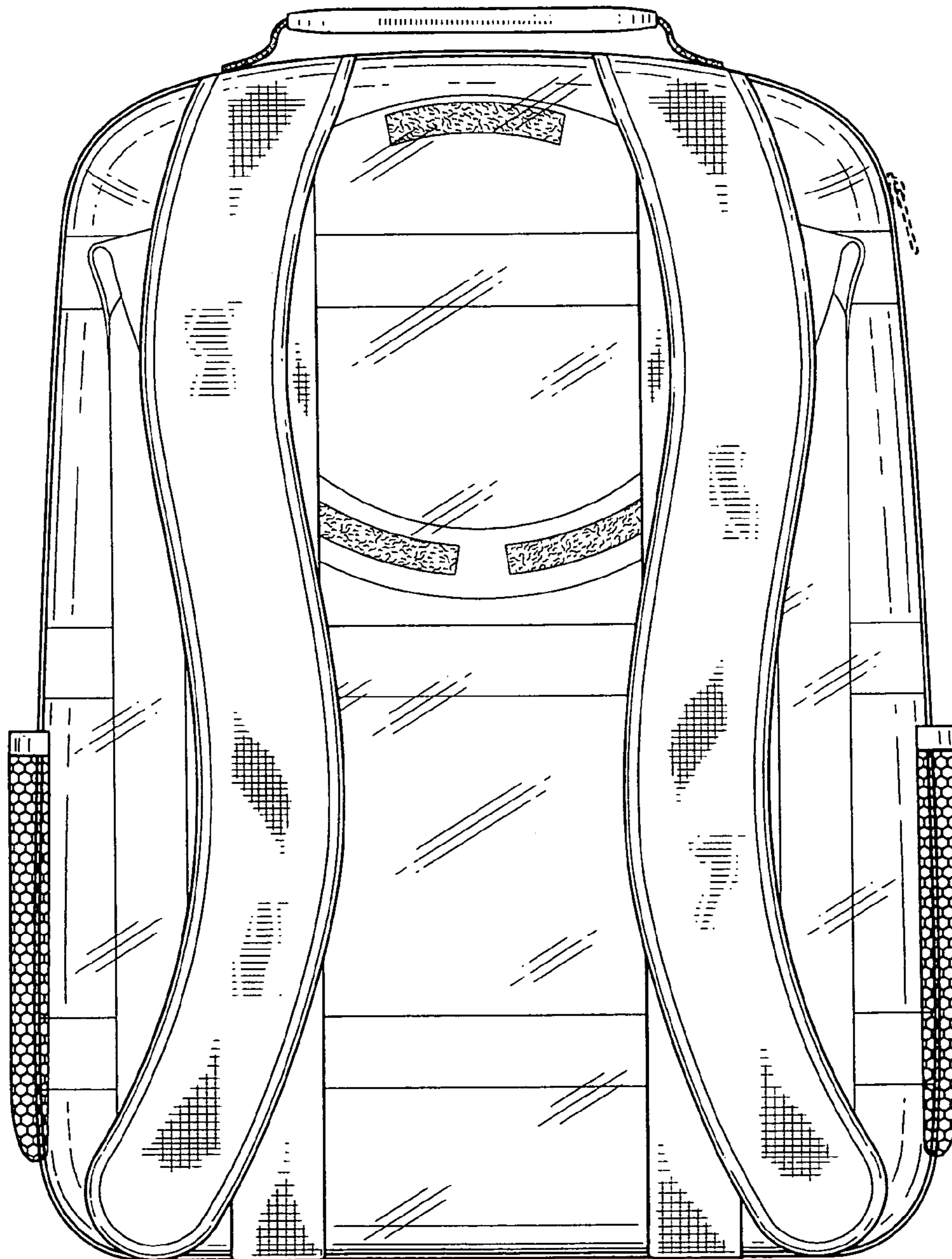

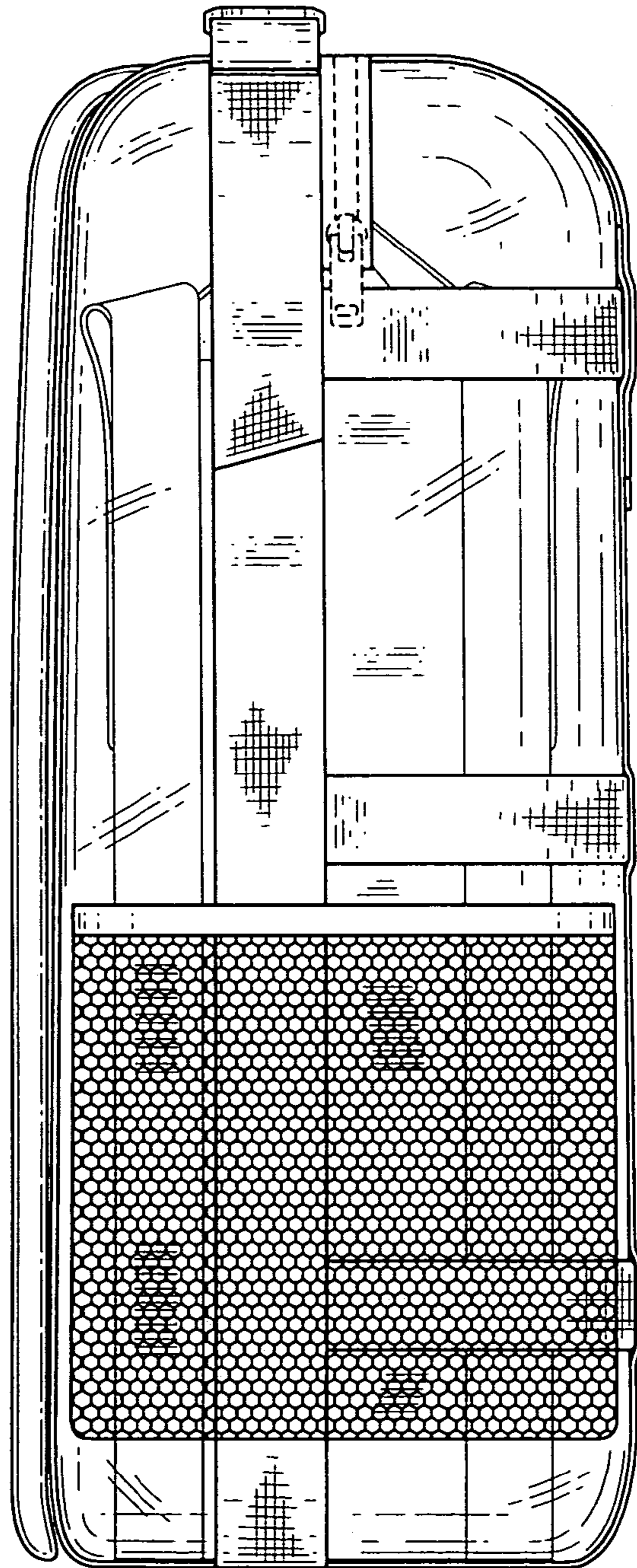

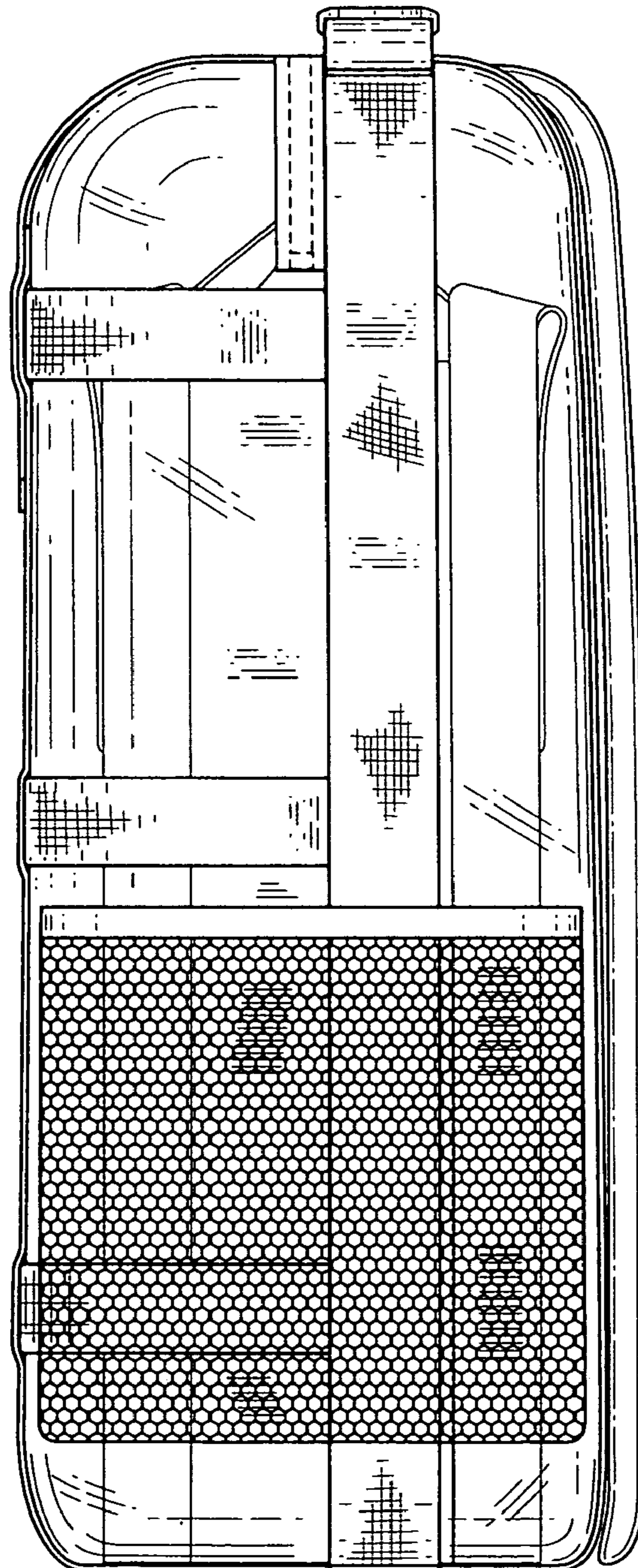

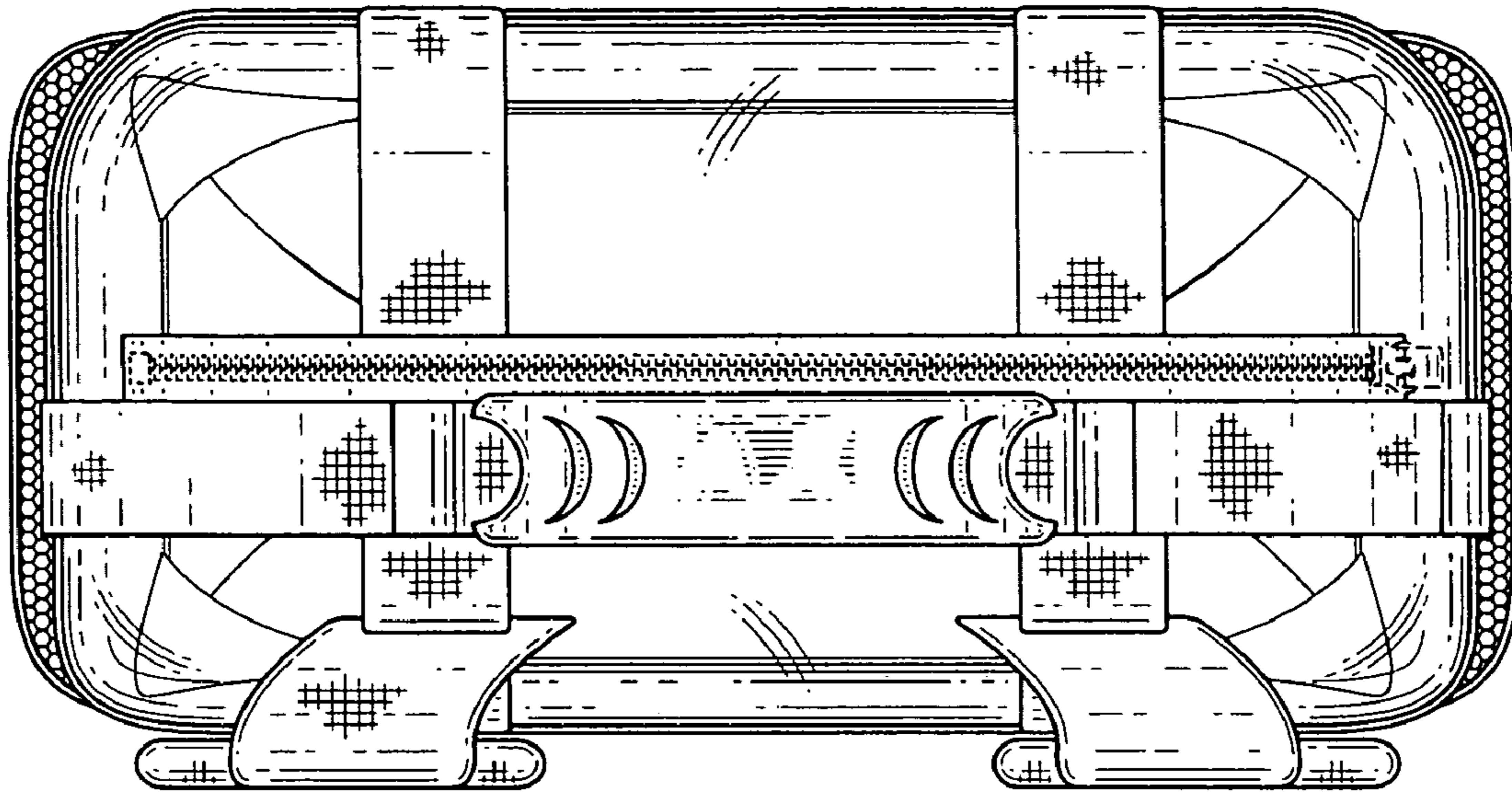

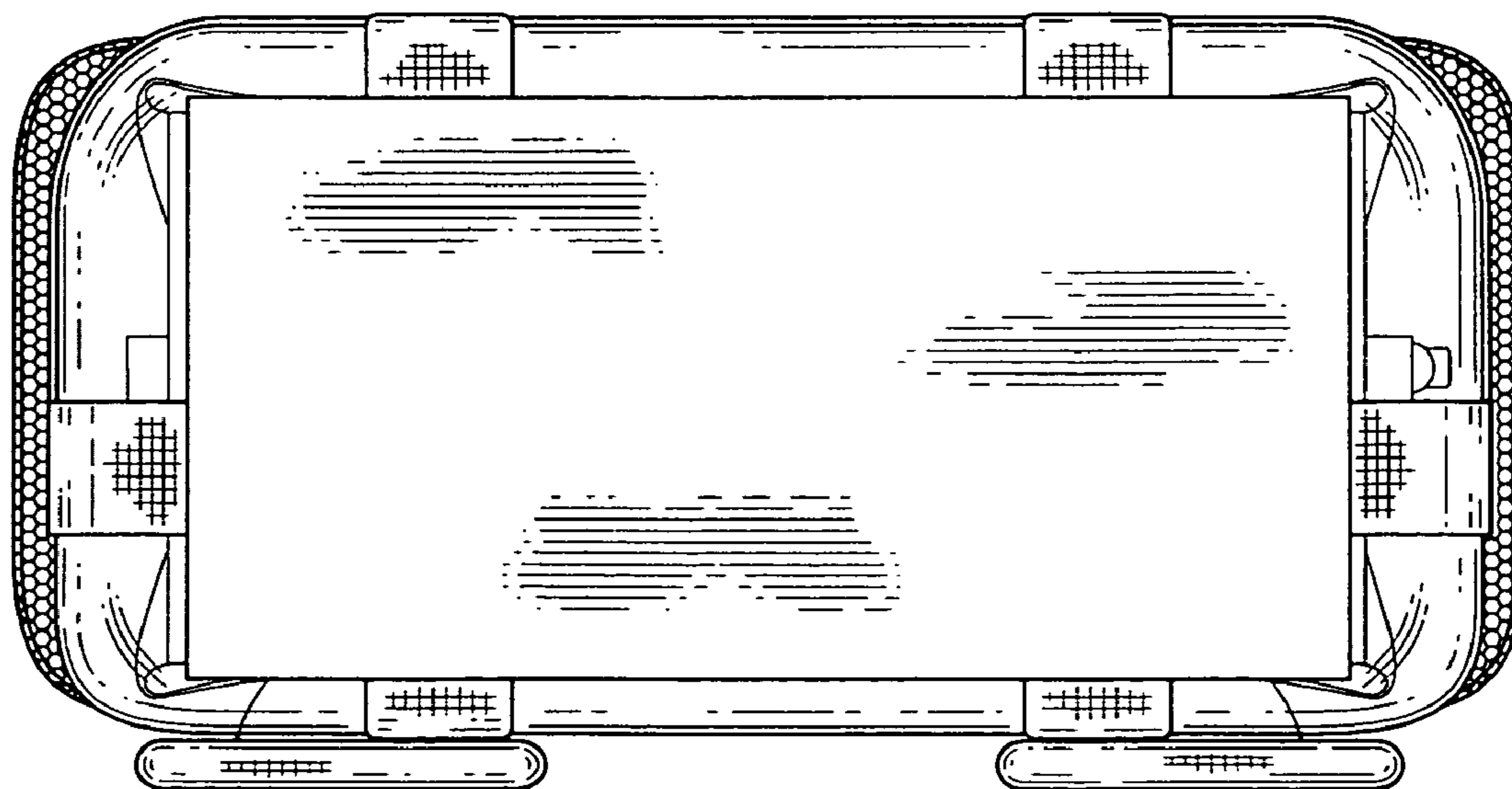

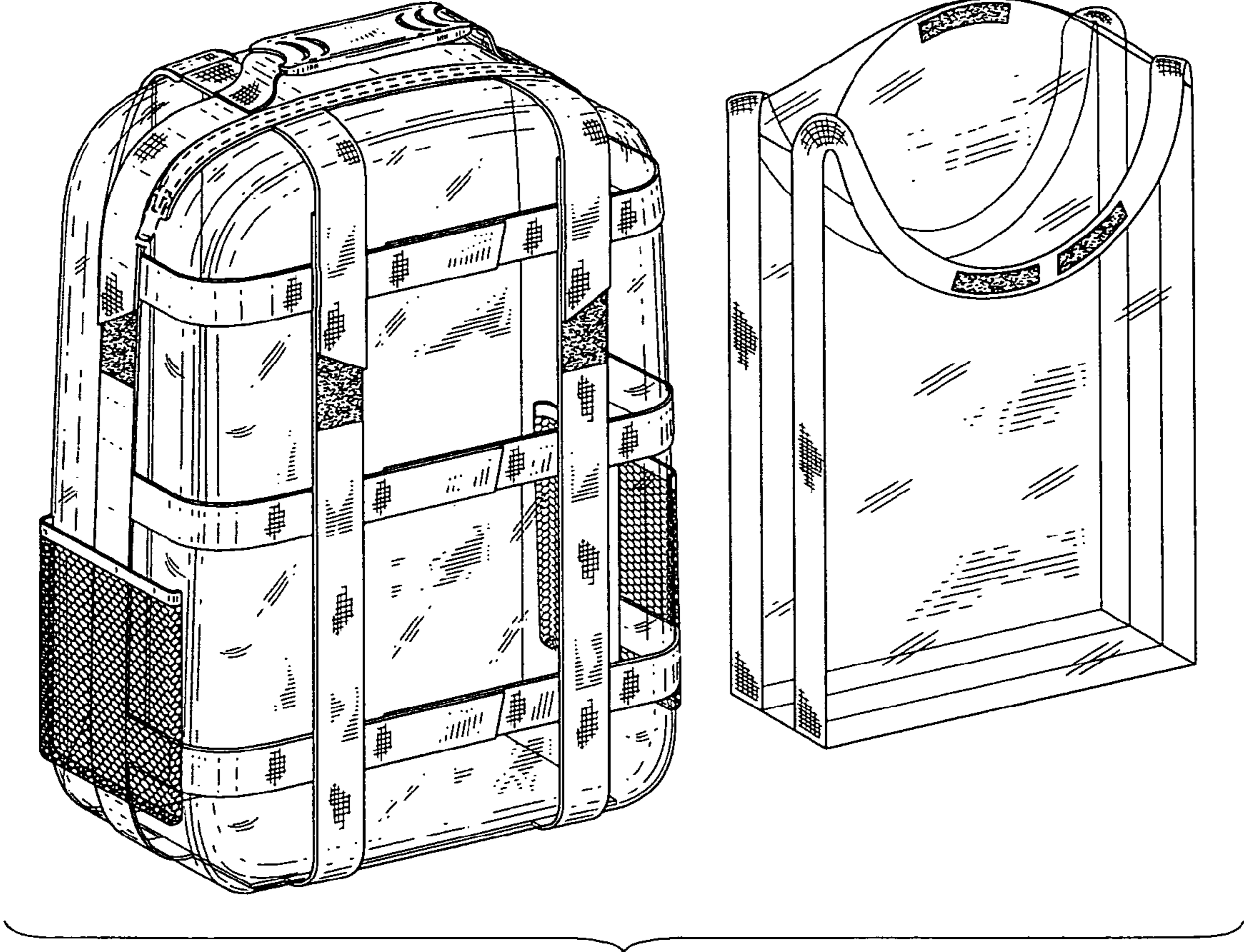

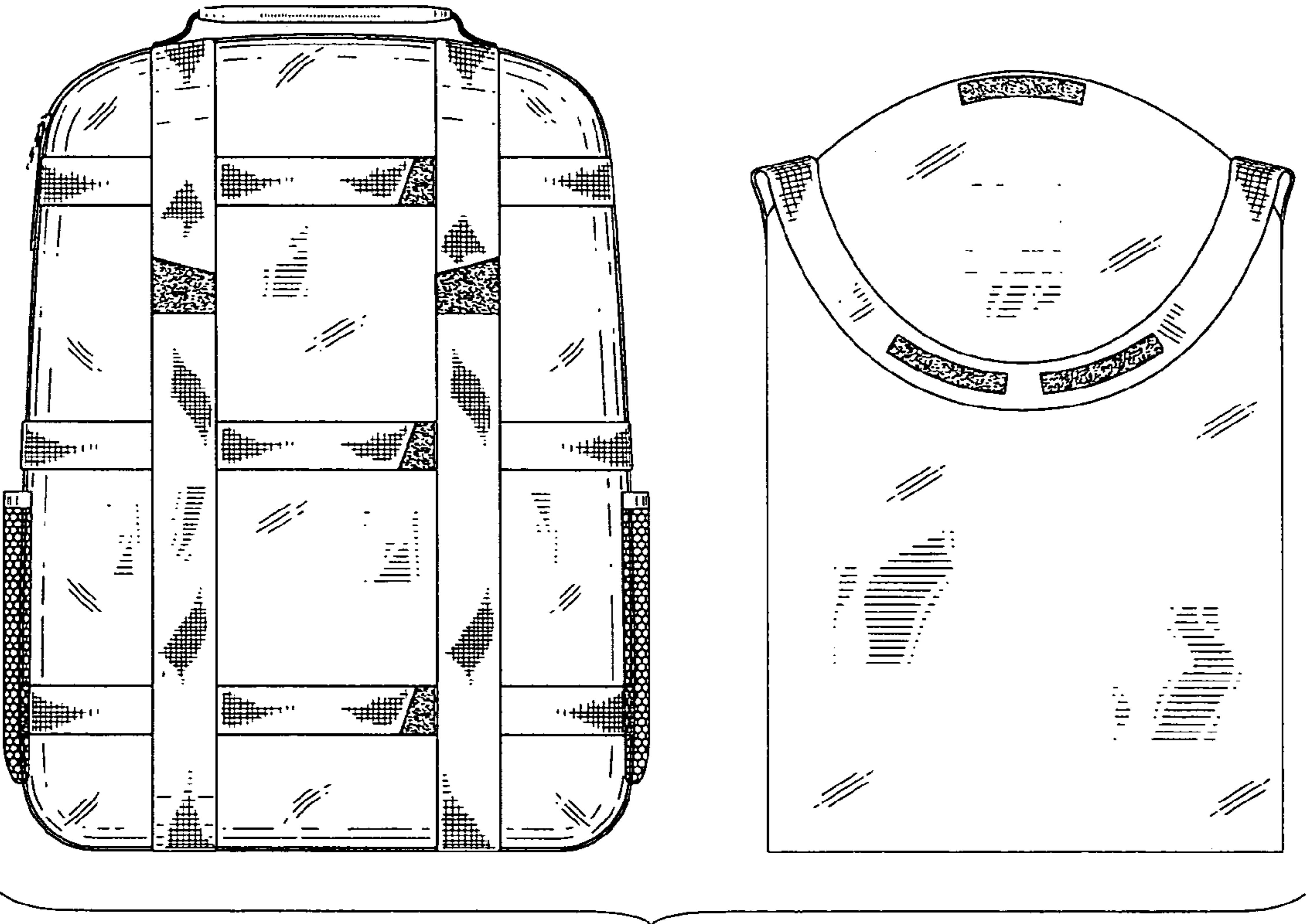

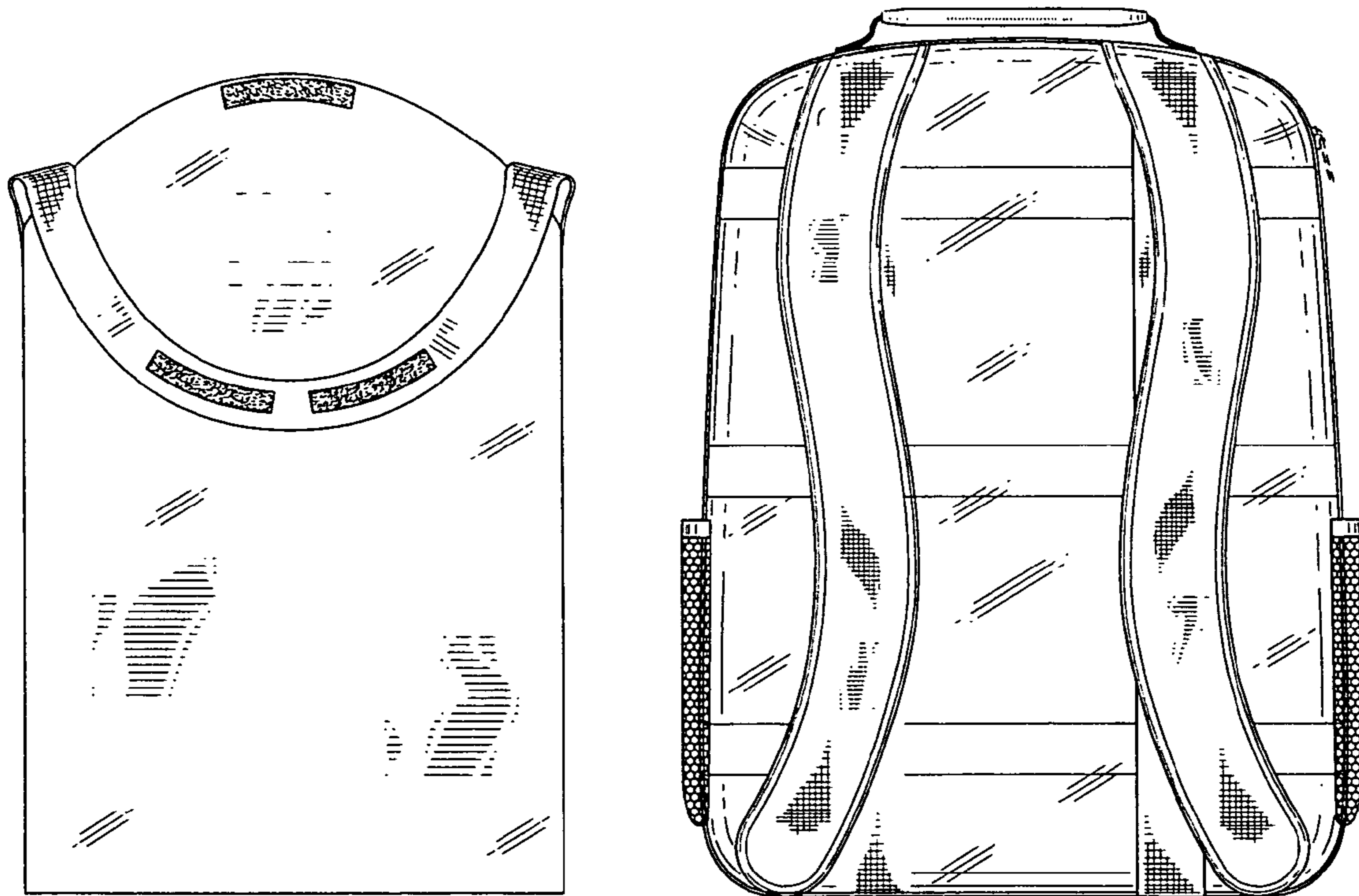

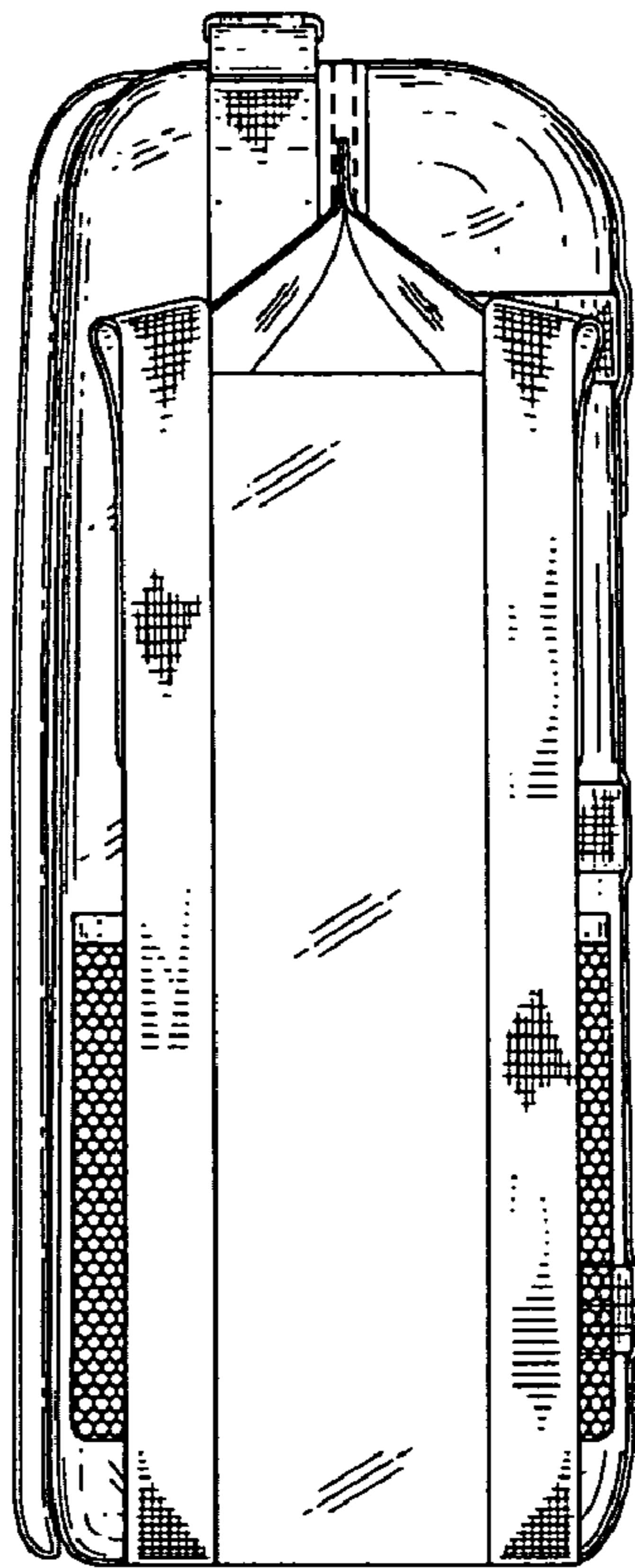

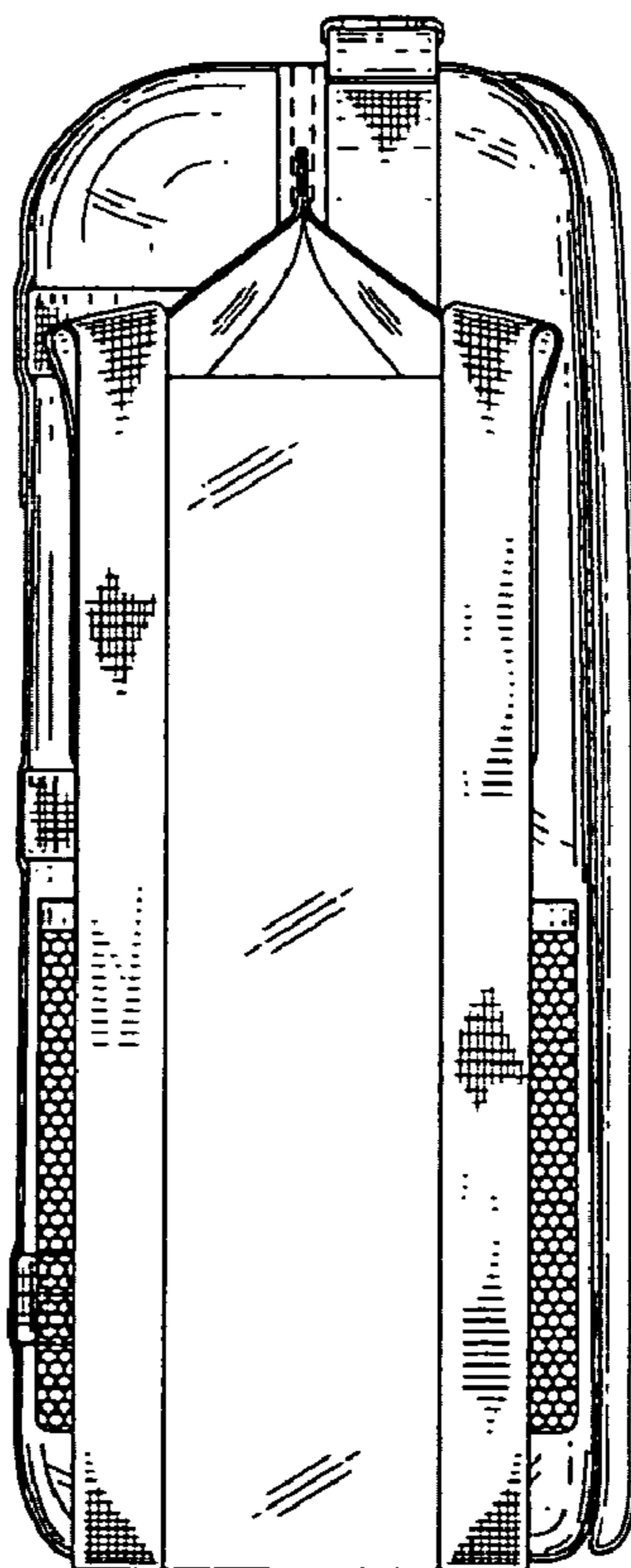

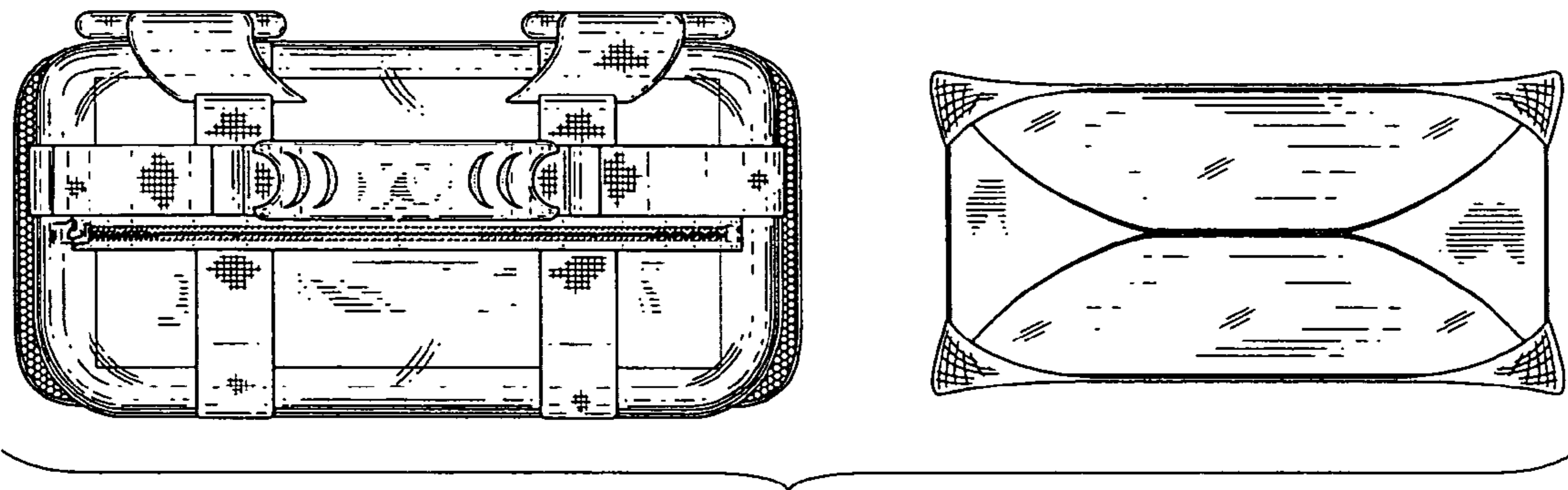

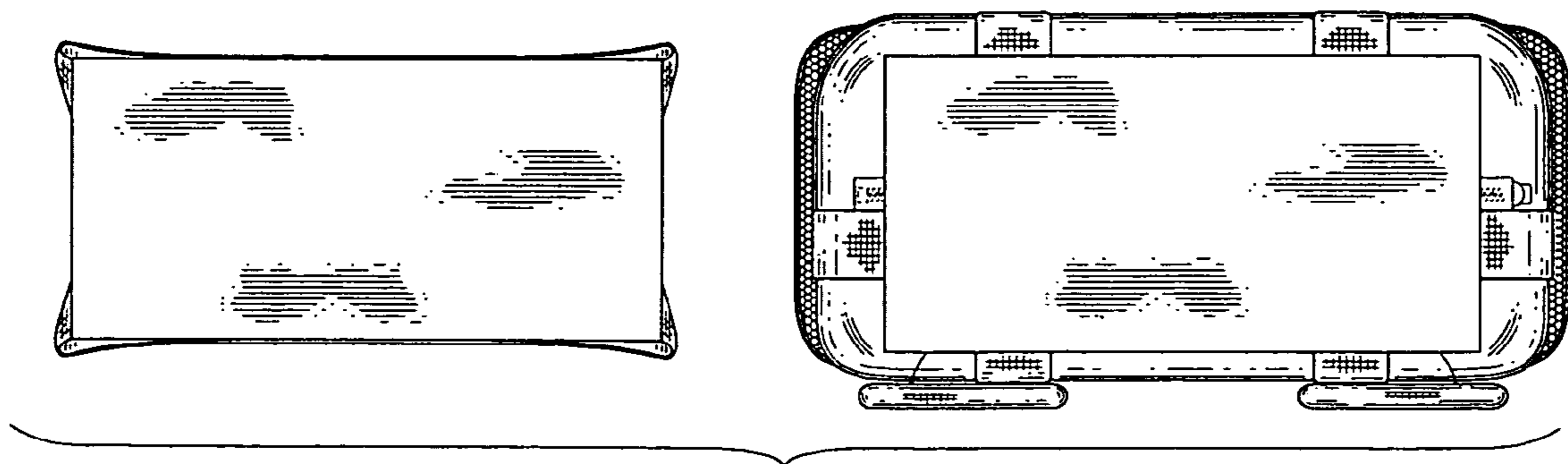
