FIG. 3 is a rear view of the back pack.

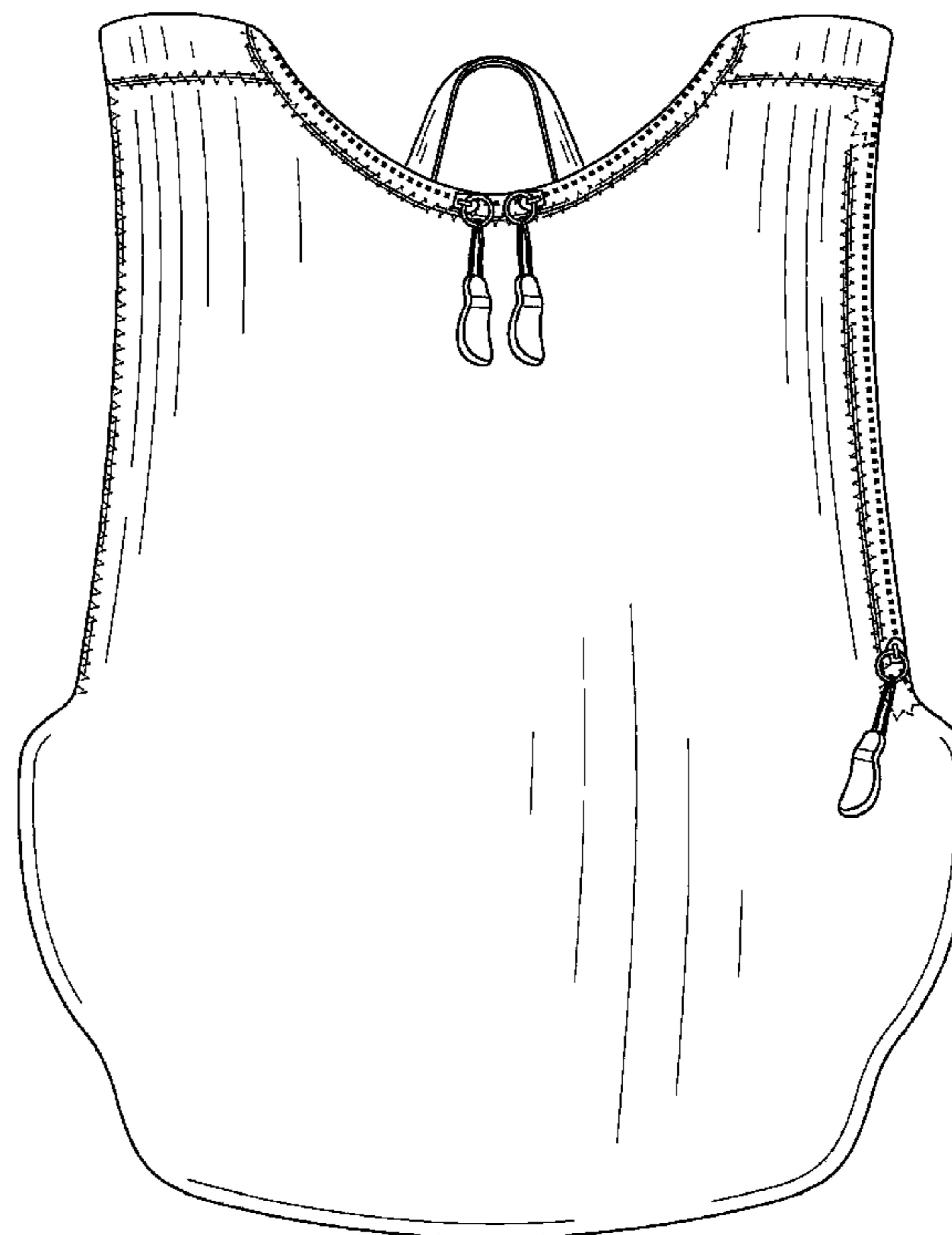
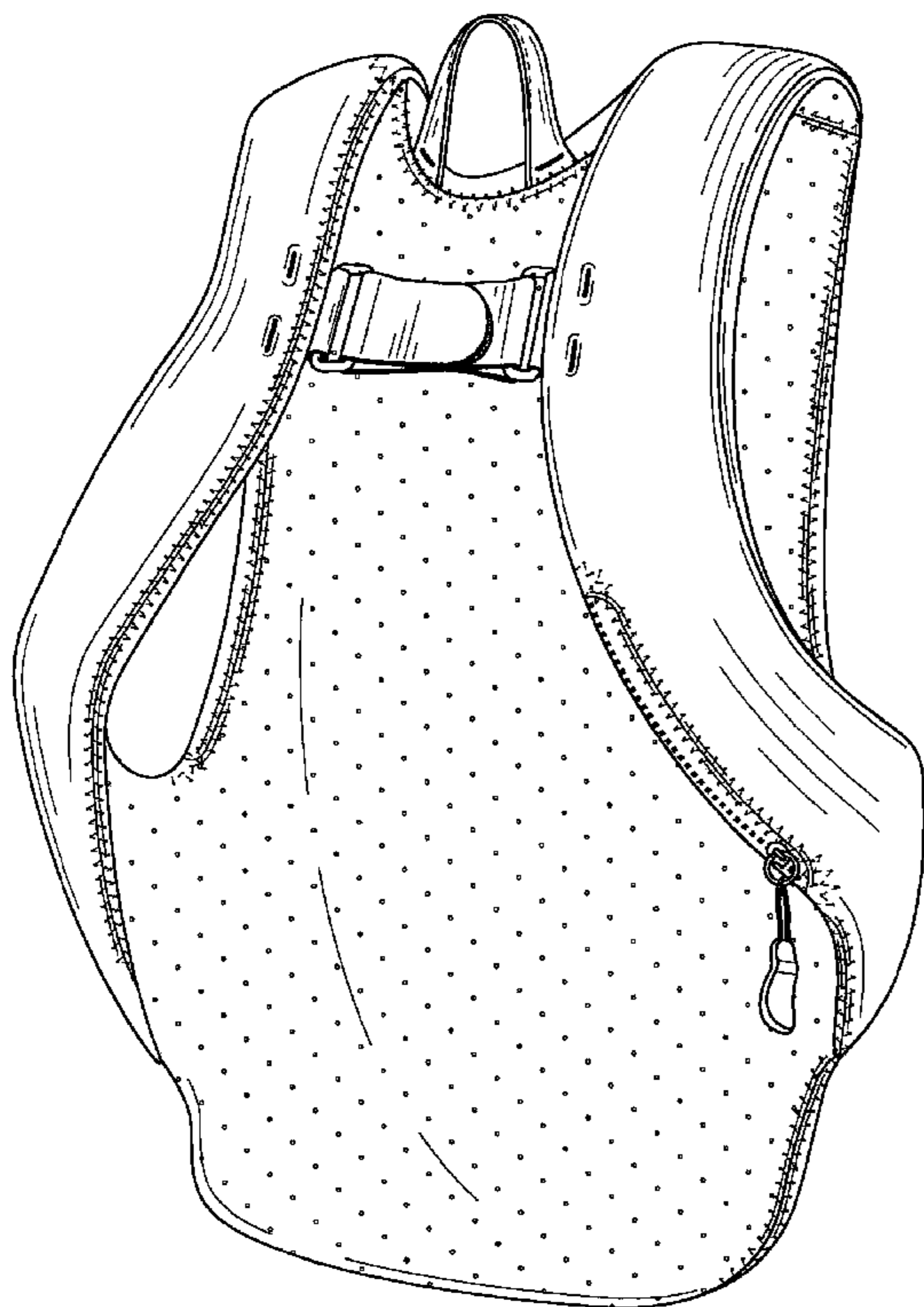
FIG. 4 is a left view of the back pack.

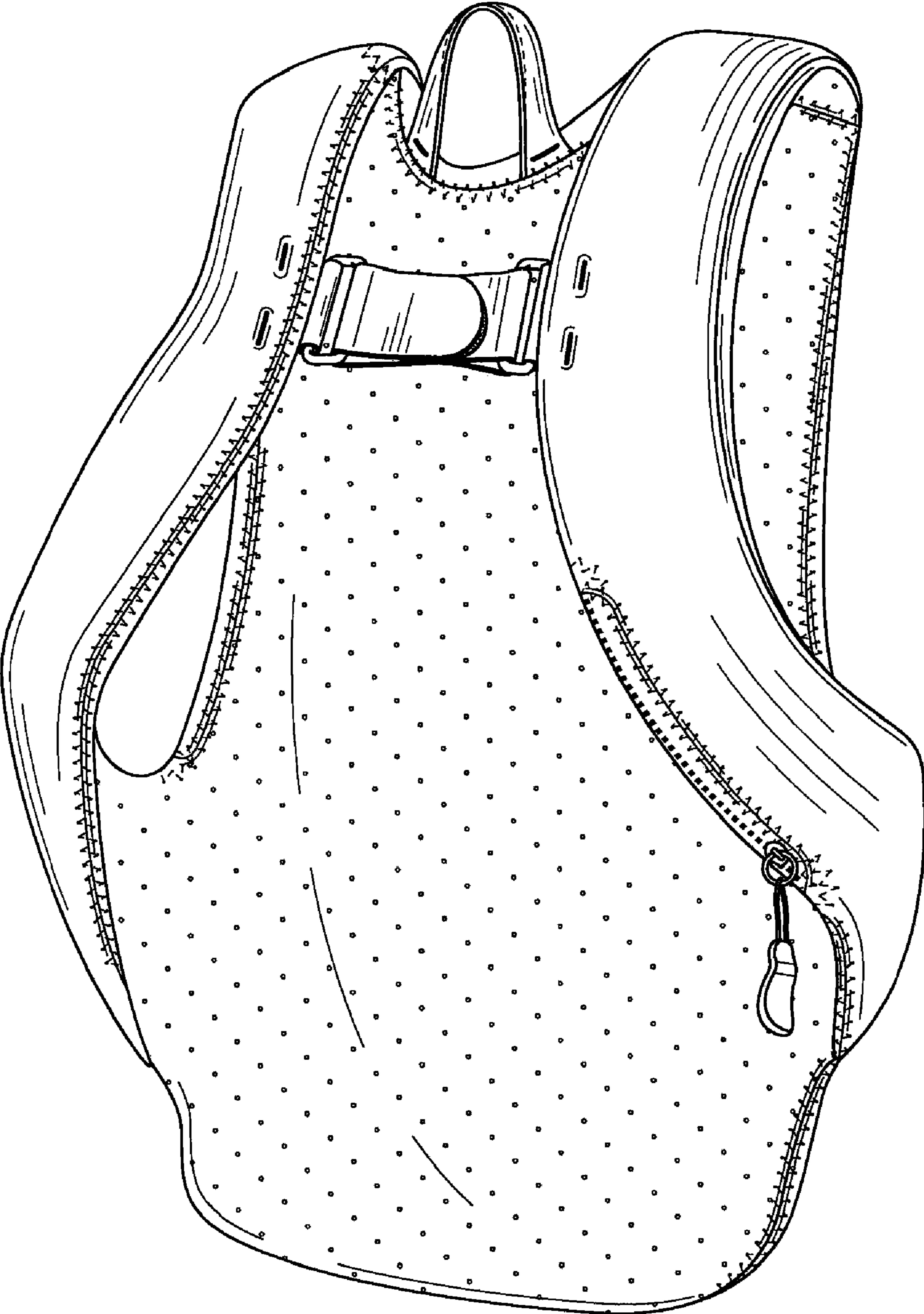

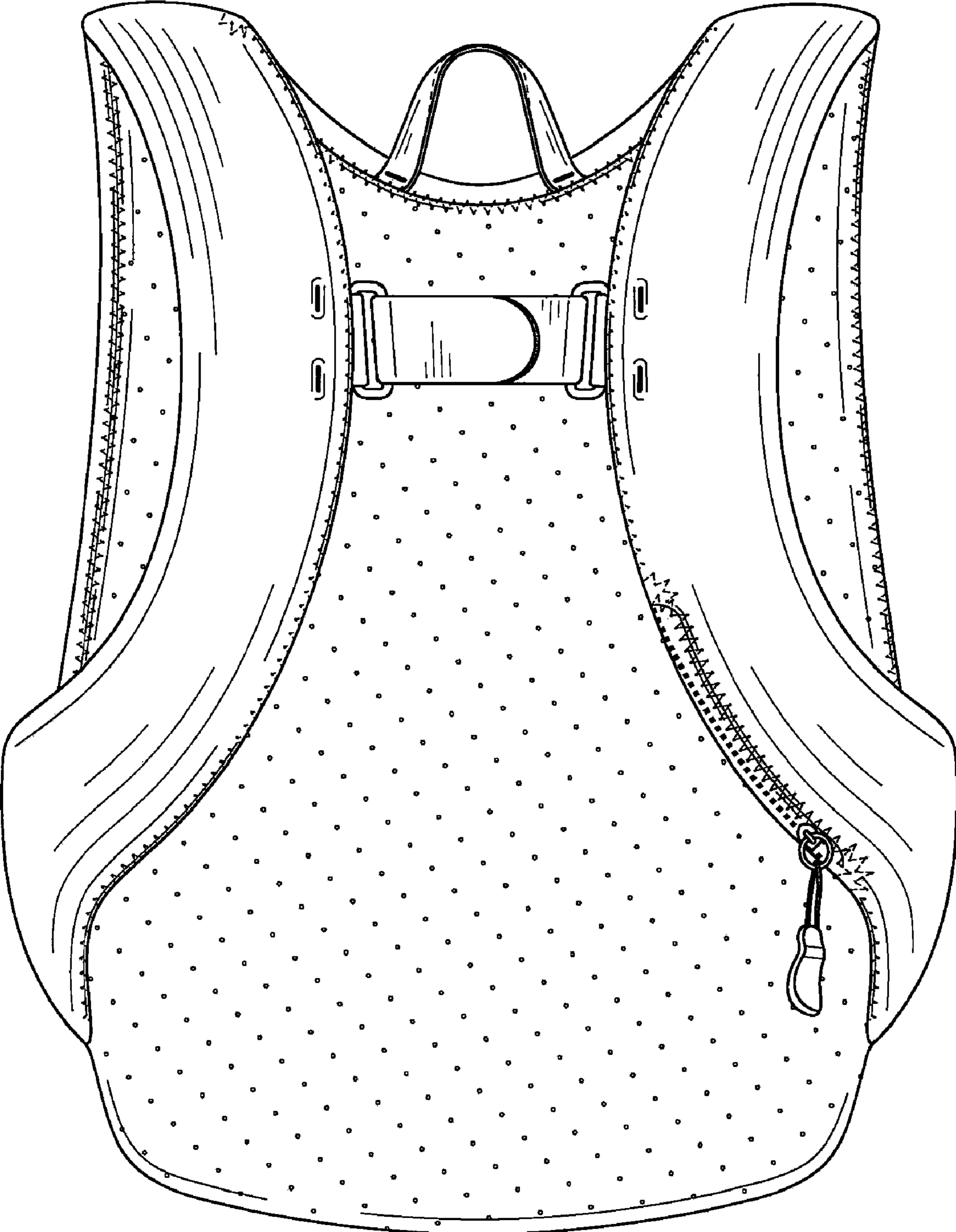

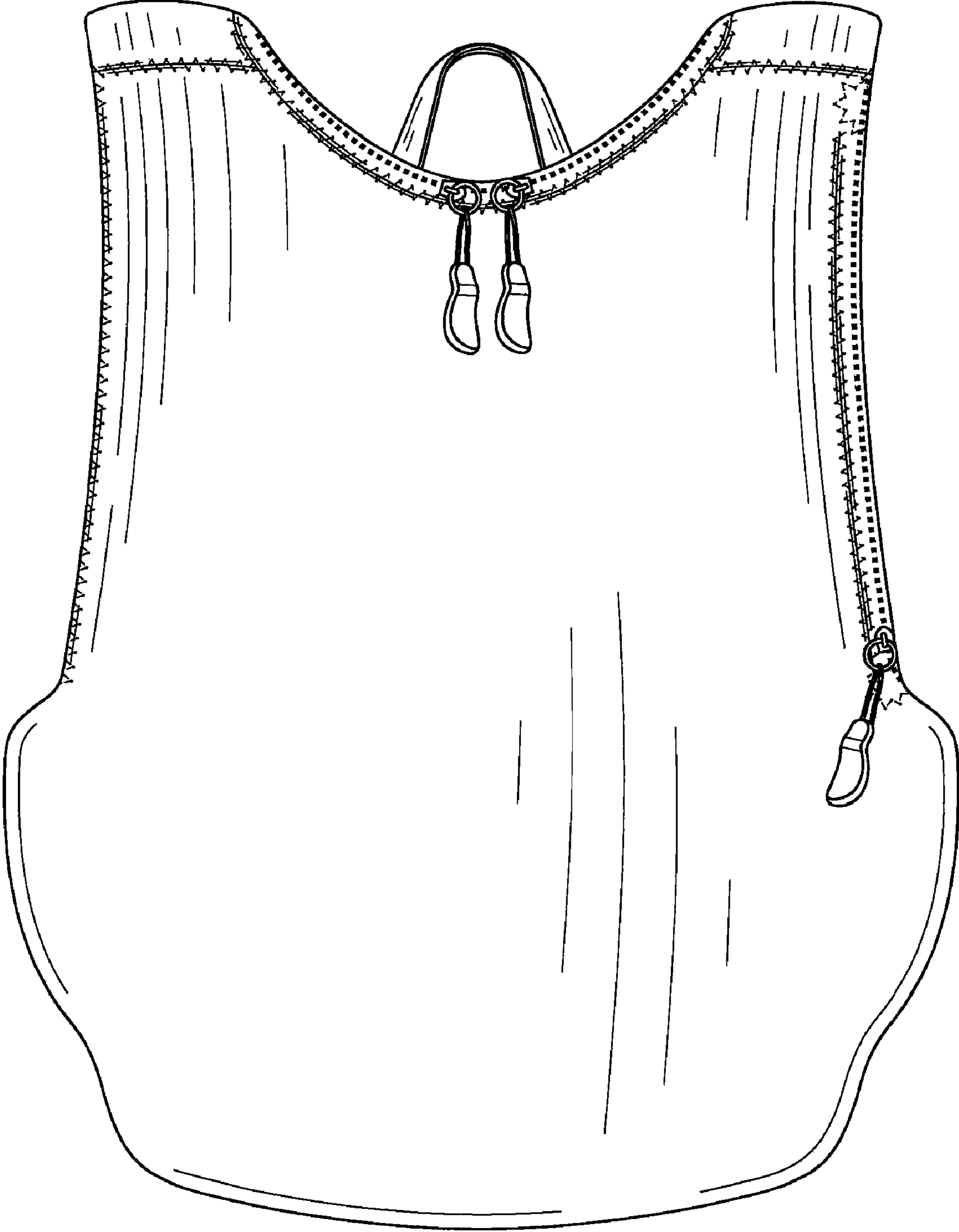

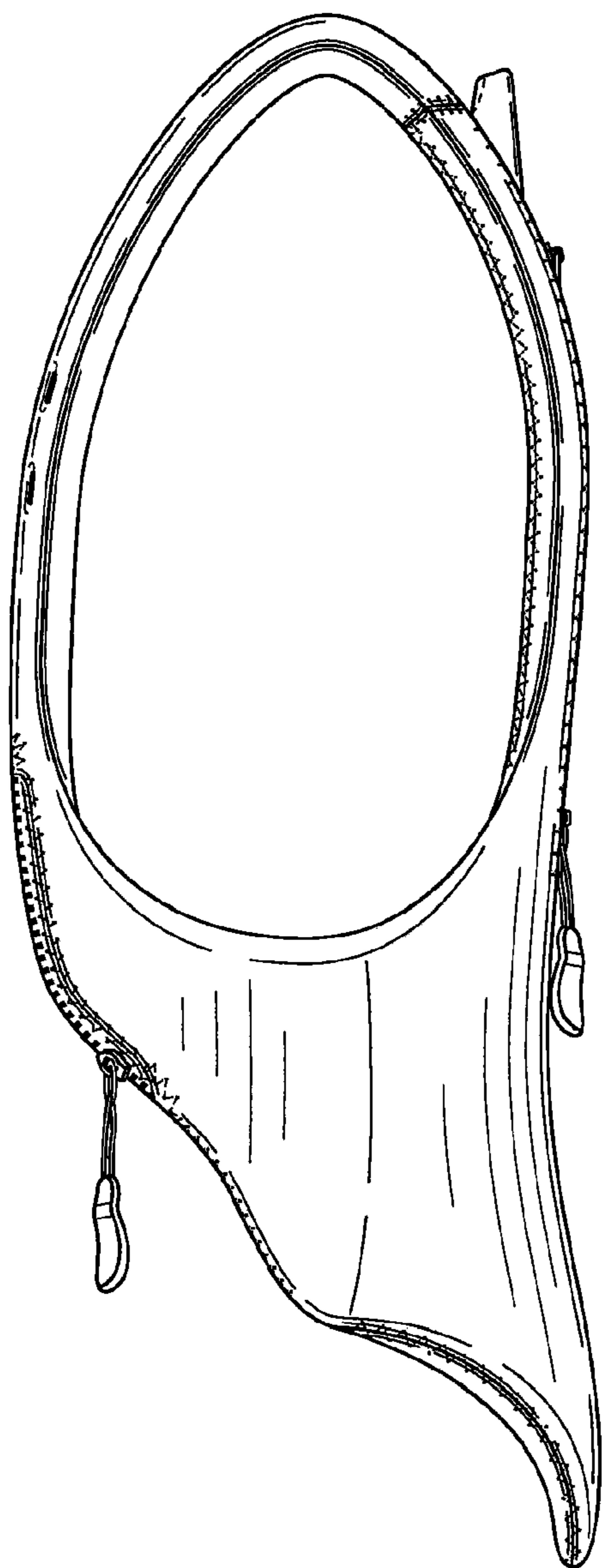

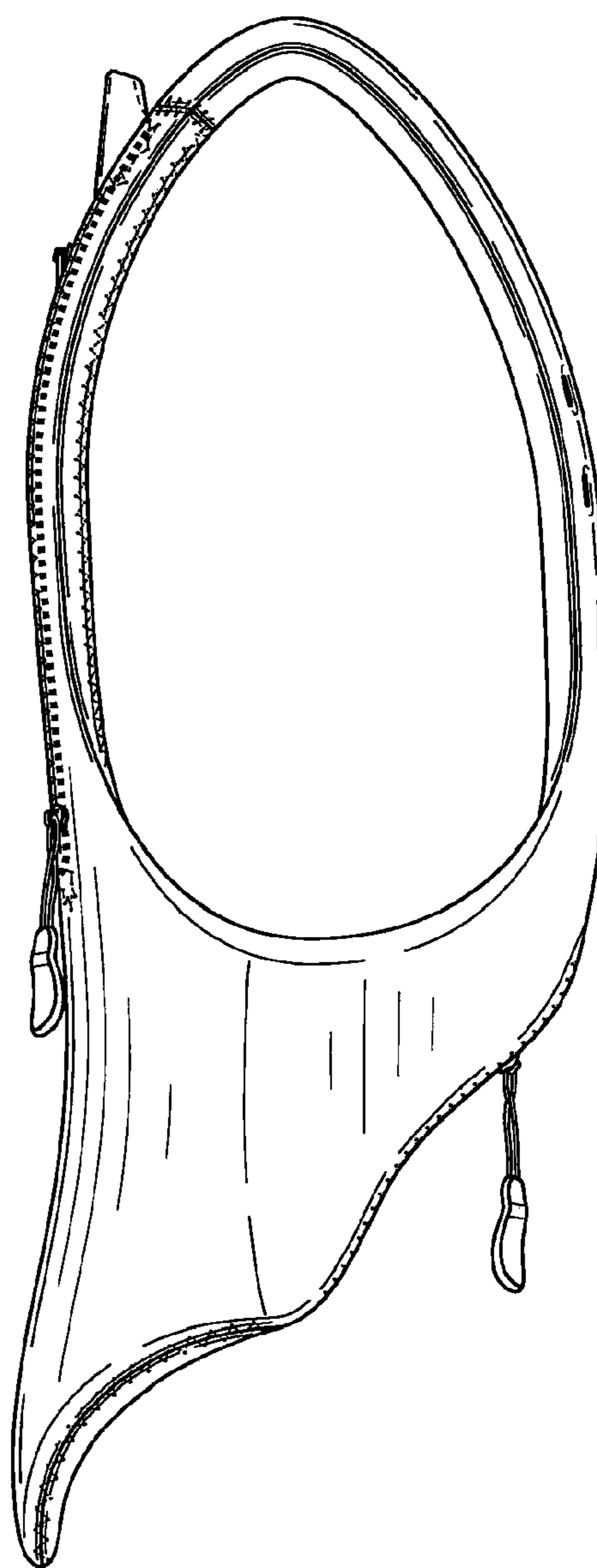

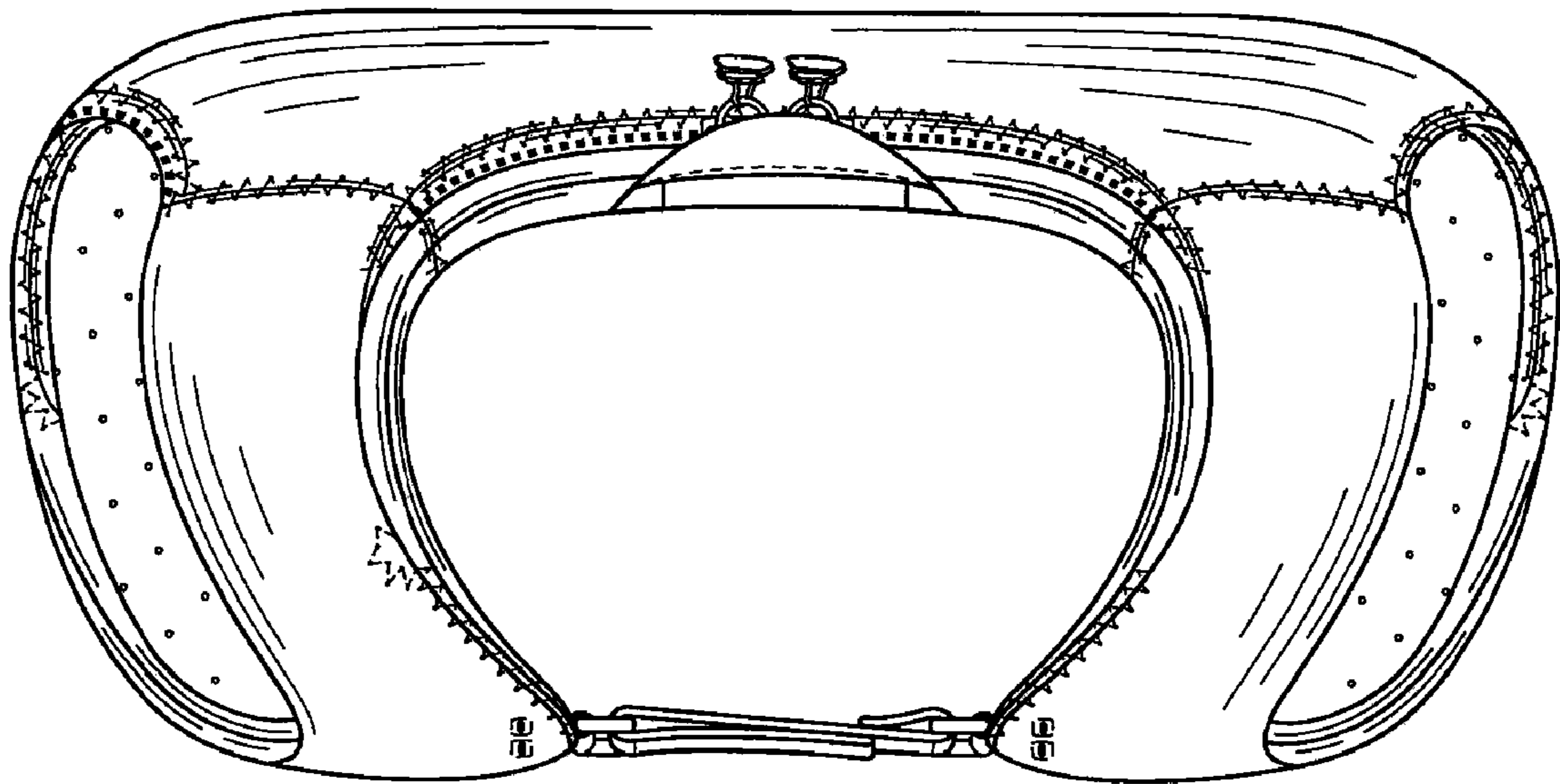

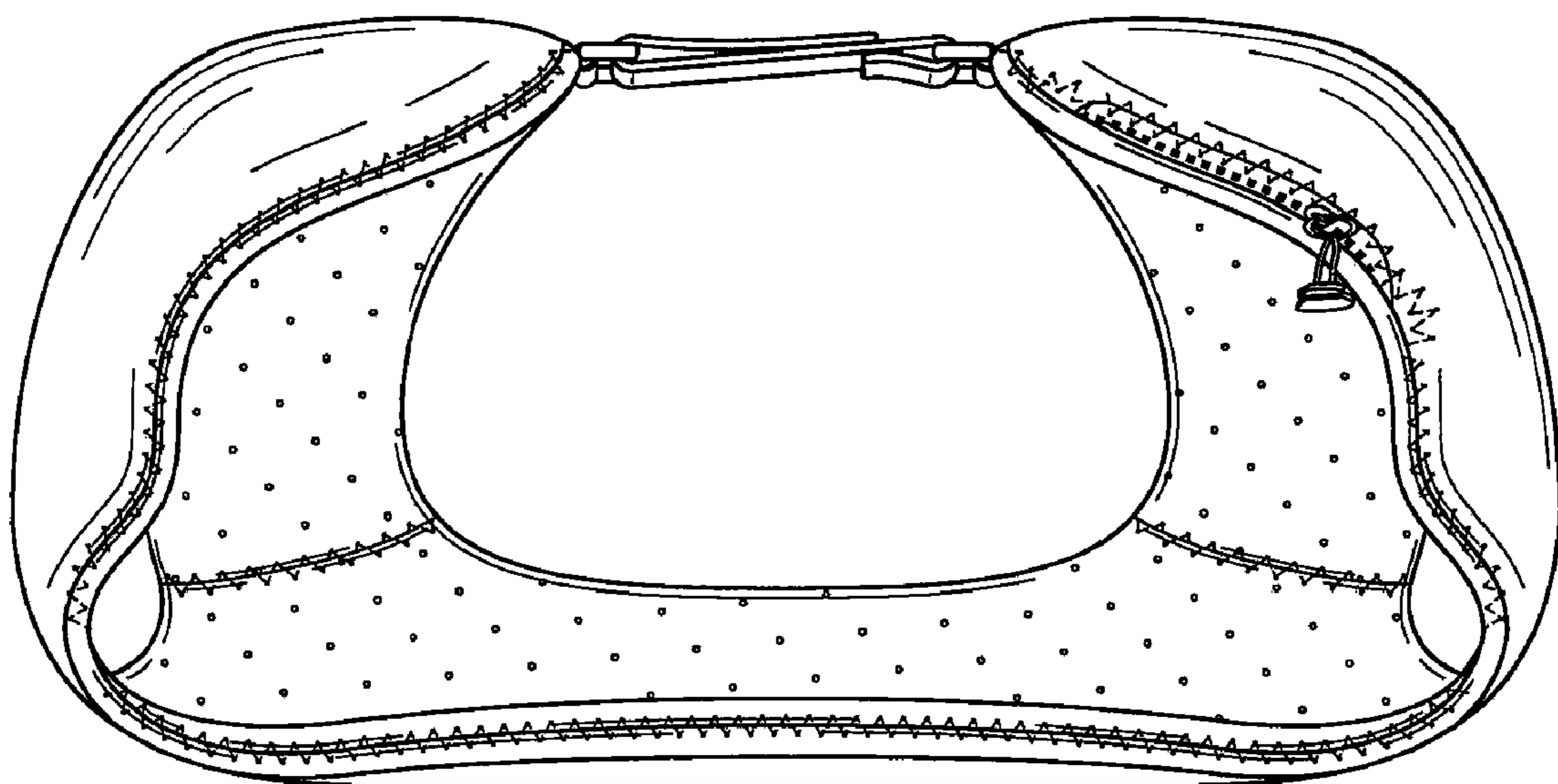
