FIG. 4 is a right view of the computer laptop shoulder bag;

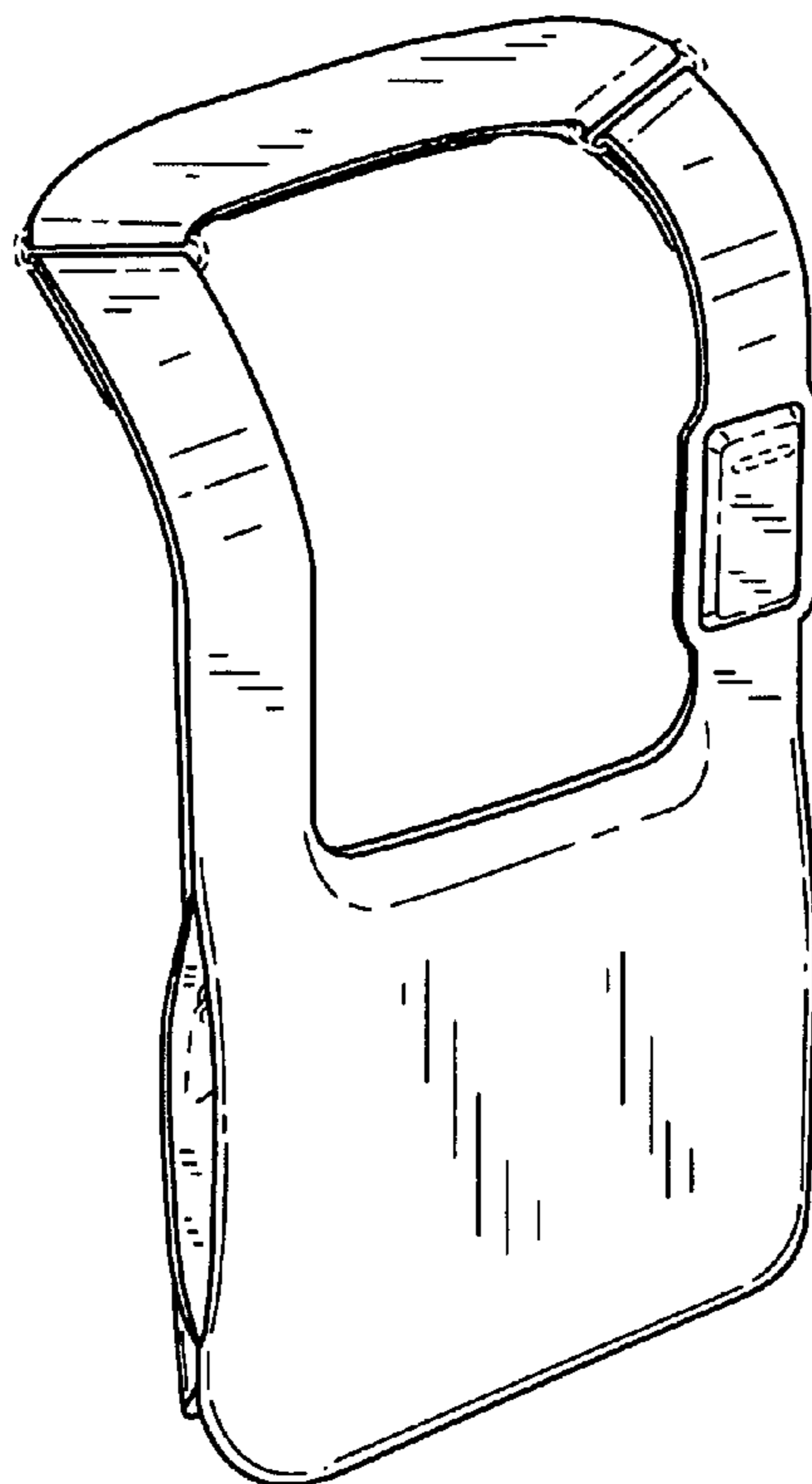
FIG. 5 is a left view of the computer laptop shoulder bag;

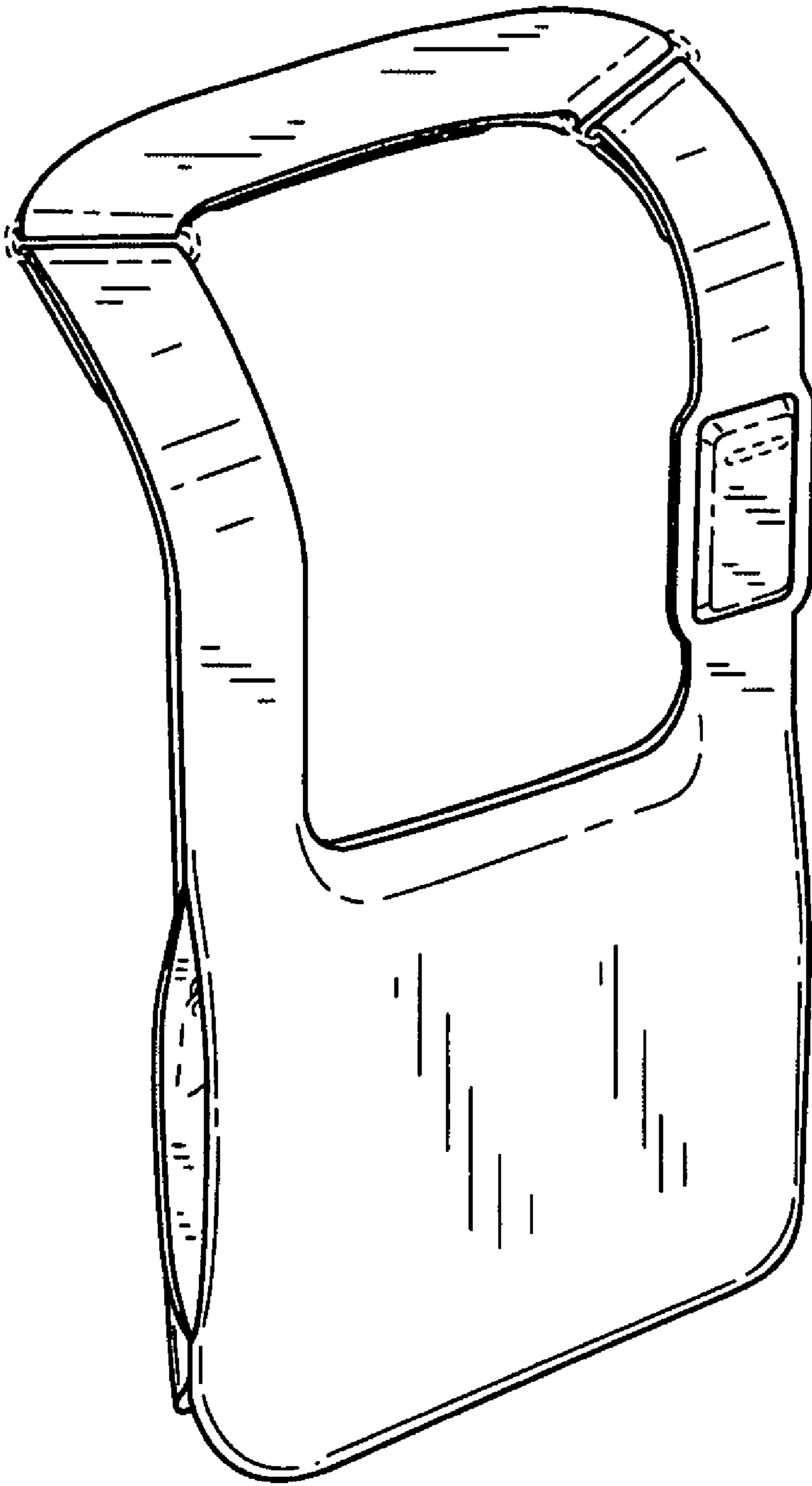

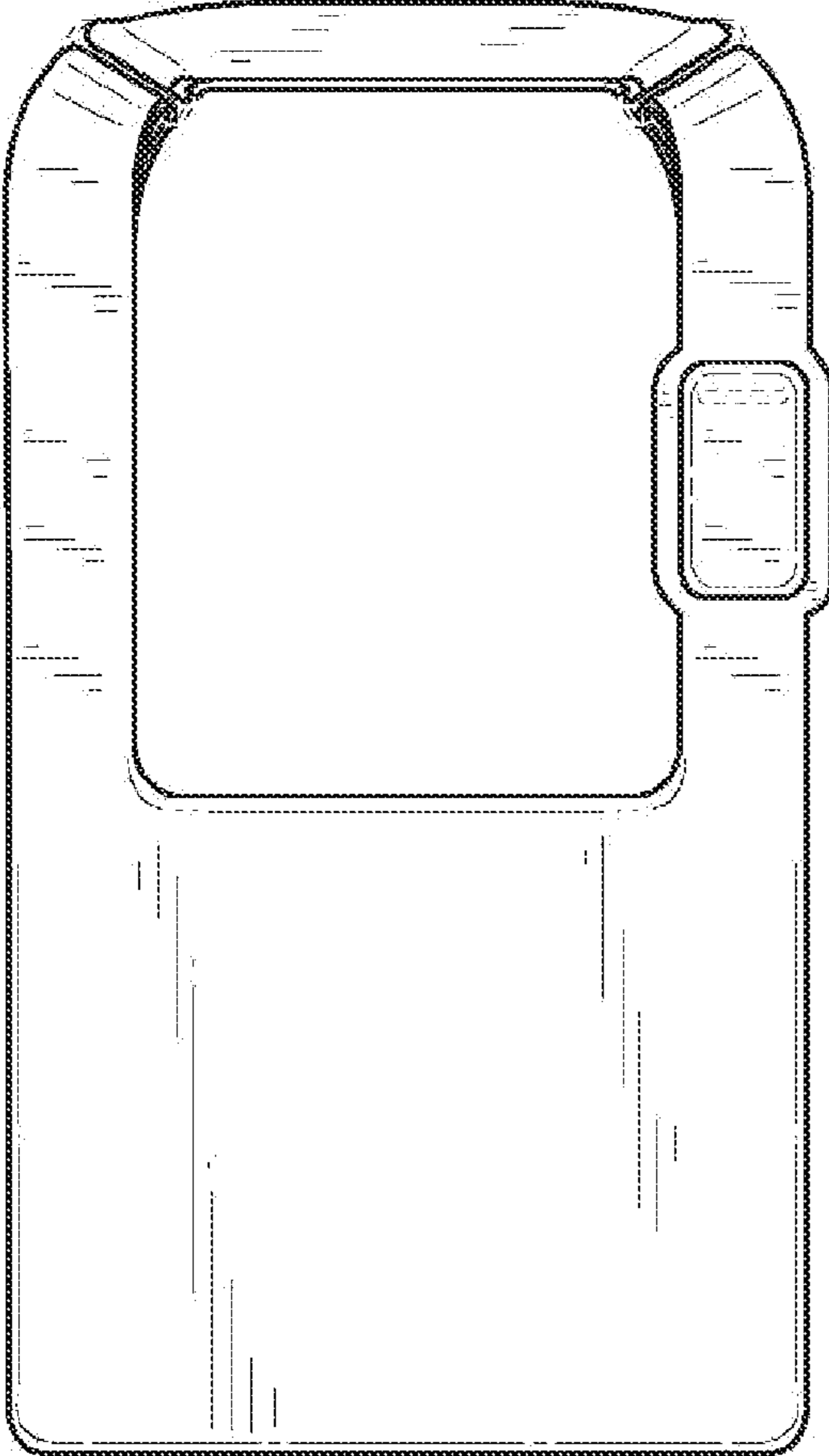

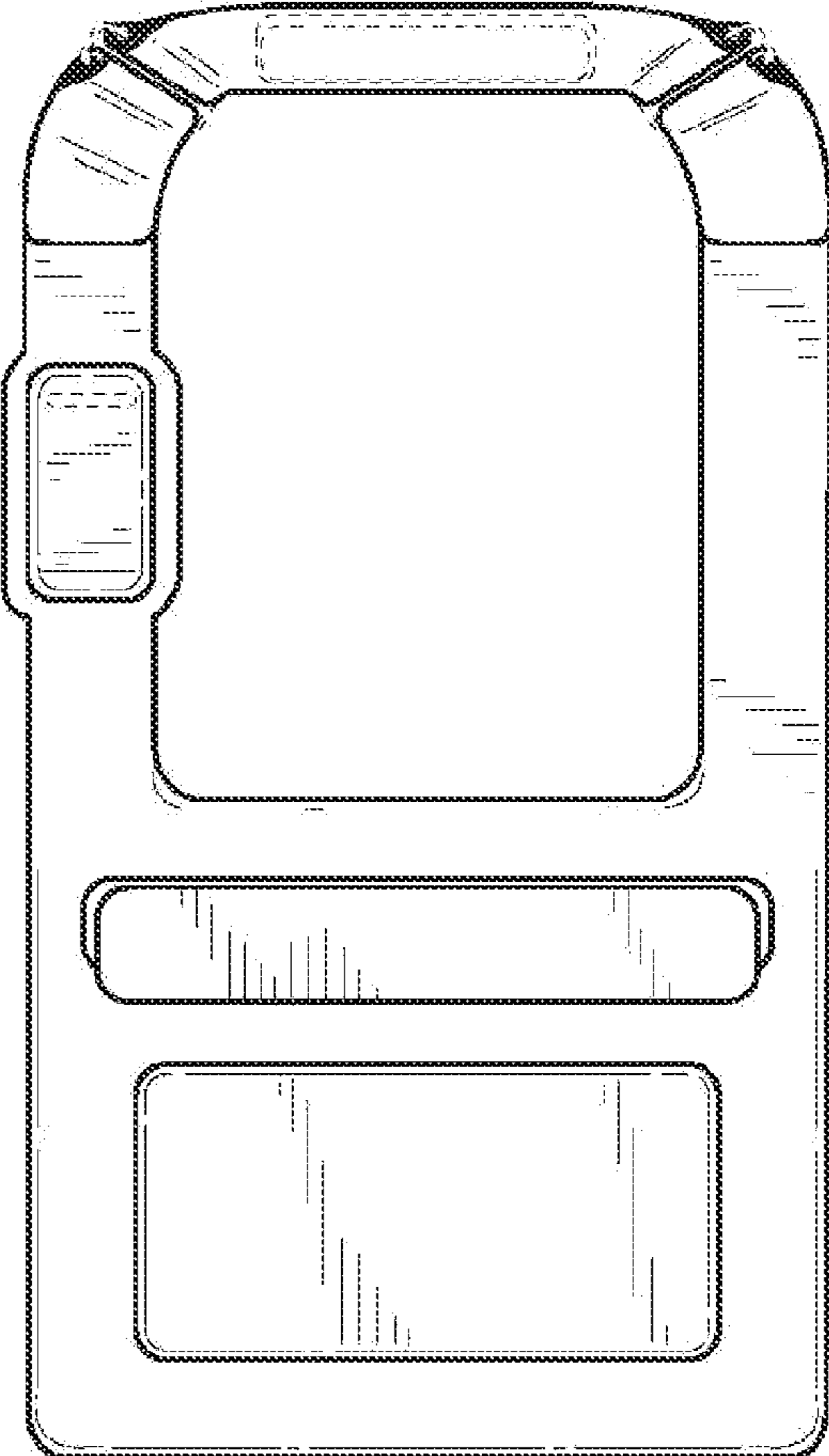

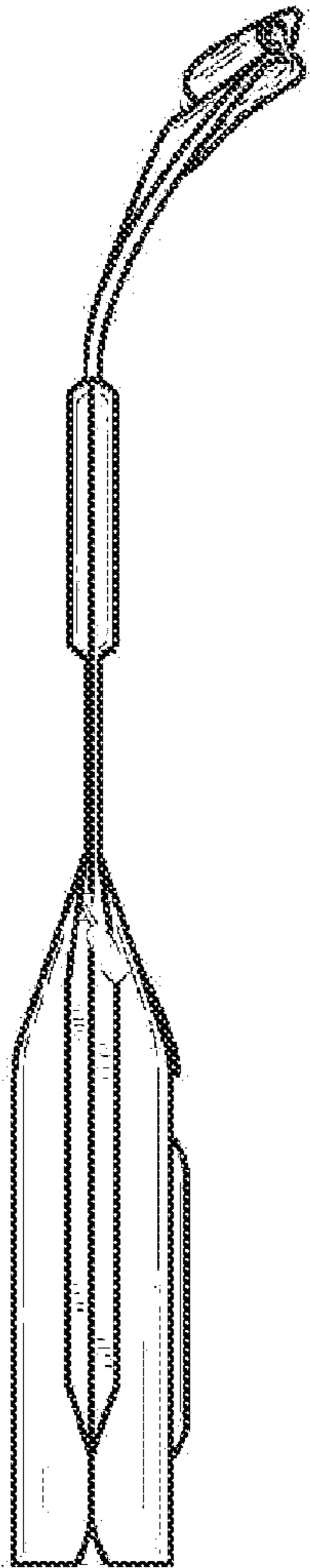

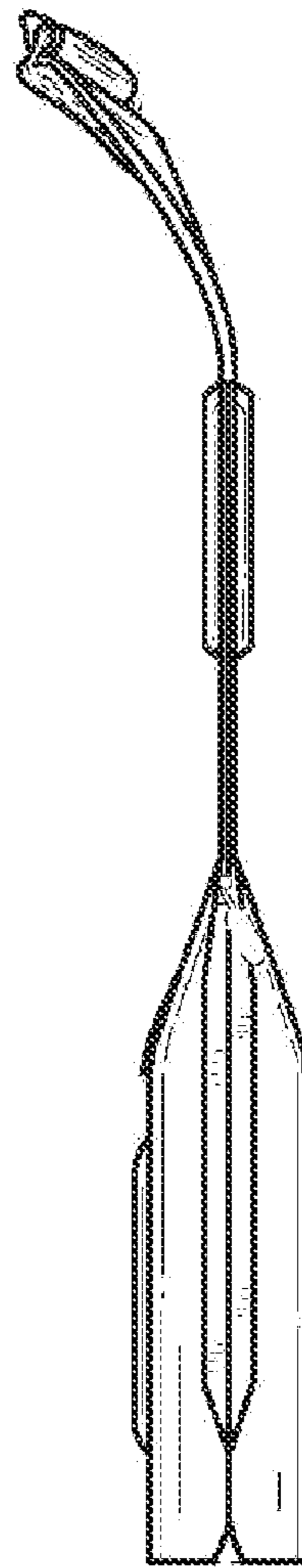

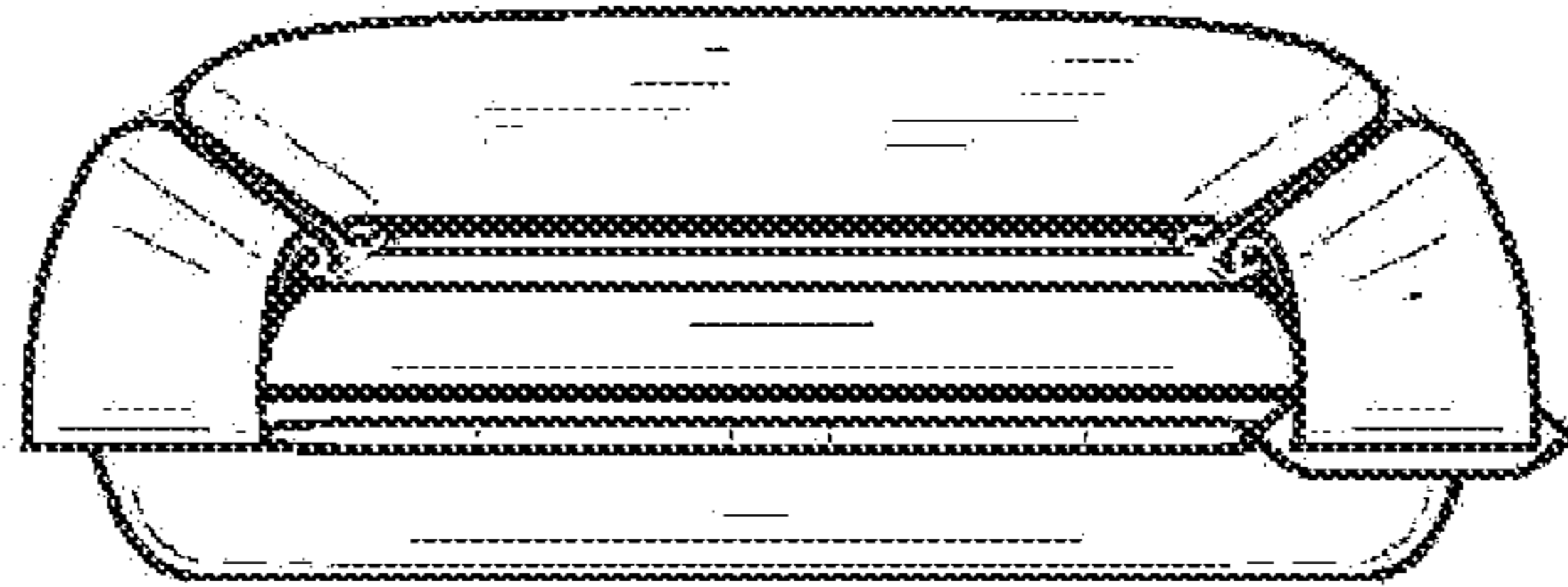

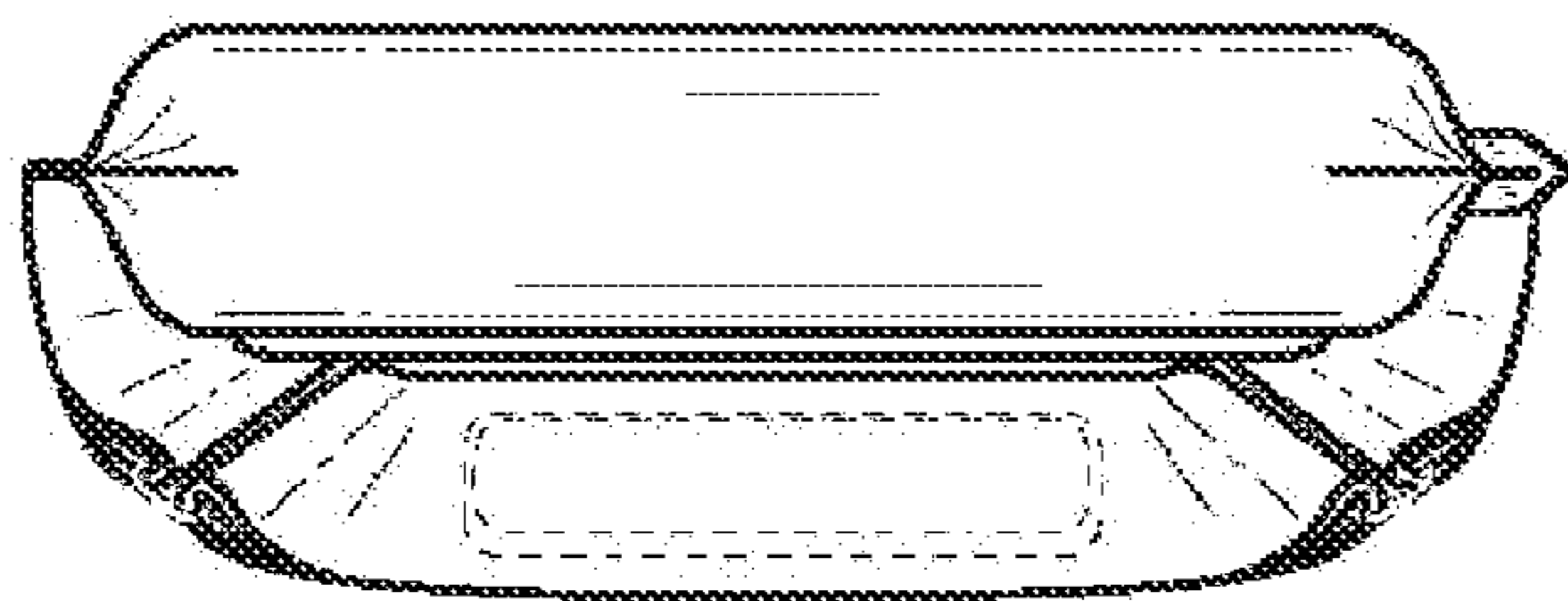
