FIG. 3 is a back view thereof.

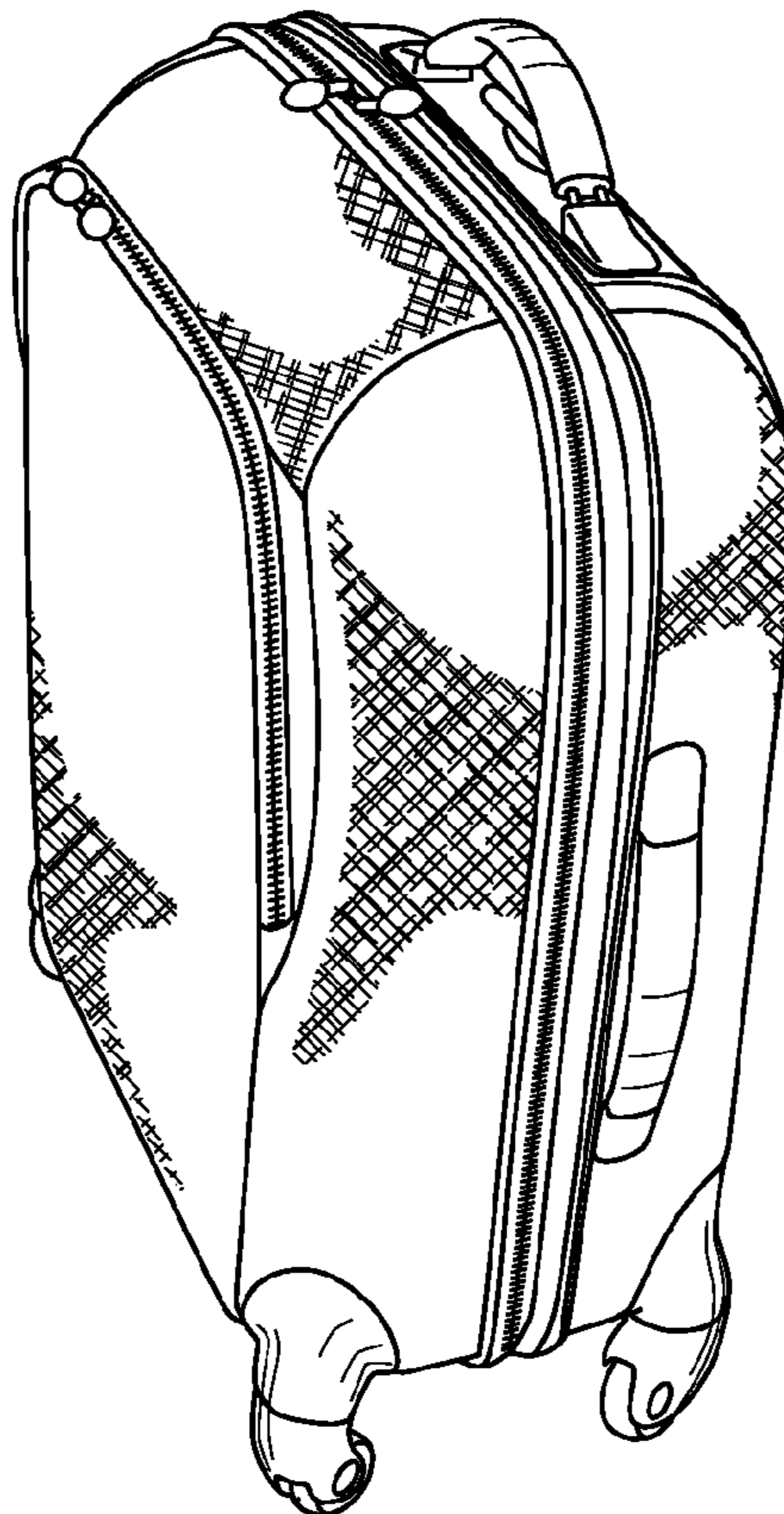
FIG. 4 is a right side view thereof.

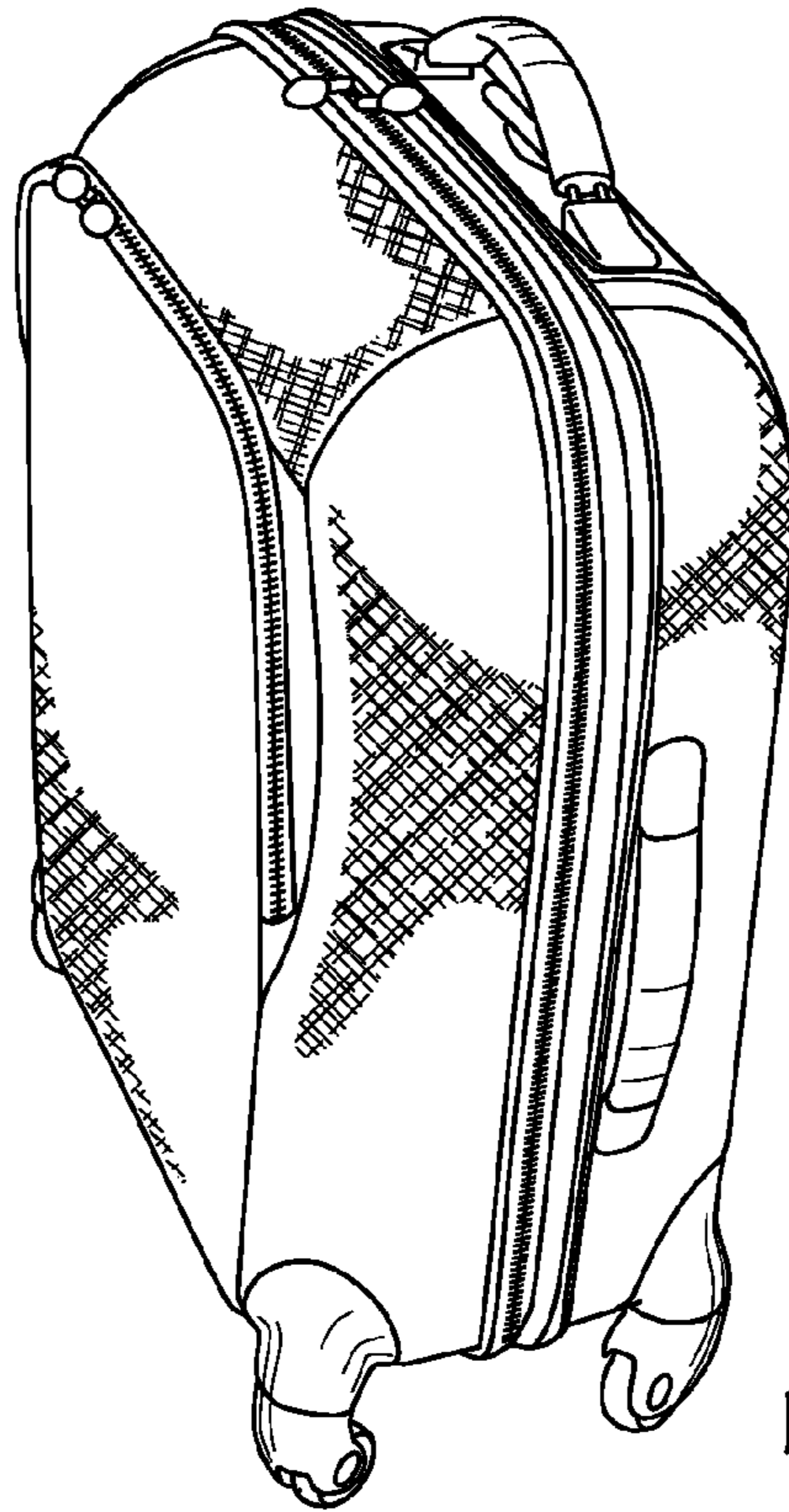

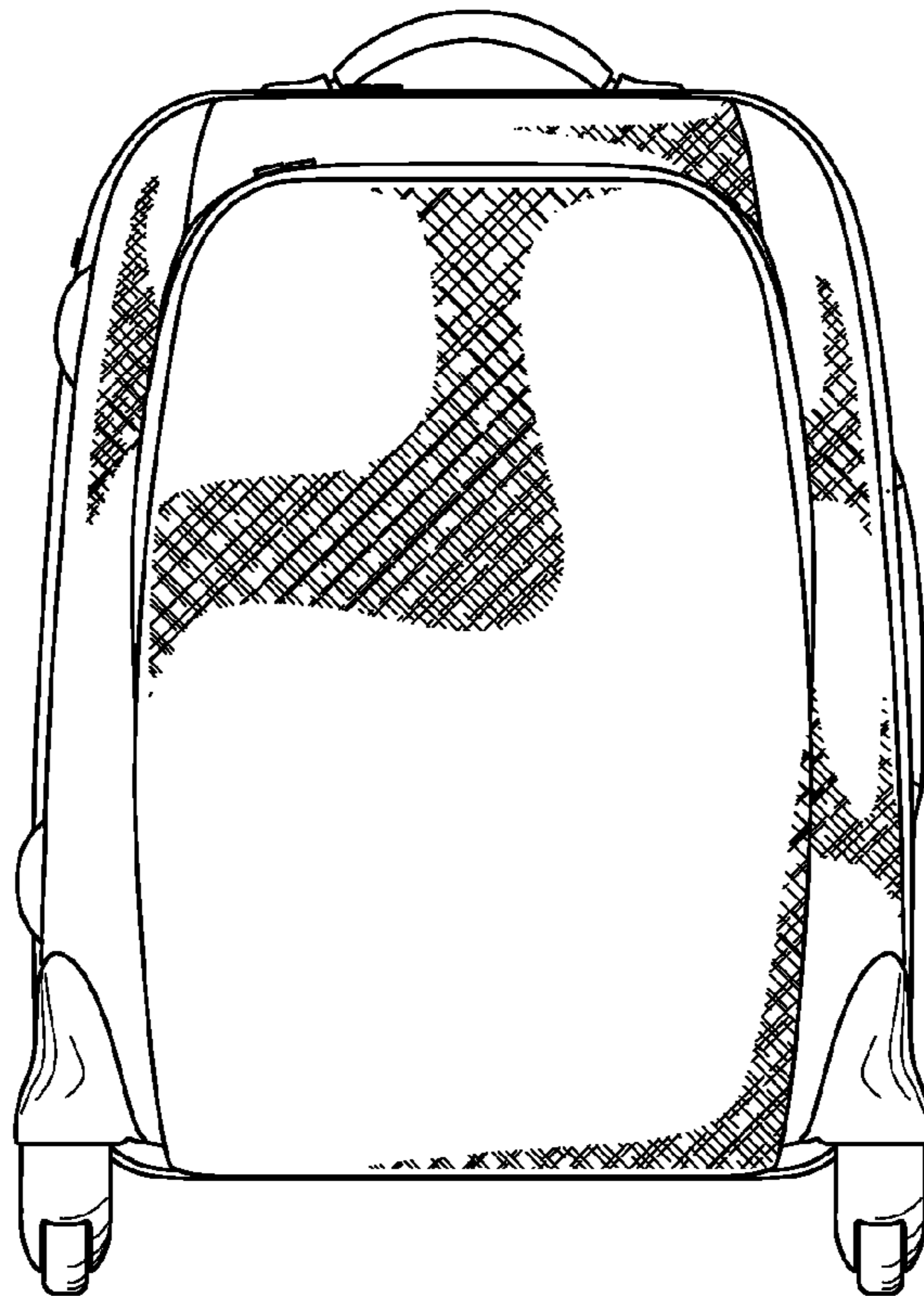

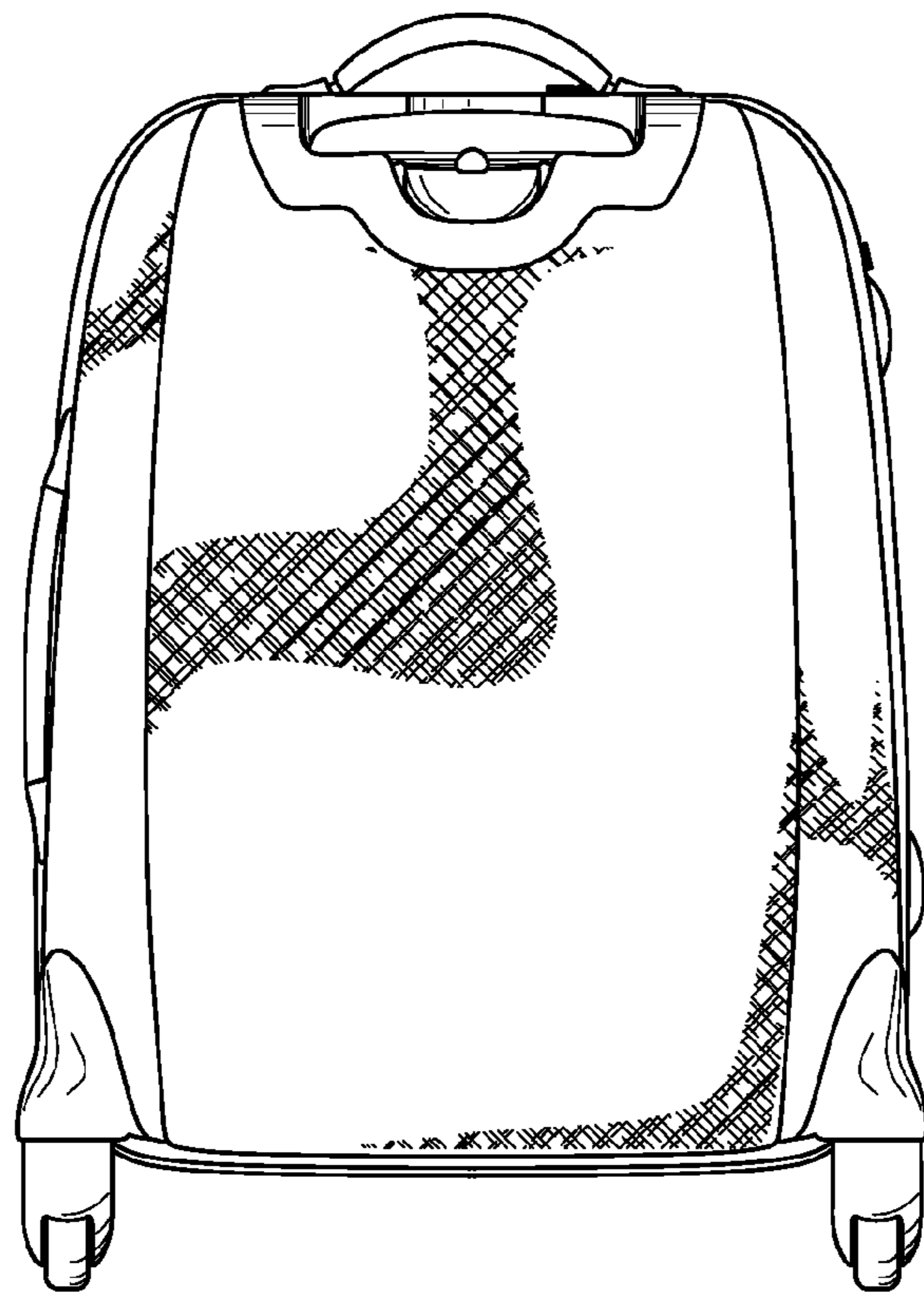

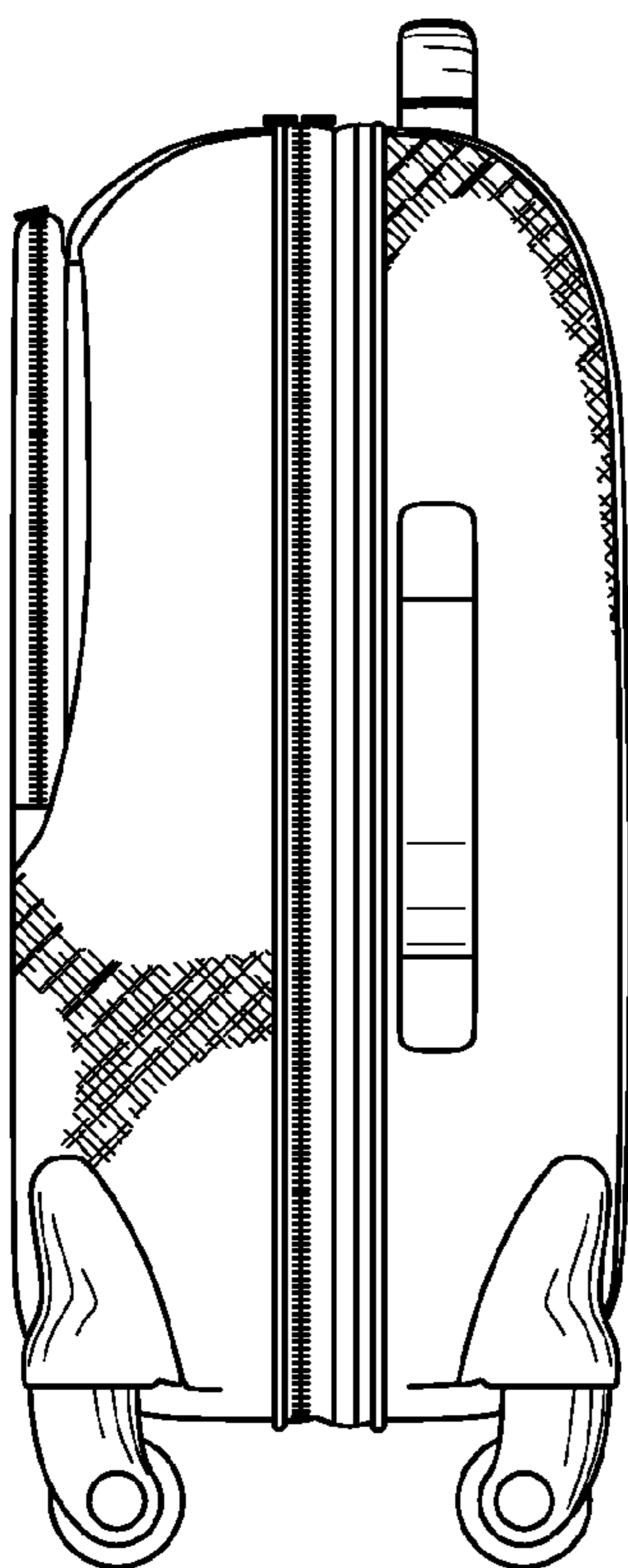

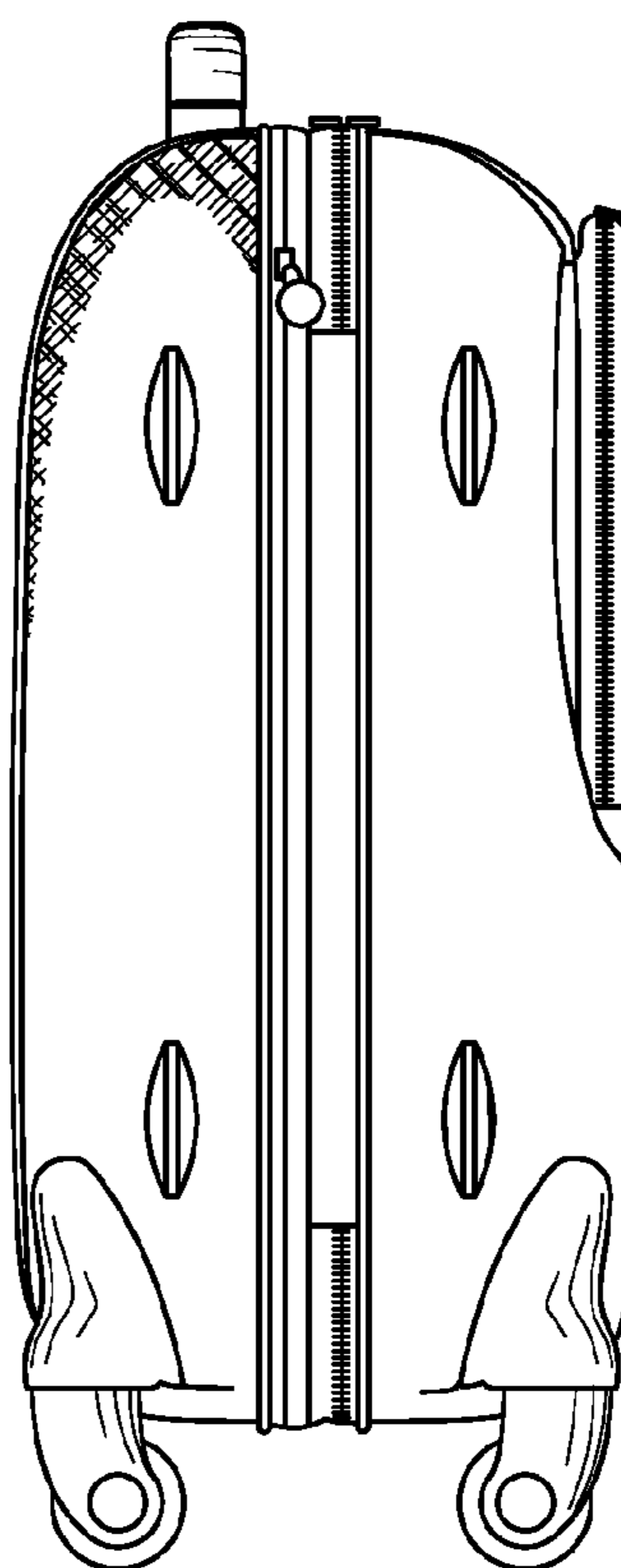

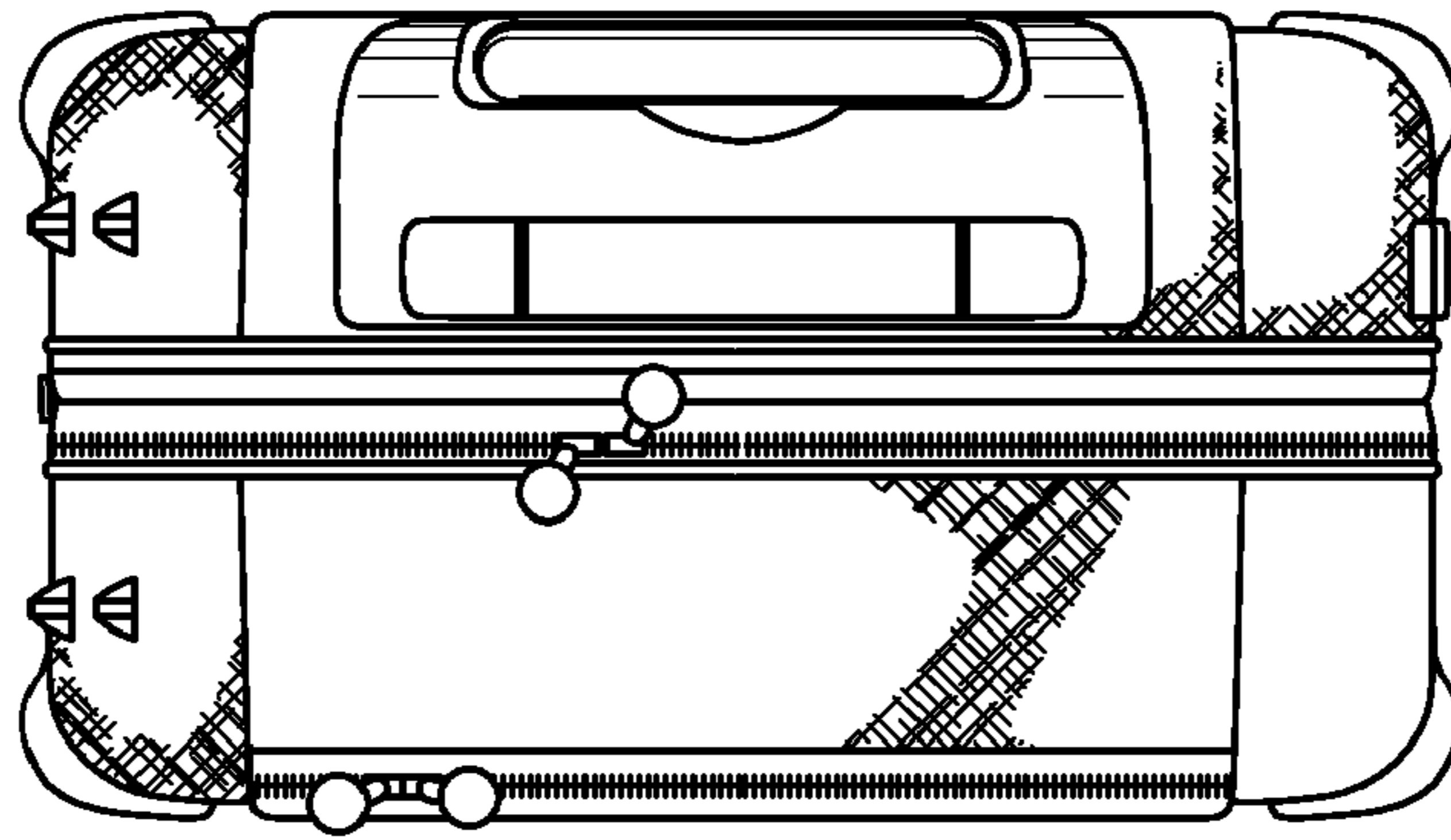

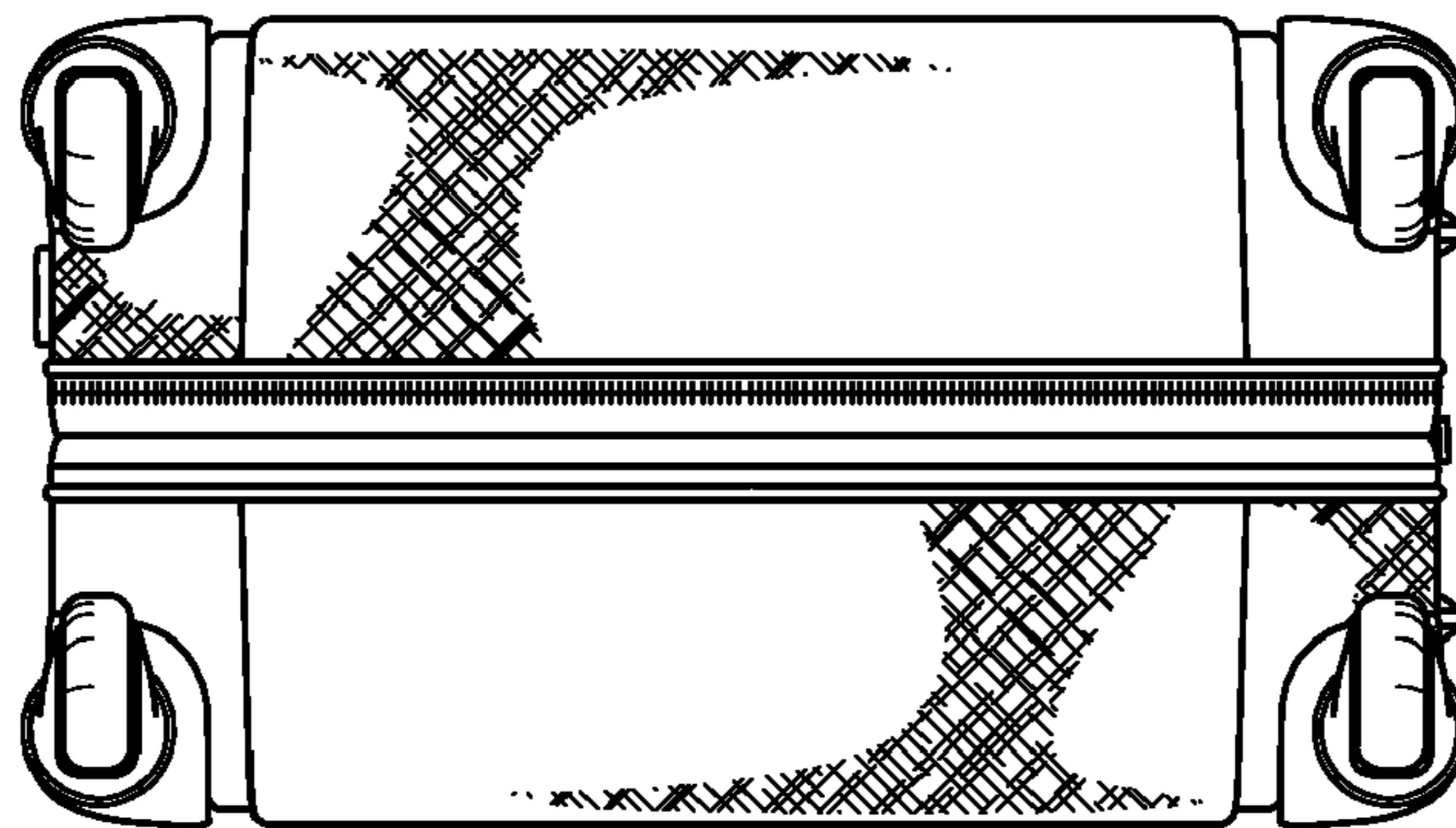
