(57) **CLAIM**

The ornamental design for a large cosmetics case, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the cosmetics case in closed position.

FIG. 2 is a view of the cosmetics case in open position.

FIG. 3 is a front view of the closed case, the back view being a mirror image.

FIG. 4 is a right side view thereof.

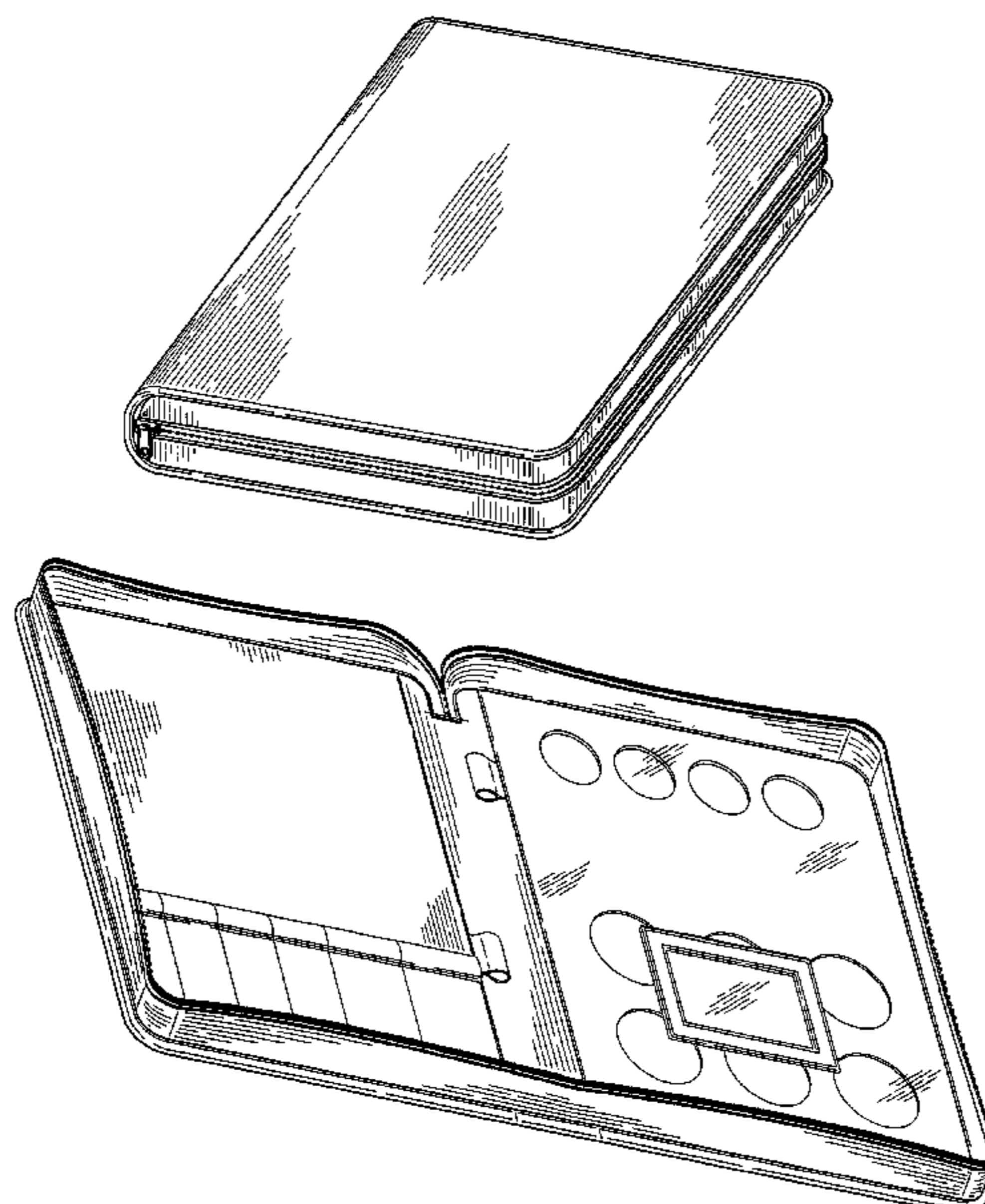
FIG. 5 is a left side view thereof.

FIG. 6 is a bottom view thereof; and,

FIG. 7 is a top view thereof.

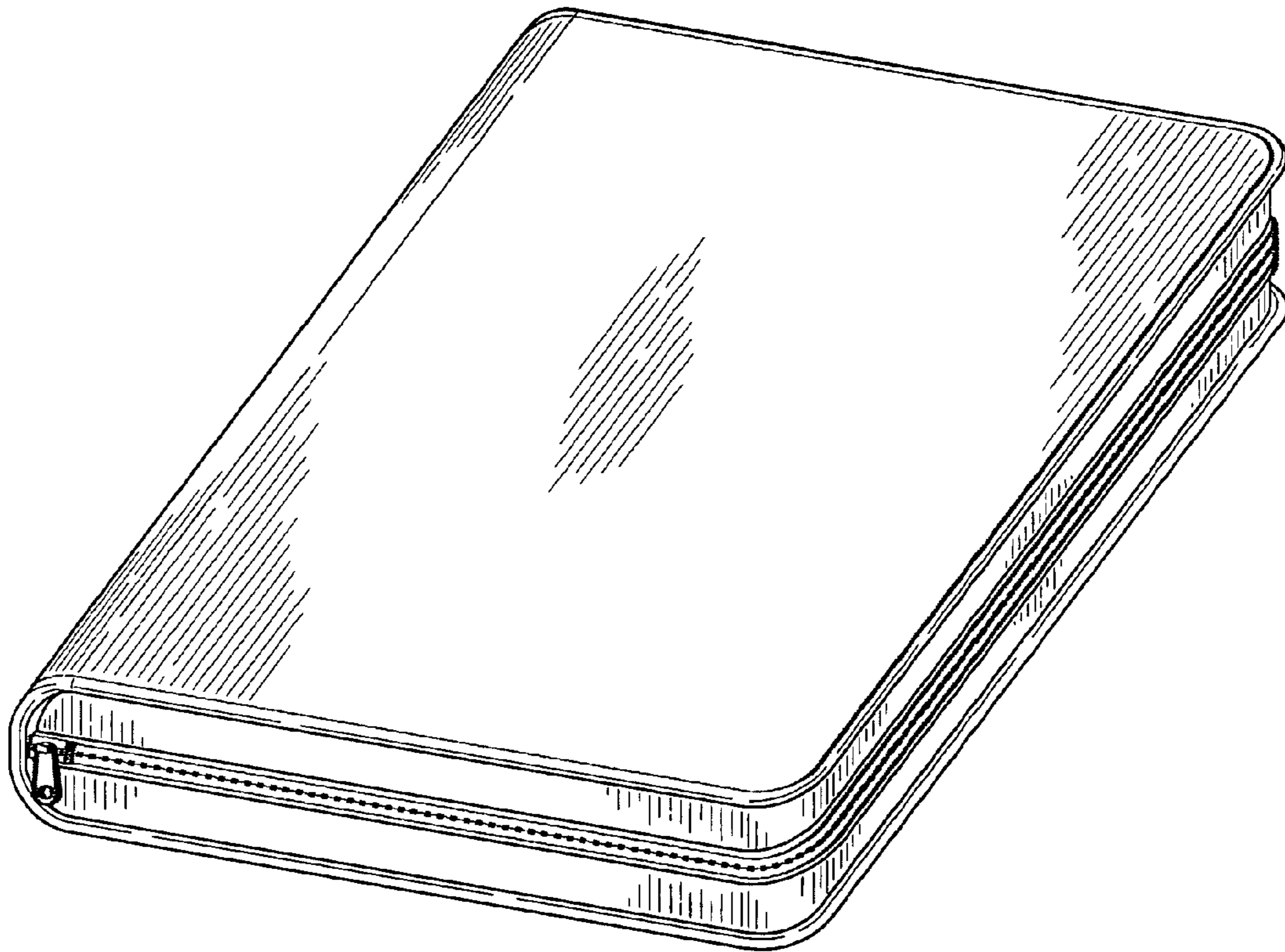

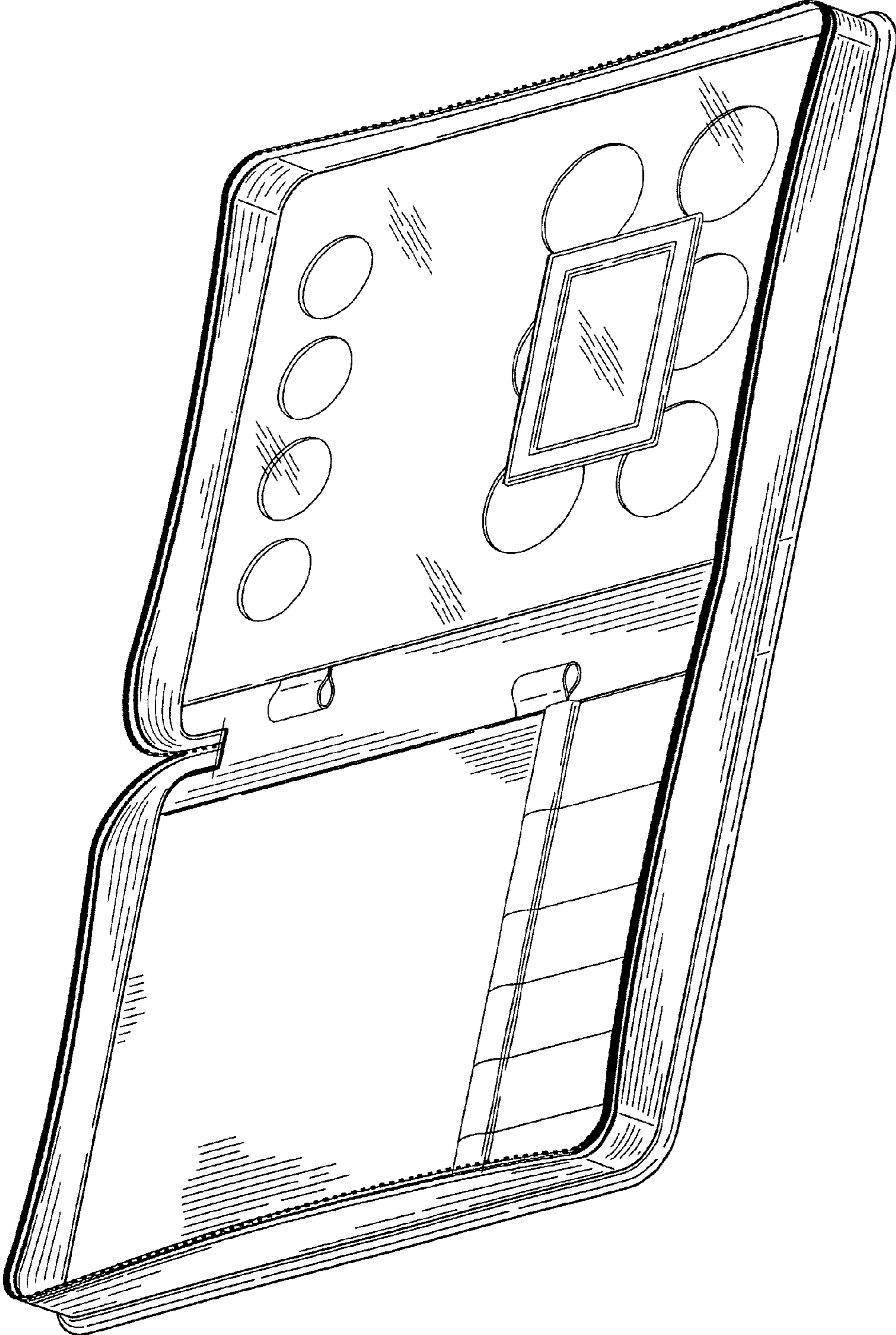

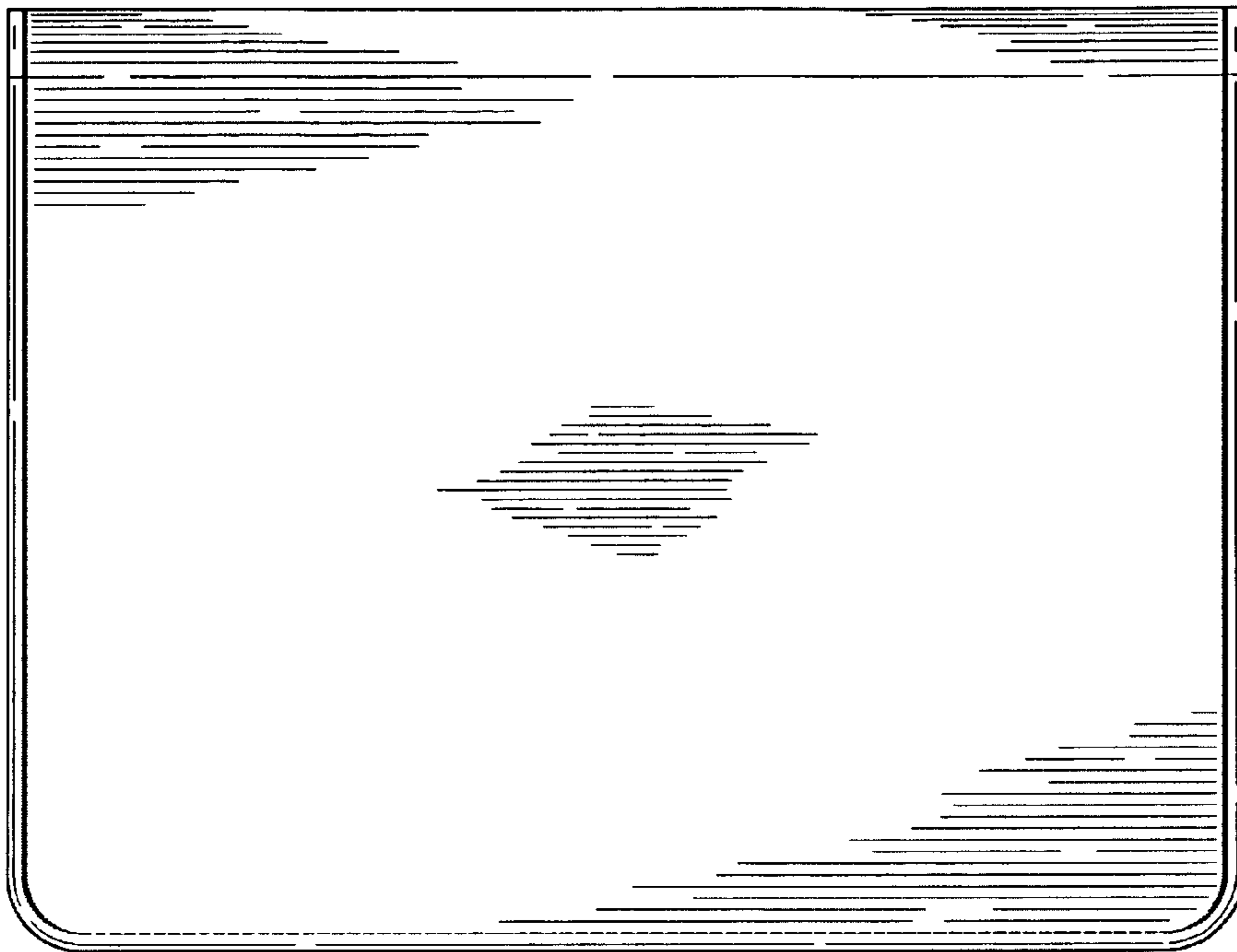

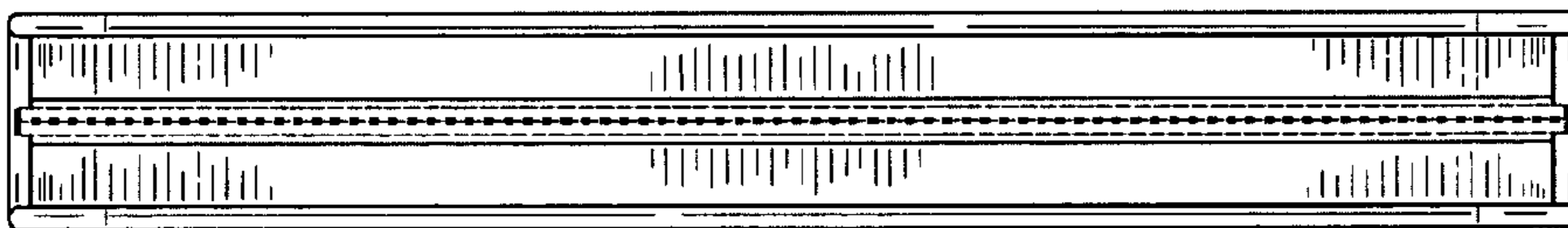

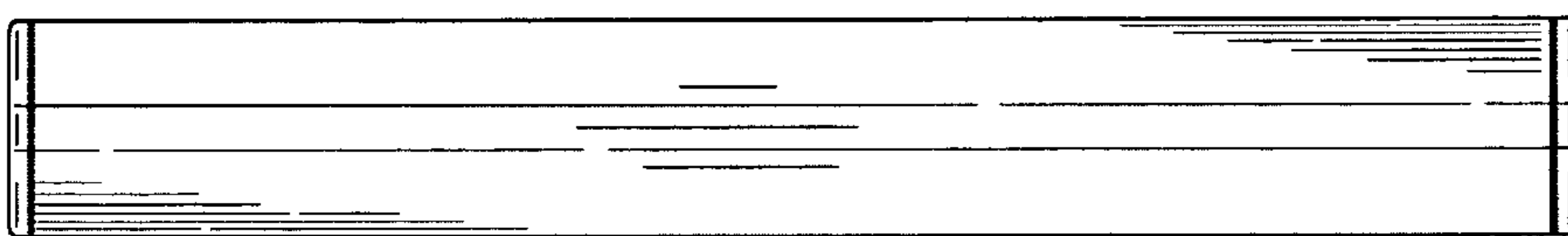

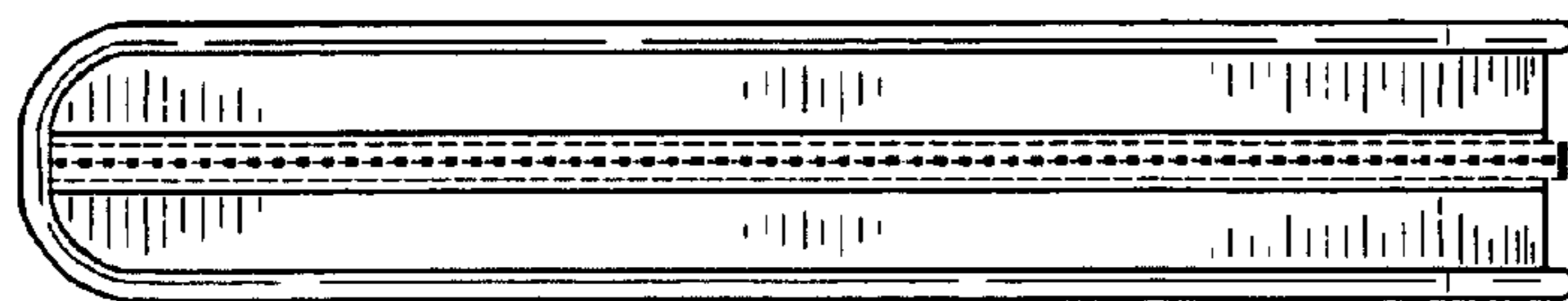

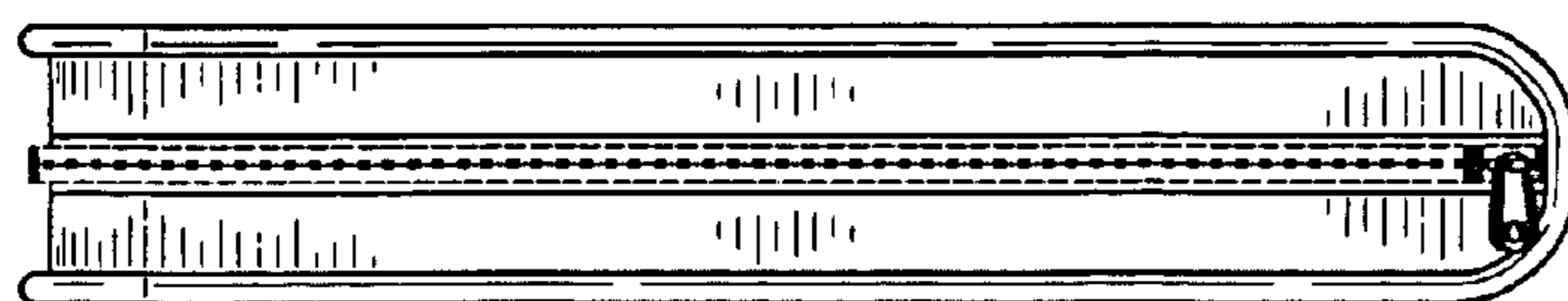
