multi-tiered shelving system;

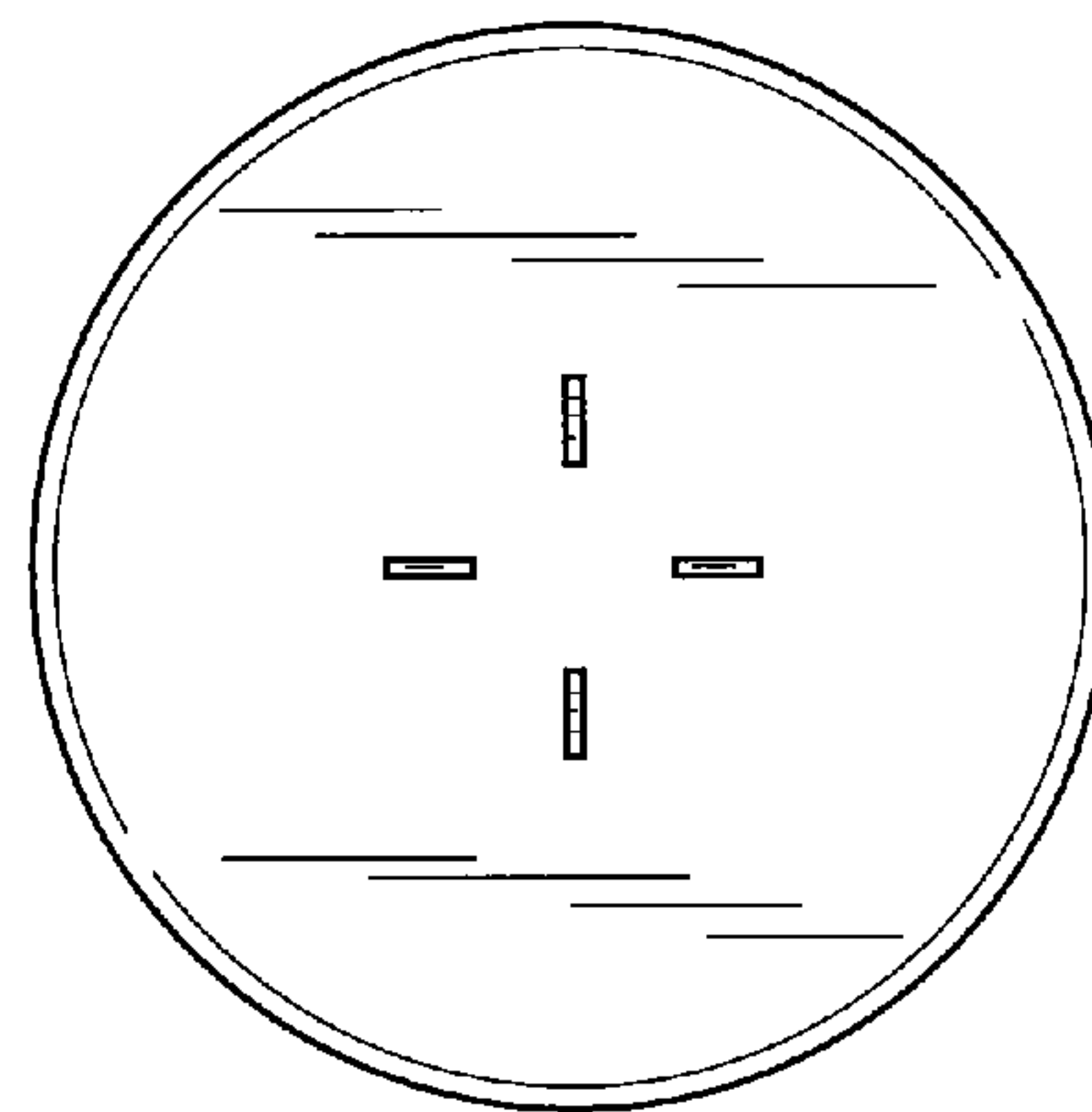
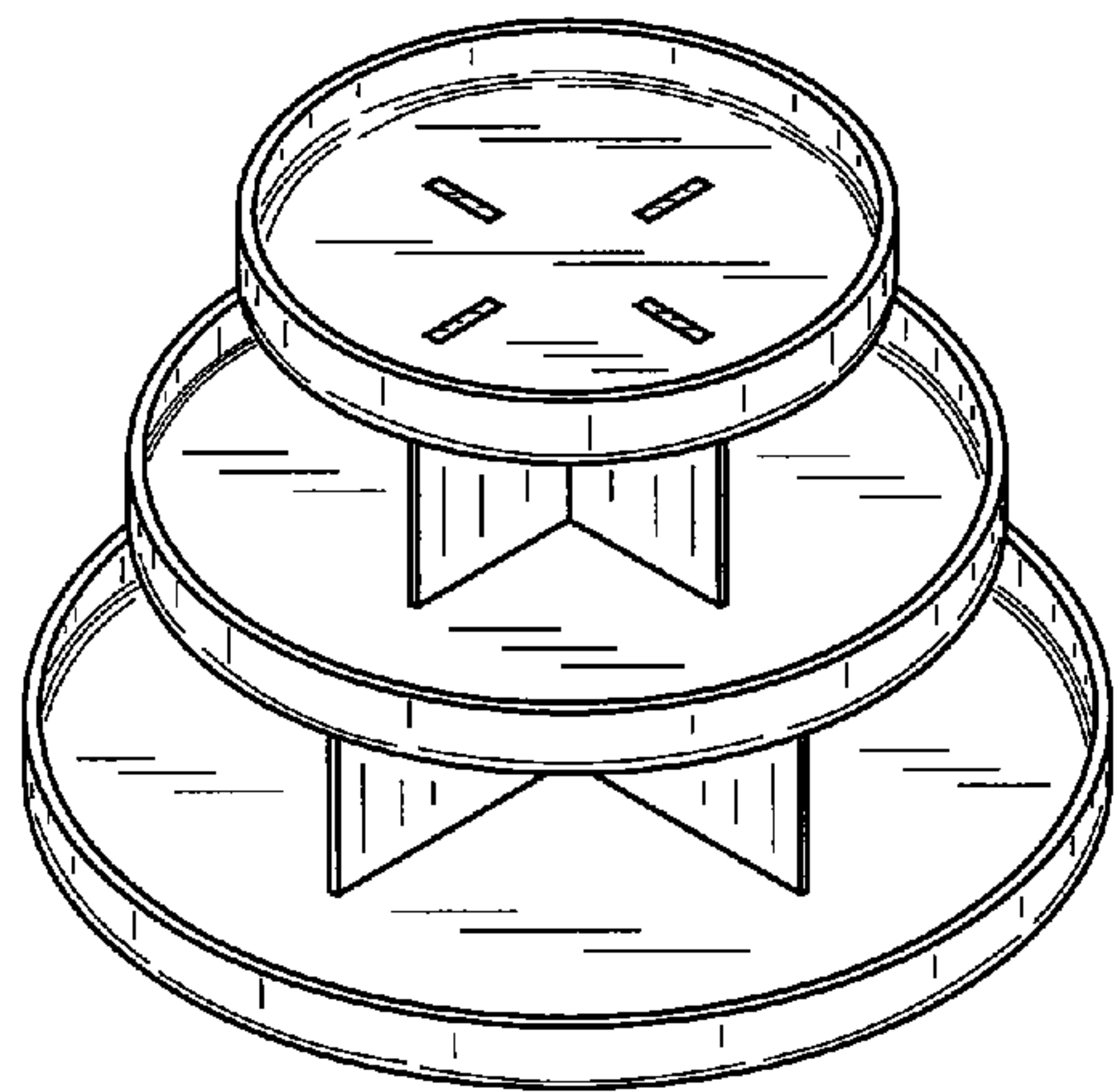
FIG. 7 is a left side plan view of FIG. 6;

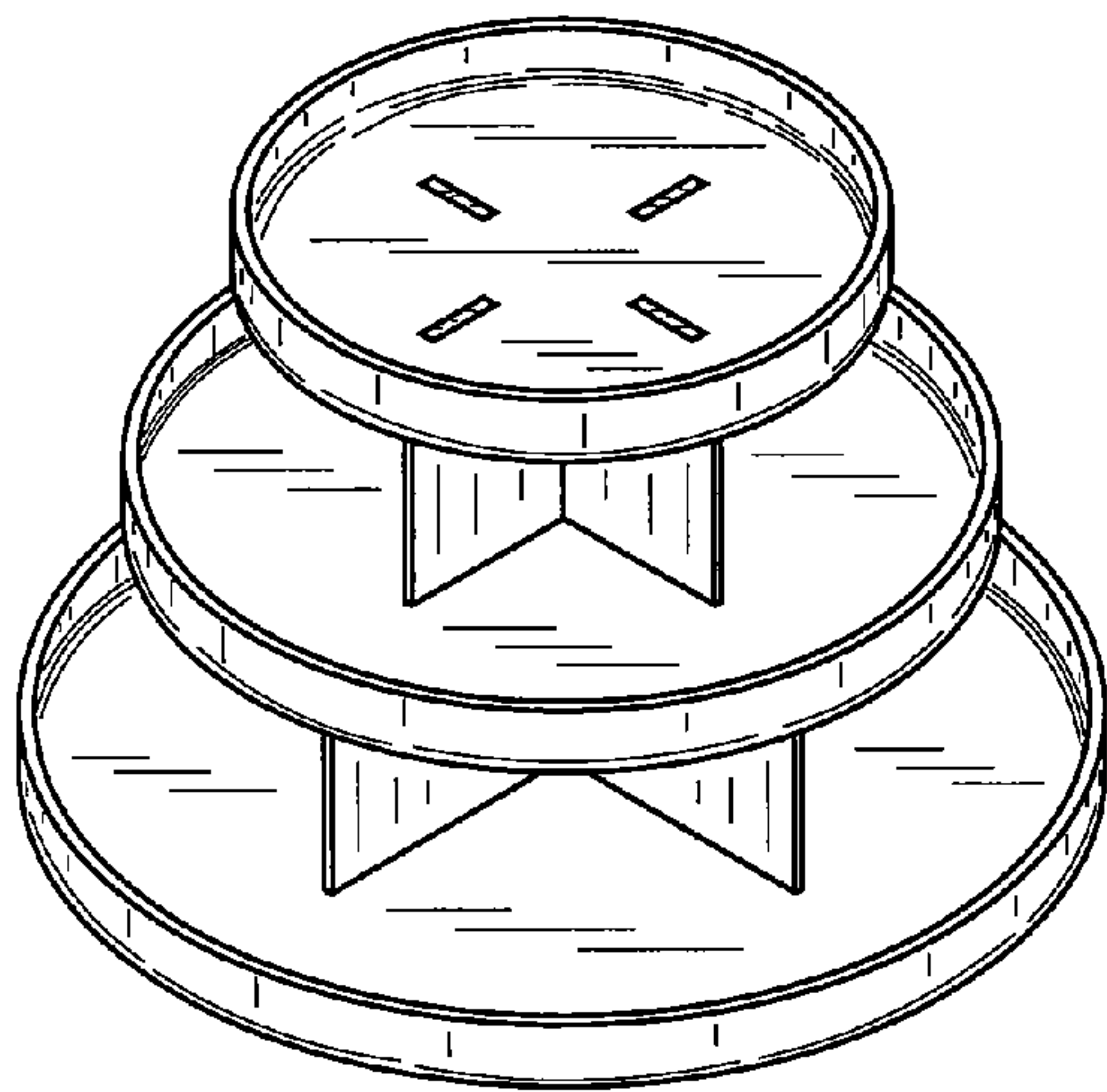

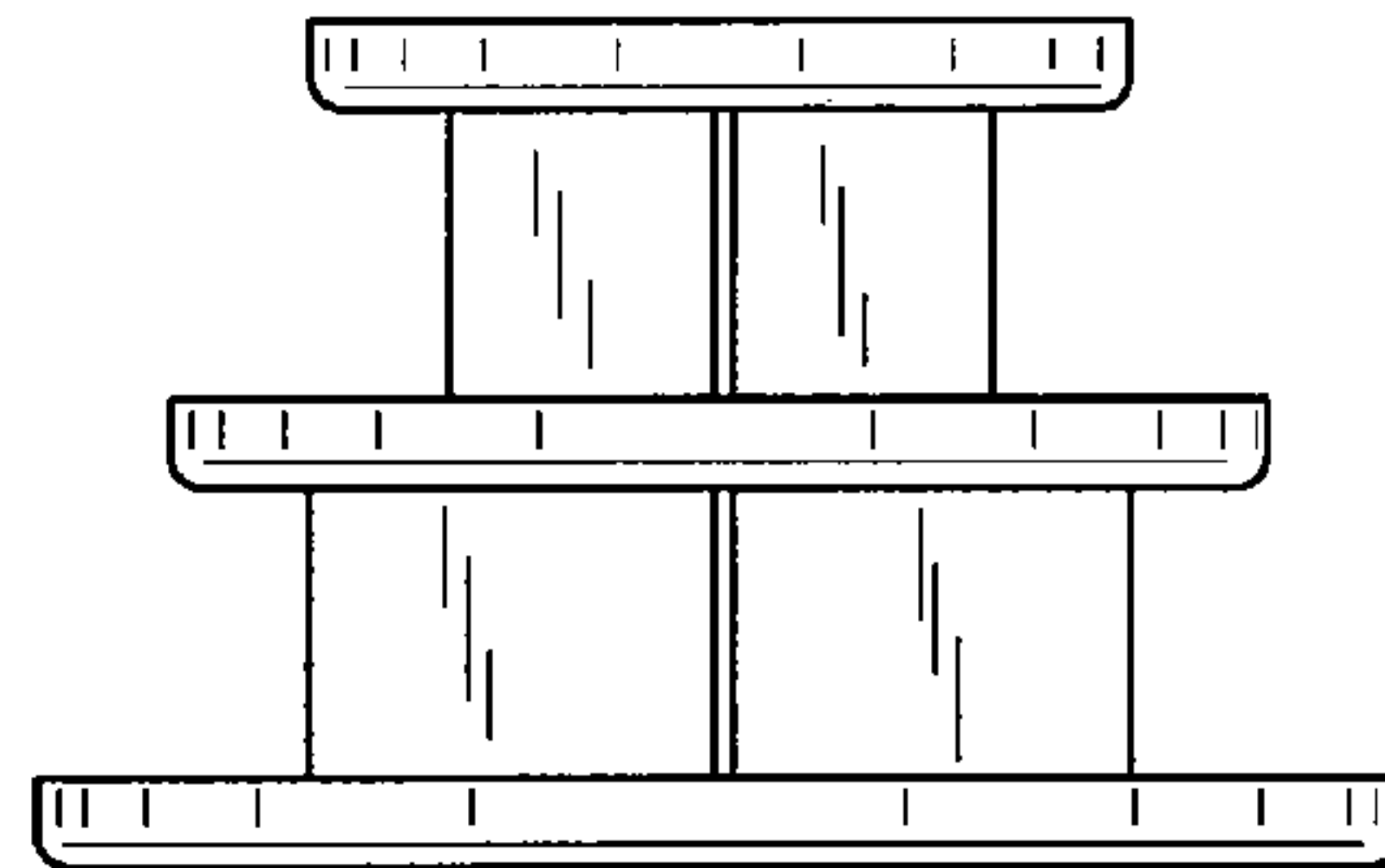

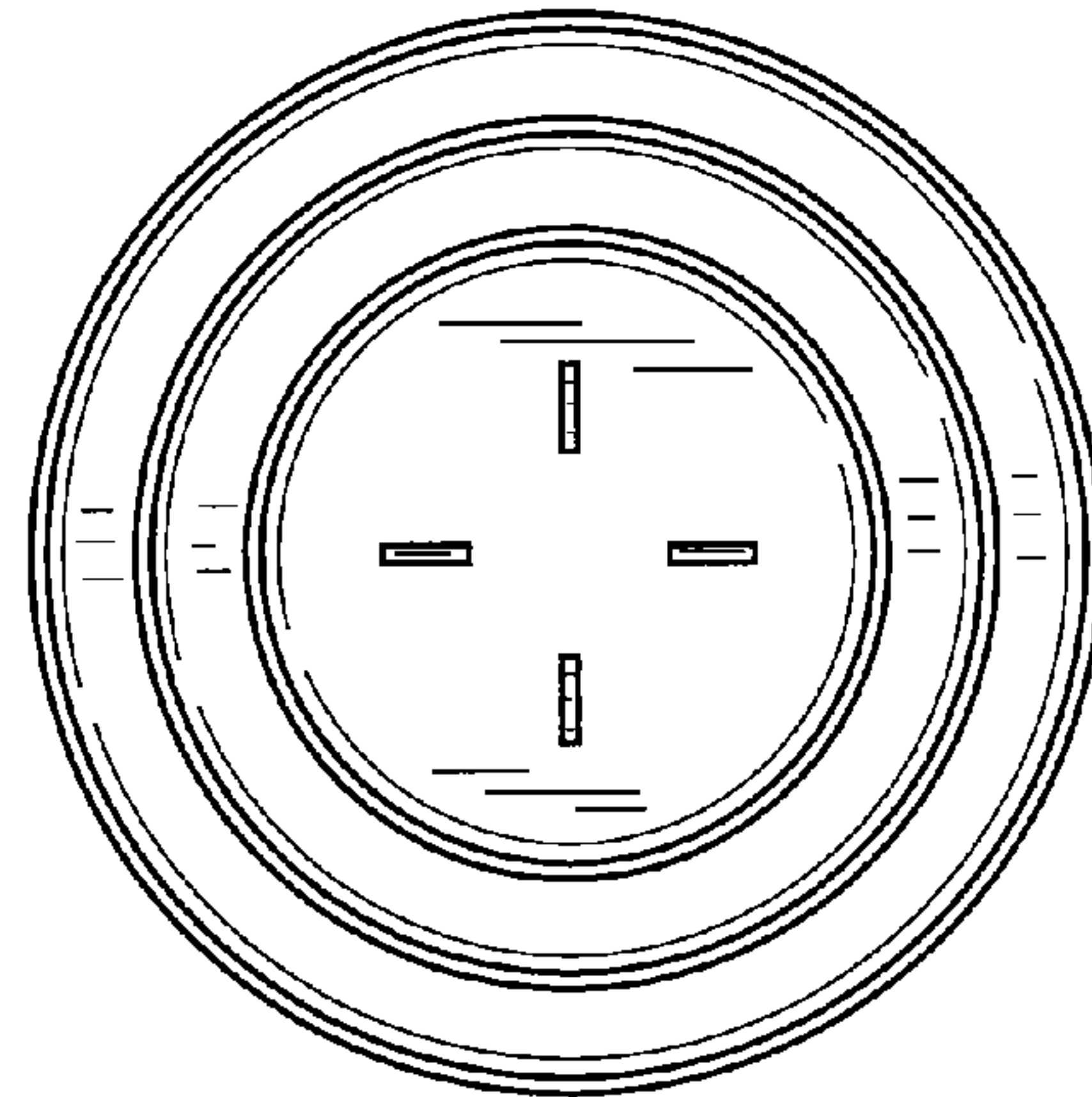

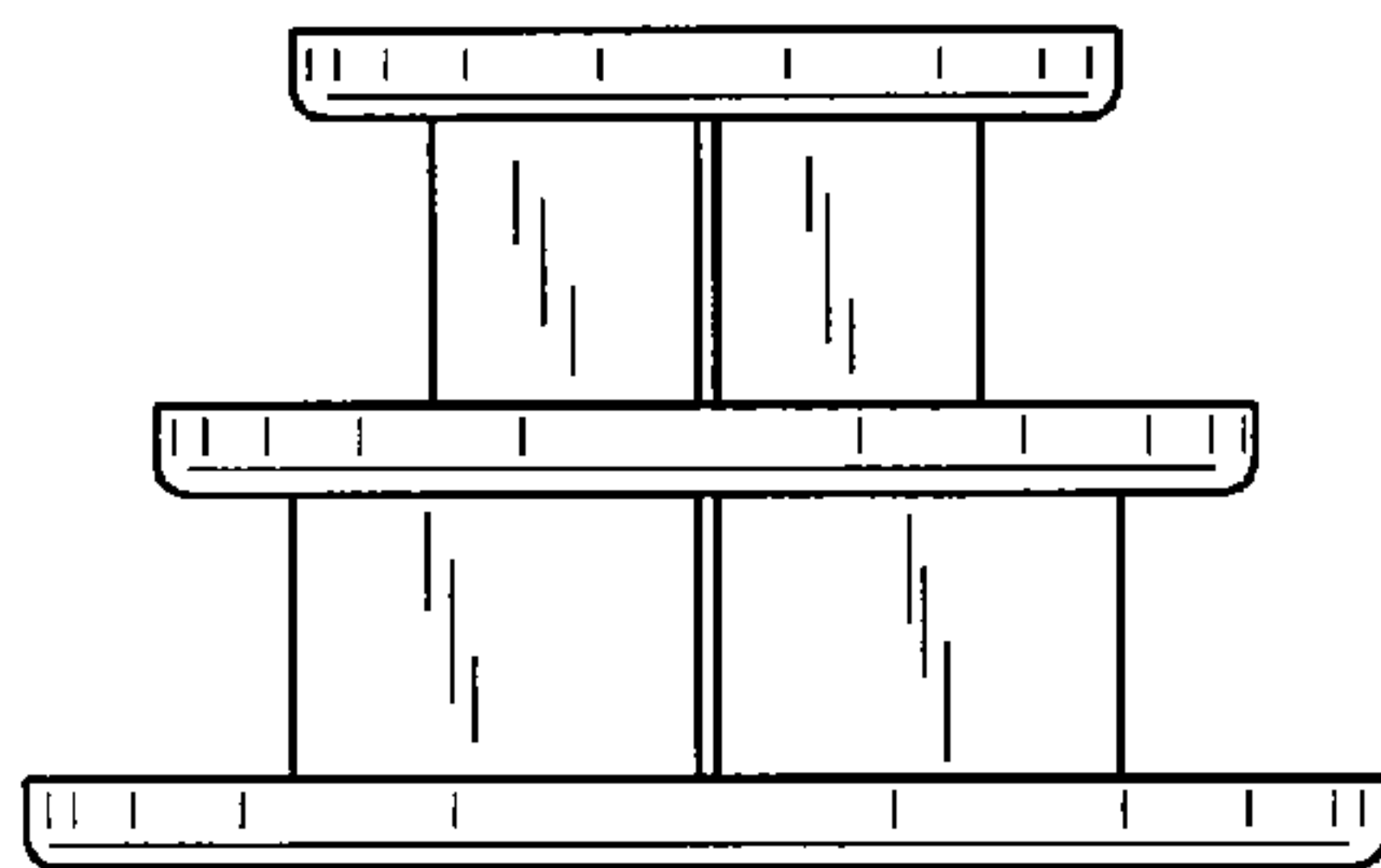

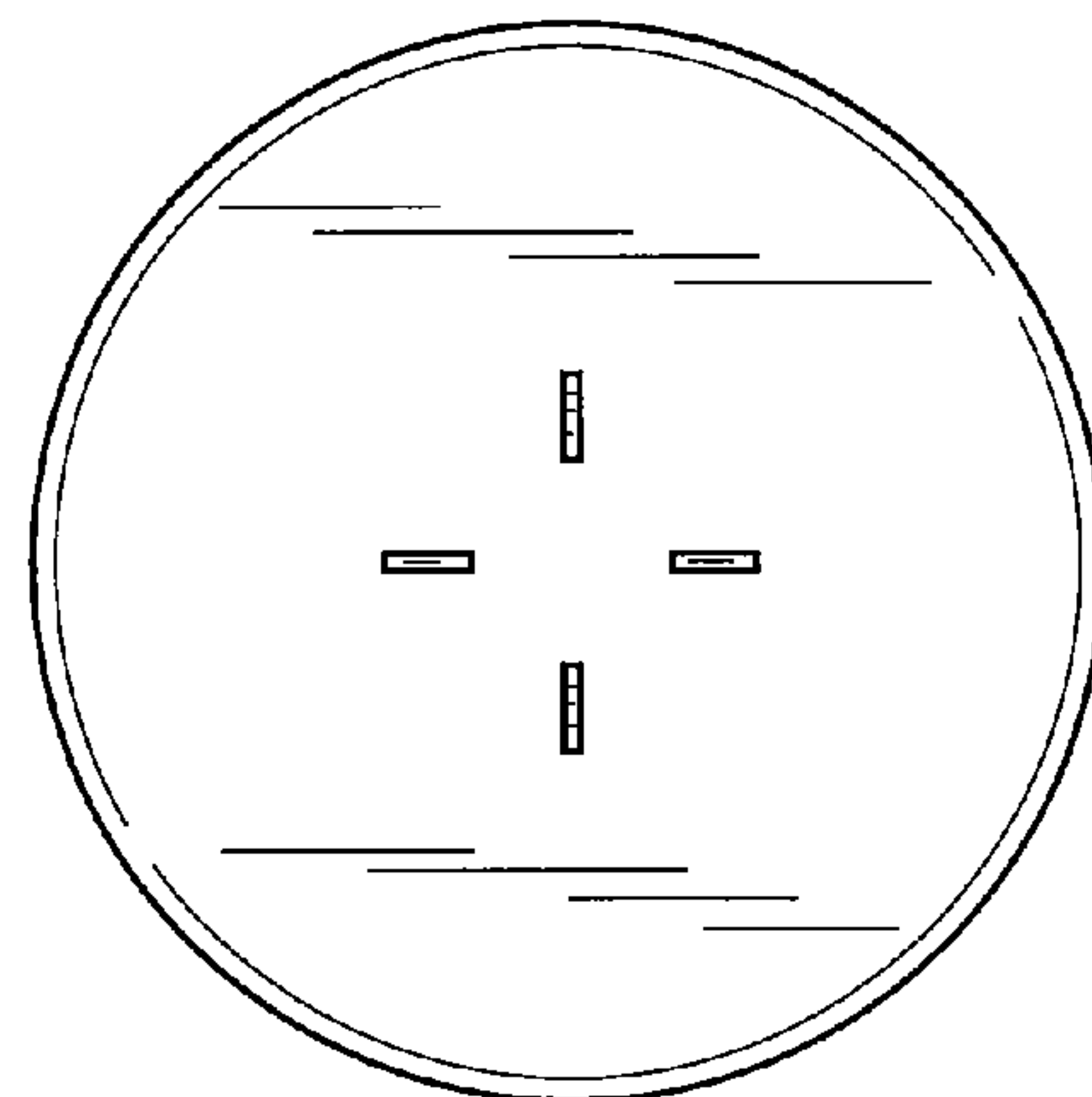

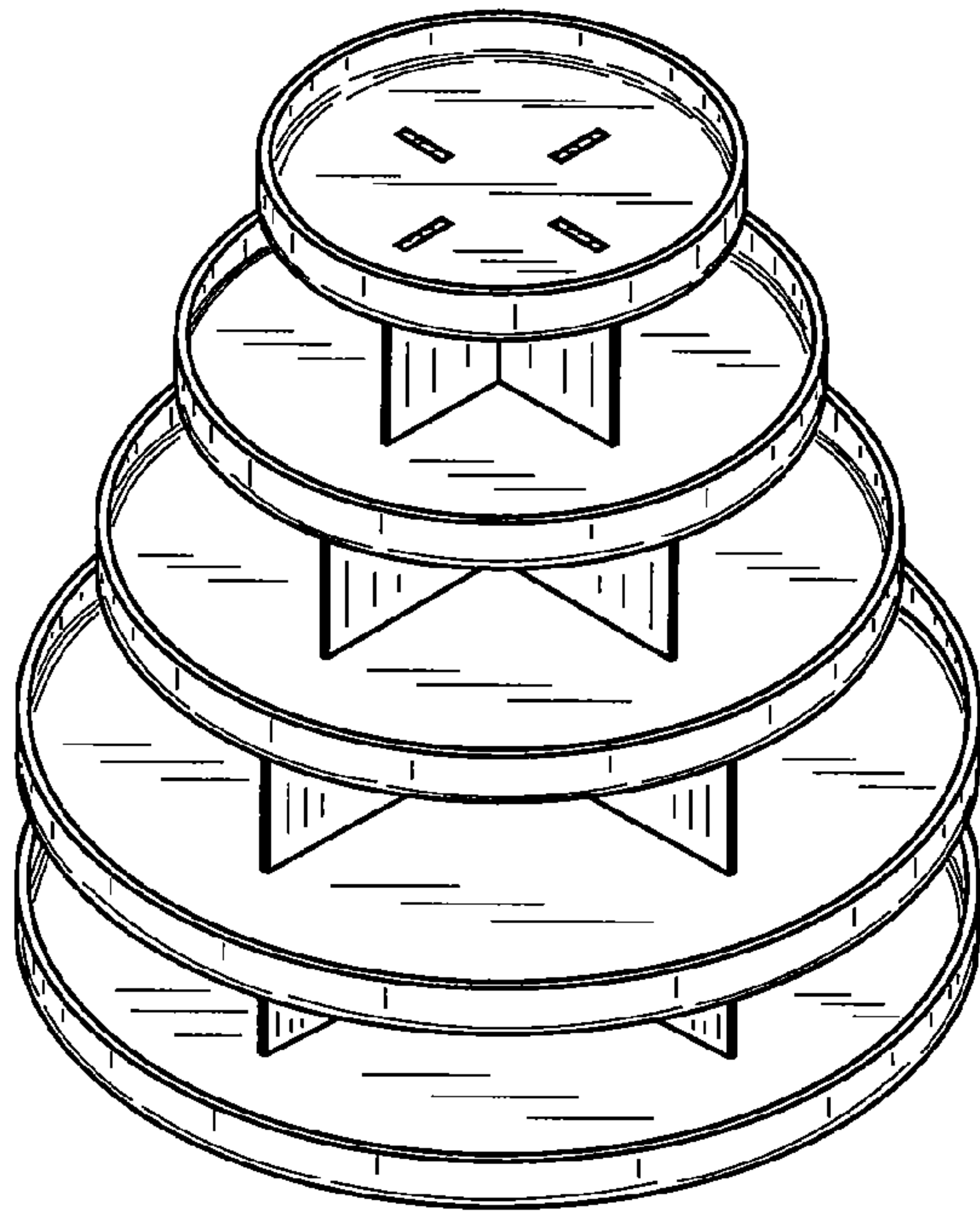

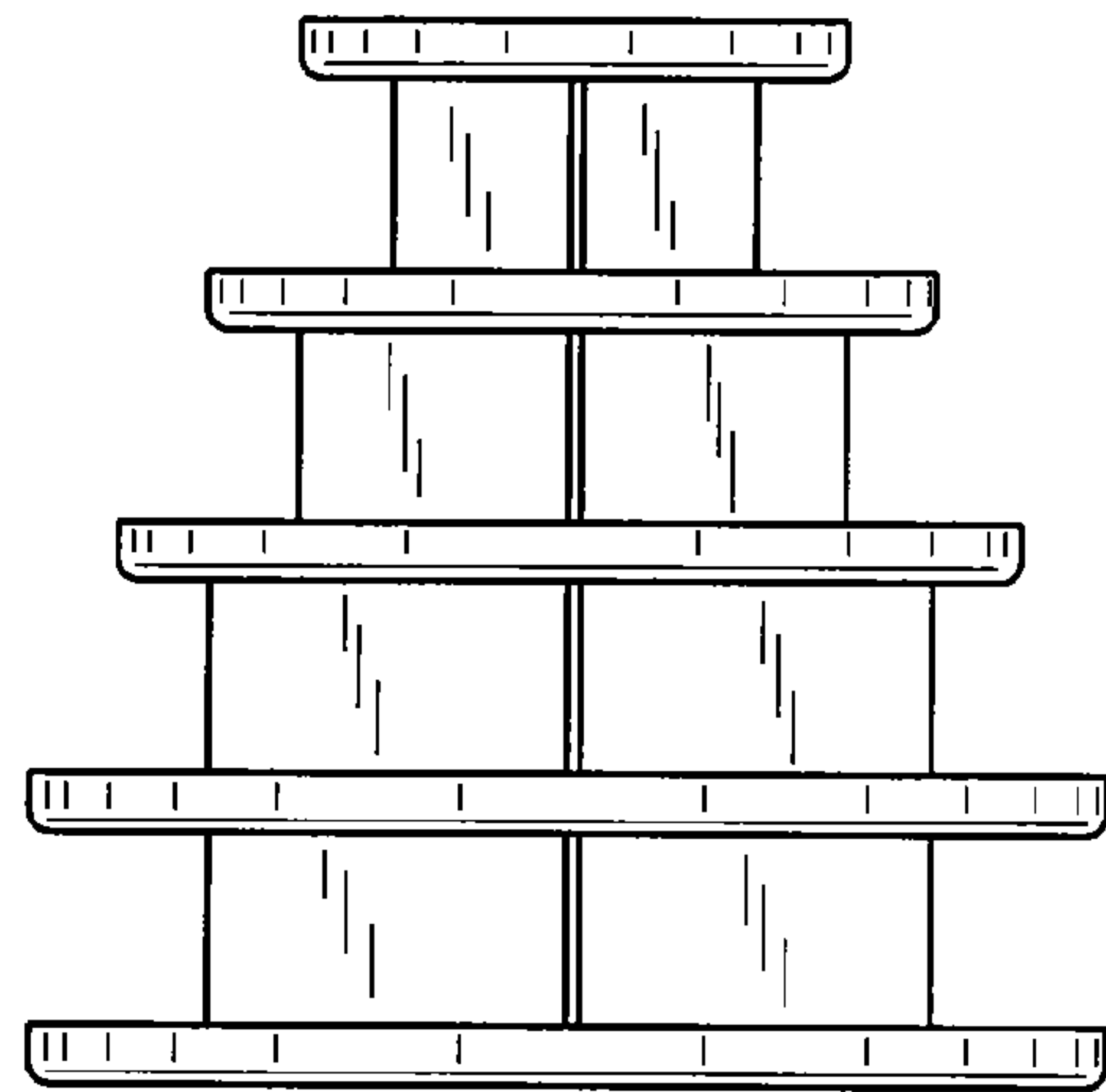

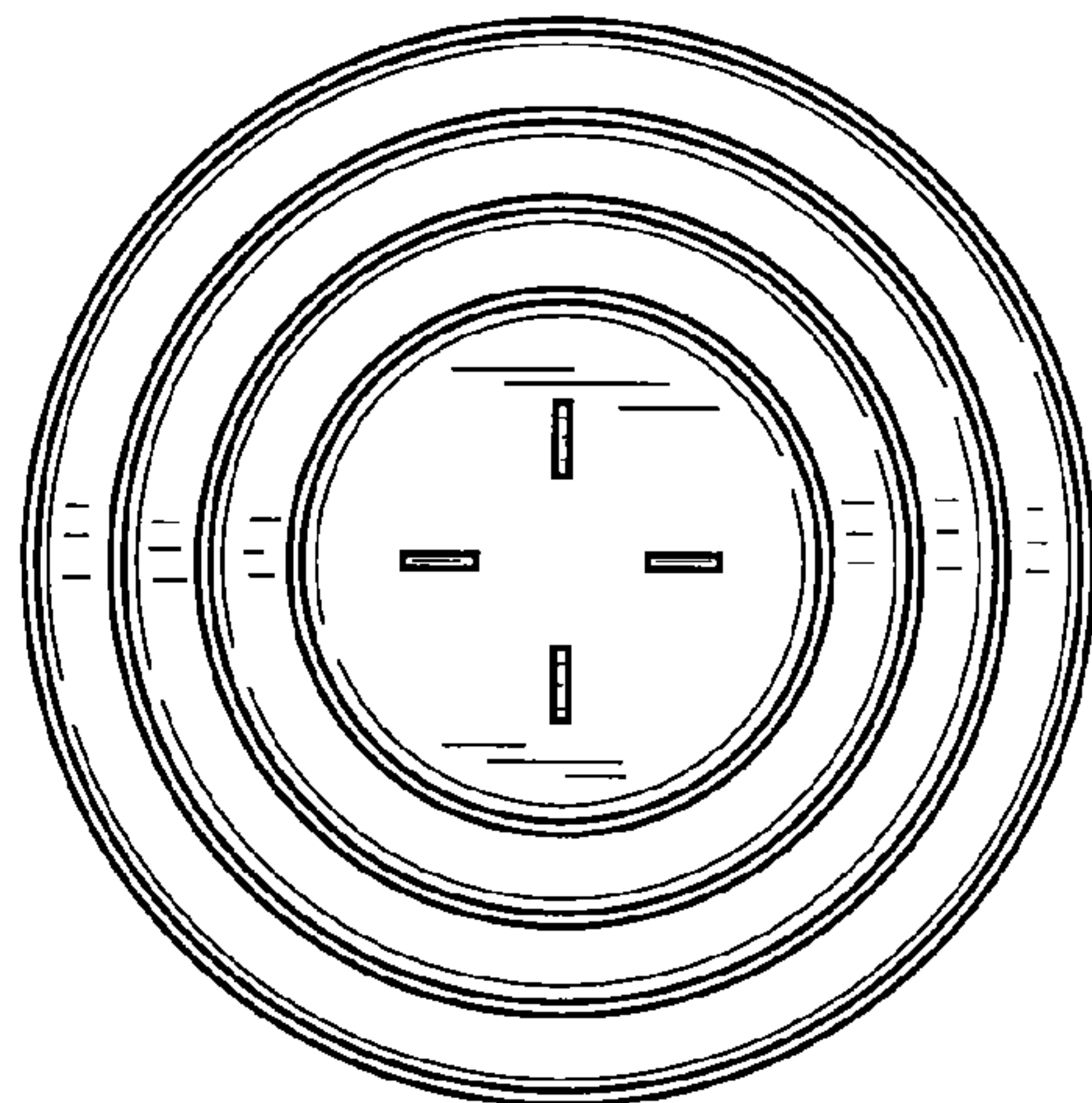

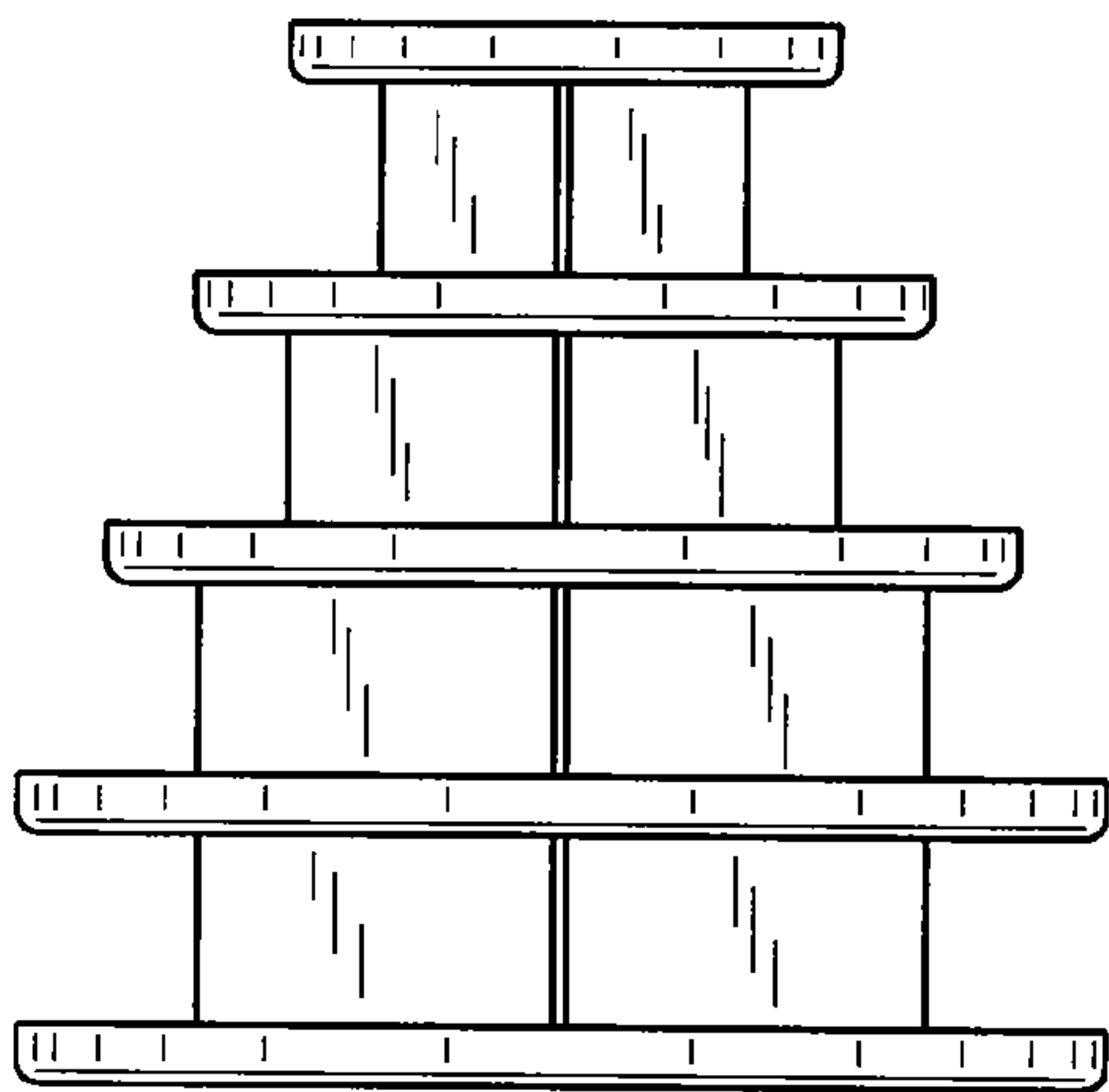

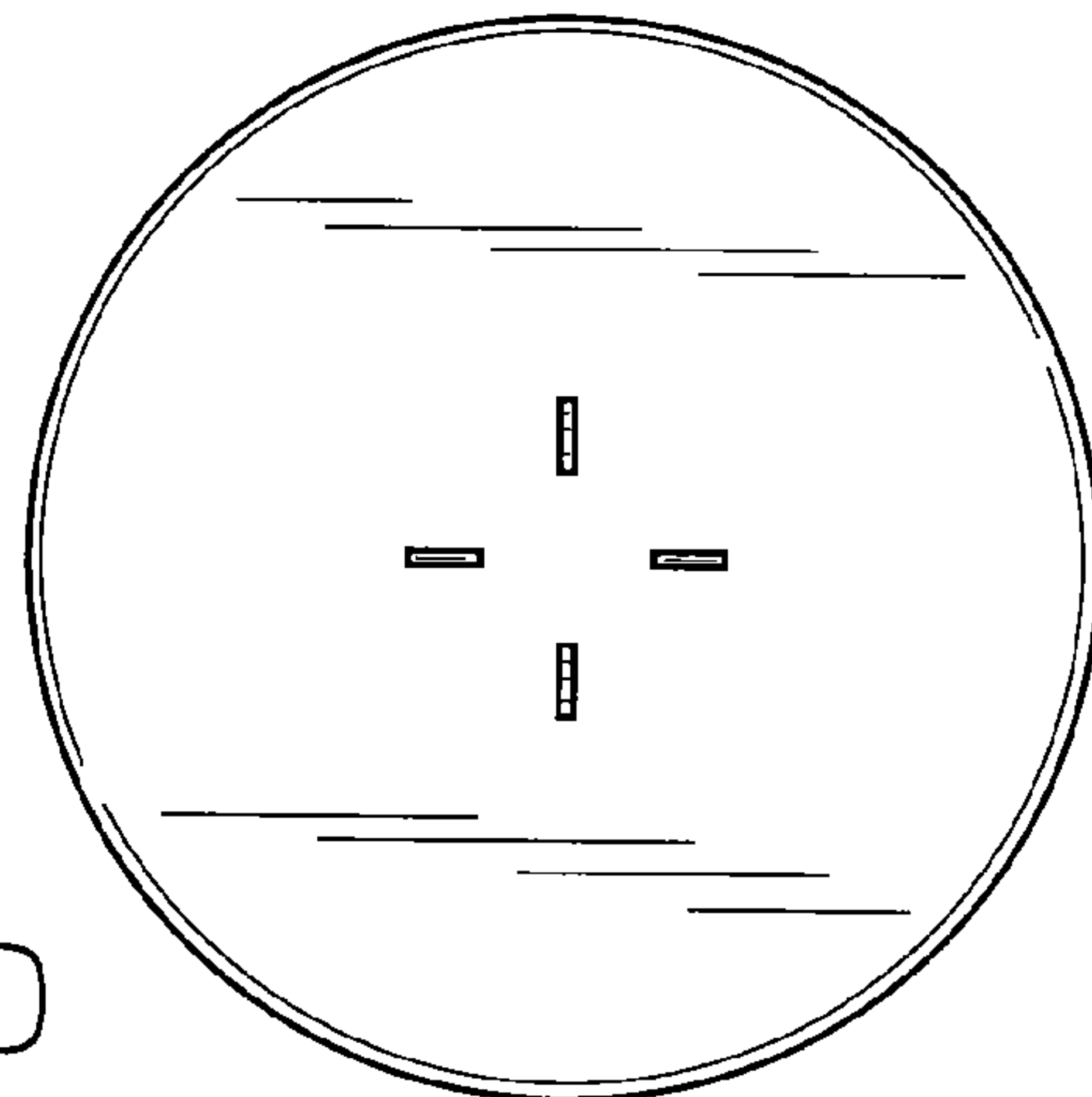
