FIG. 4 is a bottom plan view thereof;

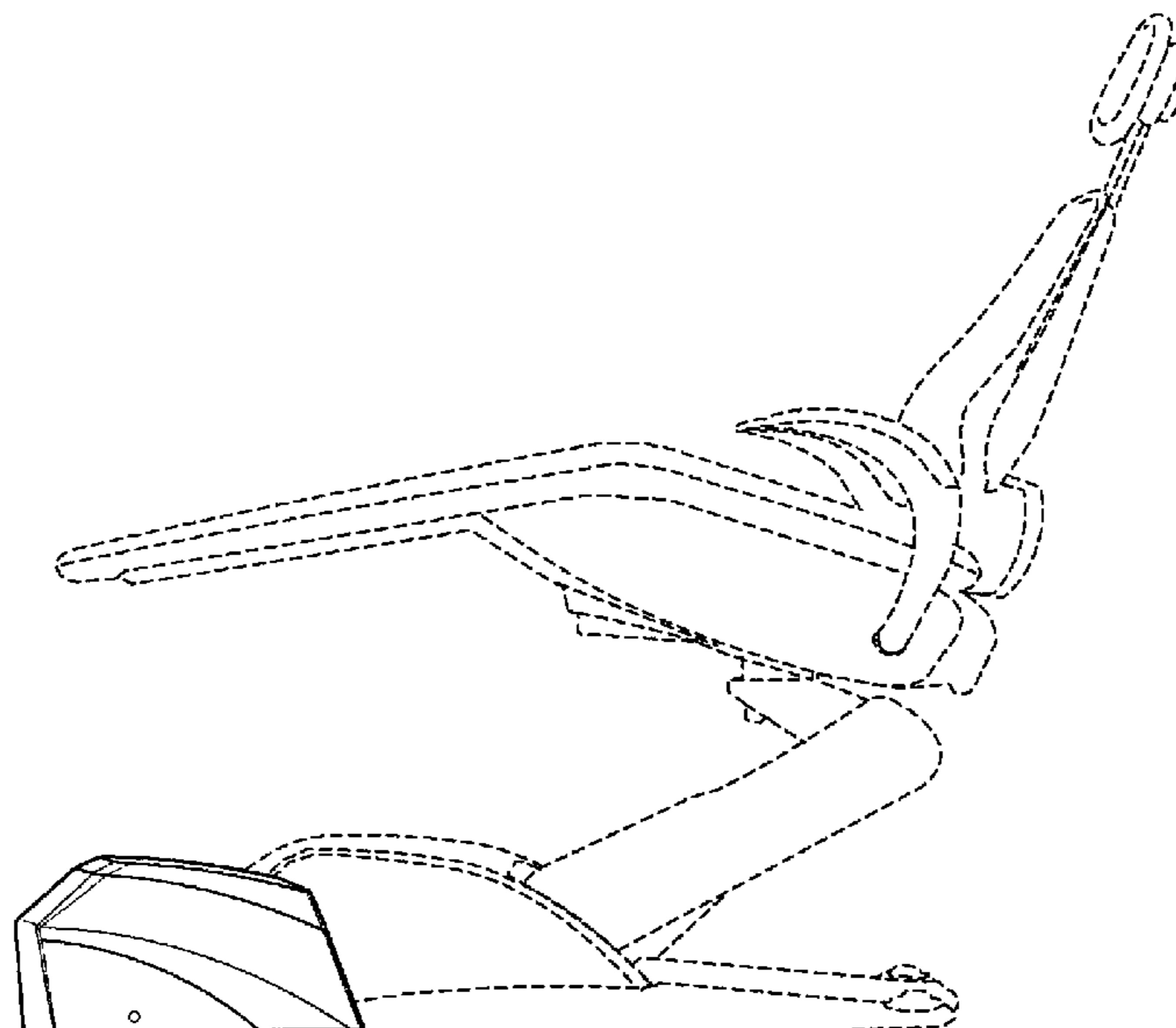
FIG. 5 is a front elevational view thereof;

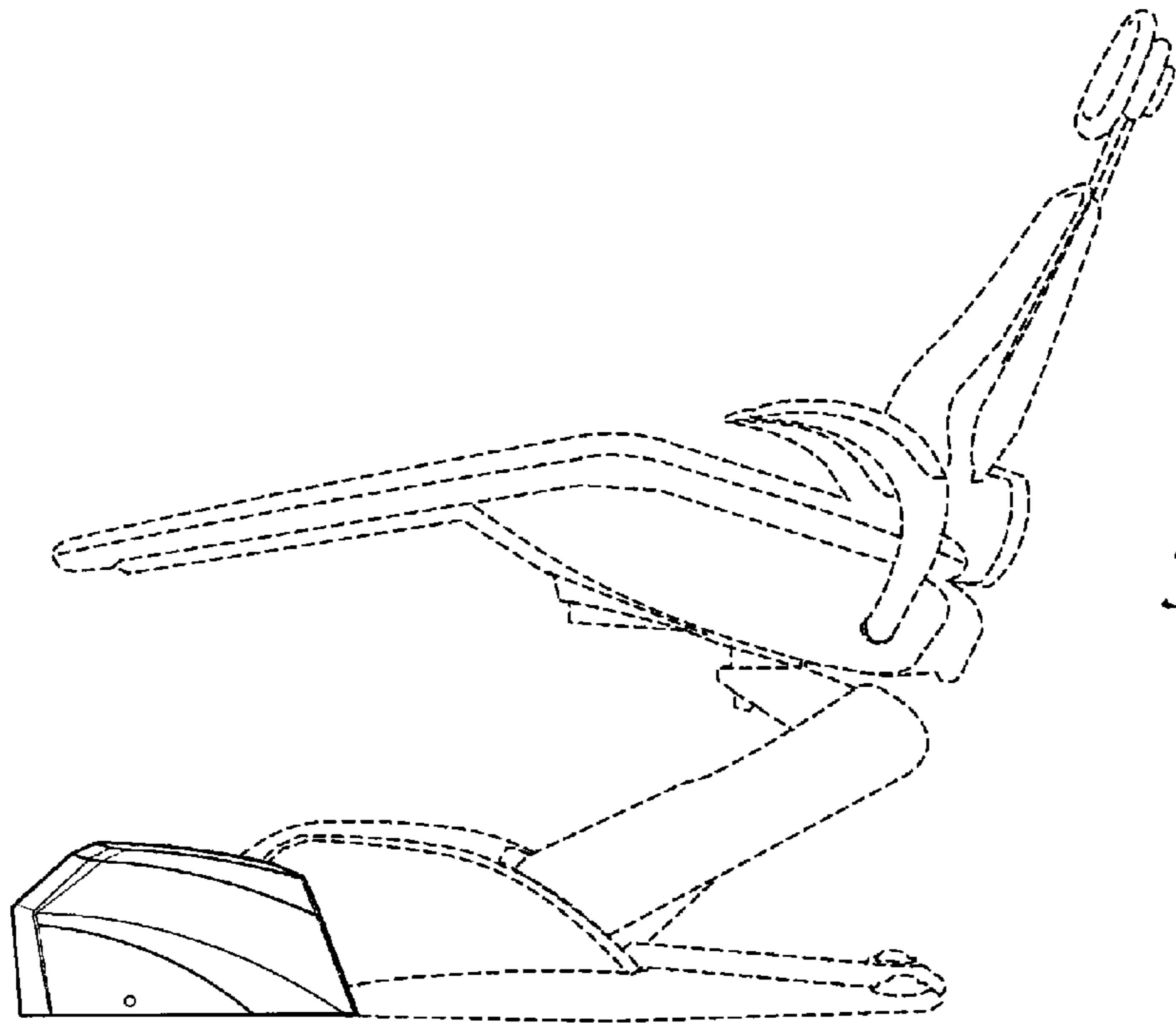
FIG. 6 is a rear elevational view thereof; and,

FIG. 7 is an enlarged side elevational view thereof.

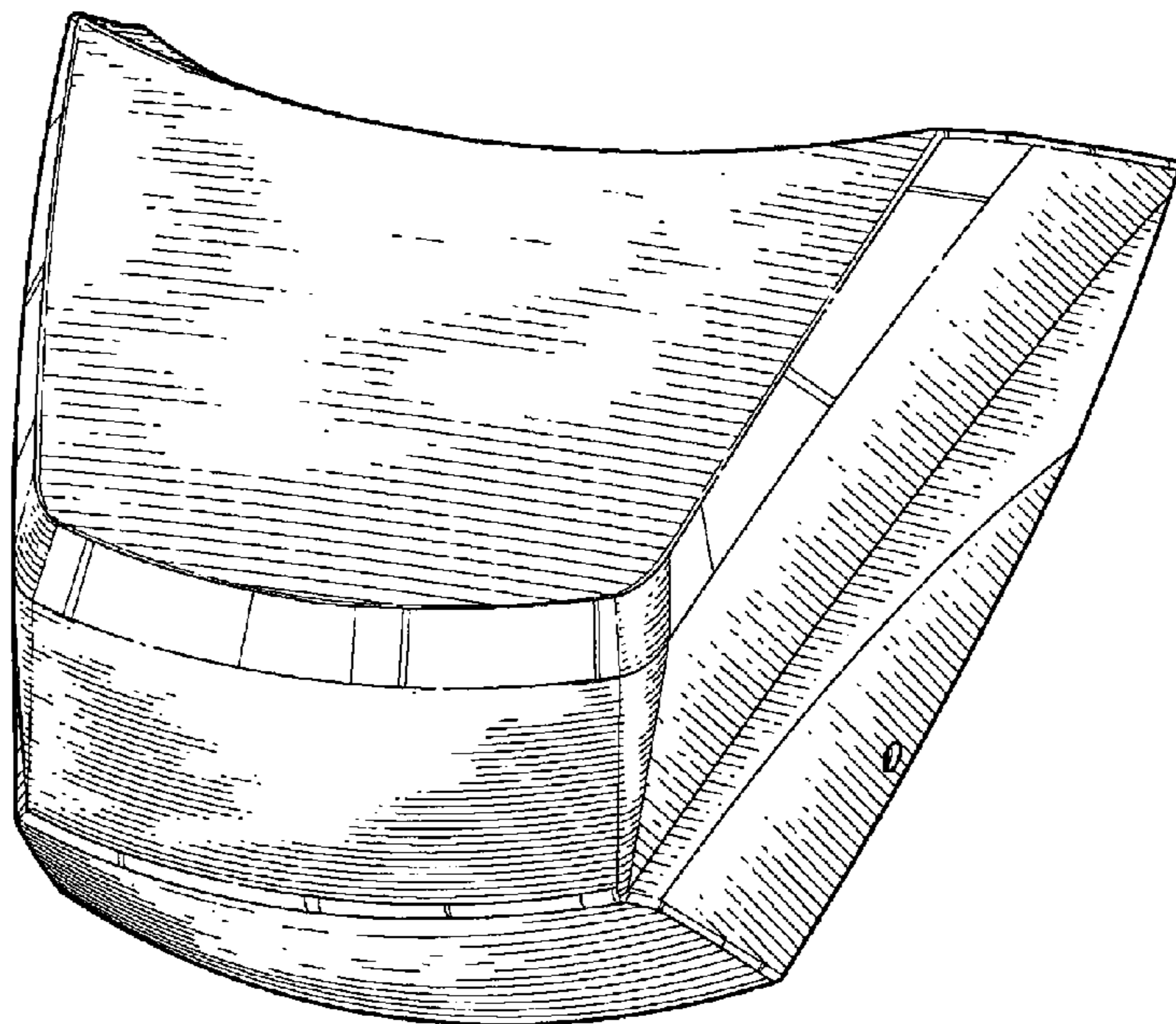

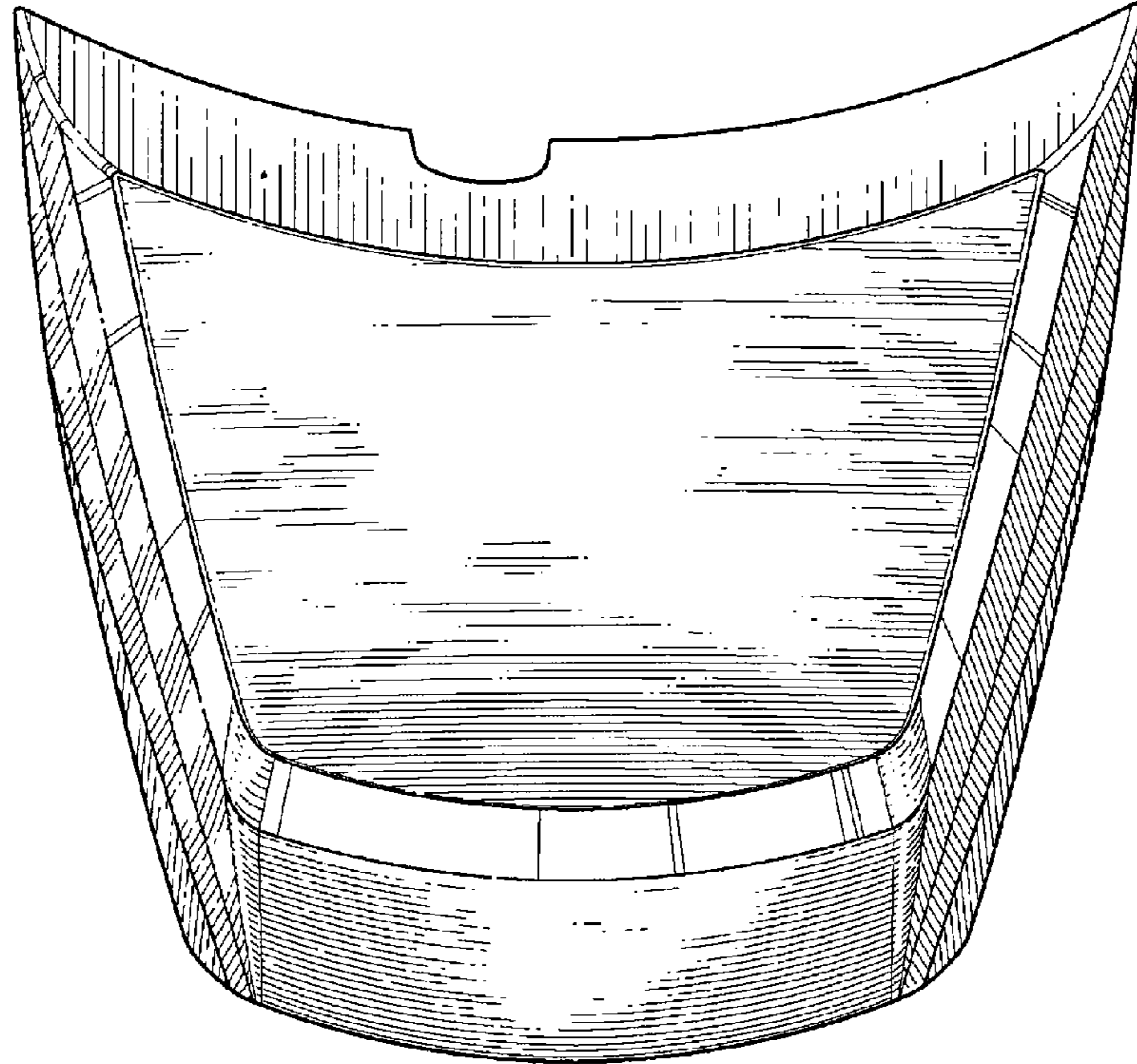

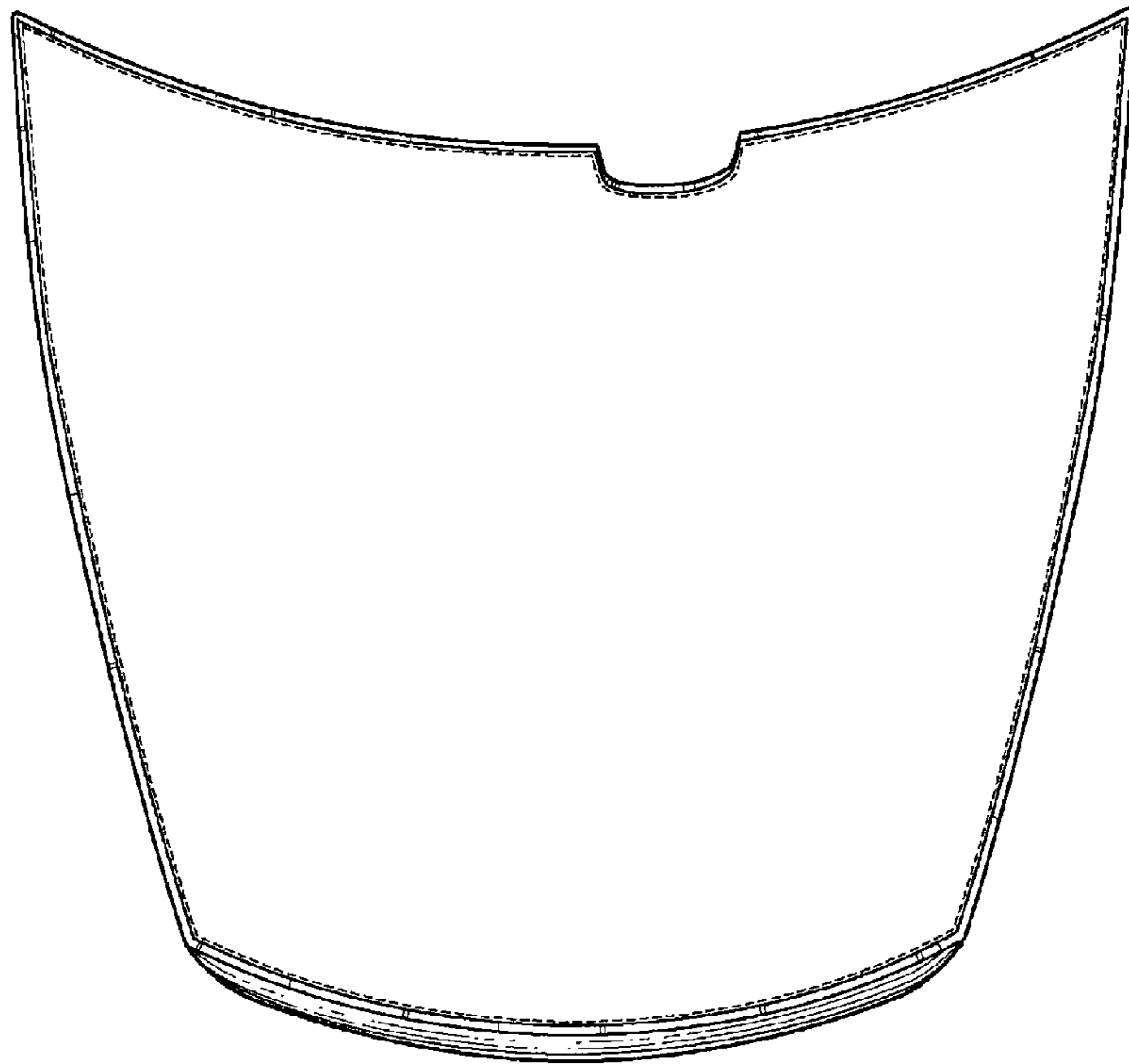


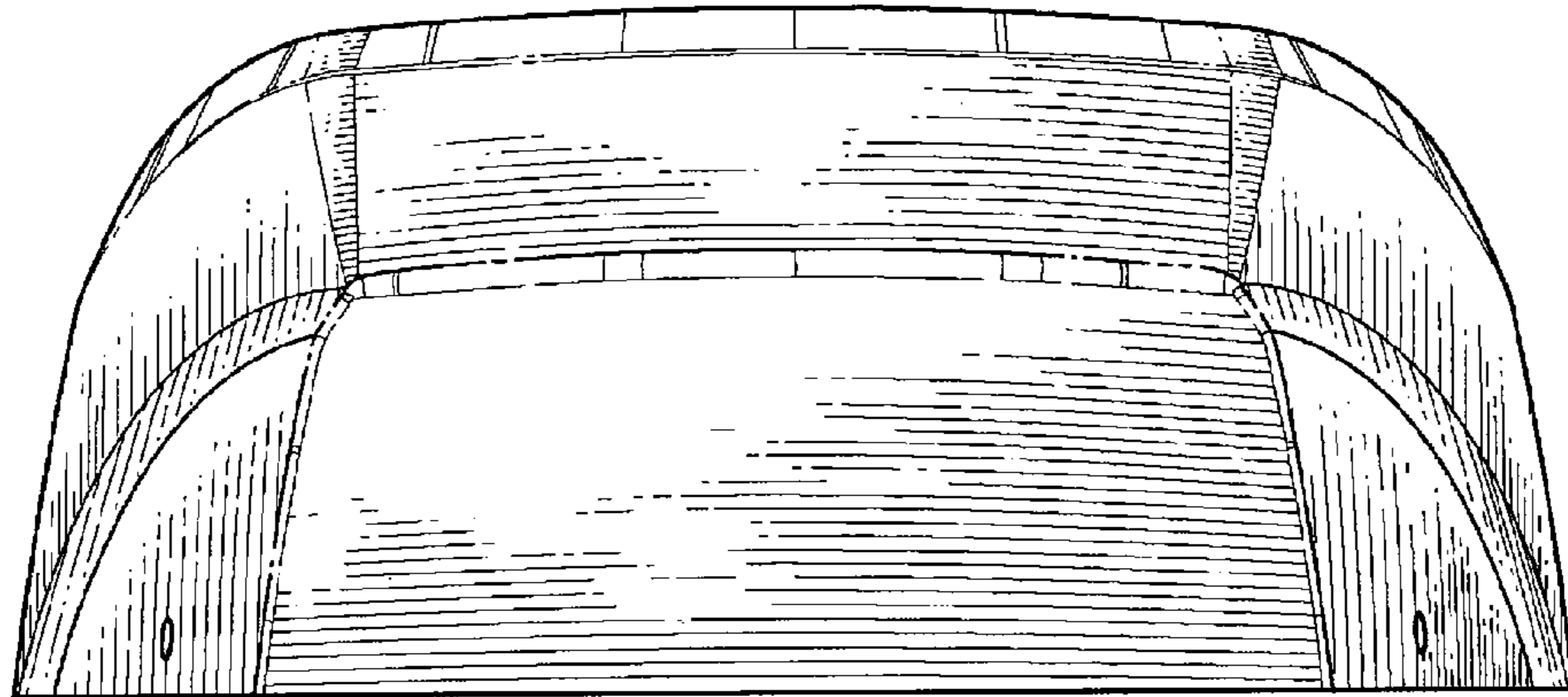

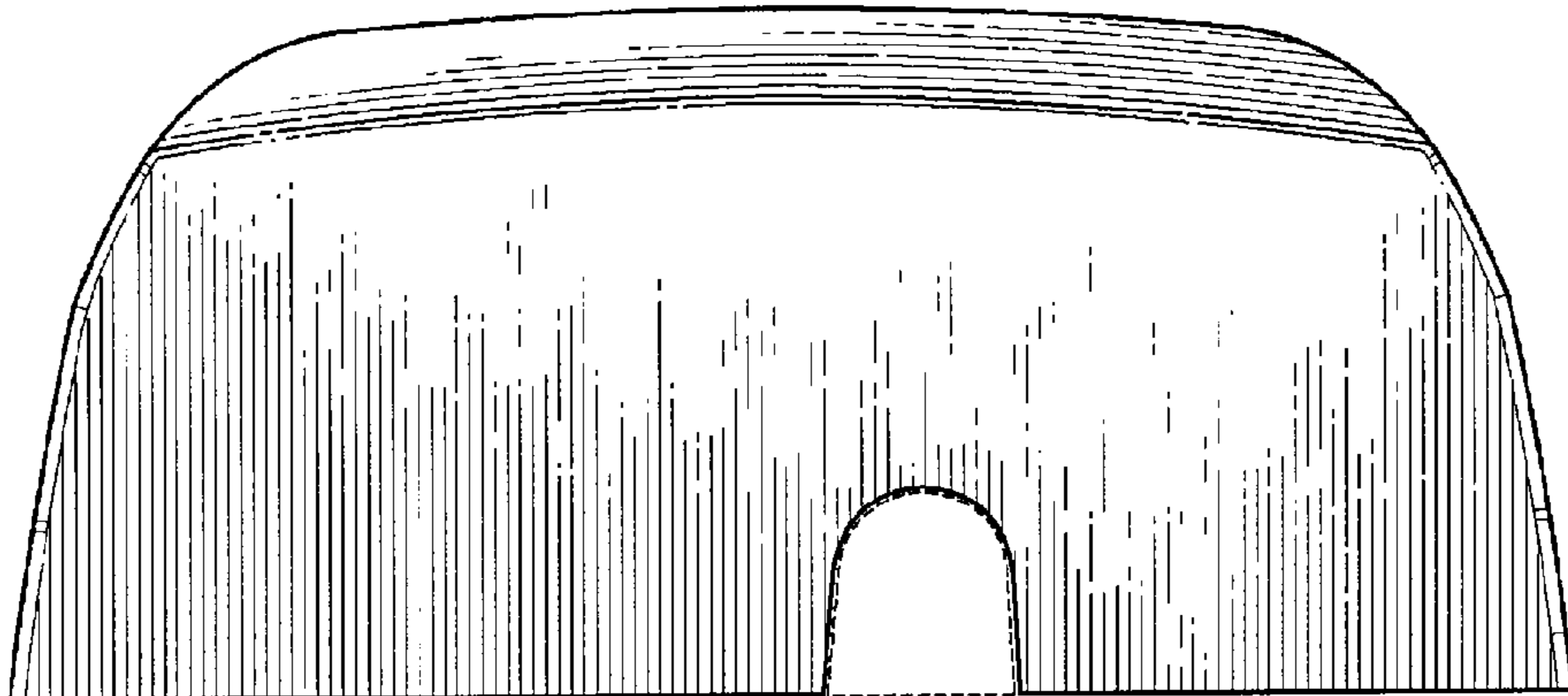
