I claim the ornamental design of a soccer ball tumbler, as shown and described.

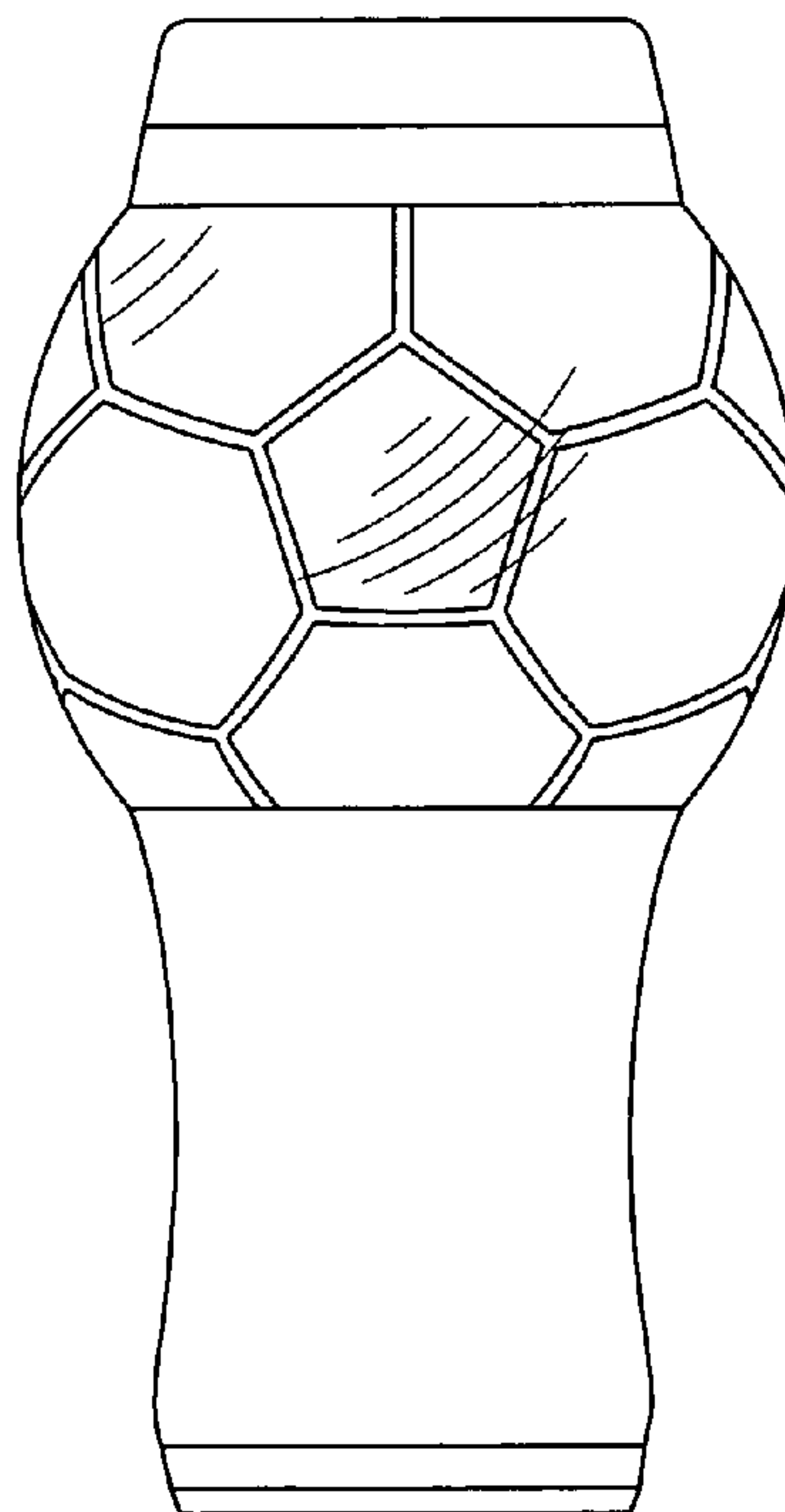
DESCRIPTION

FIG. 1: is a perspective view the soccer ball tumbler taken from above and to one side; and,

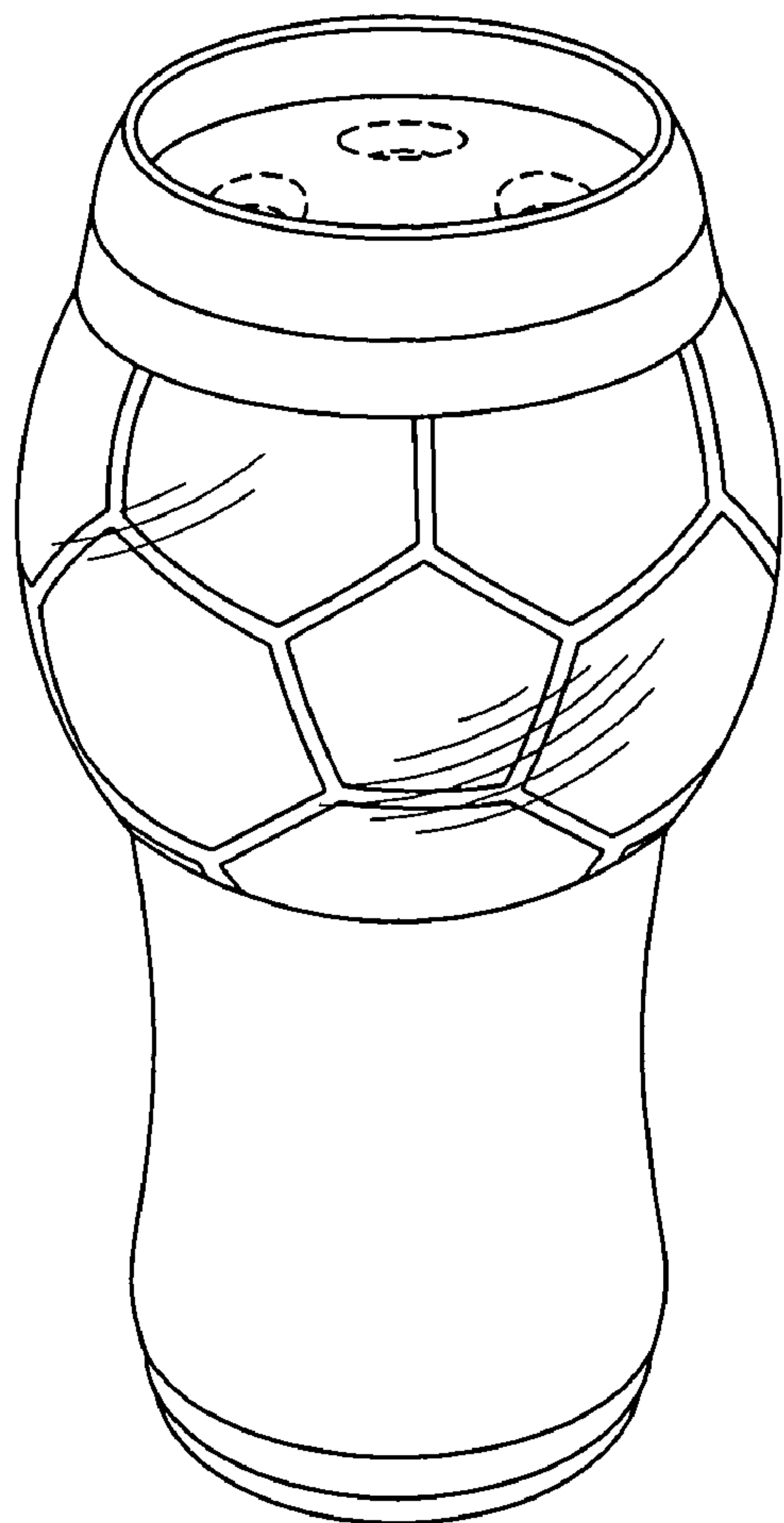

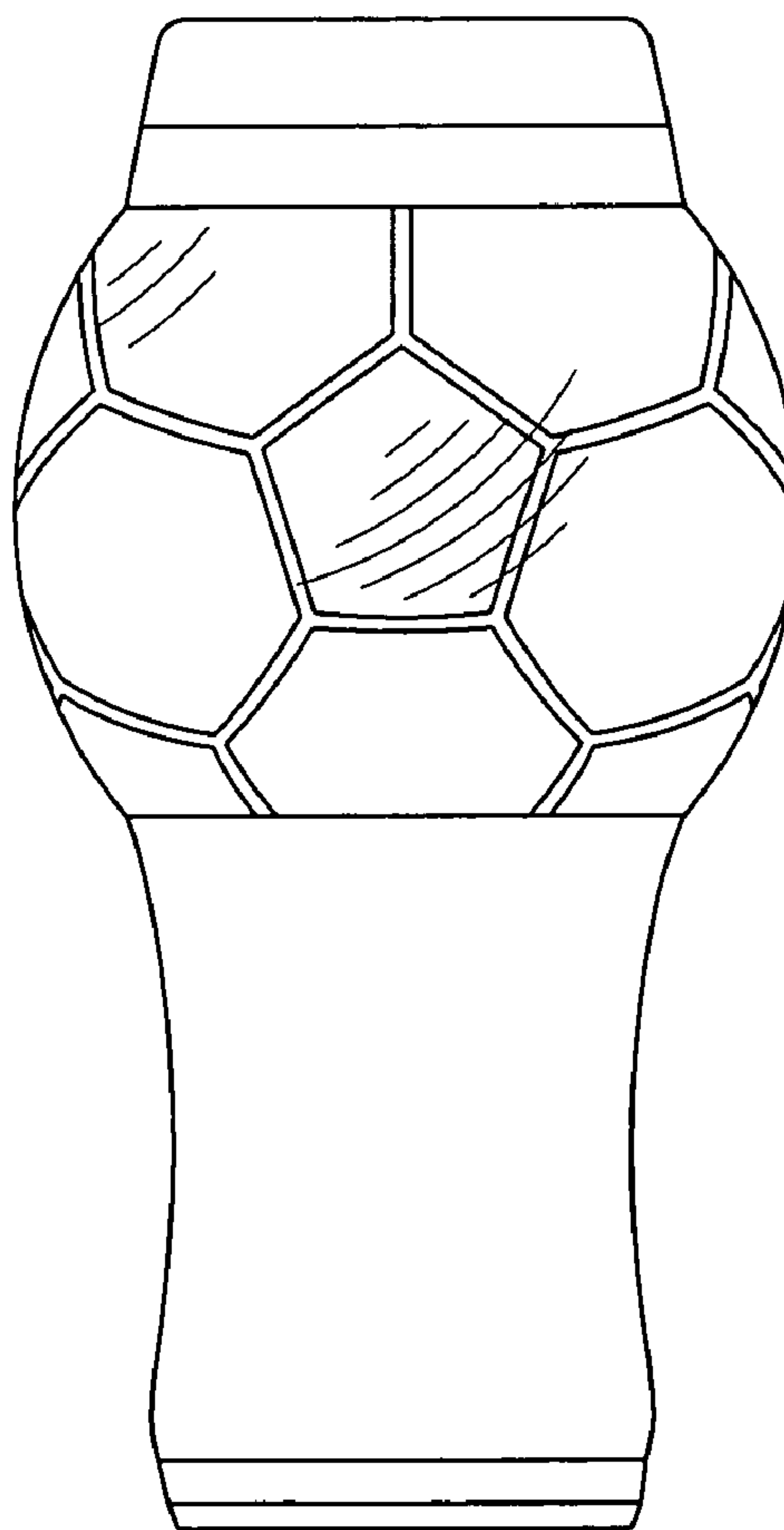
