showing our new design;

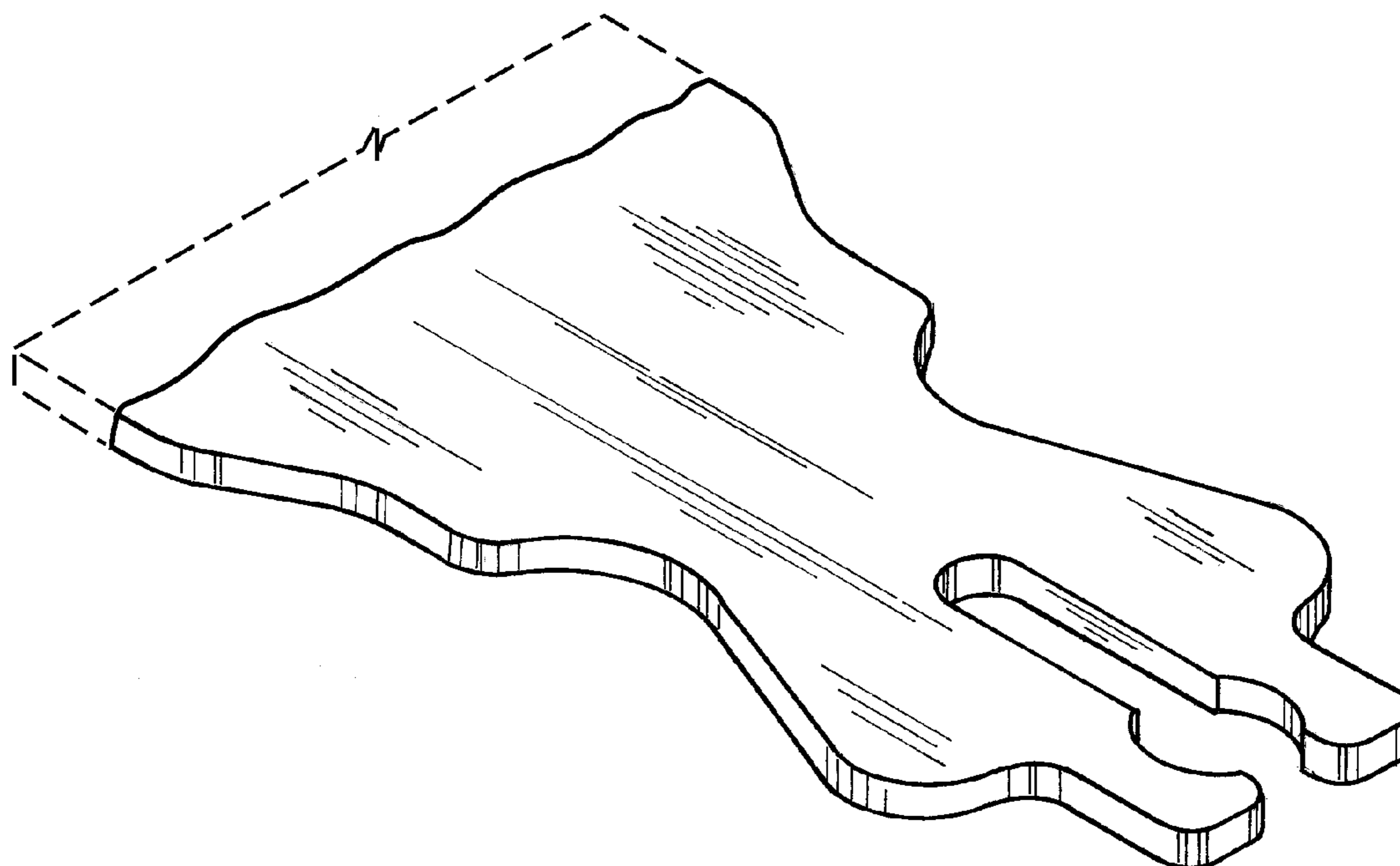
FIG. 2 is a top plan view thereof, the bottom plan view being  
a mirror image thereof;

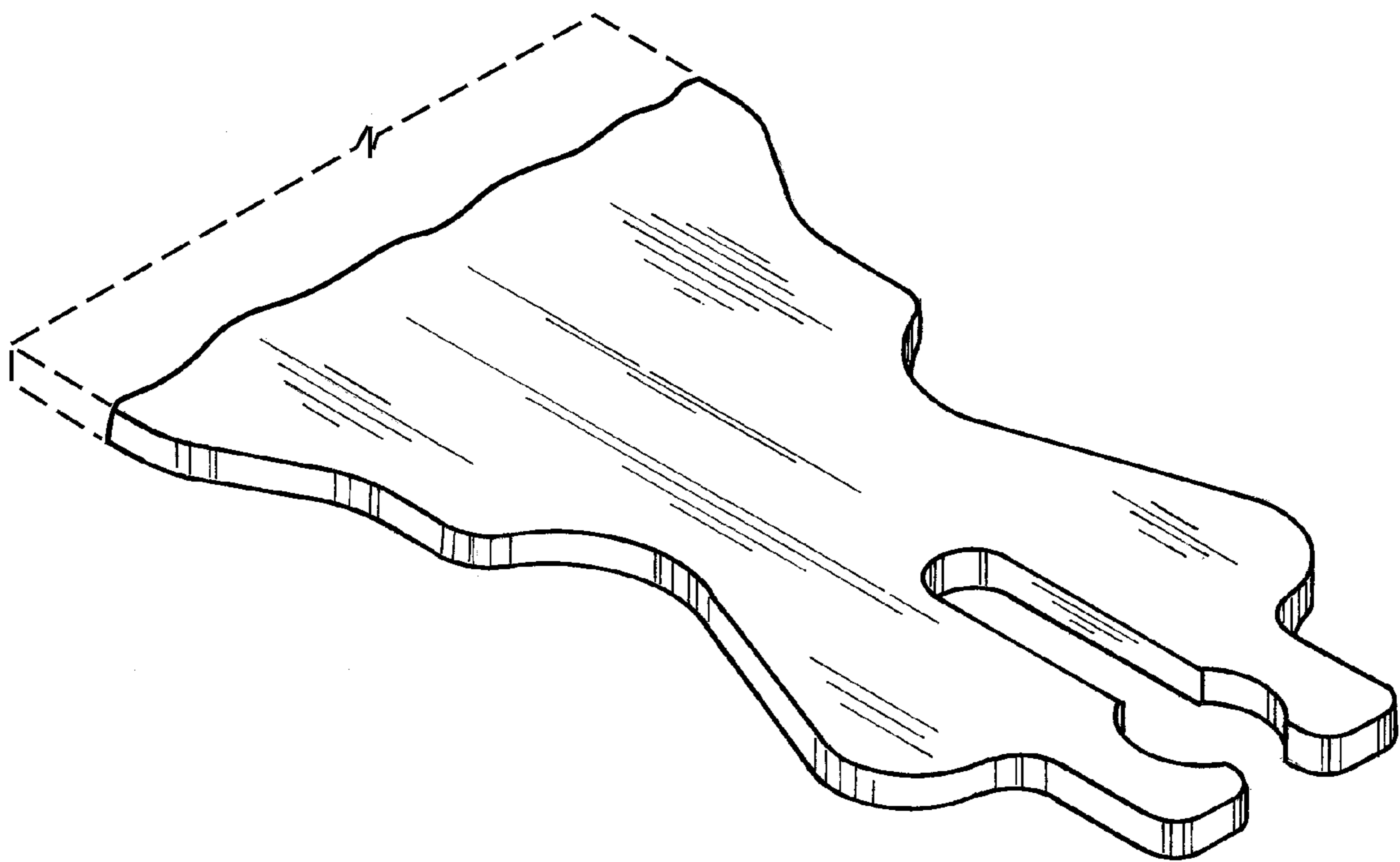
FIG. 3 is a side elevational view thereof, the opposite side

FIG. 4 is a rear elevational view thereof.

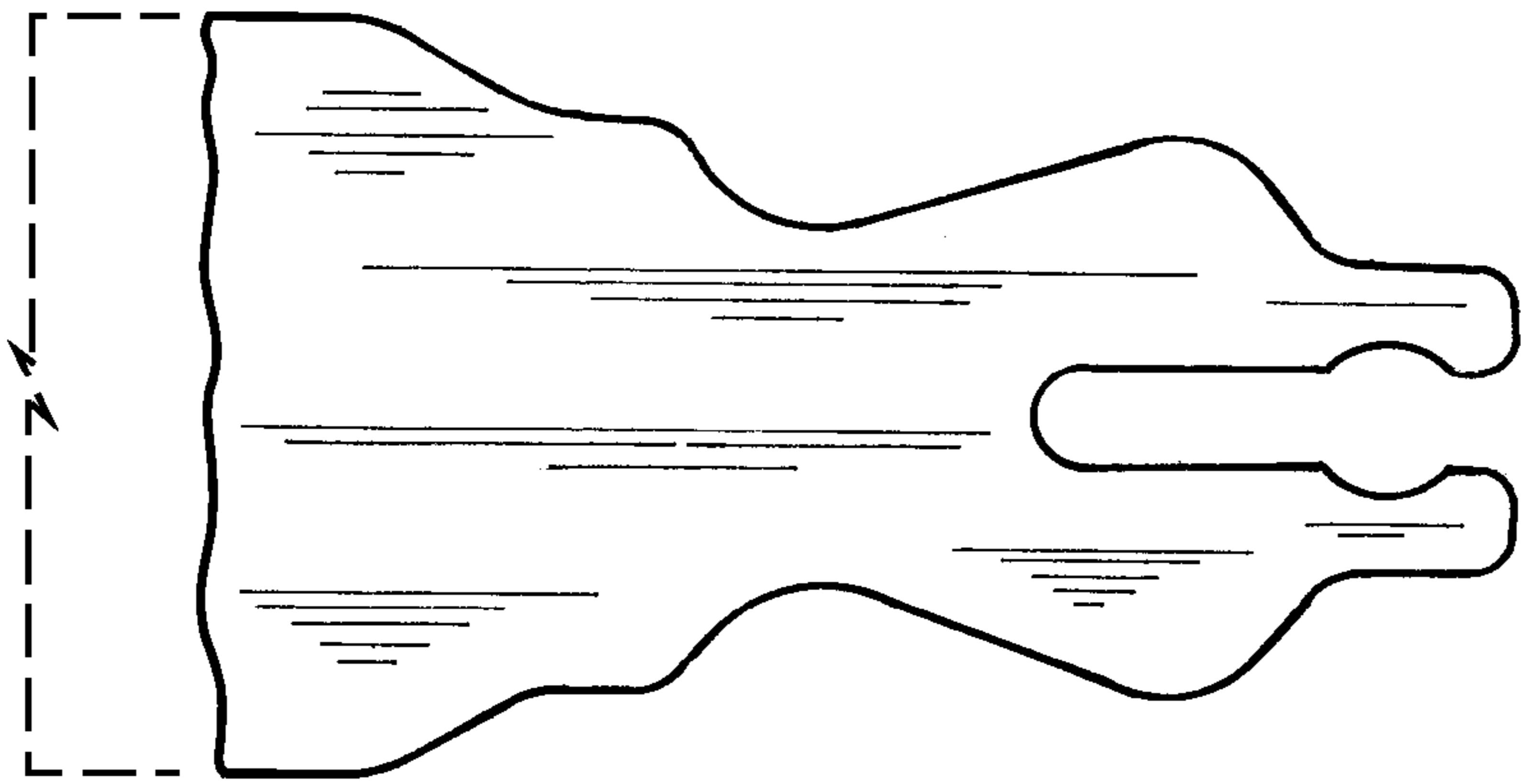
The broken lines showing of the cutting portion of the surgical
