FIG. 6 is a perspective view of a second embodiment of a personal care dispenser showing my design;

FIG. 9 is a side elevation view thereof, the other side elevation view being a mirror image thereof;

FIG. 13 is a rear elevation view thereof;

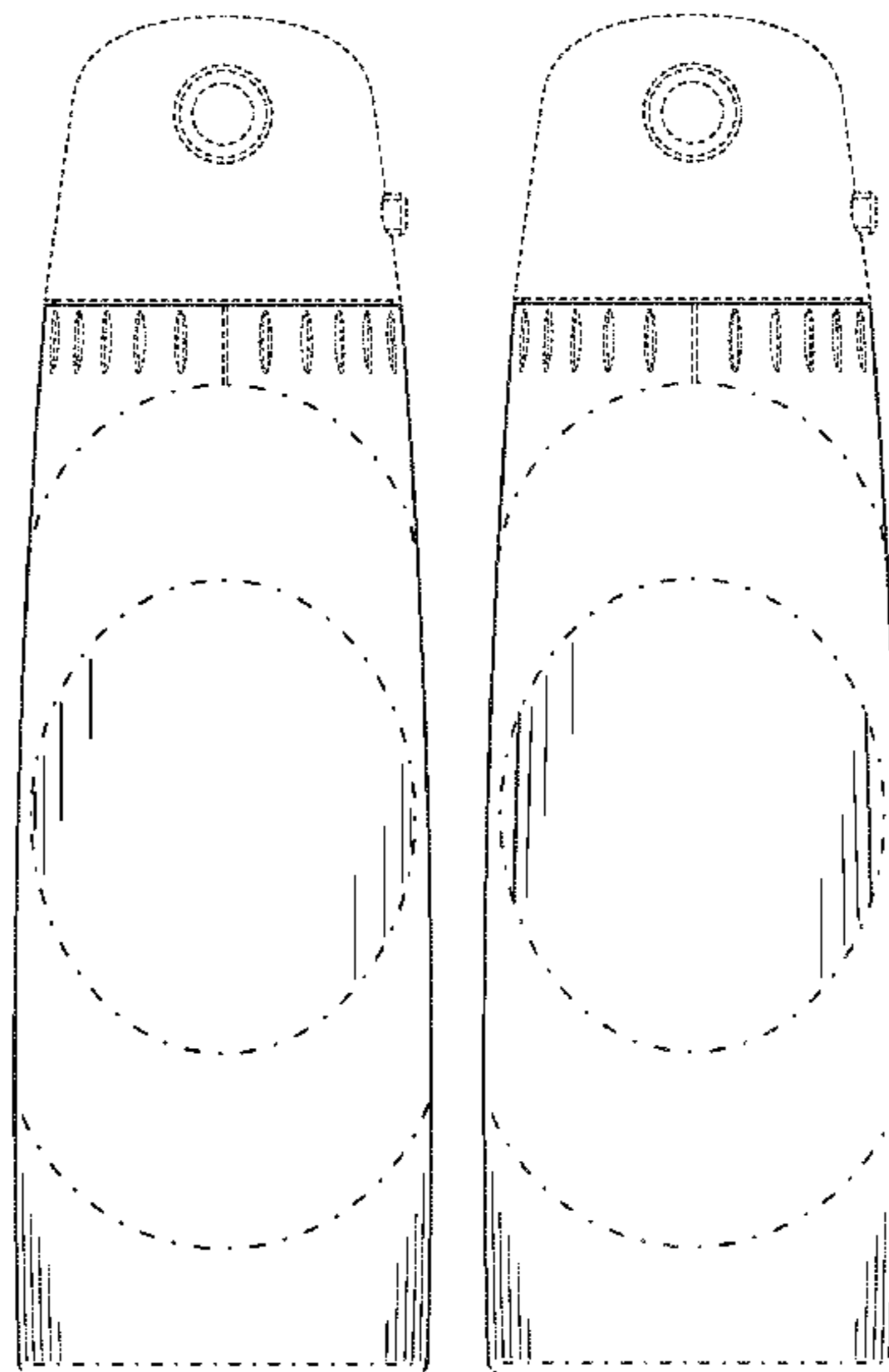
FIG. 14 is a side elevation view thereof, the other side elevation view being a mirror image thereof; and,

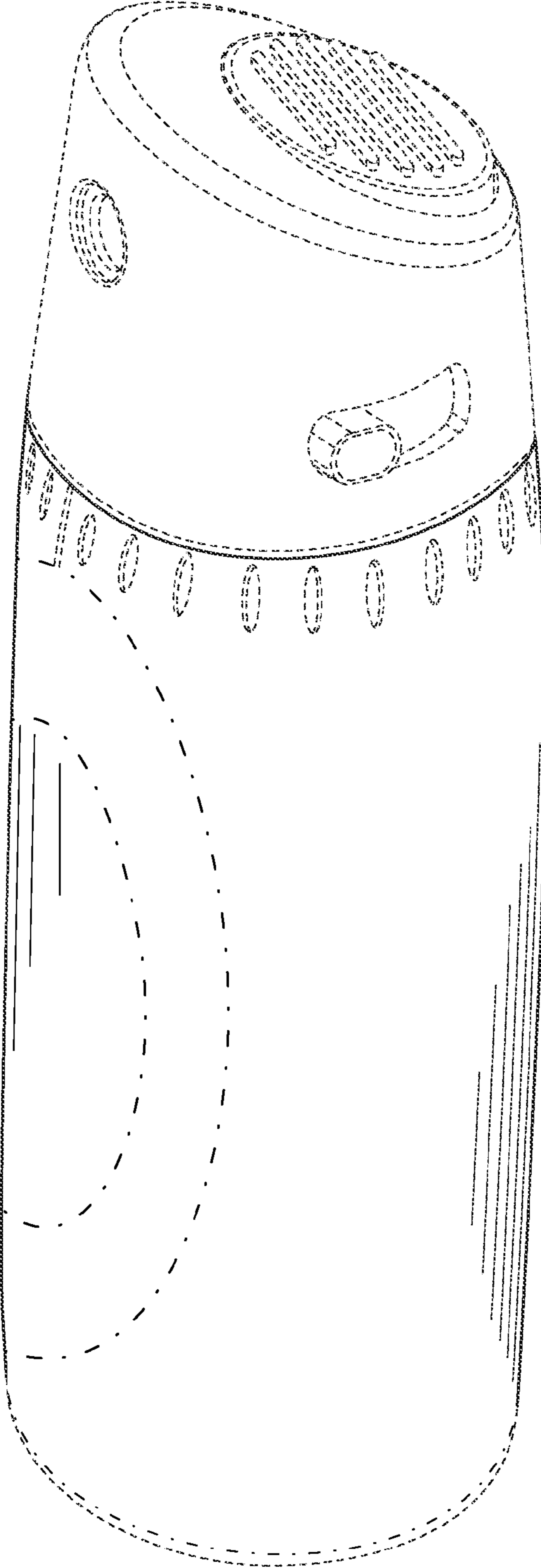

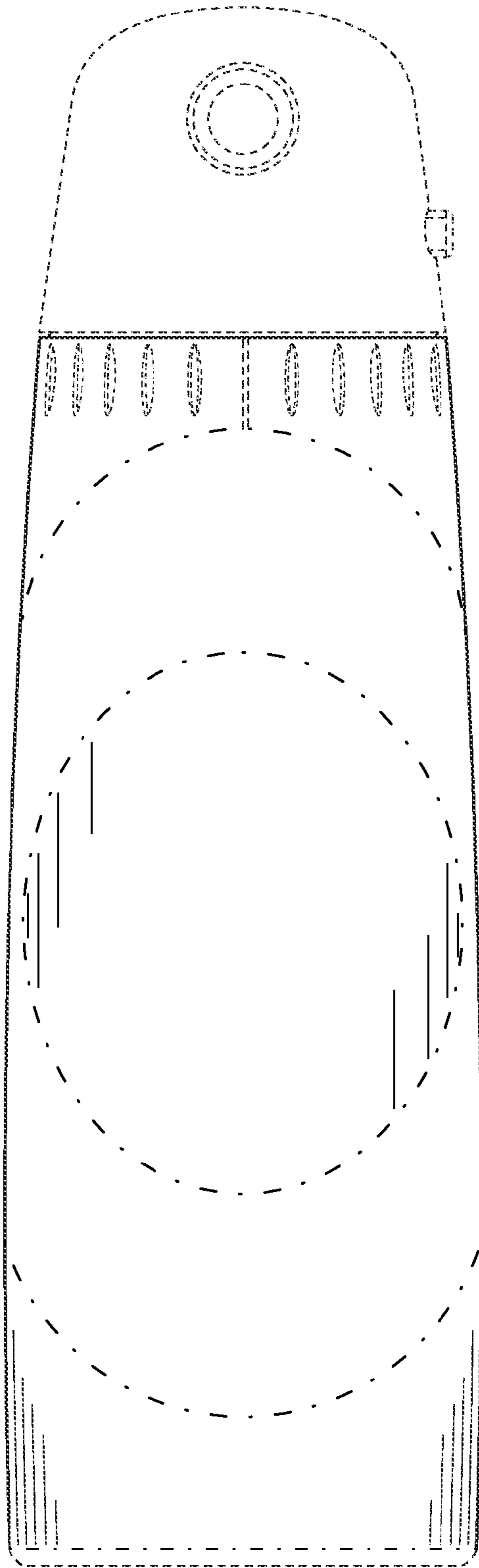

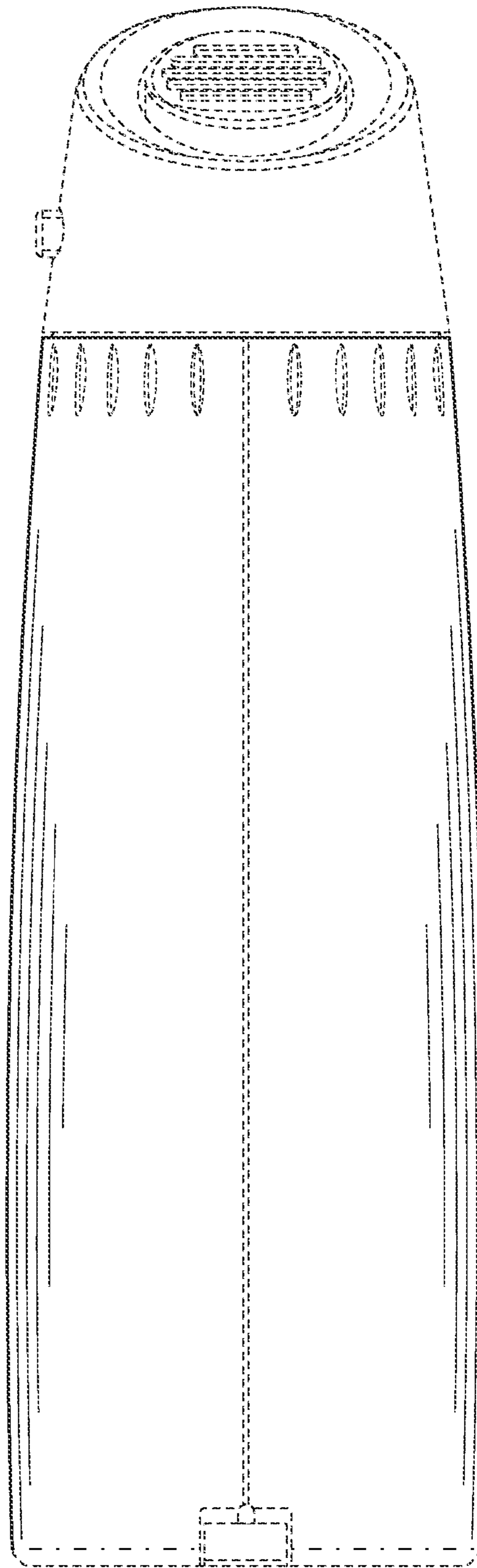

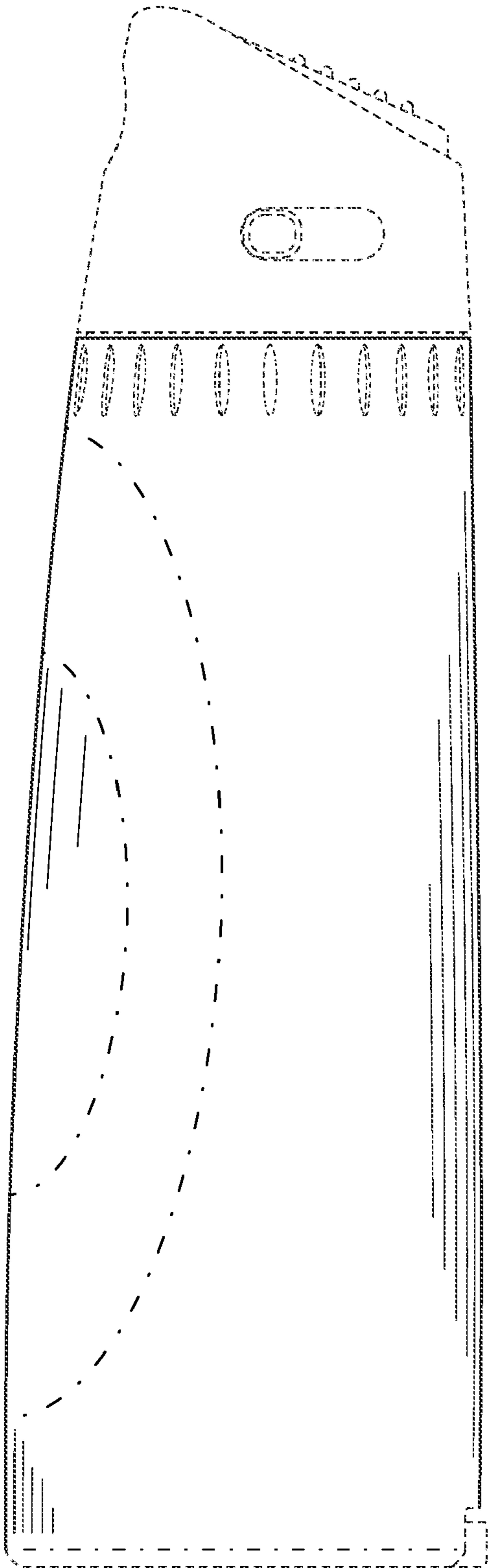

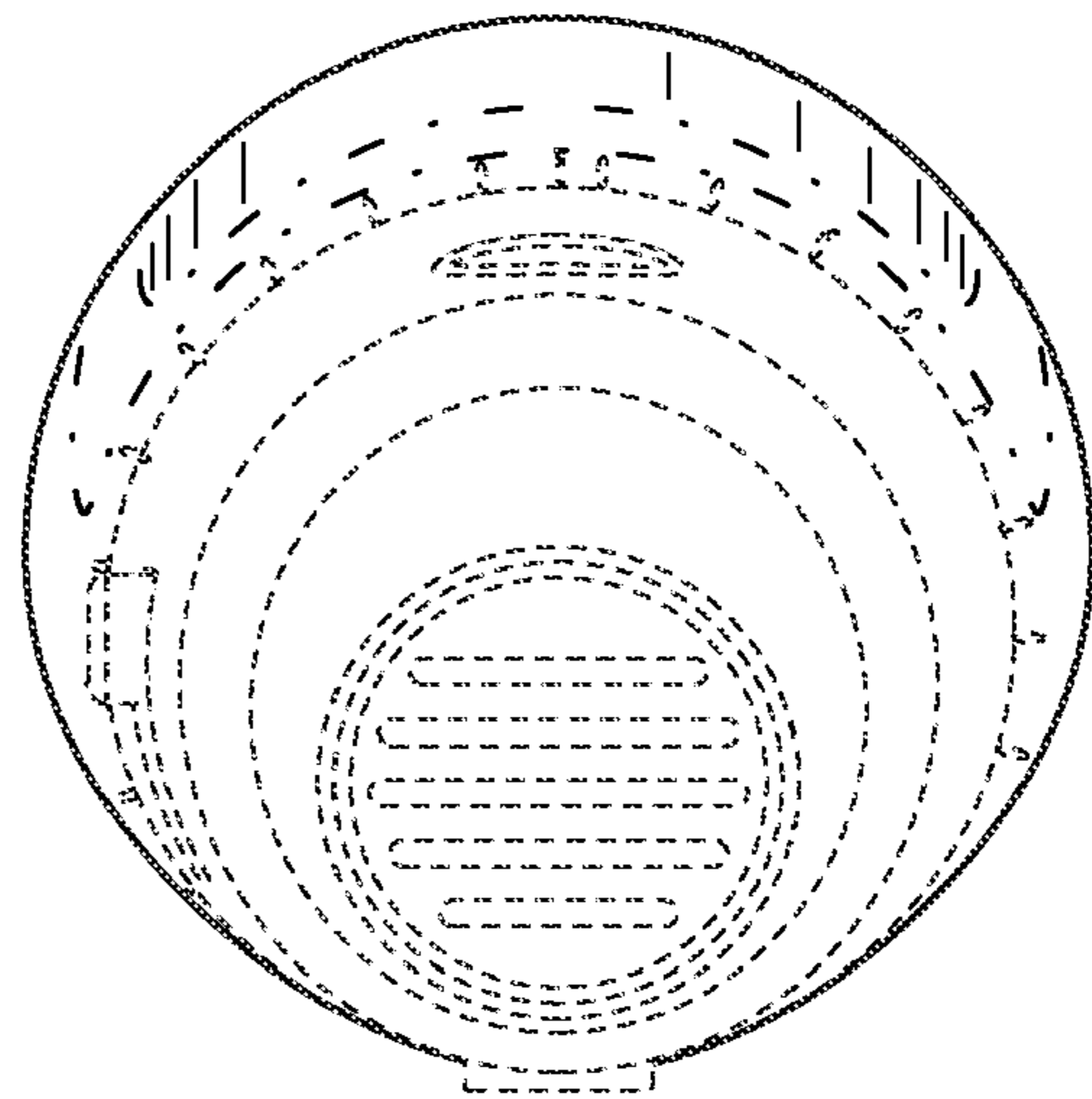

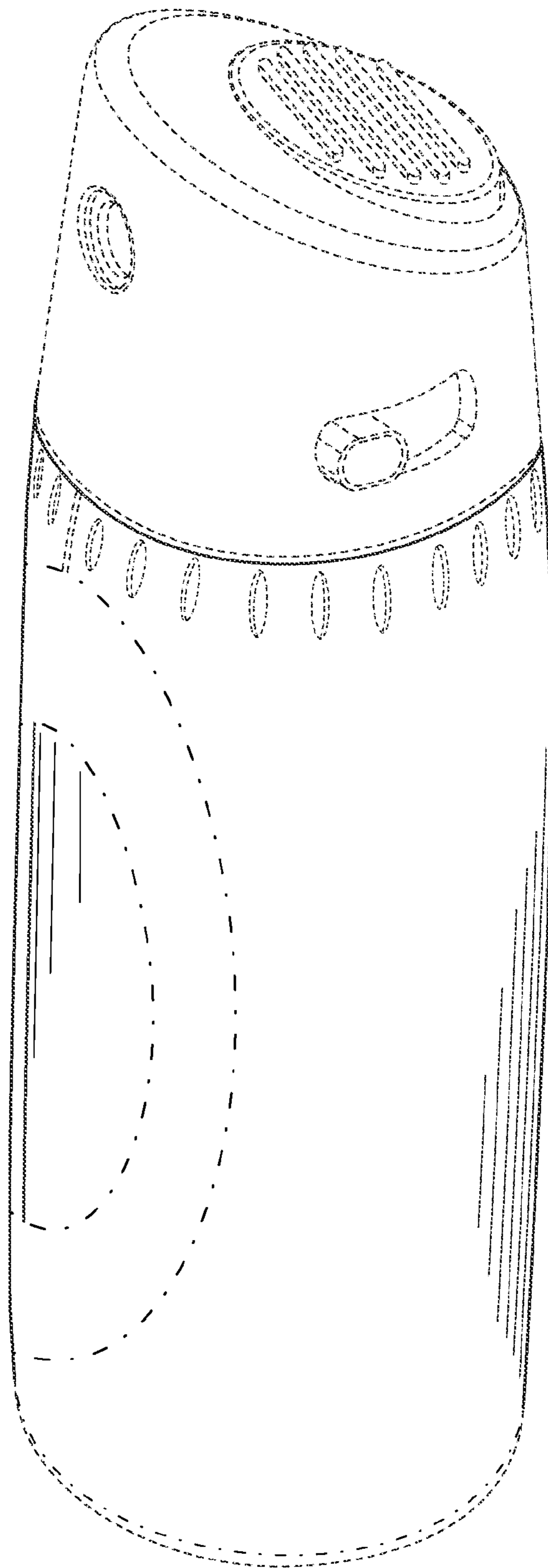

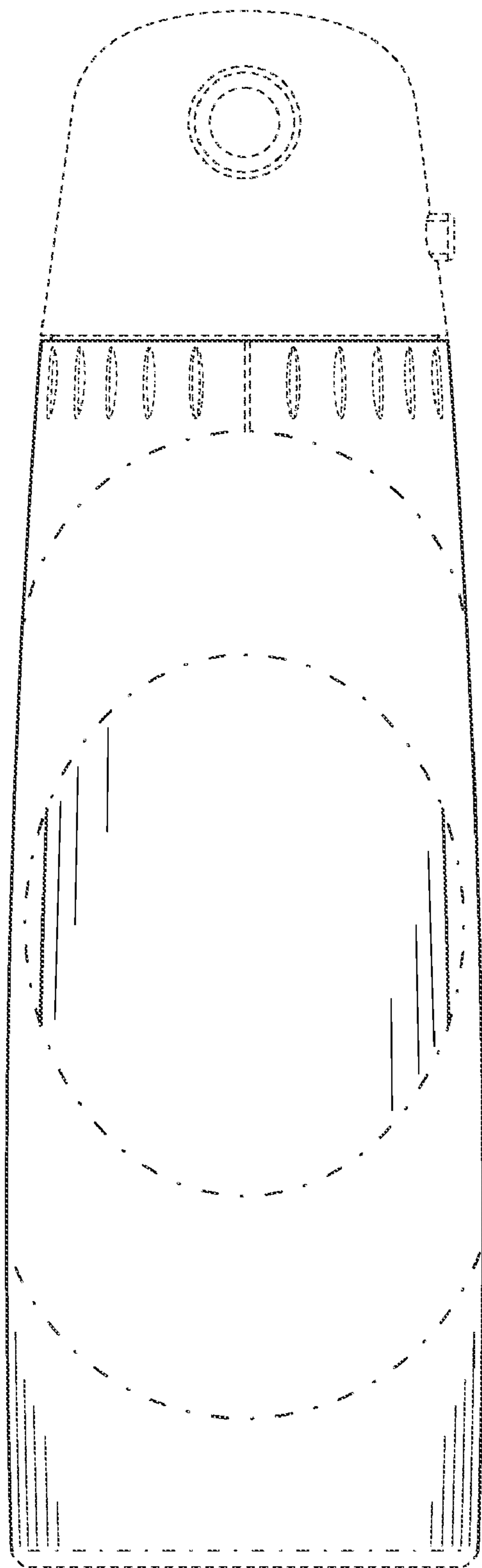

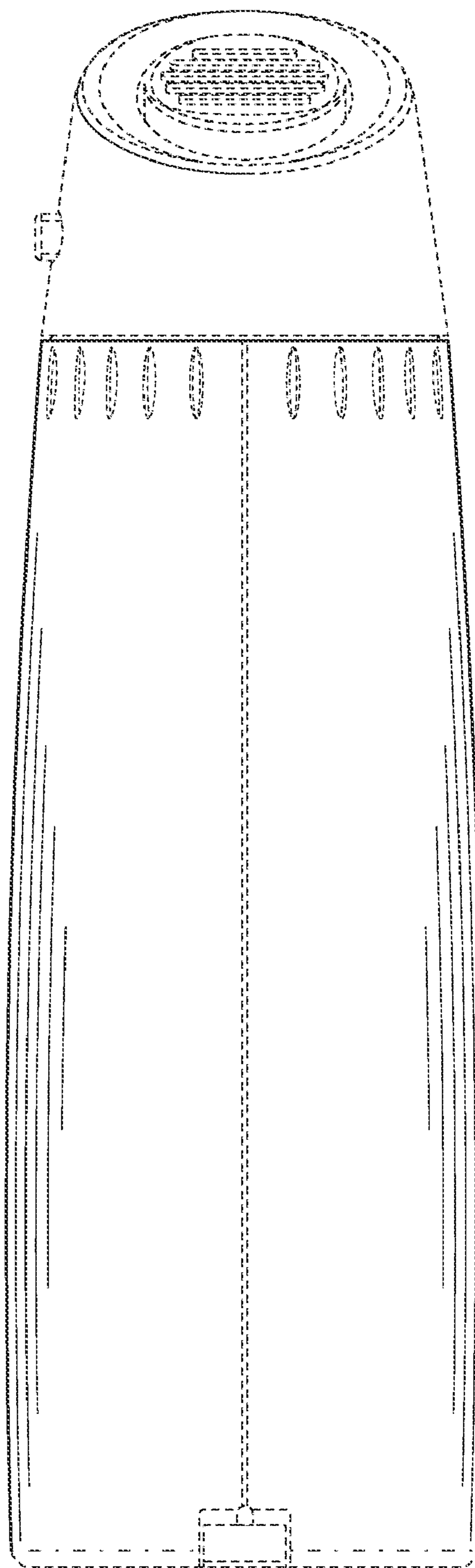

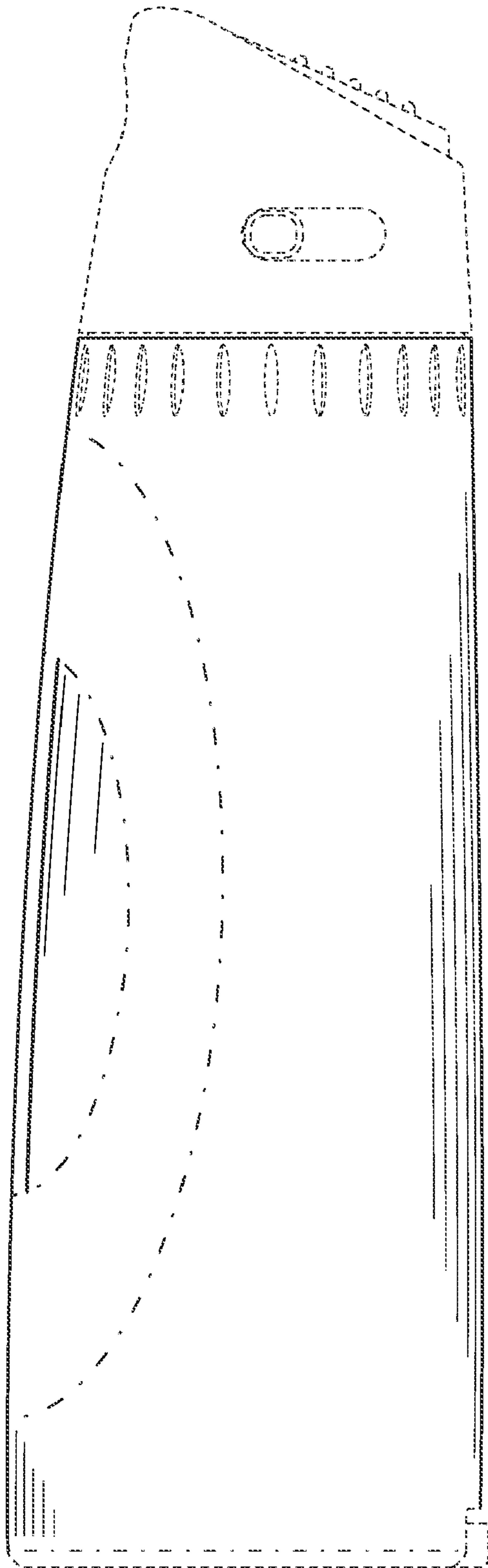

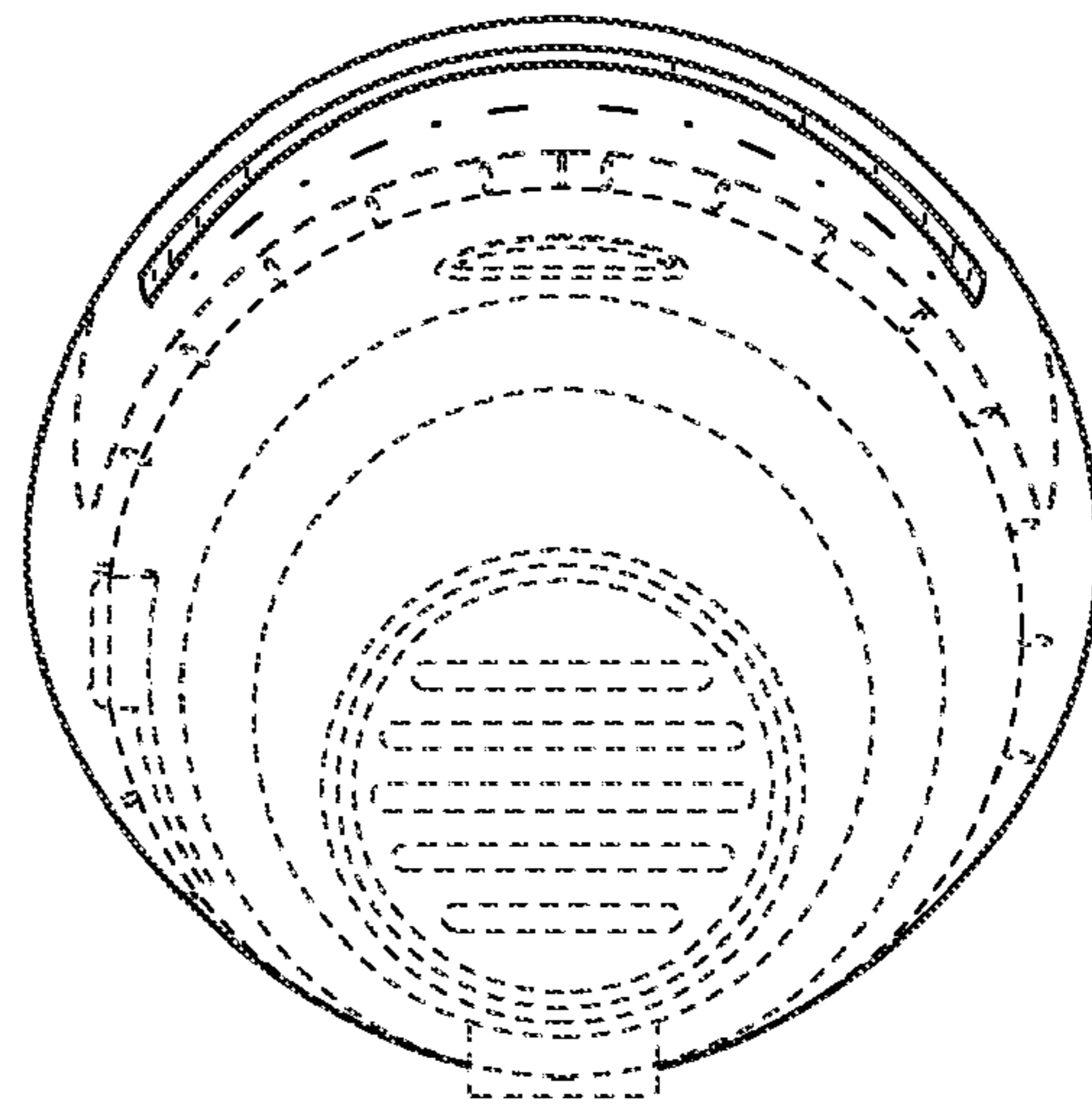

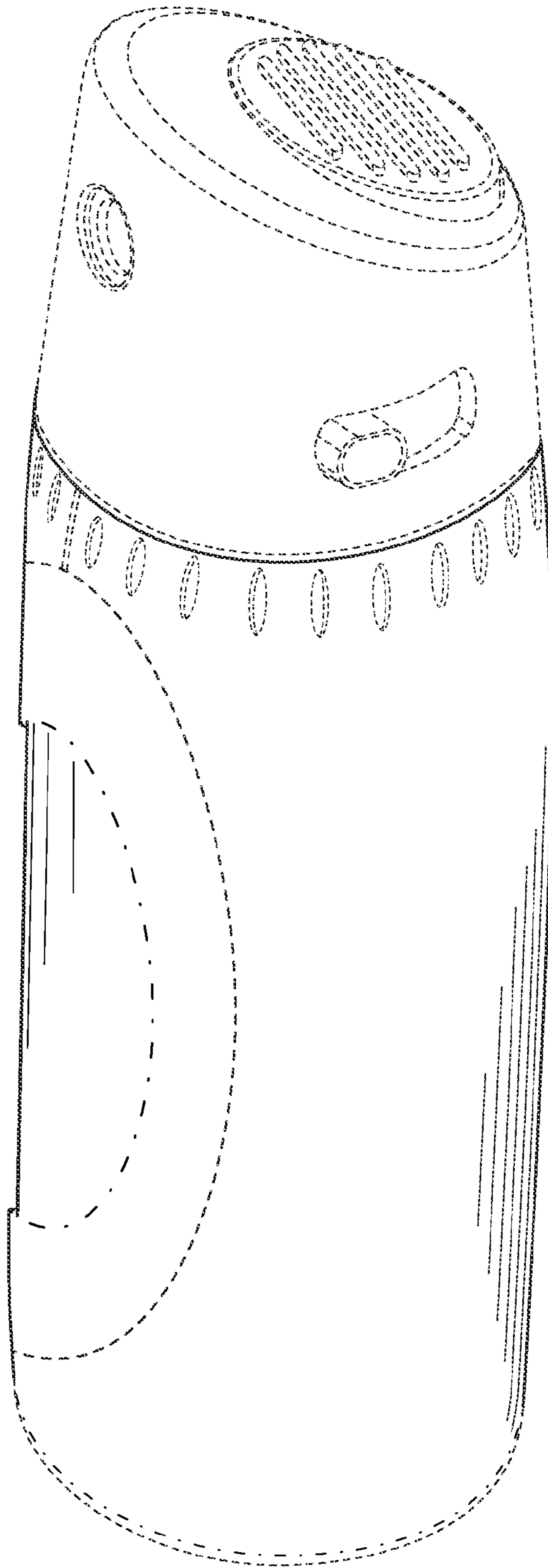

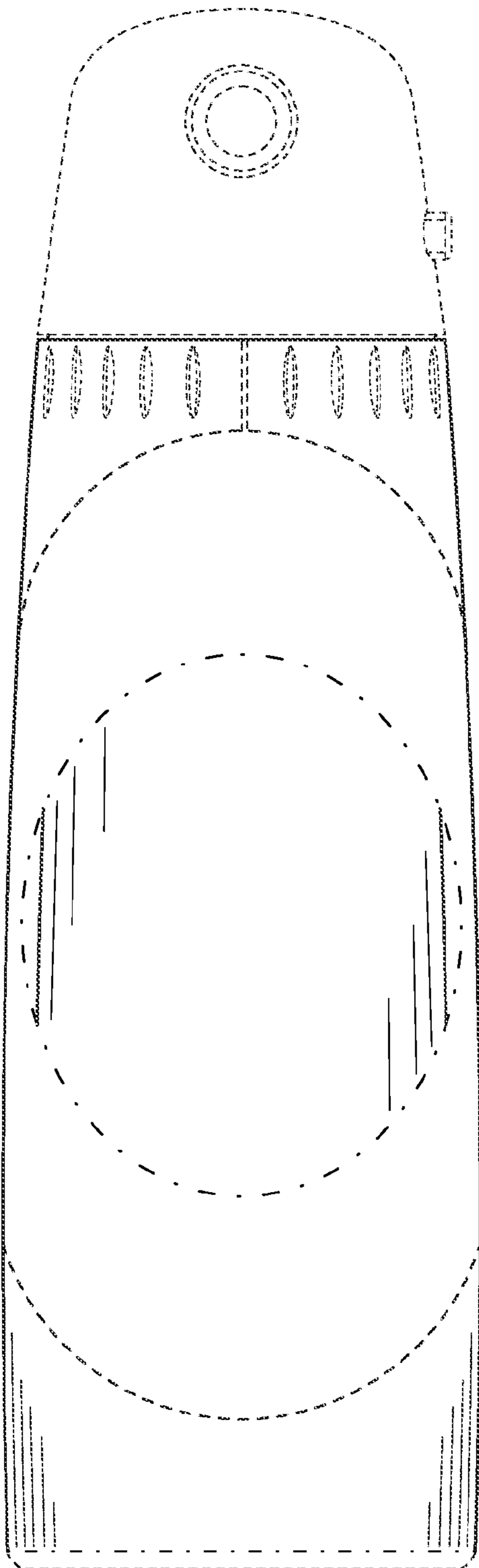

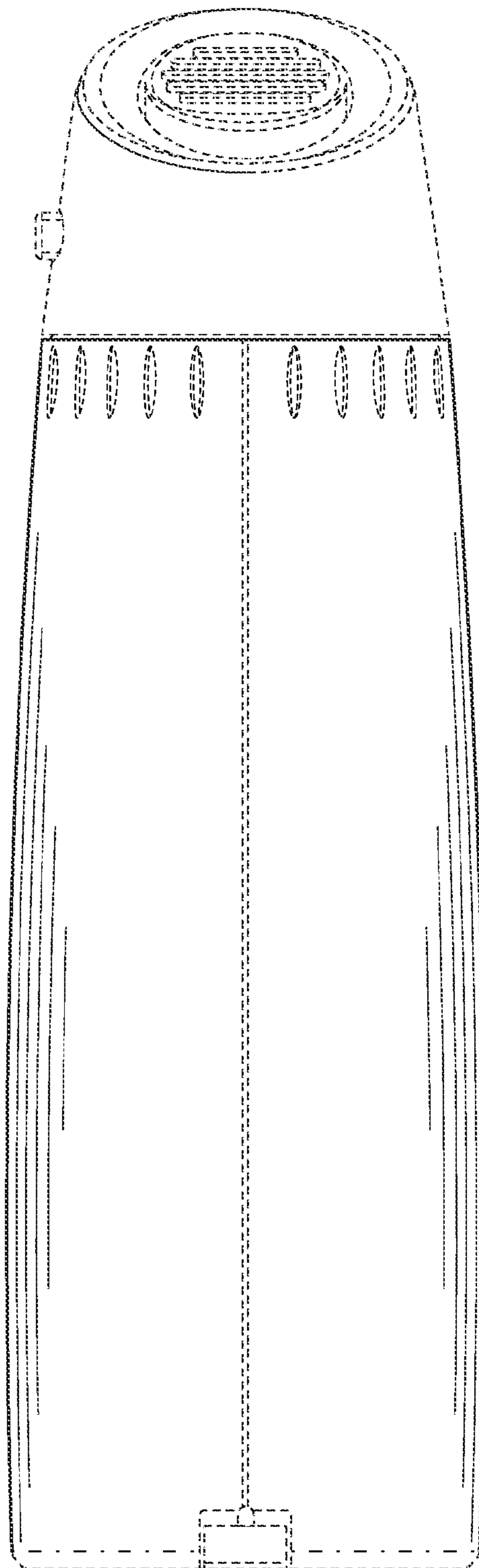

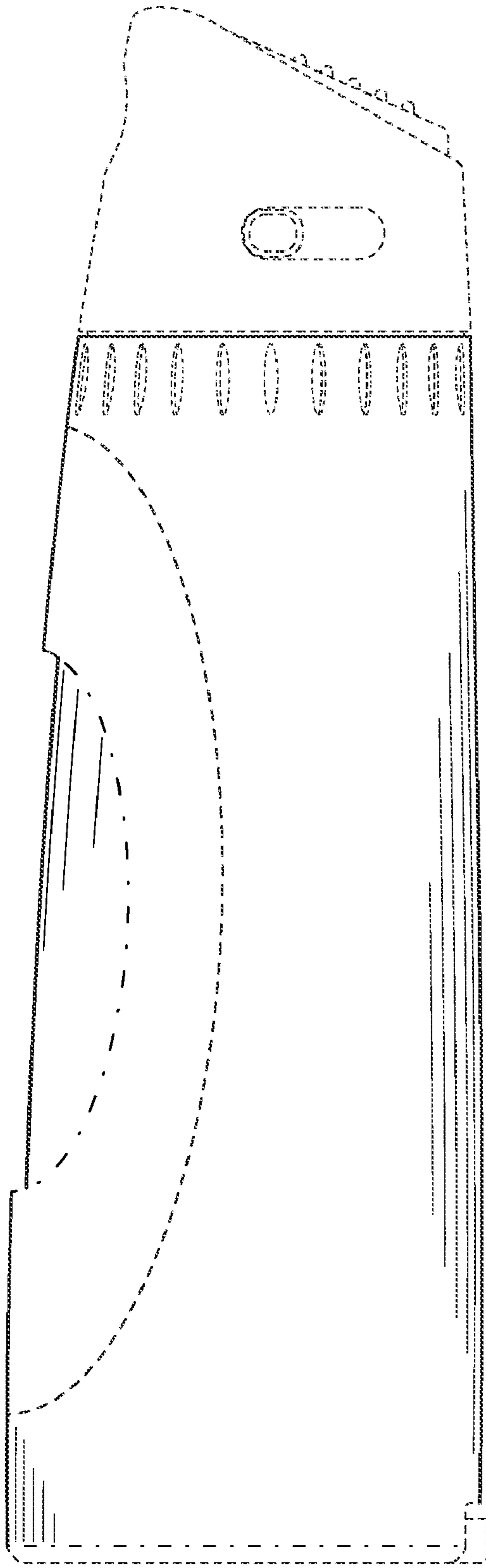

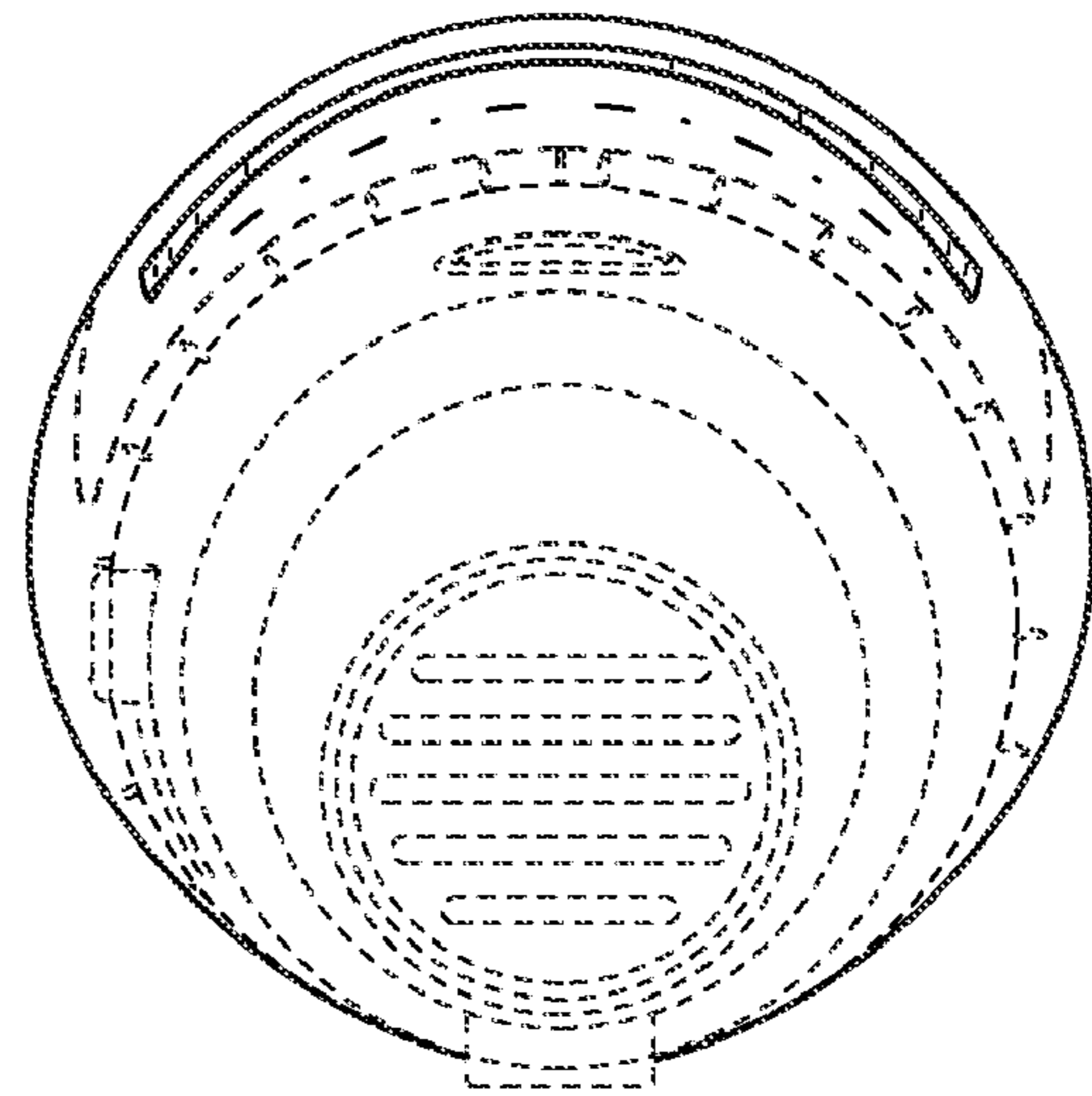
