FIG. 6 is a right elevation view of the design illustrated in FIG. 1; and,

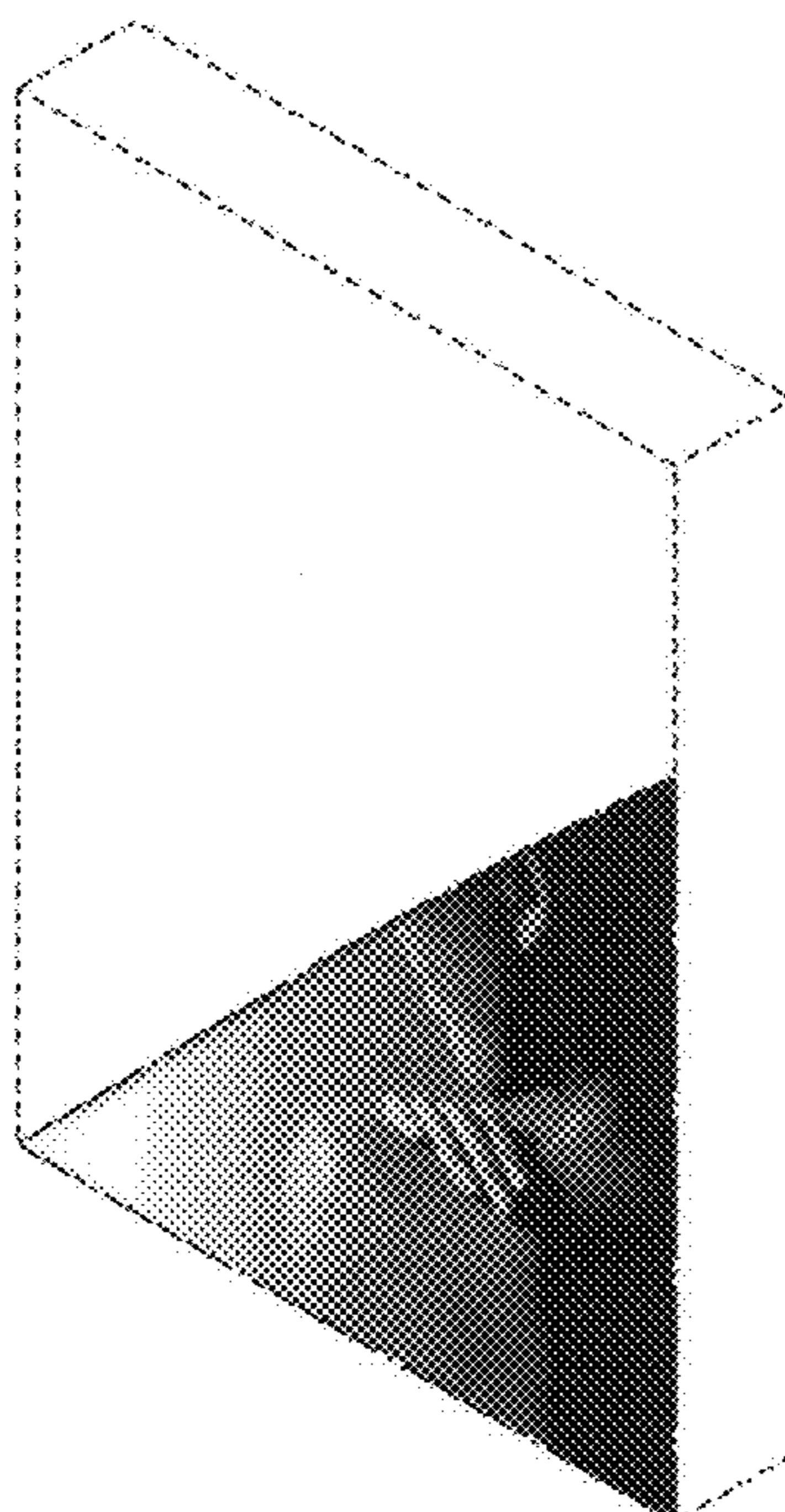
FIG. 7 is a left elevation view of the design illustrated in FIG. 1.

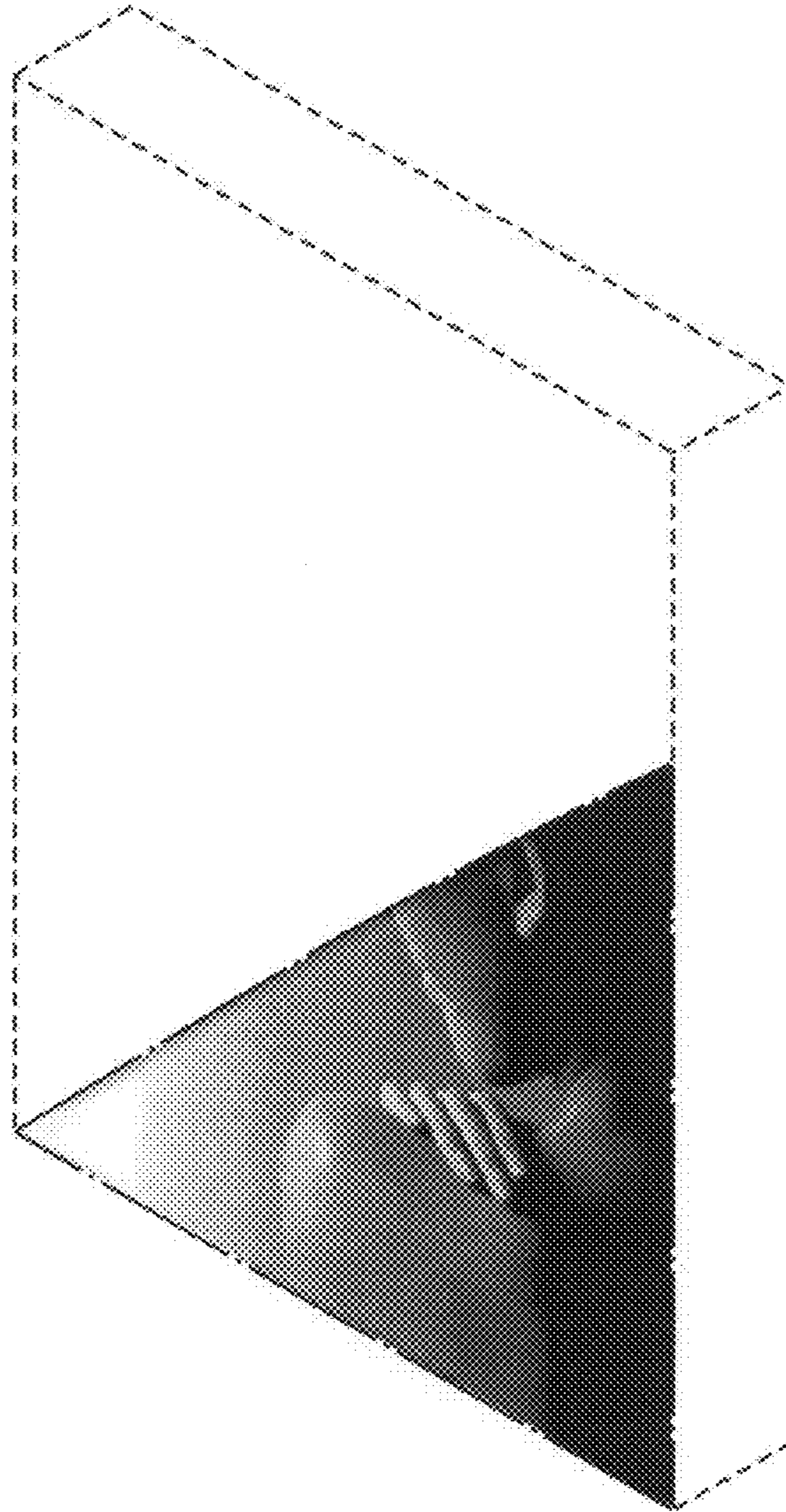

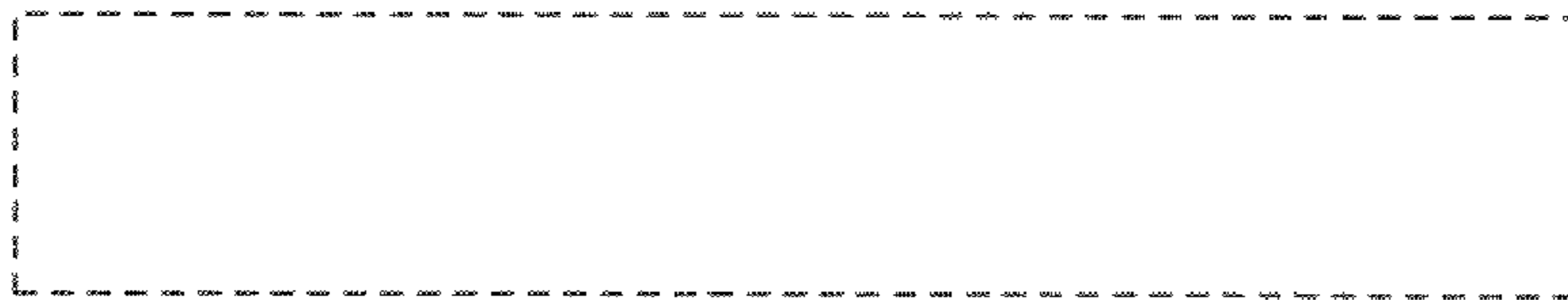

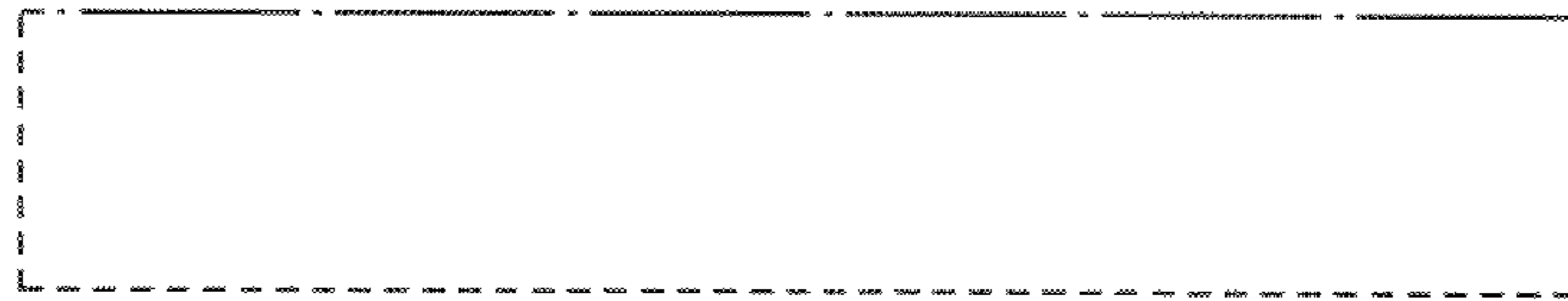

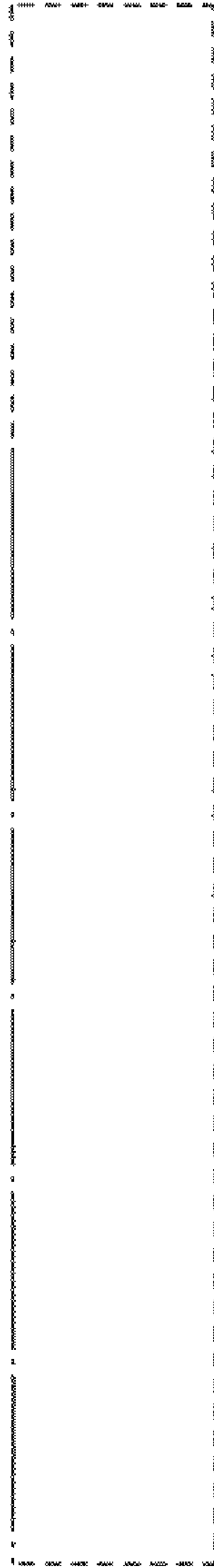
