The ornamental design for a holiday stocking, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a holiday stocking showing my new design;

FIG. 2 a front view thereof;

FIG. 3 is a back view thereof;

FIG. 4 is a side view thereof;

FIG. 5 is another side view thereof;

FIG. 6 is a top view thereof; and,

FIG. 7 is a bottom view thereof.

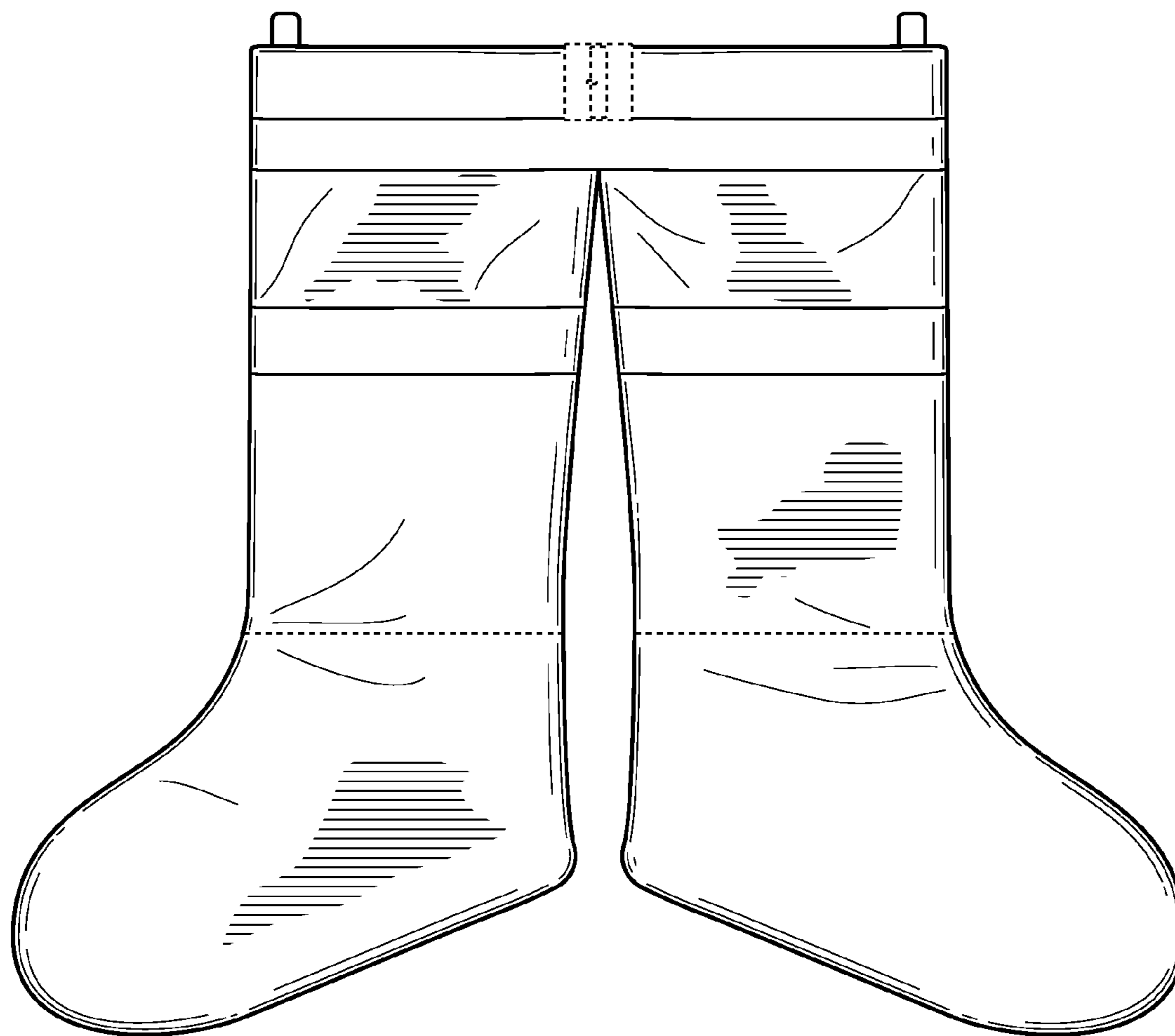

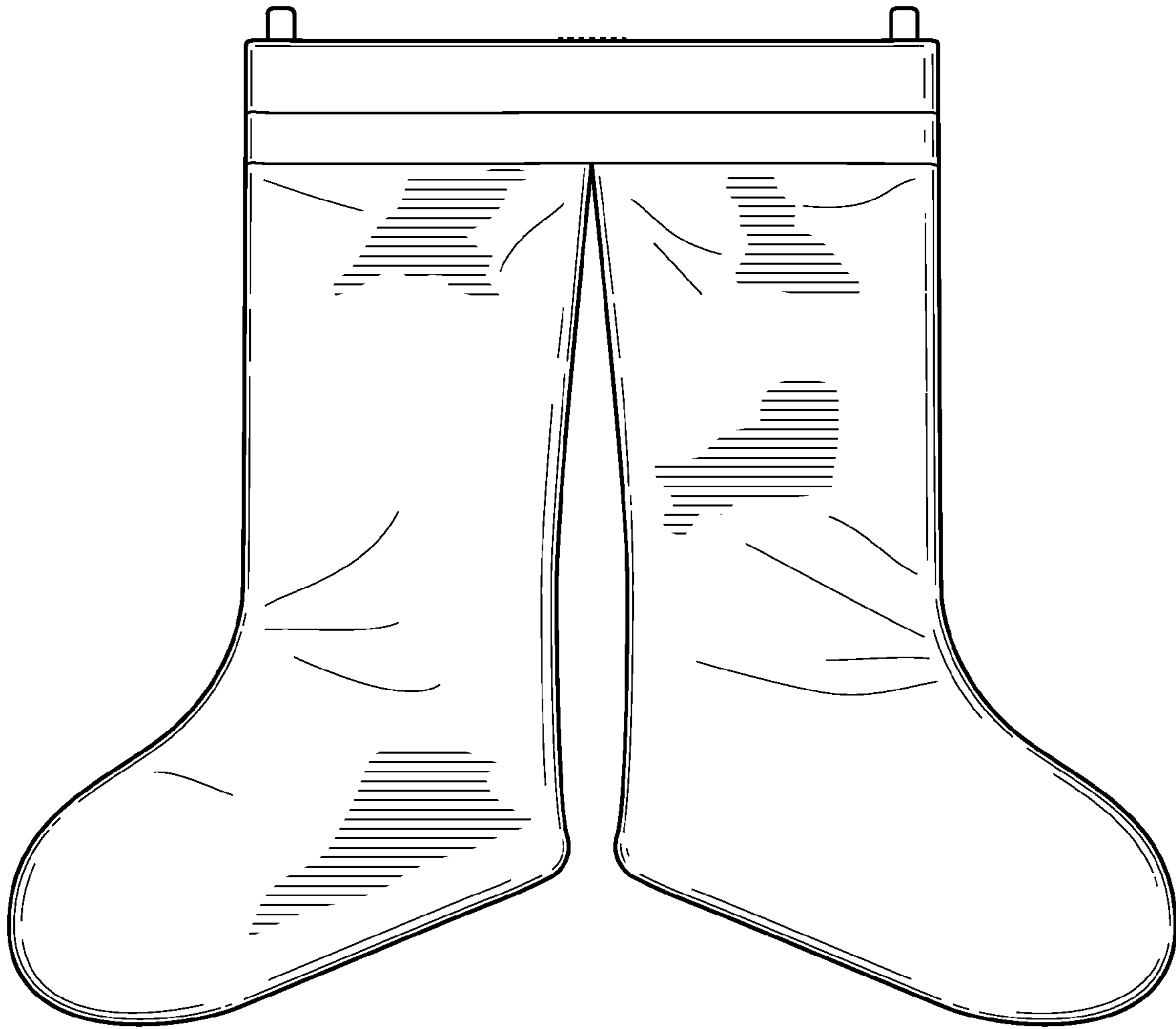
