(57) **CLAIM**

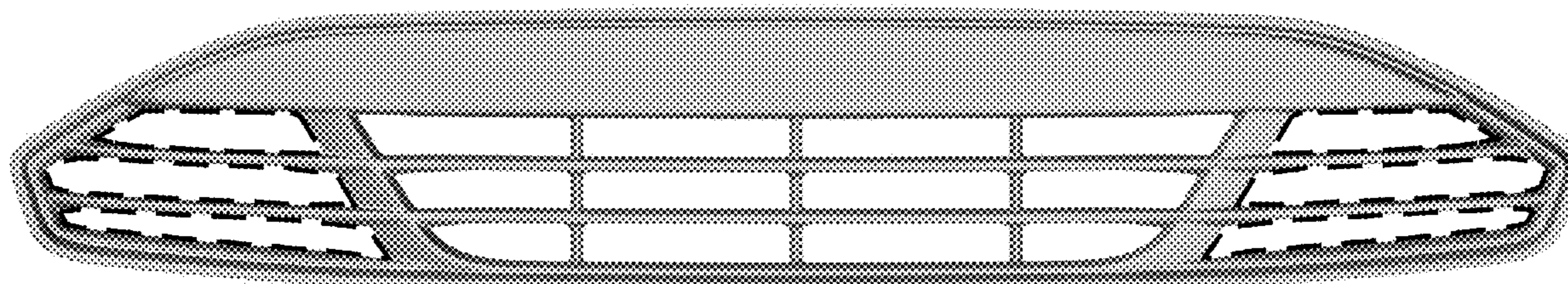
The ornamental design for a vehicle grille, shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a vehicle grille;
FIG. 2 is a bottom plan view of the vehicle grille;
FIG. 3 is front elevational view of the vehicle grille;

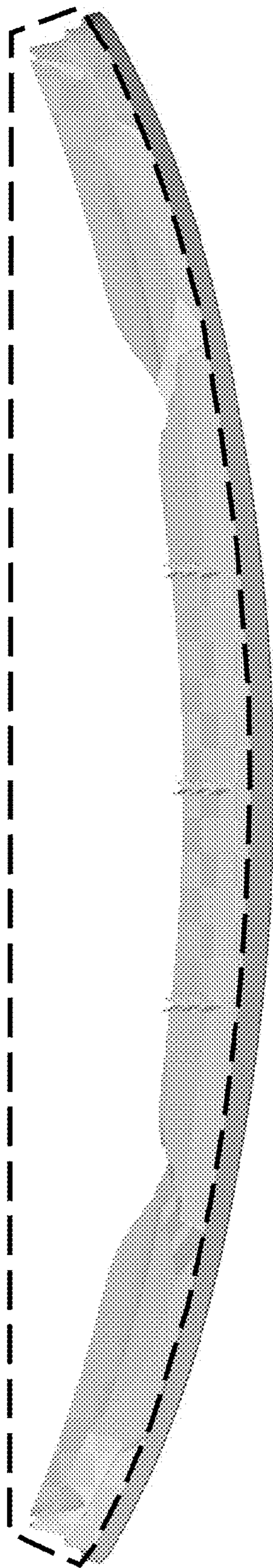
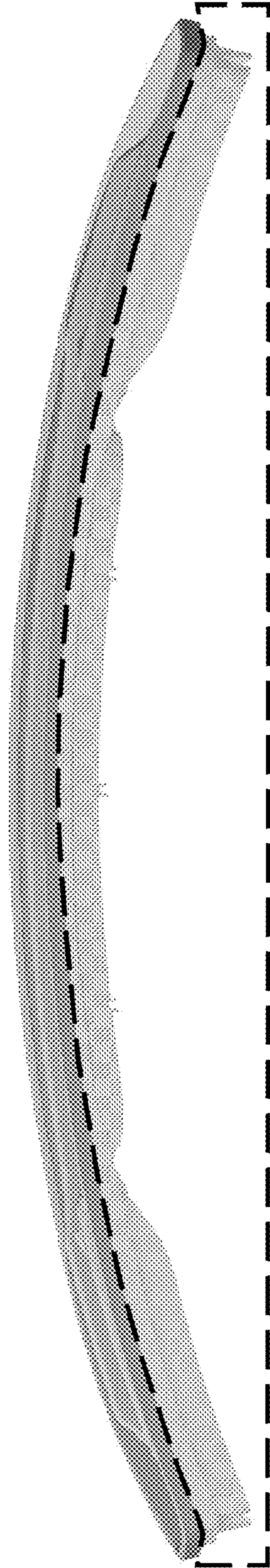

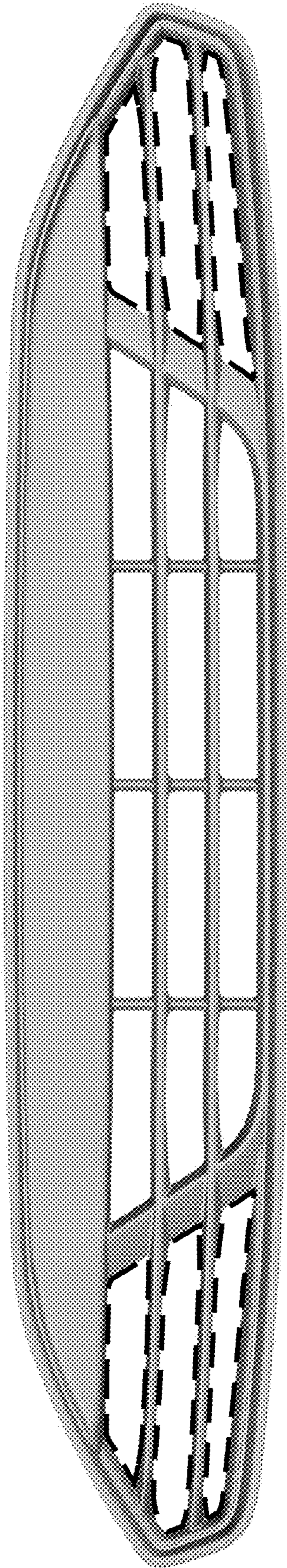

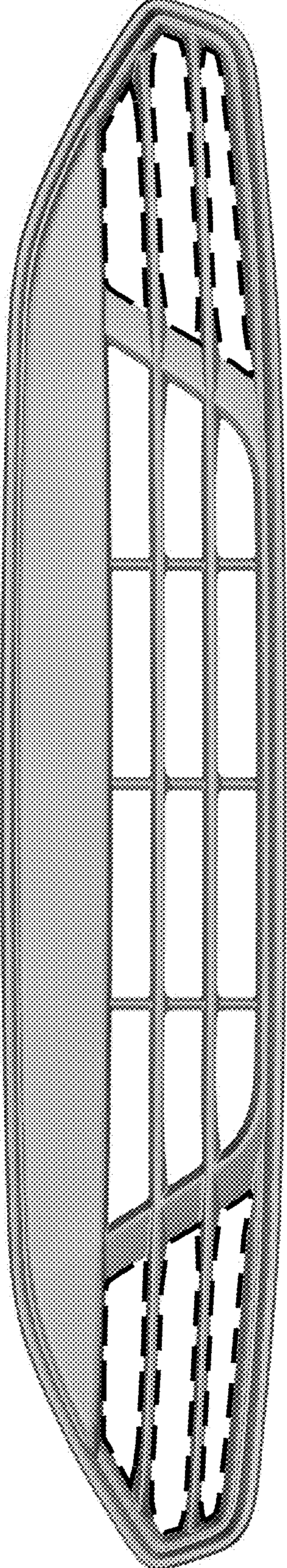

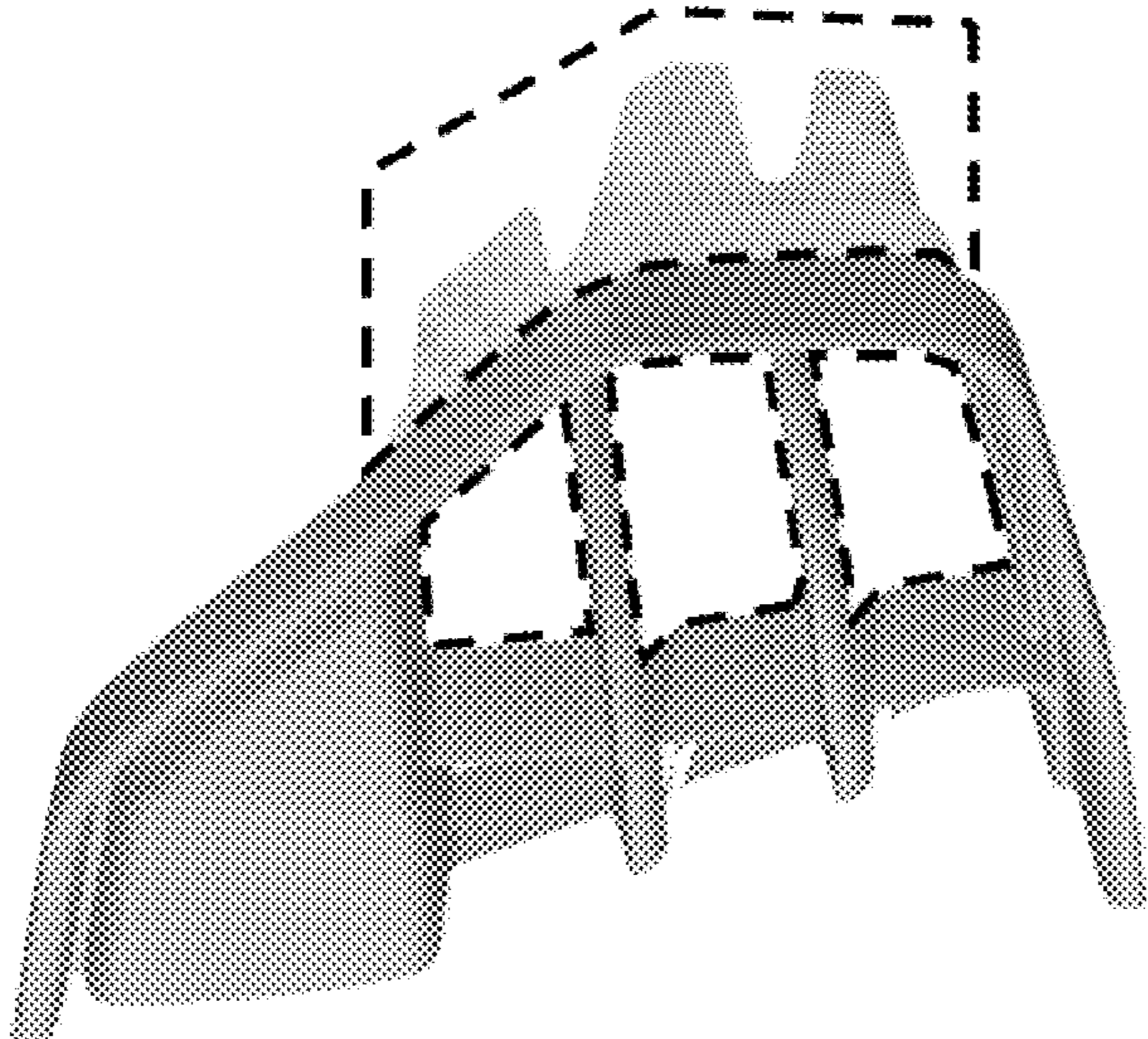

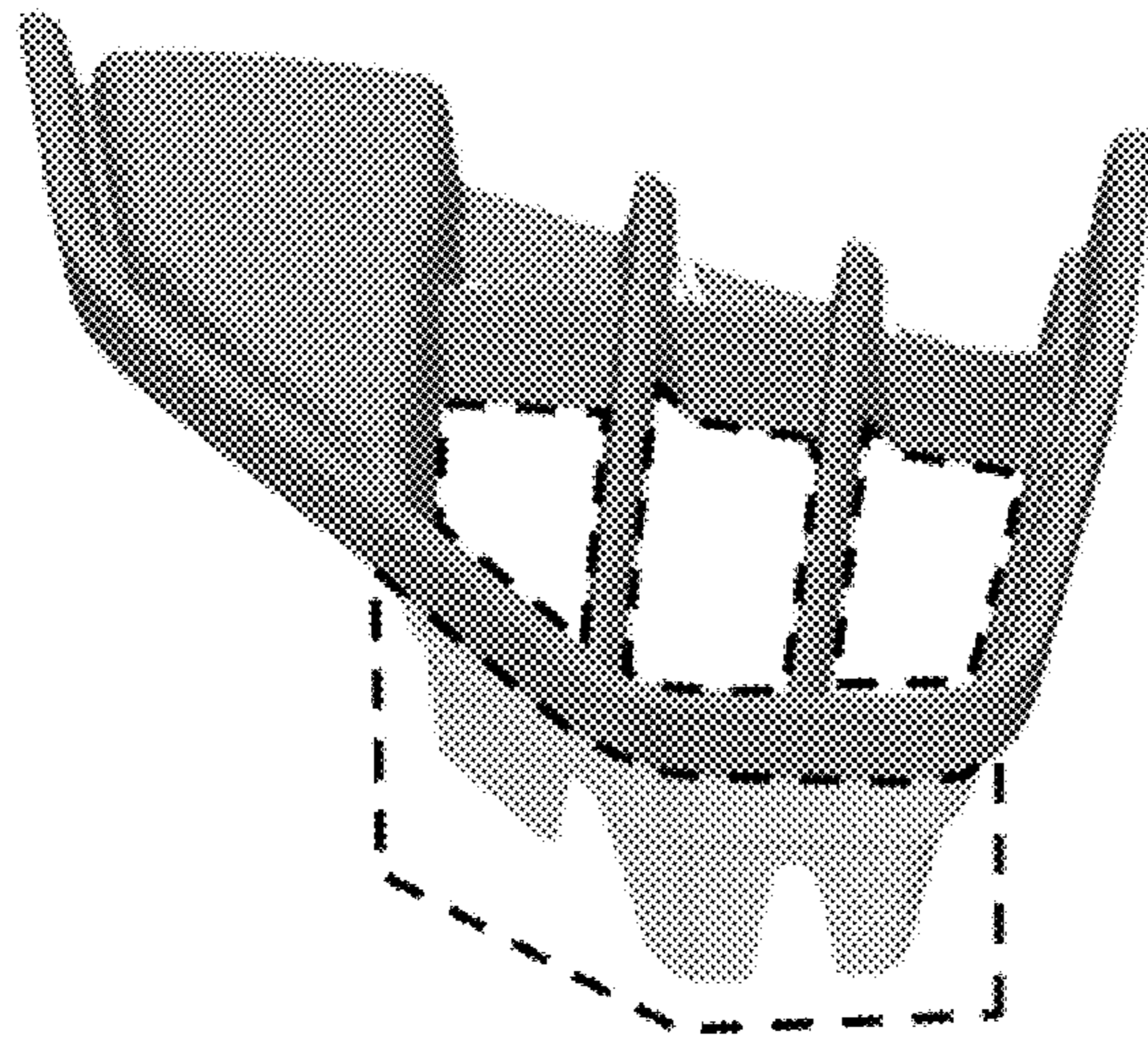

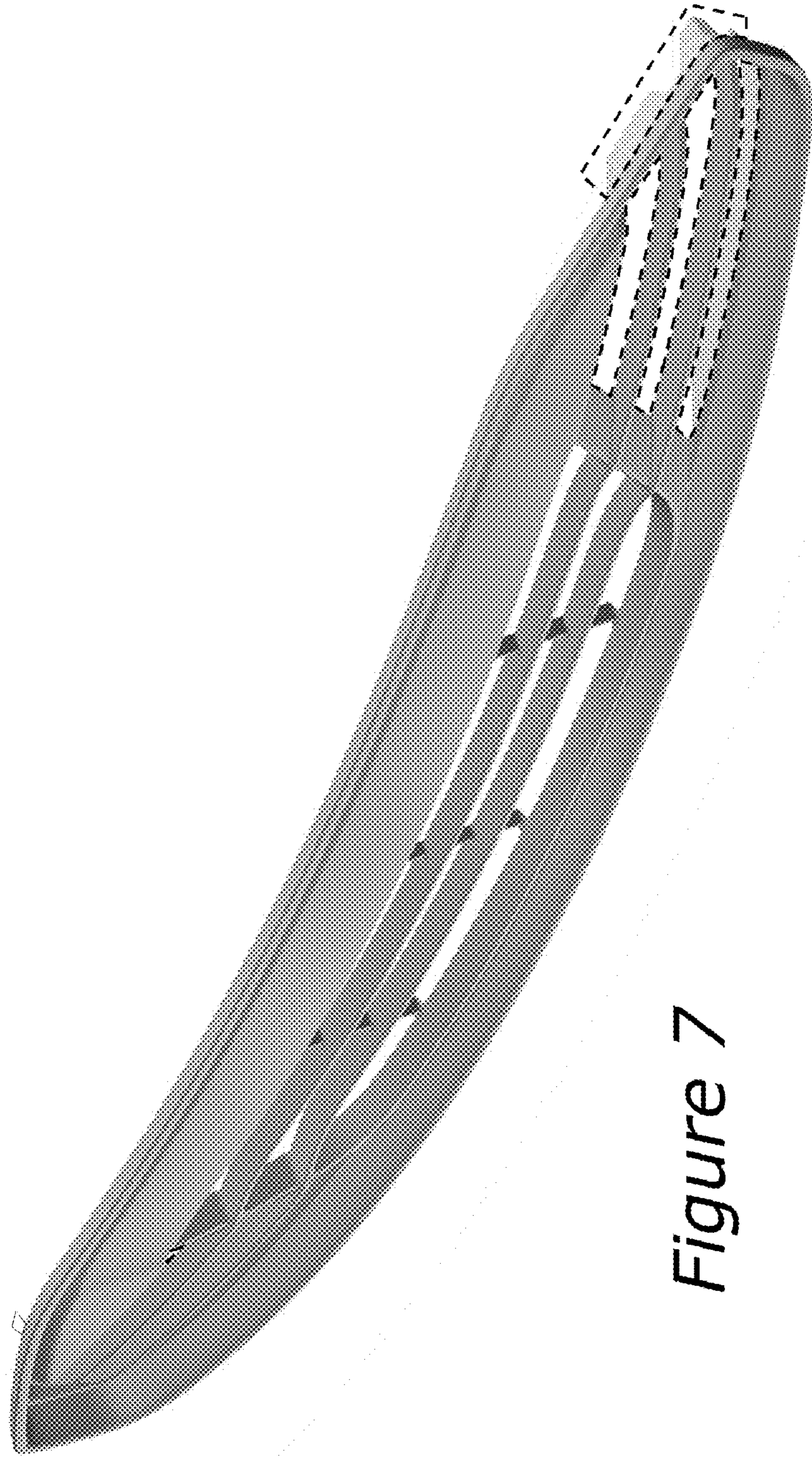
