(57) **CLAIM**

The ornamental design for tire tread for an automobile tire, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of an automobile tire showing our new design;

FIG. 2 is a front view thereof; top plan and bottom plan views are the same as the front view;

FIG. 3 is a rear view of the automobile tire of FIG. 1;

FIG. 4 is a right side view of the automobile tire of FIG. 1;

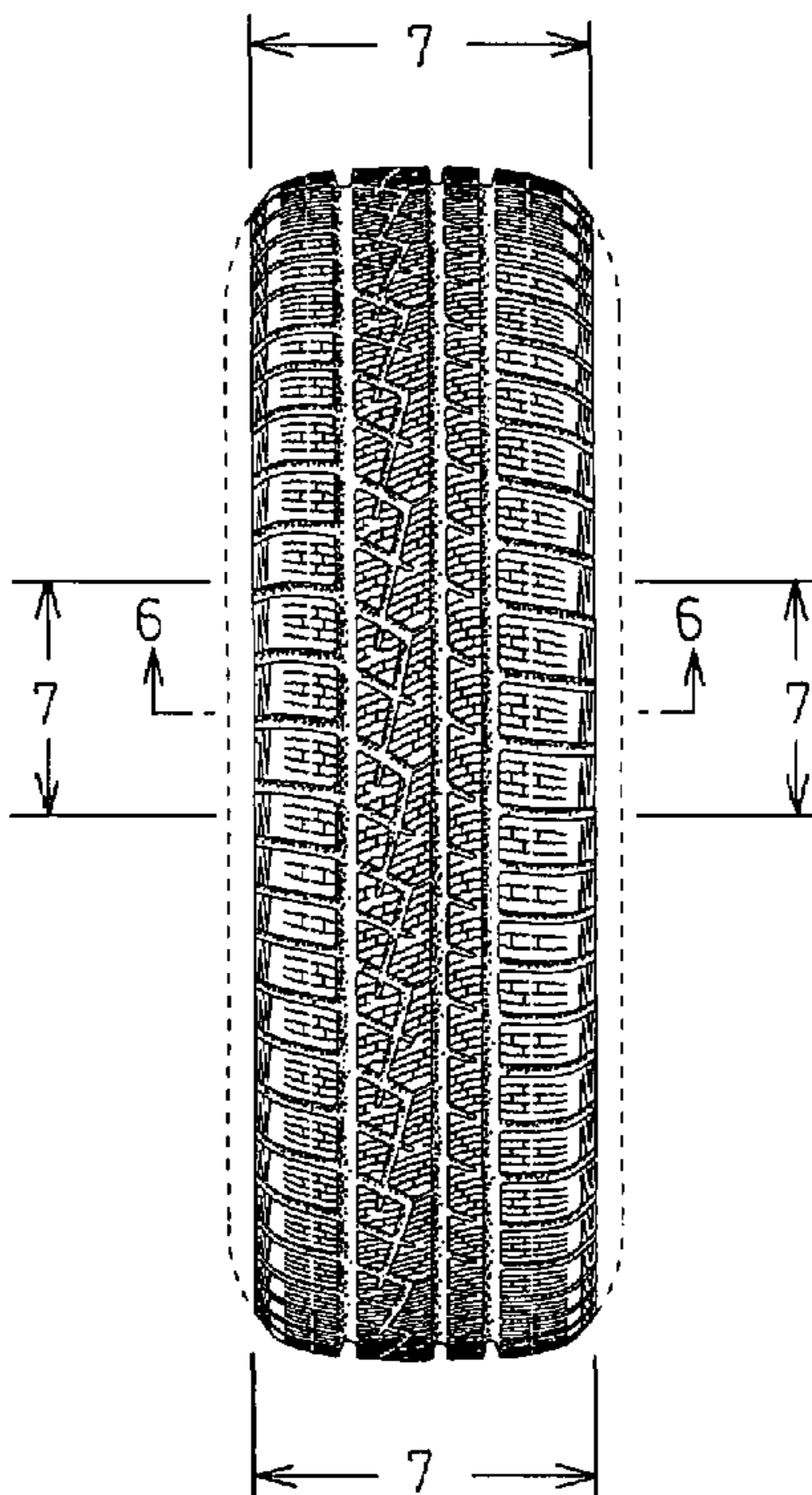
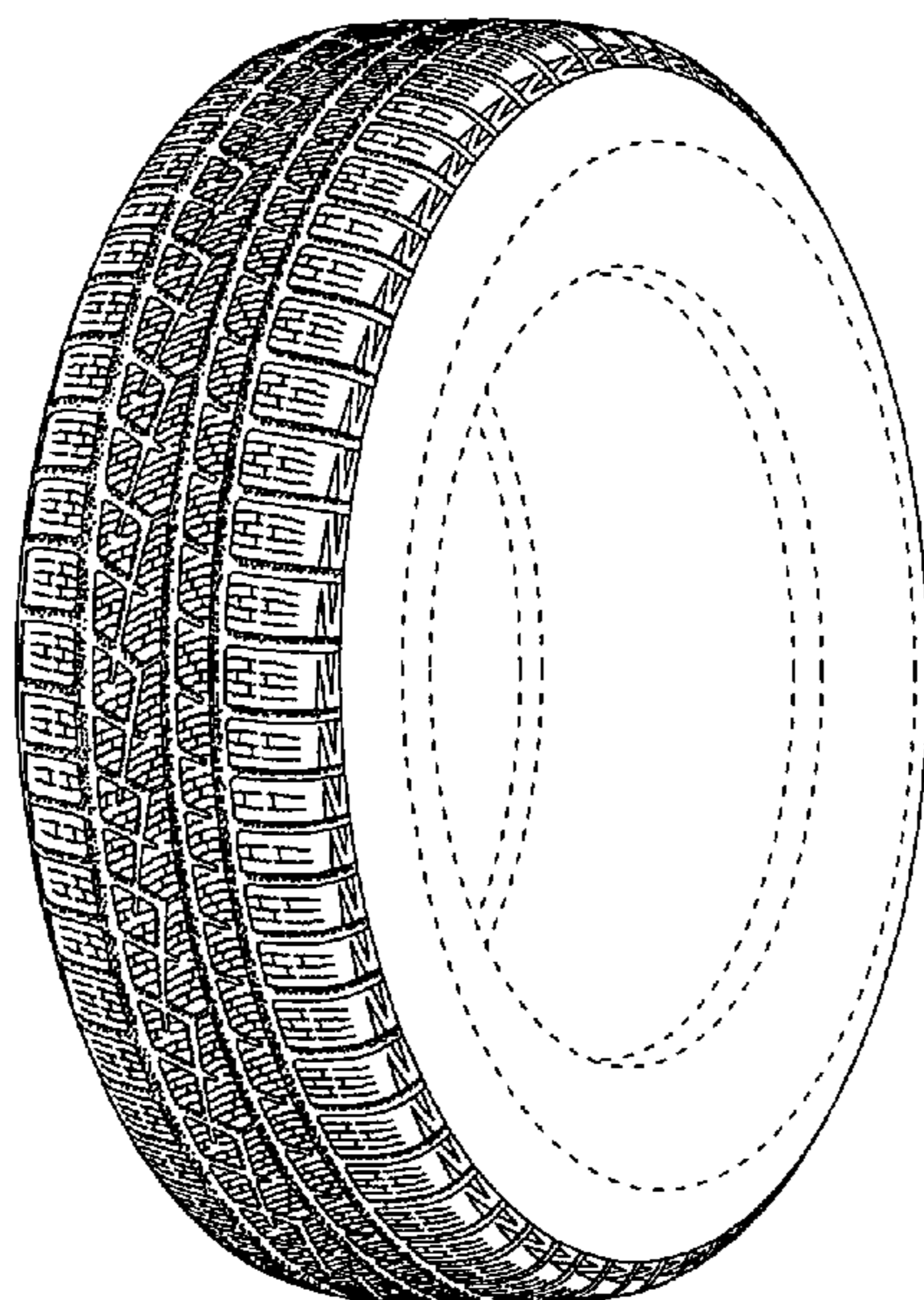
FIG. 5 is a left side view of the automobile tire of FIG. 1; and

FIG. 6 is a cross-sectional view of a part taken from the 6—6 line in FIG. 2, which shows only a cut section; top plan view thereof; and,

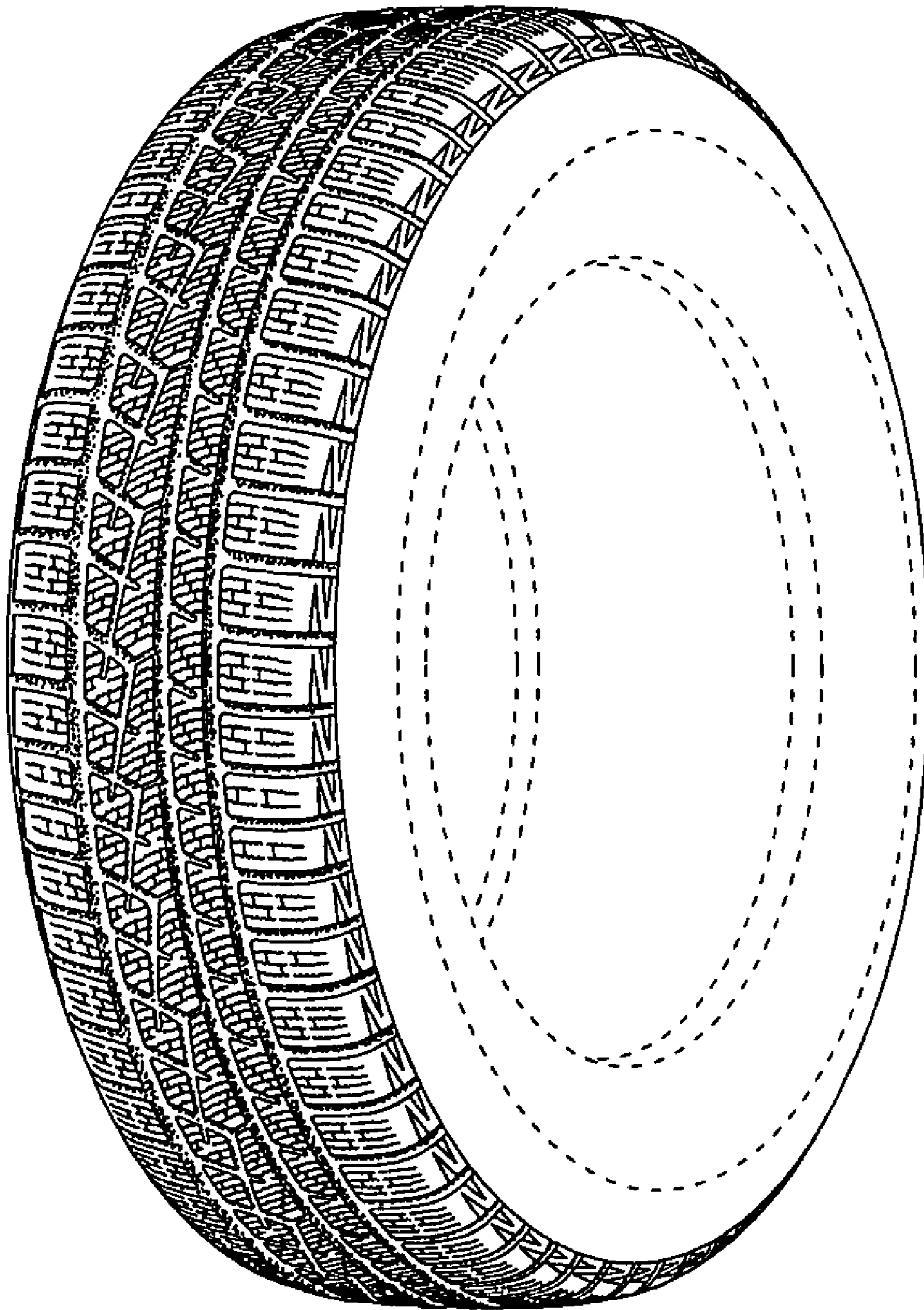

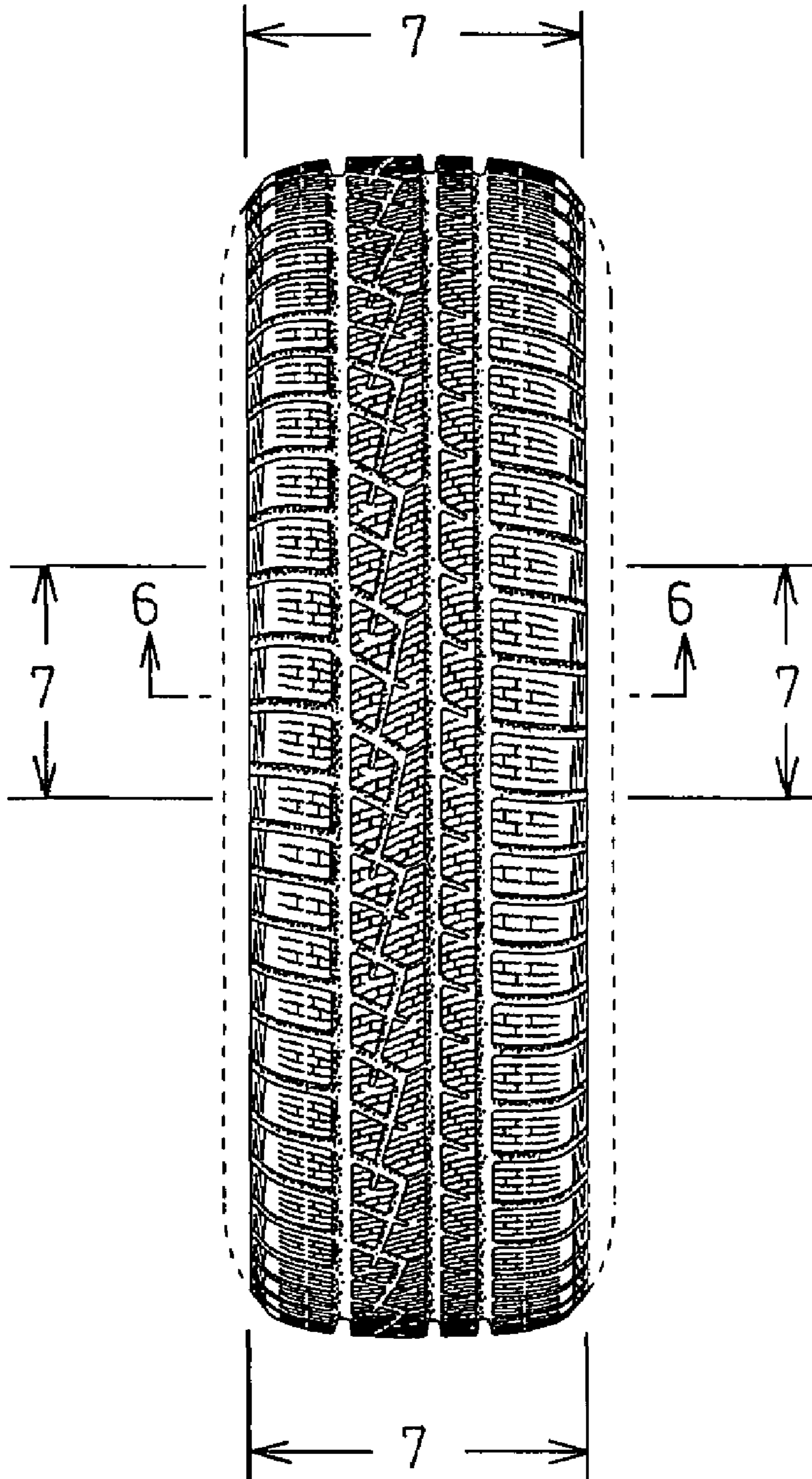

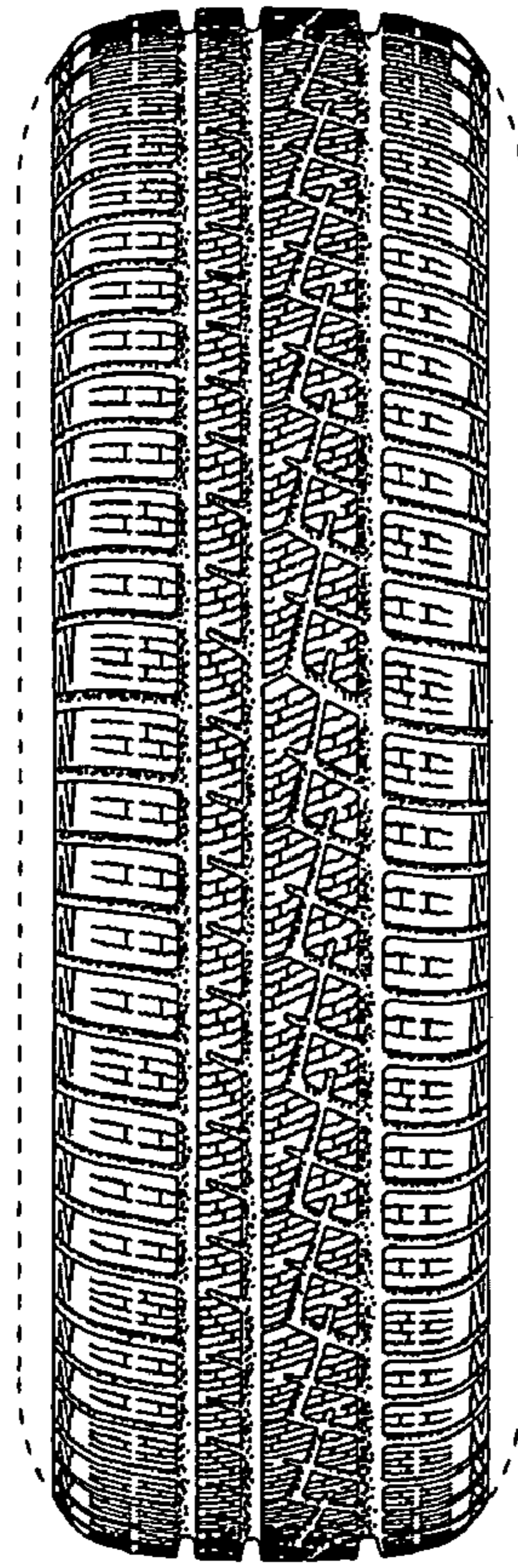

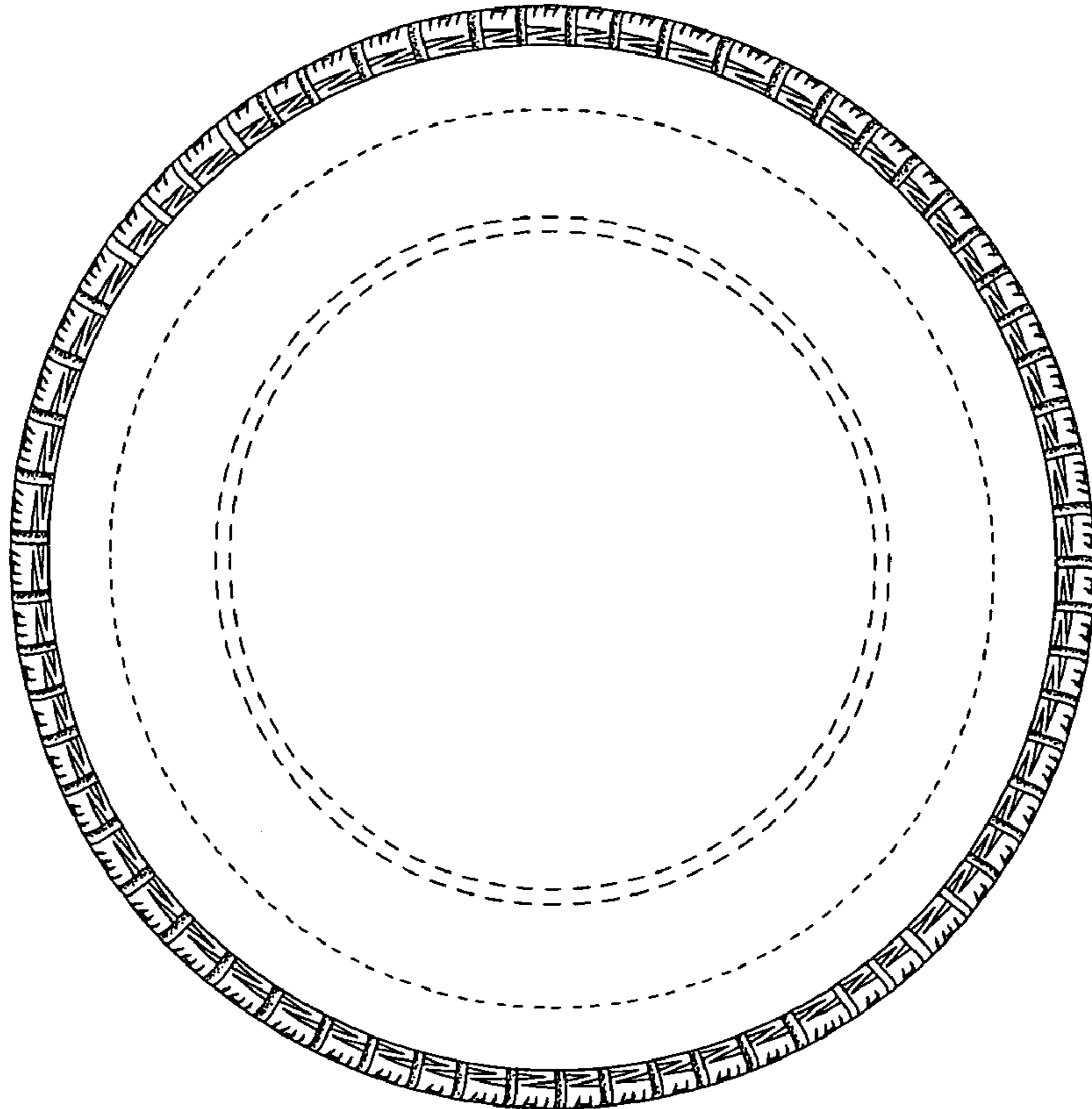

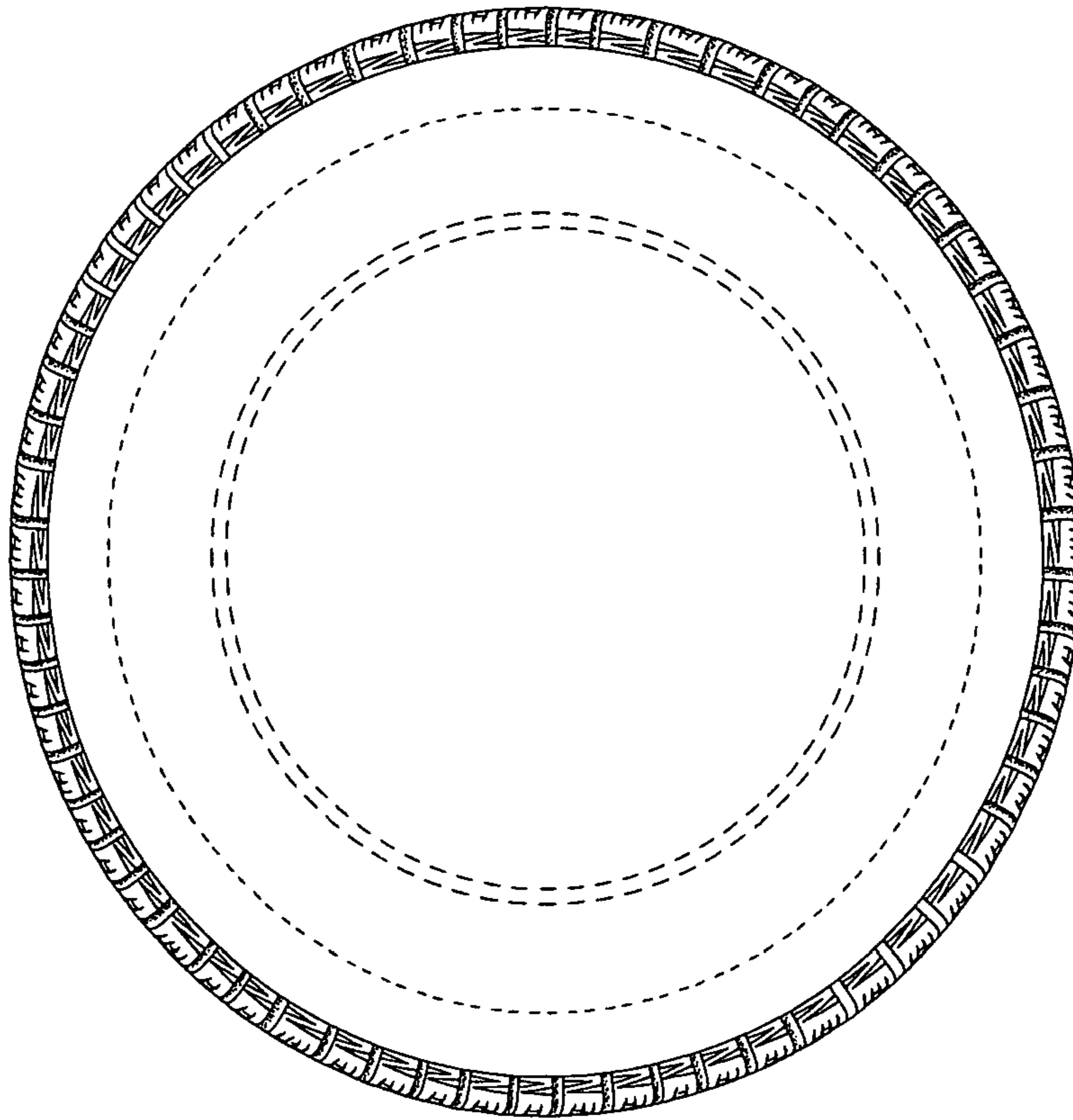
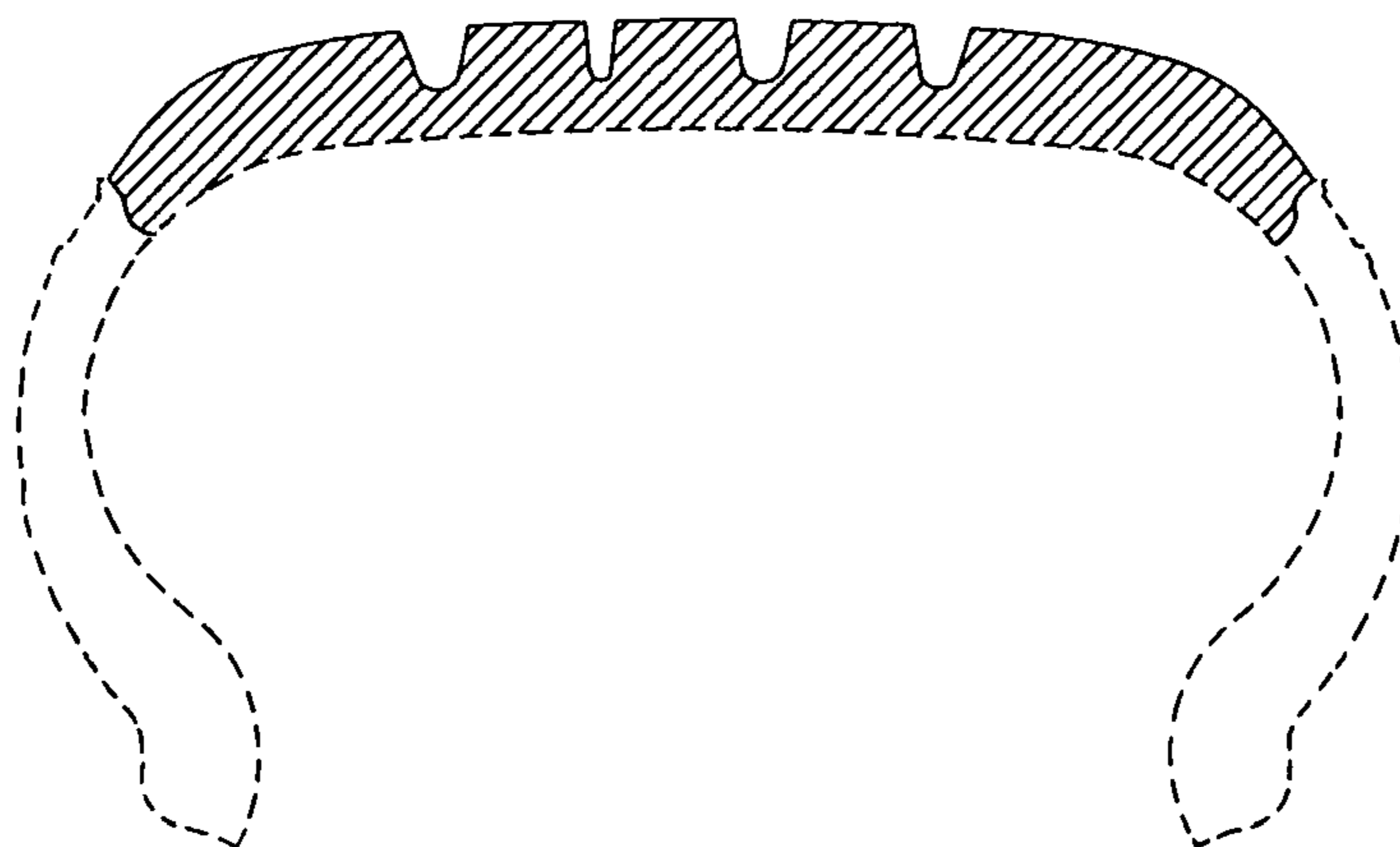
