FIG. 1 is a front perspective view of a headset holster showing my new design;

FIG. 2 is a top plan view thereof;

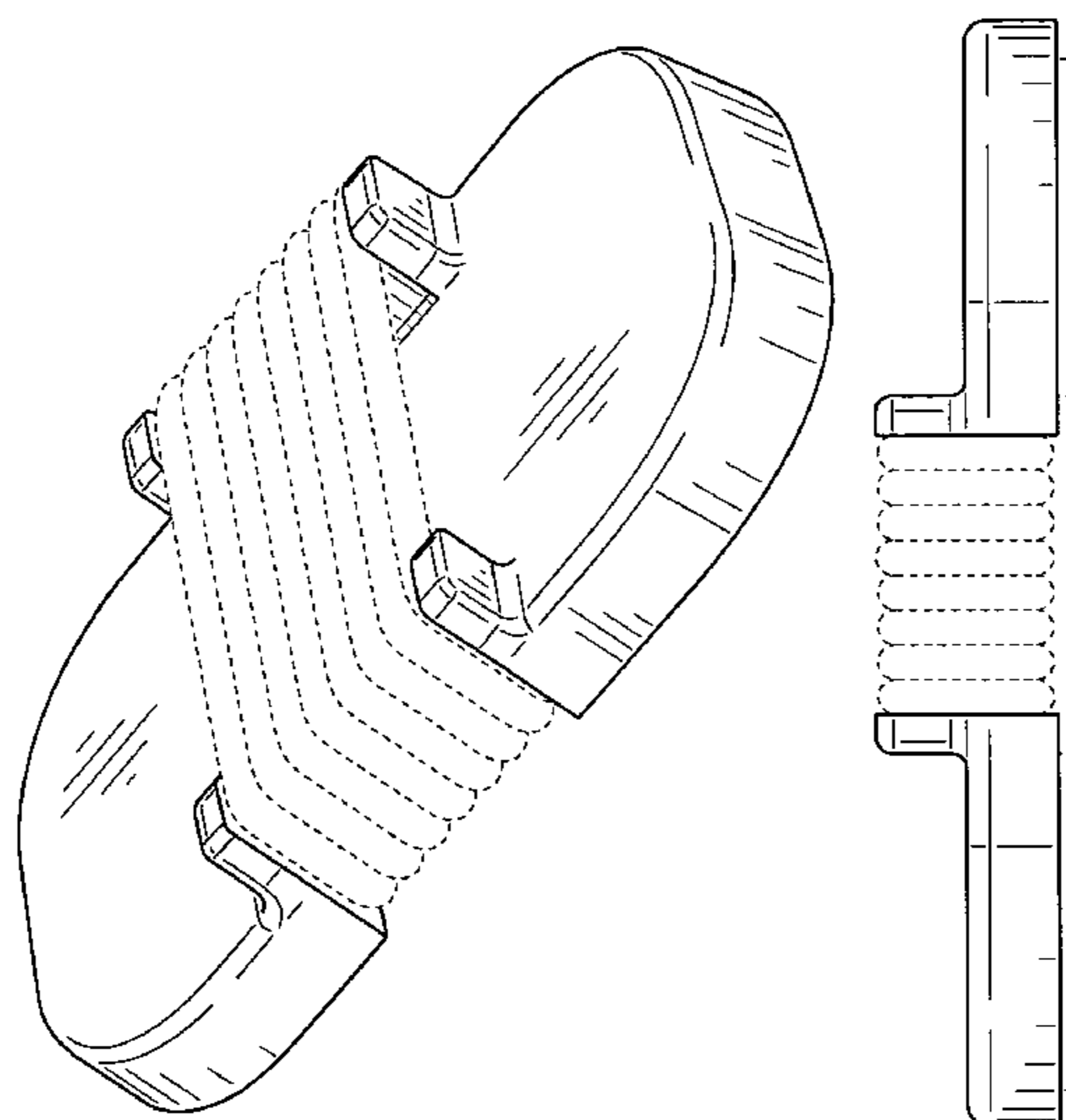
FIG. 3 is a bottom plan view thereof;

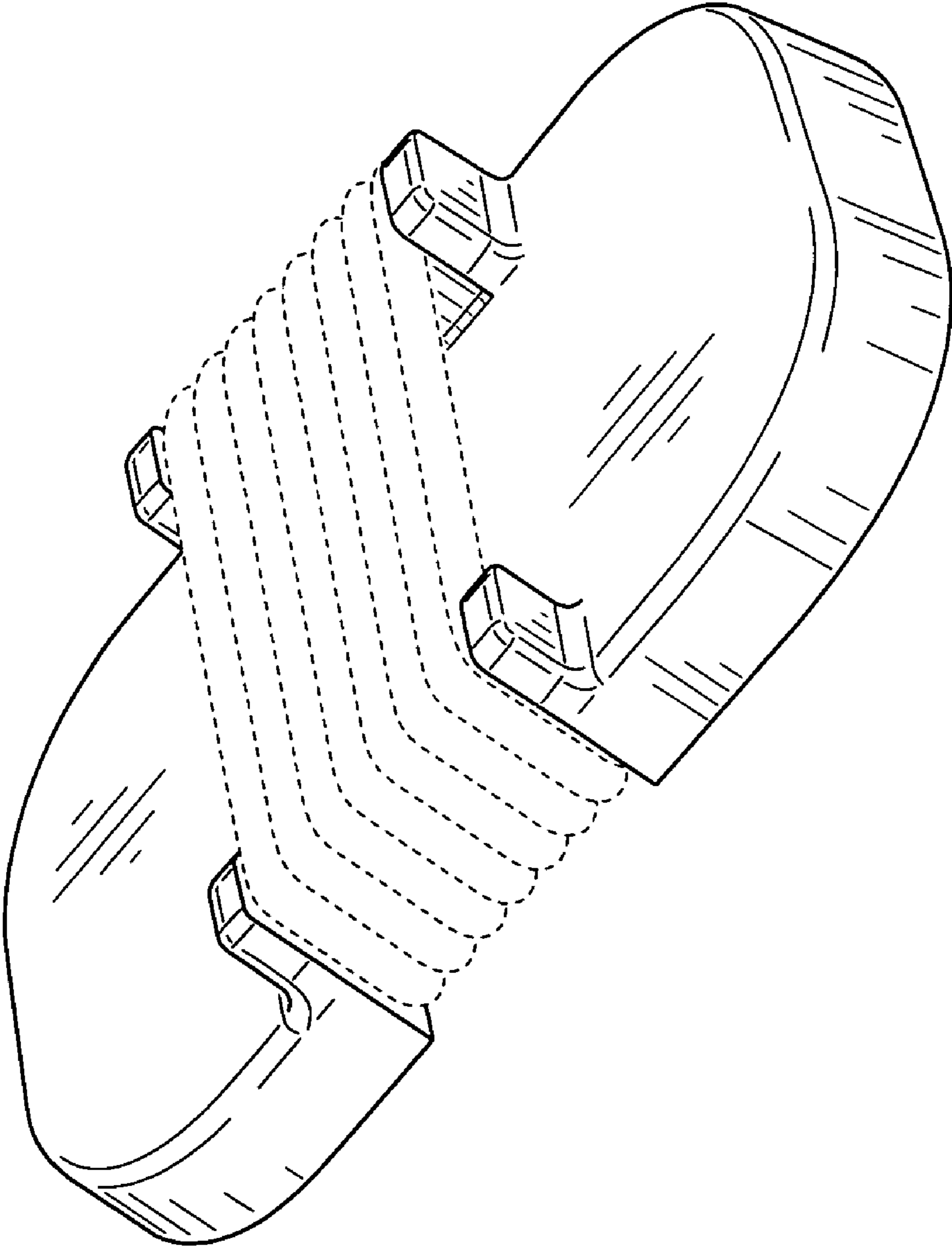

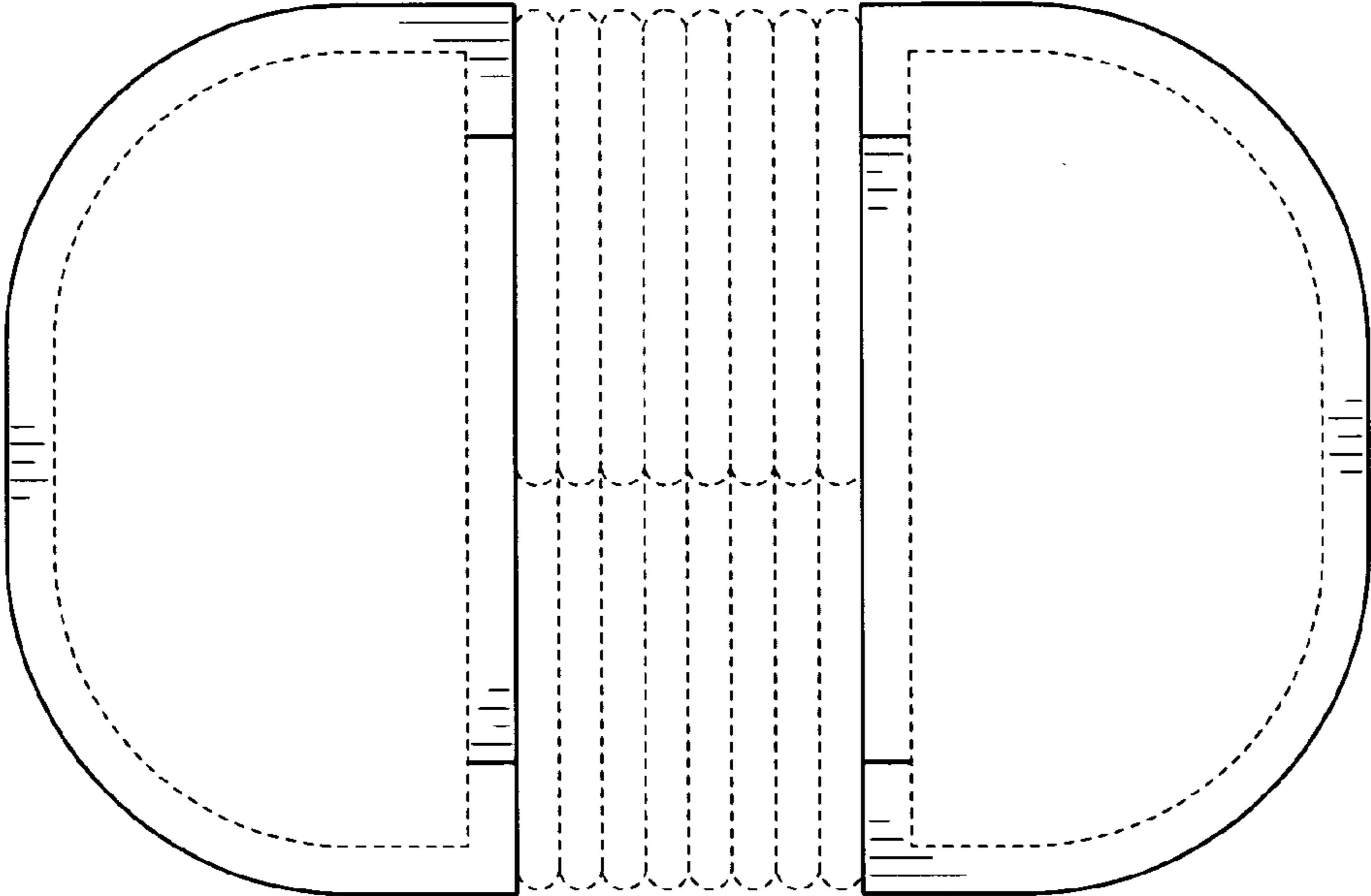

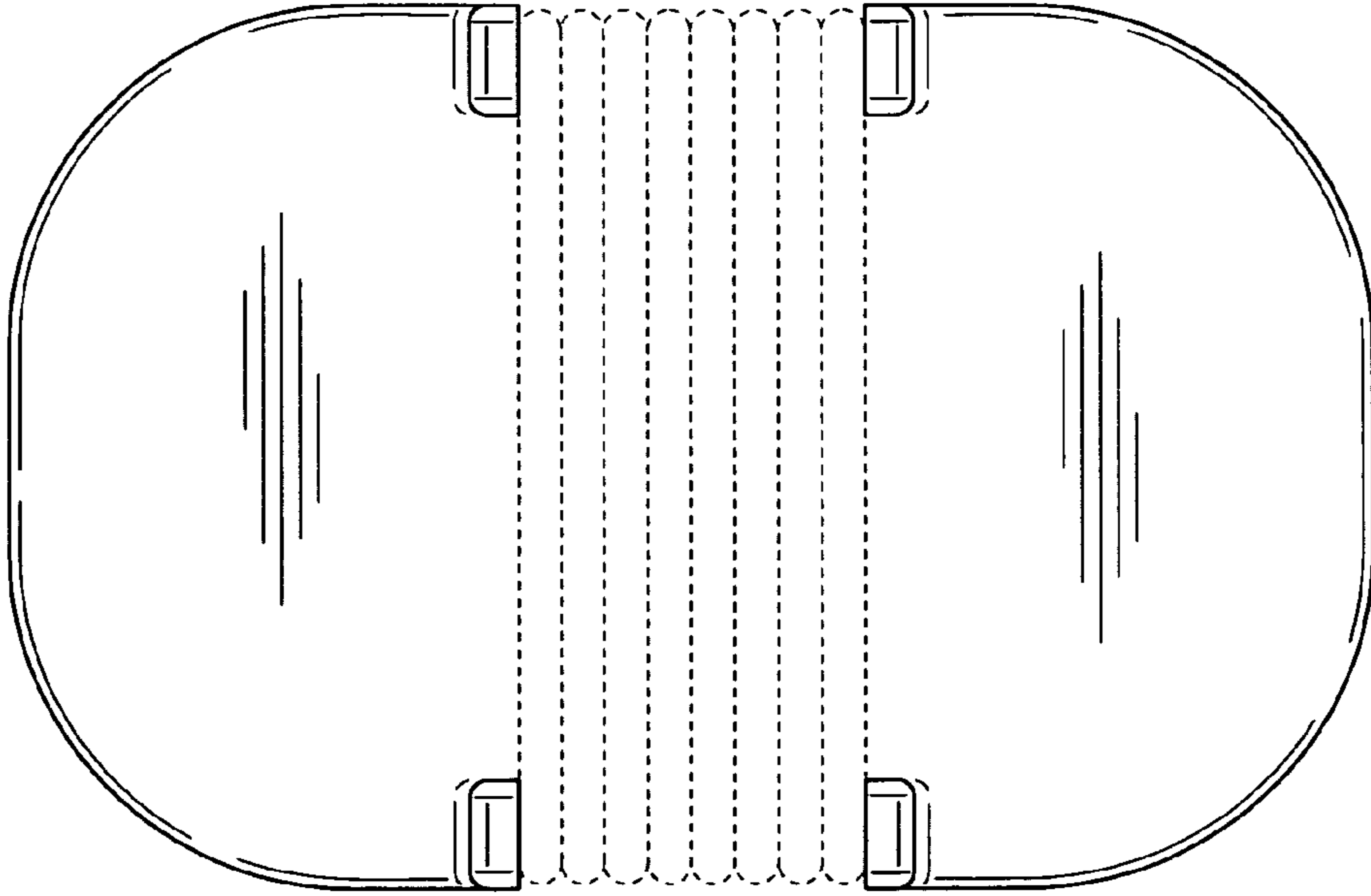

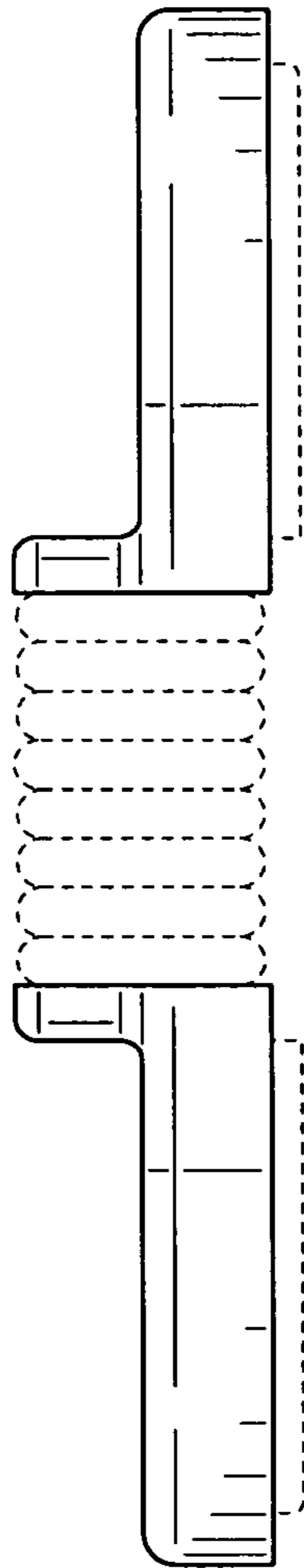

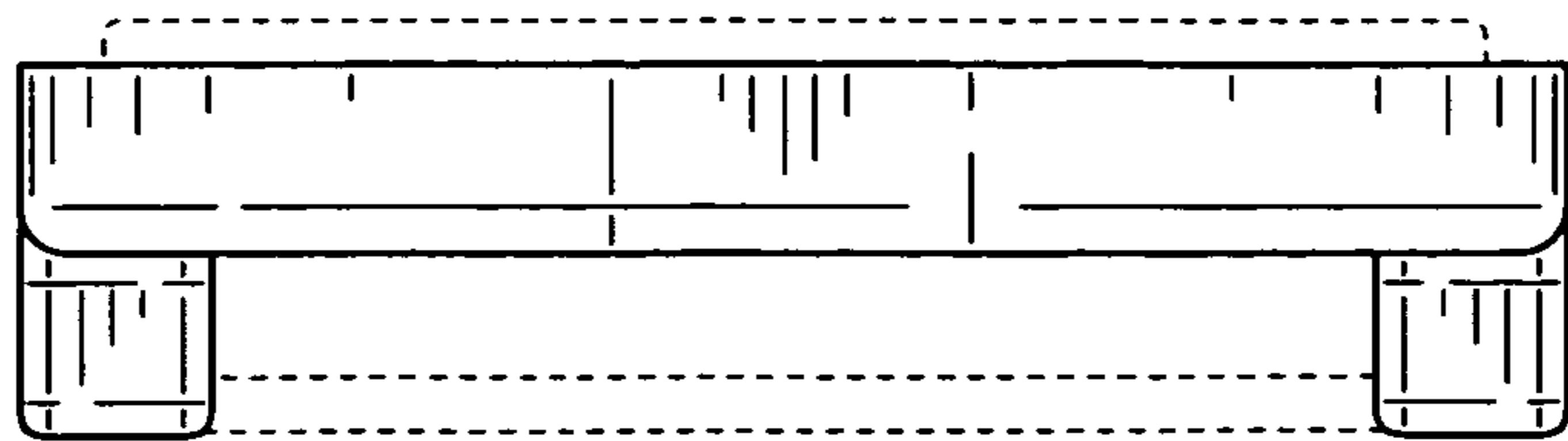
