(57) **CLAIM**

We claim the ornamental design for a hand-held electronic device cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a hand-held electronic device cover;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a back elevational view thereof;

FIG. 4 is a right side elevational view thereof;

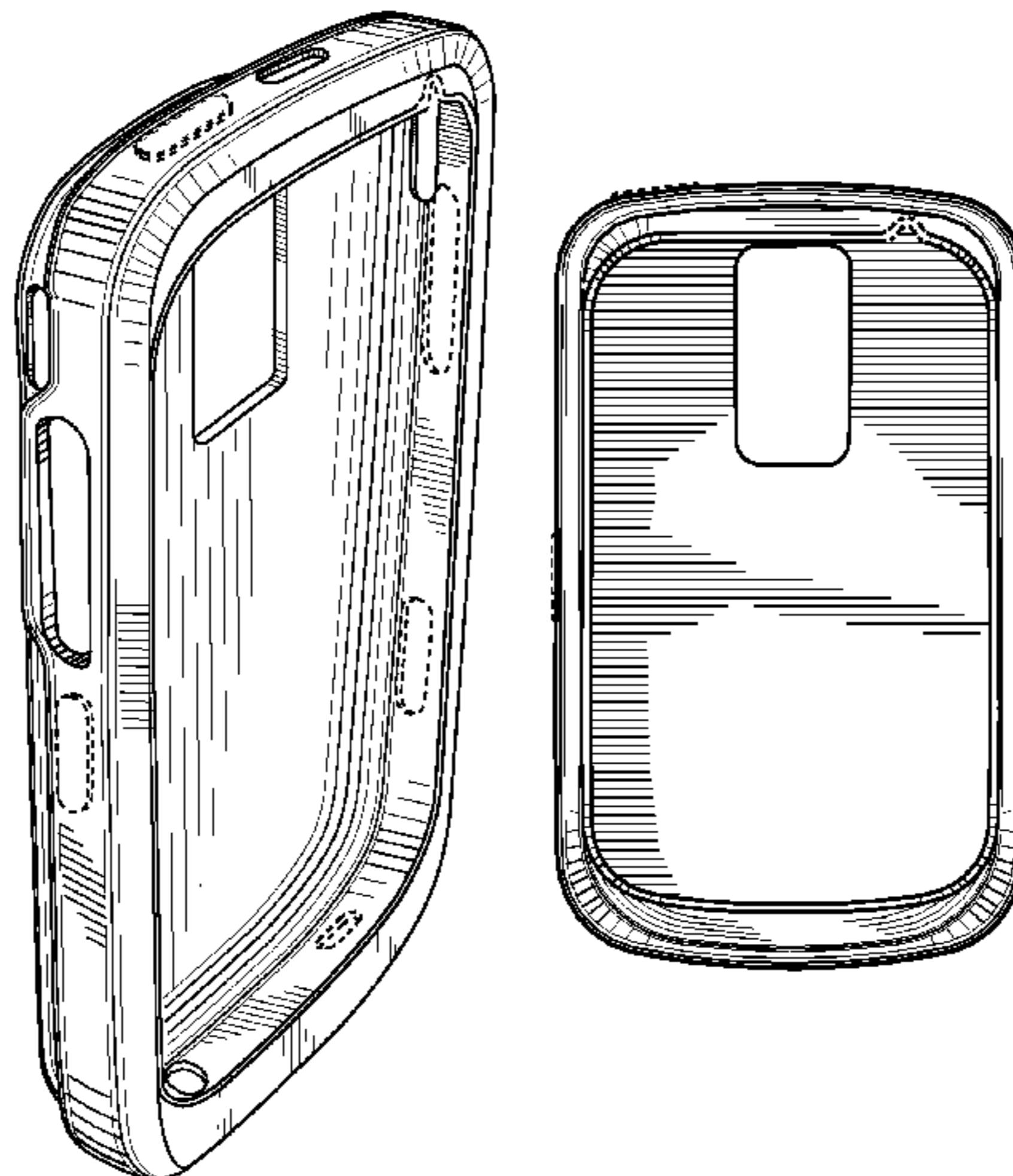
FIG. 5 is a left side elevational view thereof;

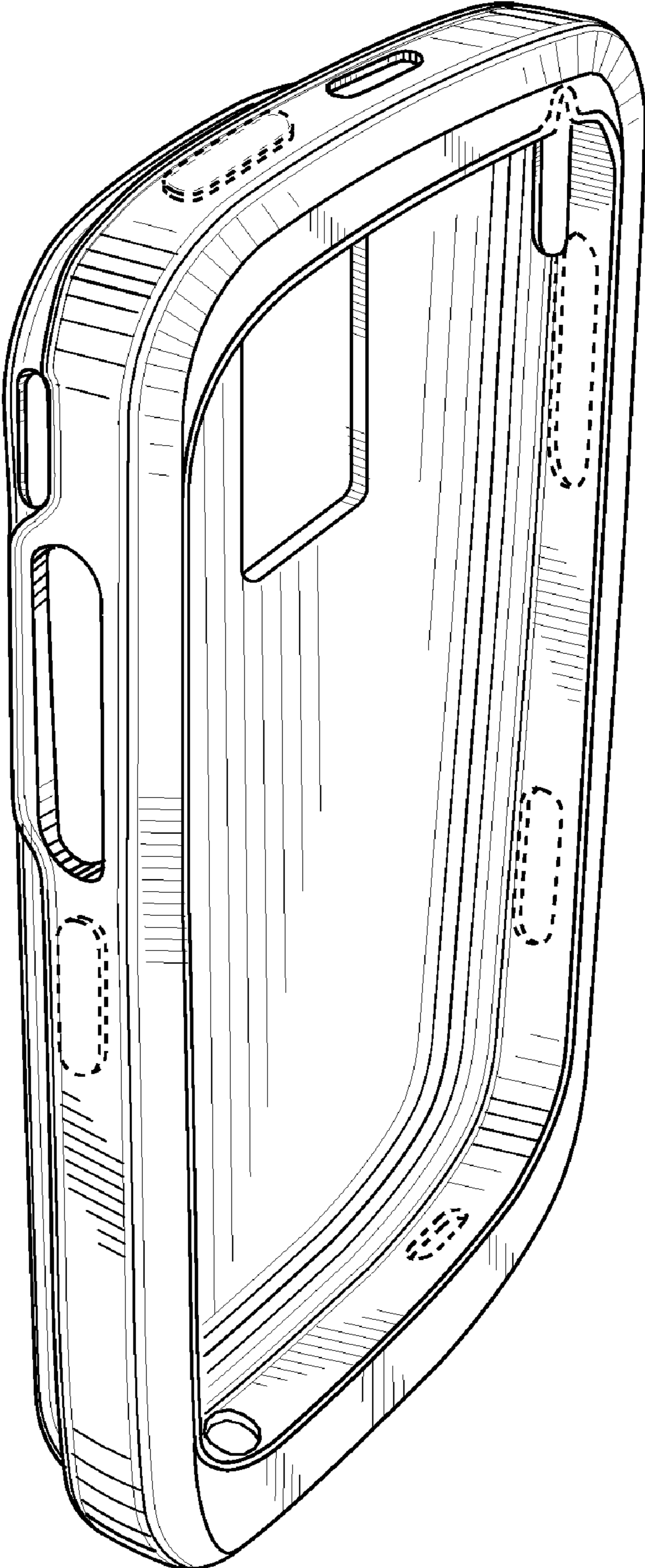

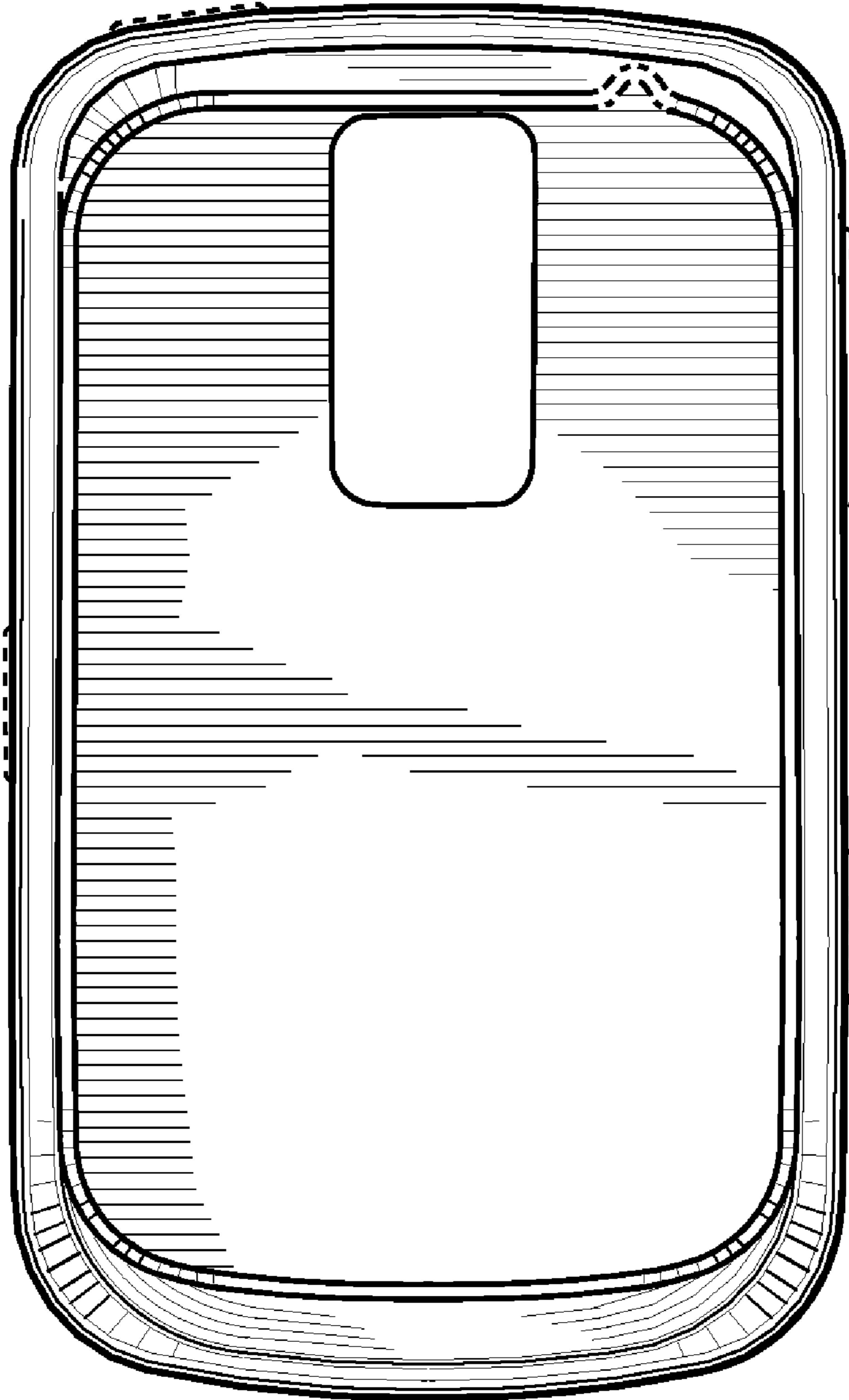

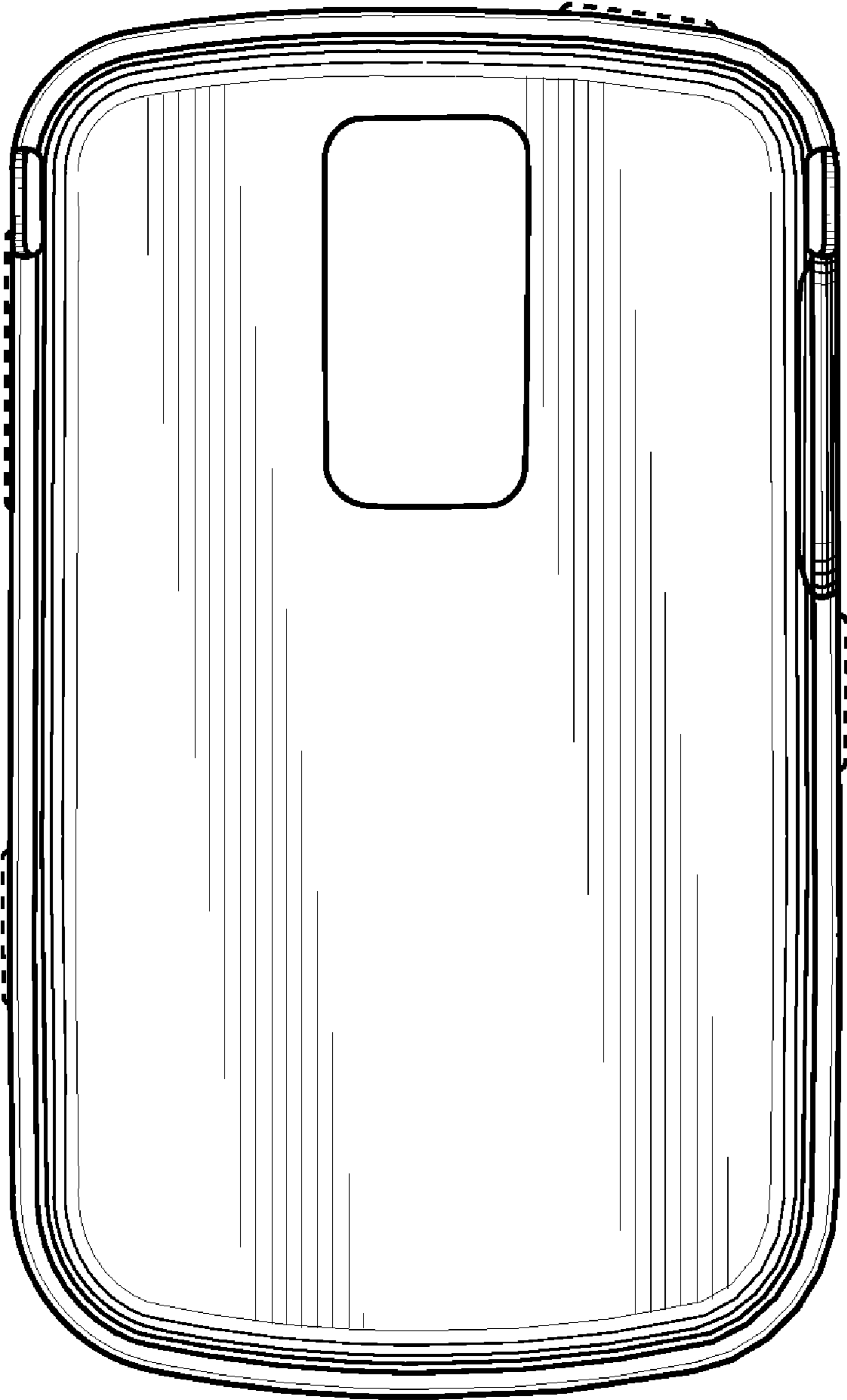

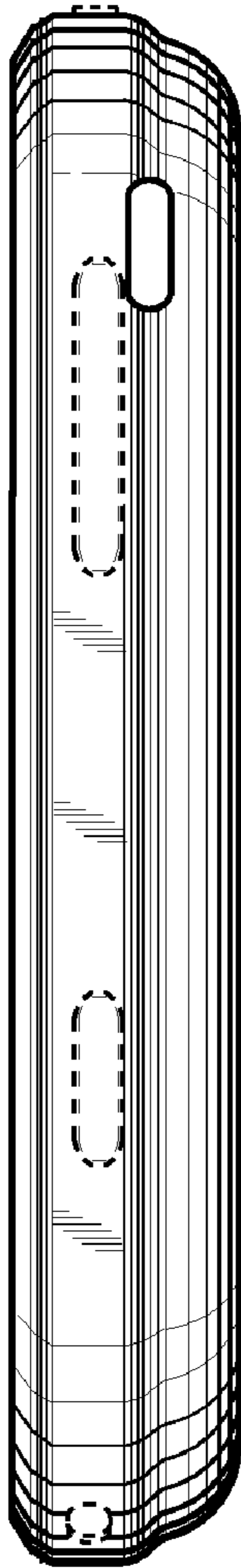

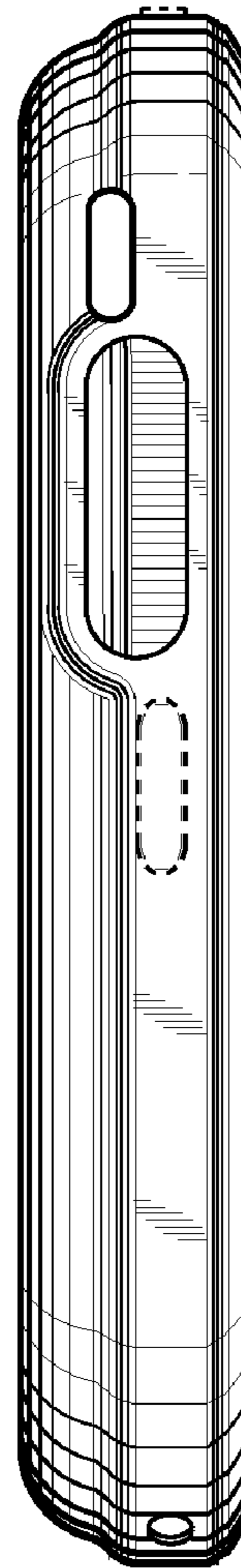

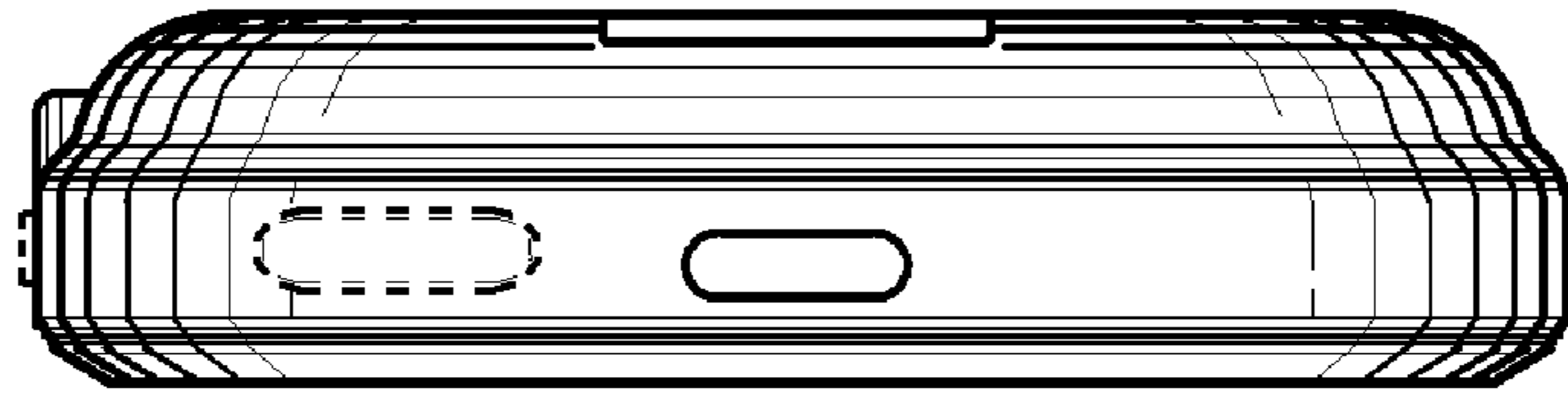

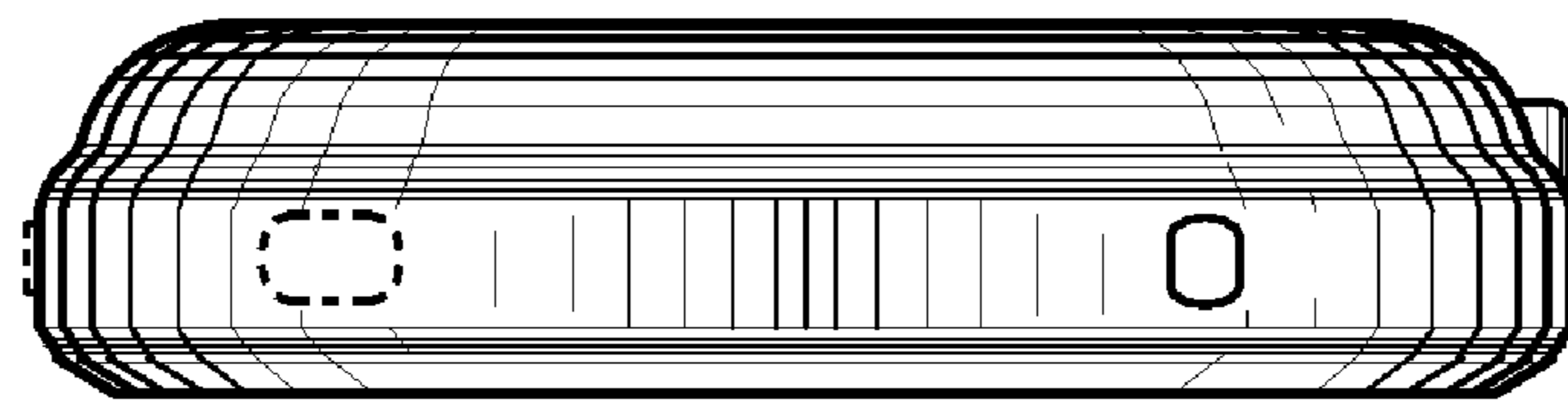
