I claim the ornamental design for a chip card, as shown and described.

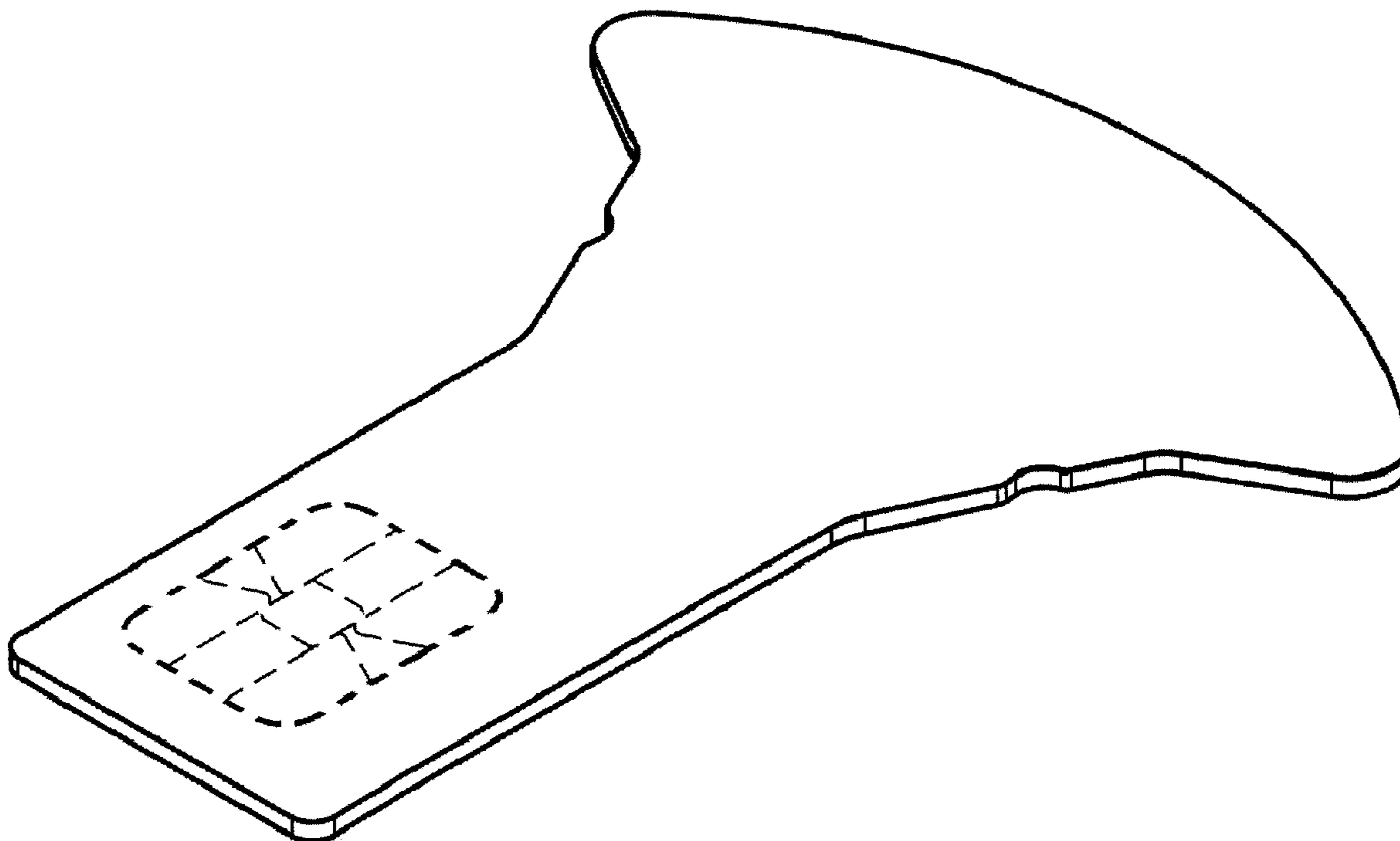
DESCRIPTION

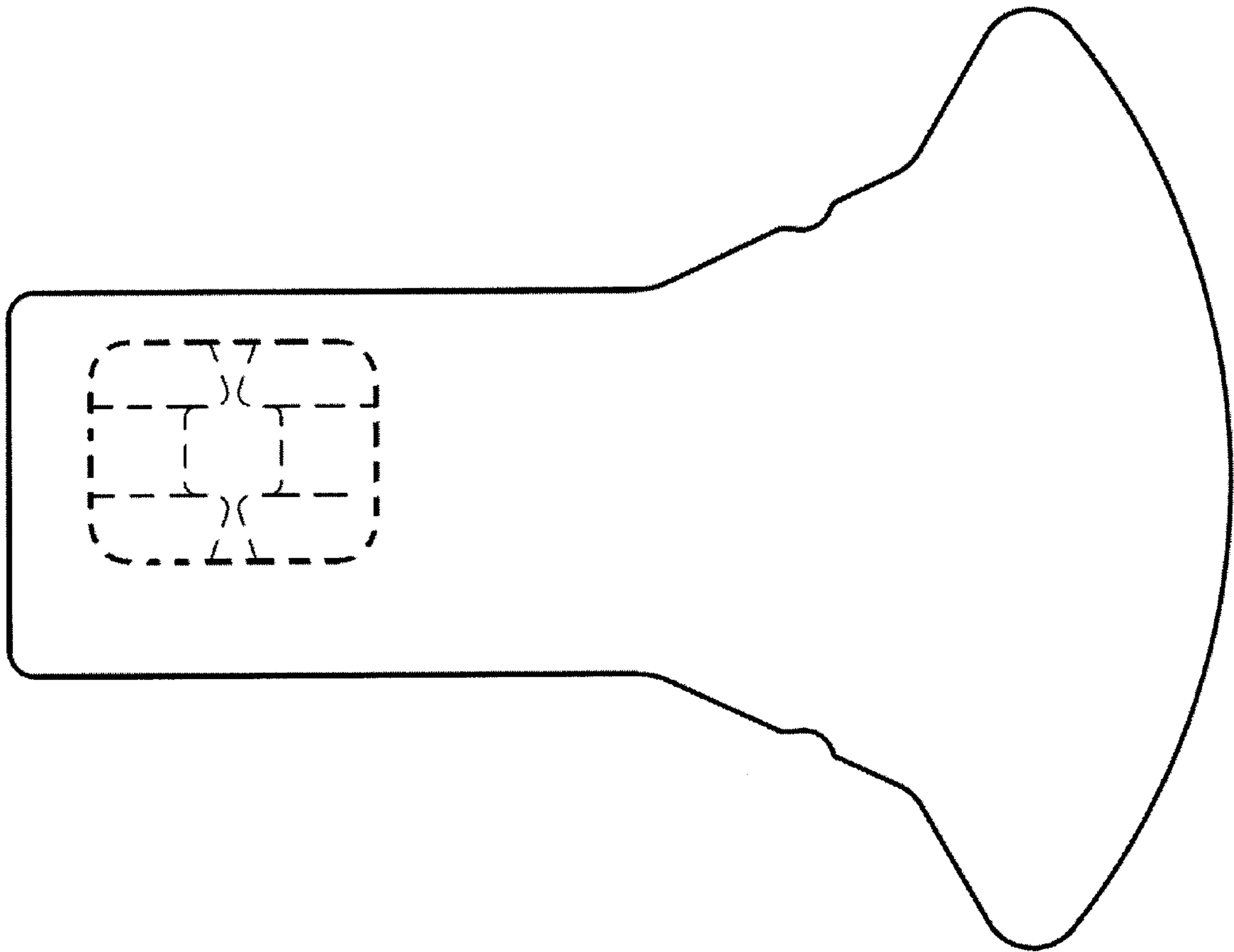
