(57) **CLAIM**

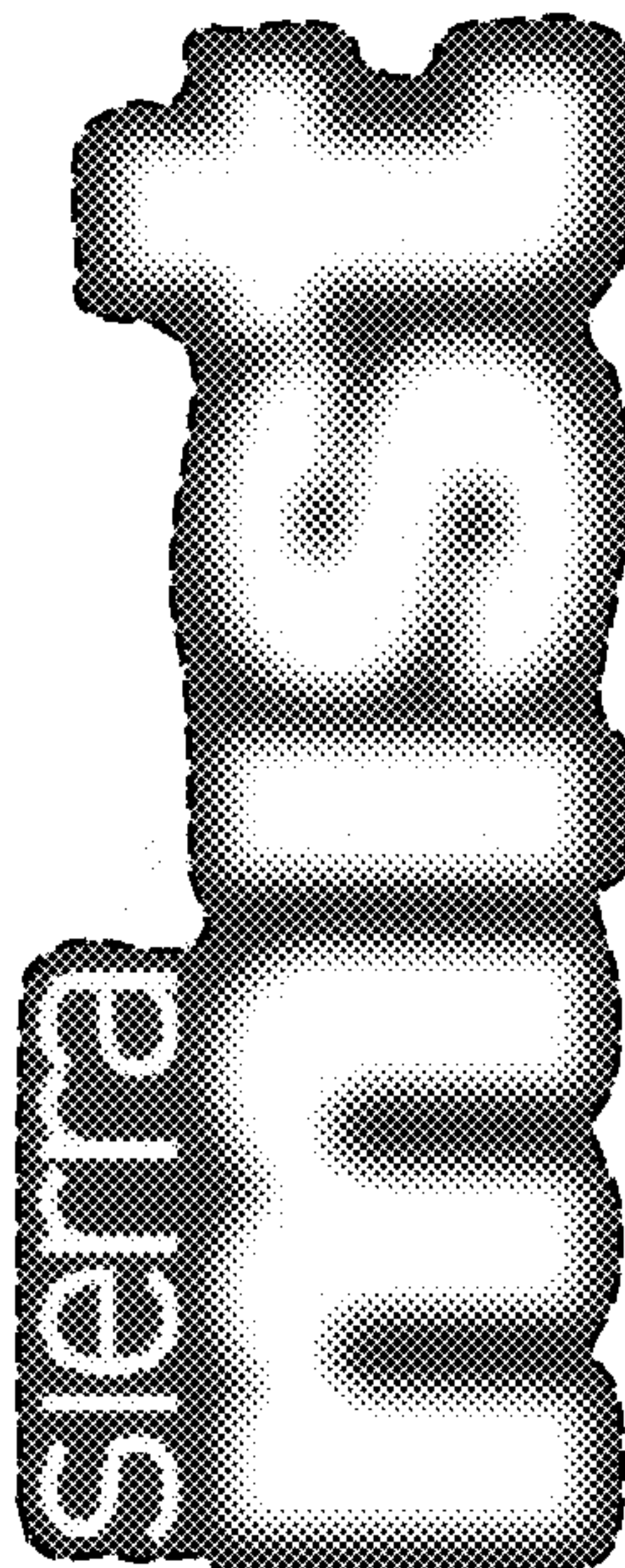
The ornamental design for display screen with icon or packaging with surface ornamentation, as shown and described.

**DESCRIPTION**

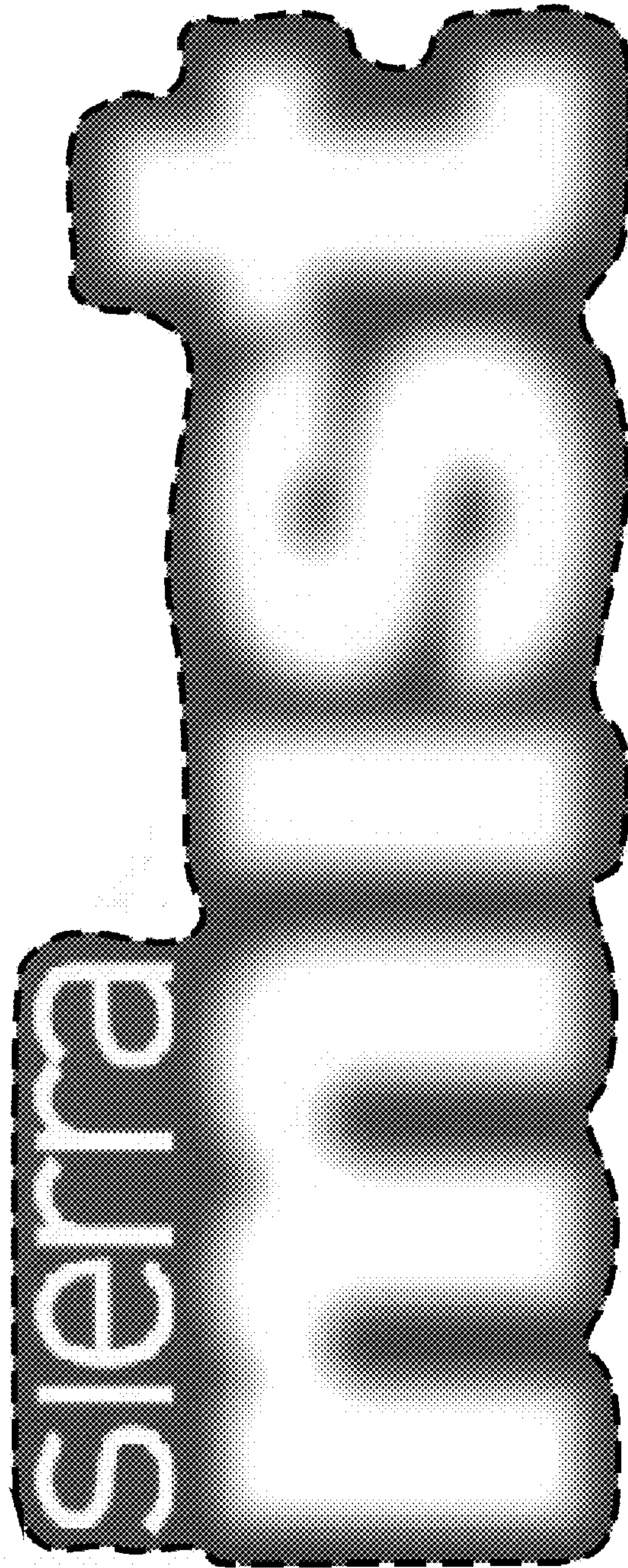
The FIGURE is a front view of an display screen with icon or packaging with surface ornamentation showing our new design.
