(57) **CLAIM**

The ornamental design for adhesive sheet of accessories for hospital rooms exhibiting electro-luminescent properties, as shown and described.

DESCRIPTION

The sole FIGURE is a top plan view of an adhesive sheet comprising removable accessories for hospital room exhibiting electro-luminescent properties.

The broken lines represent perforated lines by which a desired accessory for hospital rooms exhibiting electro-luminescent properties may be individually removed forming part of the claimed design.
