FIG. 3 is the rear view thereof;

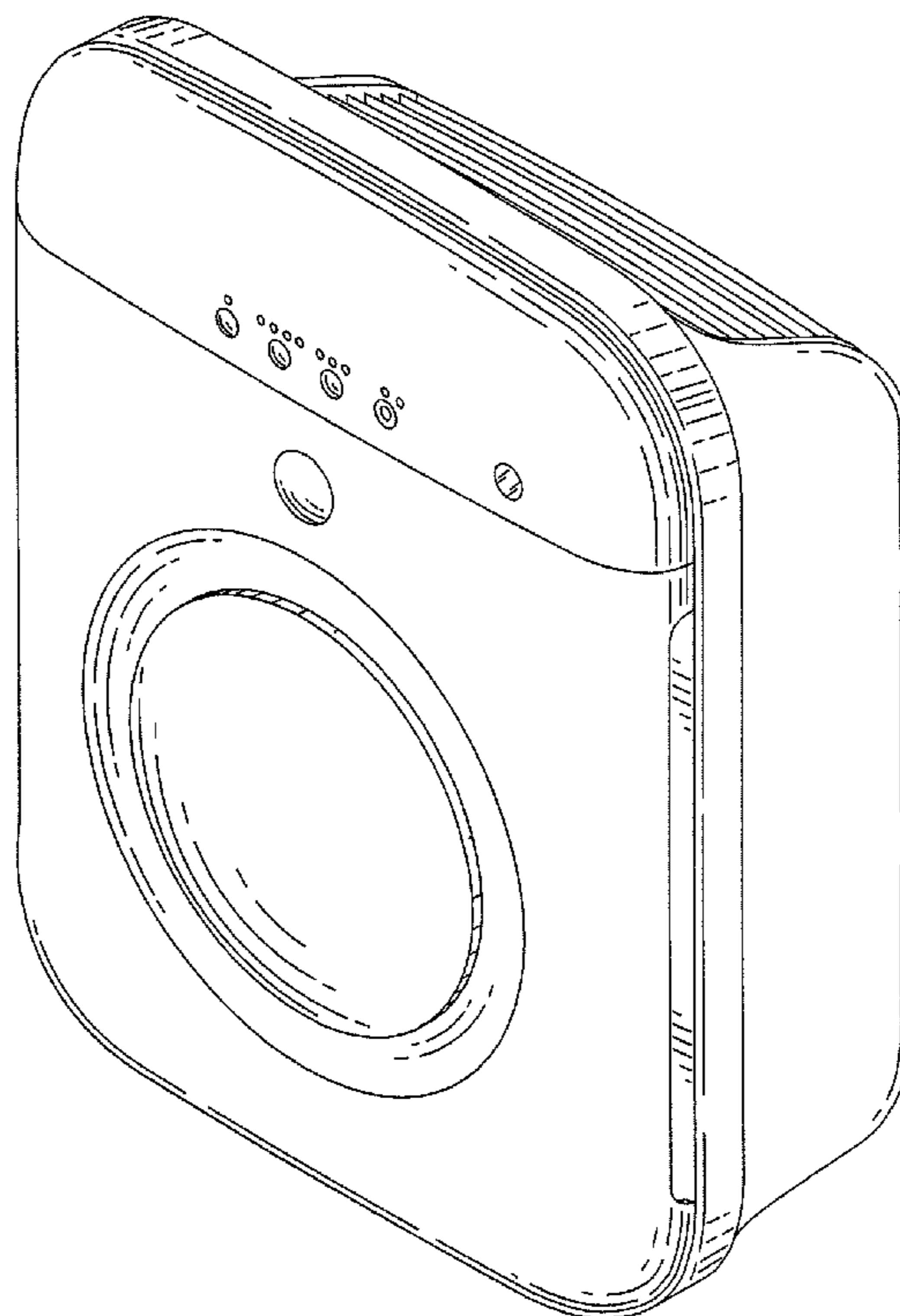
FIG. 4 is the left side view thereof;

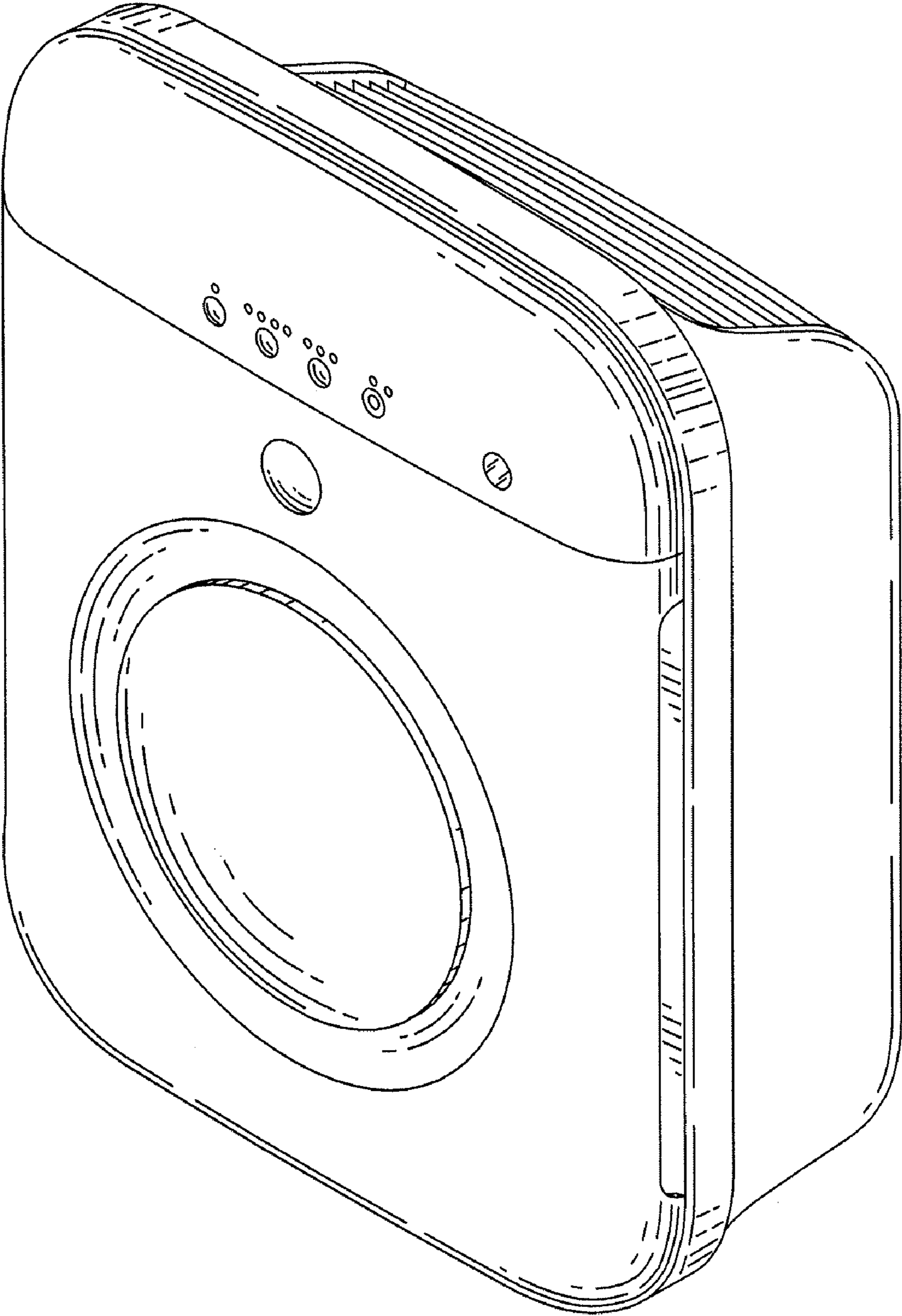

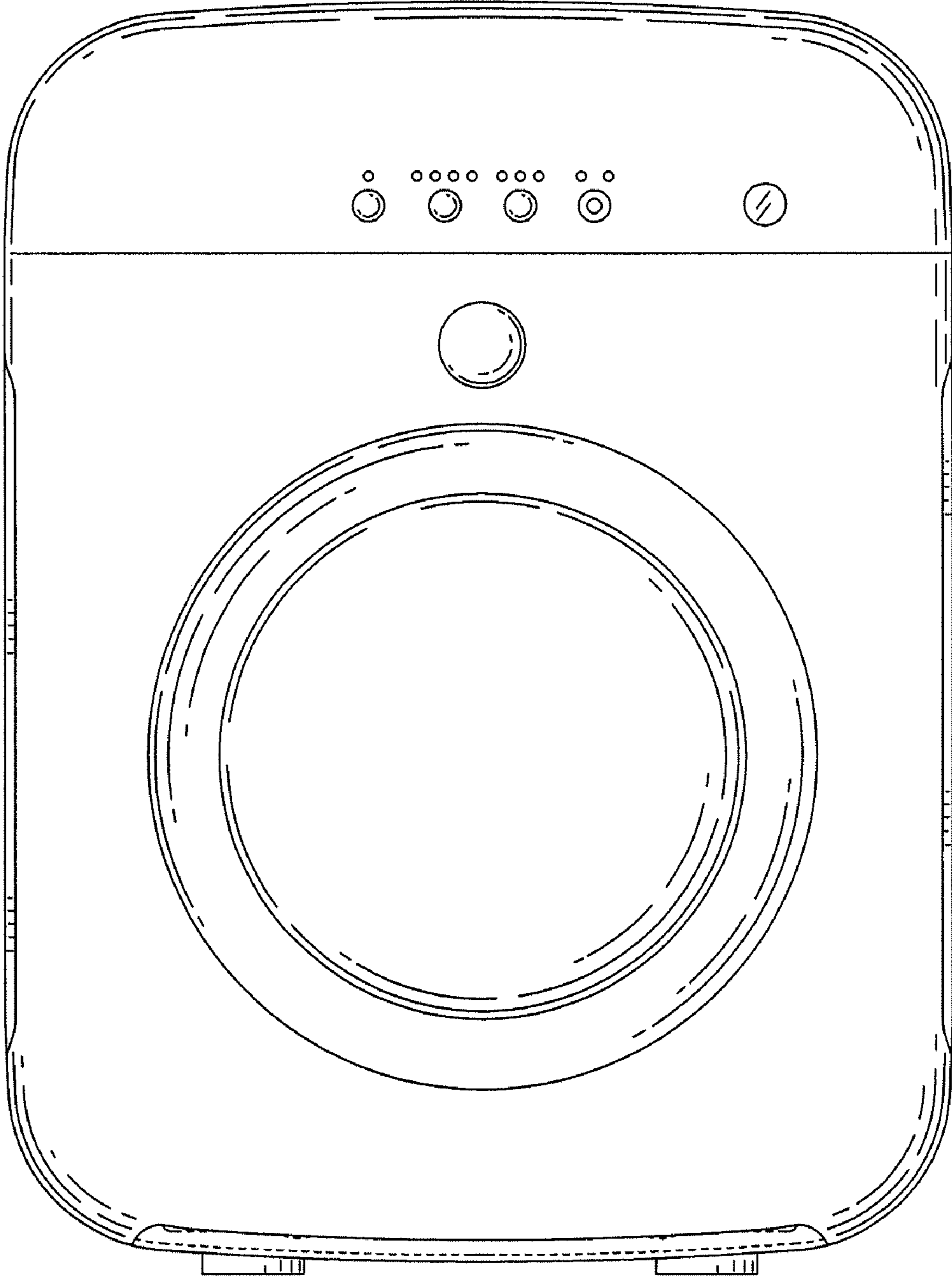

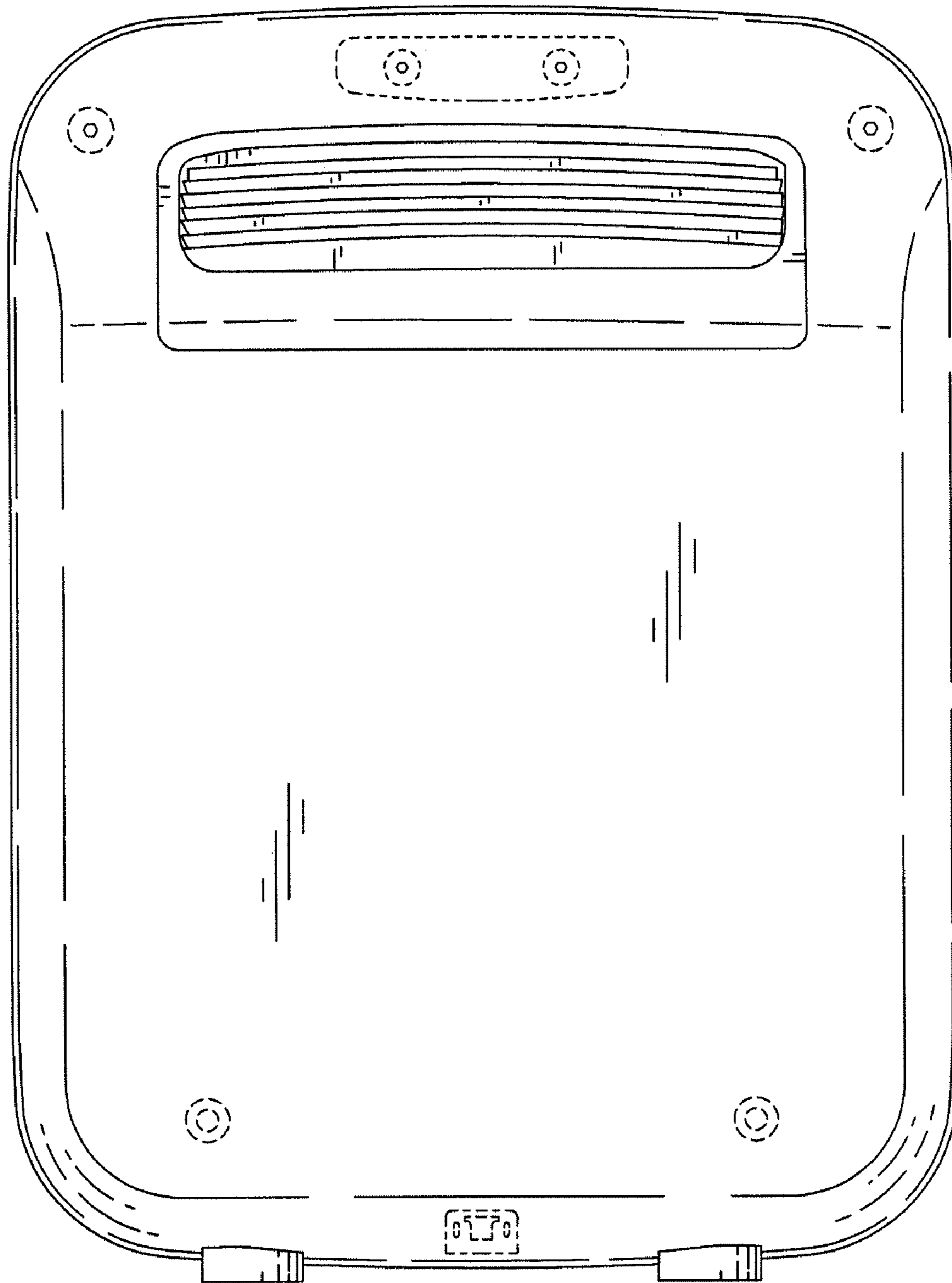

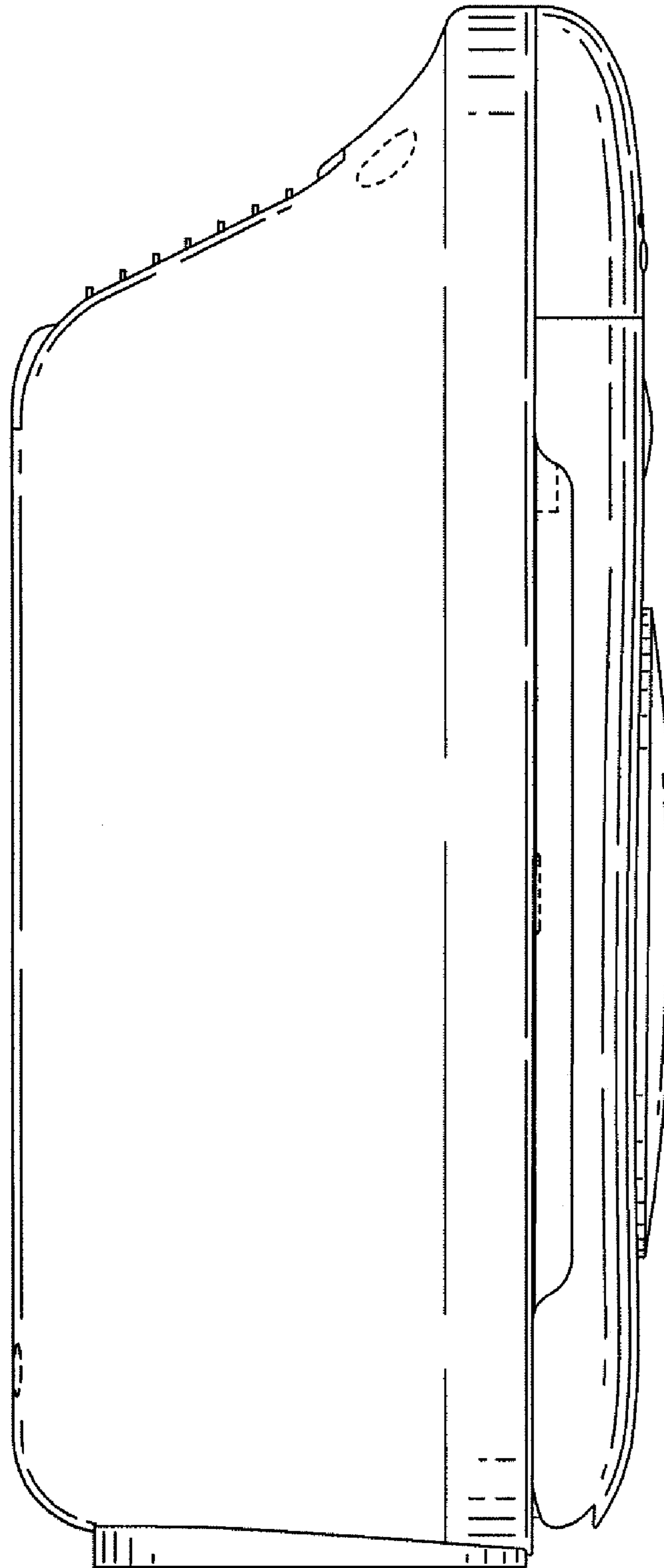

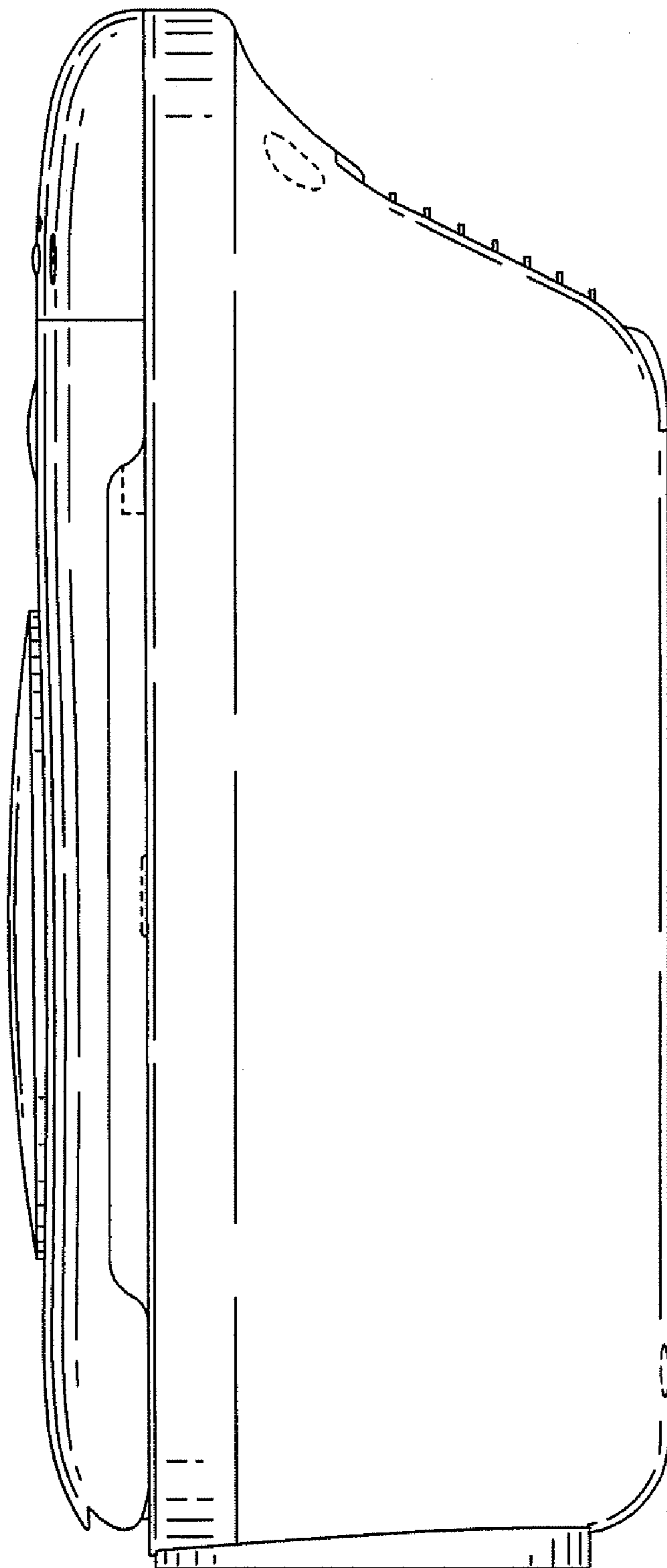

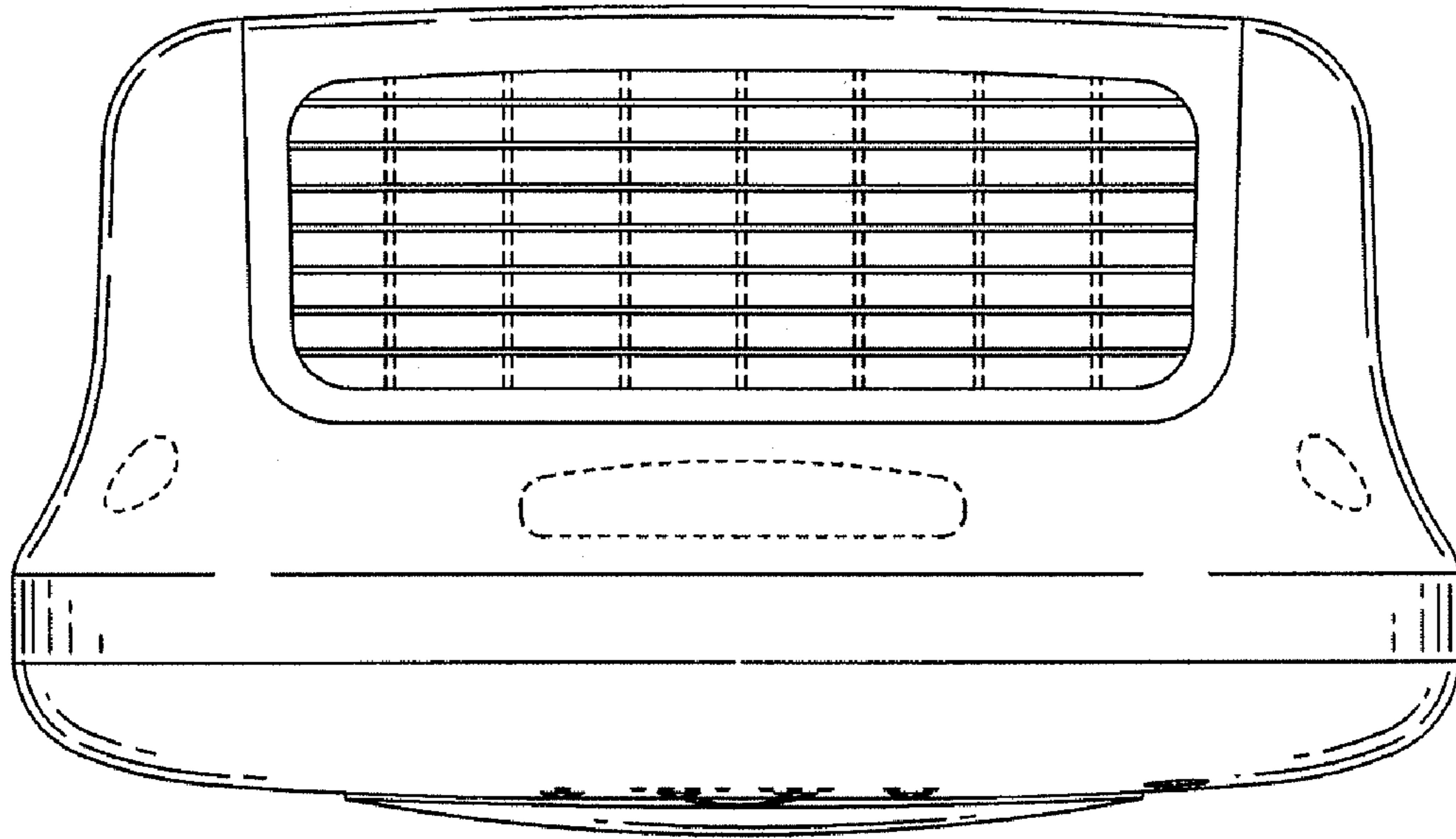

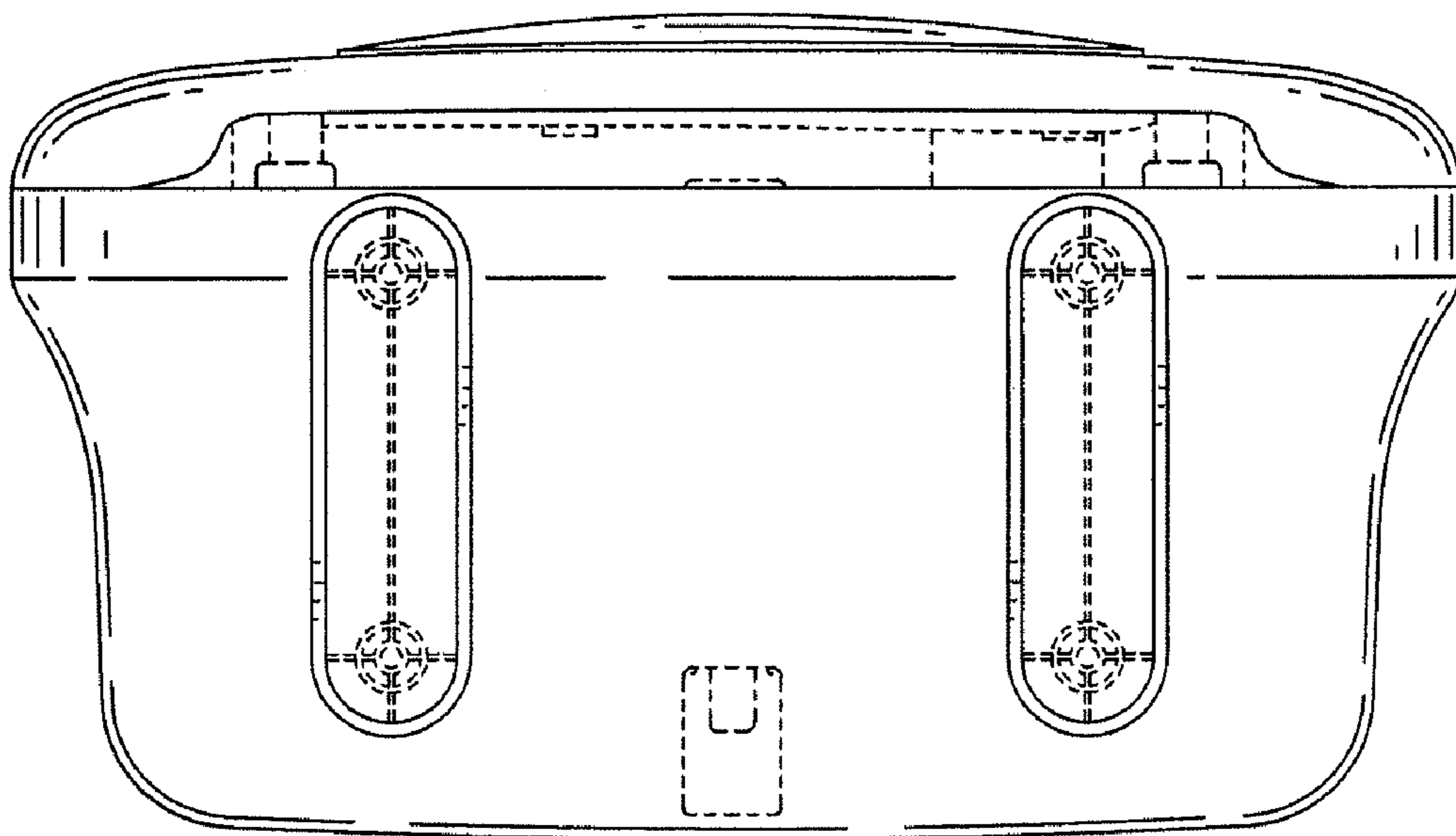
