FIG. 4 is a left view of FIG. 2.

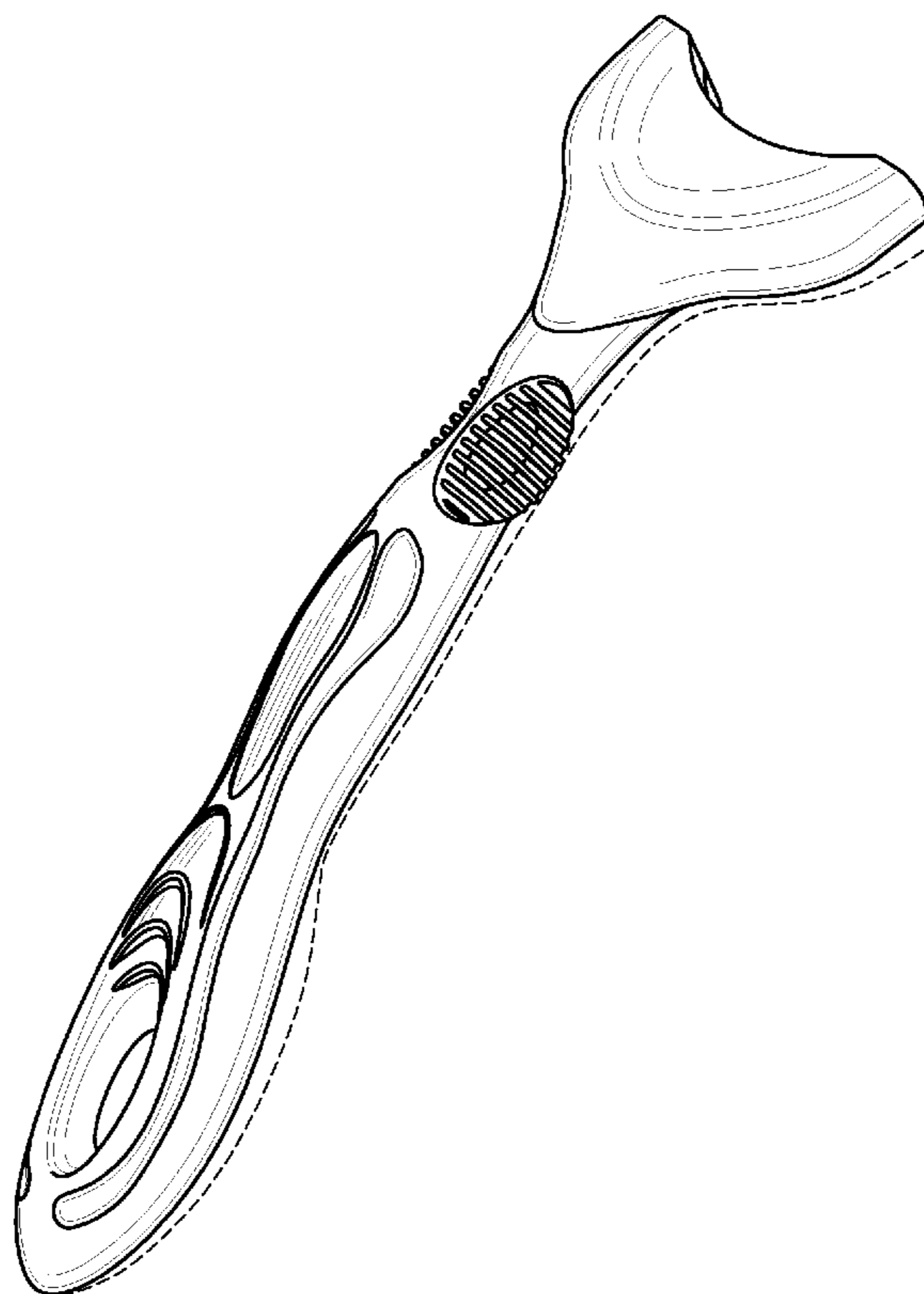
FIG. 5 is a right view of FIG. 2.

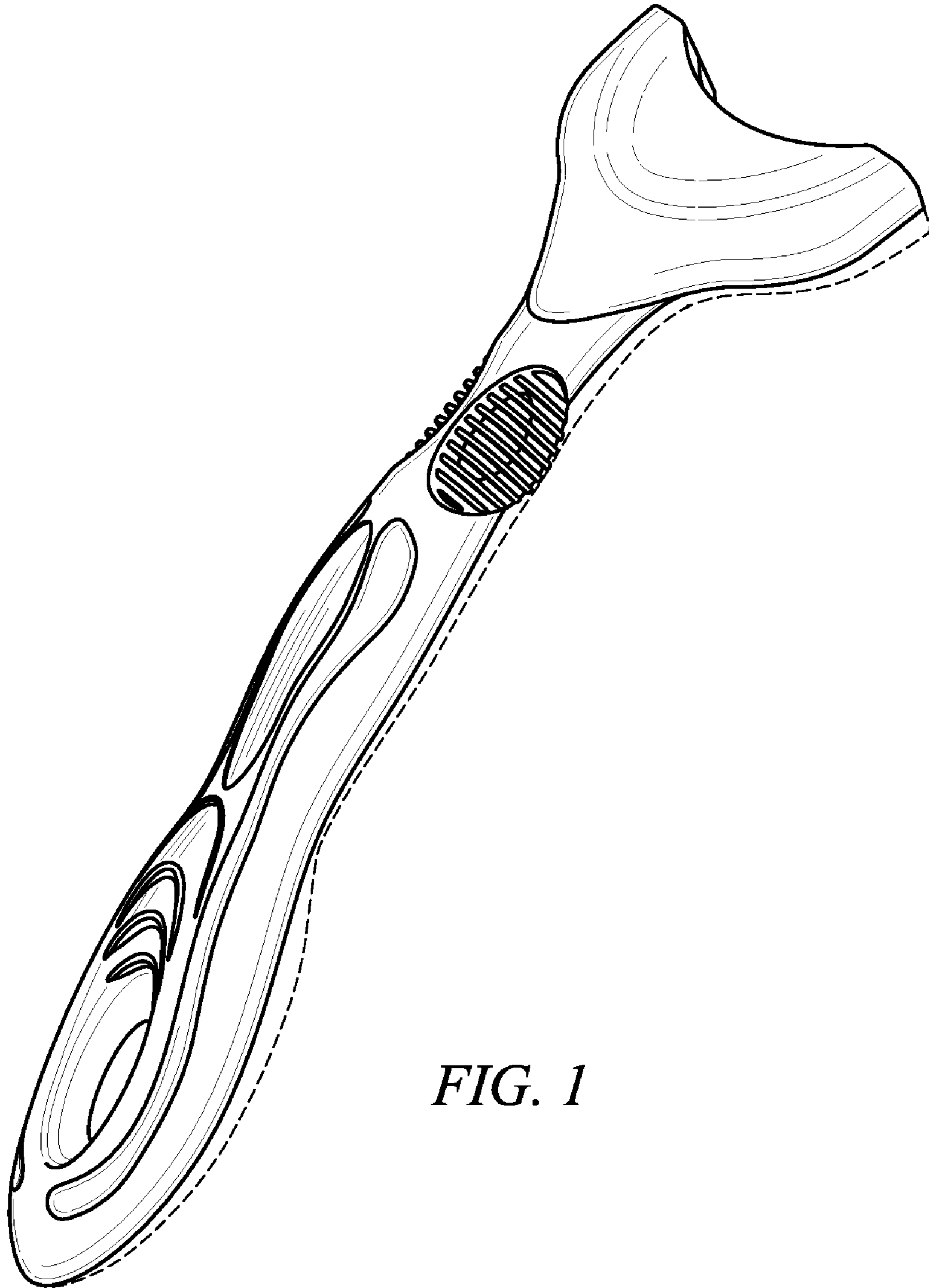
FIG. 6 is an upper end view thereof; and,

FIG. 7 is a lower end view thereof.

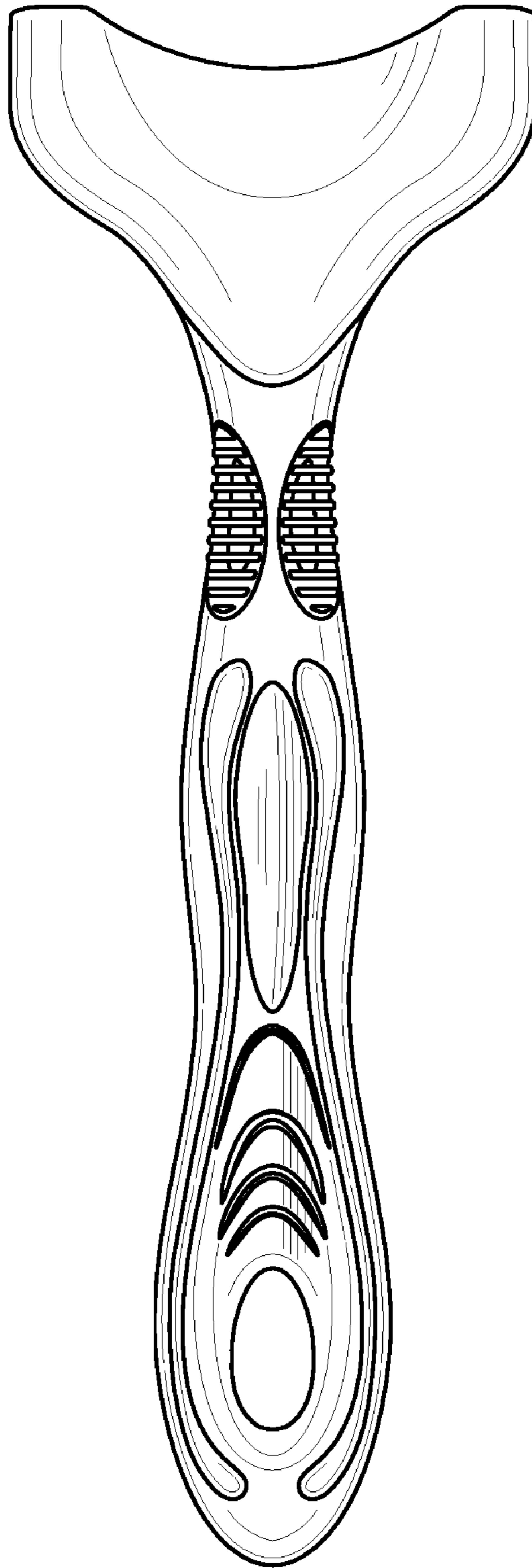

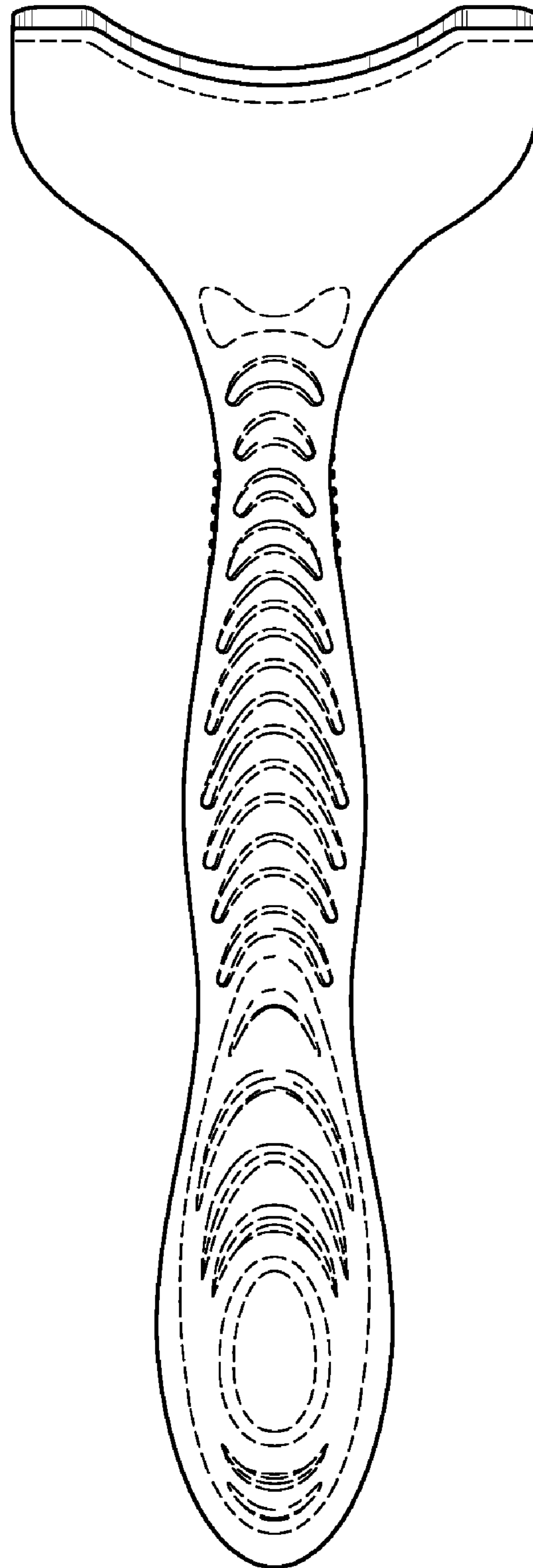




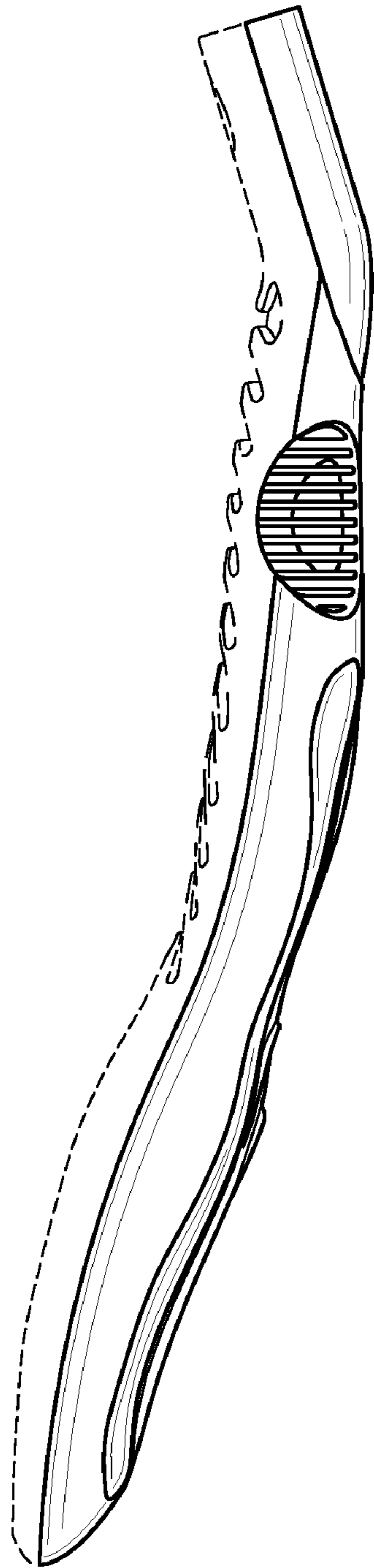

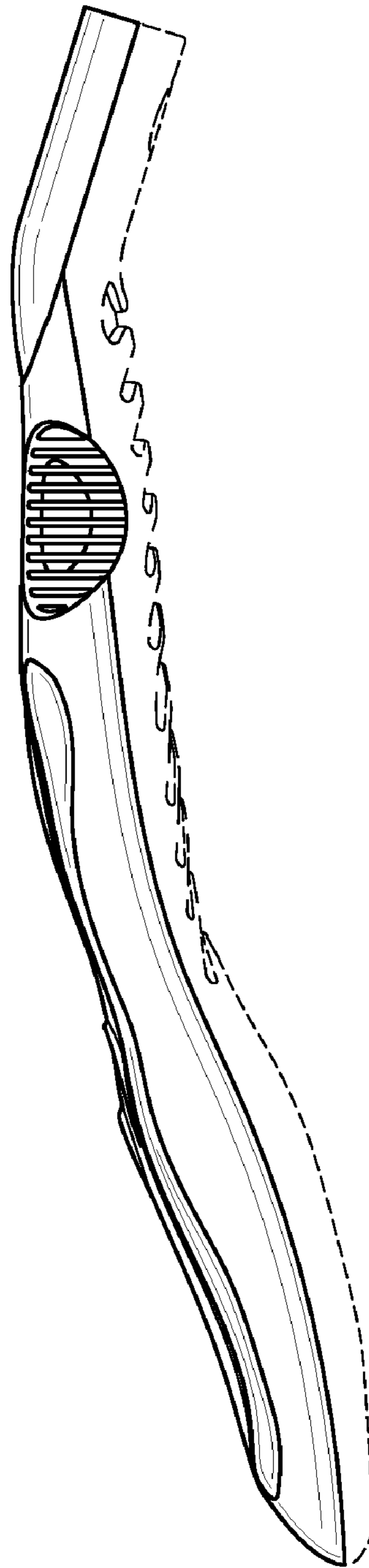

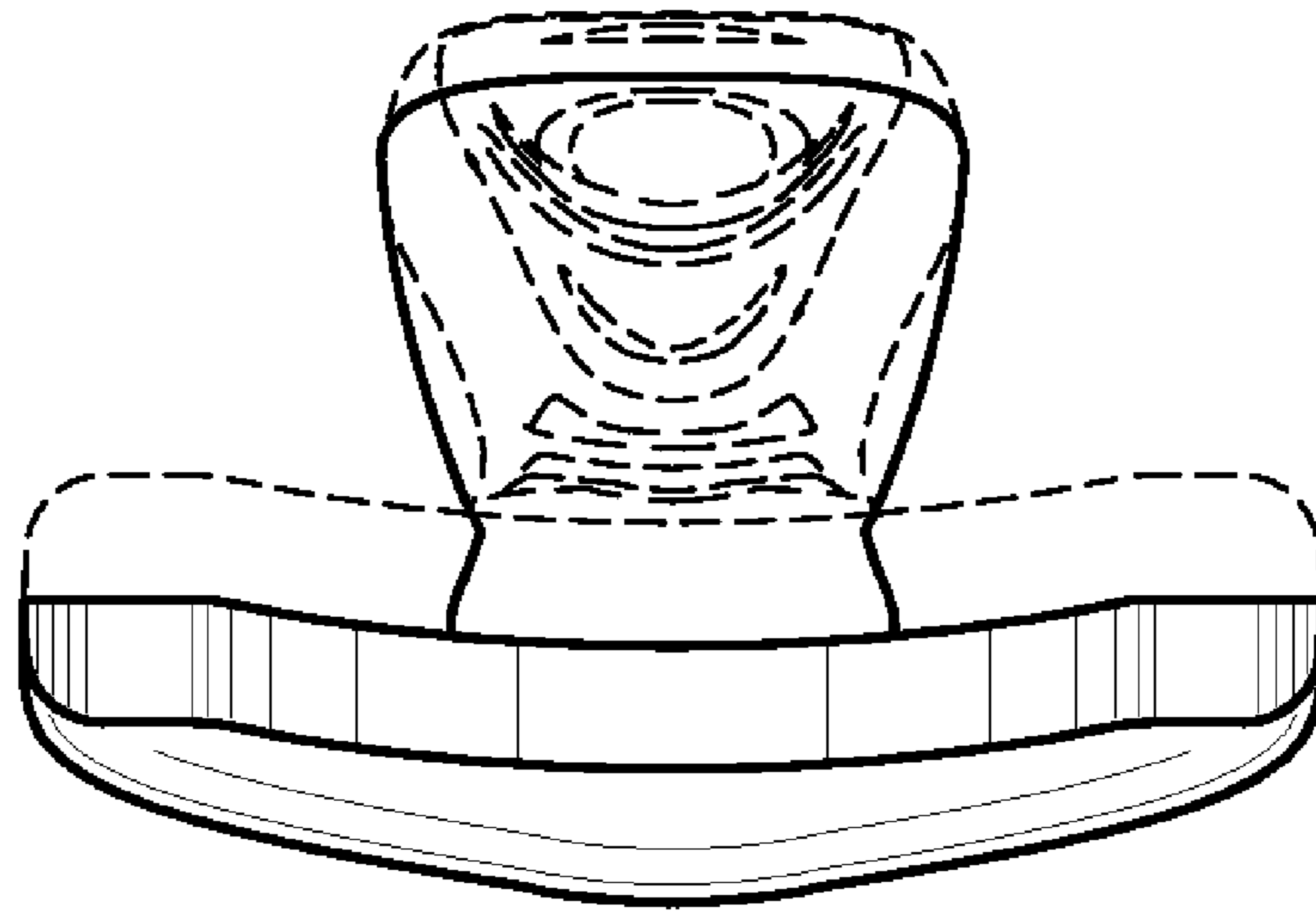

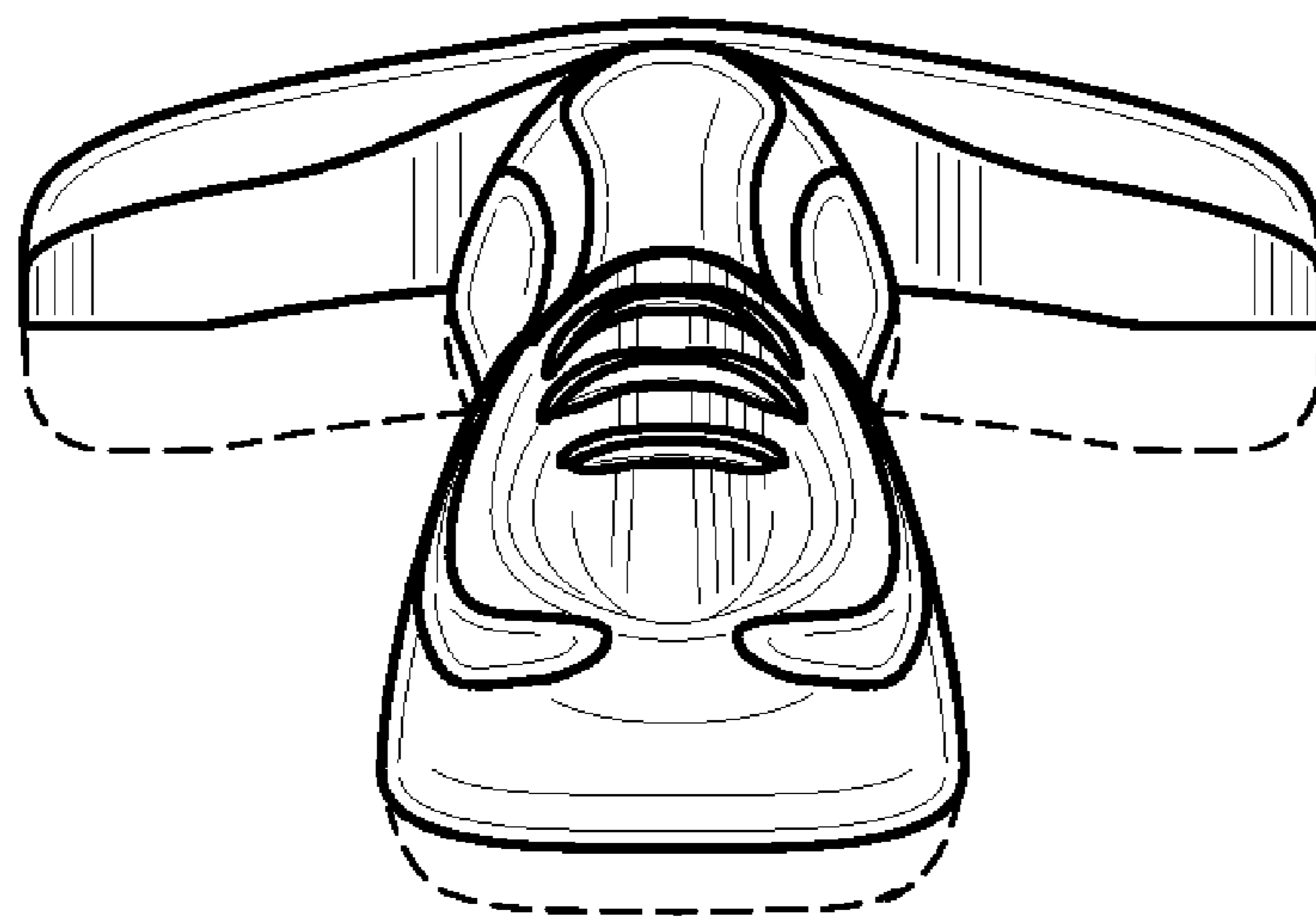
