(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom perspective view of a shoe in accordance with my new design;

FIG. 2 is a bottom view thereof;

FIG. 3 is a top view thereof;

FIG. 4 is a front view thereof;

FIG. 5 is a rear view thereof;

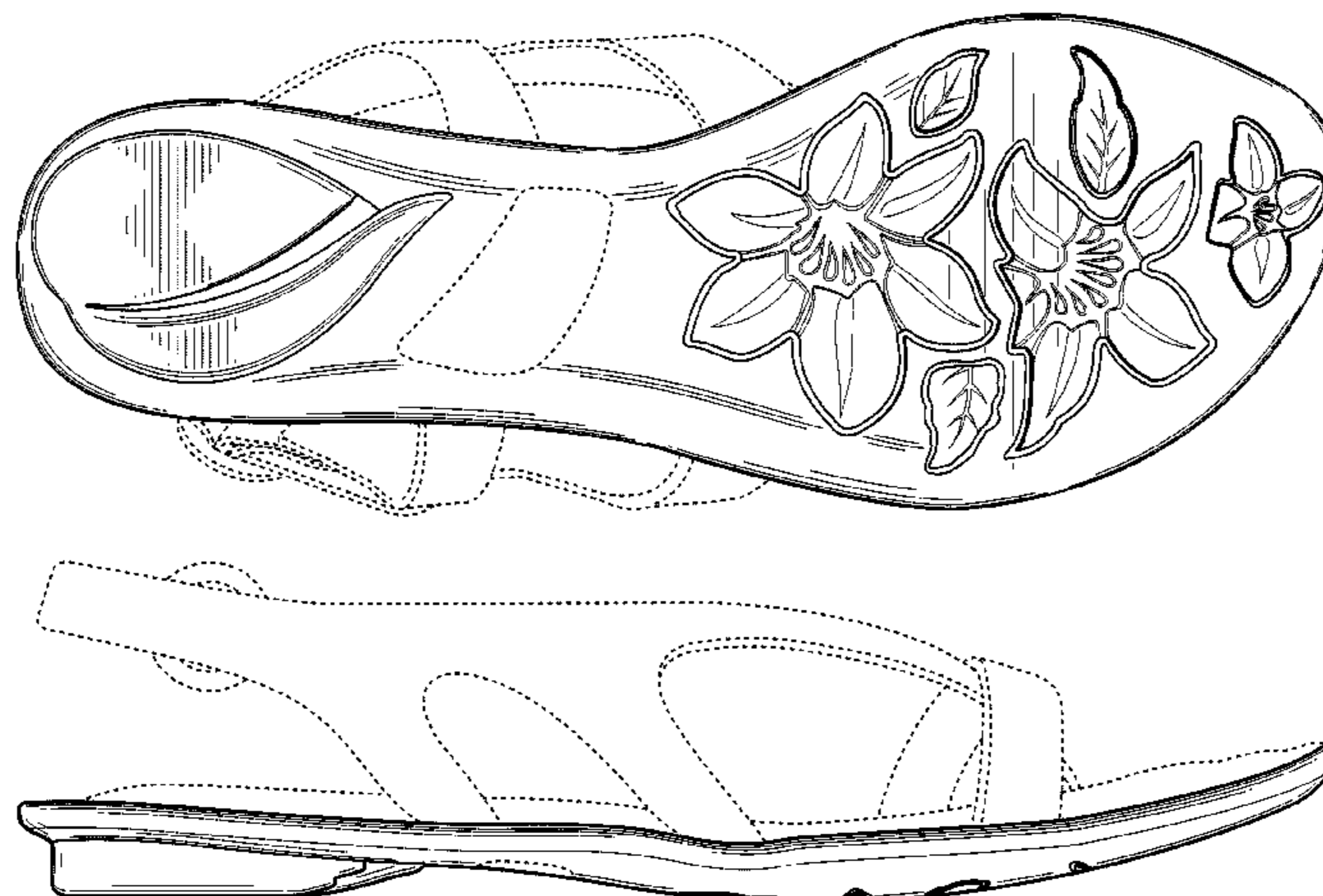
FIG. 6 is a left side view thereof;

FIG. 8 is an enlarged perspective view of the area labeled “8” in FIG. 1.

The broken lines shown in each arch area of FIGS. 1–2 and 6–7 represent boundaries of the design with the lines themselves and the areas within them forming no part of the claim.

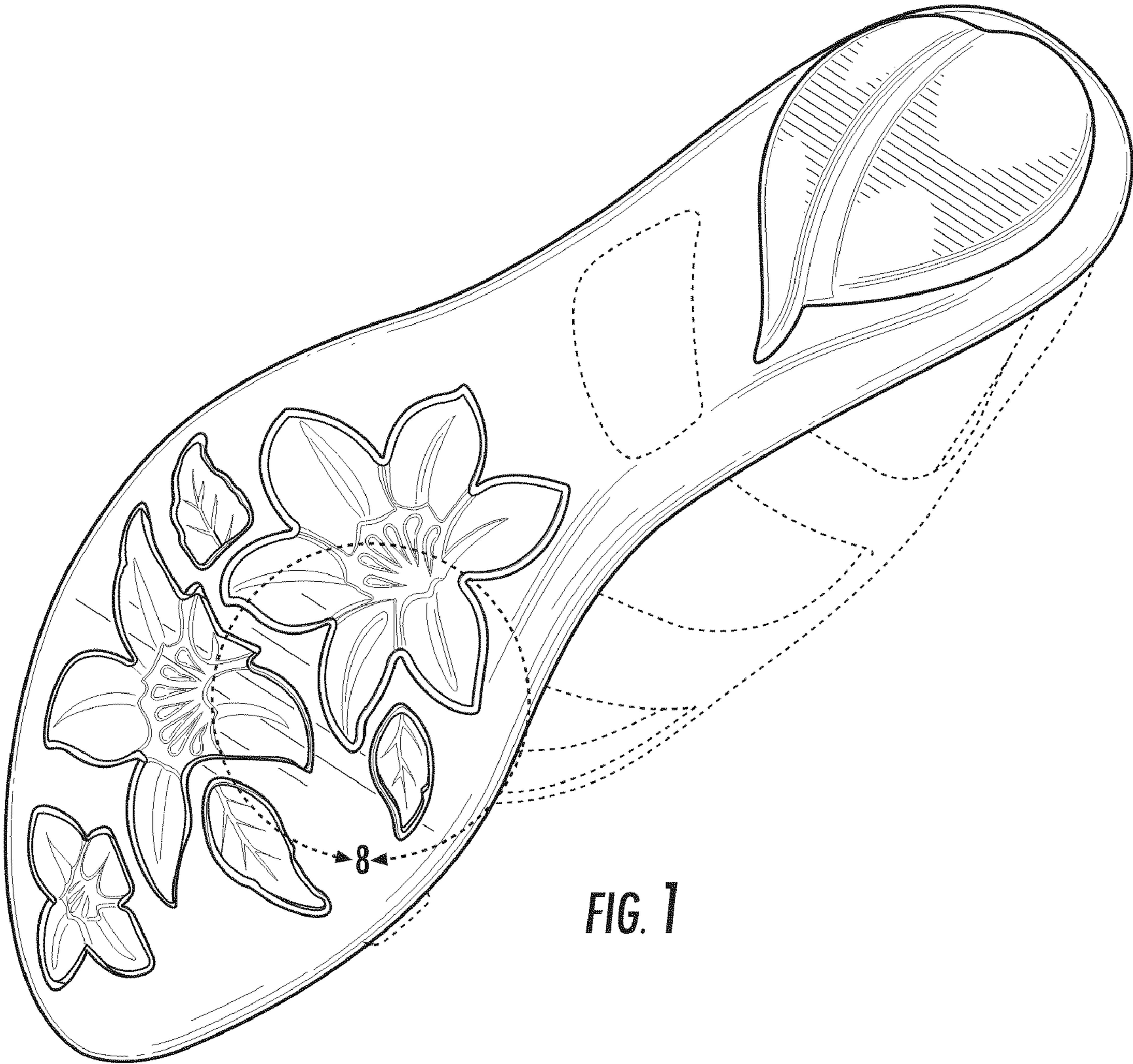

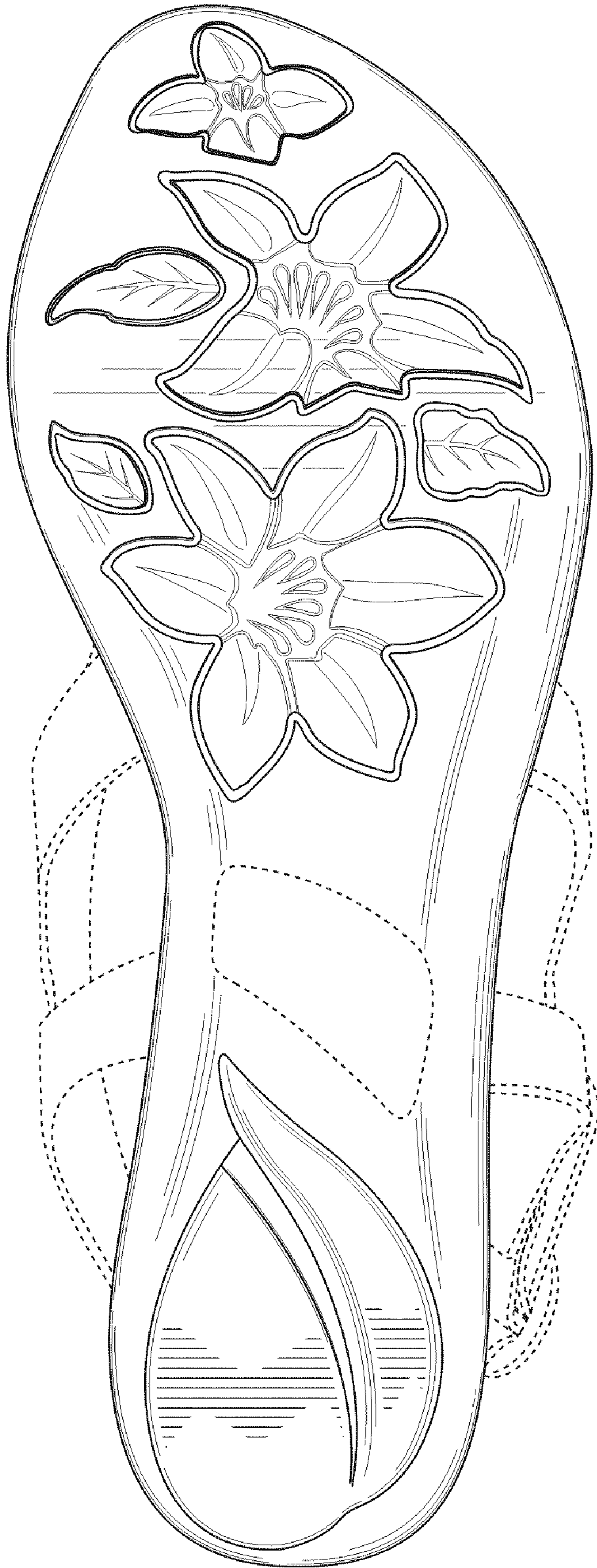

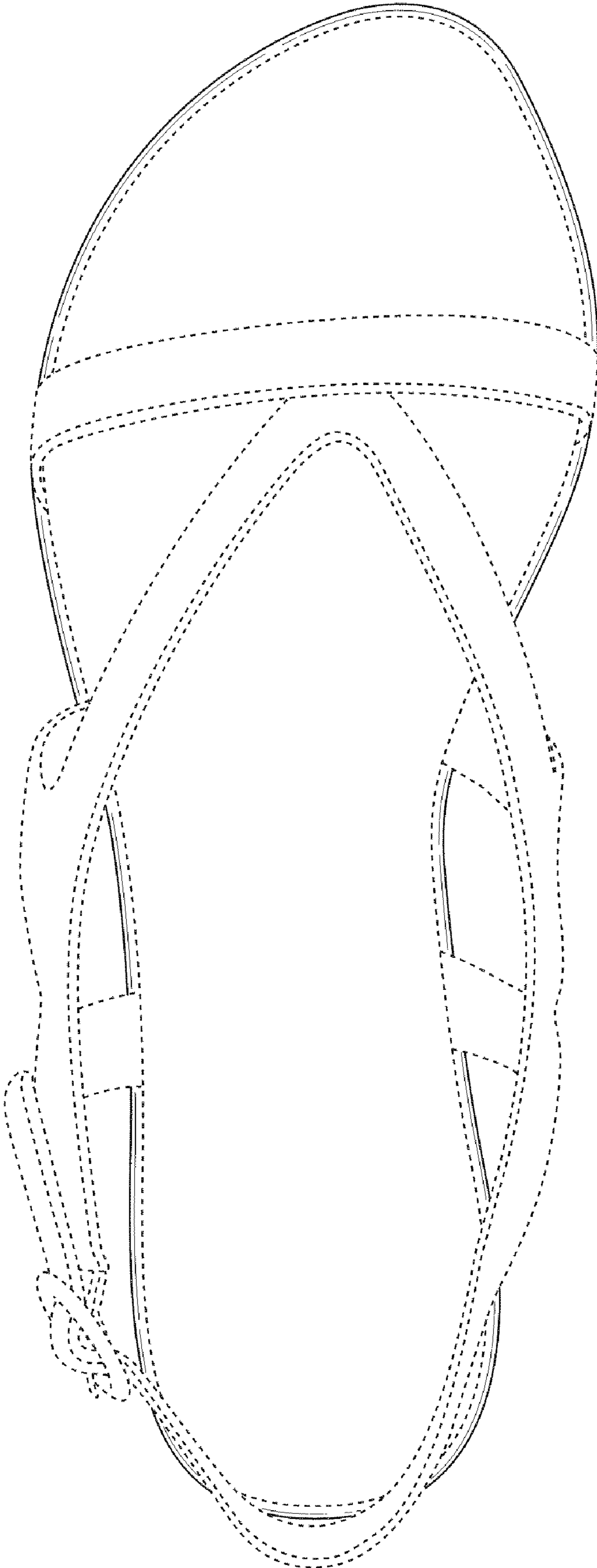
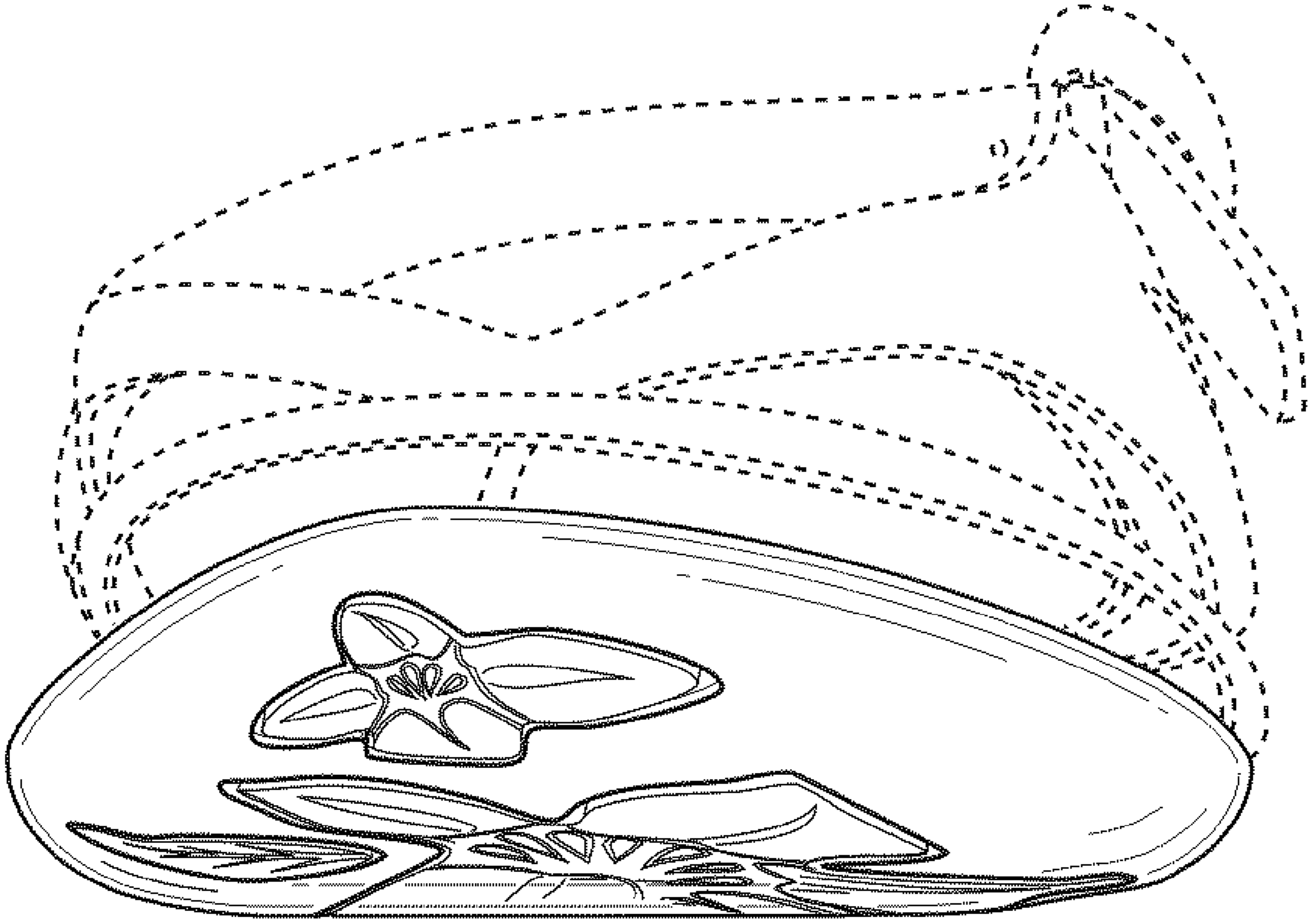
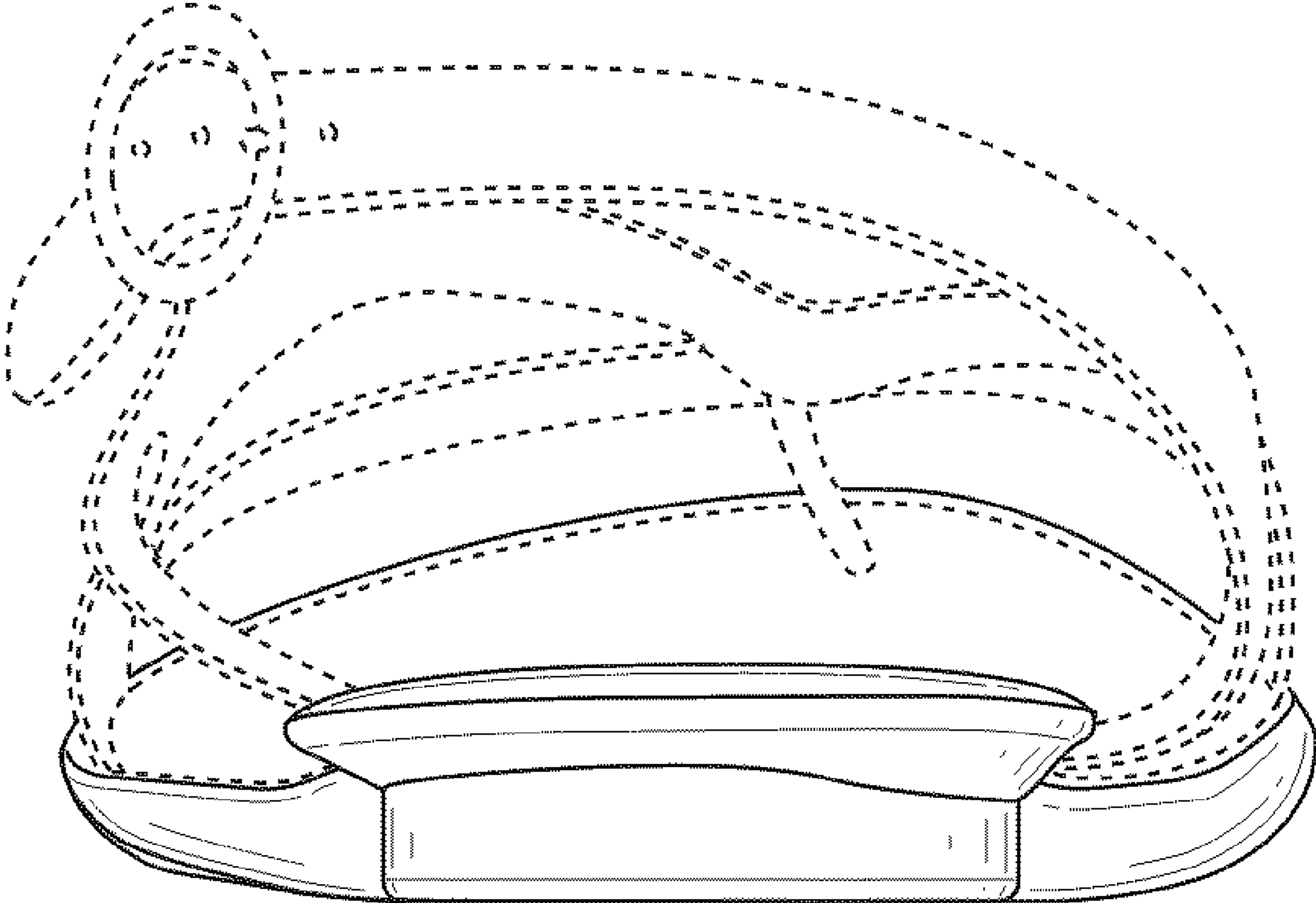

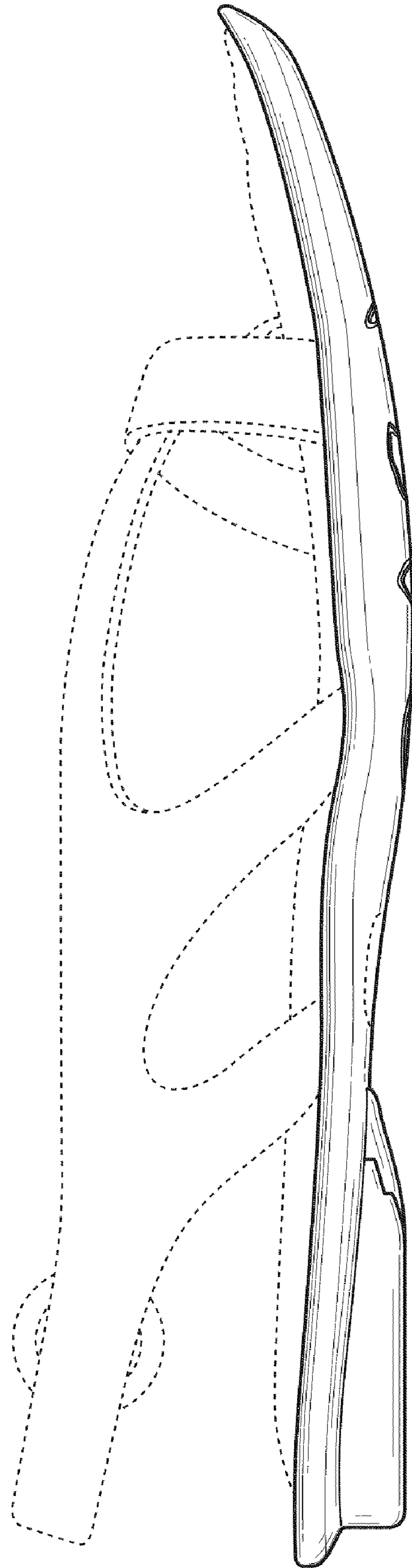

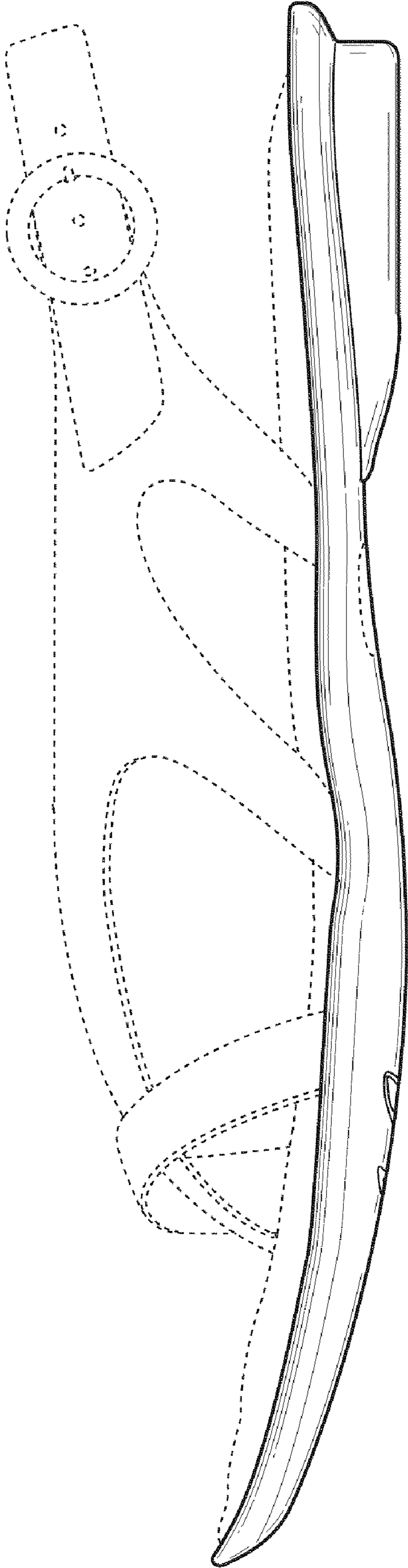
