FIG. 9 is a cross-sectional view thereof taken along line 9—9 of FIG. 2.

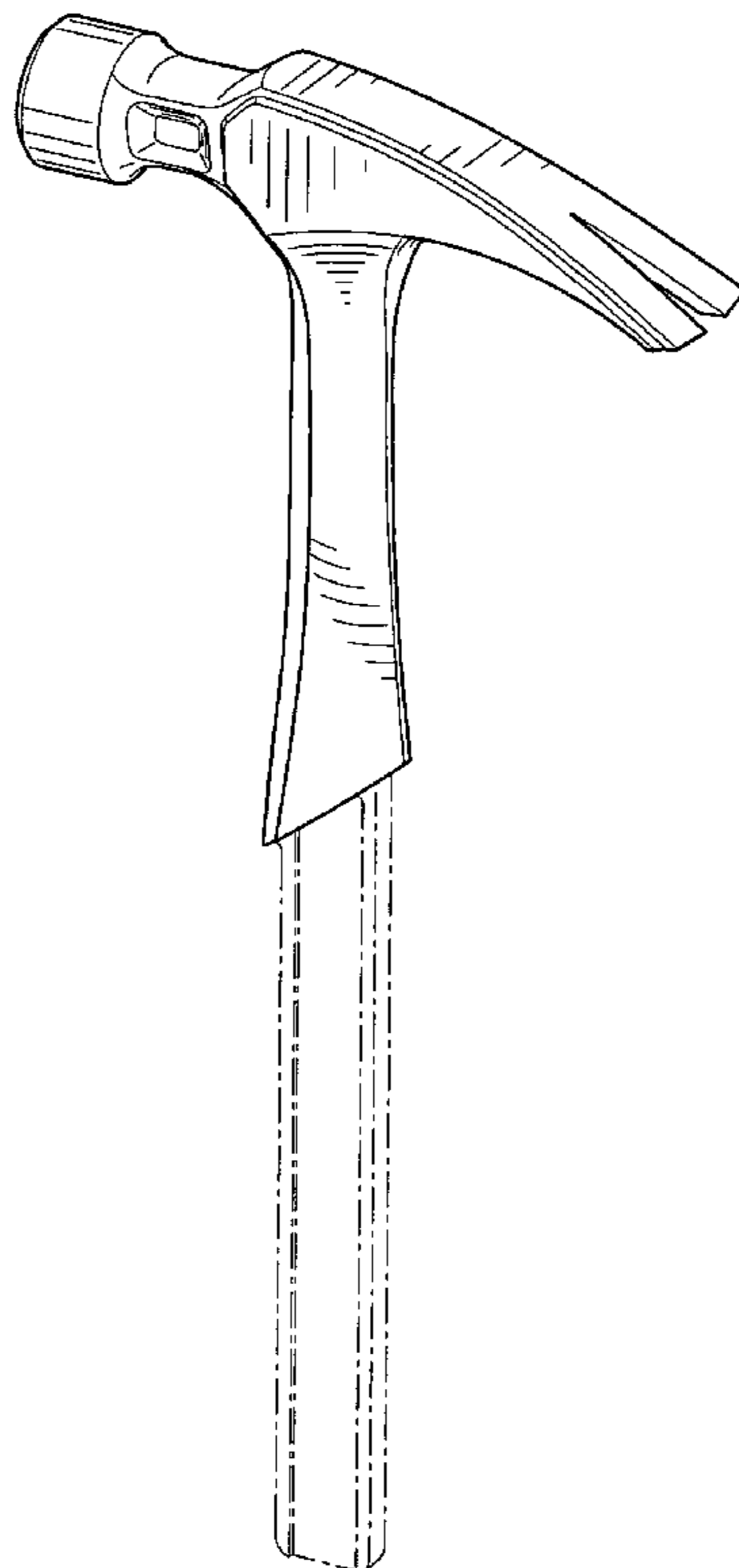
The handle attached to the hammerhead shown in broken lines is included for illustrative purposes only and forms no part of the claimed design.

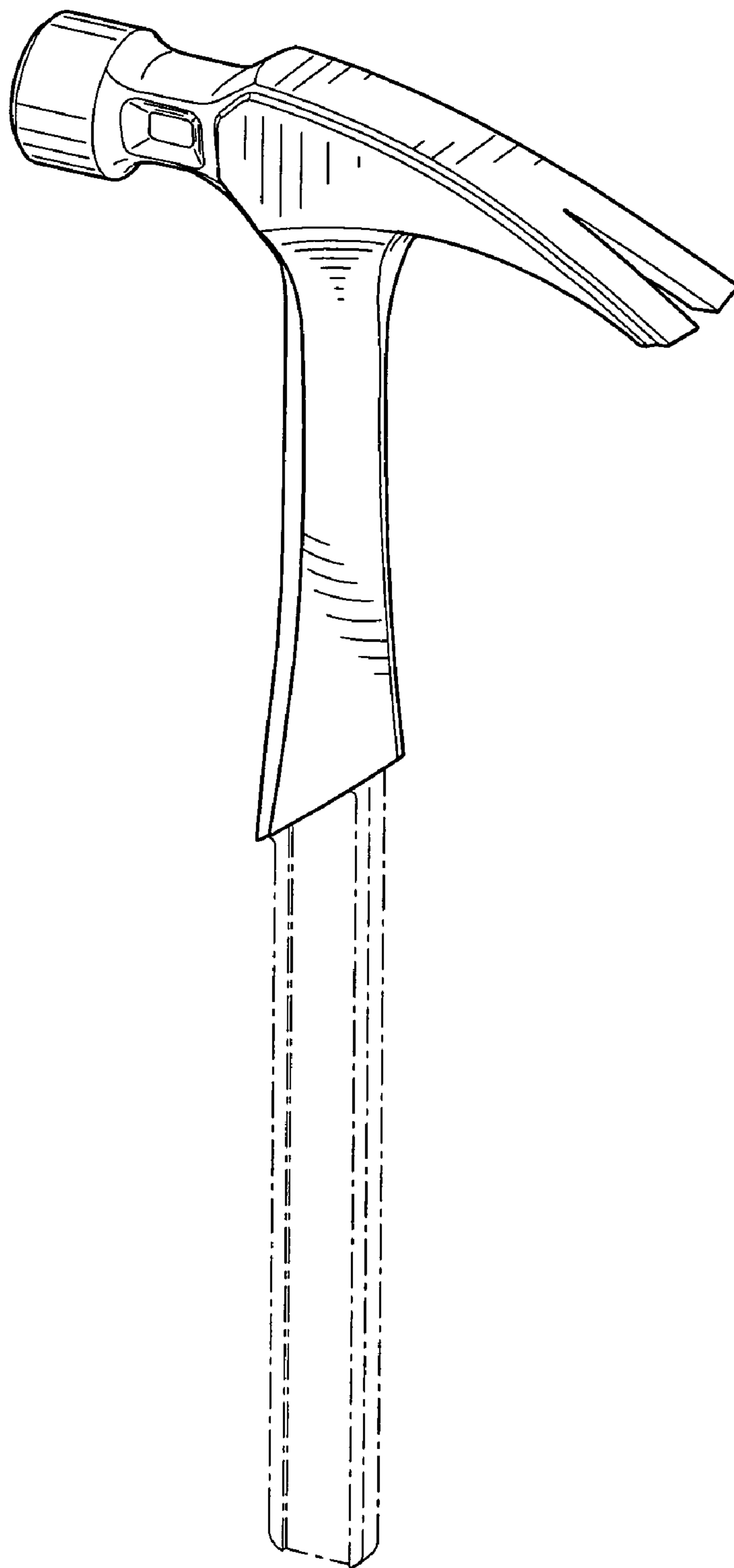

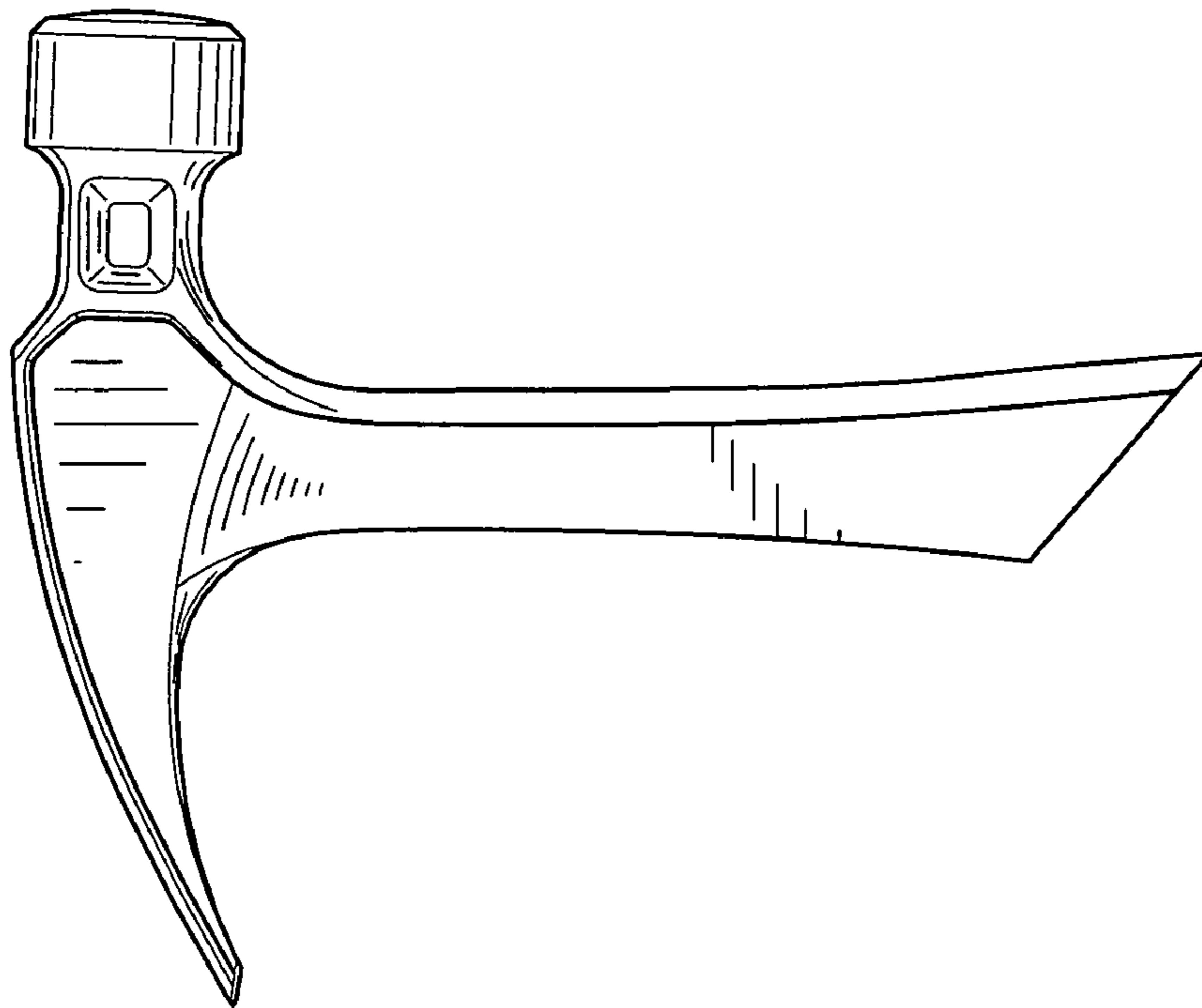

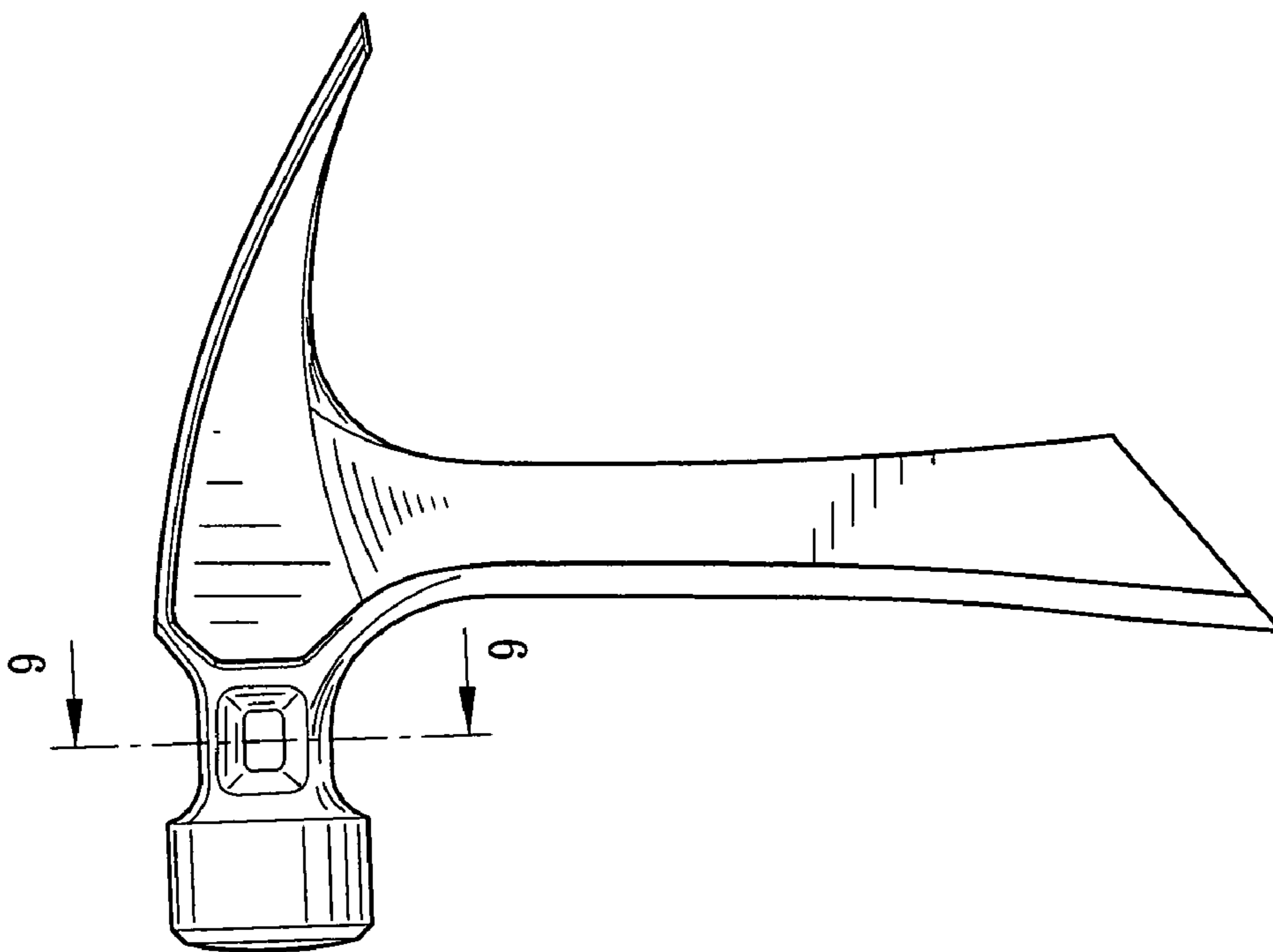

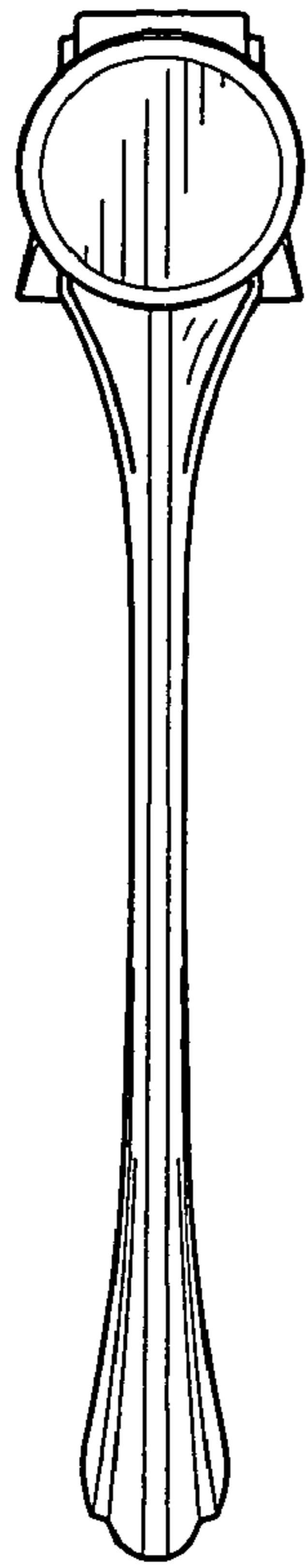

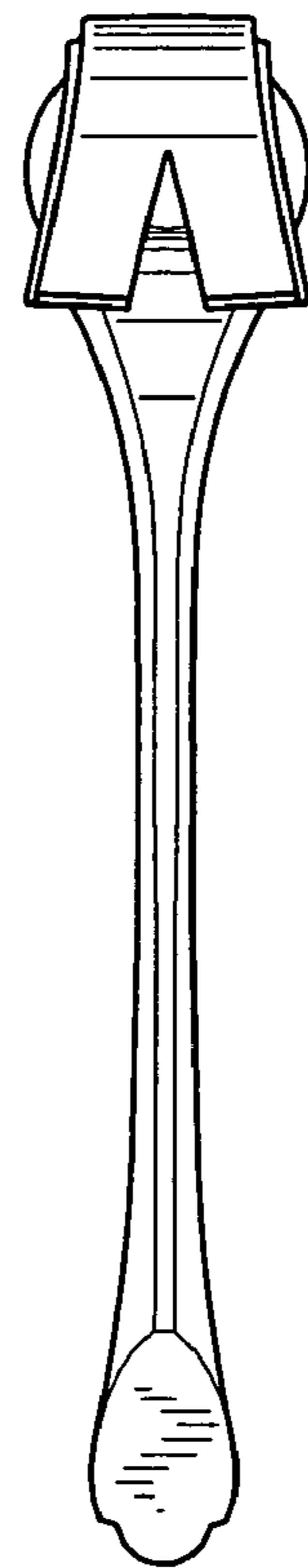

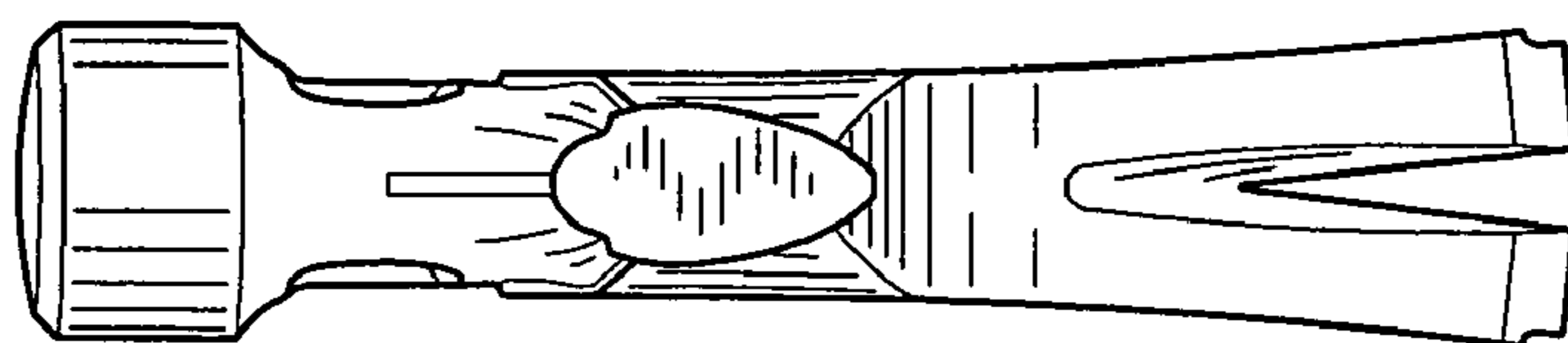

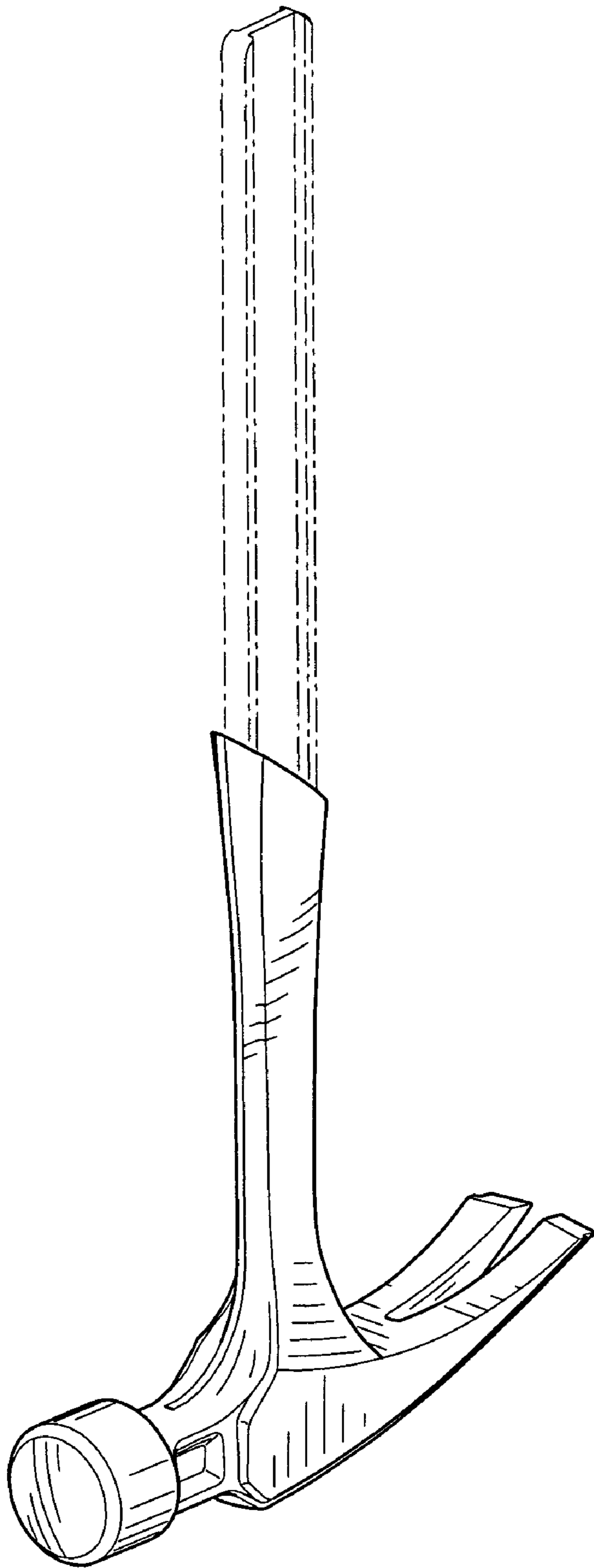

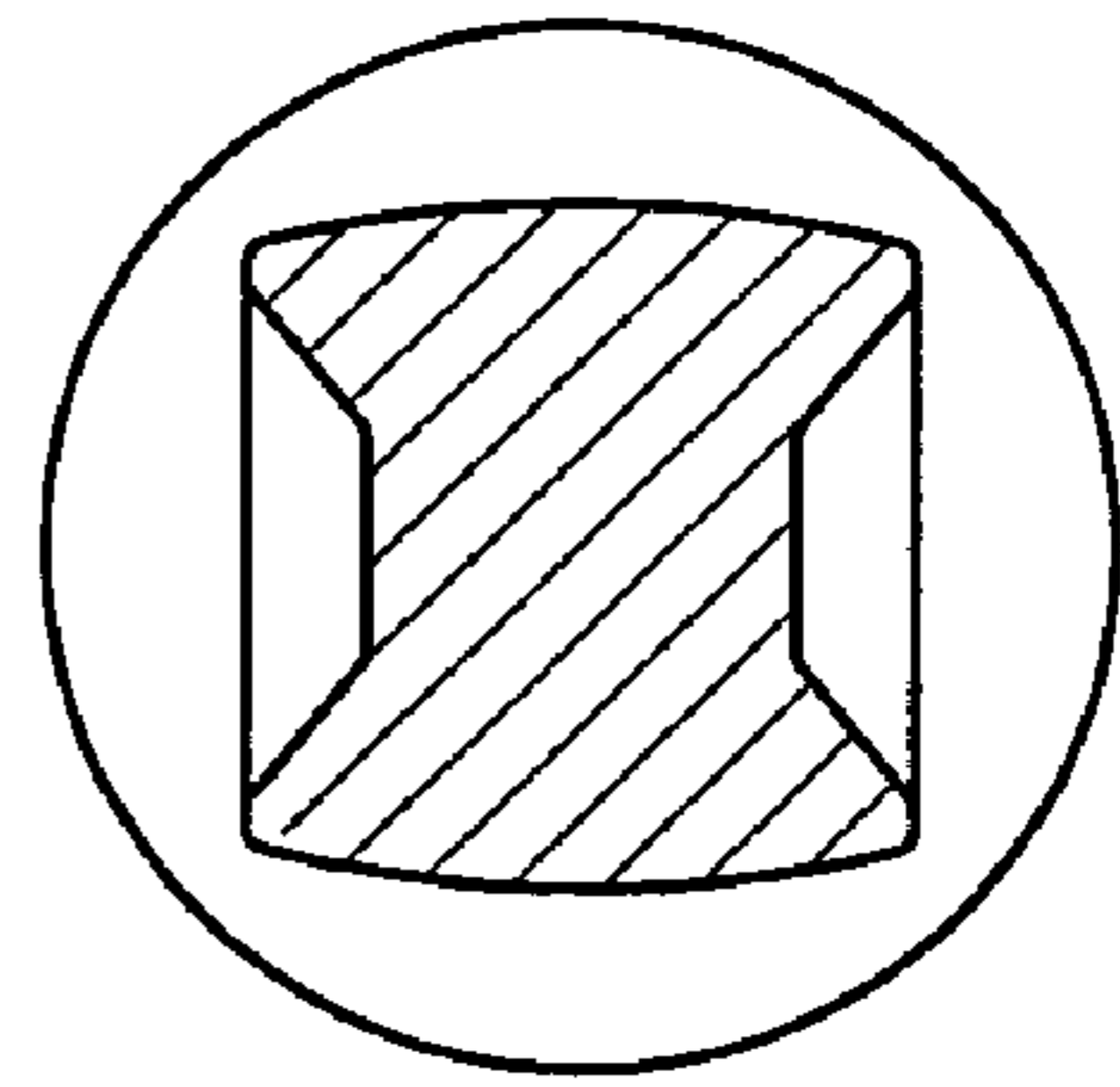
