(57) **CLAIM**

I claim the ornamental design for a foldable lighted multi-purpose tool, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a foldable lighted multi-purpose tool, with the multi-purpose tool in a folded configuration.

FIG. 2 is a front elevation view of the multi-purpose tool of FIG. 1.

FIG. 3 is a rear elevation view of the multi-purpose tool of FIG. 1.

FIG. 4 is another front elevation view of the multi-purpose tool of FIG. 1, with the multi-purpose tool in an unfolded configuration.

FIG. 5 is a right elevation view of the multi-purpose tool of FIG. 1.

FIG. 6 is a left elevation view of the multi-purpose tool of FIG. 1.

FIG. 7 is a top plan view of the multi-purpose tool of FIG. 1; and,

FIG. 8 is a bottom plan view of the multi-purpose tool of FIG. 1.

The broken lines shown in the drawings represent unclaimed portions of the foldable lighted multi-purpose tool and form no part of the claimed design.

The shading lines shown on the claimed surfaces of the design represent surface shading and contour lines and are not surface decoration.

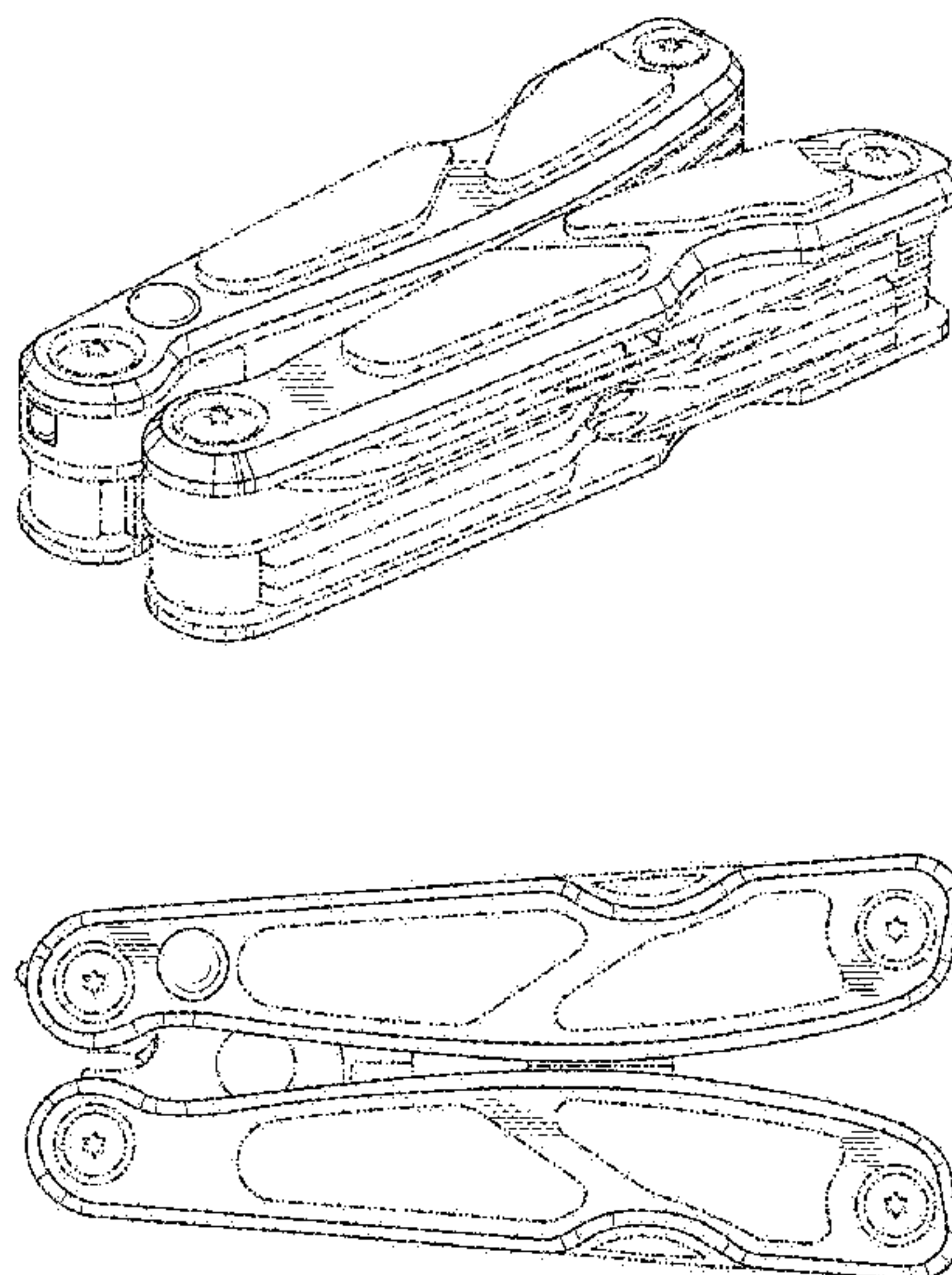

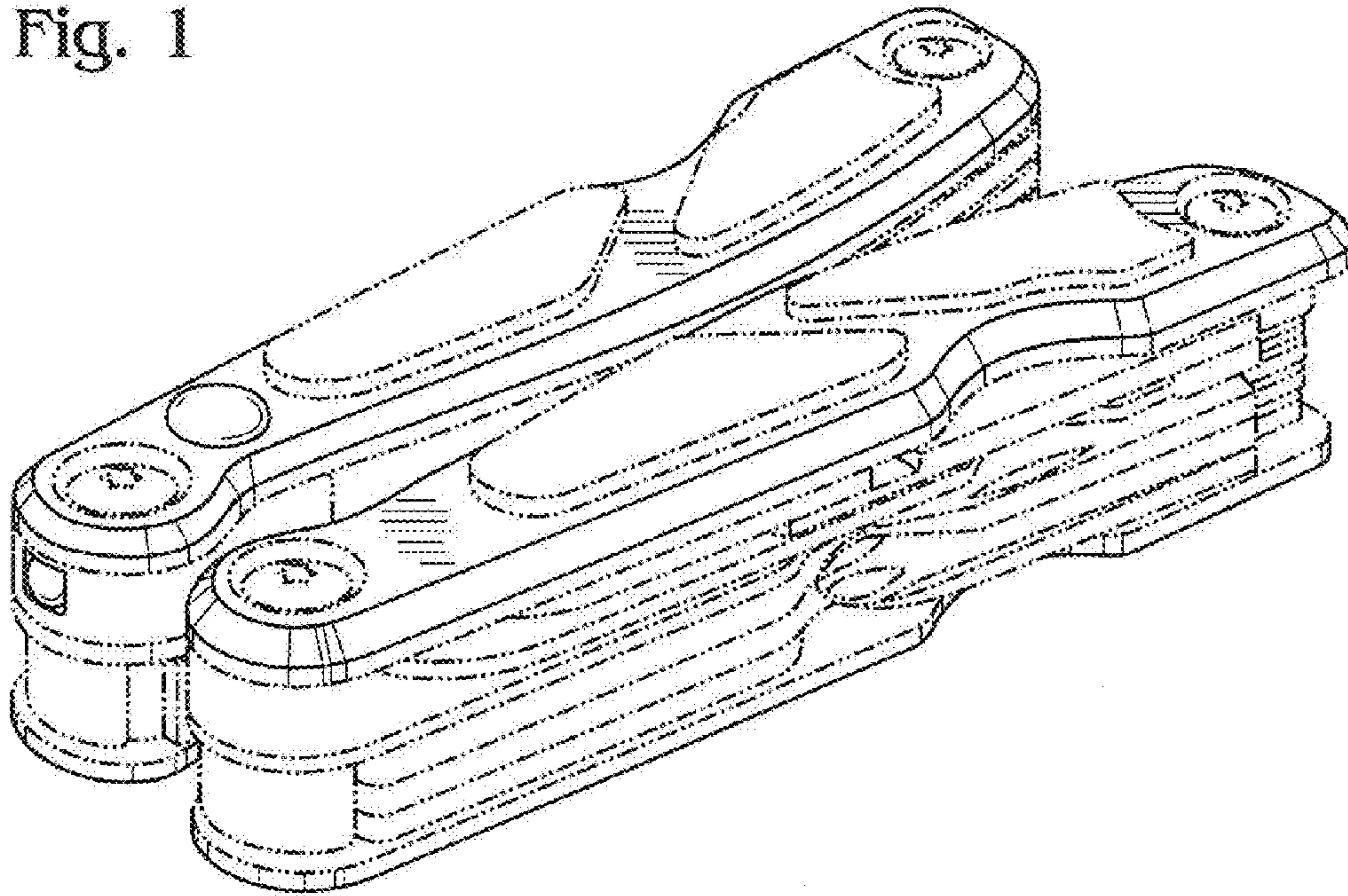

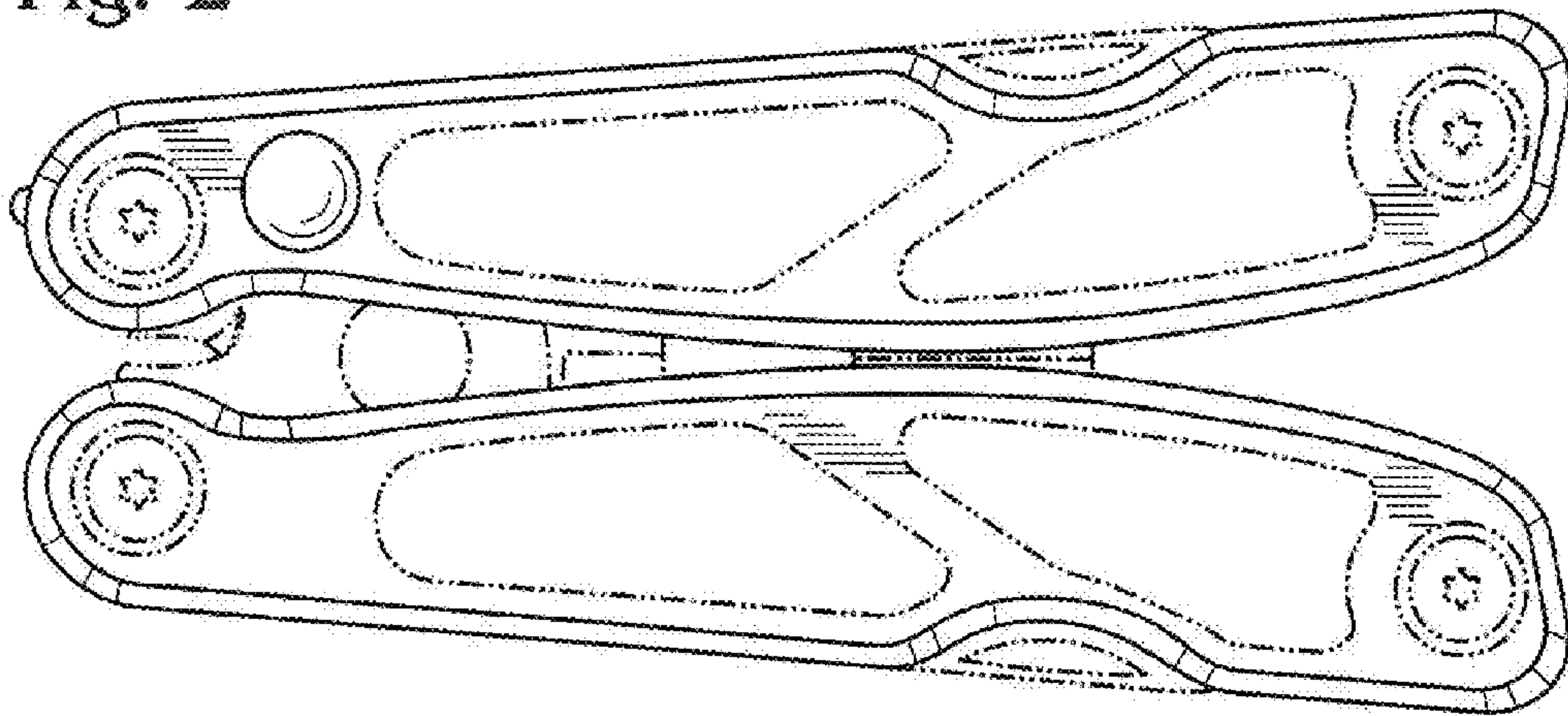

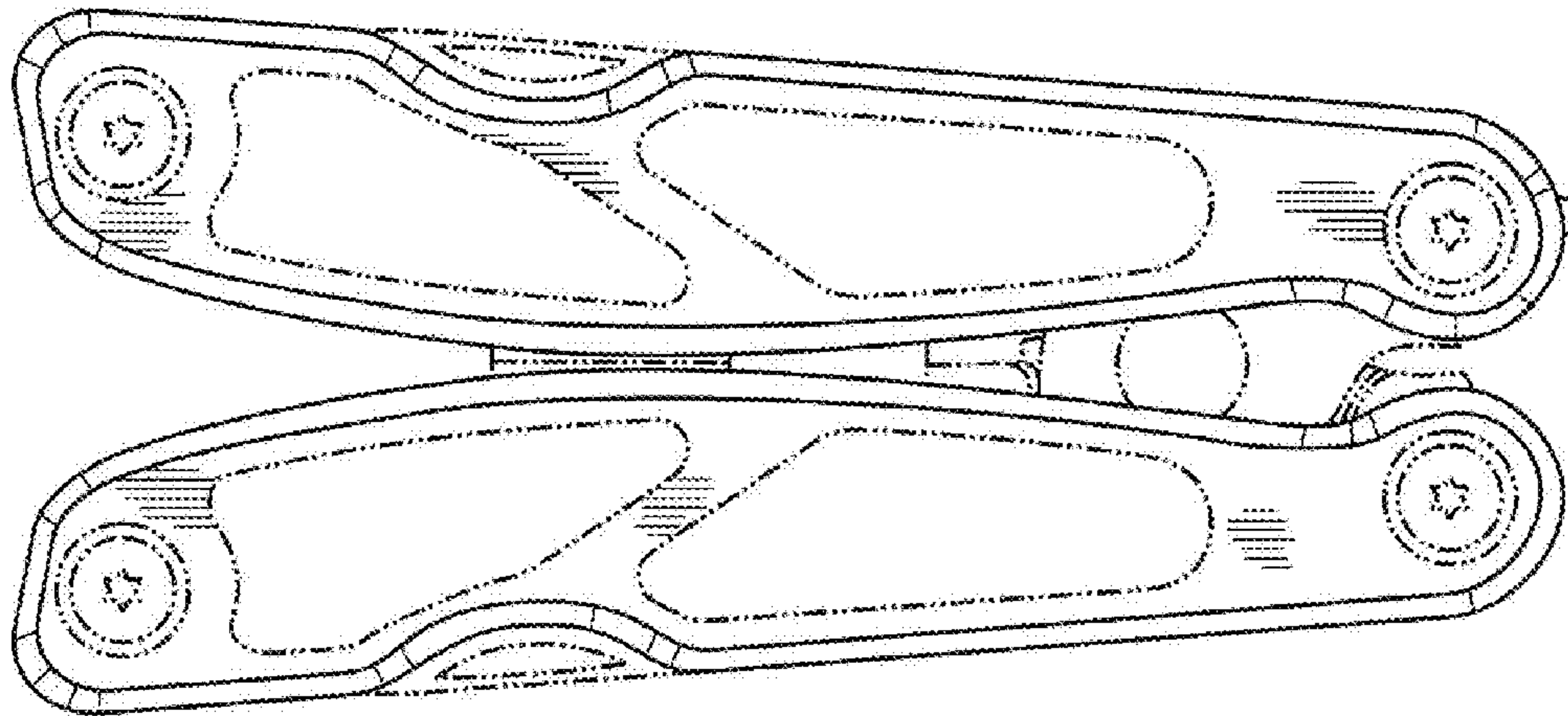

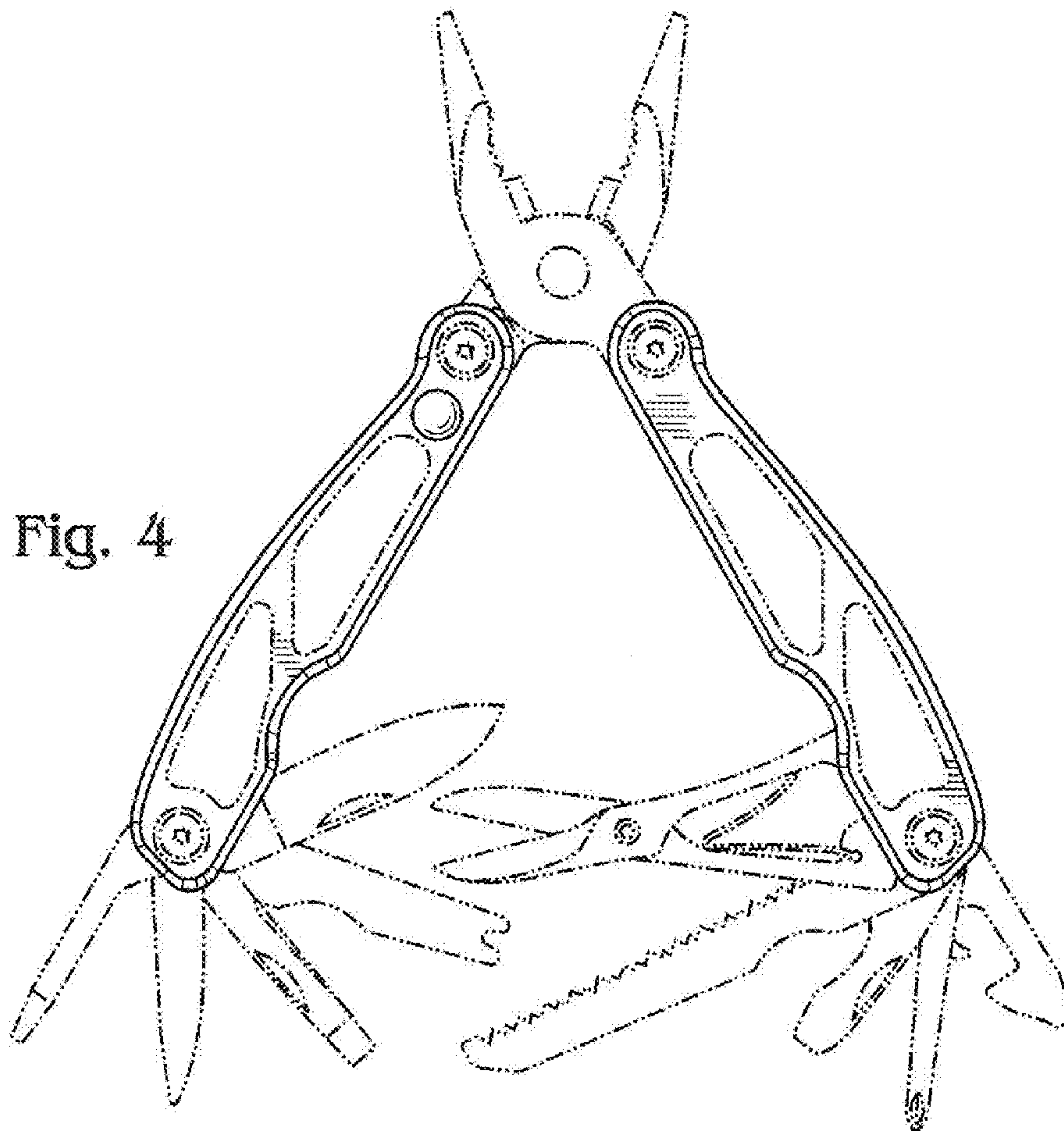

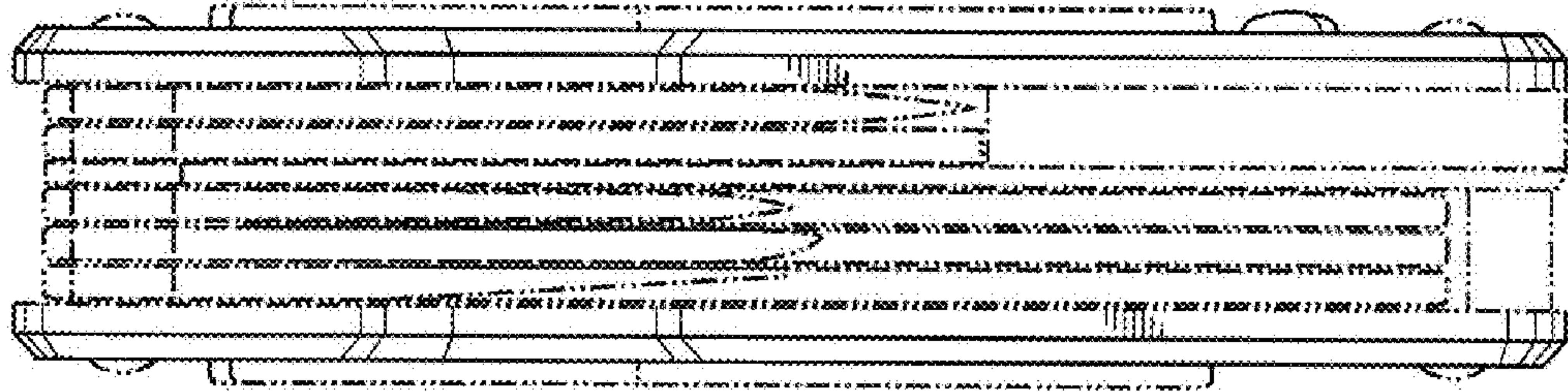

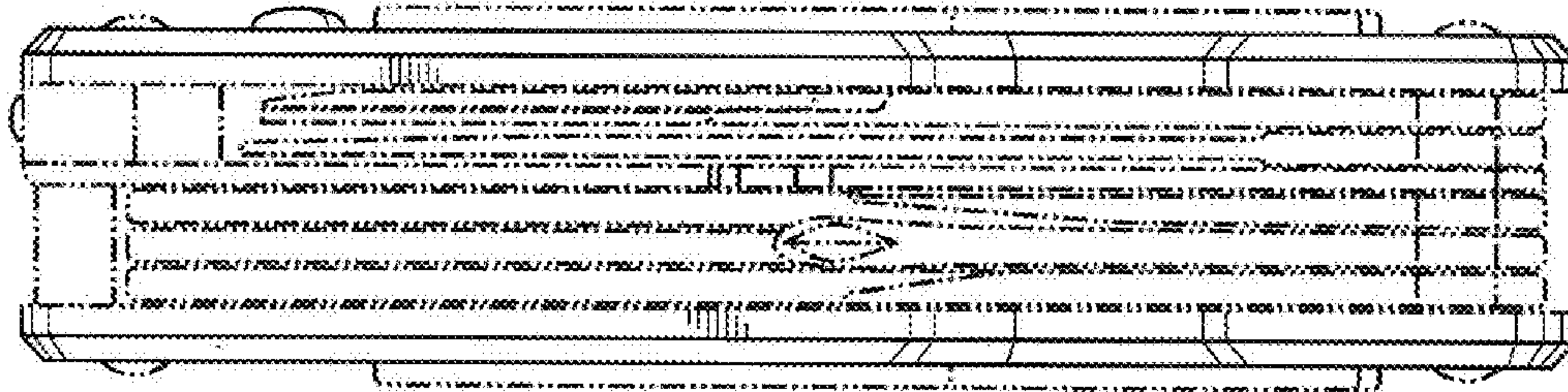

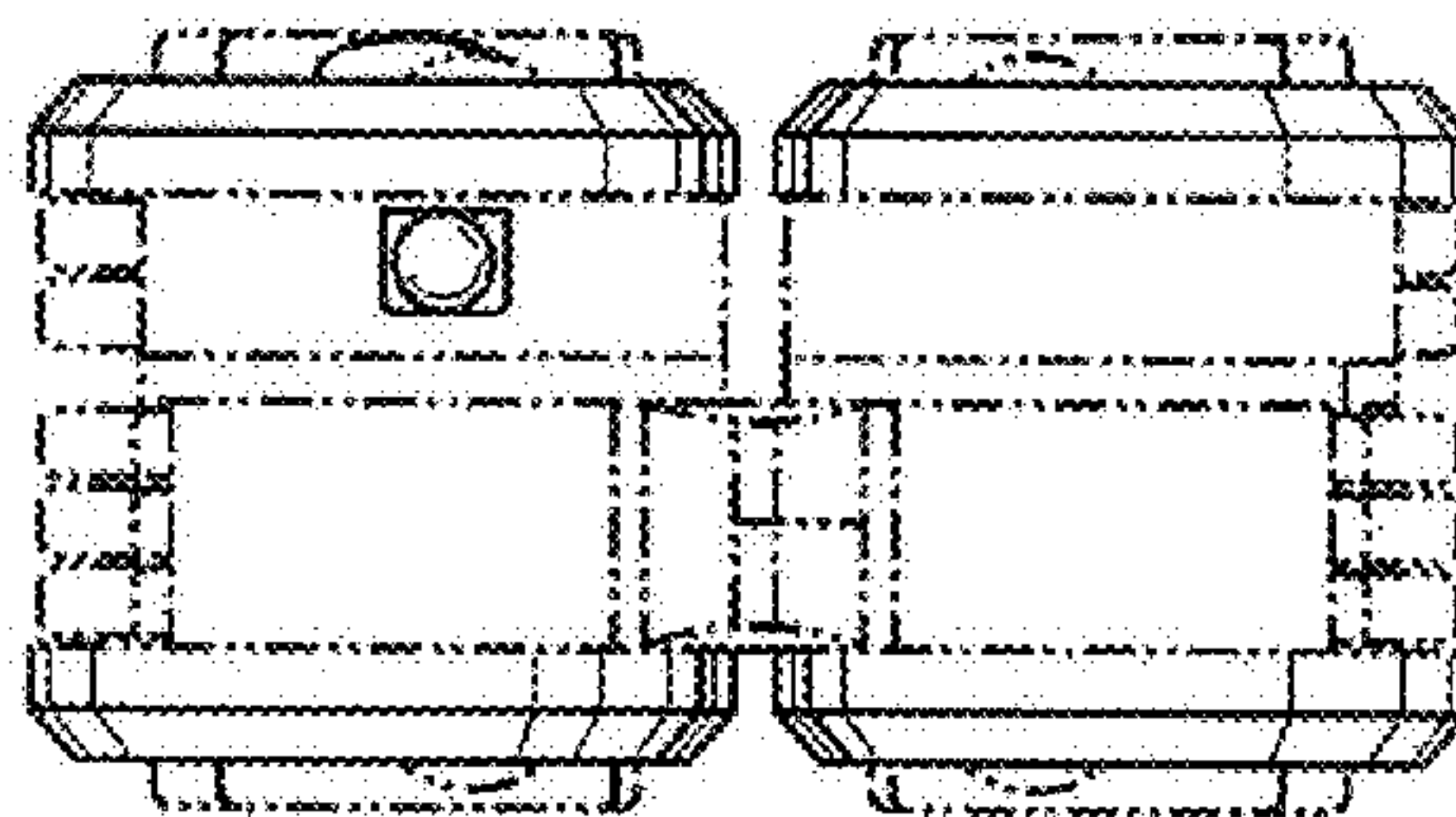
