The ornamental design for a reclosable package, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a reclosable package showing our new design;

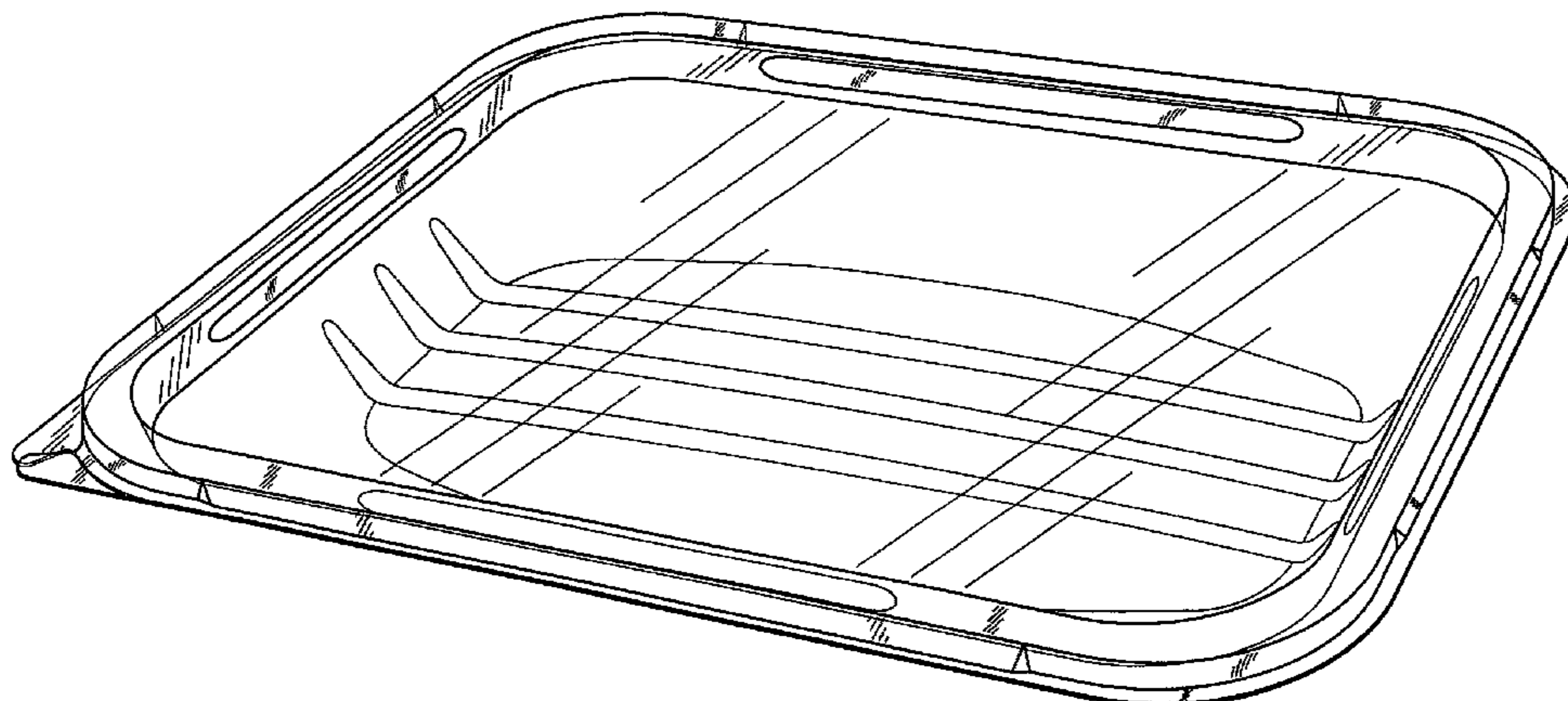
FIG. 2 is a front elevation view thereof, the rear being a mirror image;

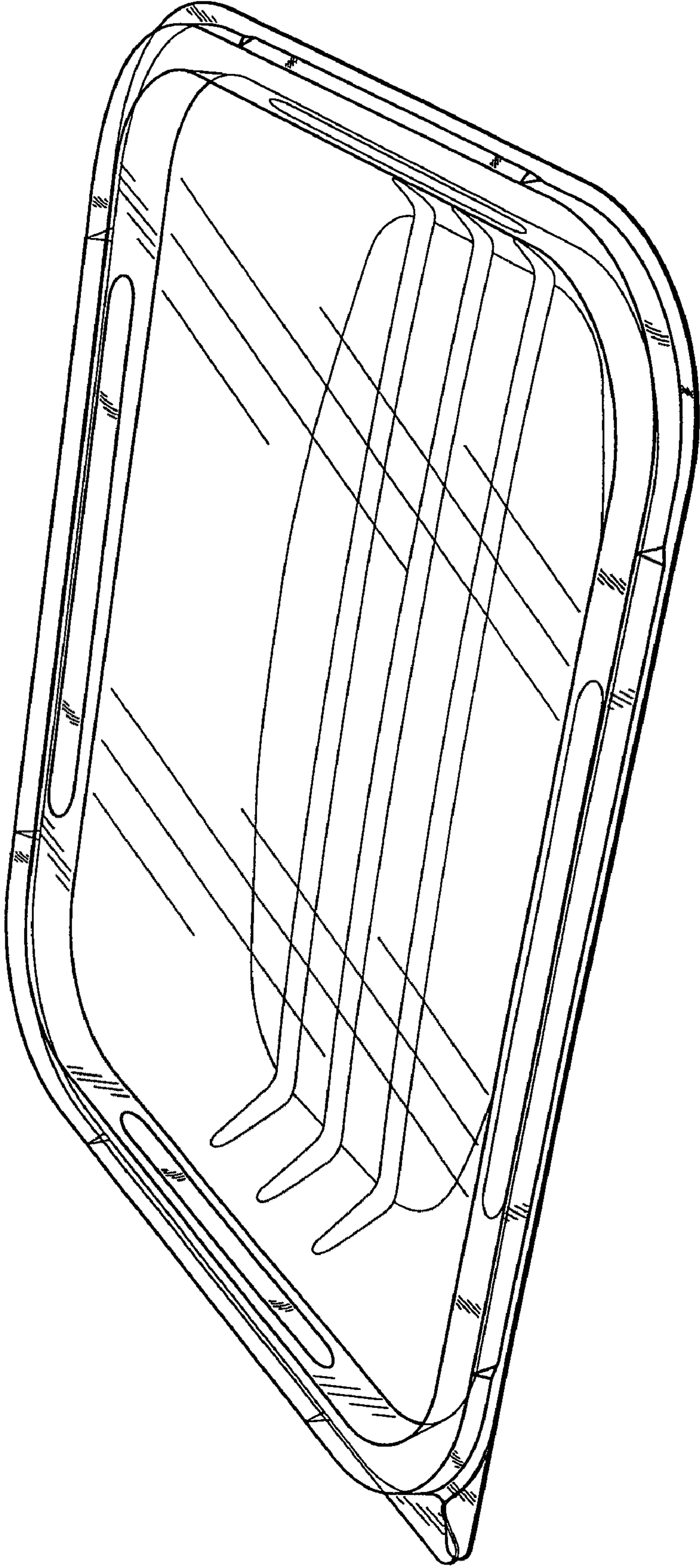

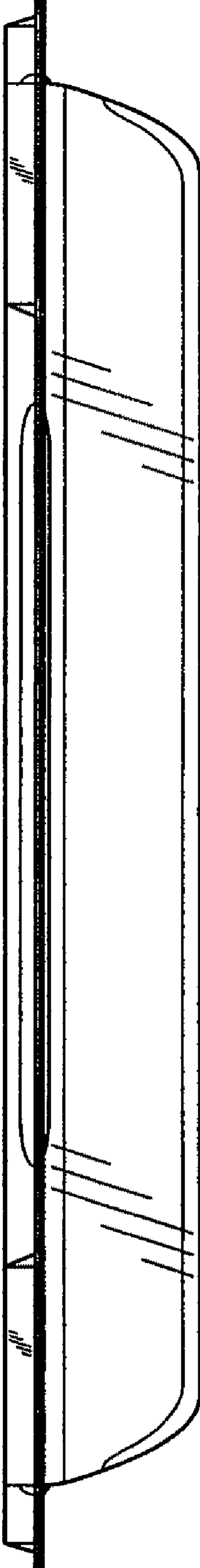

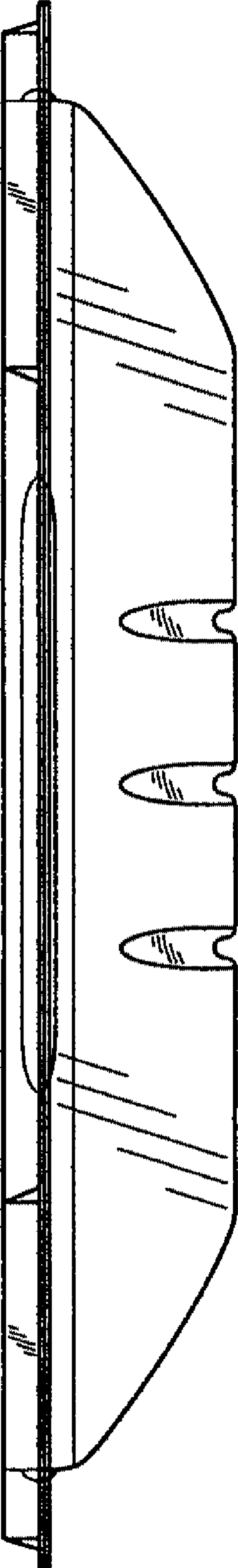

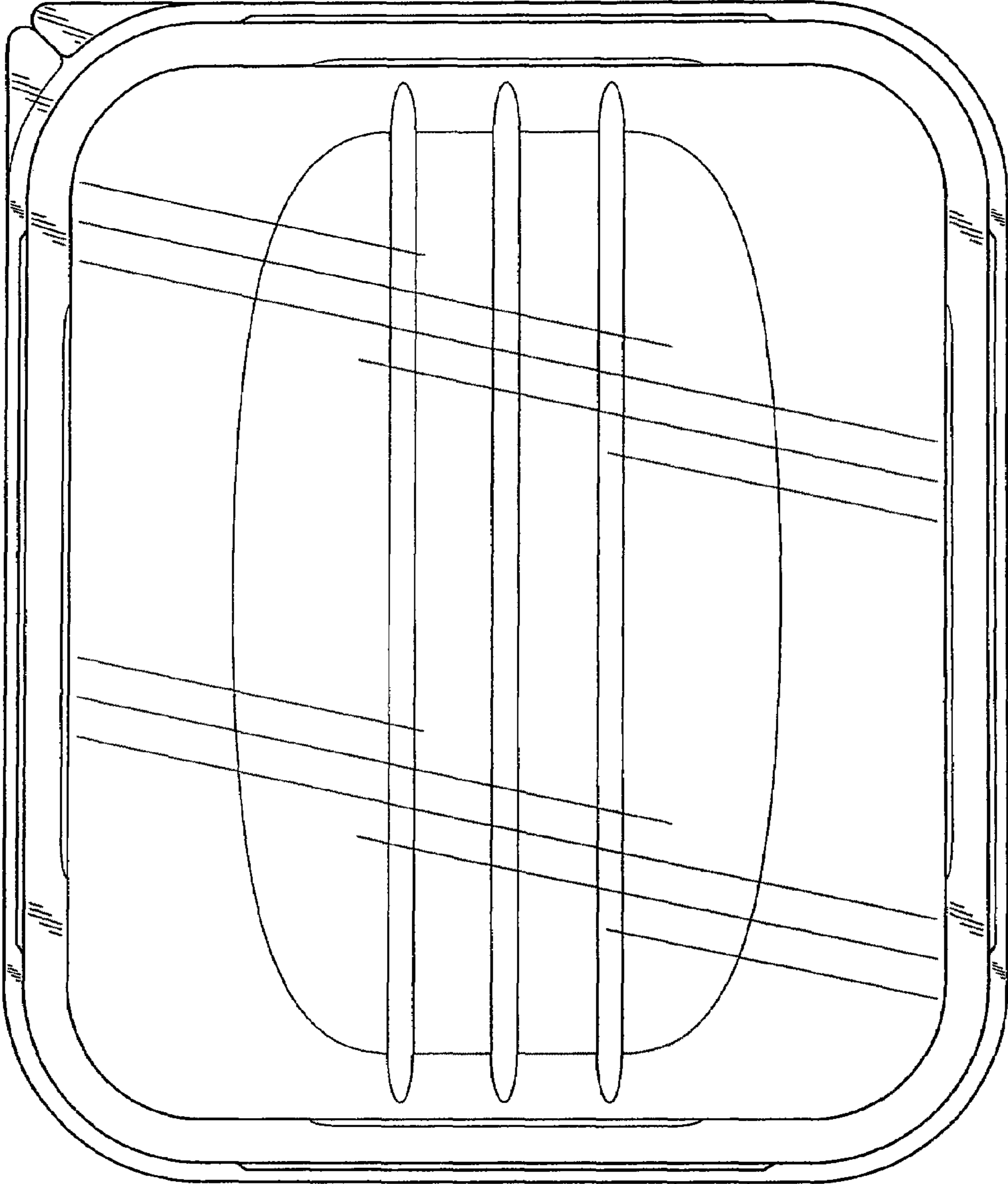

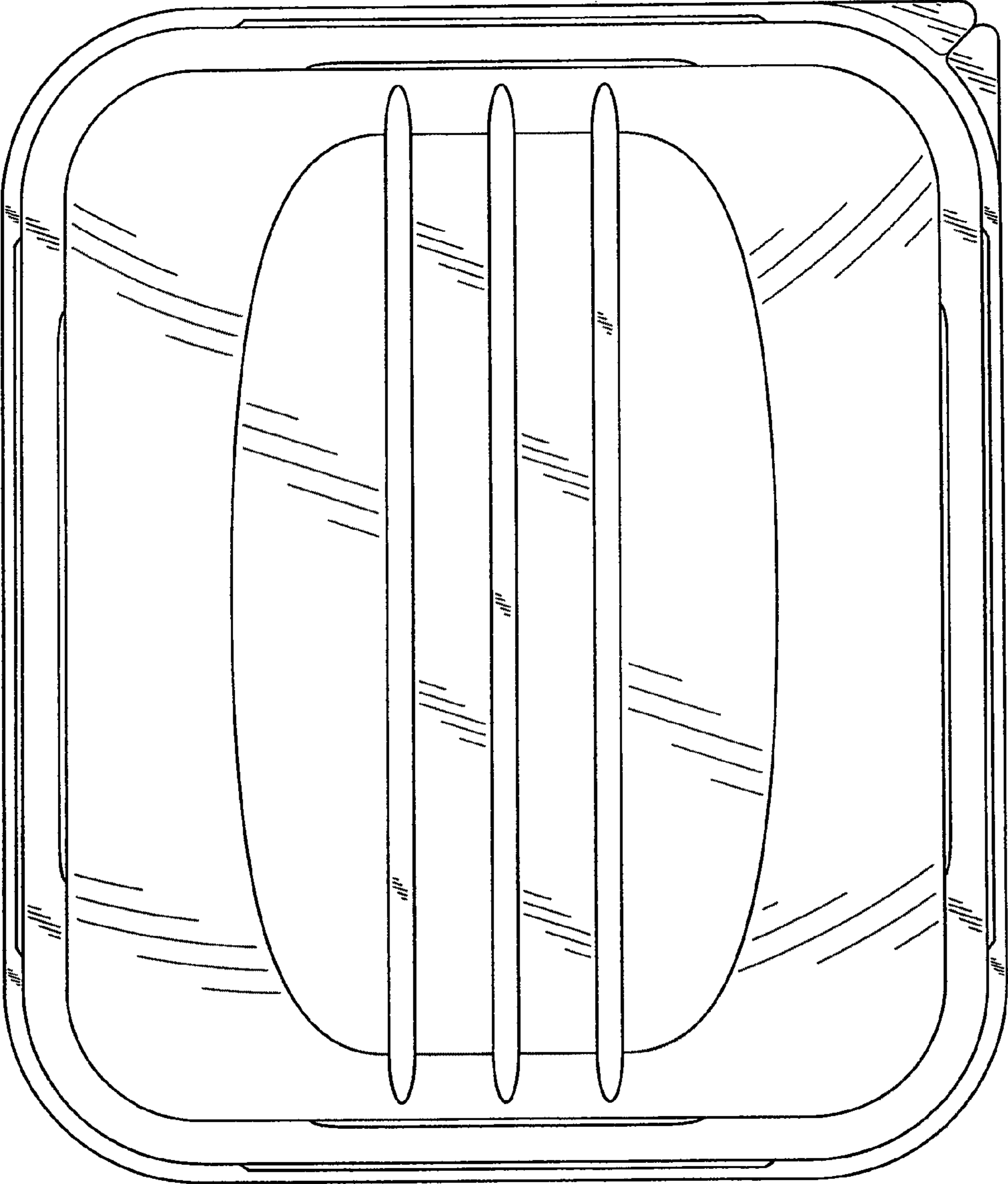
