FIG. 2 is a left view thereof;

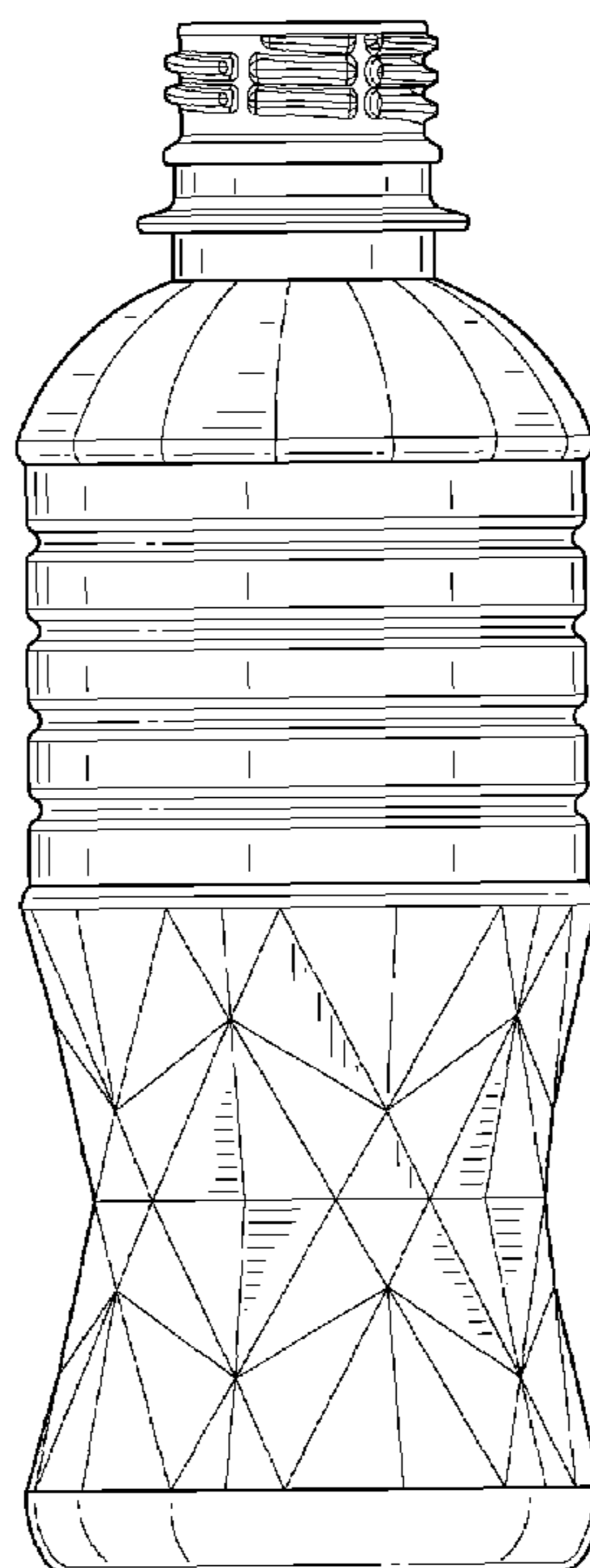
FIG. 3 is an isometric view thereof;

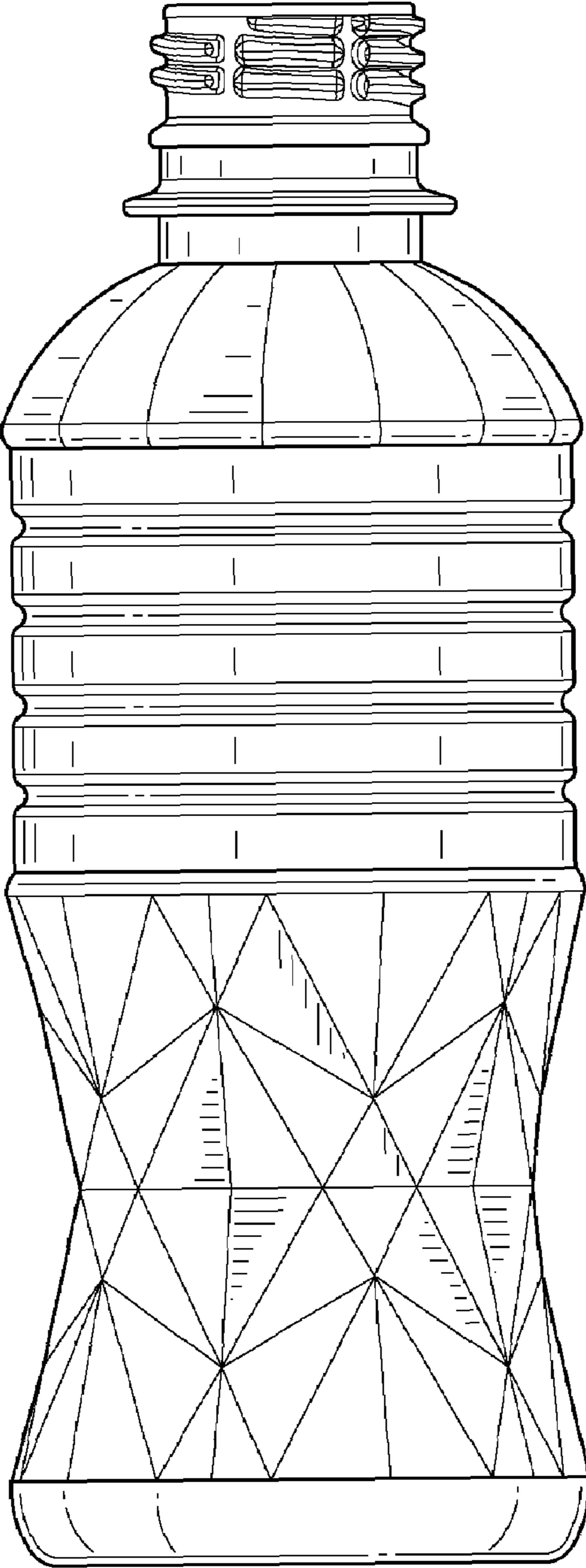

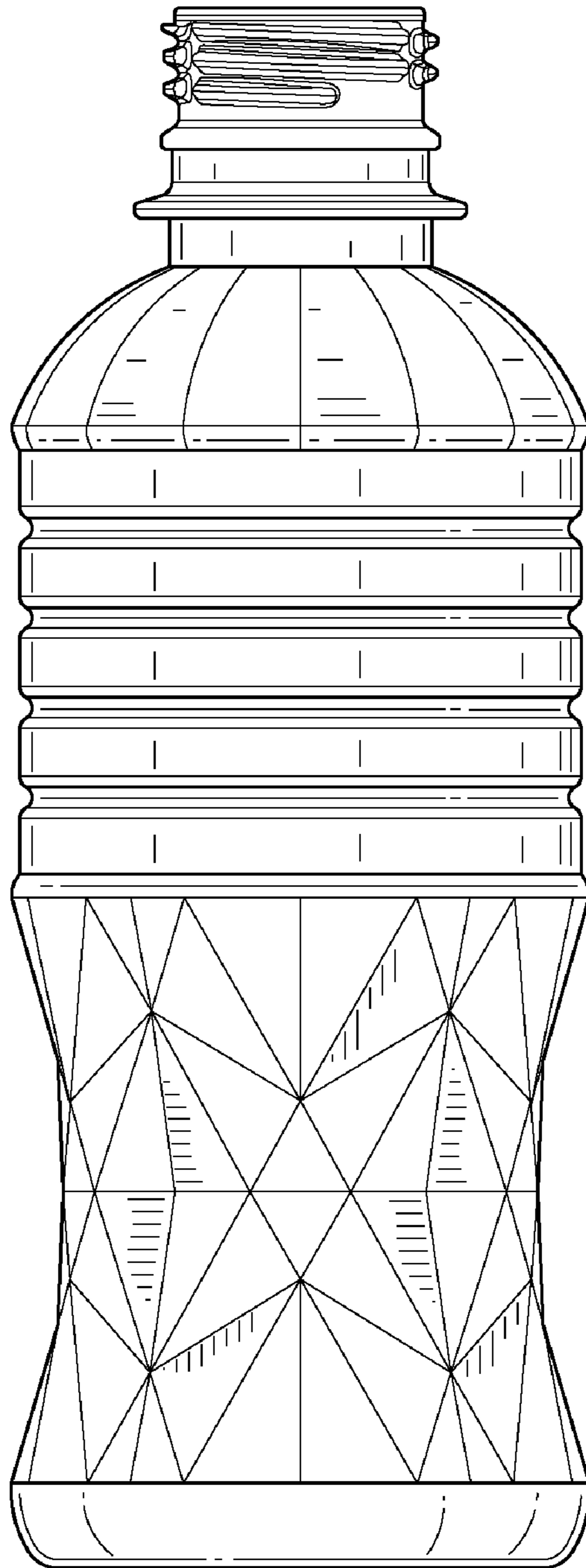

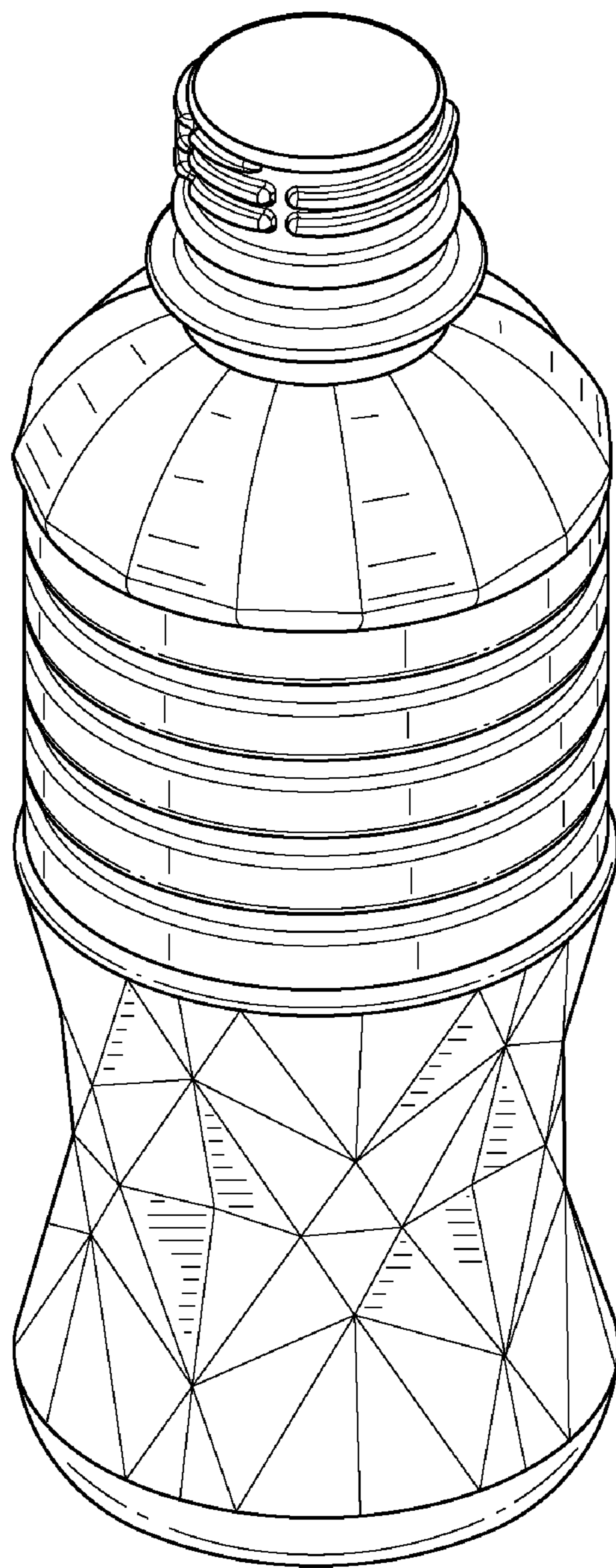

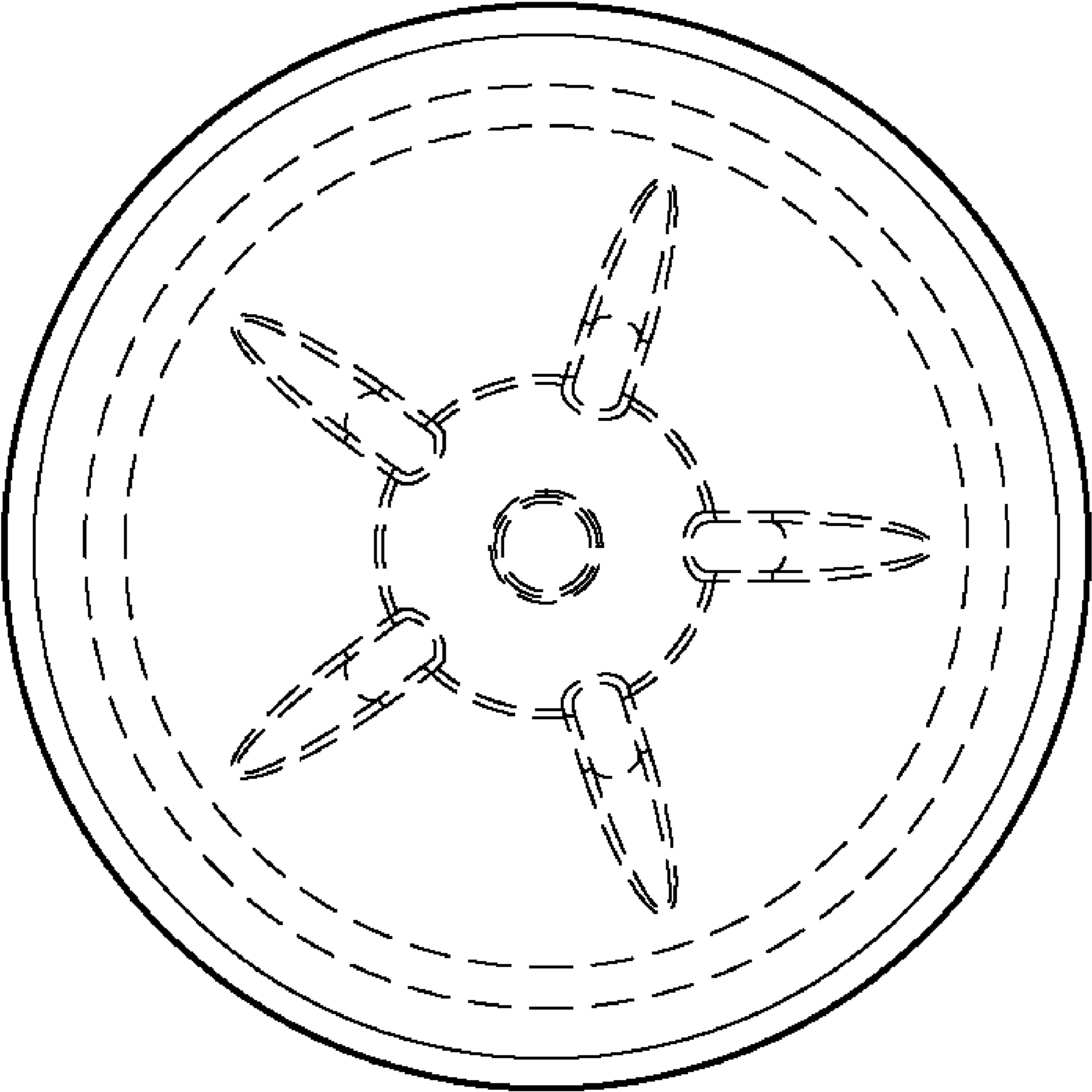

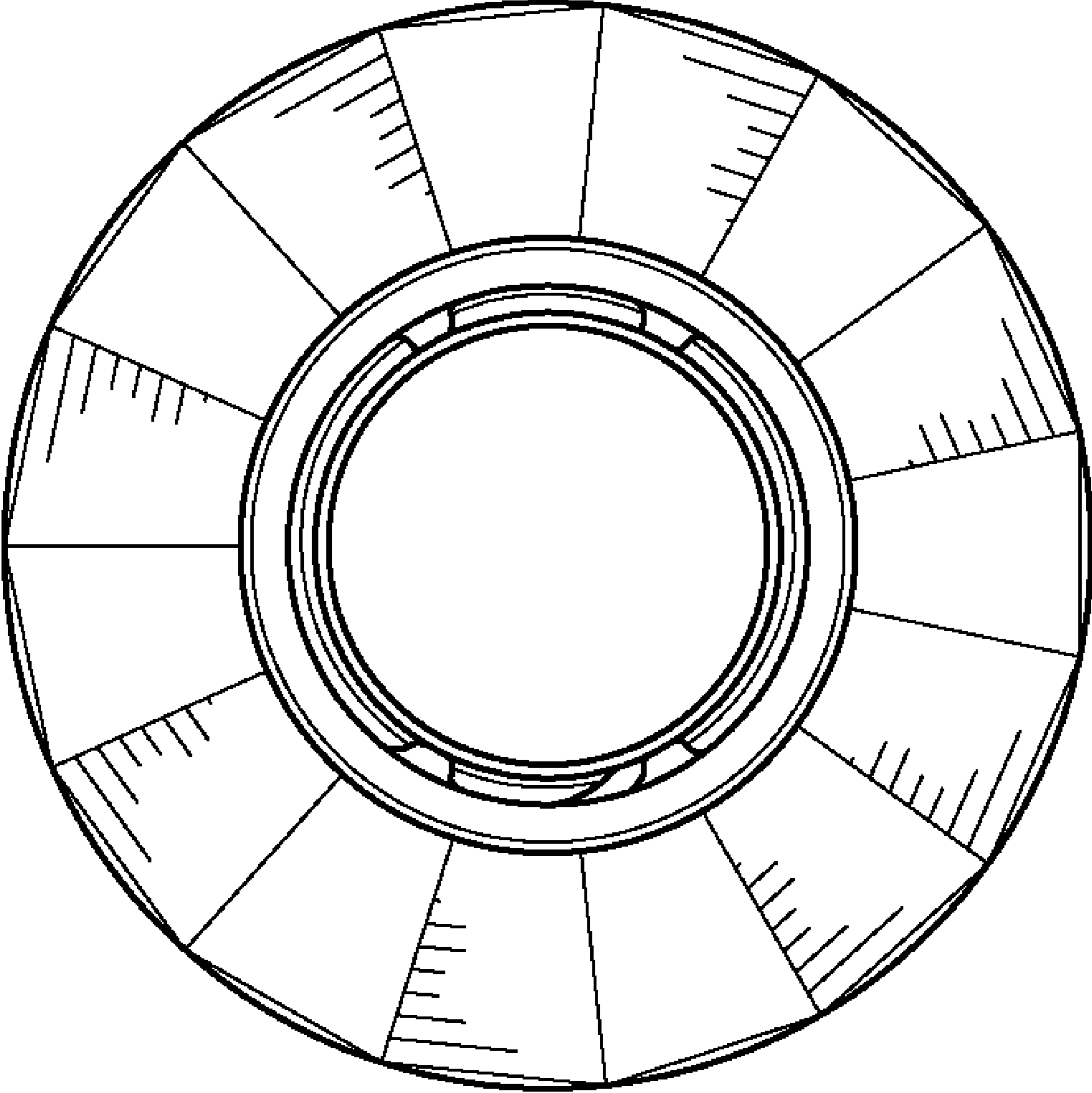
