FIG. 1 is an isometric view of a bottle showing my new design;

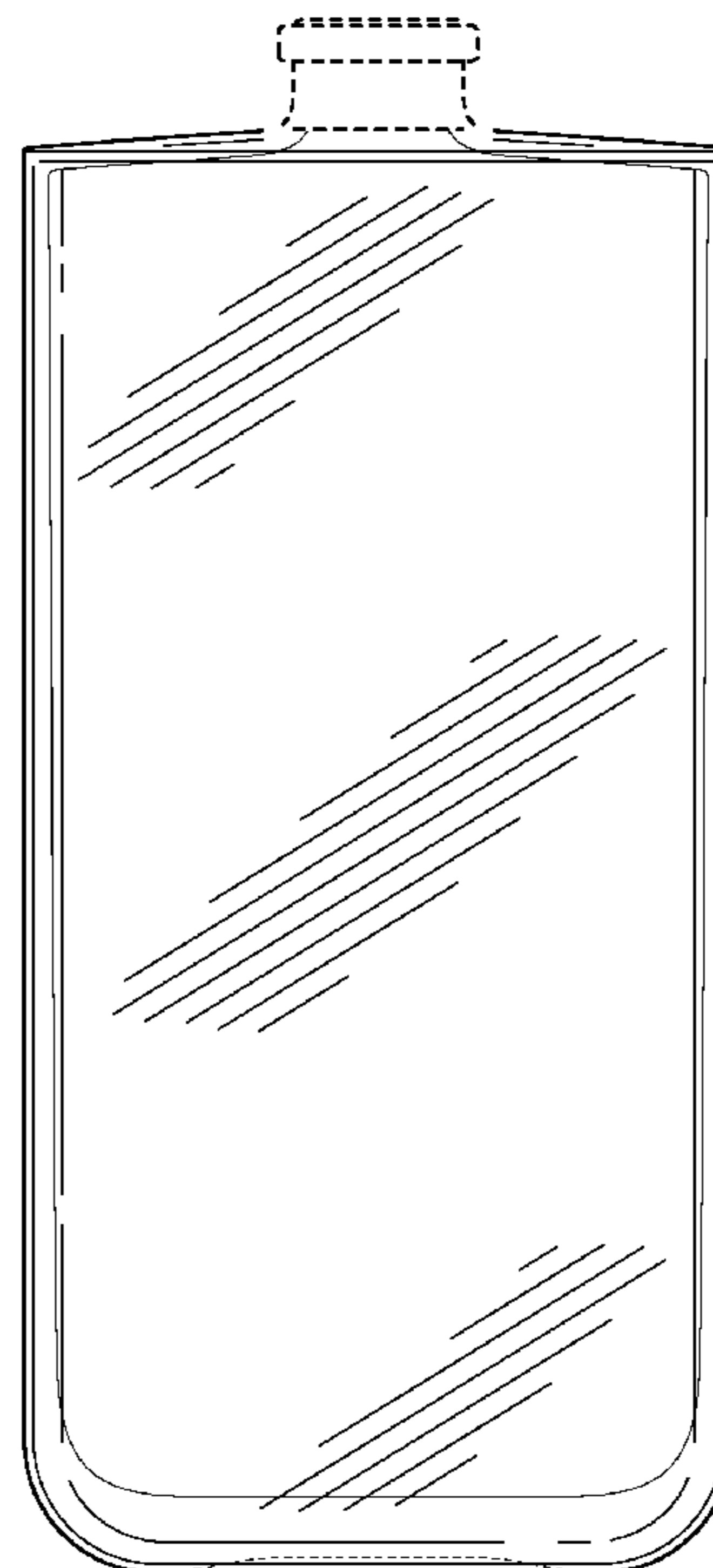
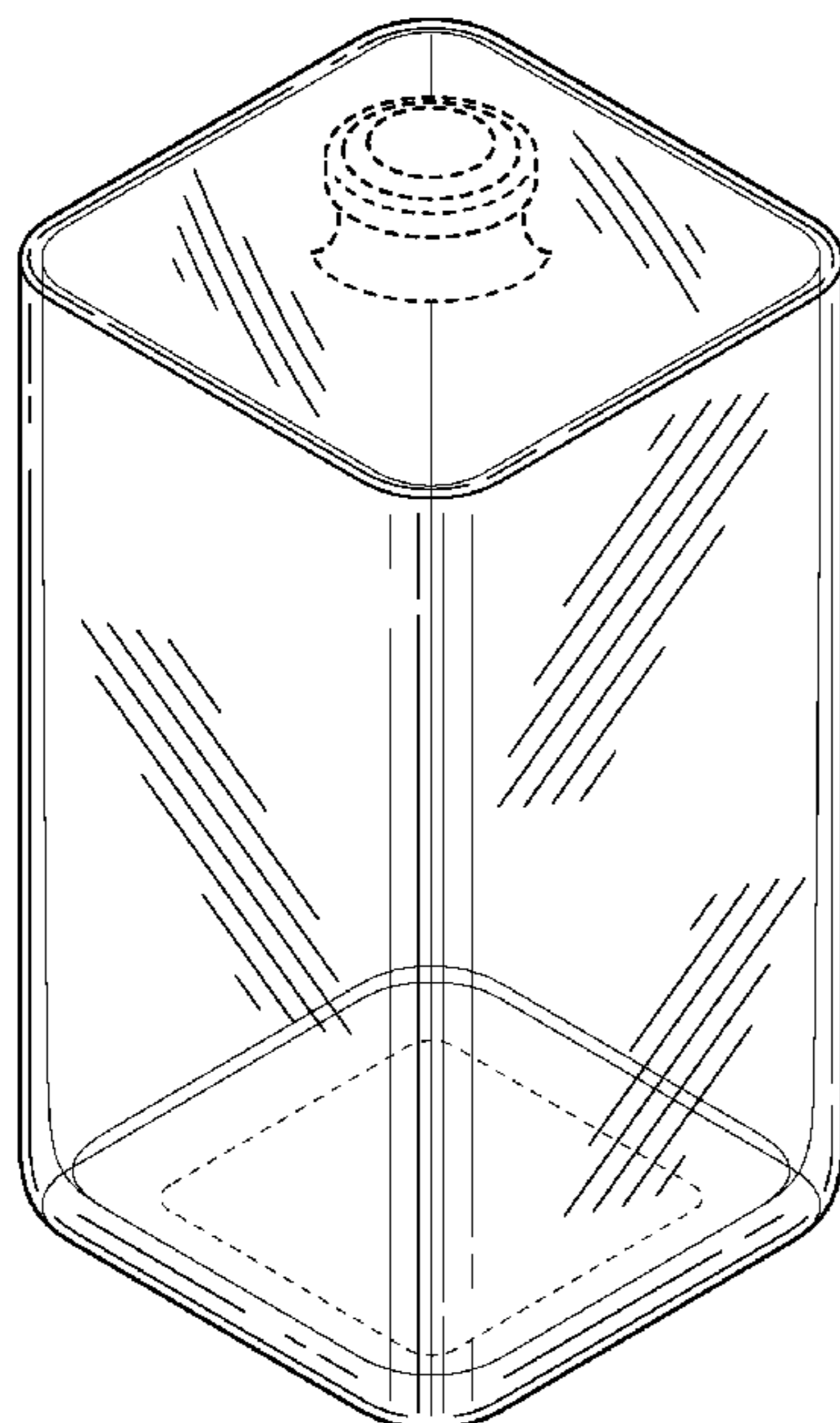
FIG. 2 is a front elevational view thereof, the rear, right and left elevational views being the same;

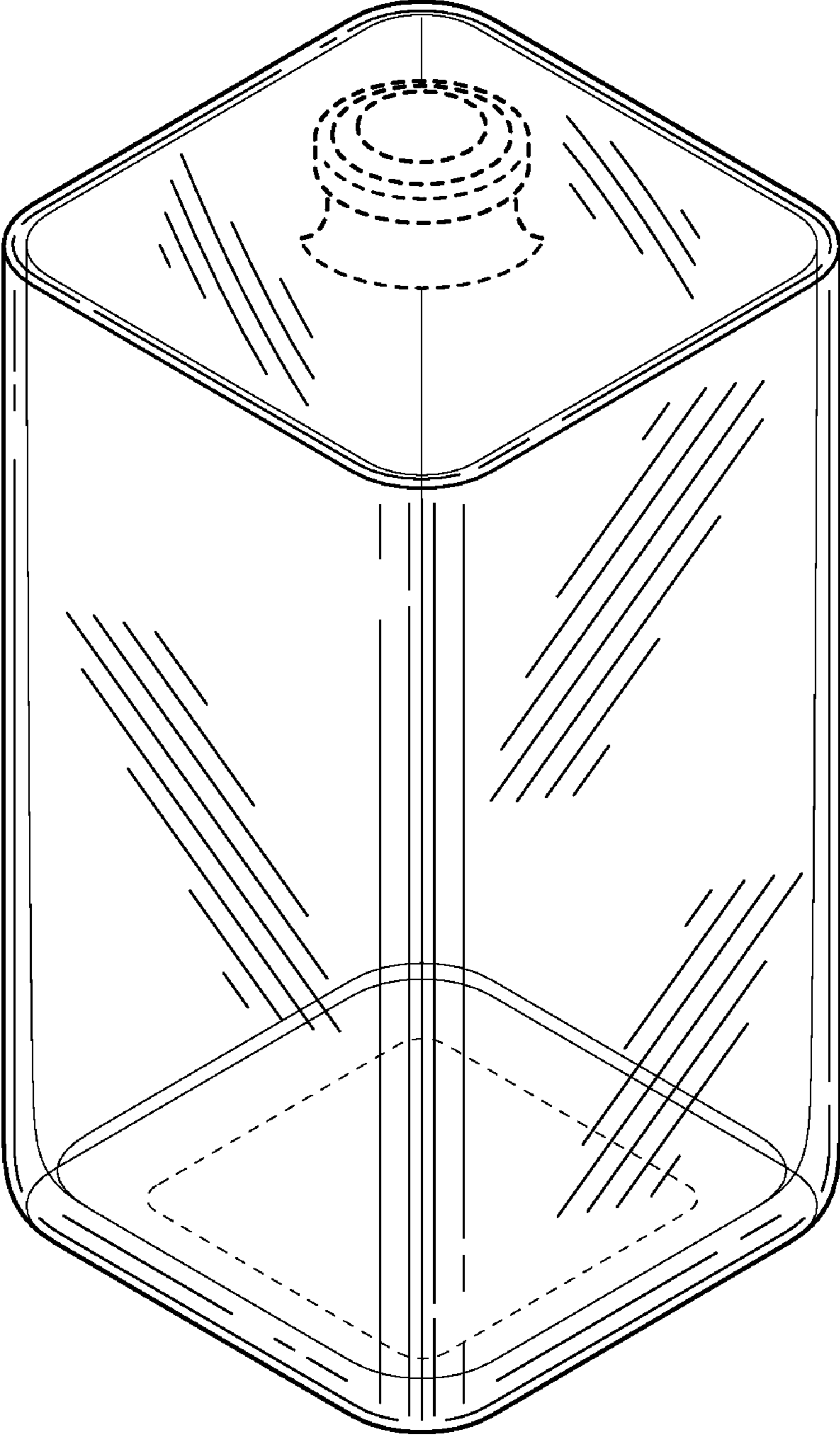

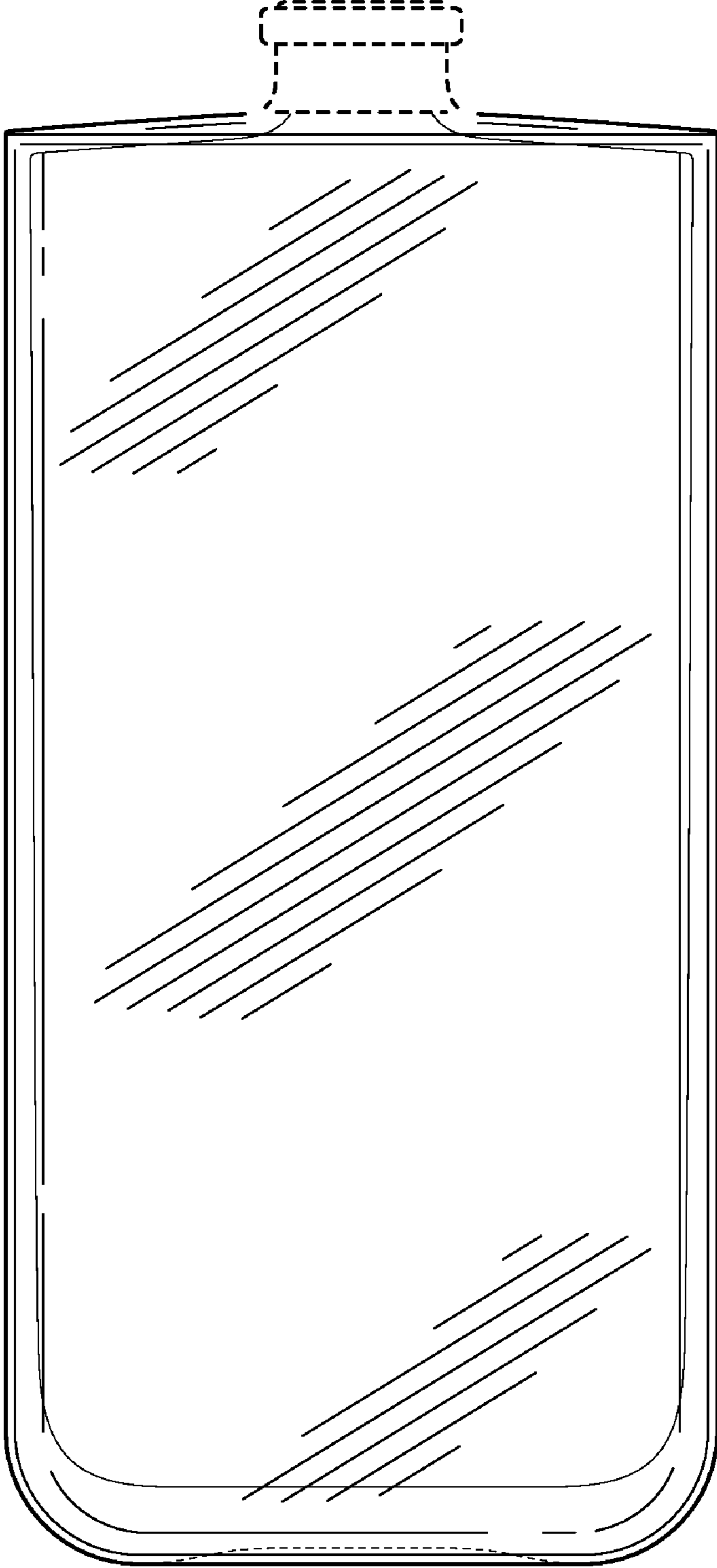

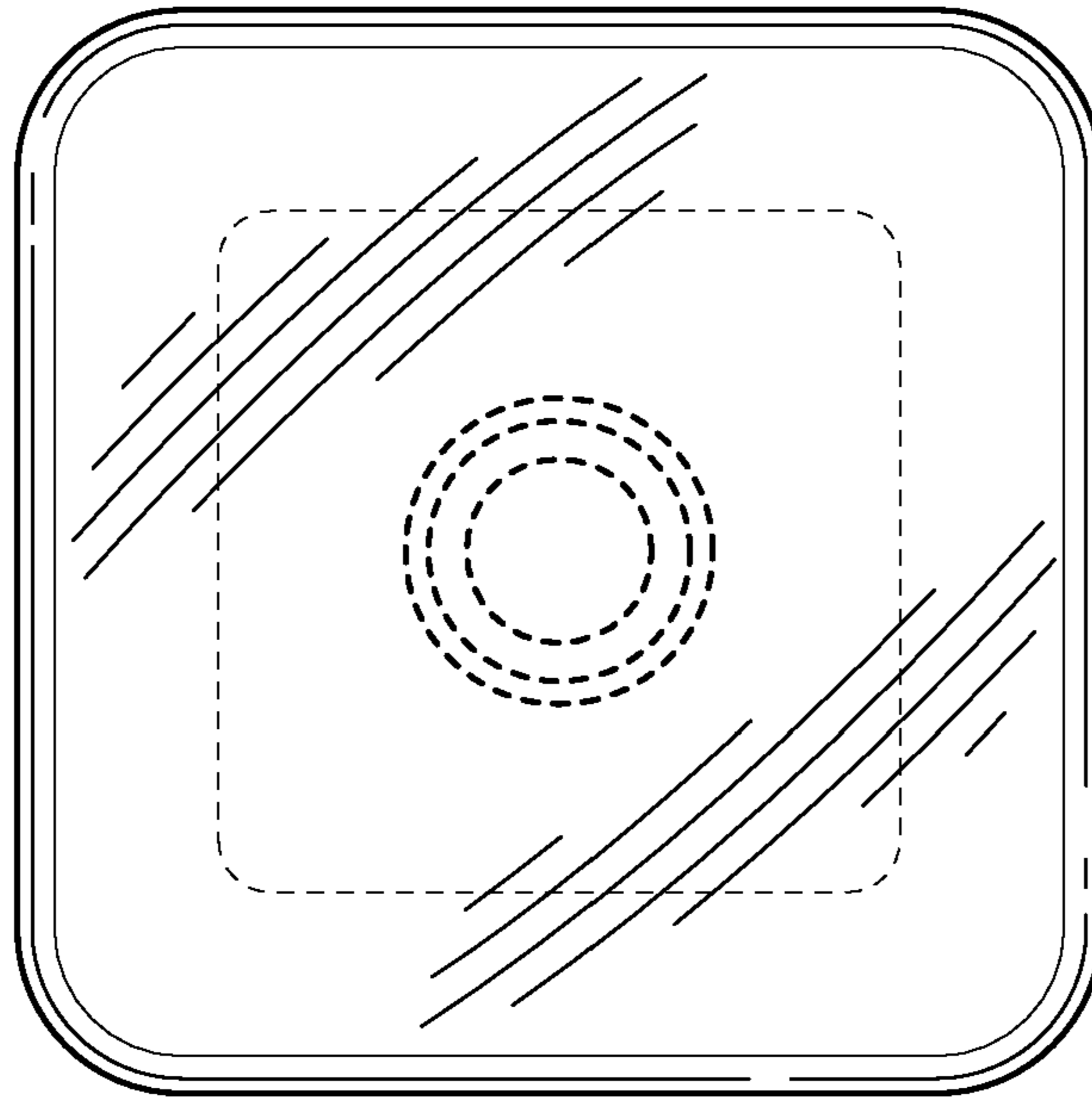

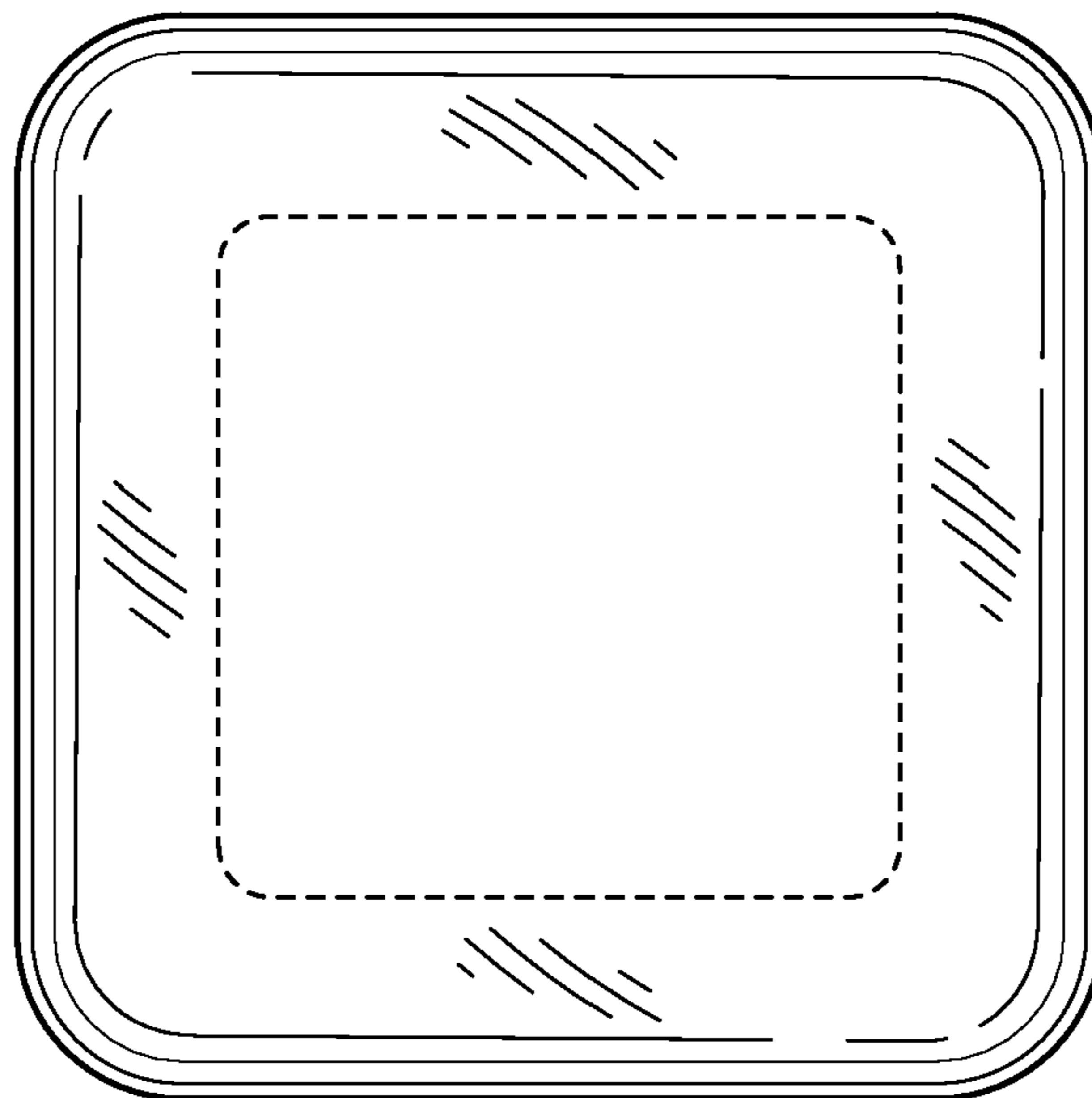
