FIG. 4 is a rear elevation view of the design illustrated in FIG. 1;

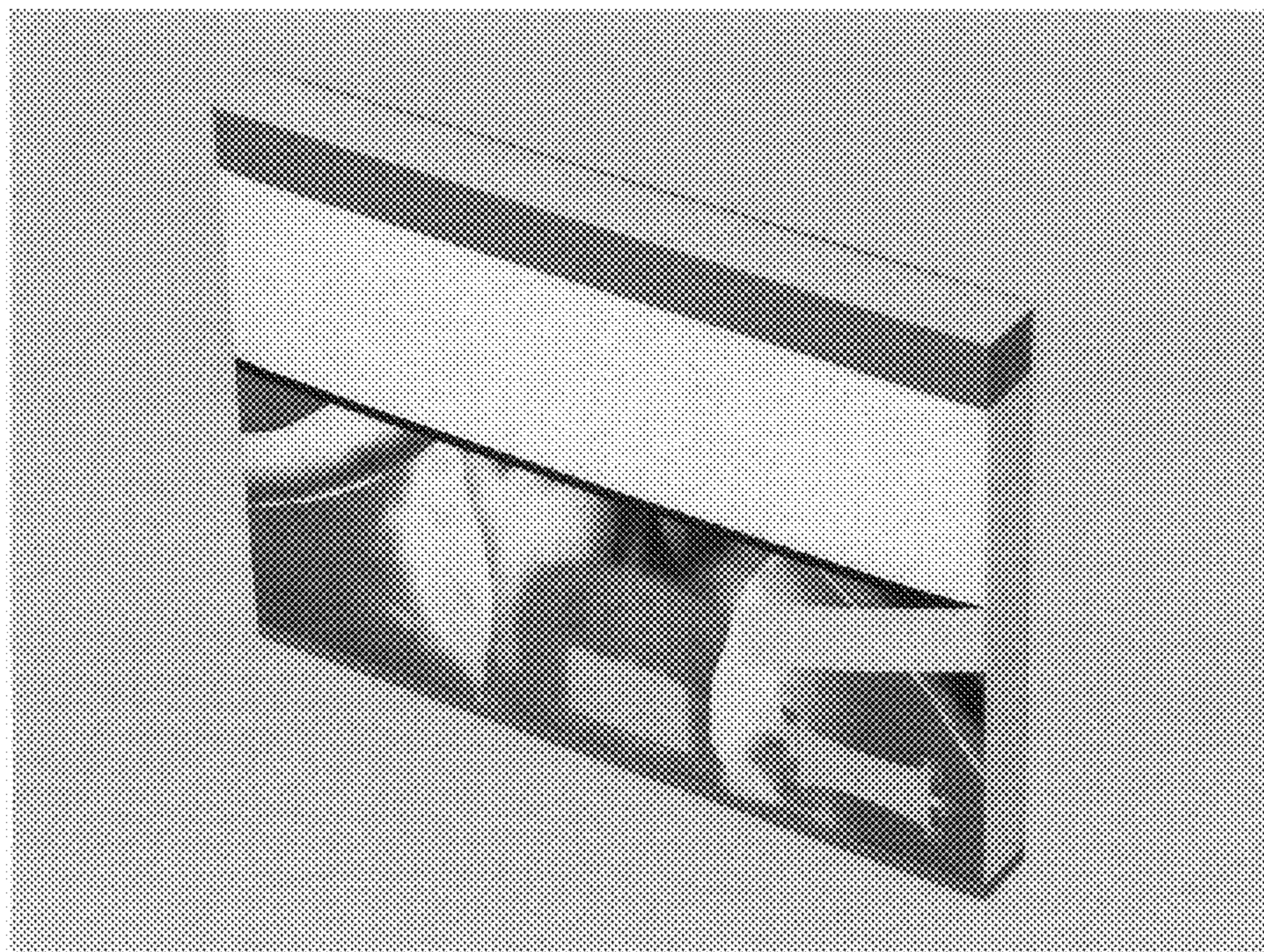
FIG. 5 is a top plan view of the design illustrated in FIG. 1;

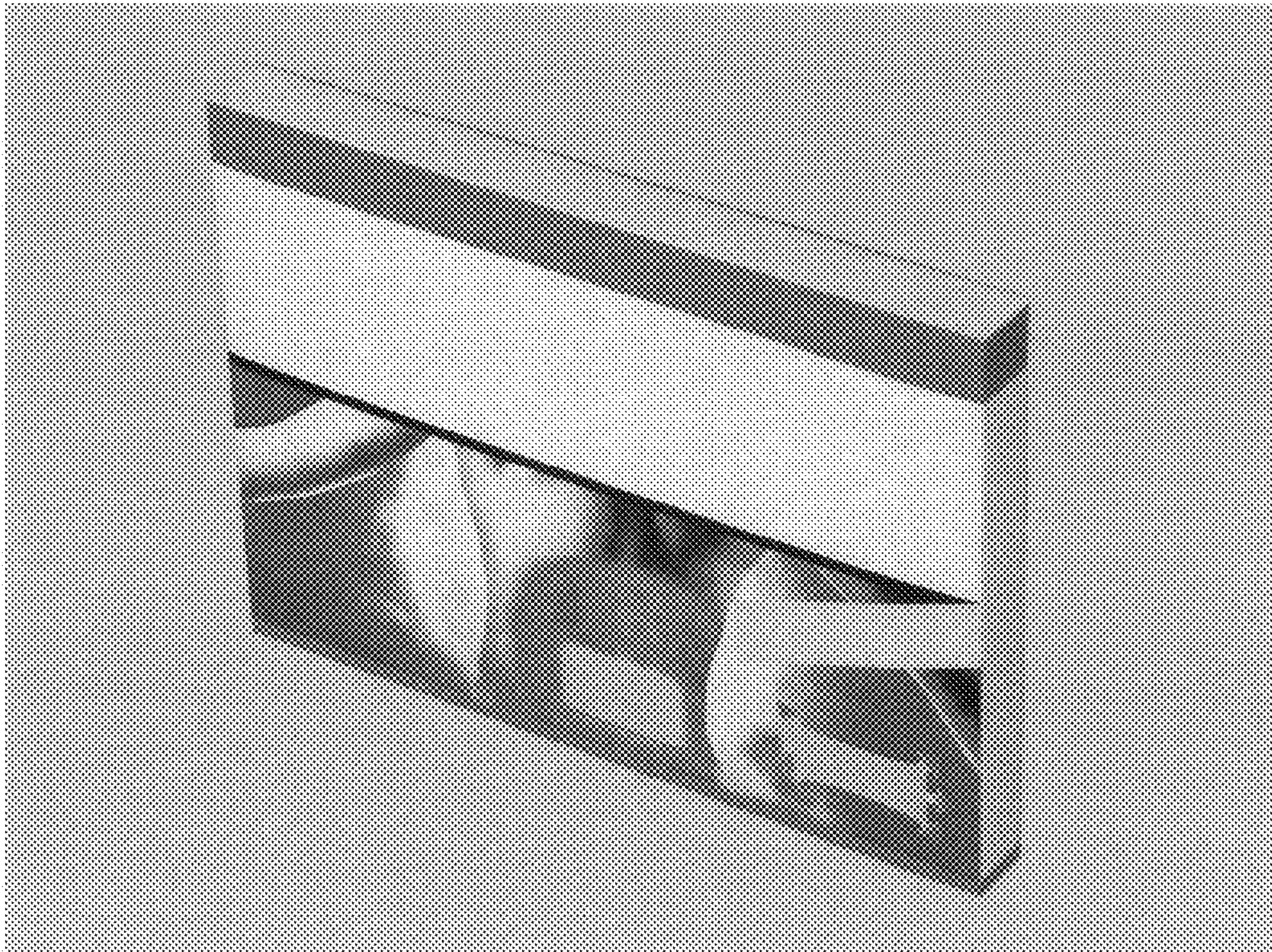

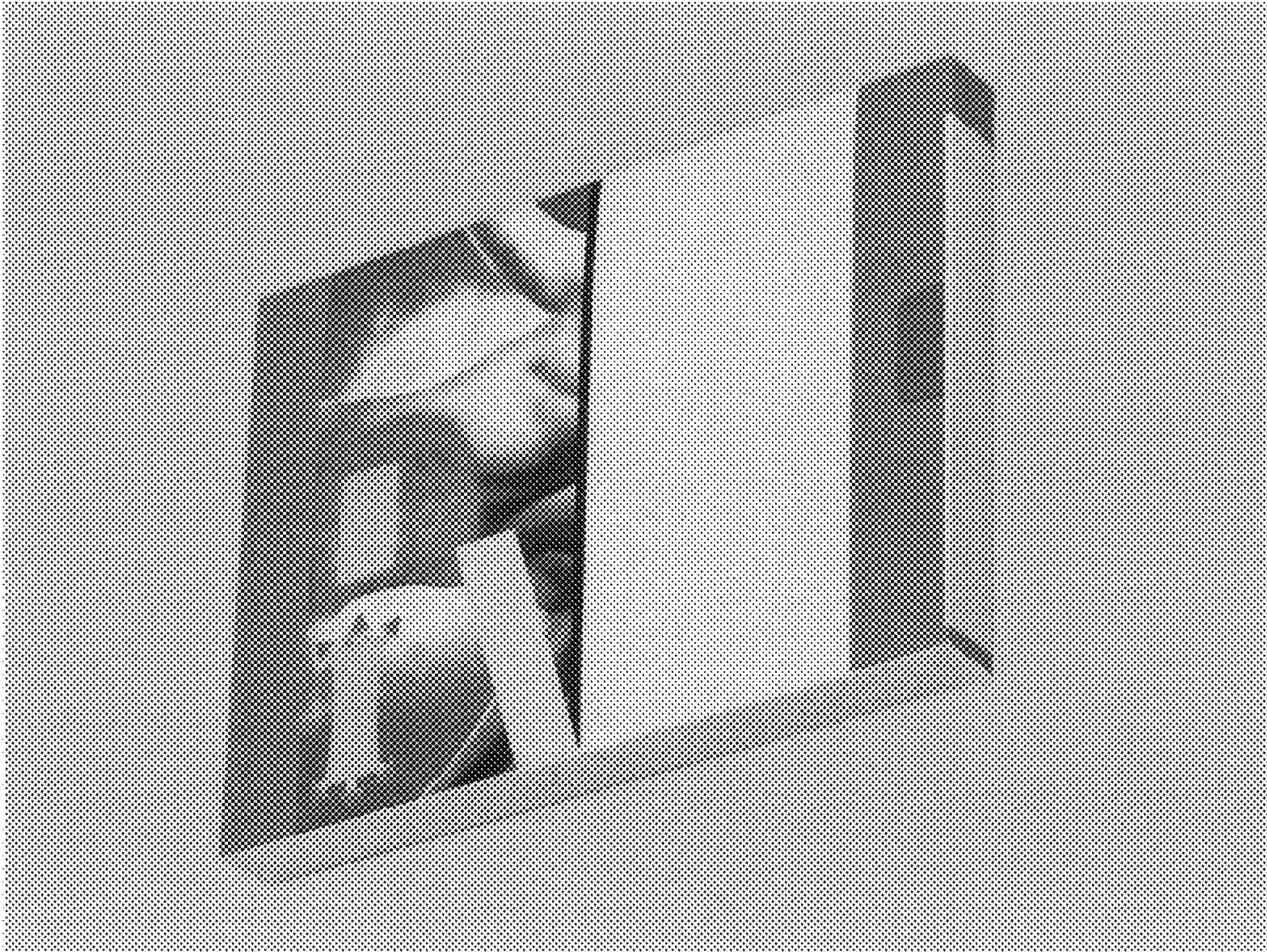

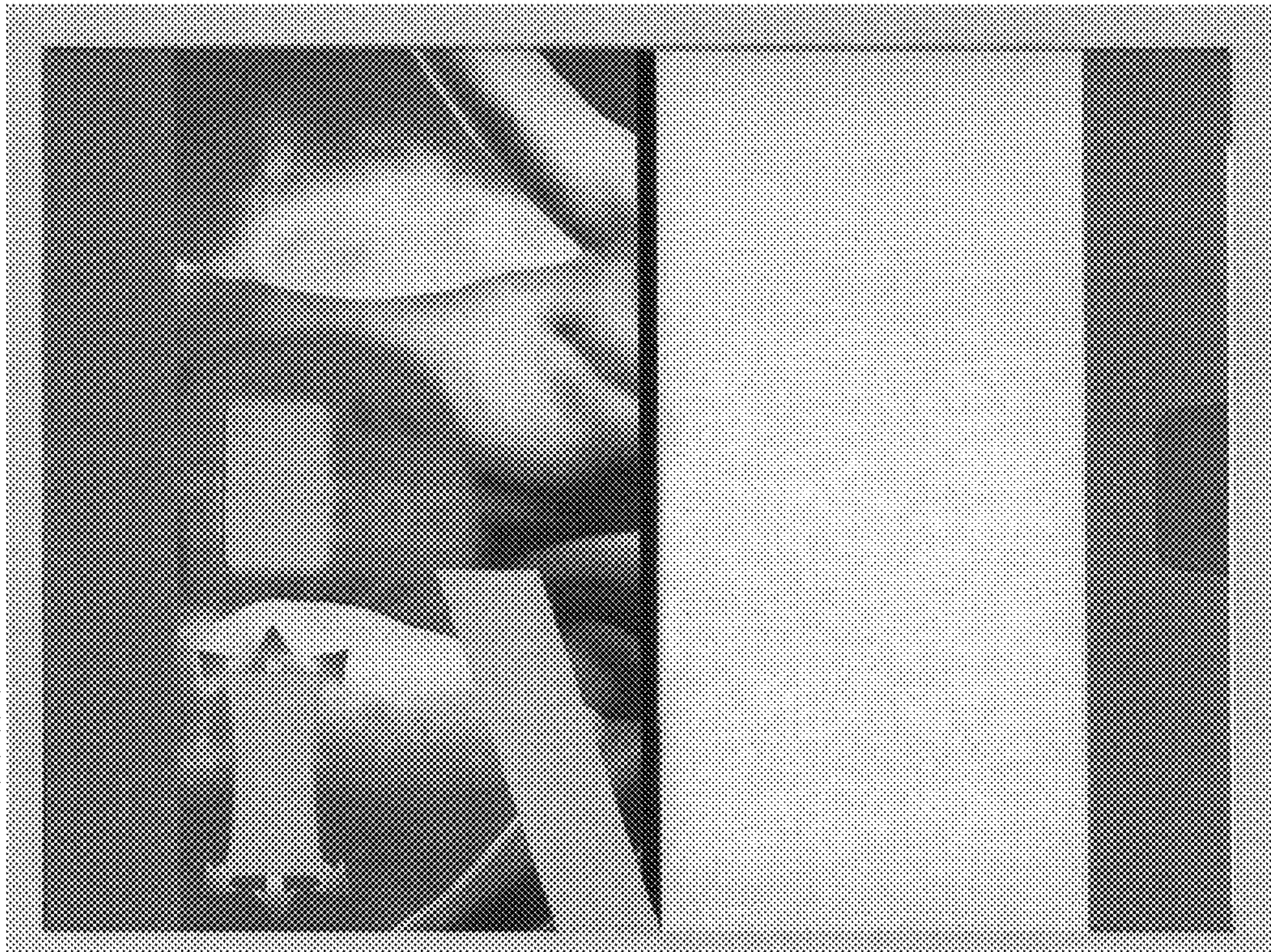

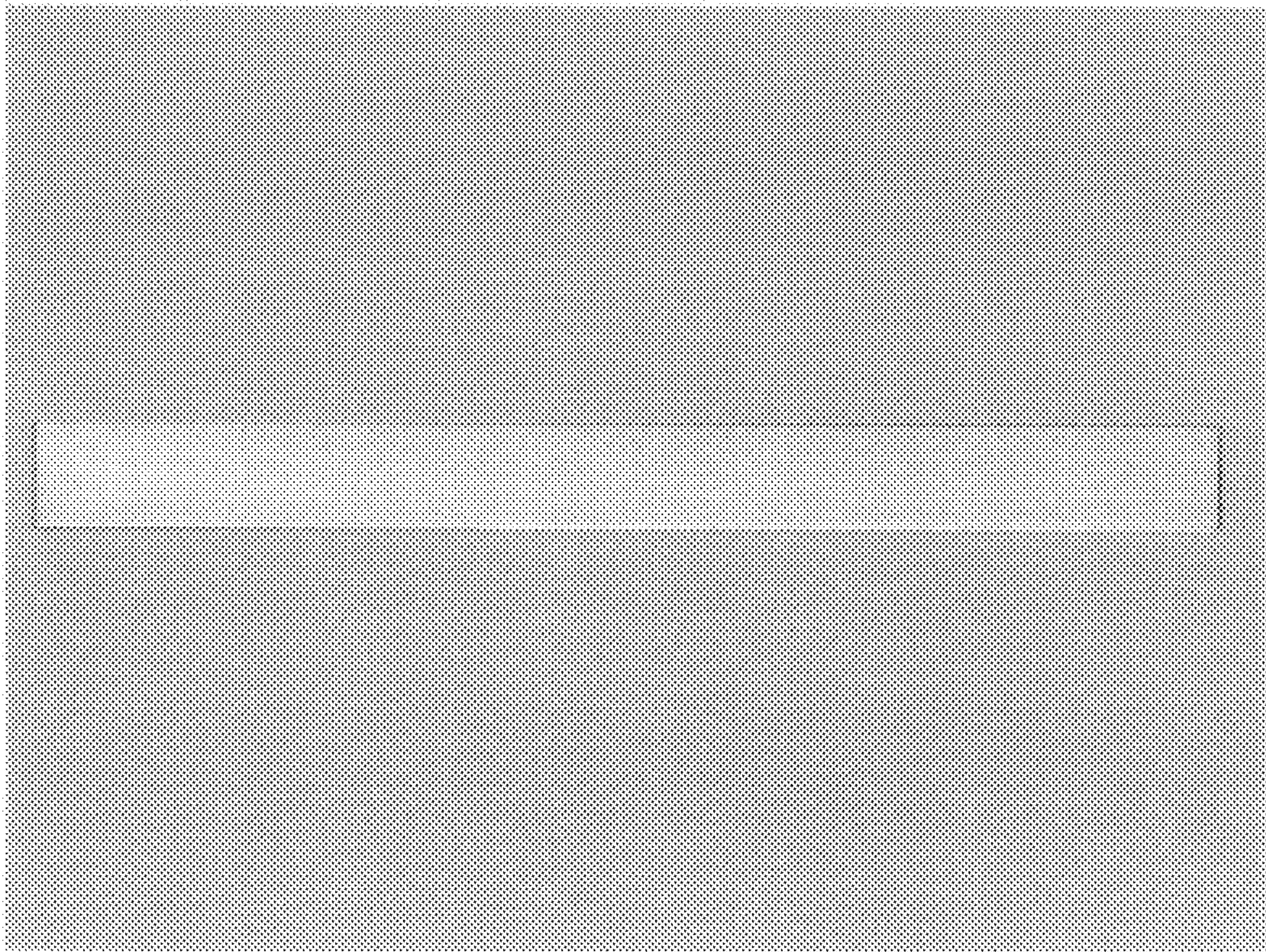

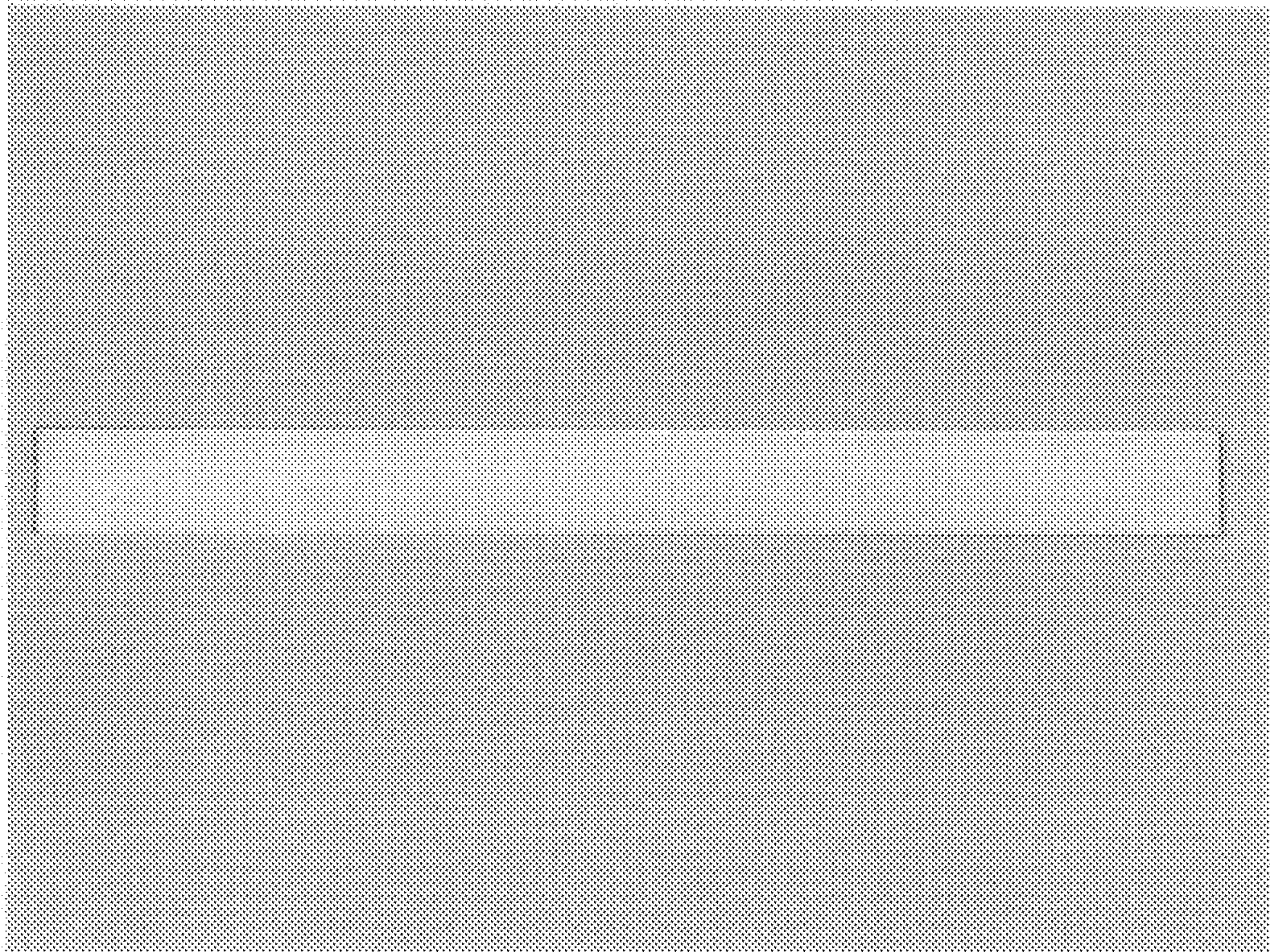

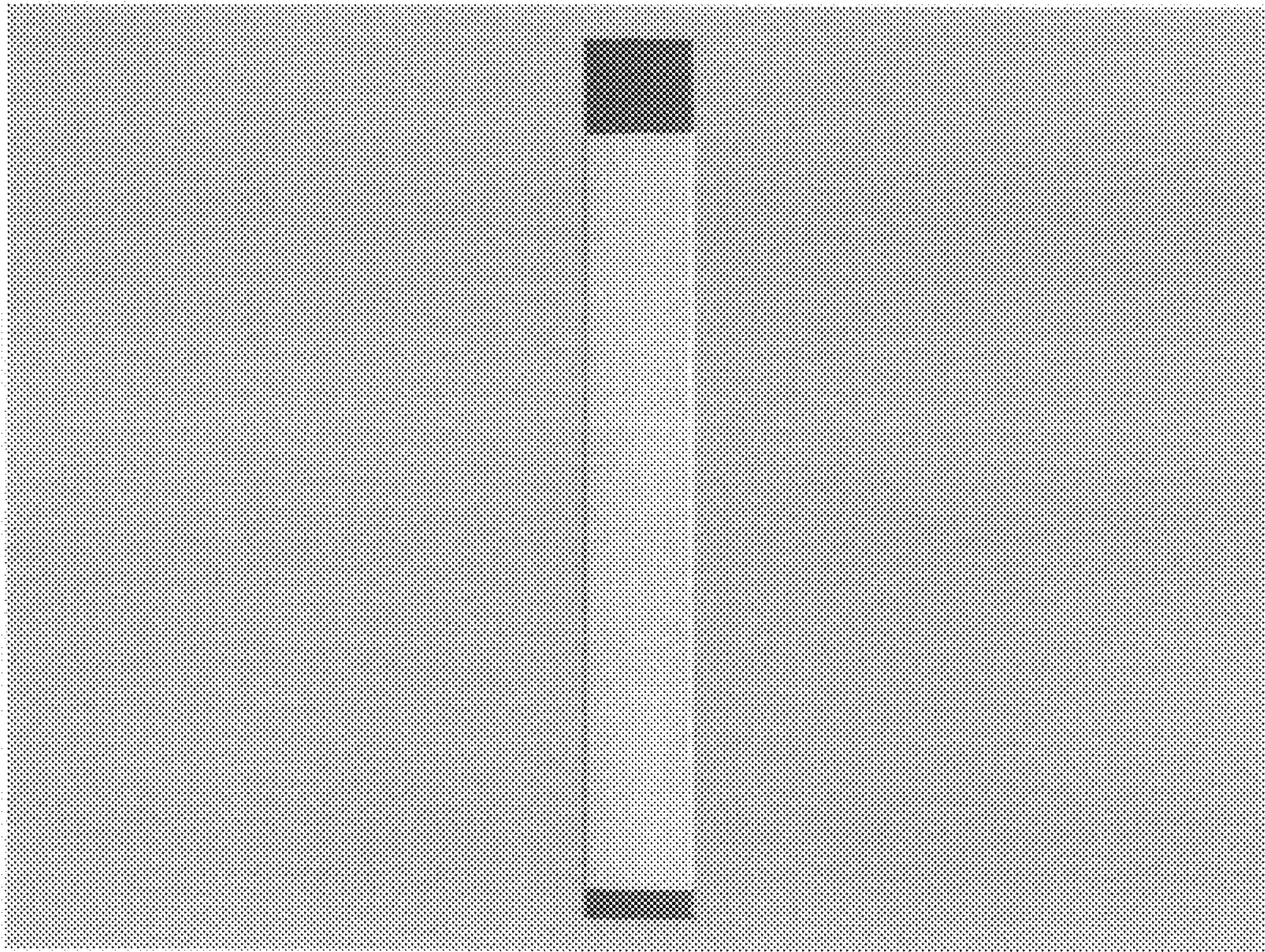

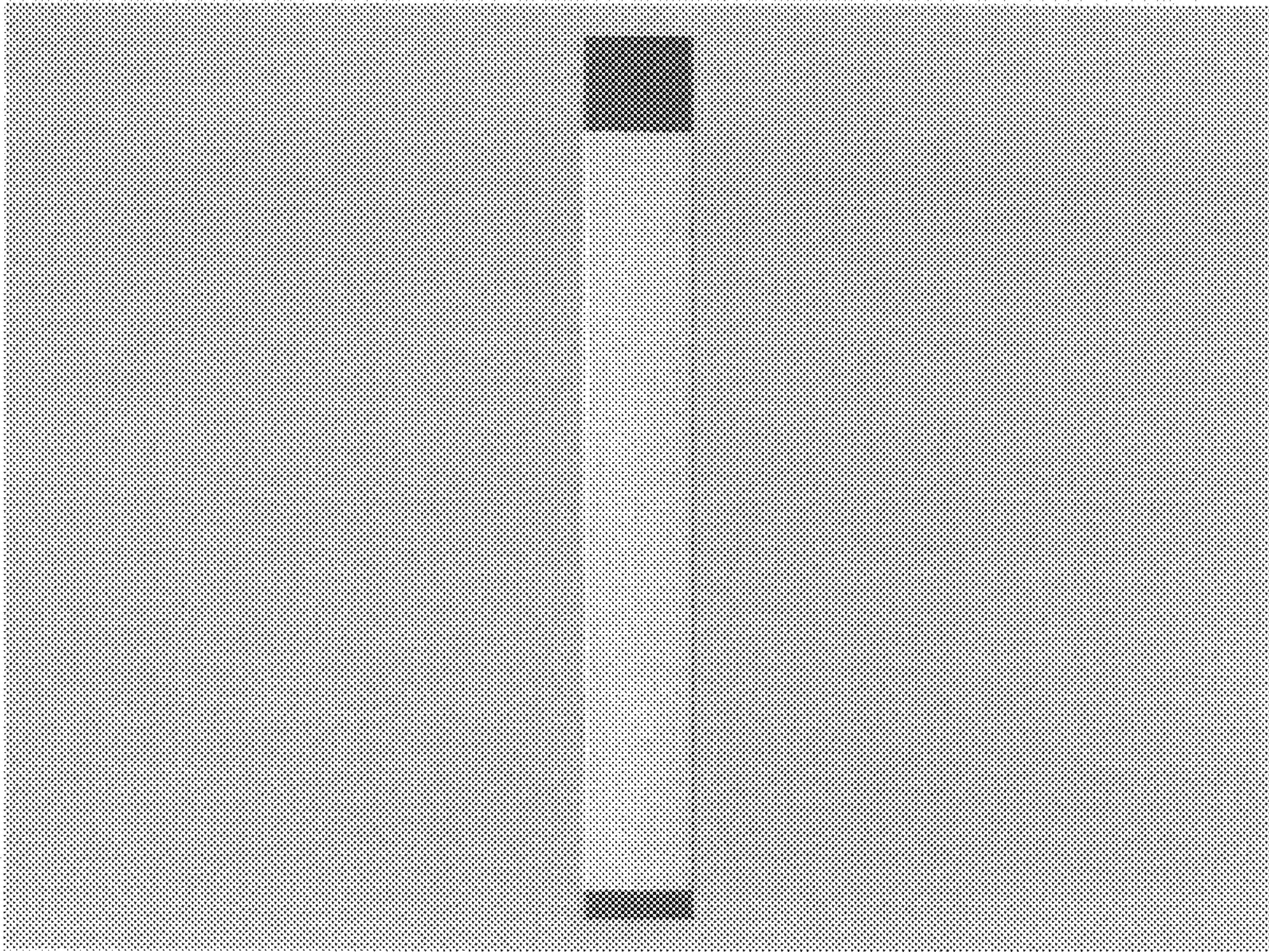
