DESCRIPTION

FIG. 1 is a perspective view of the link.

FIG. 2 is a bottom plan view of the link.

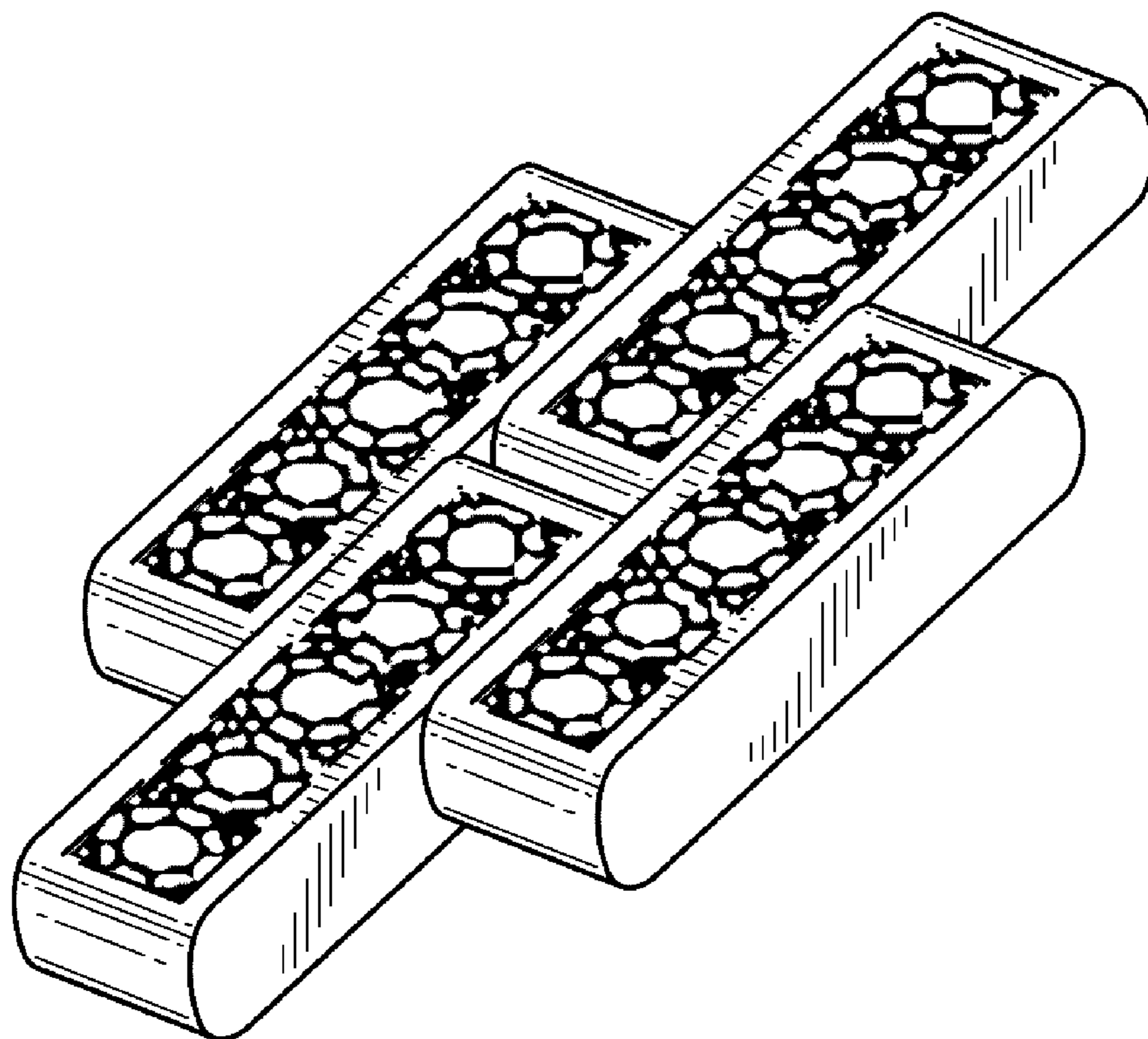
FIG. 3 is a left view of the link, the right side view being identical.

FIG. 4 is a front elevation view of the link, the rear elevation view being identical; and,

FIG. 5 is a top plan view of the link.

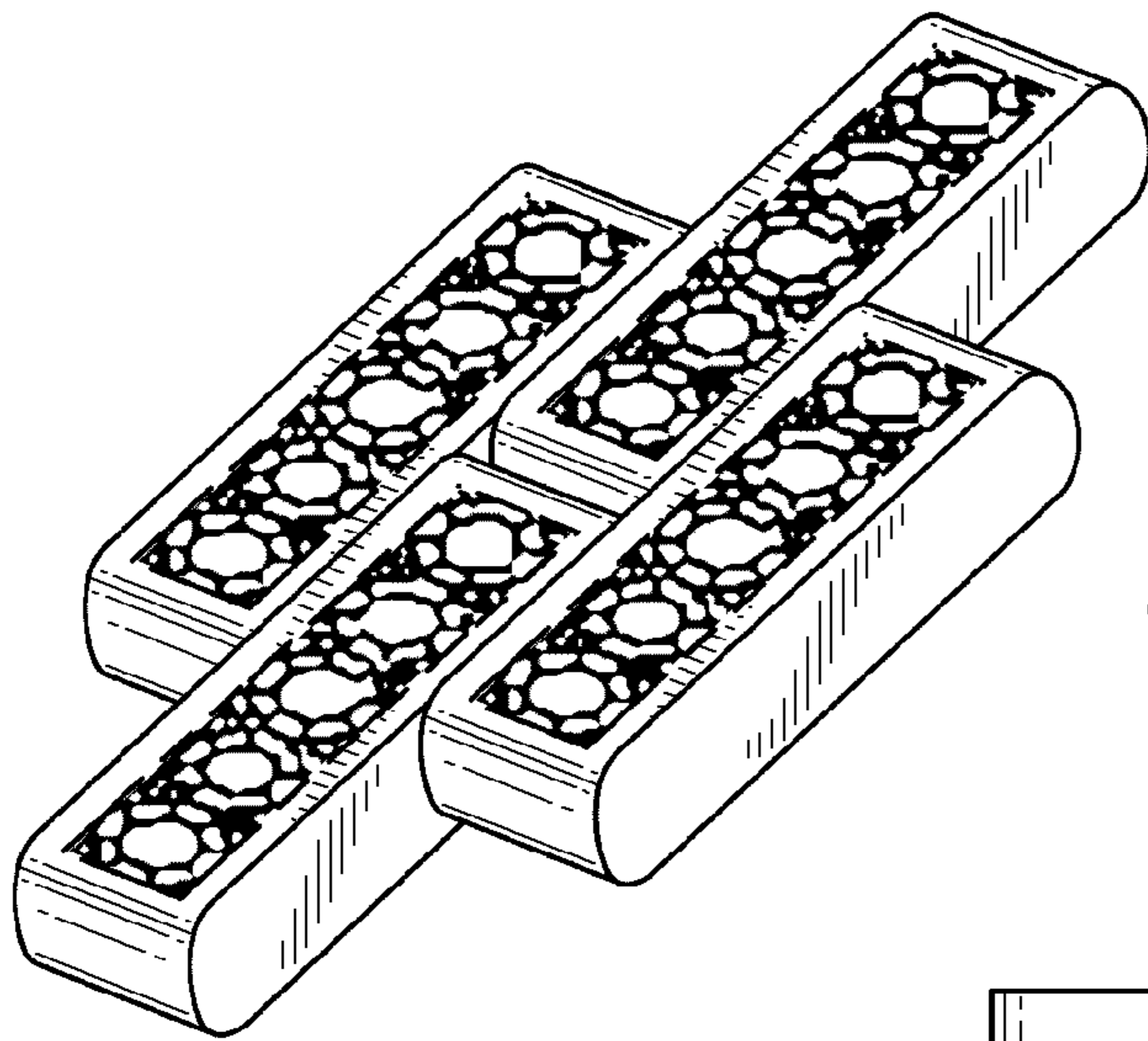

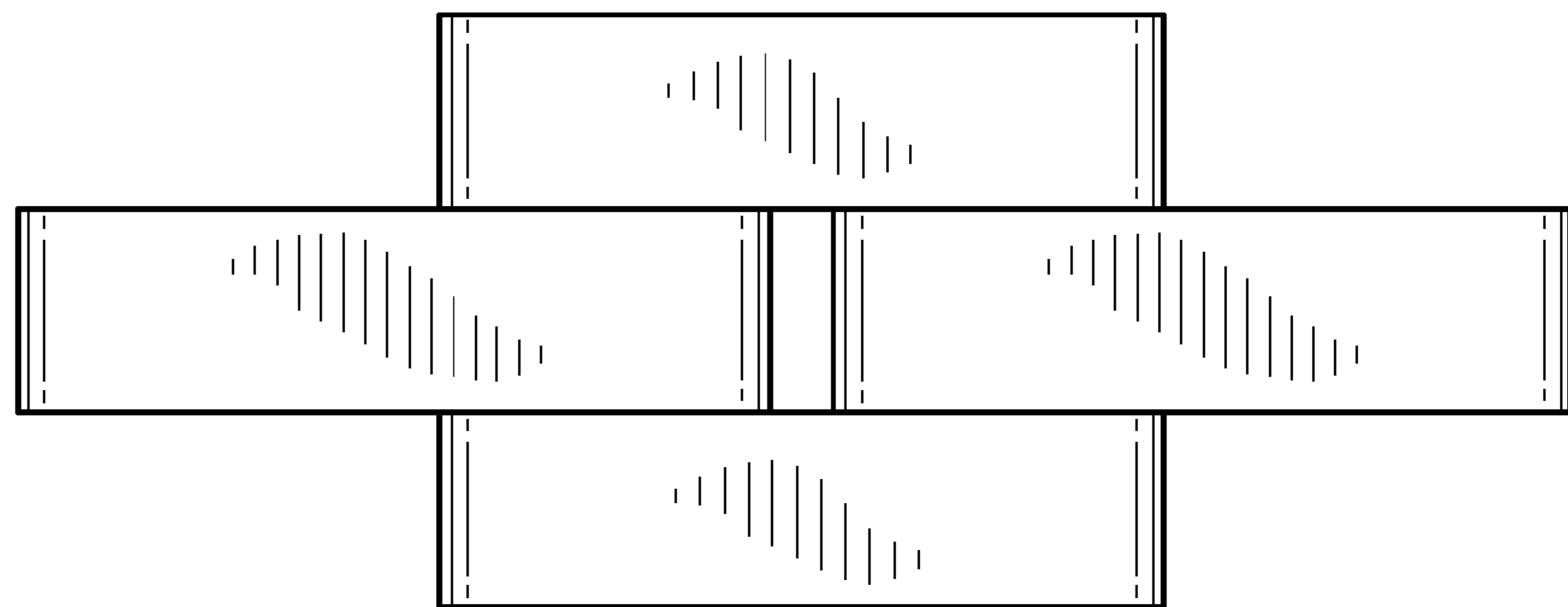

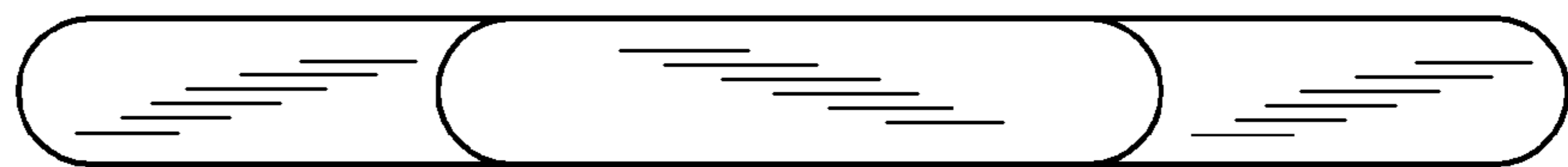

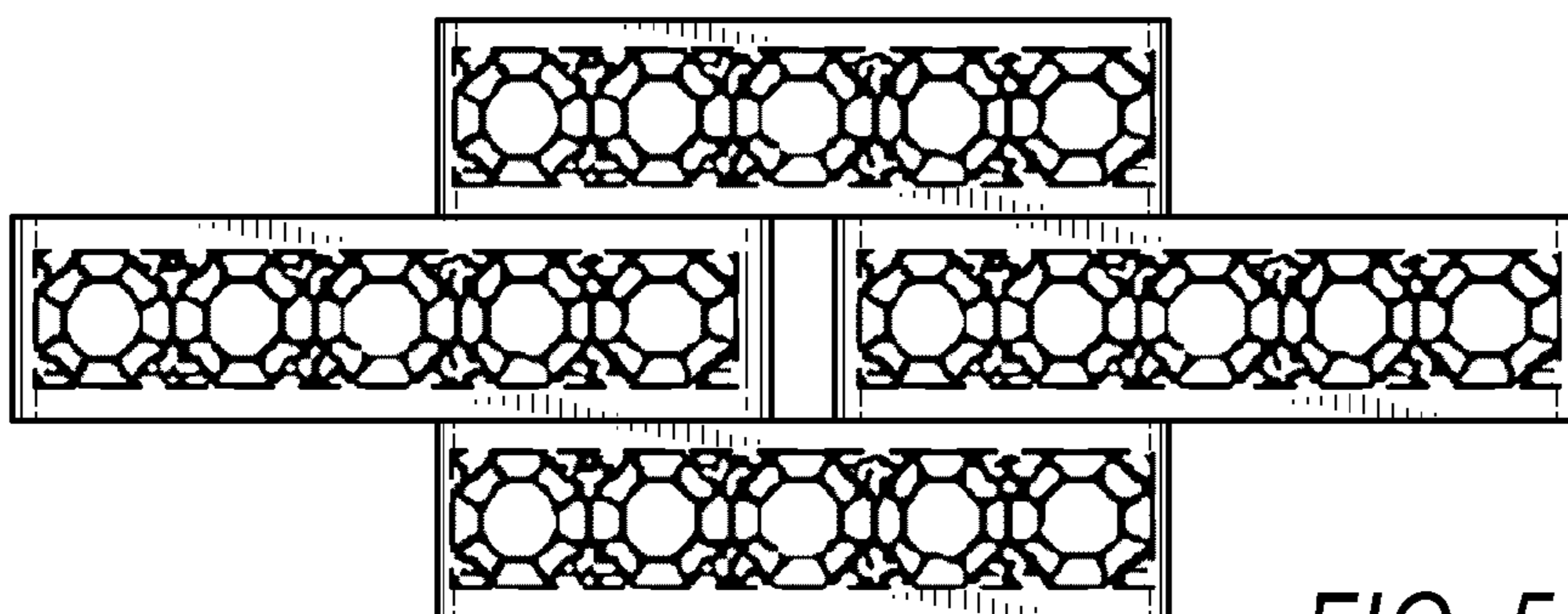
