FIG. 6 is a reference view showing a state of being used thereof.

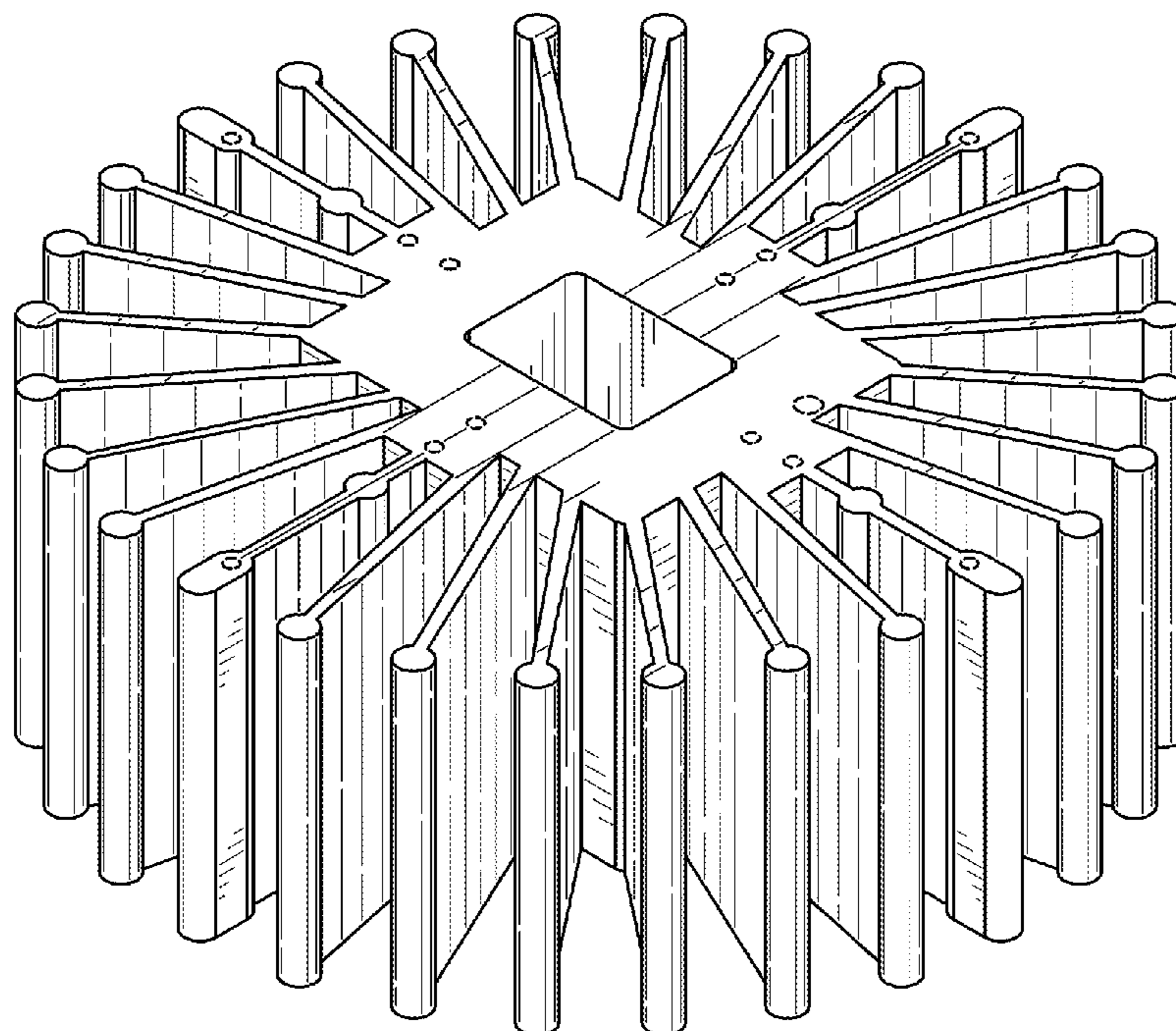

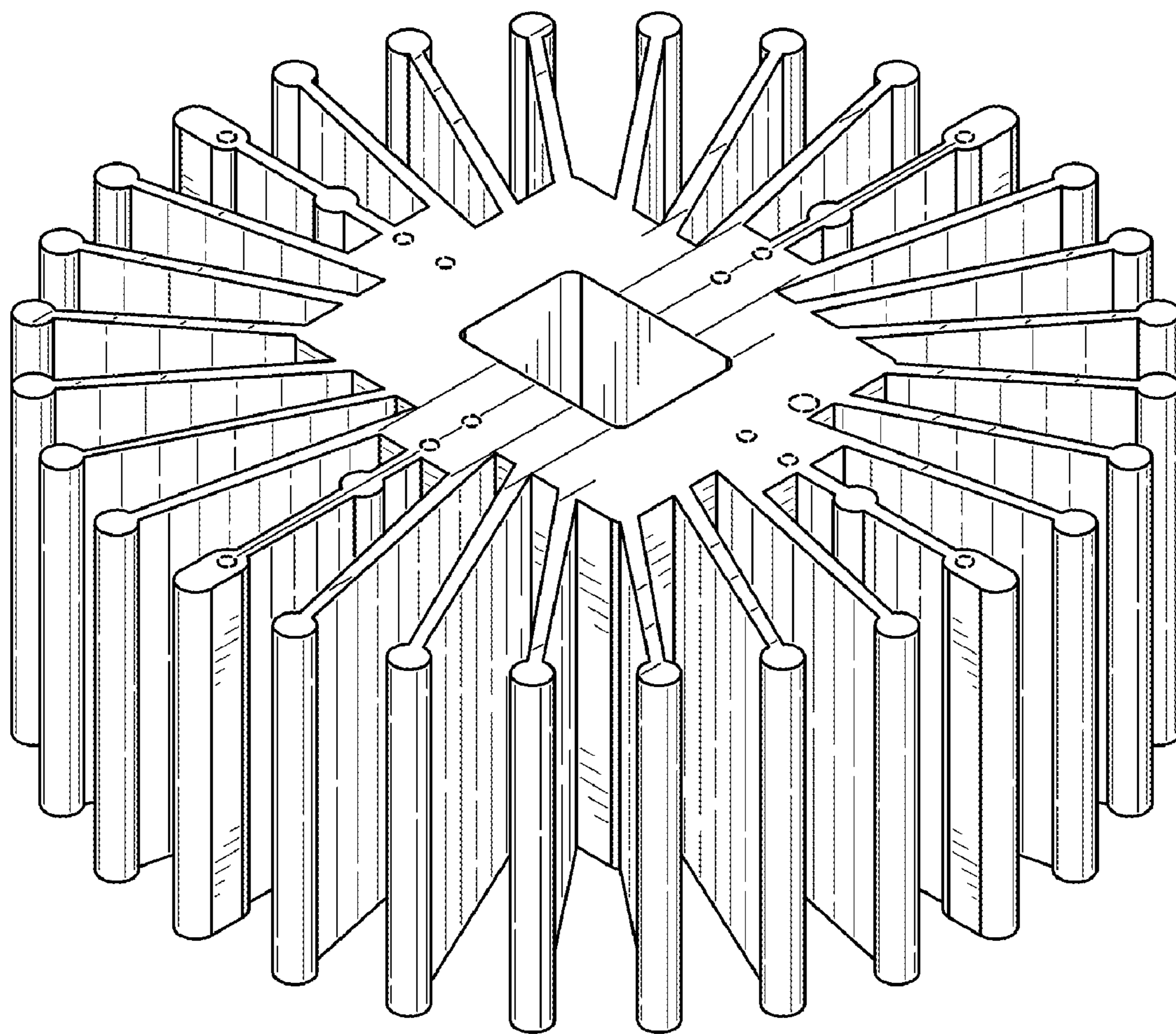

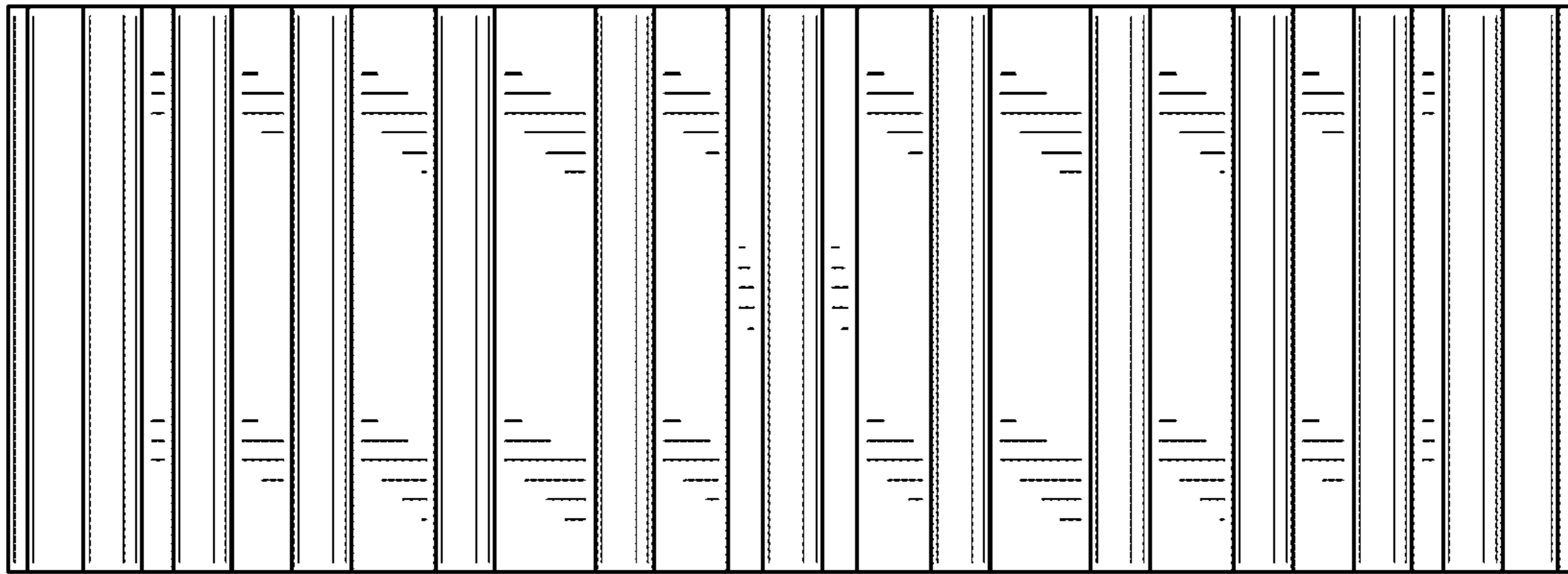

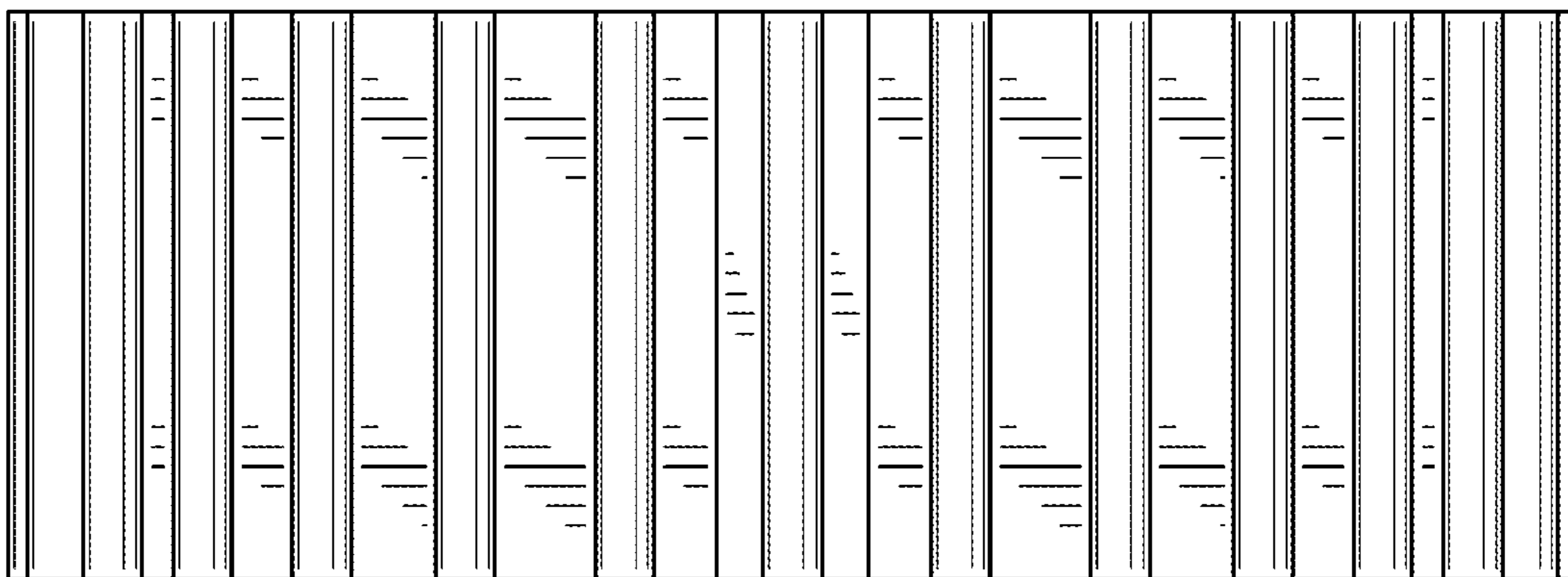

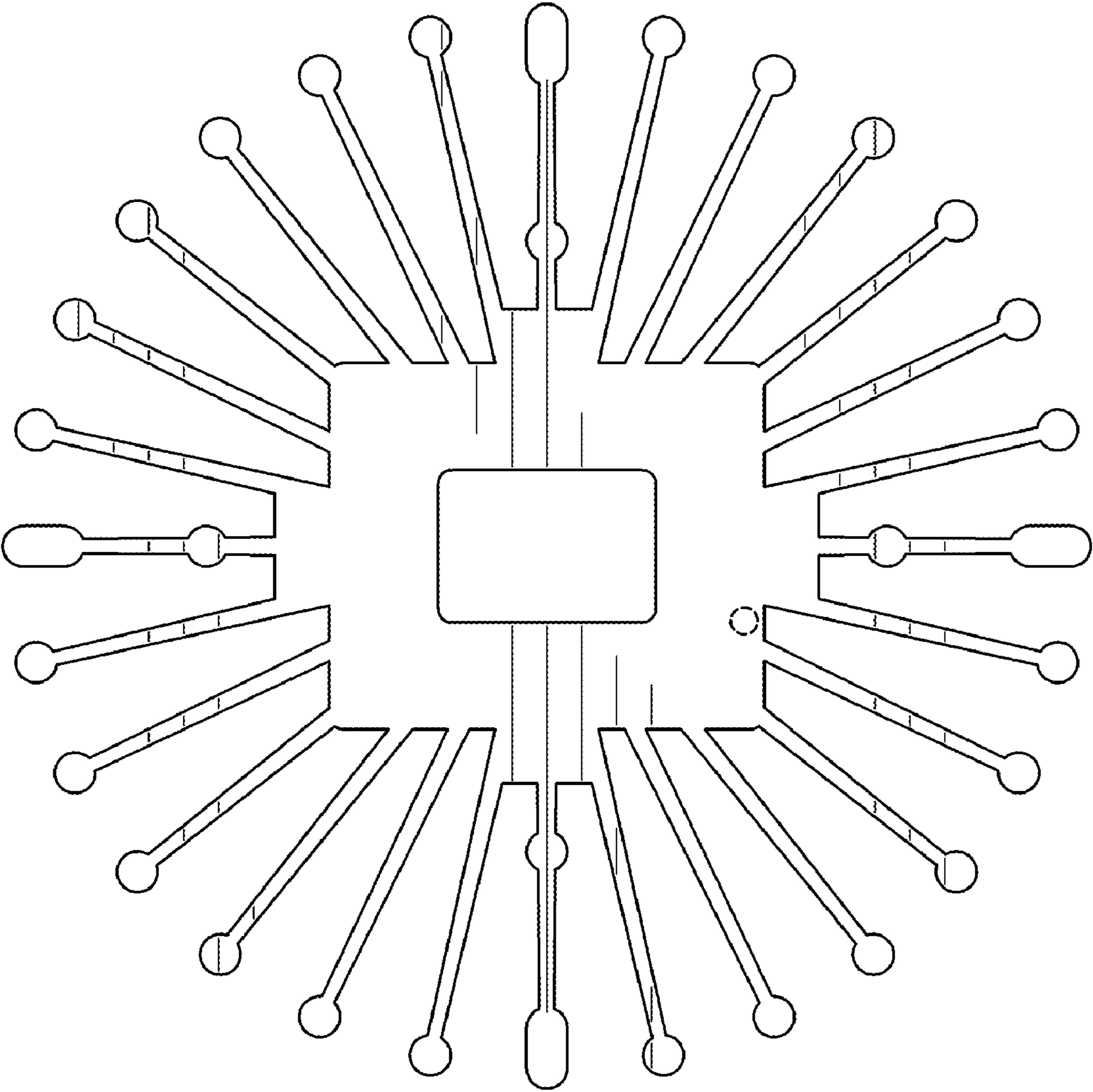

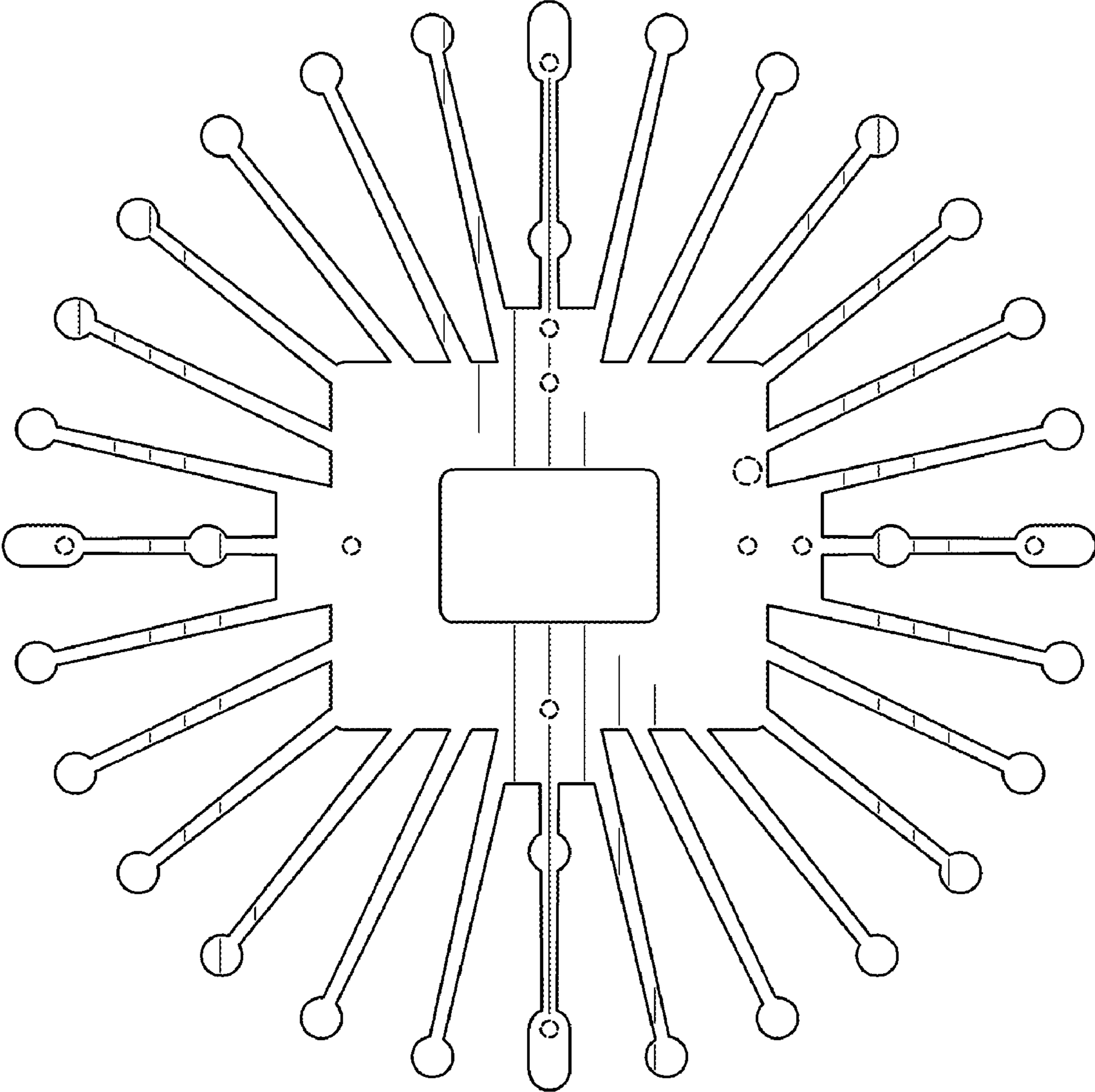

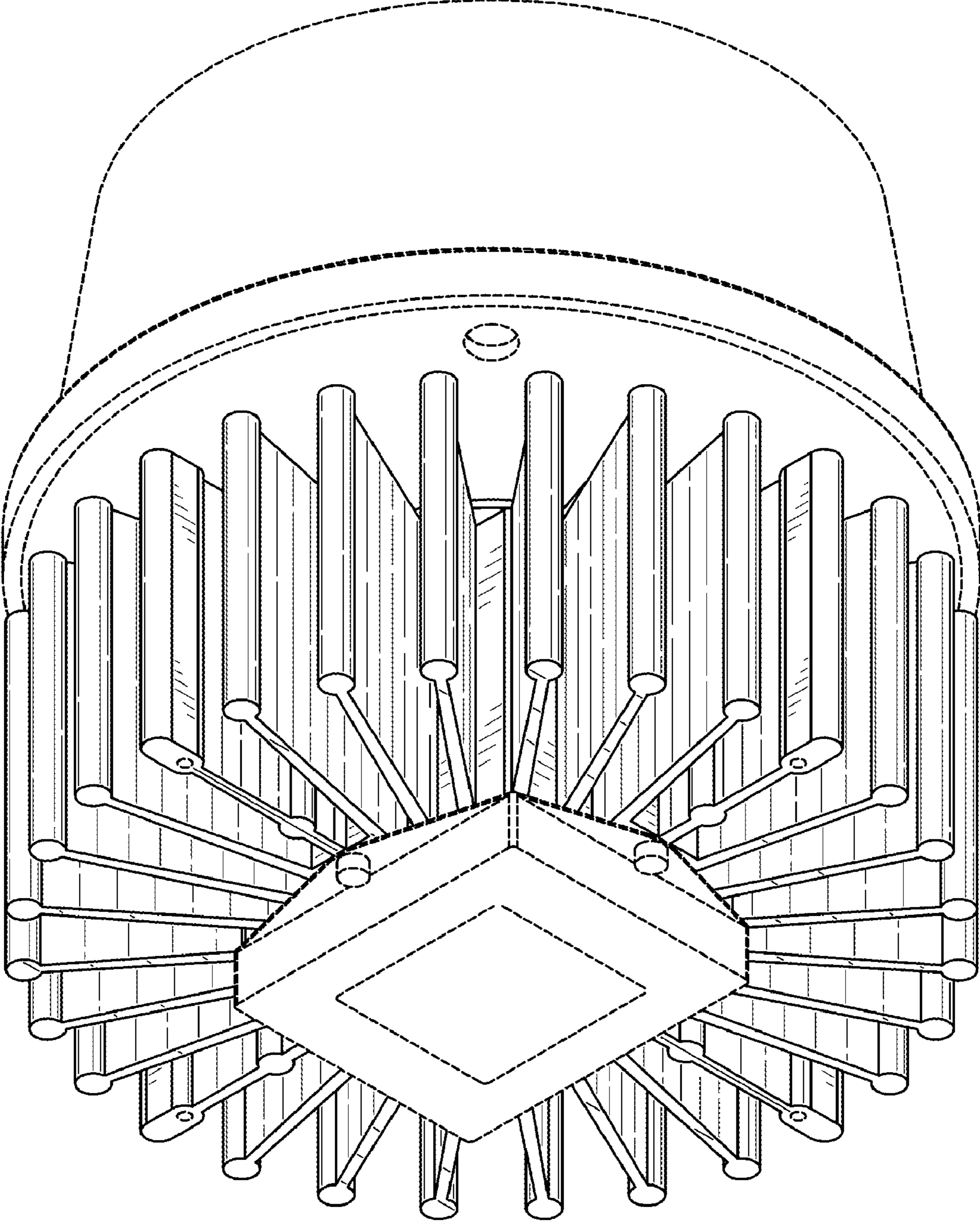
