The ornamental design for a graphical user interface for a display screen of a communications terminal, as shown and described.

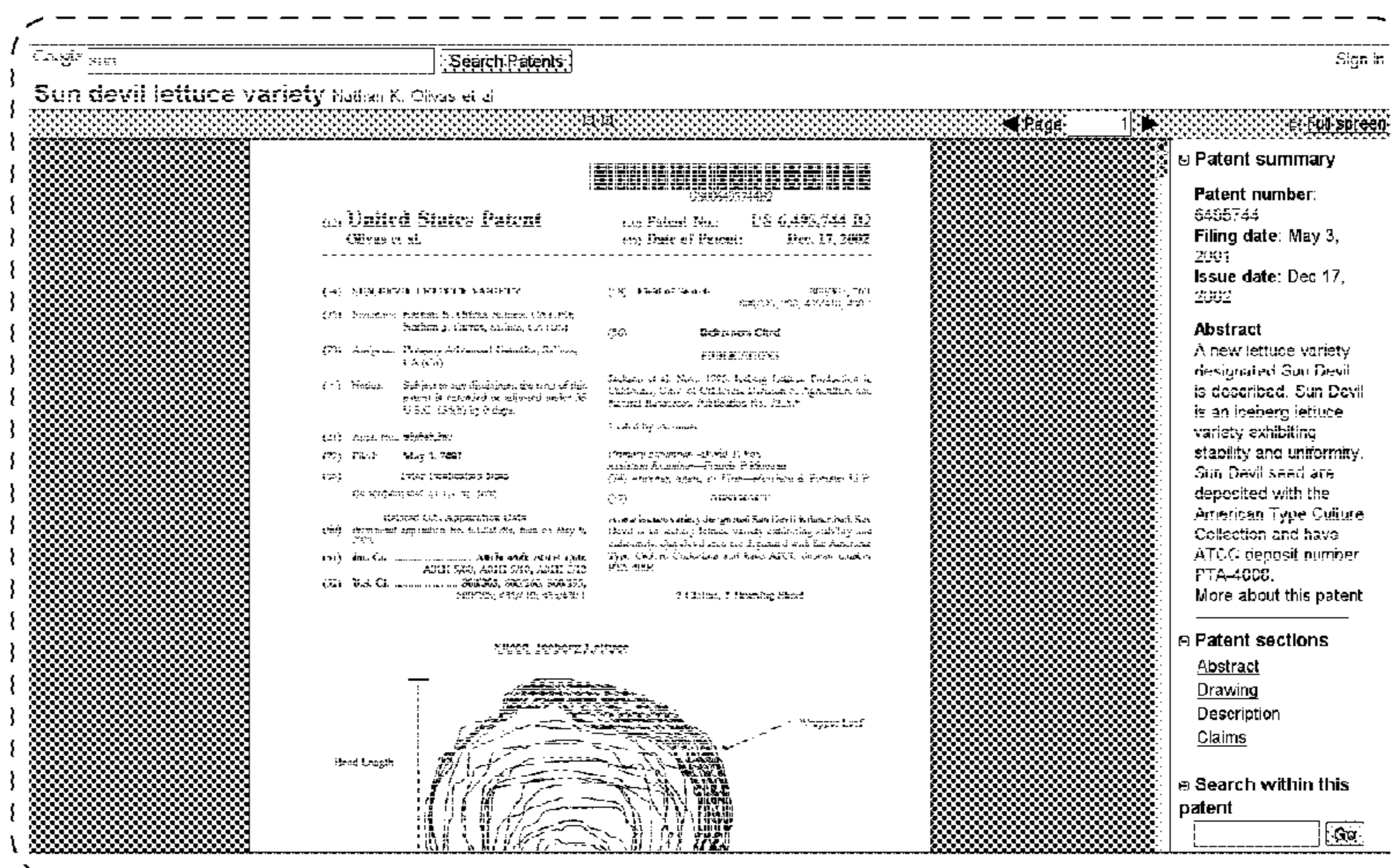
DESCRIPTION
