FIG. 3 is a back end view of the plectrum of the invention;

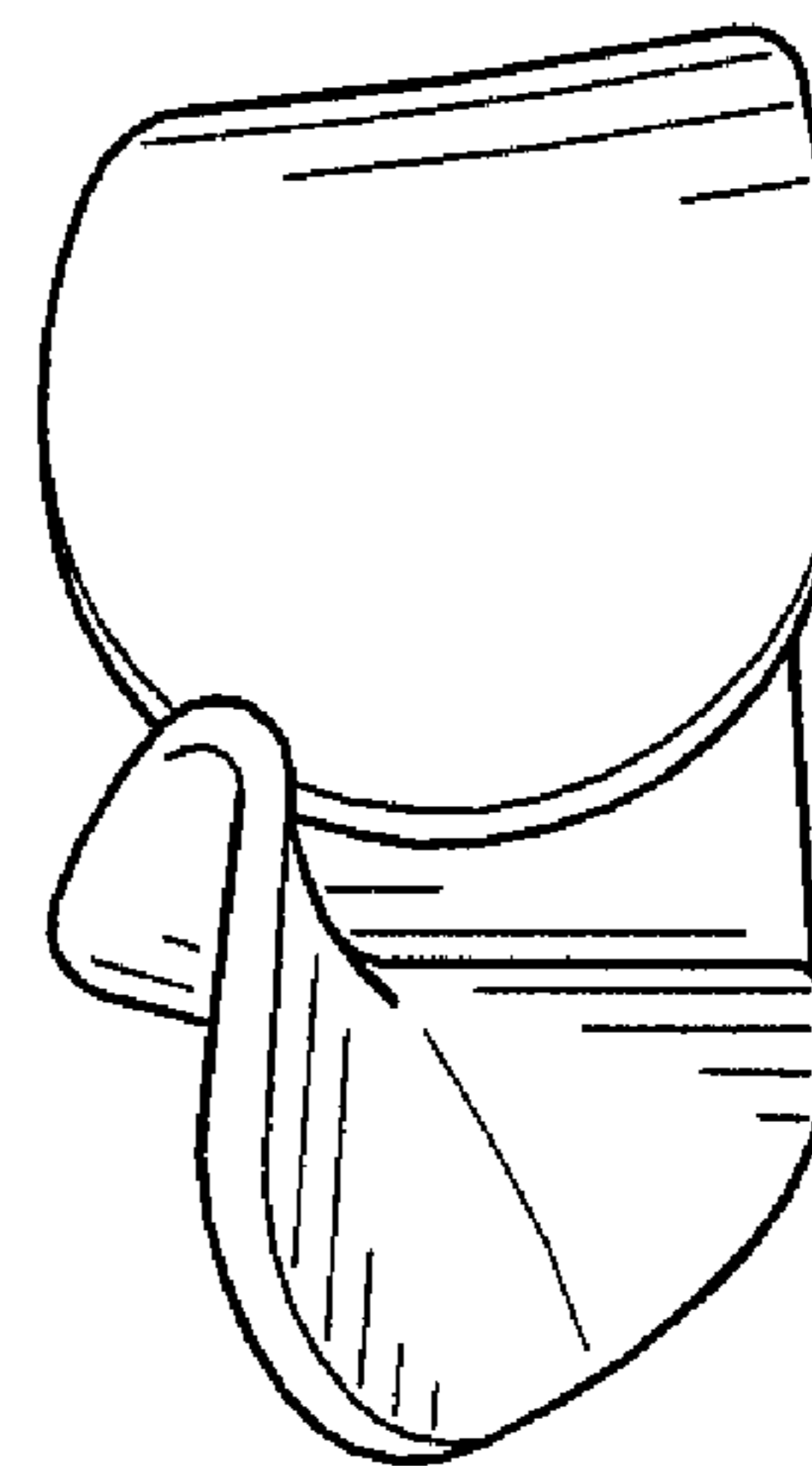
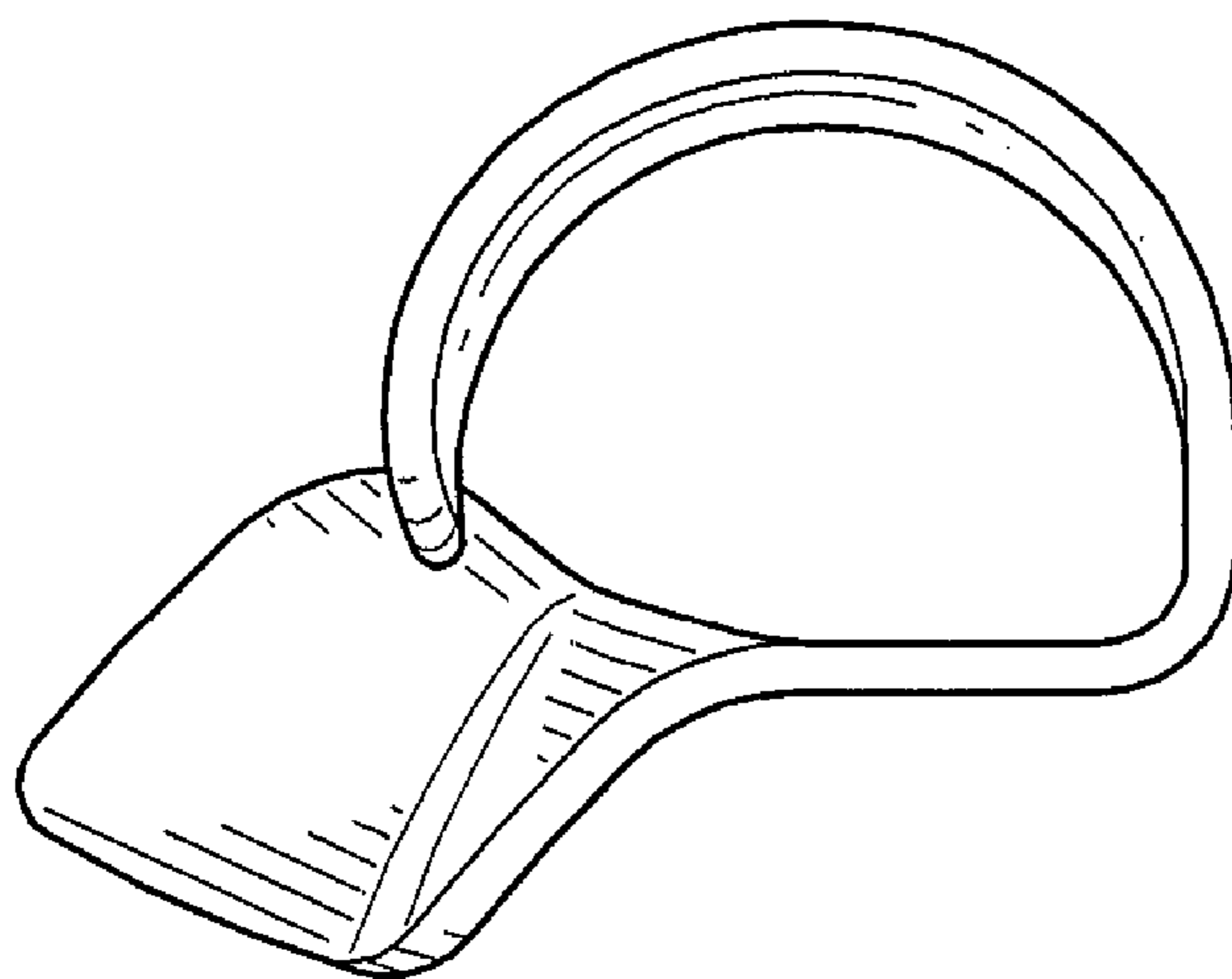
FIG. 4 is a front end view of the plectrum of the invention;

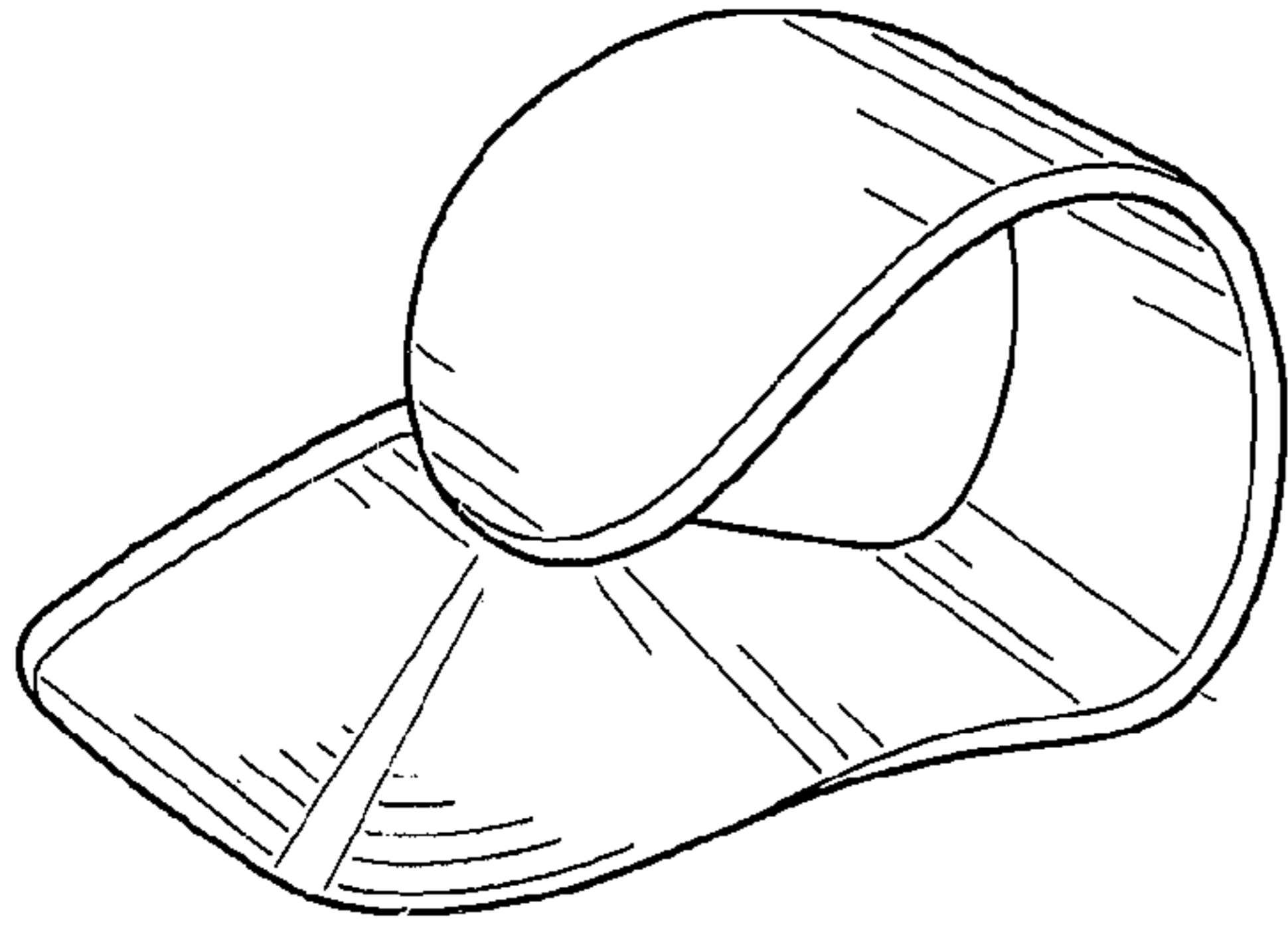

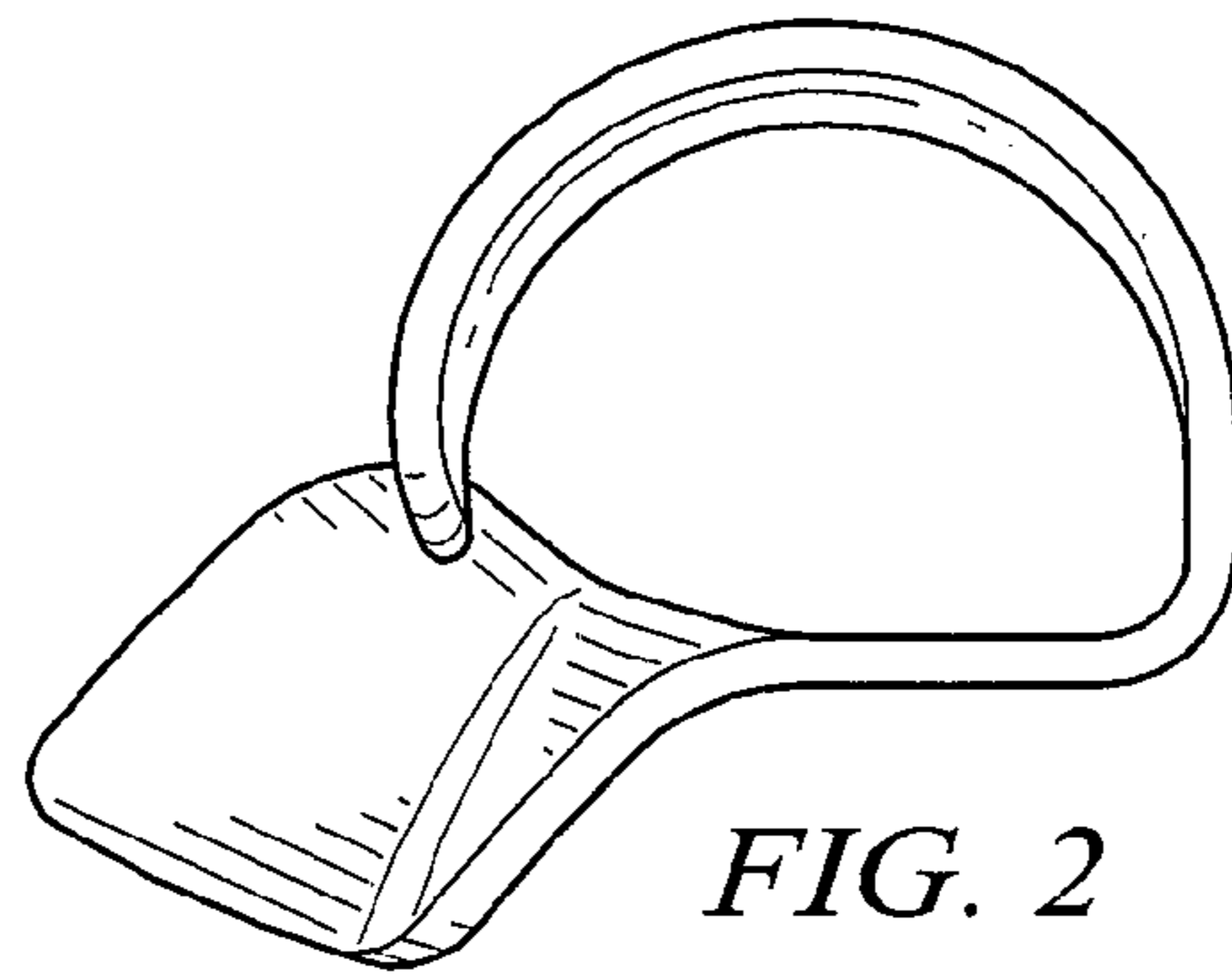

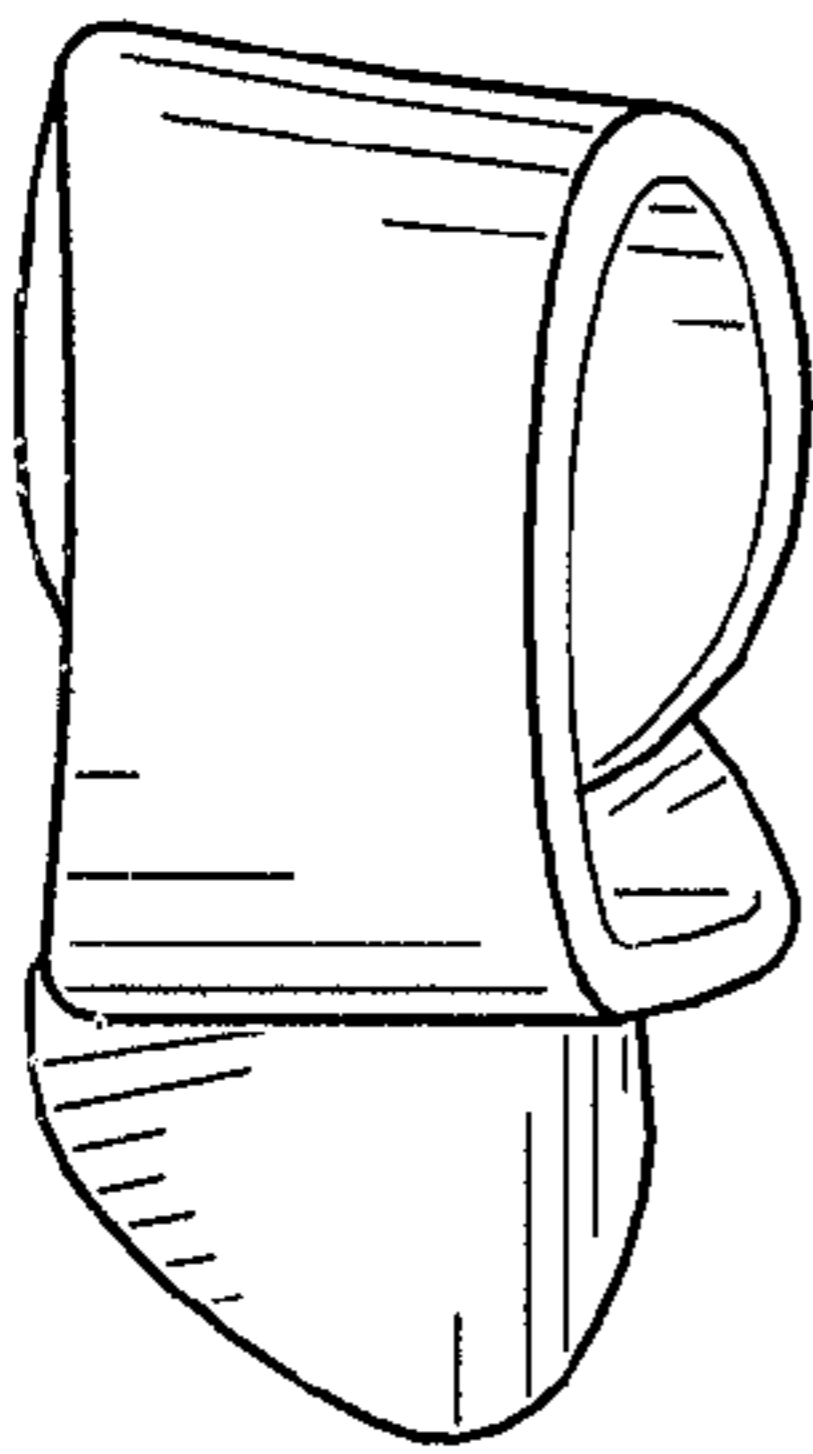

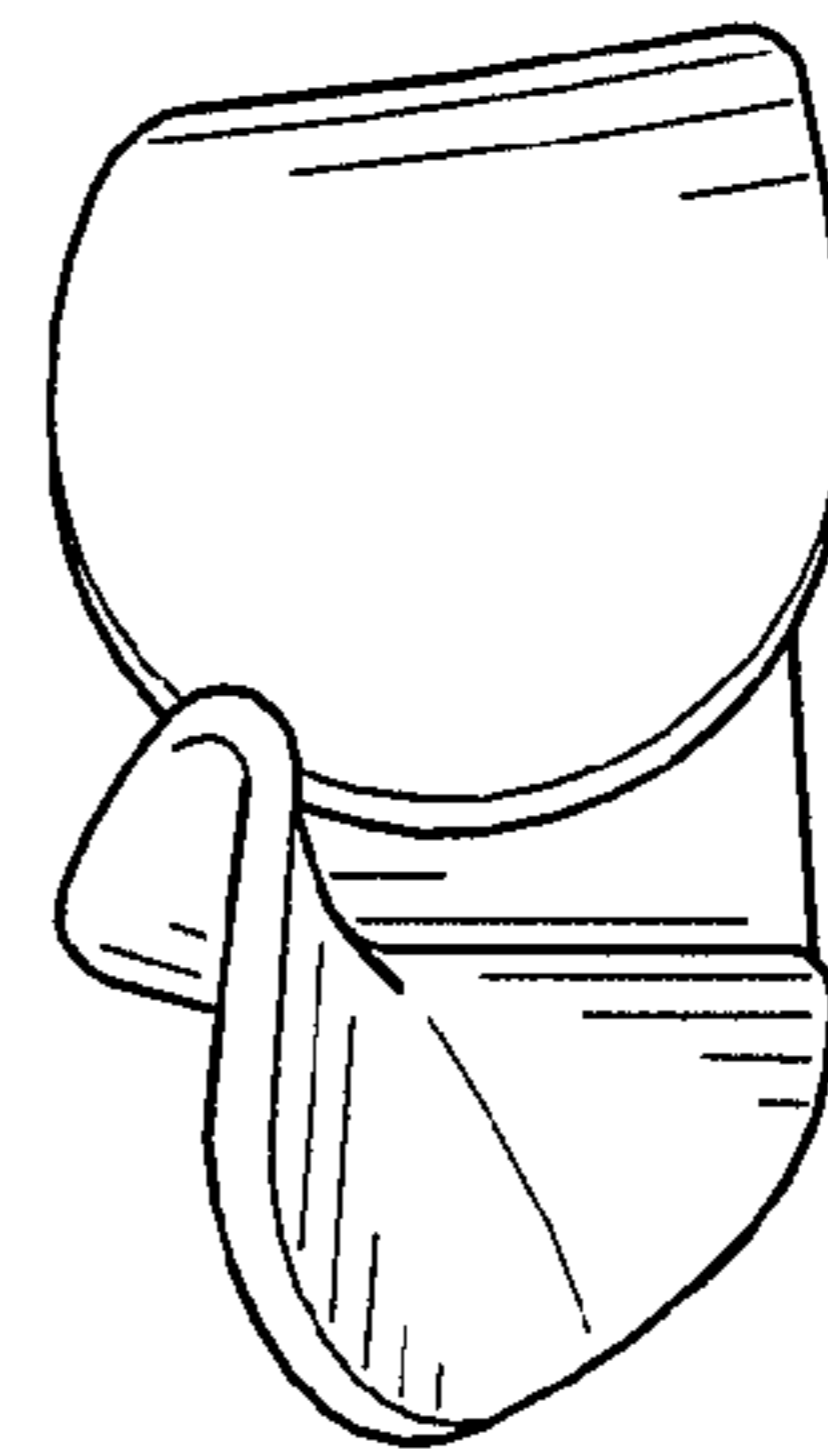

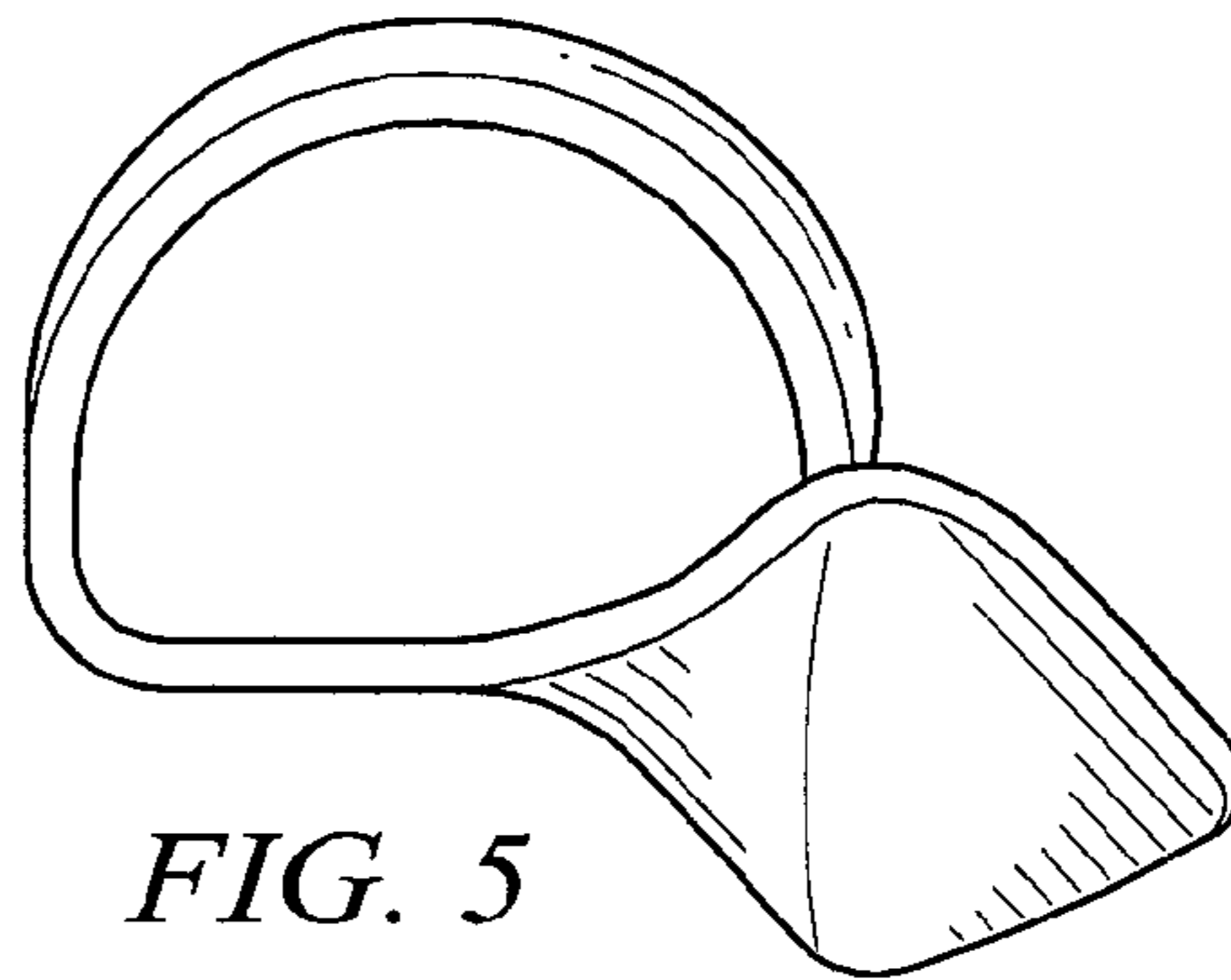

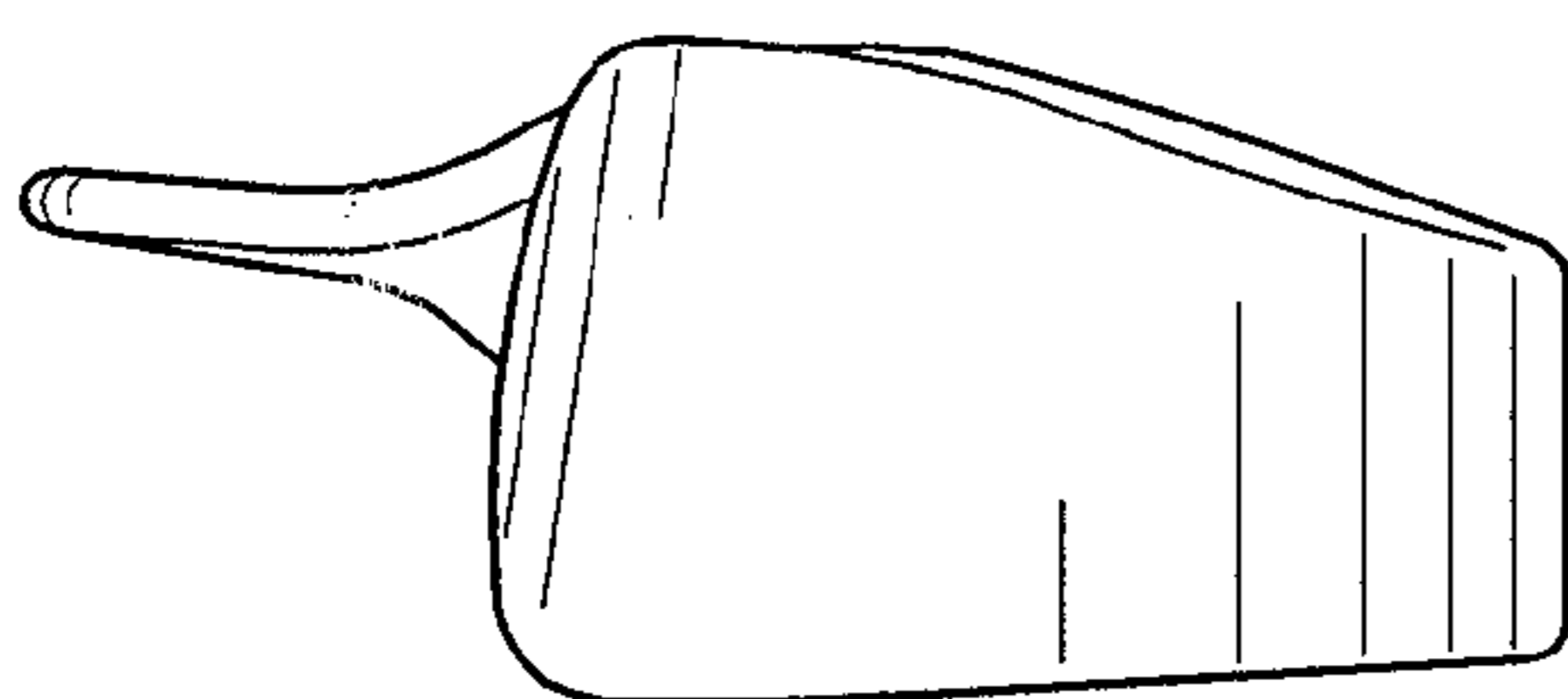

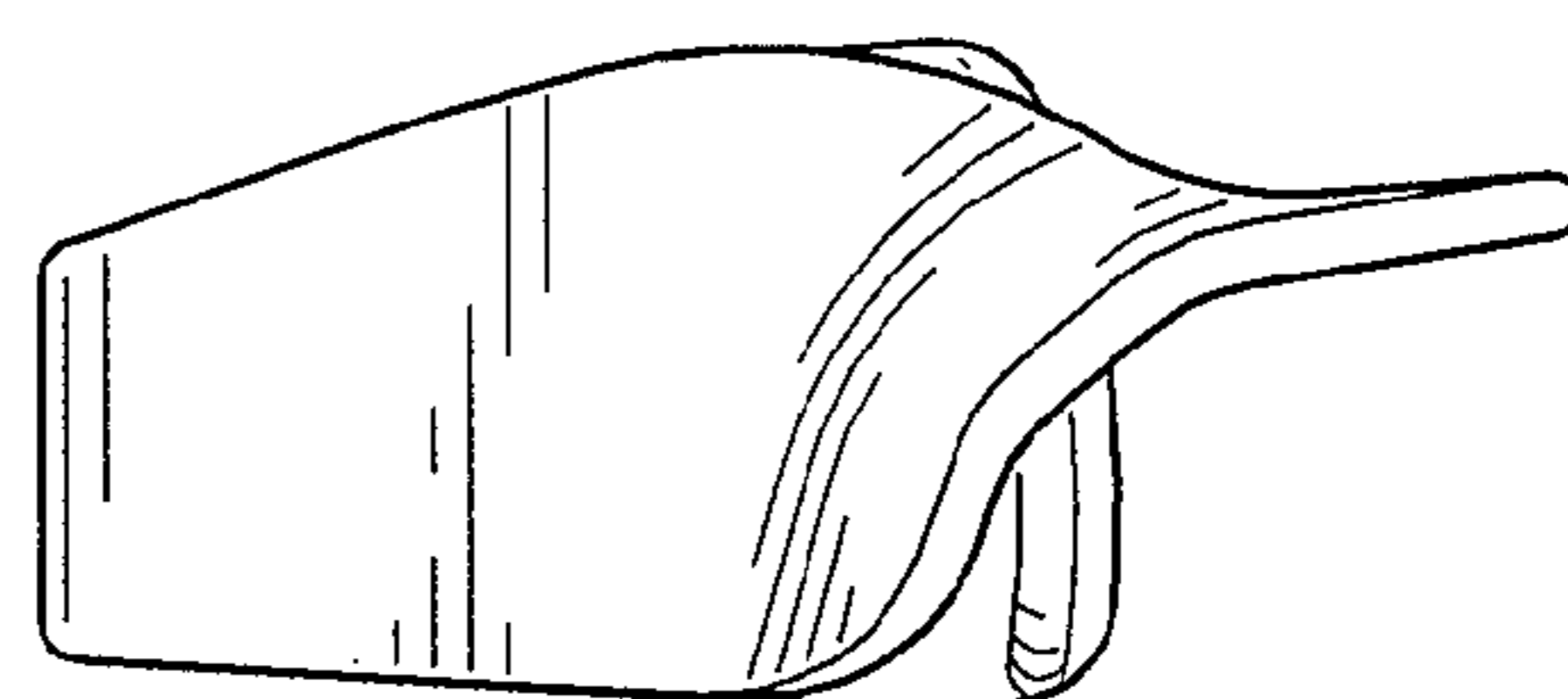
