FIG. 2 is back elevation view thereof;

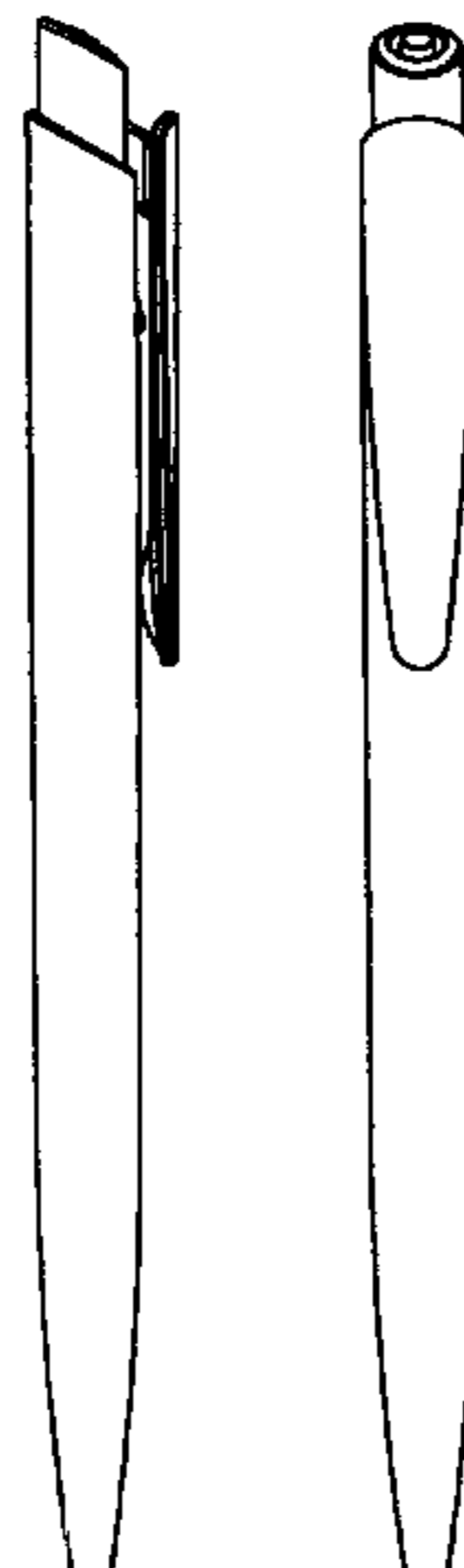
FIG. 3 is an opposite side elevation view from that shown in FIG. 1;

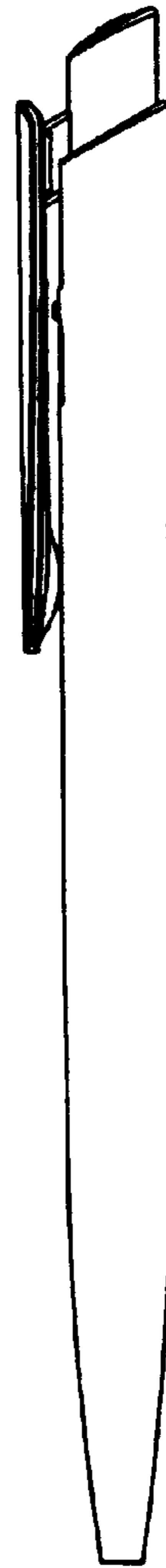
