(57) **CLAIM**

The ornamental design for a structural member for model robots, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a structural member showing our new design, the broken lines illustrating environmental structure are for illustrative purposes only and form no part of the claimed design;

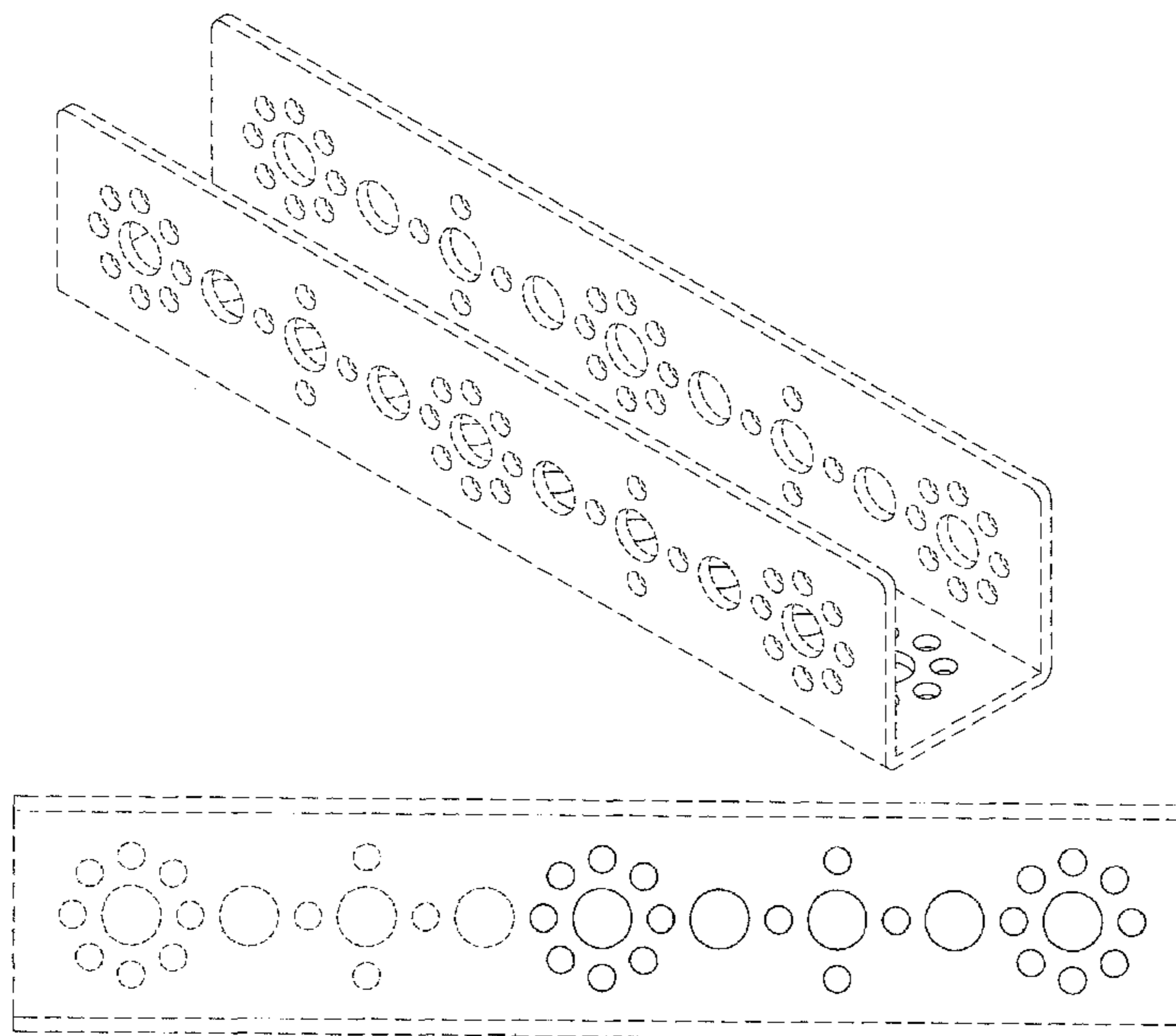

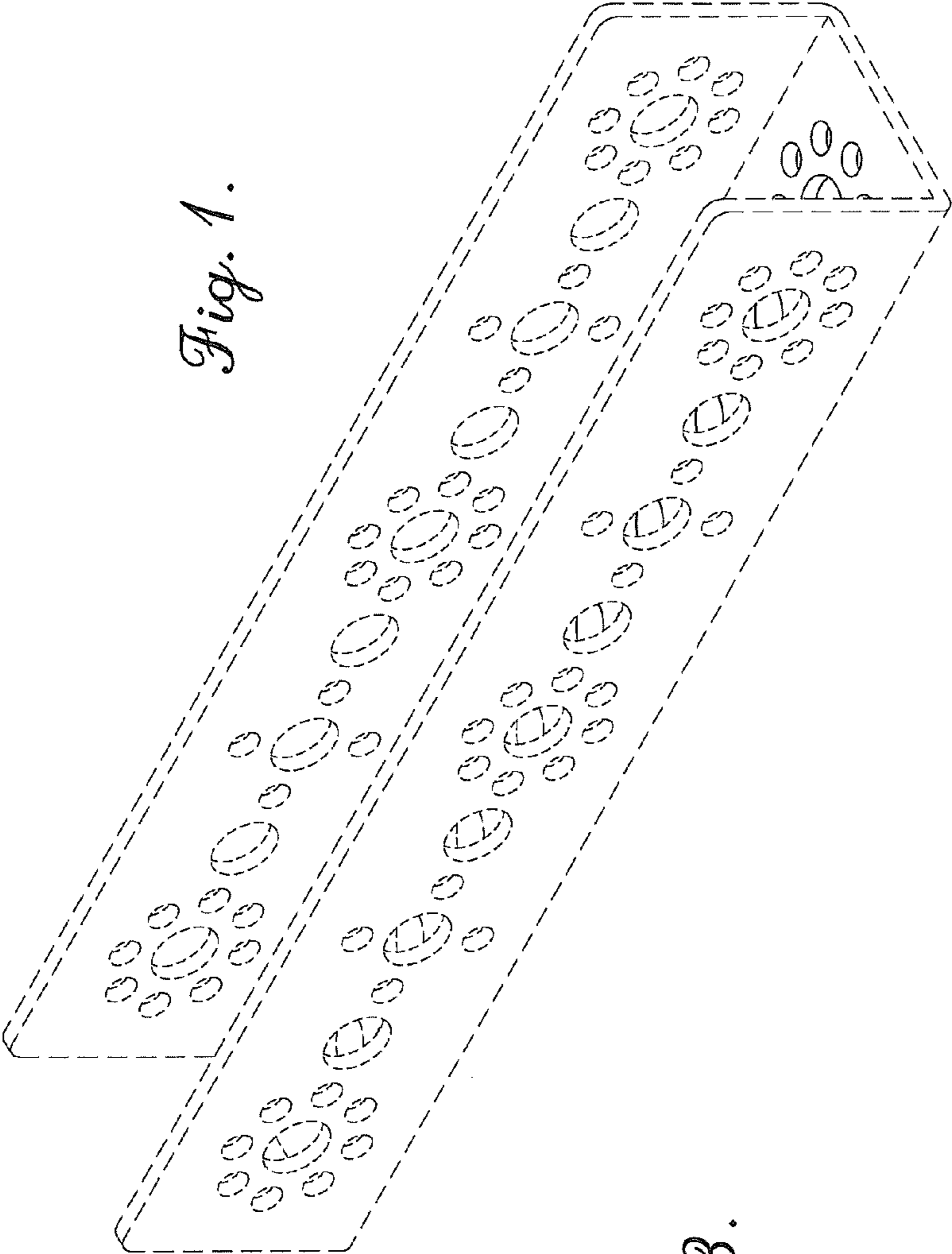

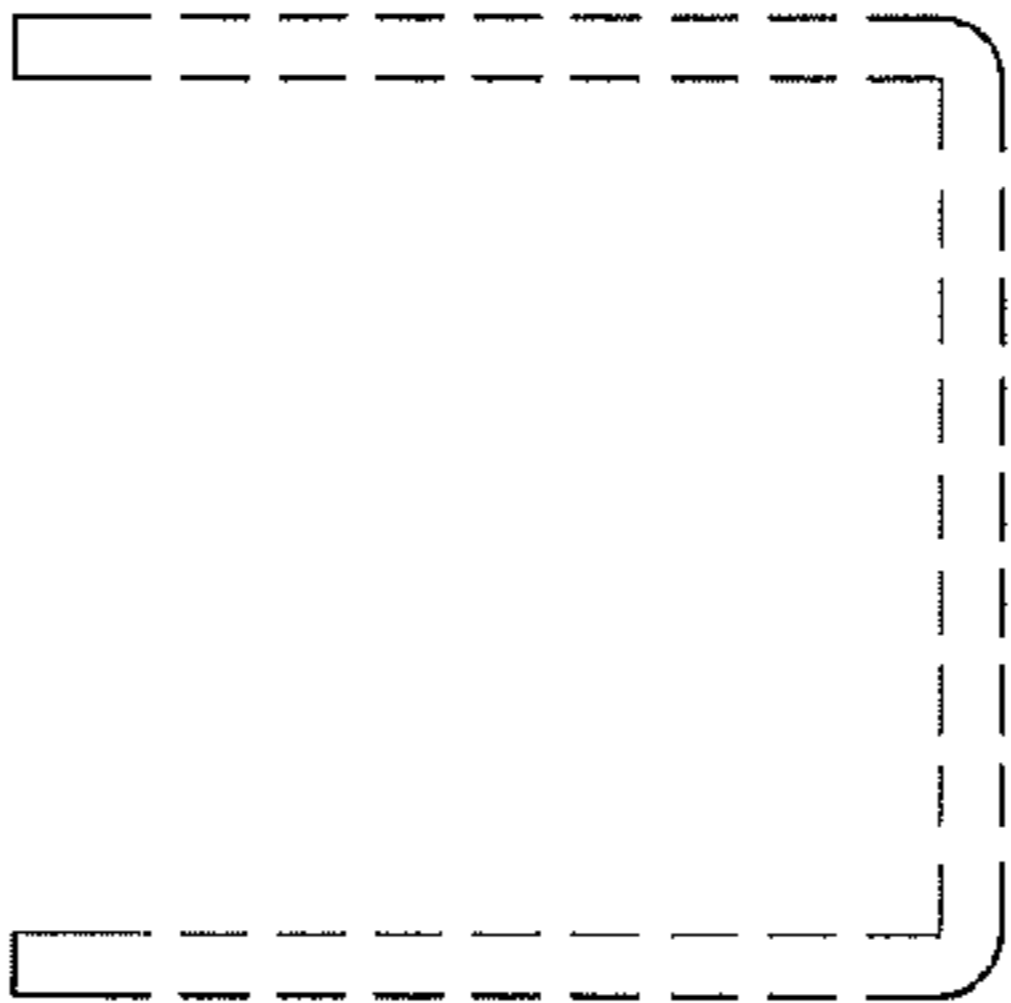

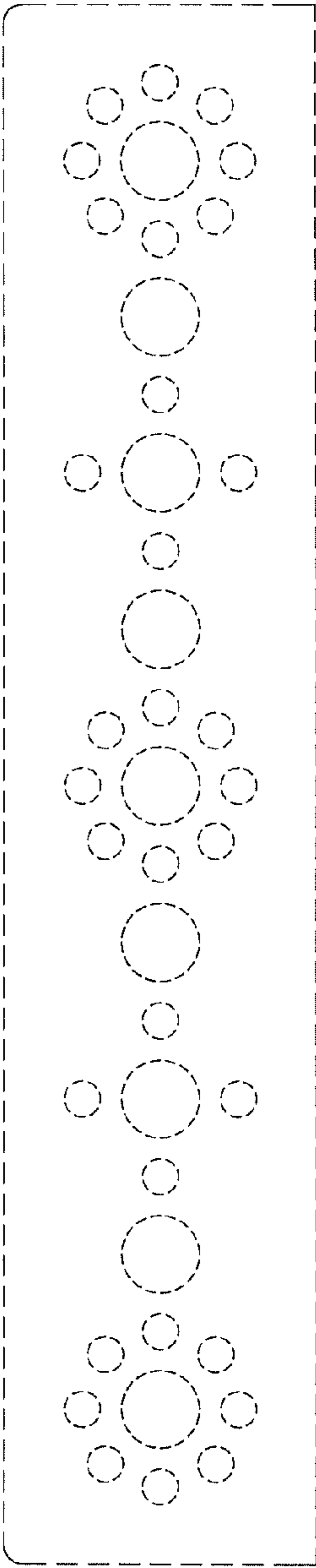

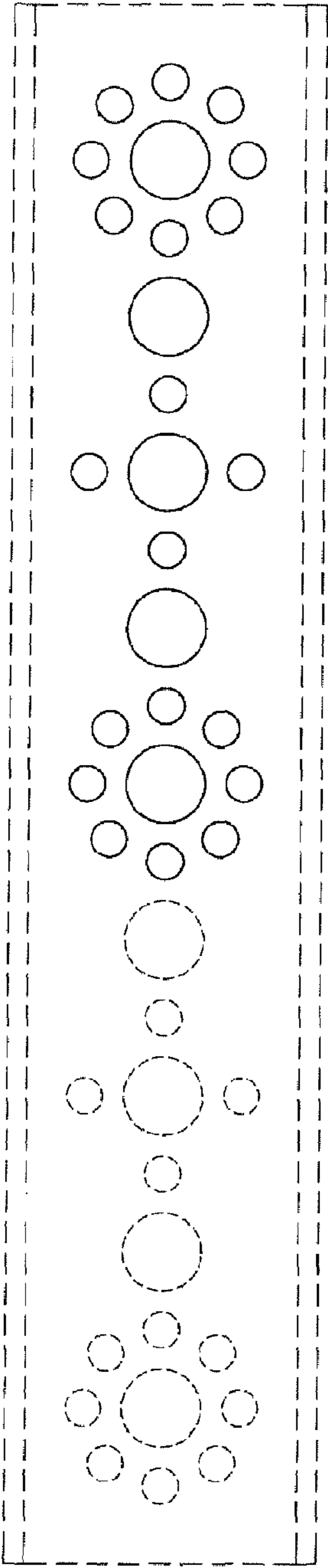

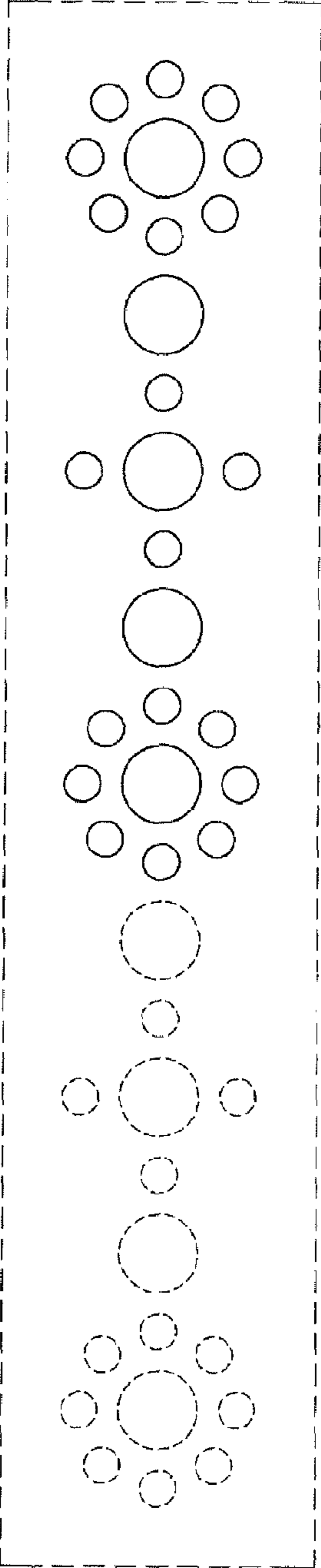
