The ornamental design for a ball, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a ball showing our new design;

FIG. 2 is a rear view of the ball in FIG. 1;

FIG. 3 is a right view of the ball in FIG. 1;

FIG. 4 is a left view of the ball in FIG. 1;

FIG. 5 is a top view of the ball in FIG. 1;

FIG. 6 is a bottom view of the ball in FIG. 1;

FIG. 7 is a front right perspective view of the ball in FIG. 1; and,

FIG. 8 is an inverted front left perspective view of the ball in FIG. 1.

The grayscale shading represents a contrast in either grayscale tone or color consonant with the visual appearance shown in the drawings.
