**DESCRIPTION**

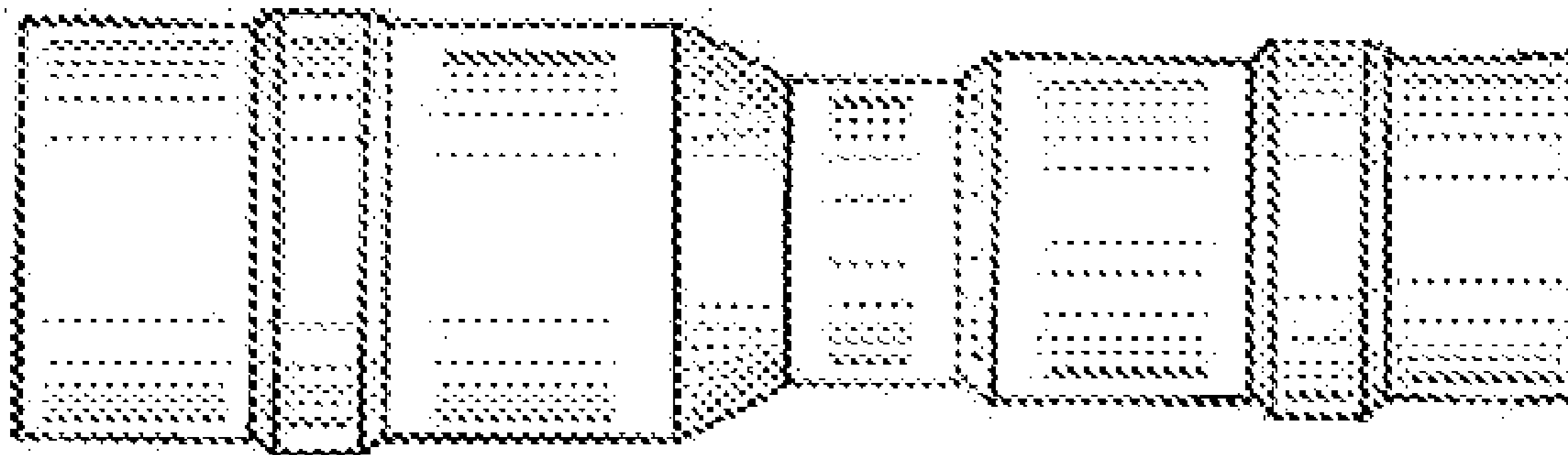
FIG. 1 is a cross-sectional view taken along line 1—1 in FIG. 3;

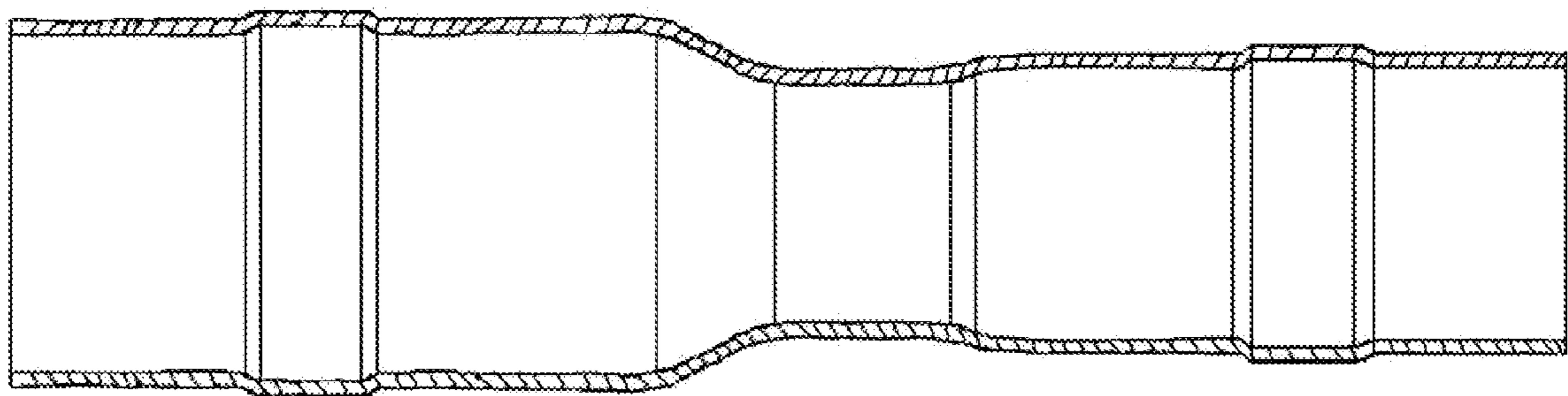
FIG. 2 is a front view showing the structure of surface of the portion of a pipe illustrated in FIG. 1;

FIG. 3 is a left side or left end view of the portion of a pipe of FIG. 2; and,

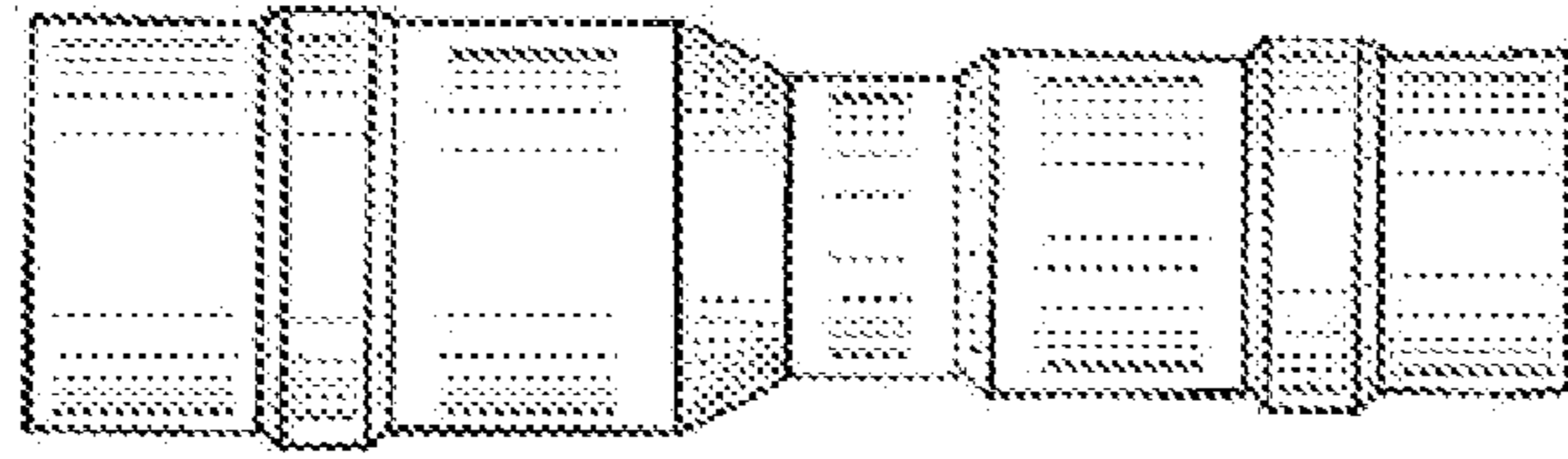
FIG. 4 is a right side or right end view of the portion of a pipe of FIG. 2.

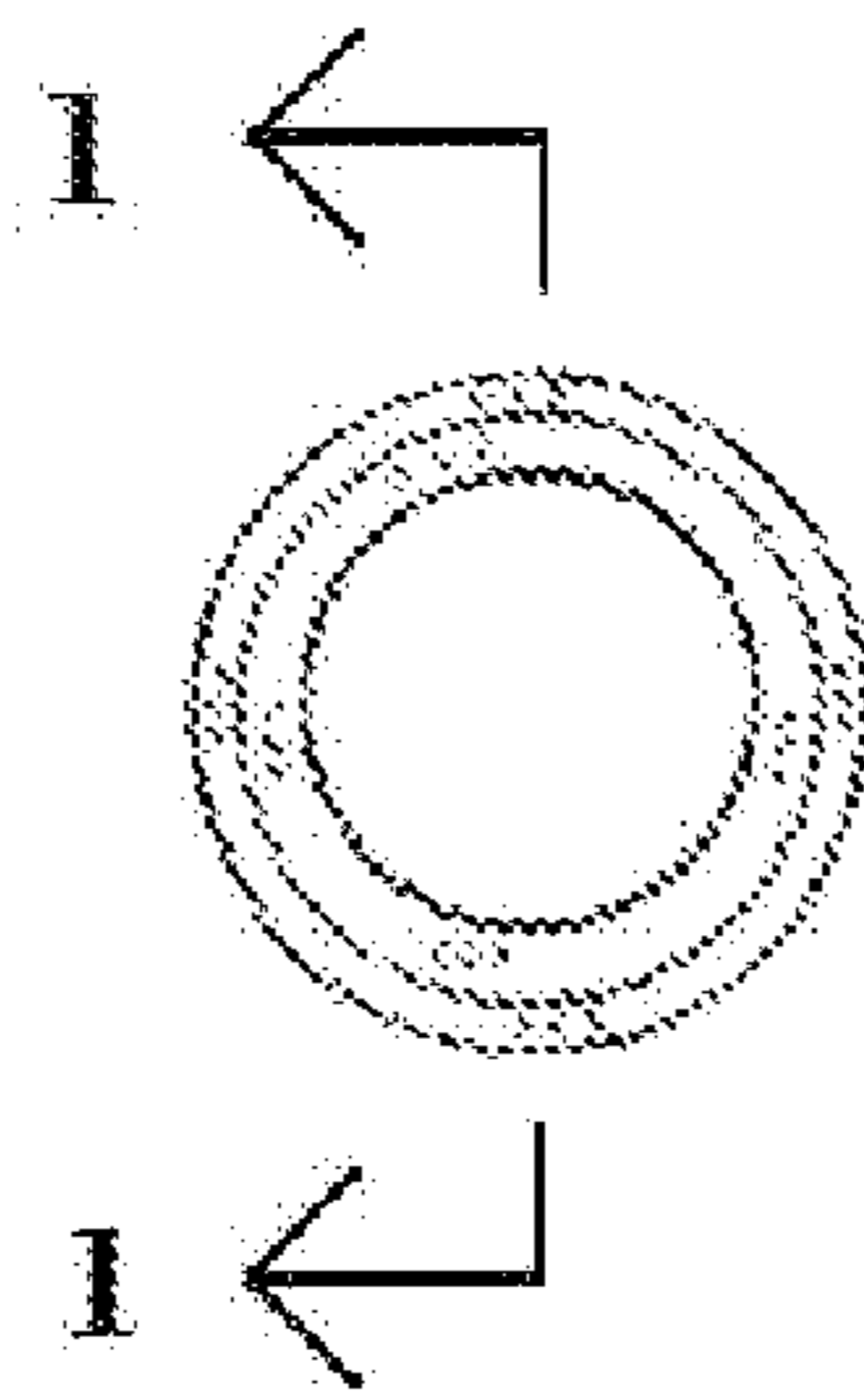




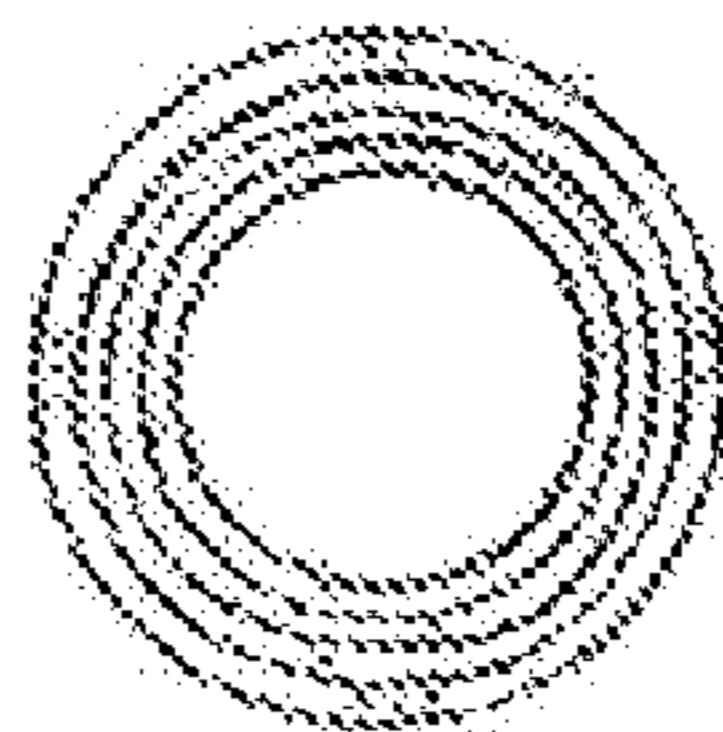
