The ornamental design for an air purifier housing, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a air purifier housing showing our new design.

FIG. 2 is a front view thereof.

FIG. 3 is a rear view thereof.

FIG. 4 is a left side view thereof, the right side view being a mirror image thereof.

FIG. 5 is a top view thereof; and,

FIG. 6 is a bottom view thereof.

The broken lines depict portions of the air purifier housing that form no part of the claimed design.

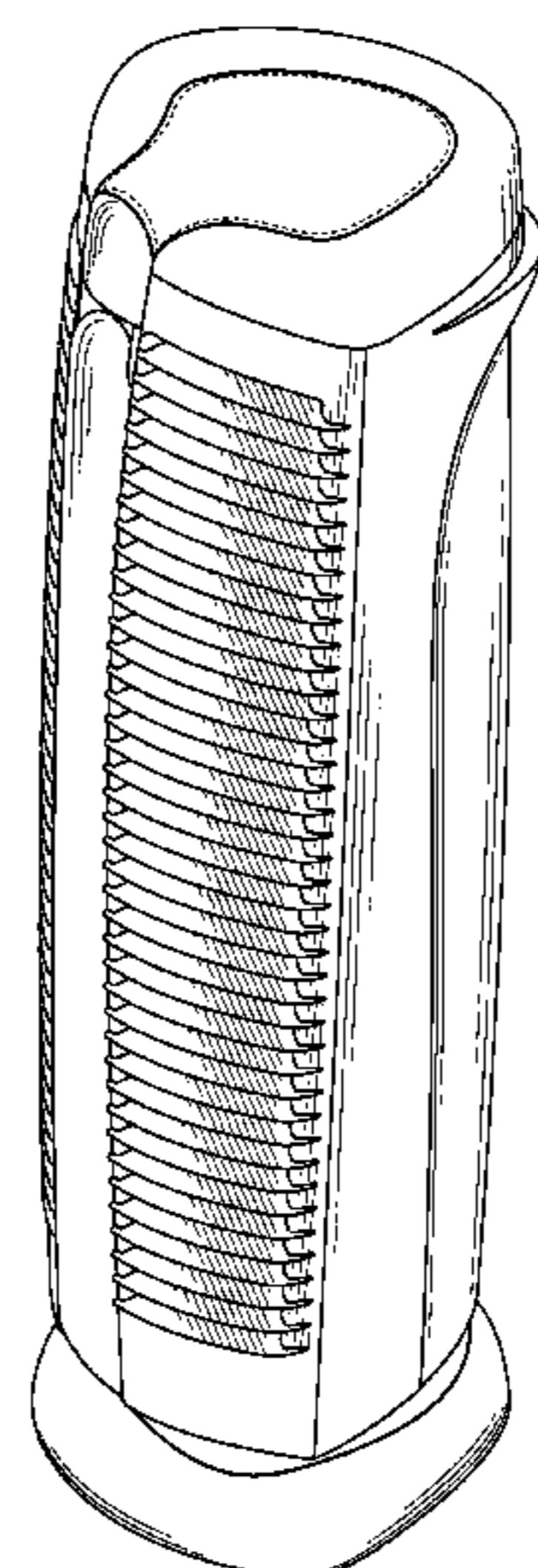

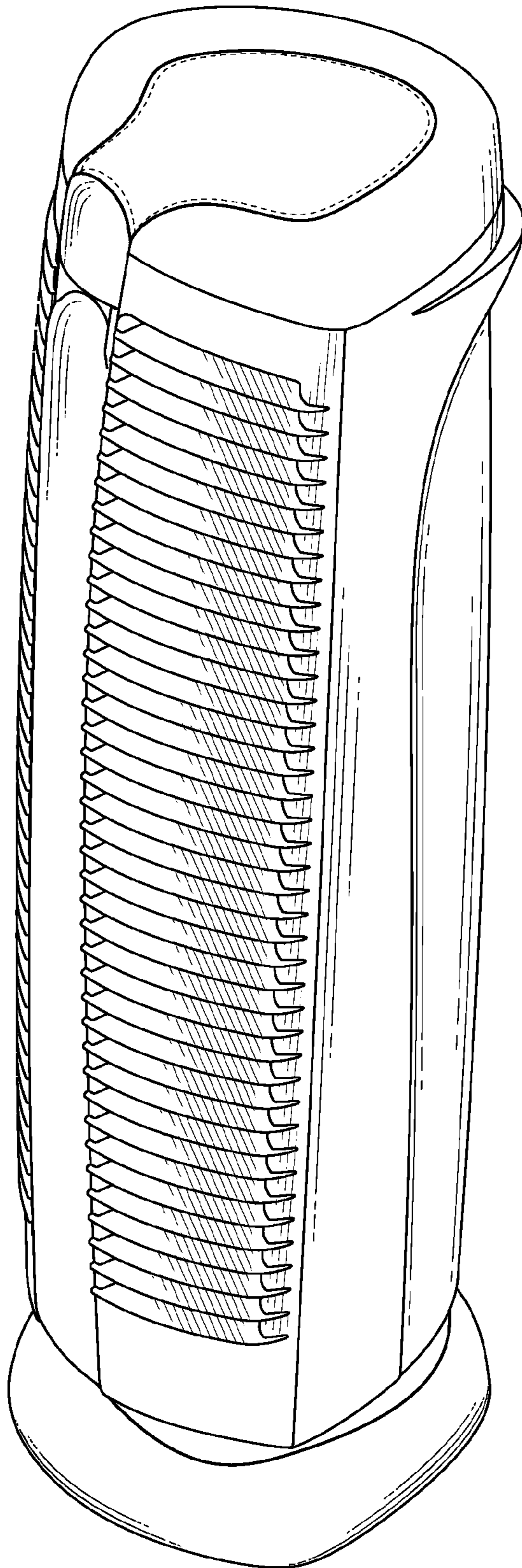

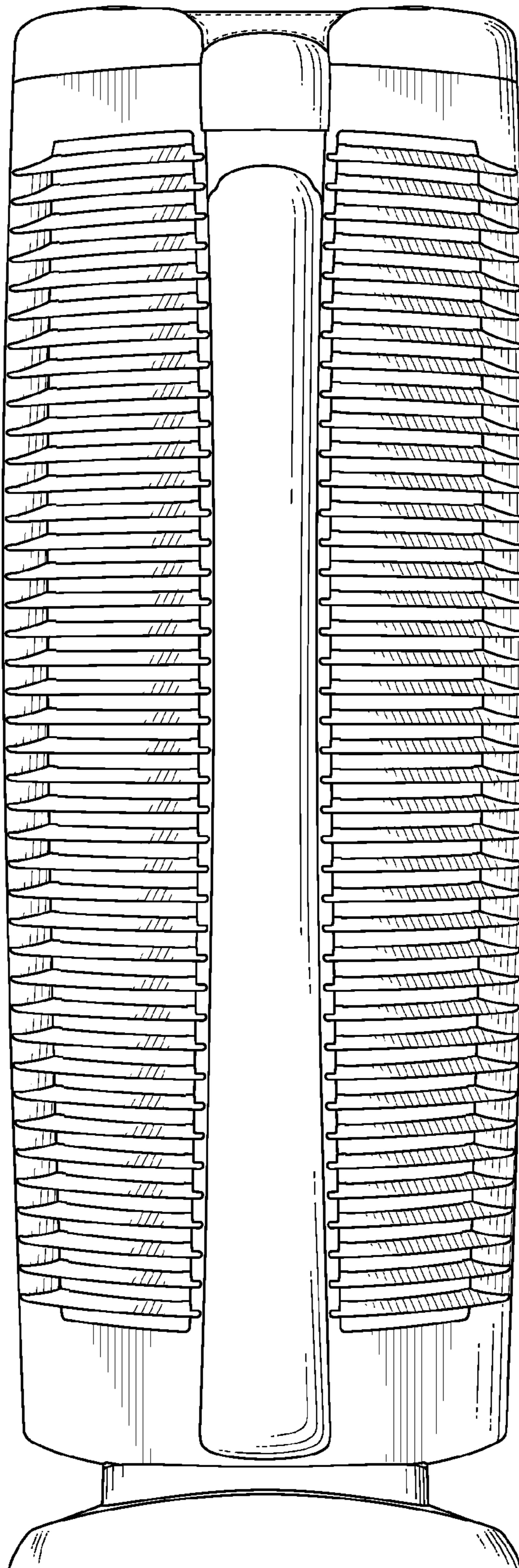

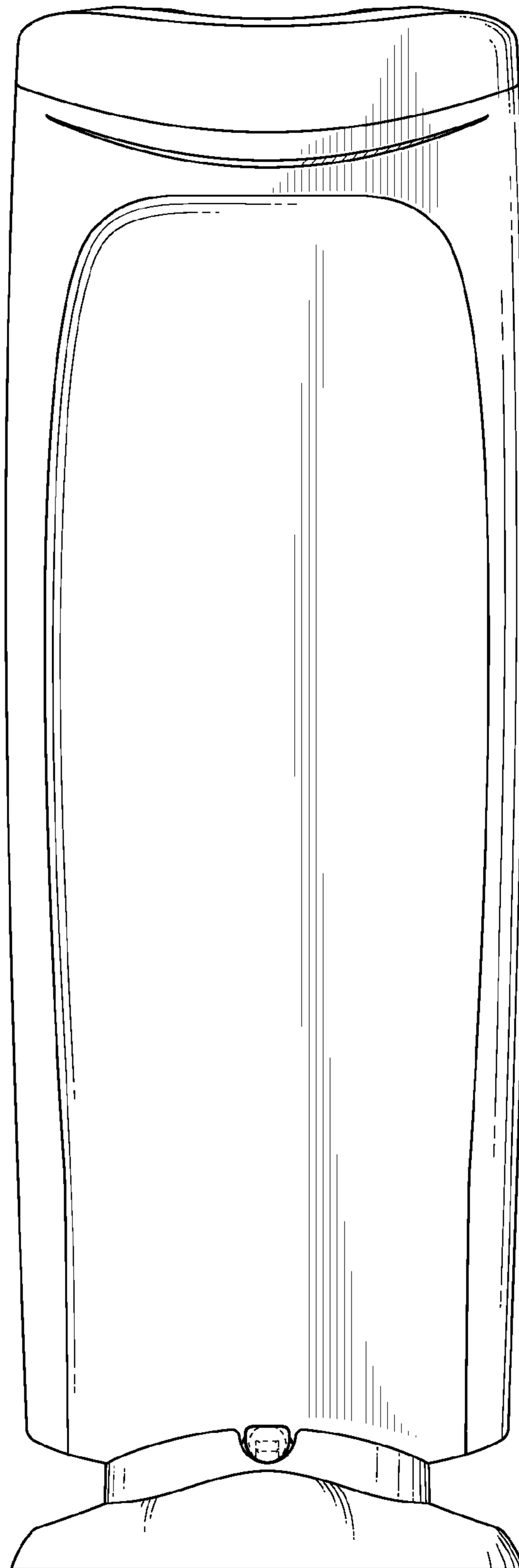

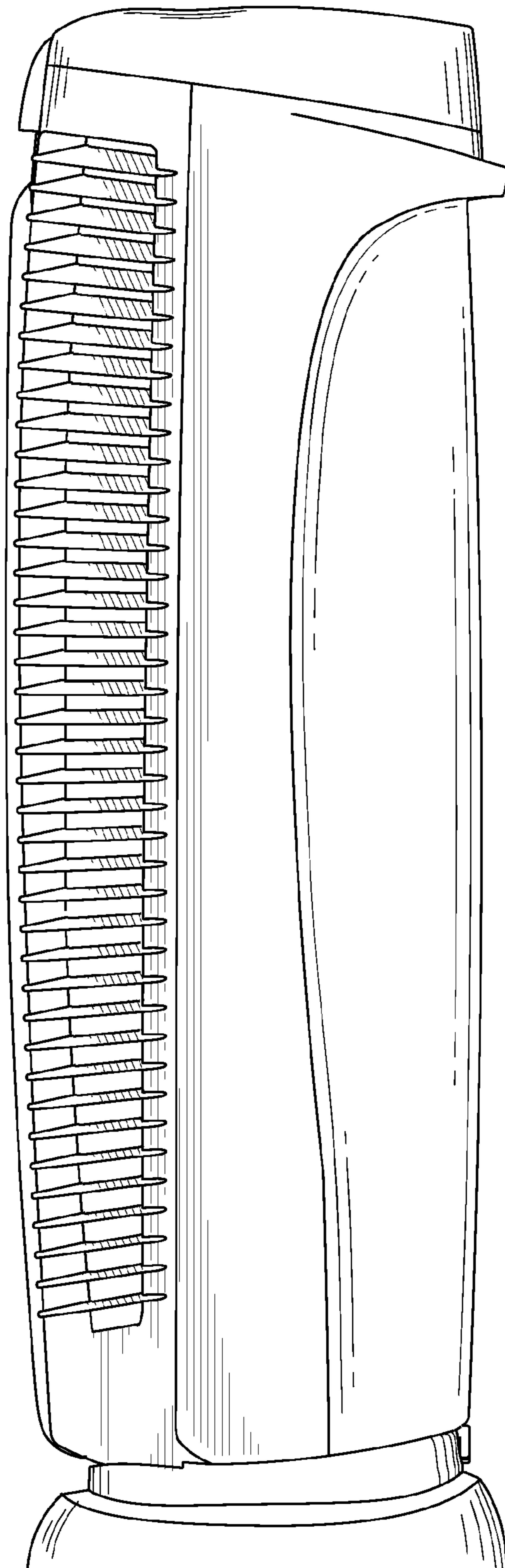

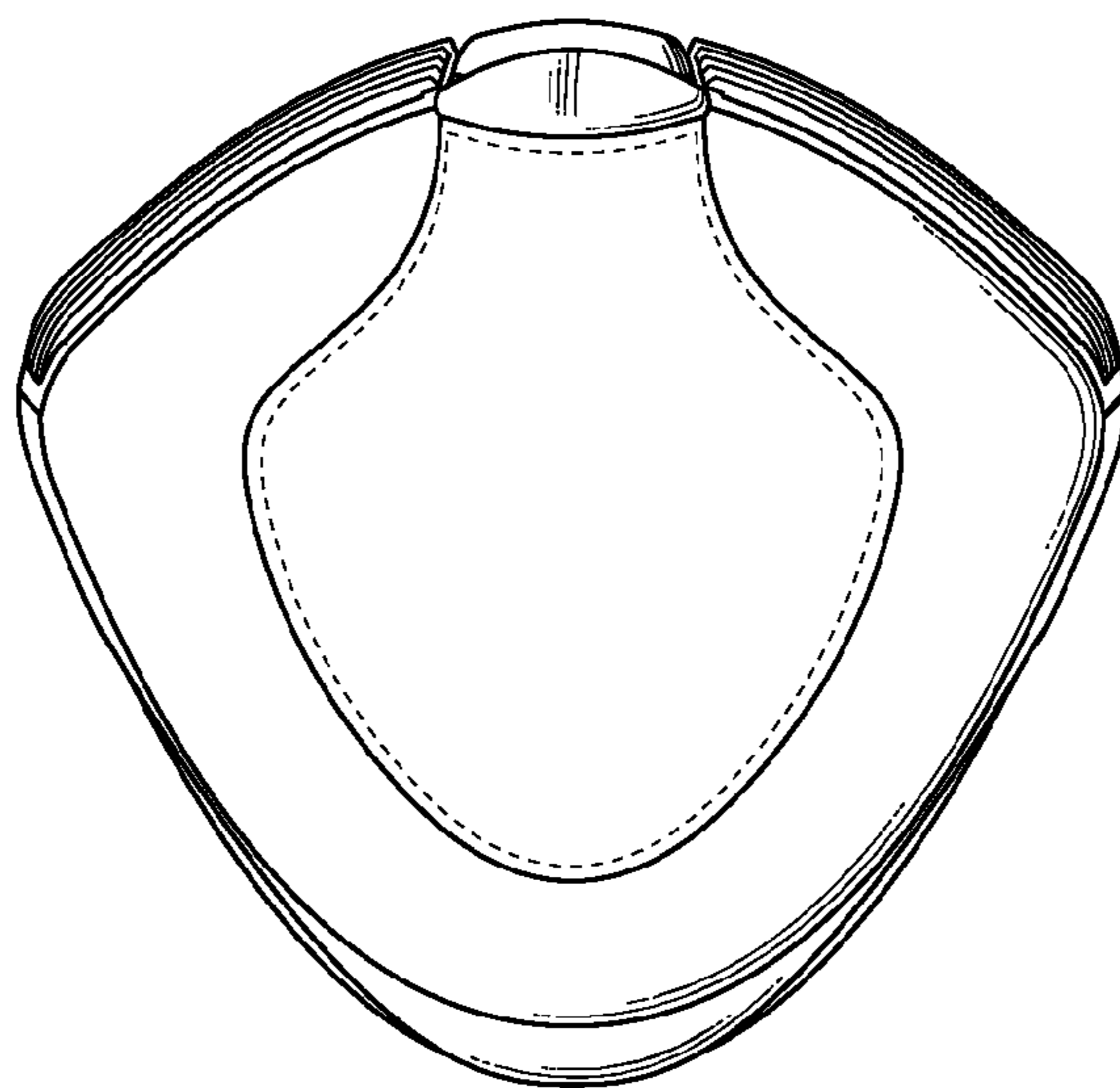
