(57) **CLAIM**

I claim the ornamental design for a corner piece, as shown herein.

DESCRIPTION

FIG. 1 is a bottom perspective view of an exterior of a corner piece illustrating shake siding elements,

FIG. 2 is a left side view of the exterior of the corner piece of FIG. 1,

FIG. 3 is a right side view of an interior of the corner piece of FIG. 1,

FIG. 4 is a right side view of the exterior of the corner piece of FIG. 1,

FIG. 5 is a left side view of the interior of the corner piece of FIG. 1,

FIG. 6 is a bottom perspective view of the interior of the corner piece of FIG. 1,

FIG. 7 is a top view of the corner piece of FIG. 1,

FIG. 8 is a bottom view of the corner piece of FIG. 1,

FIG. 9 is a bottom perspective view of a second embodiment of the design shown in FIGS. 1-8, the only differences residing in the length of the shake siding elements of the corner piece and the number of shake siding elements shown,

FIG. 10 is a left side view of the exterior of the corner piece of FIG. 9,

FIG. 11 is a right side view of an interior of the corner piece of FIG. 9,

FIG. 12 is a right side view of the exterior of the corner piece of FIG. 9,

FIG. 13 is a left side view of the interior of the corner piece of FIG. 9,

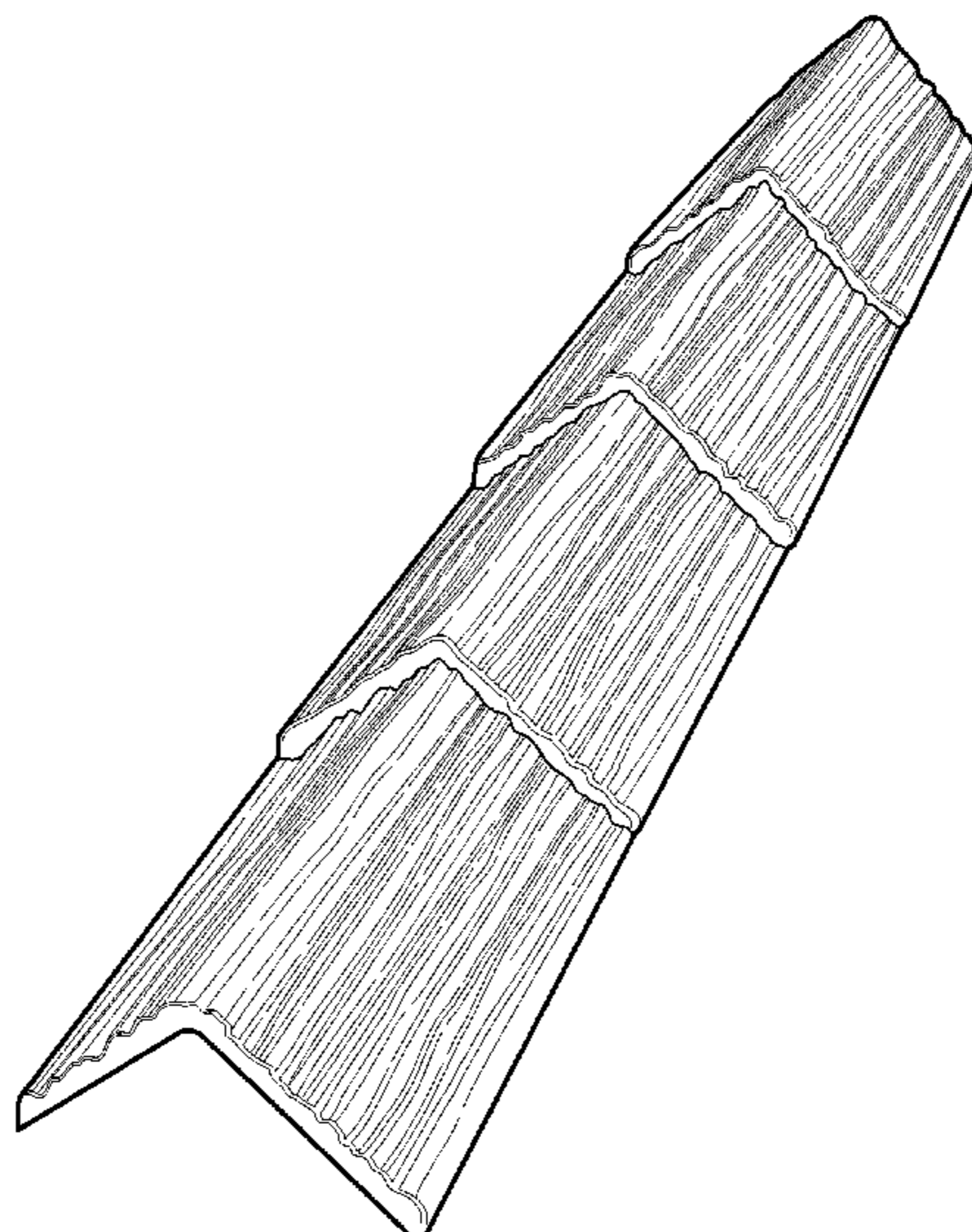
FIG. 14 is a bottom perspective view of the interior of the corner piece of FIG. 9,

FIG. 15 is a top view of the corner piece of FIG. 9; and,

FIG. 16 is a bottom view of the corner piece of FIG. 9.

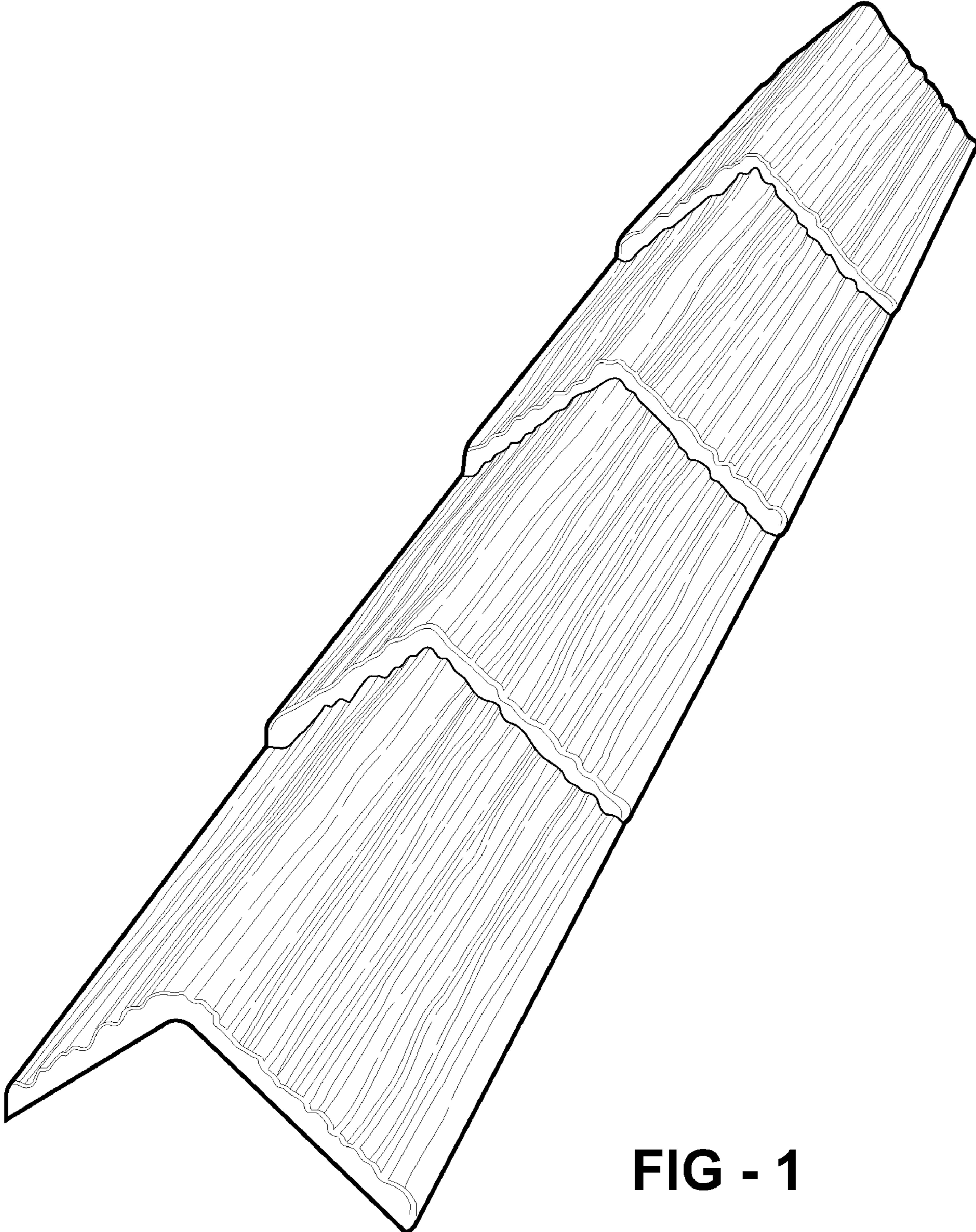

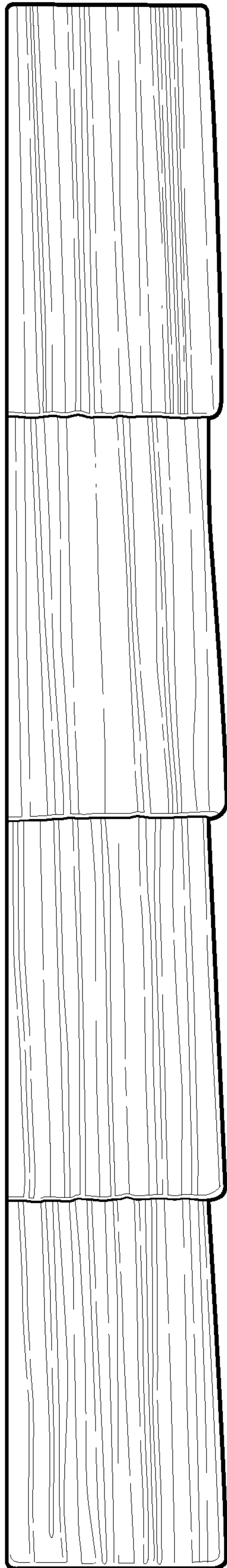

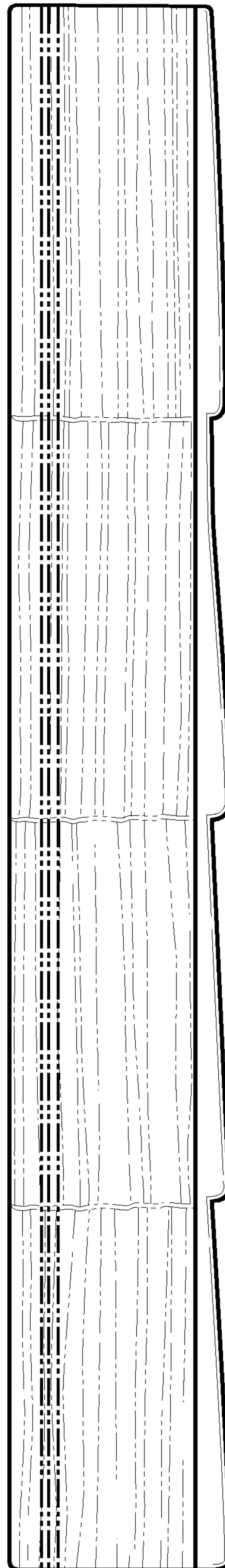

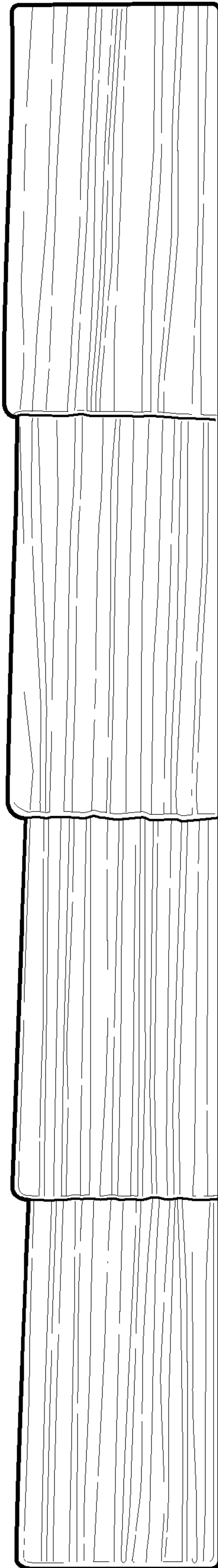

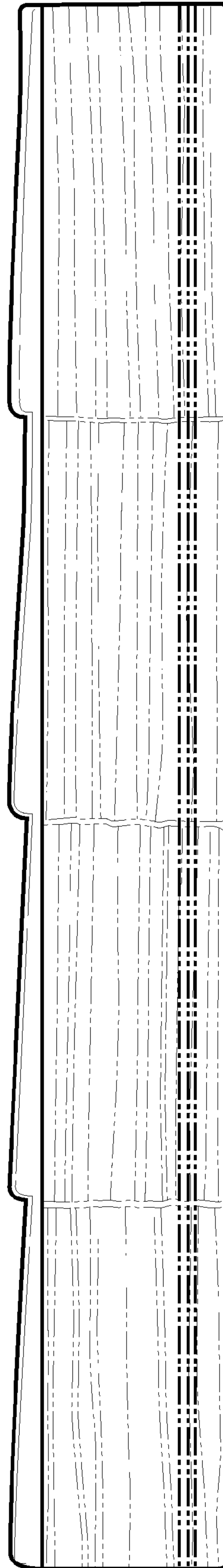
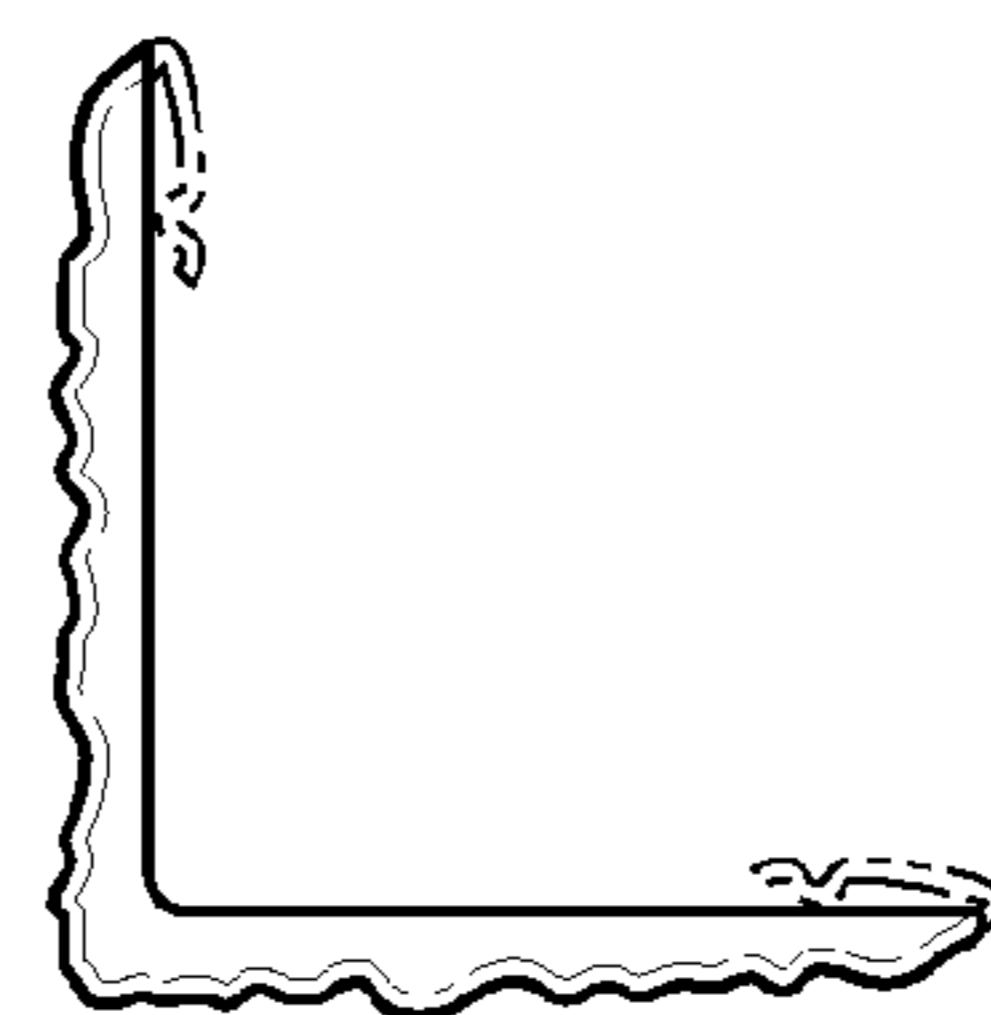
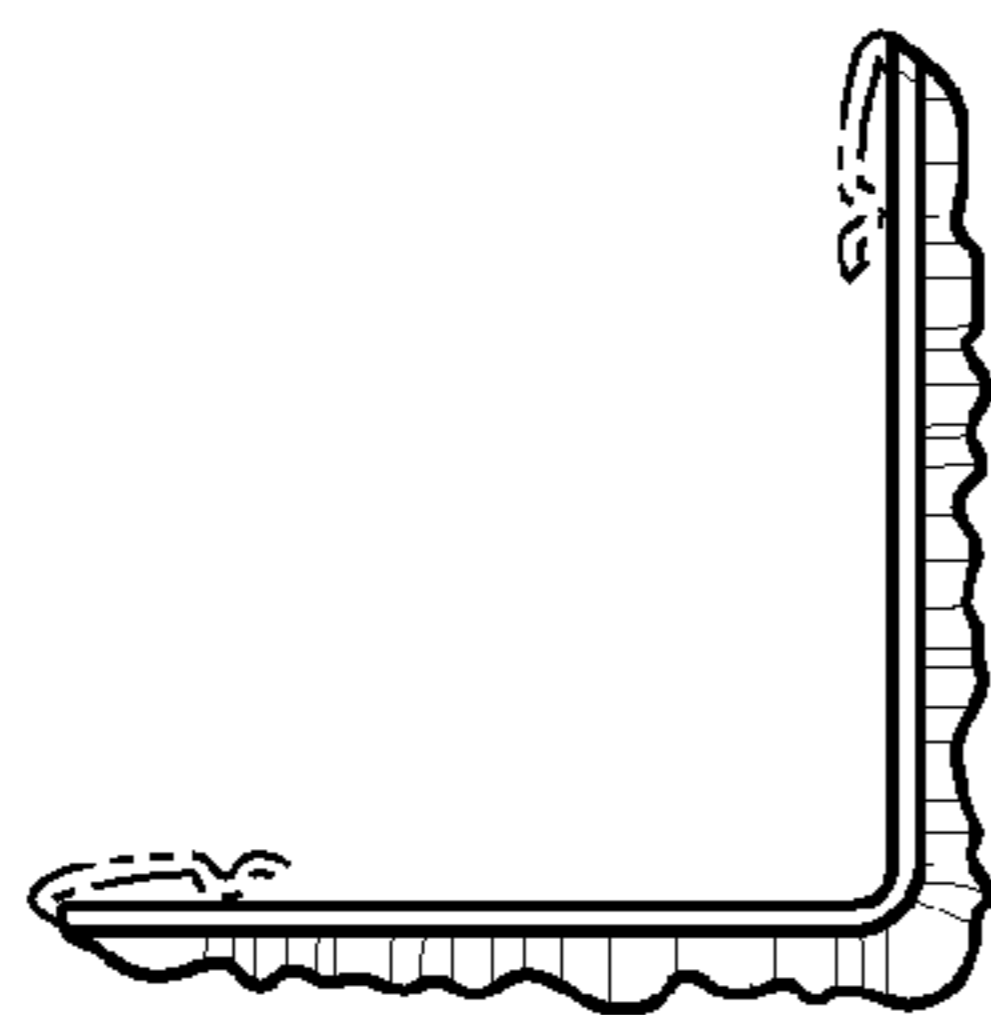
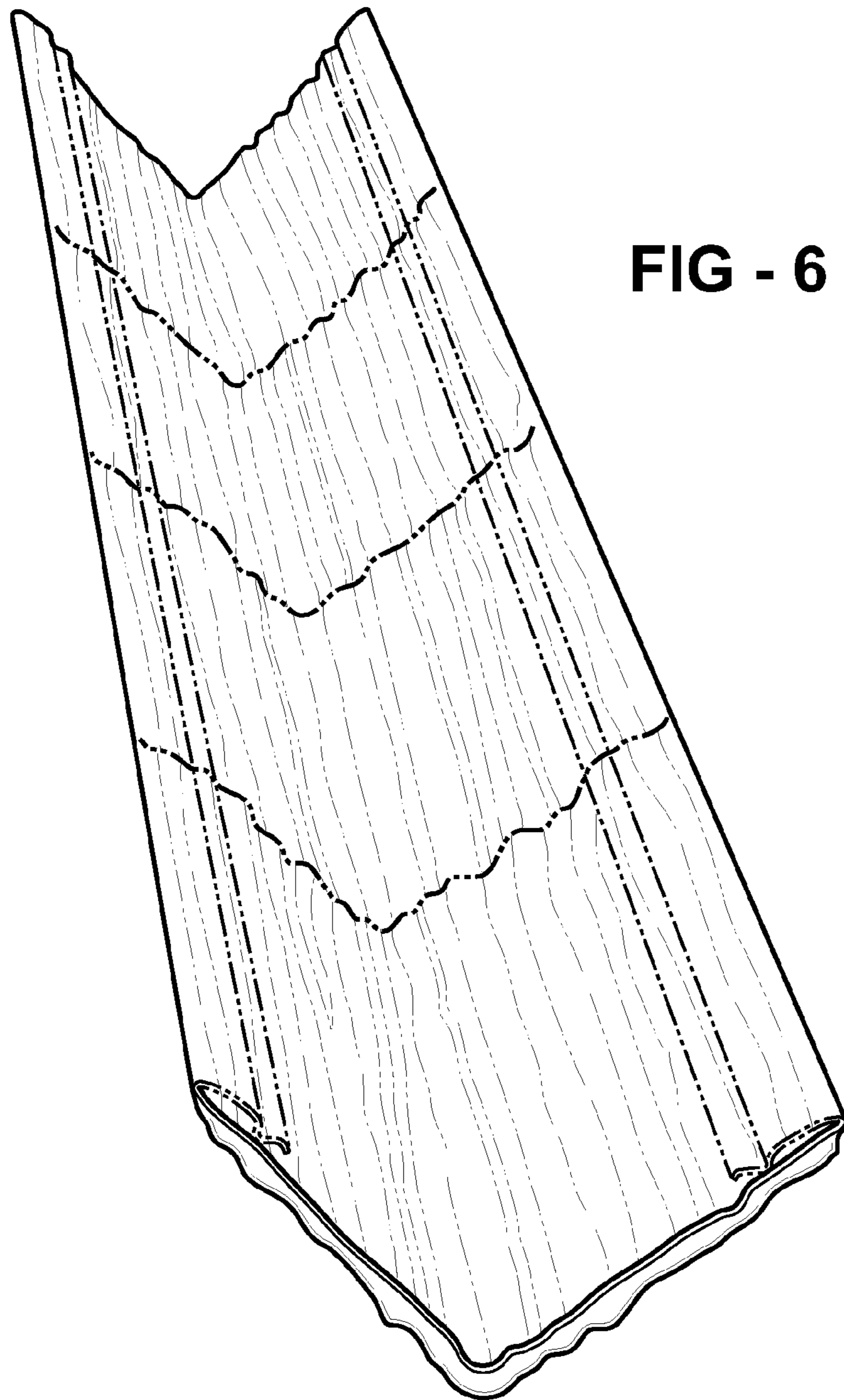

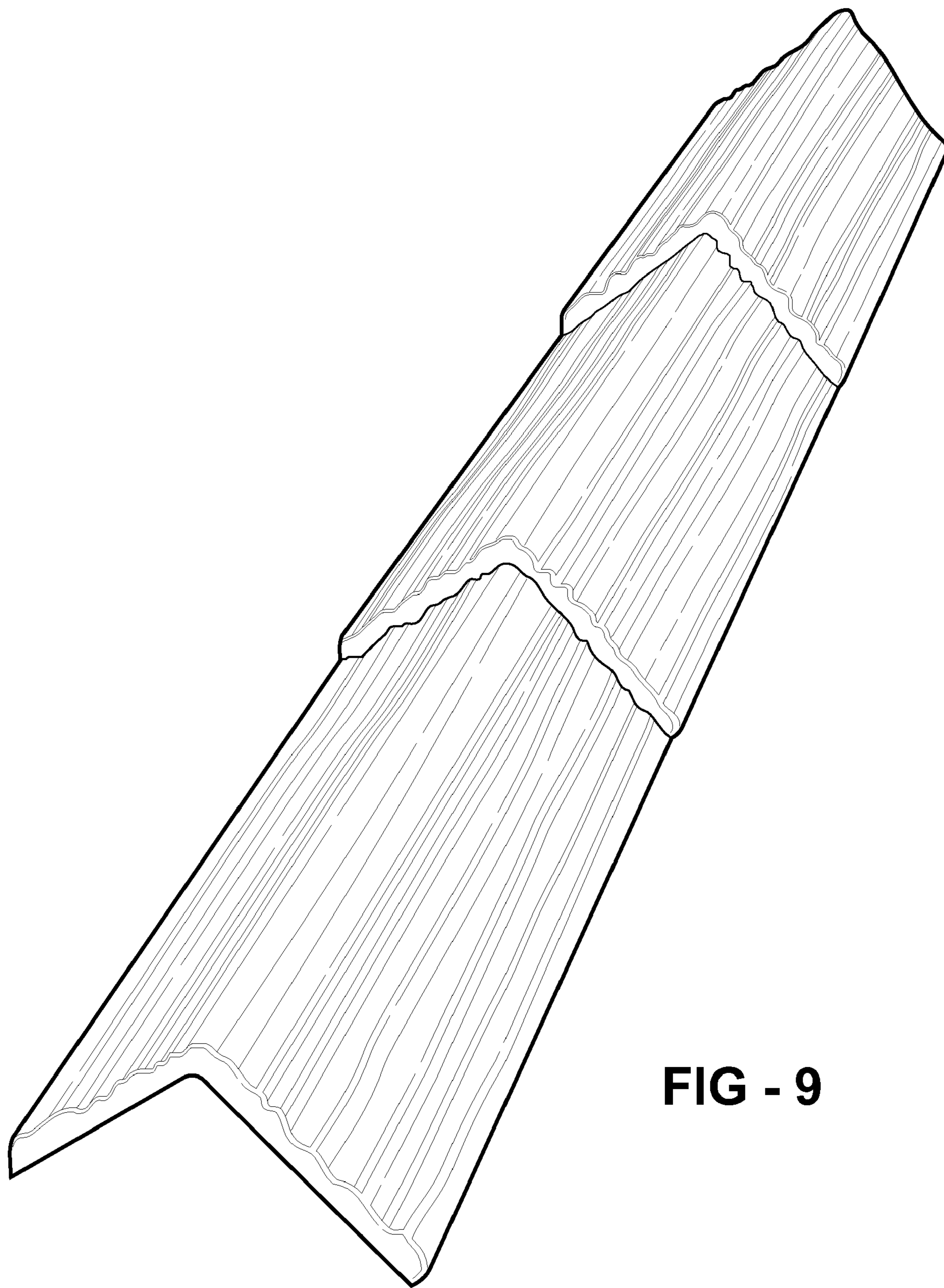

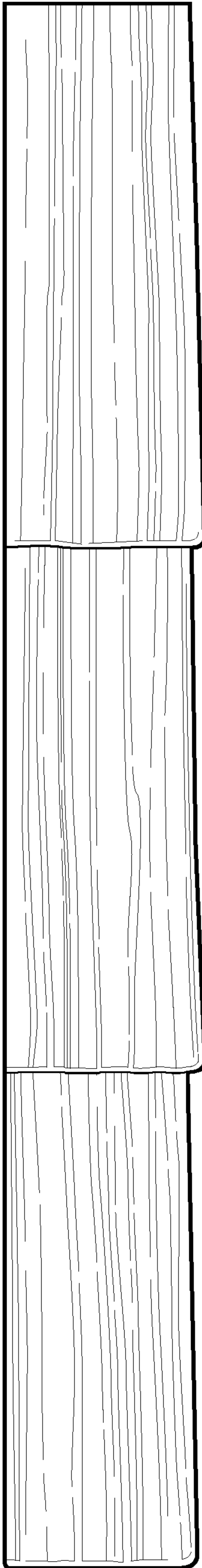

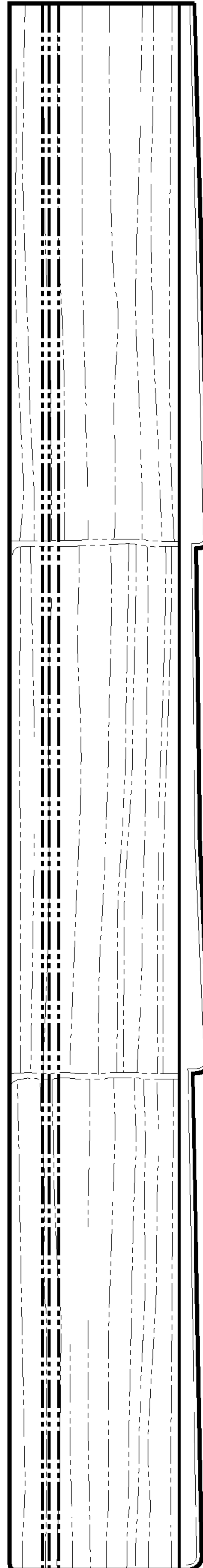

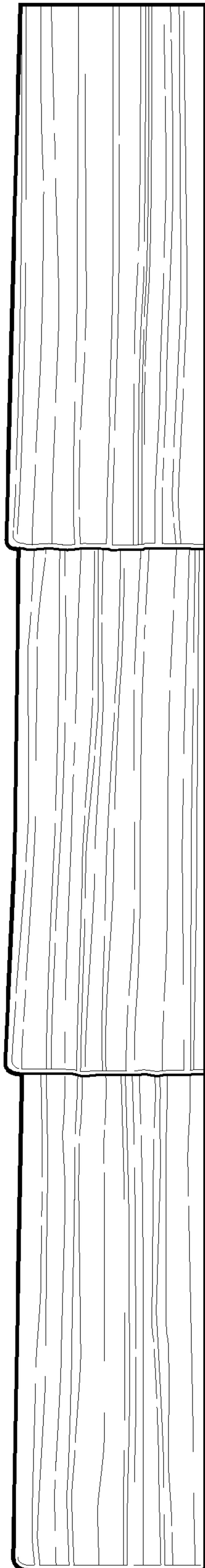

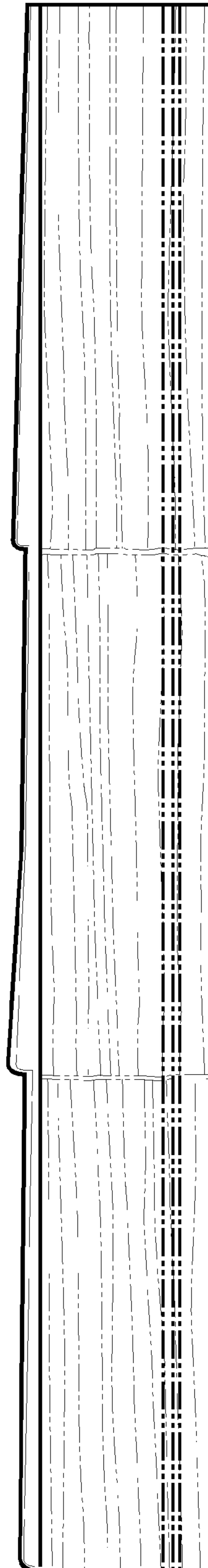

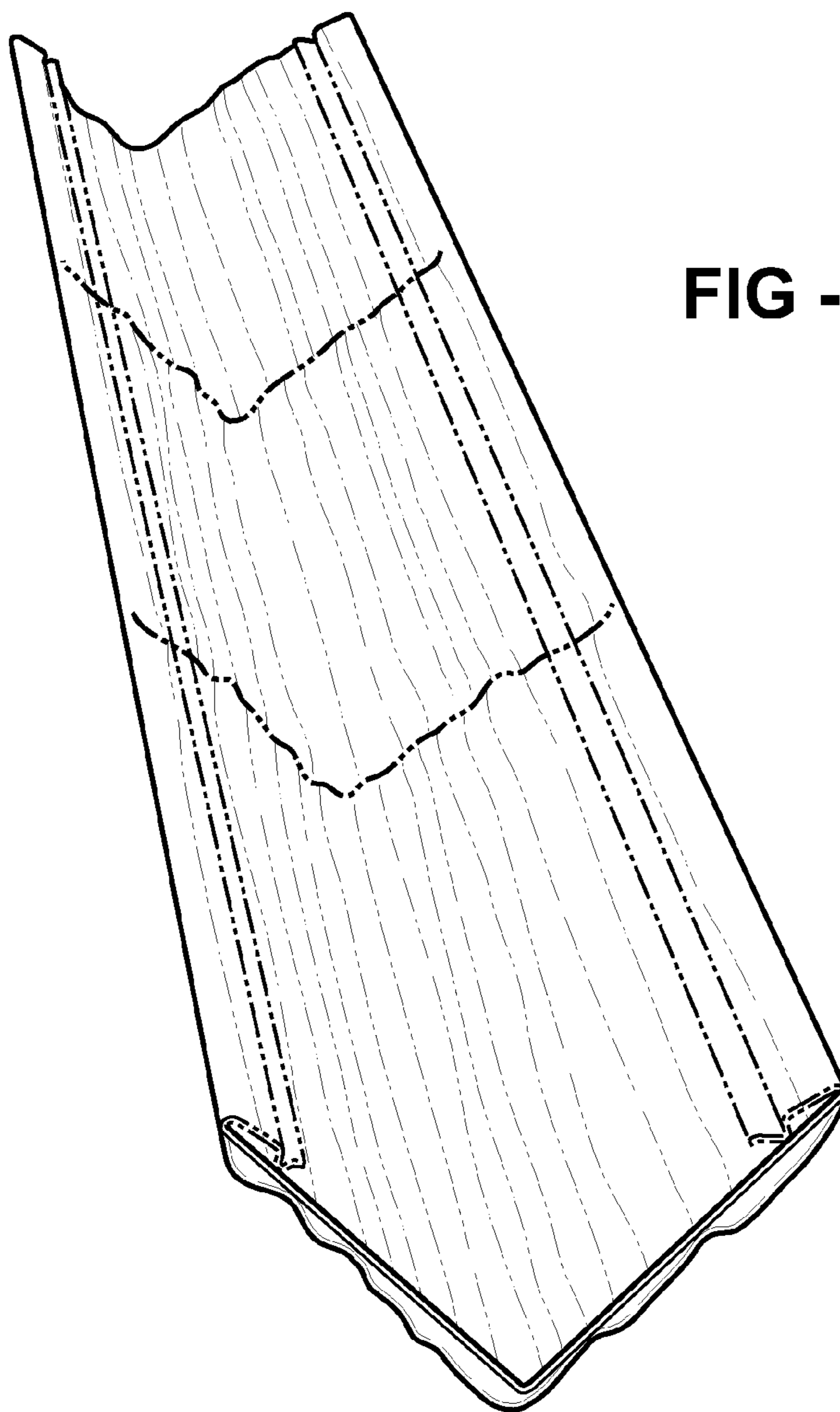

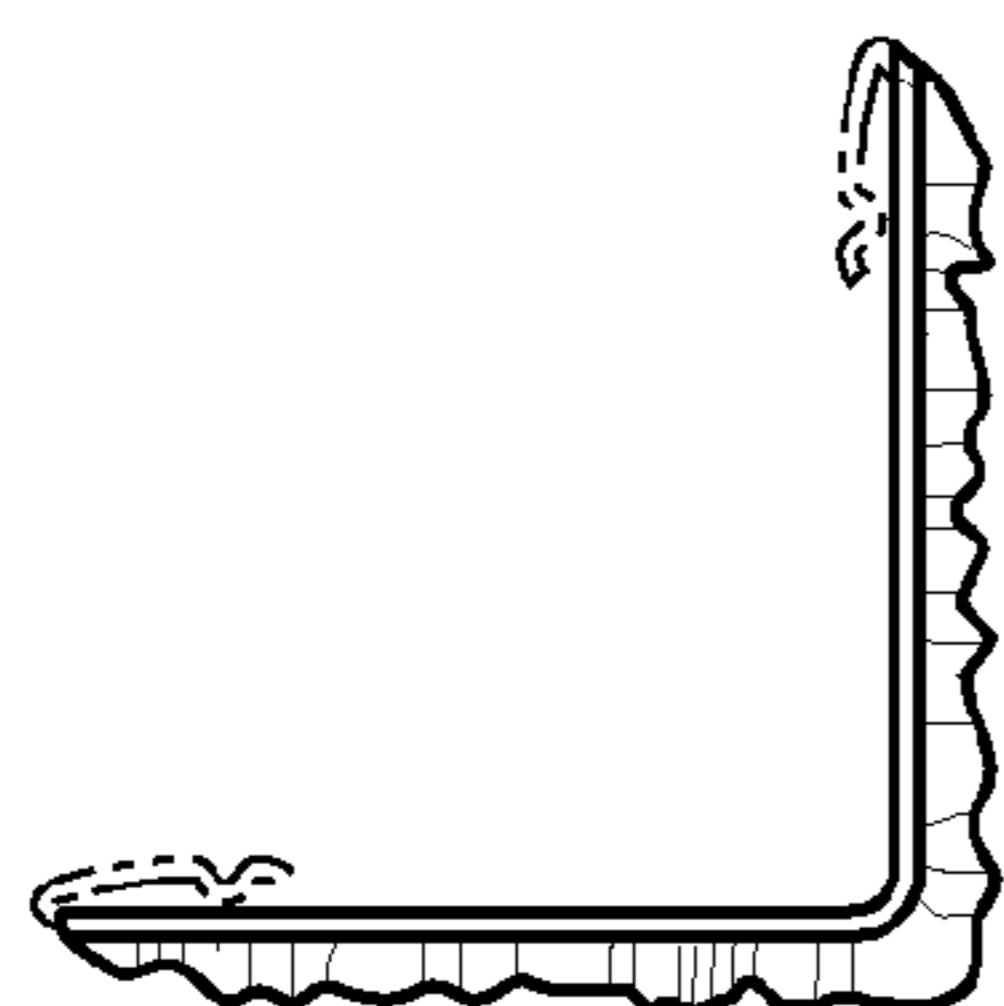

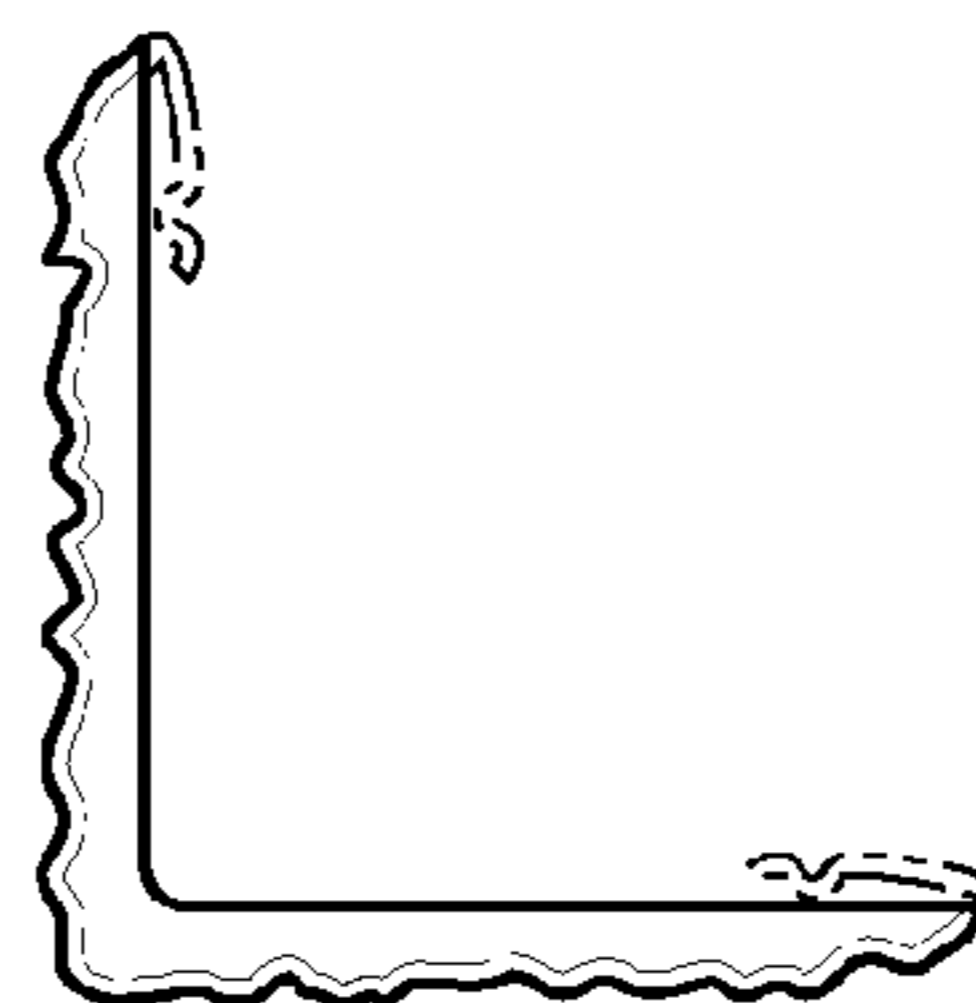
