FIG. 4 is a bottom elevational view of the cover for a remote device;

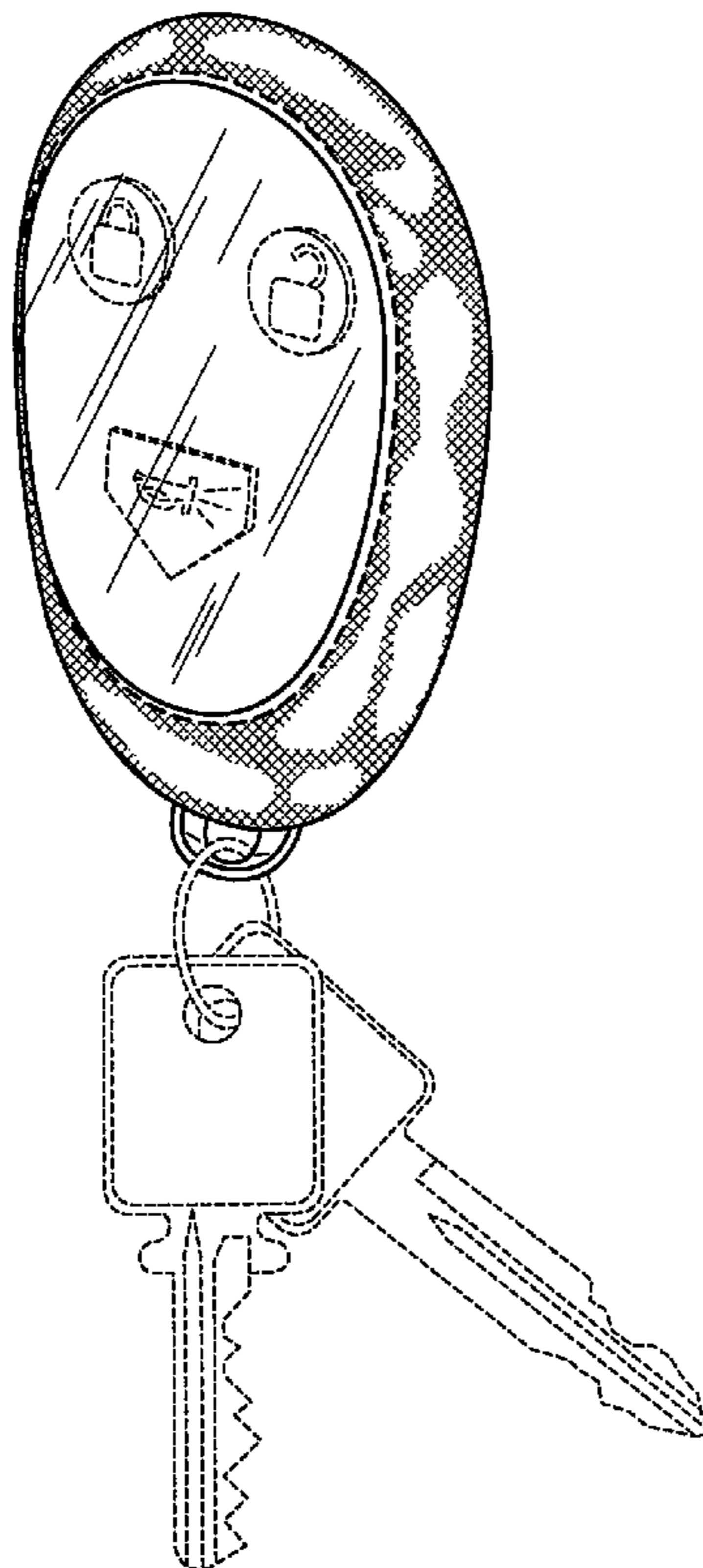
FIG. 5 is a top elevational view of the cover for a remote device;

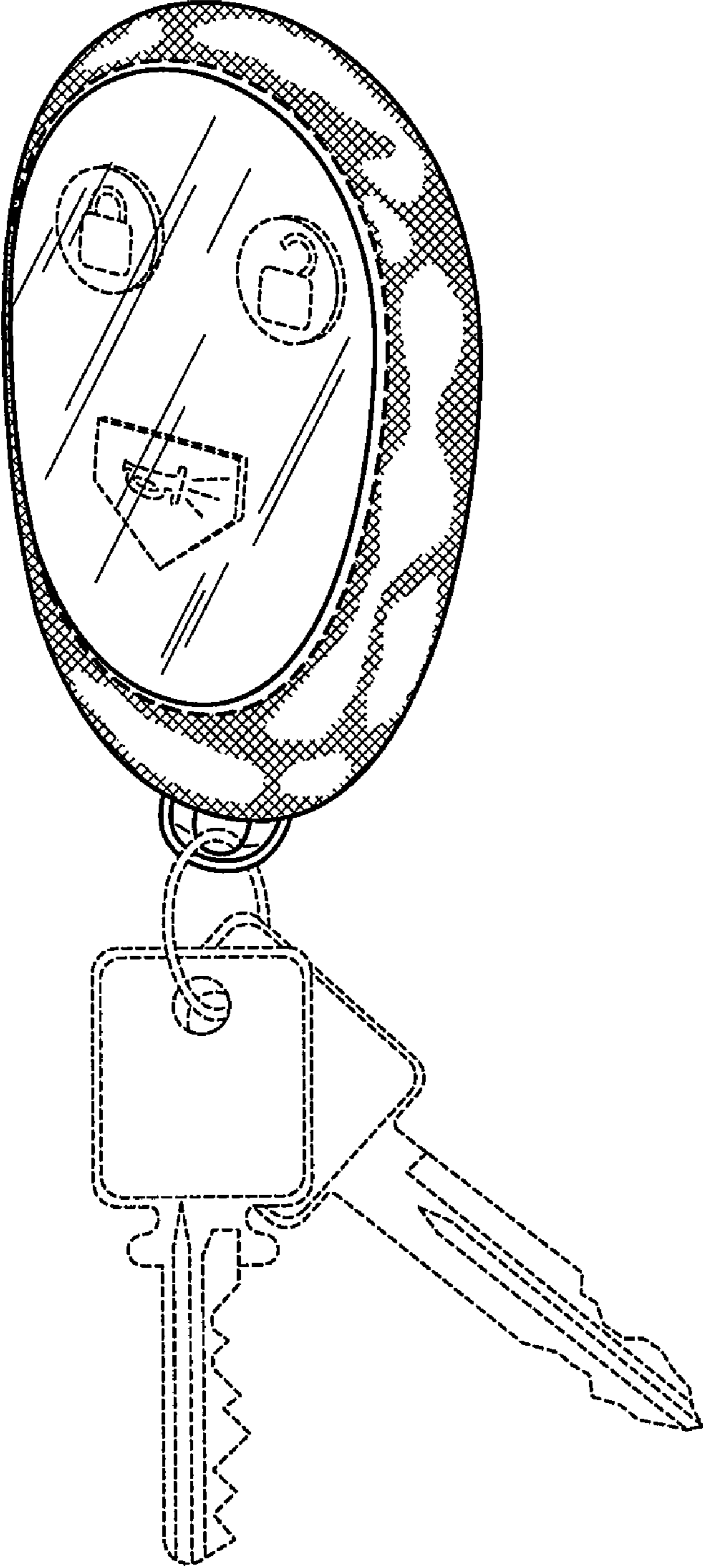
FIG. 6 is a right elevational view of the cover for a remote device; and,

FIG. 7 is a left elevational view of the cover for a remote device.

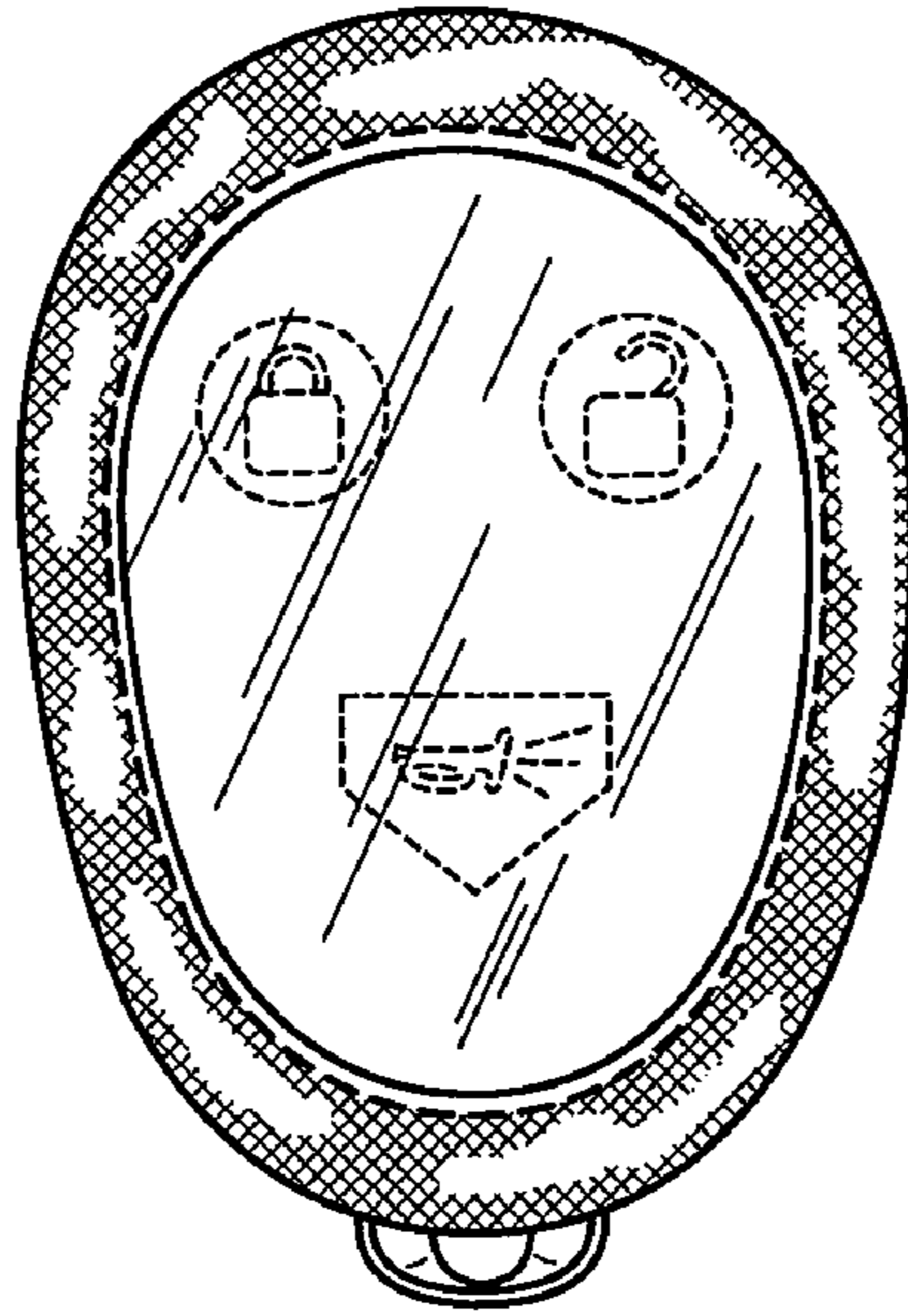

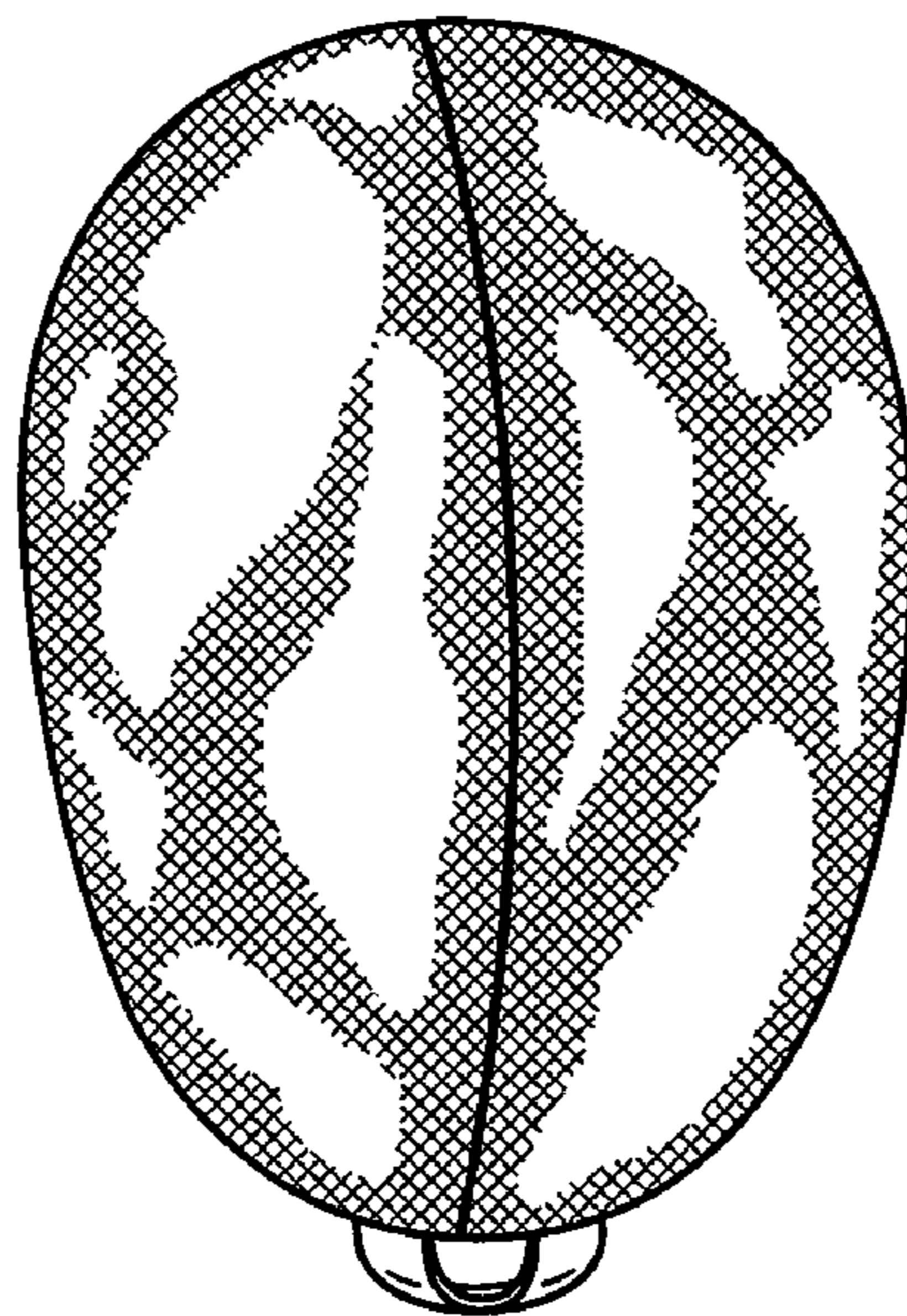




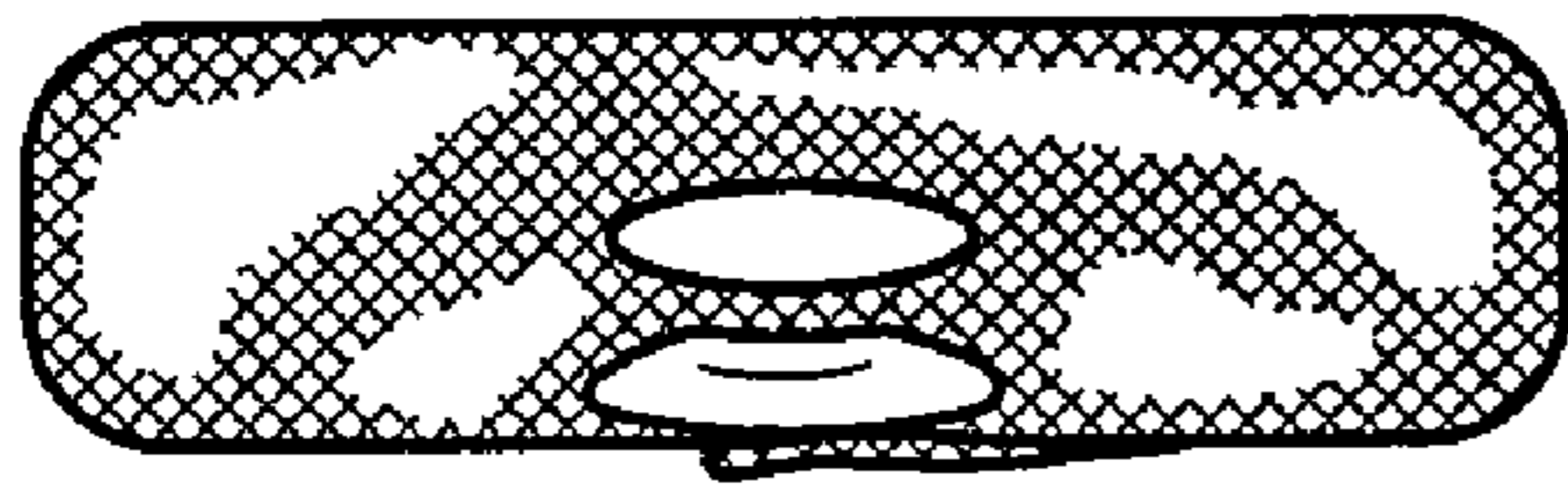

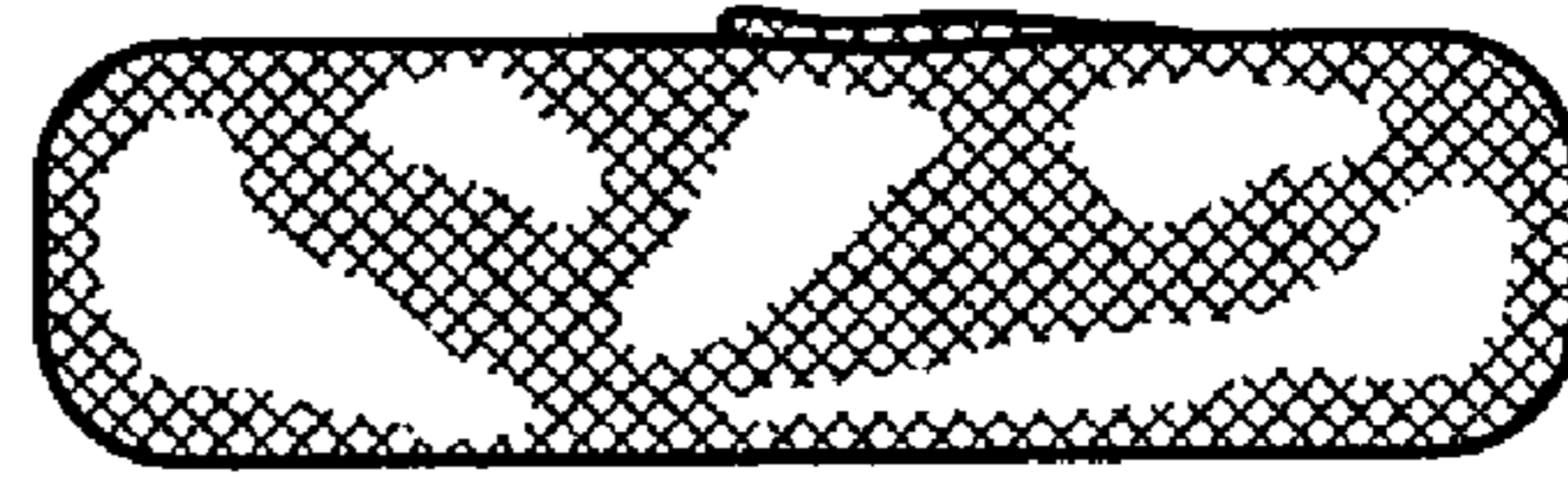

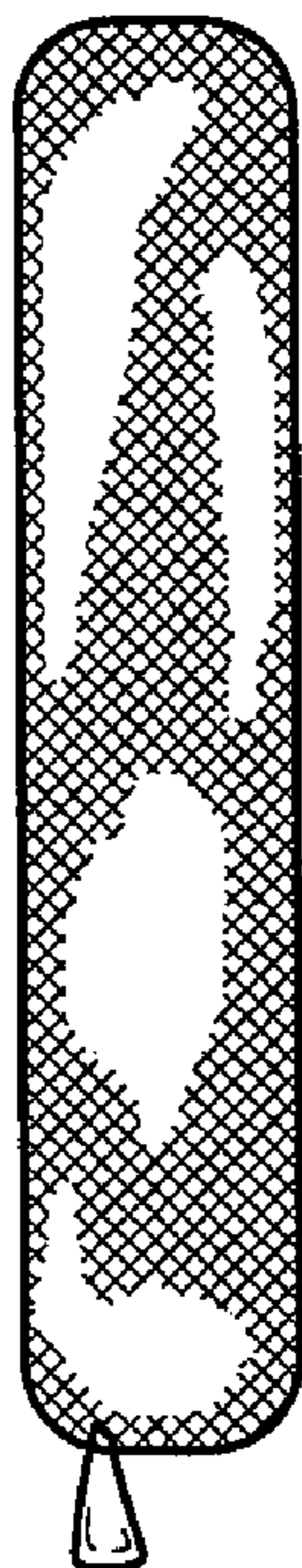

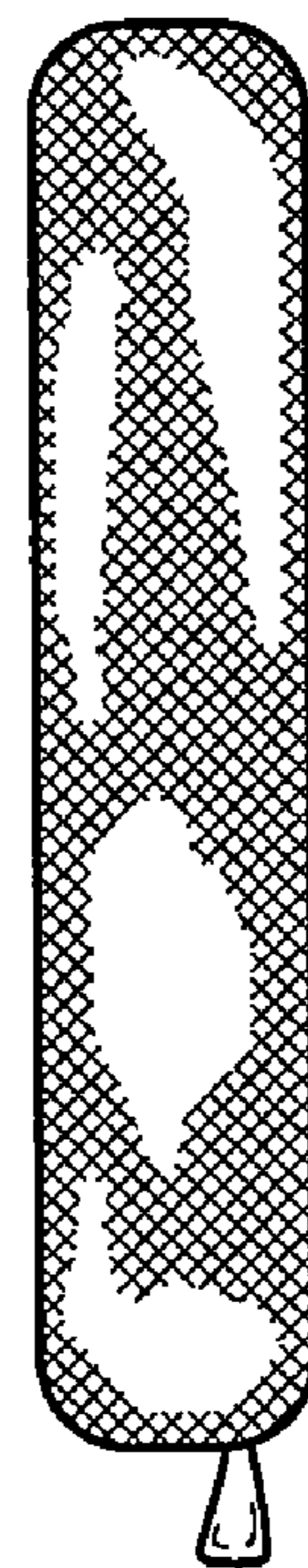
