FIG. 5 is a second end view of the design therefor;

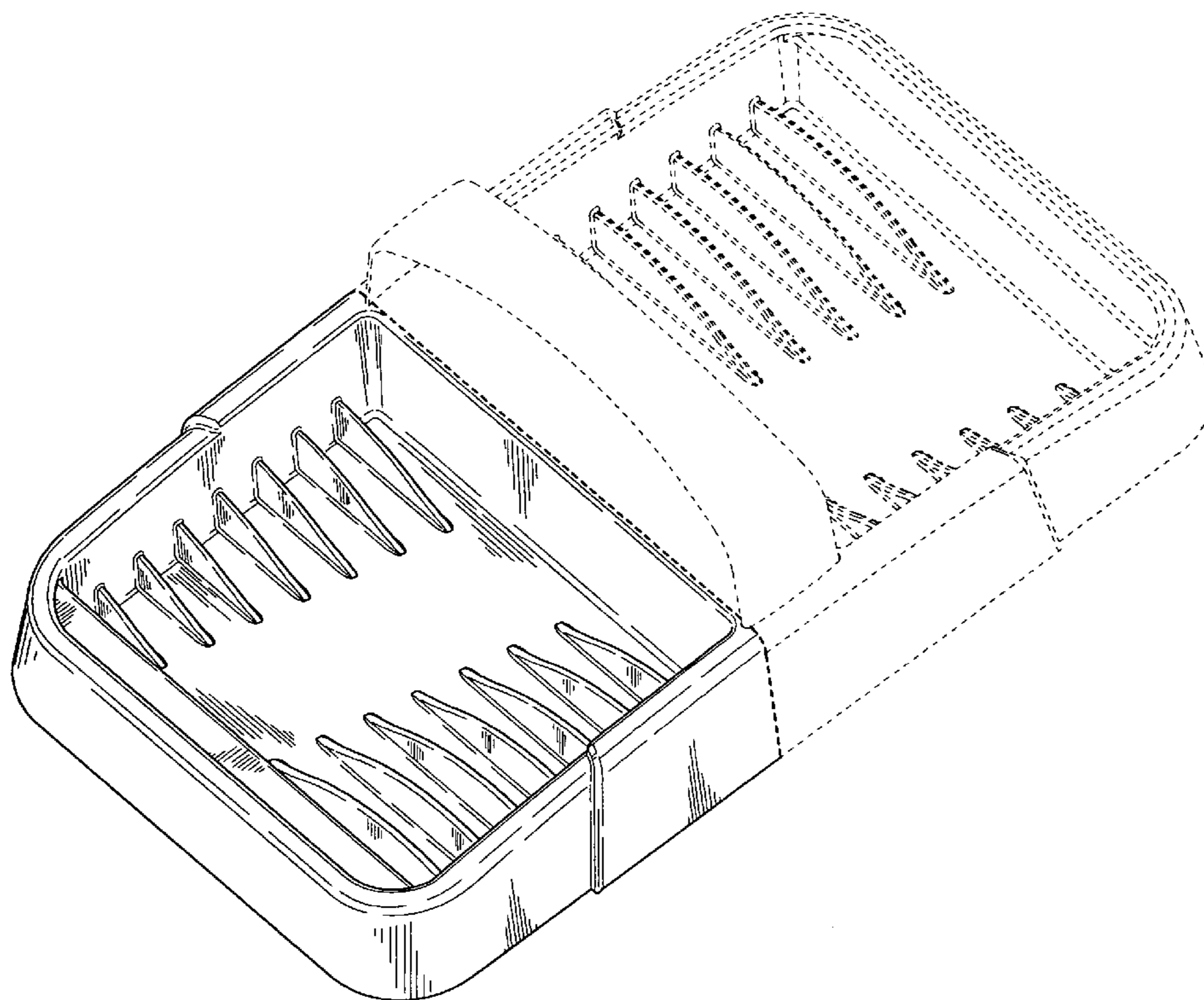
FIG. 6 is a side view of the design therefor mirrored on the opposing side;

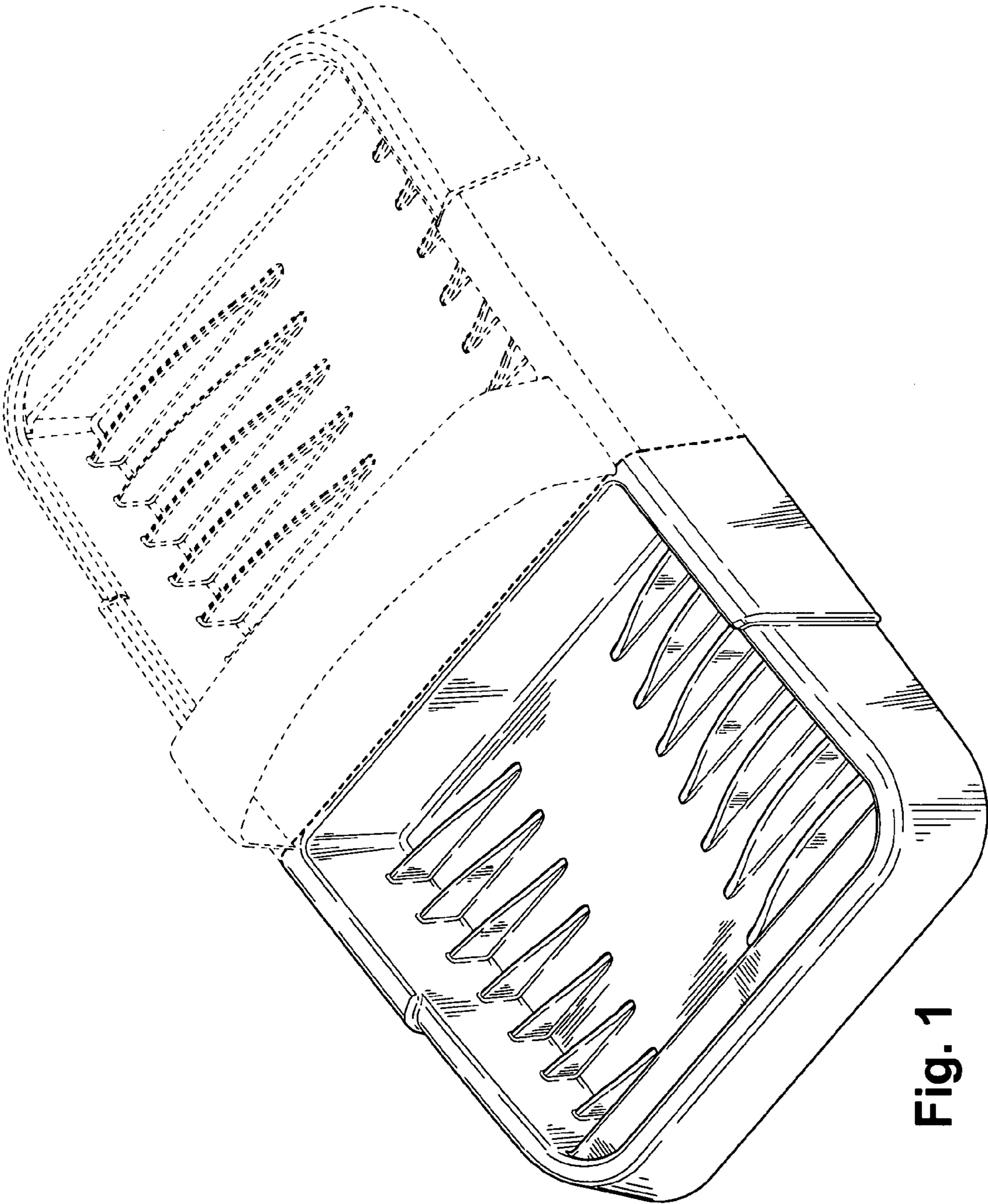

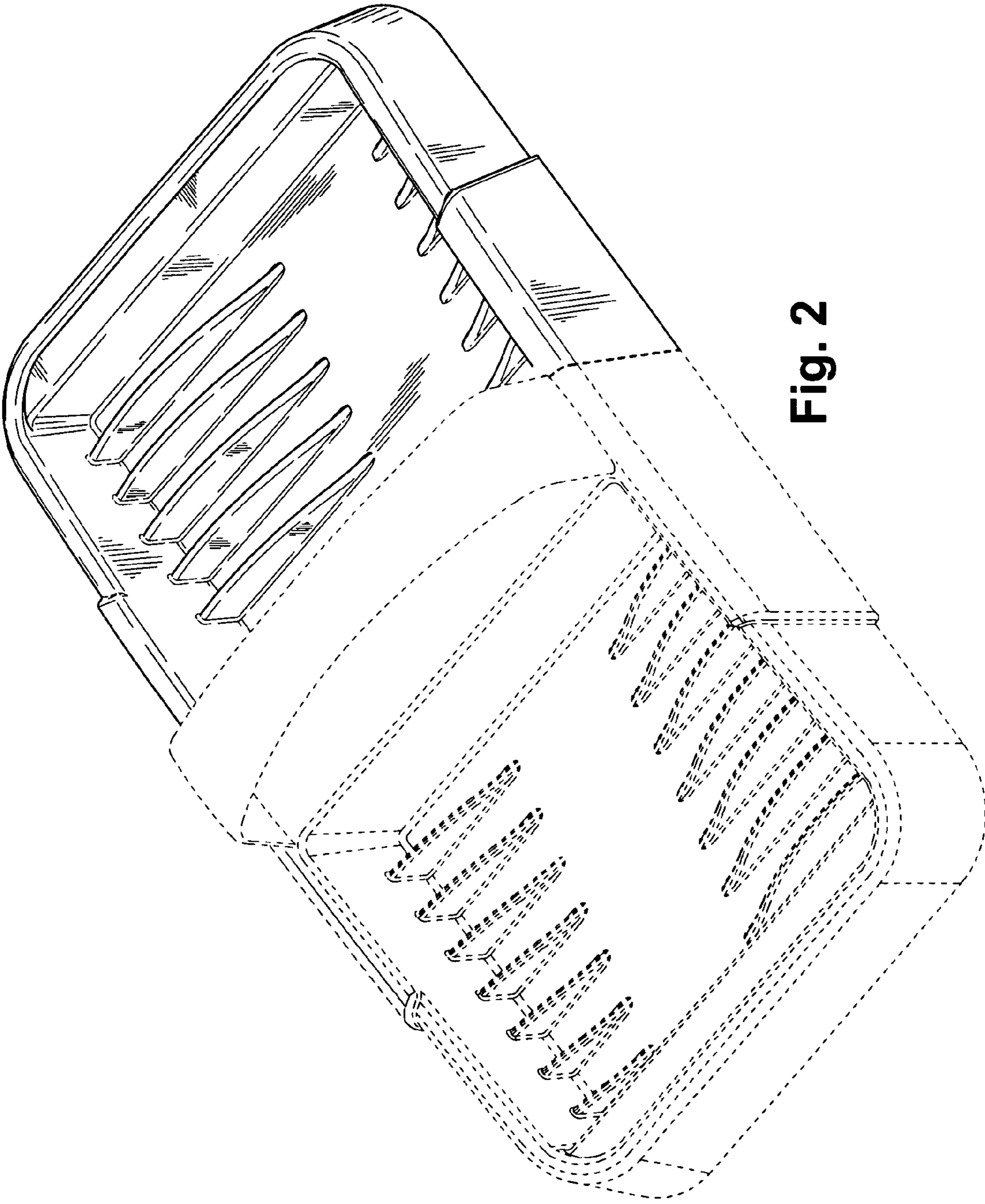

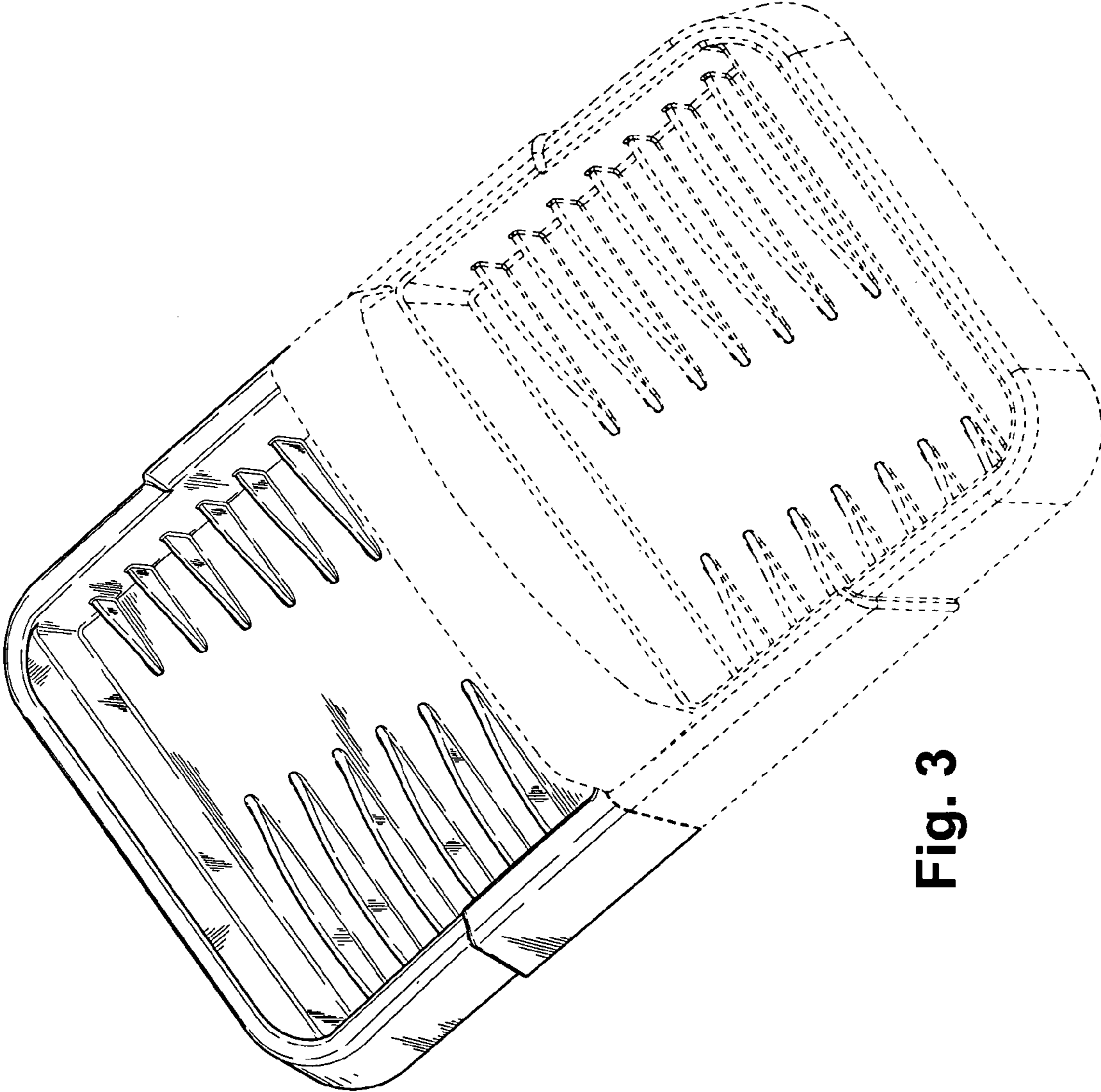

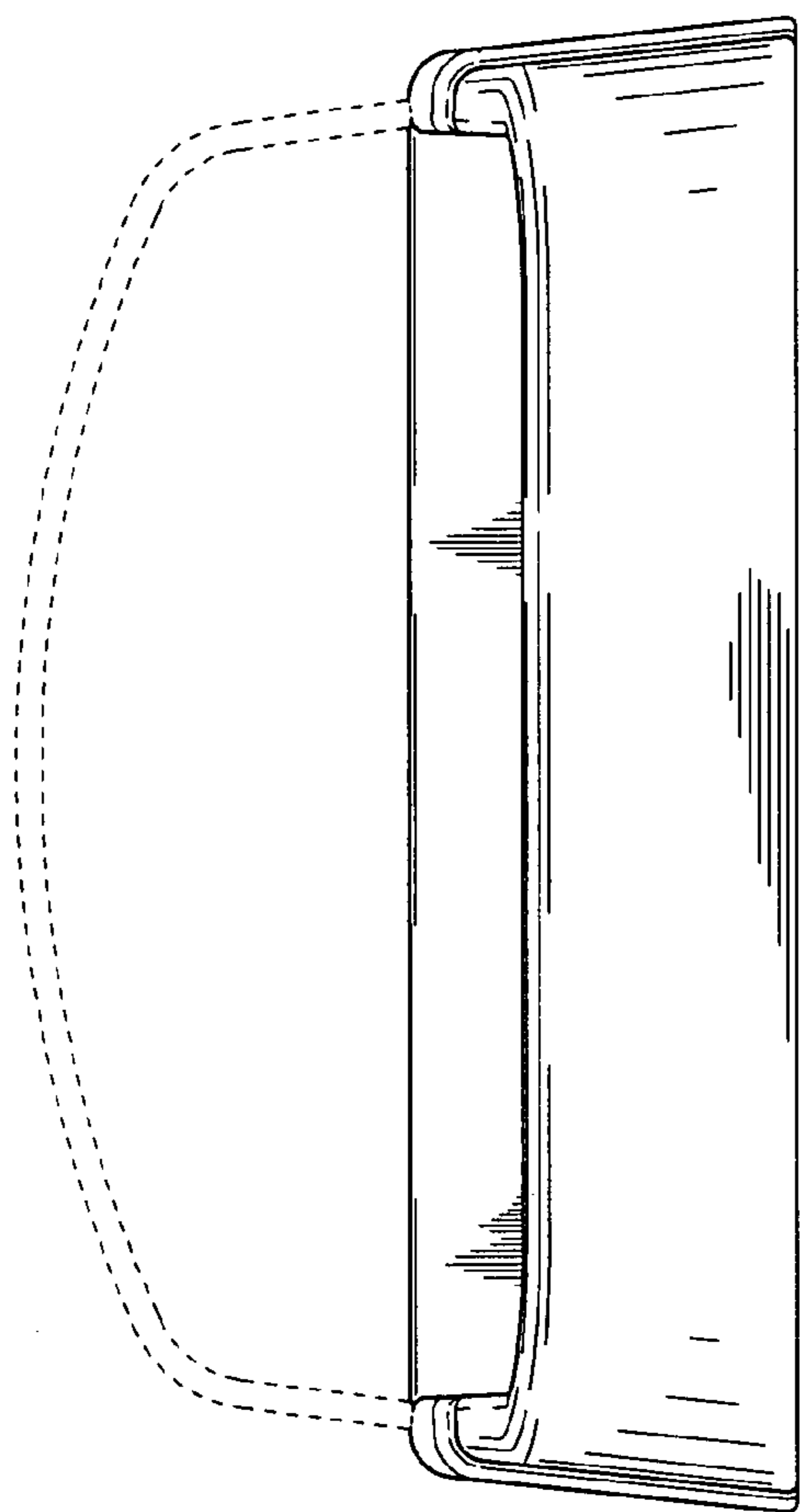

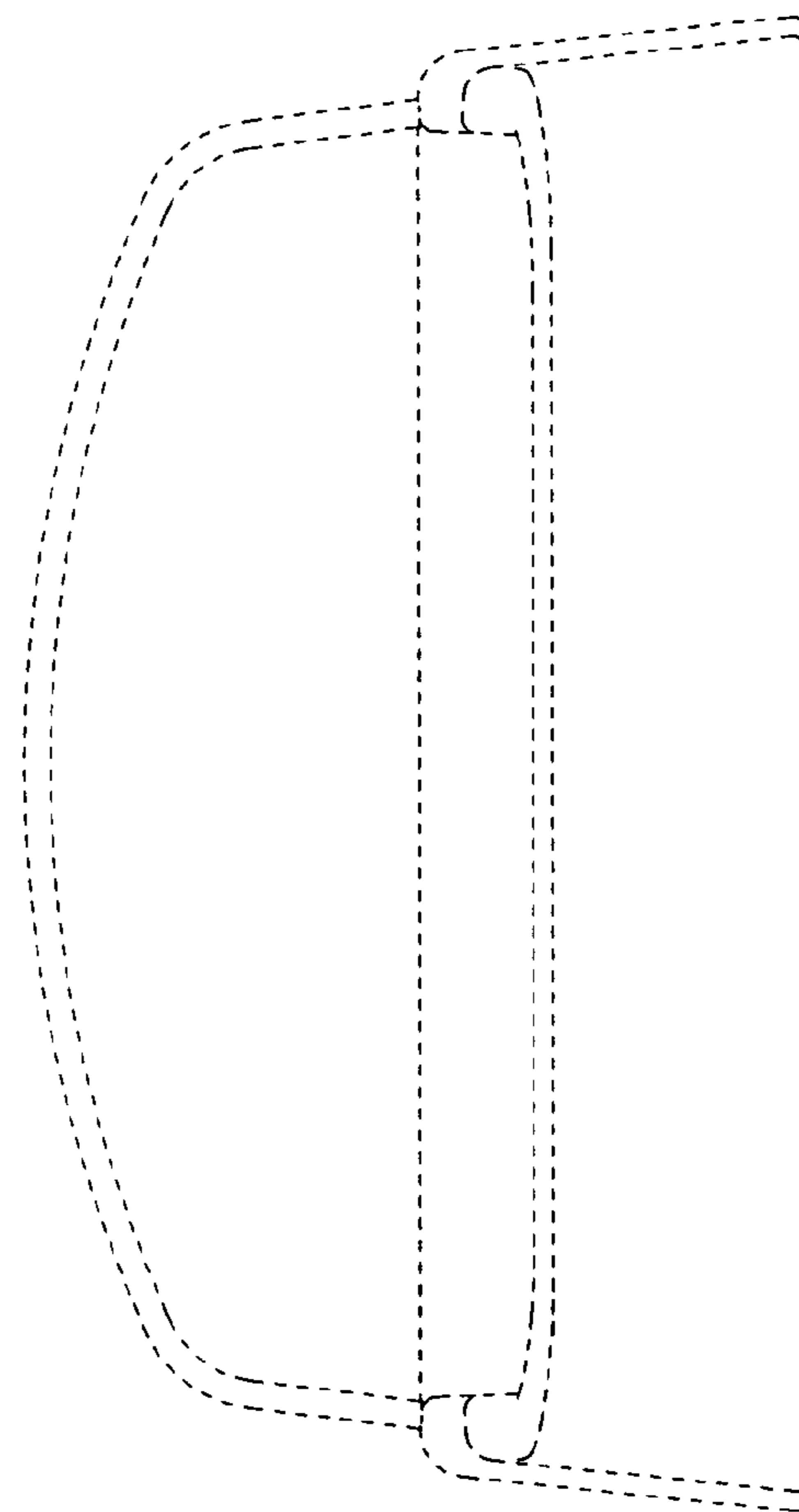

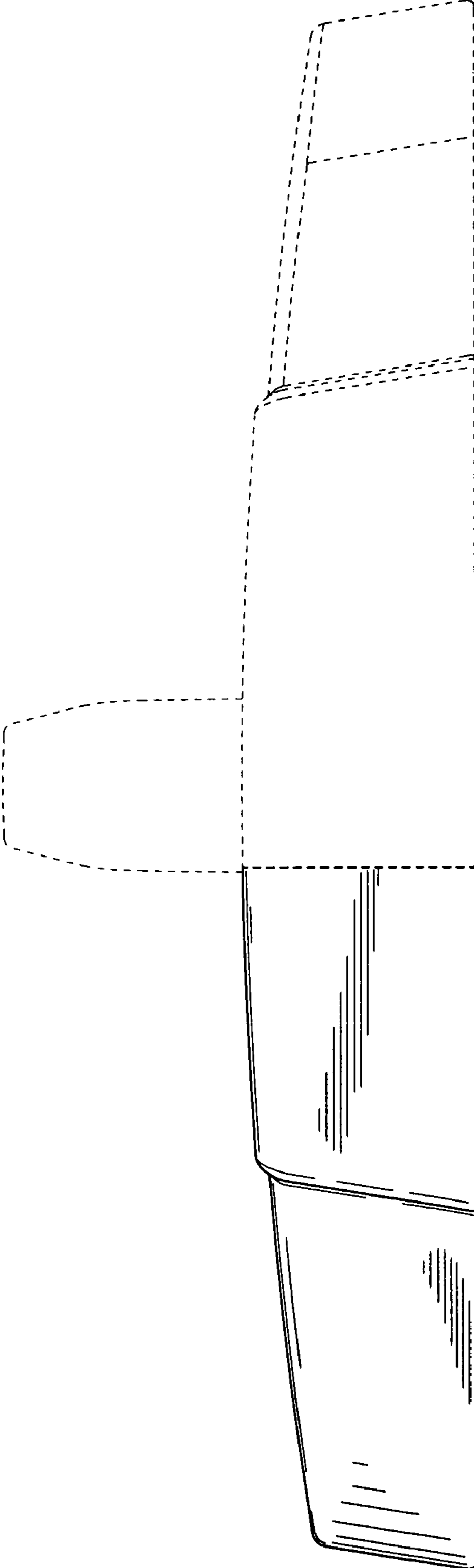

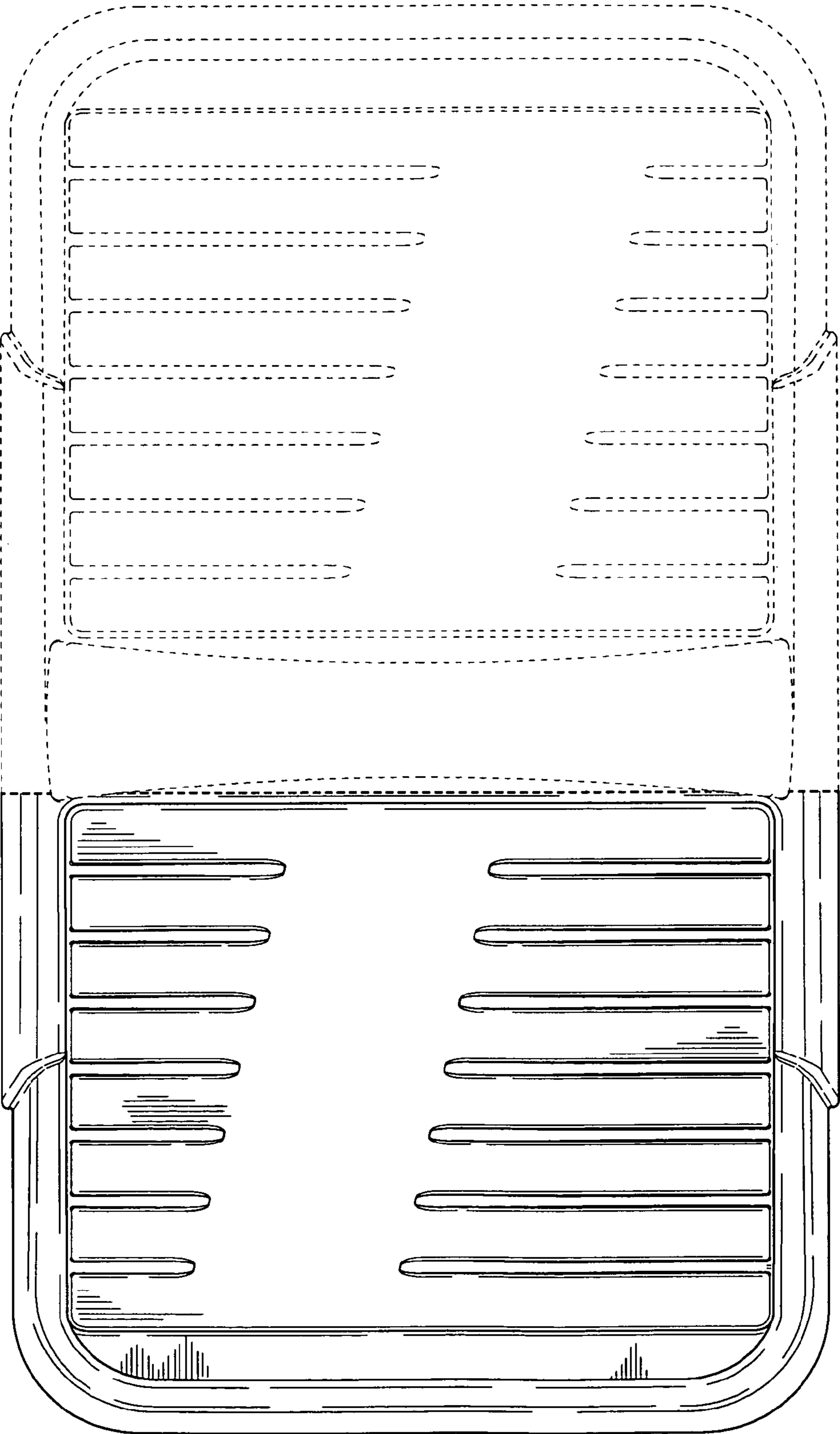

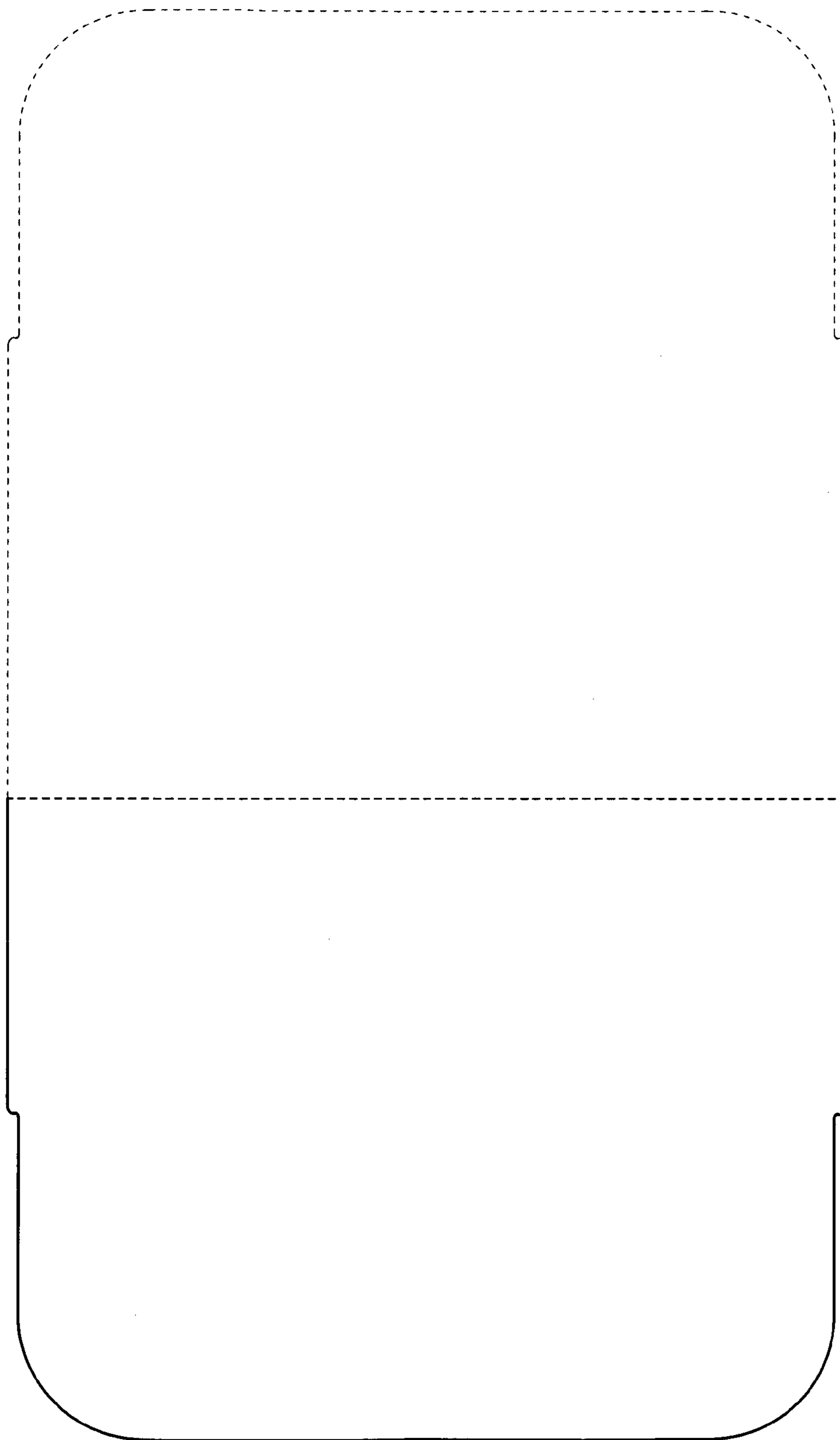
