FIG. 4 is a rear plan view;

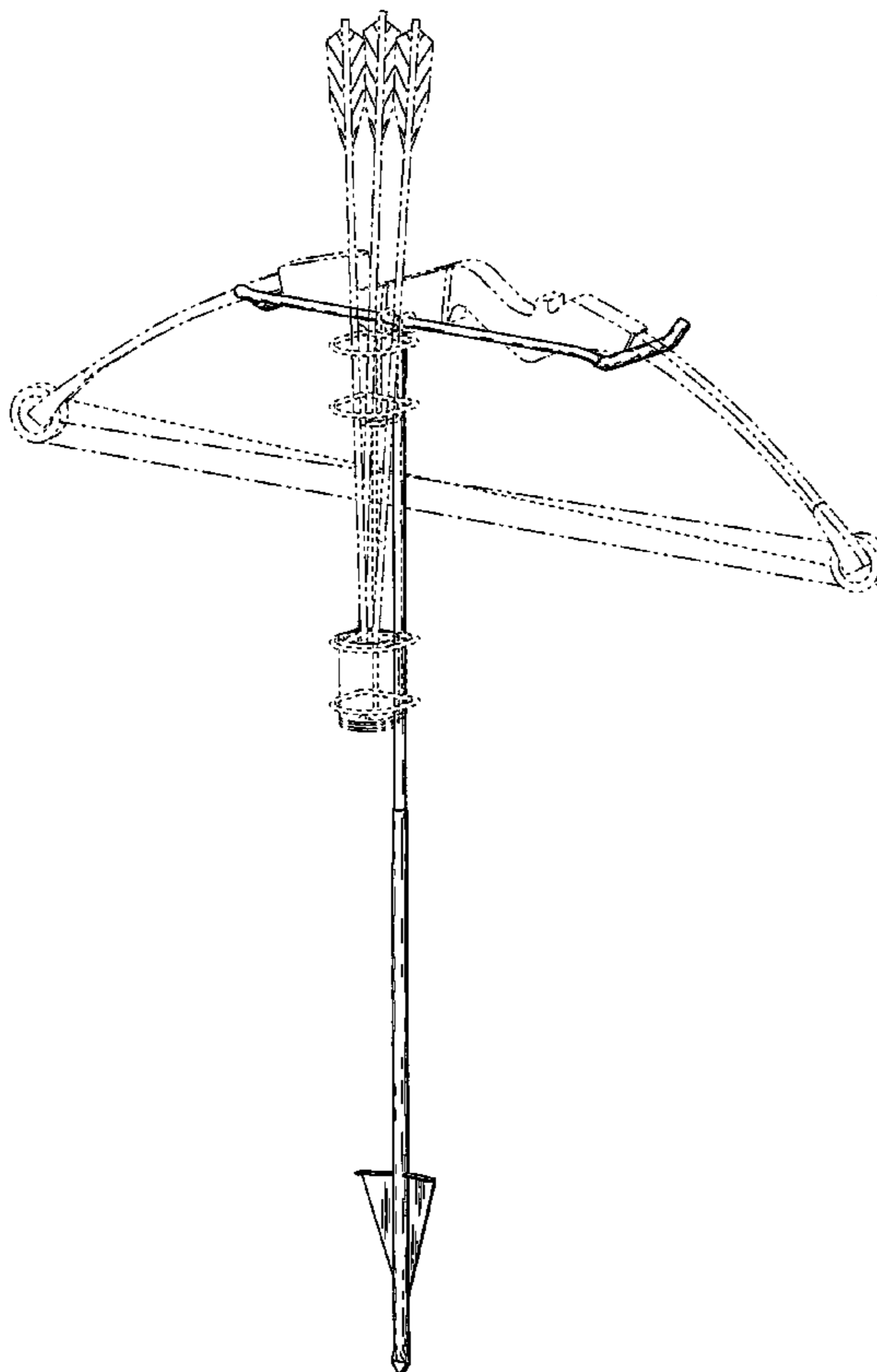
FIG. 5 is a left side view;

FIG. 6 is a right side view;

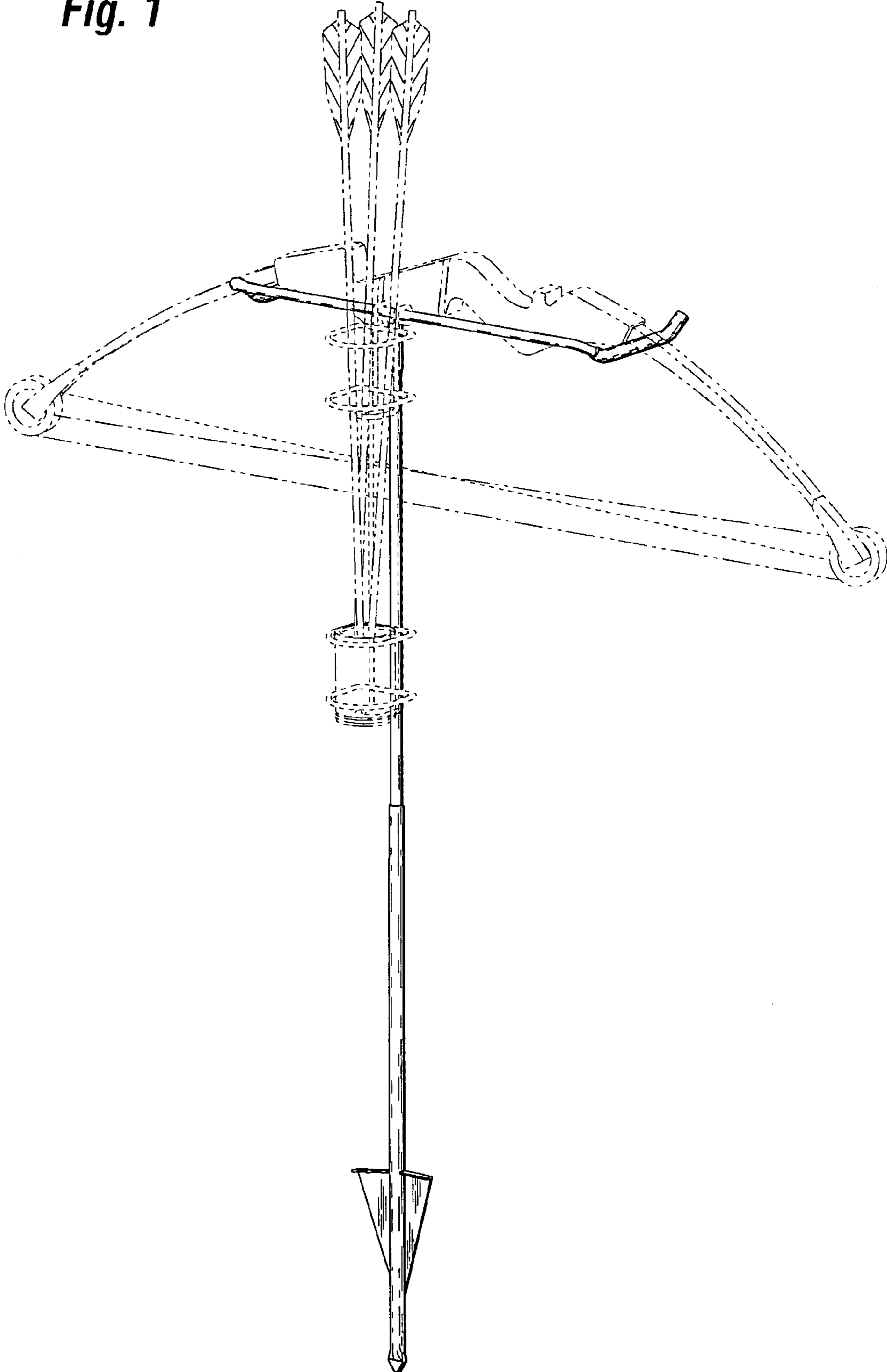
FIG. 7 is a top view; and,

FIG. 8 is a bottom view.

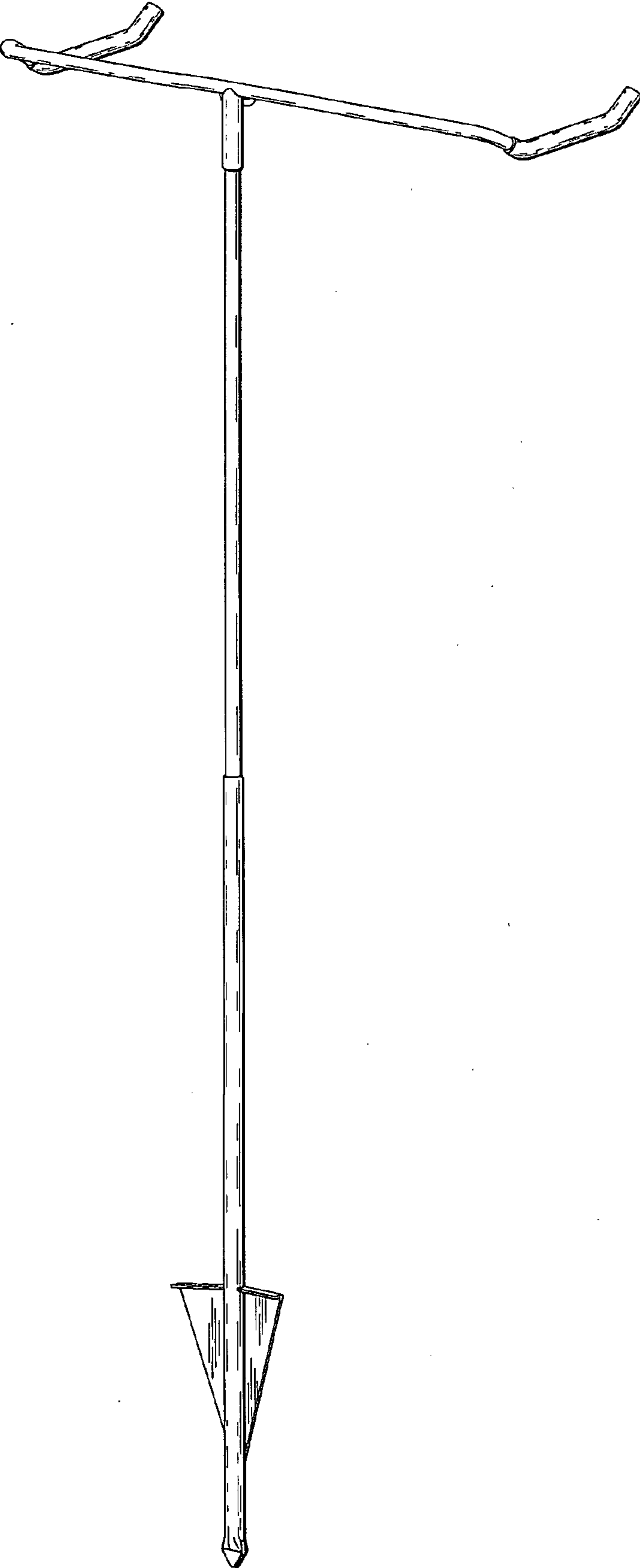

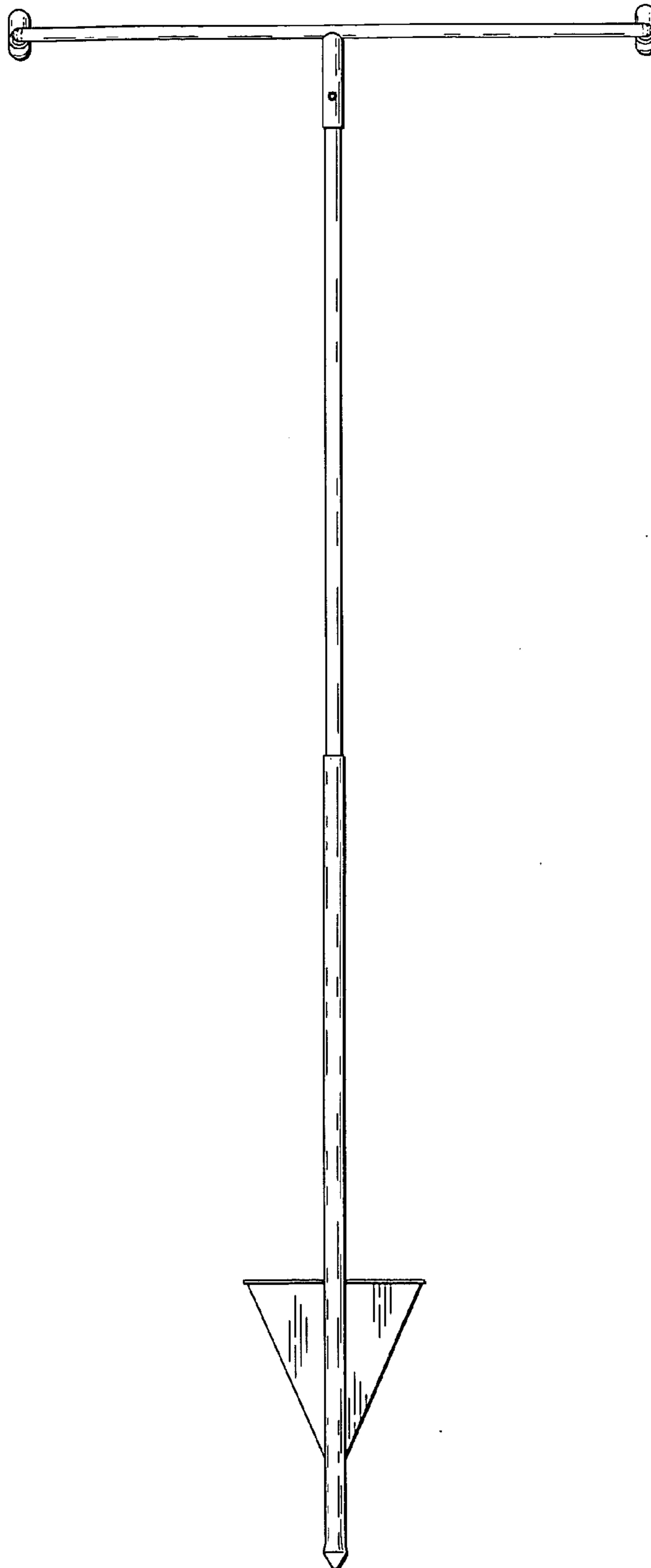

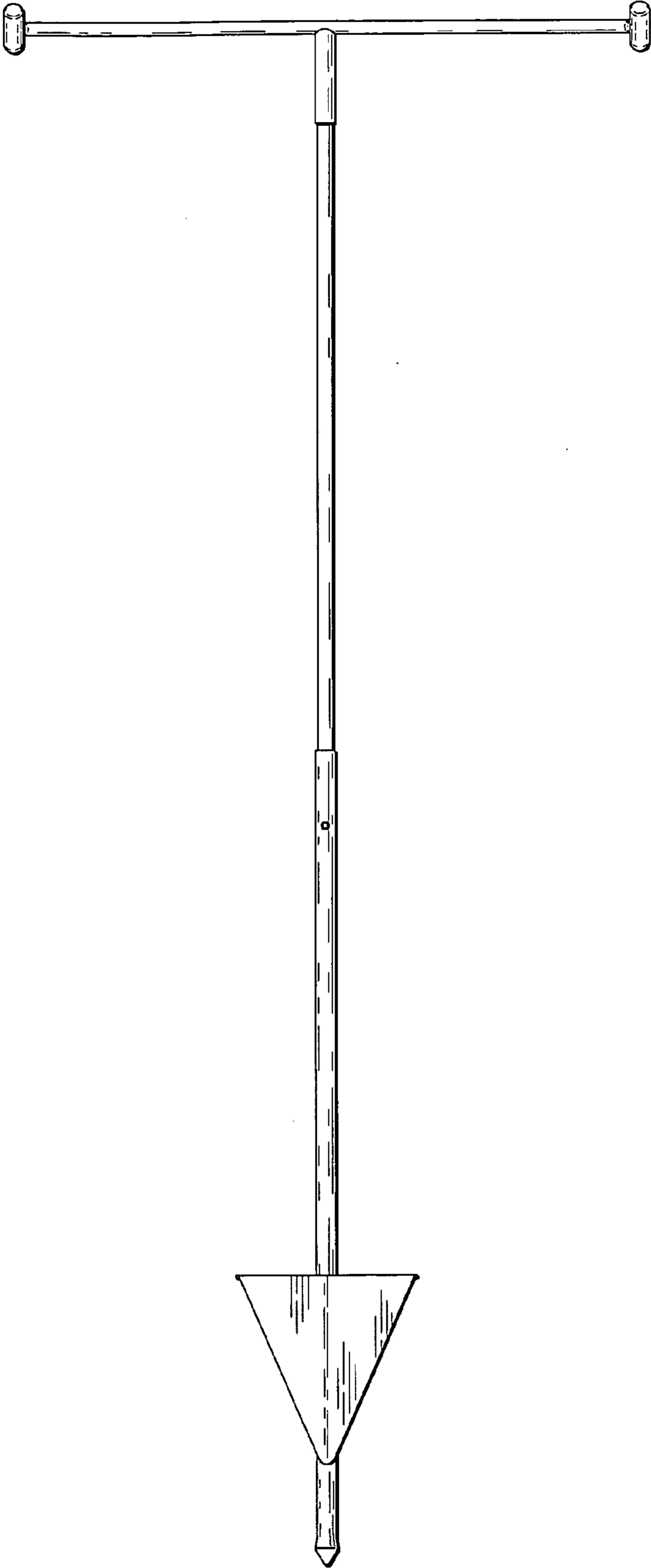

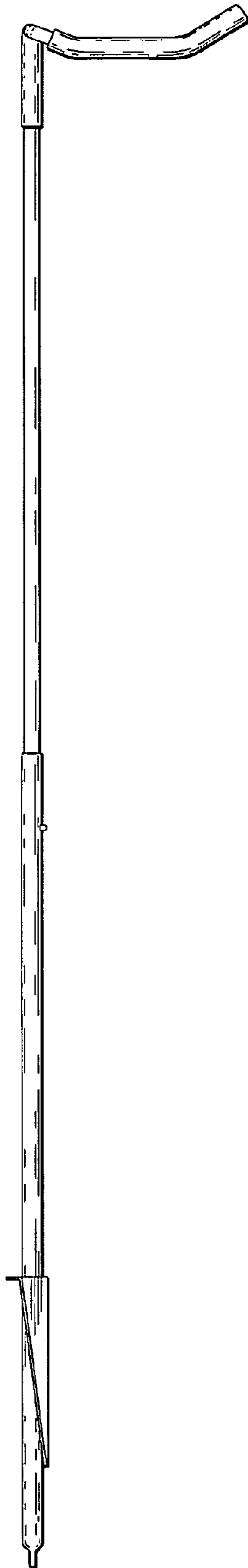

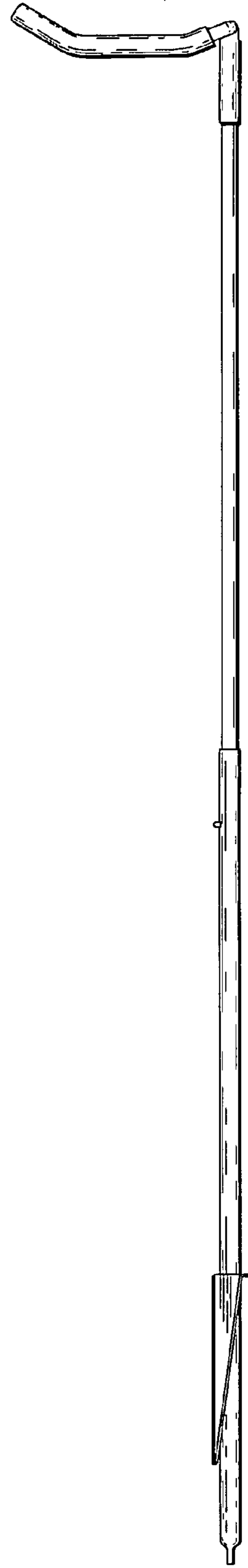

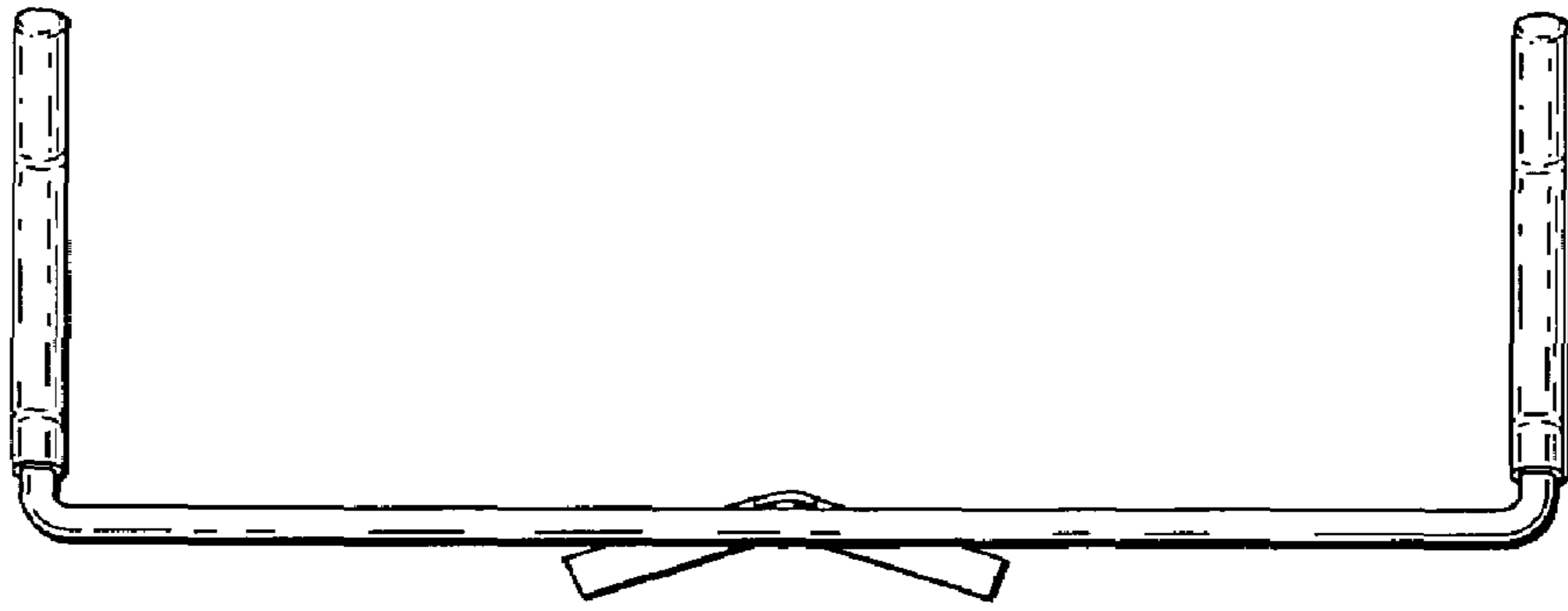
