FIG. 15 is a top plan view of the ball organizer of FIG. 9; and,

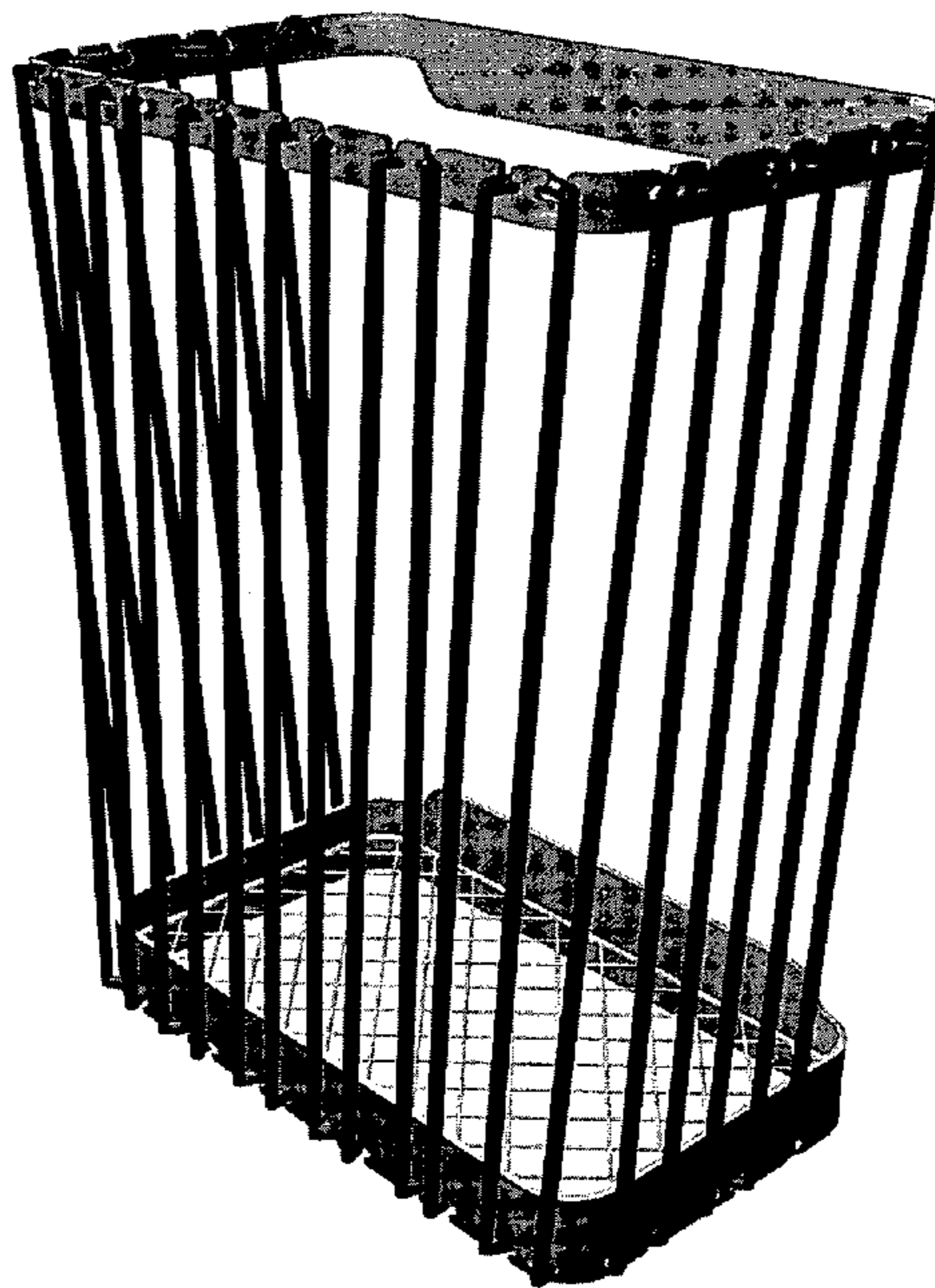
FIG. 16 is a bottom plan view of the ball organizer of FIG. 9.

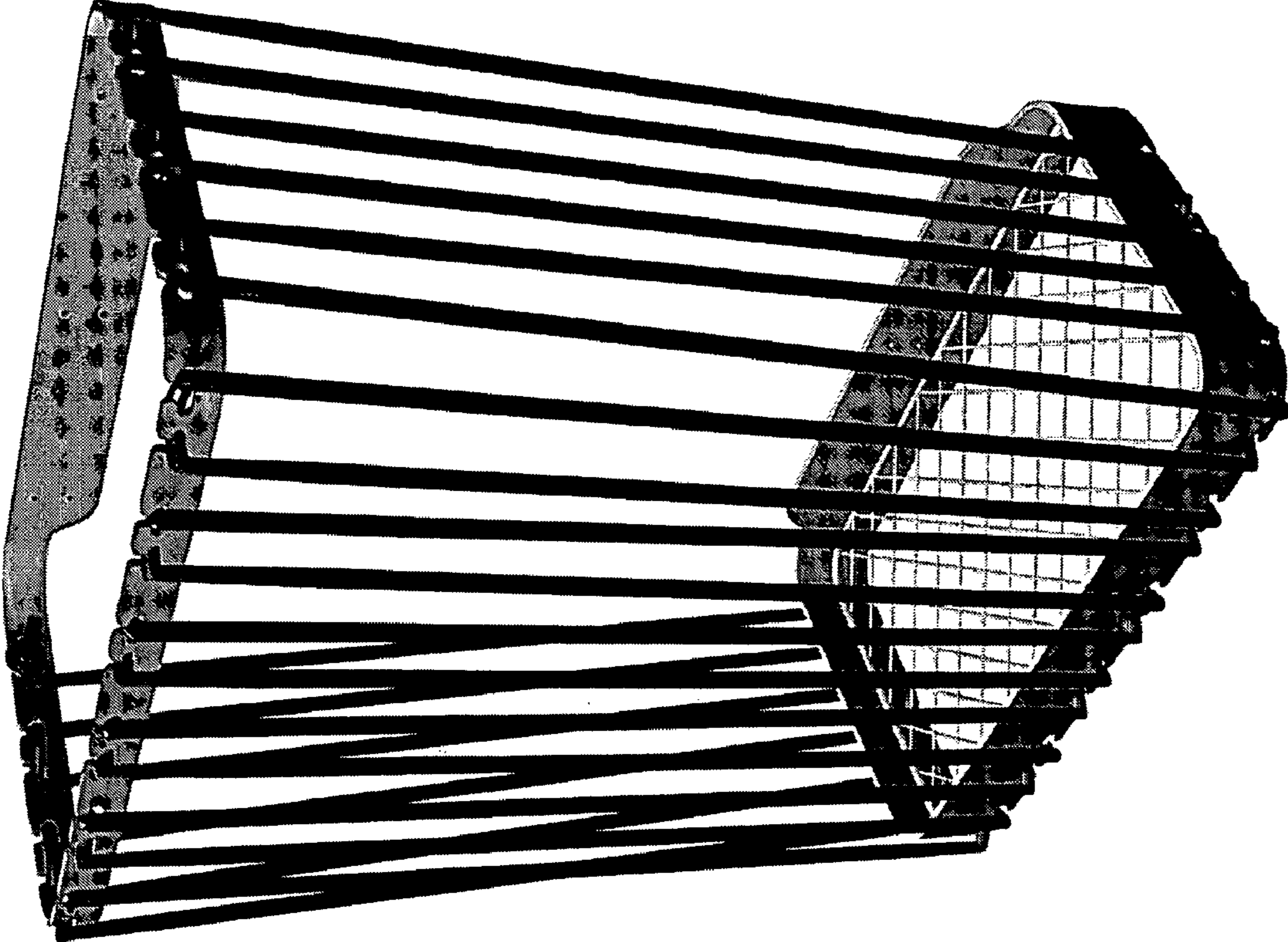

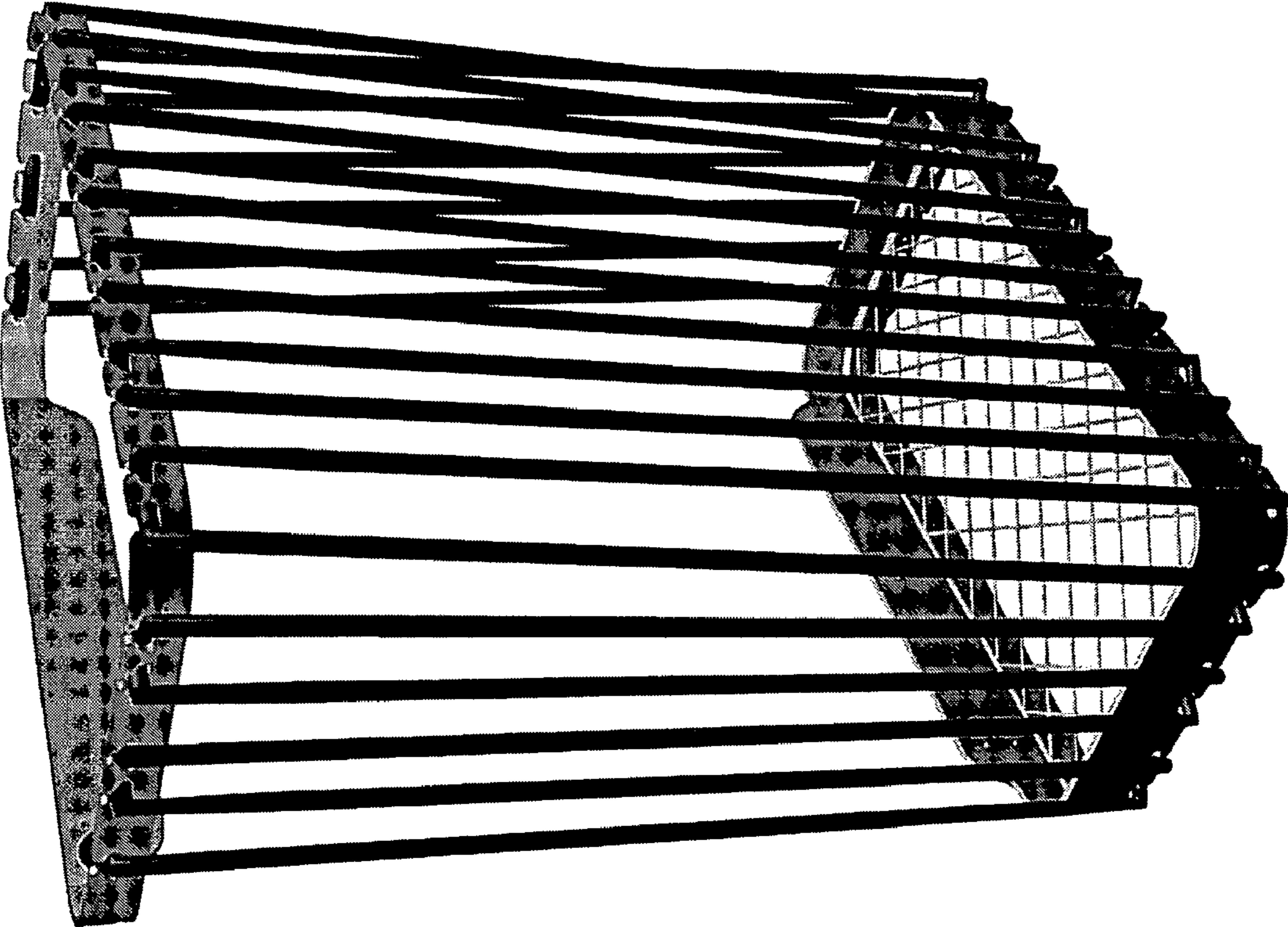

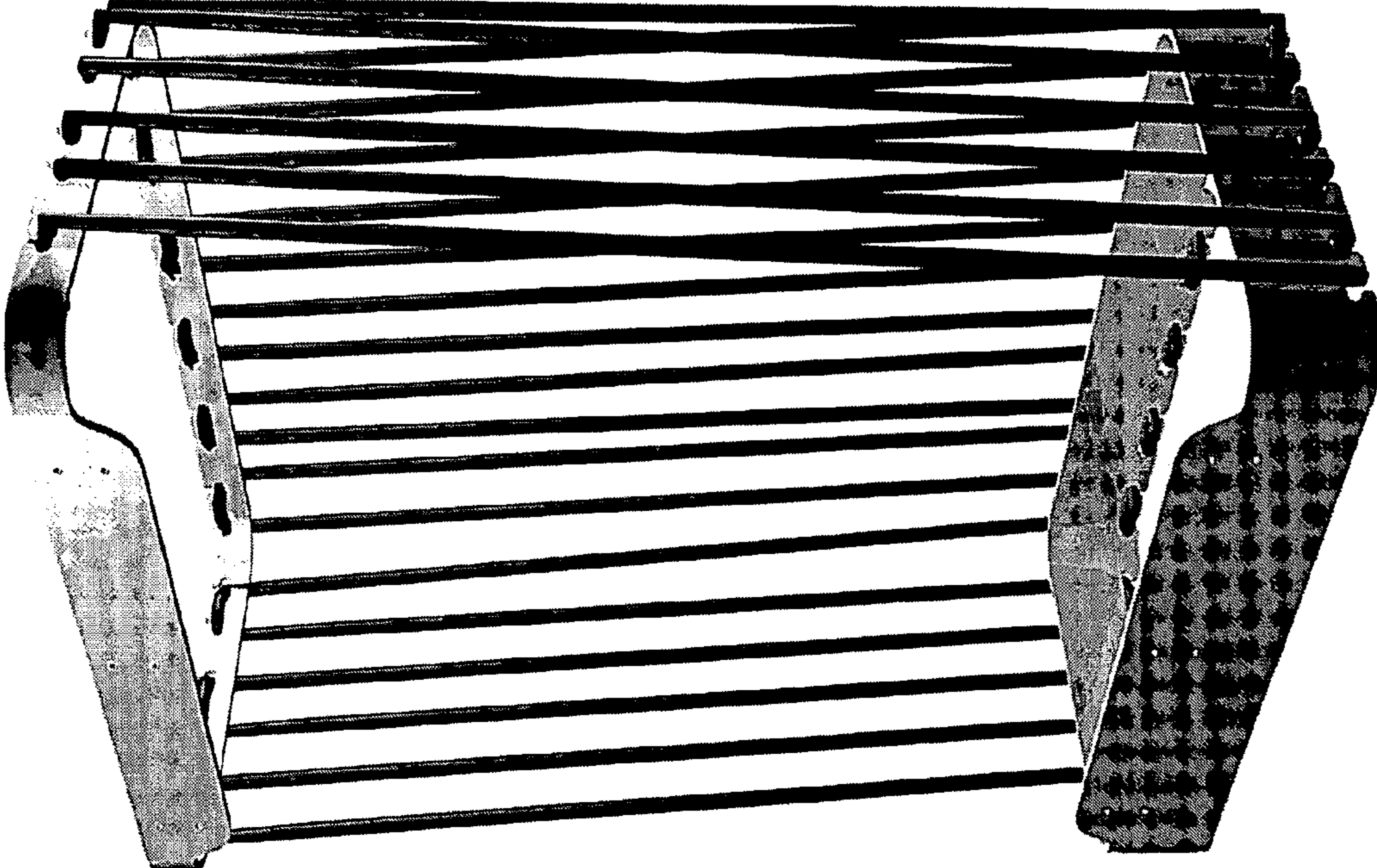

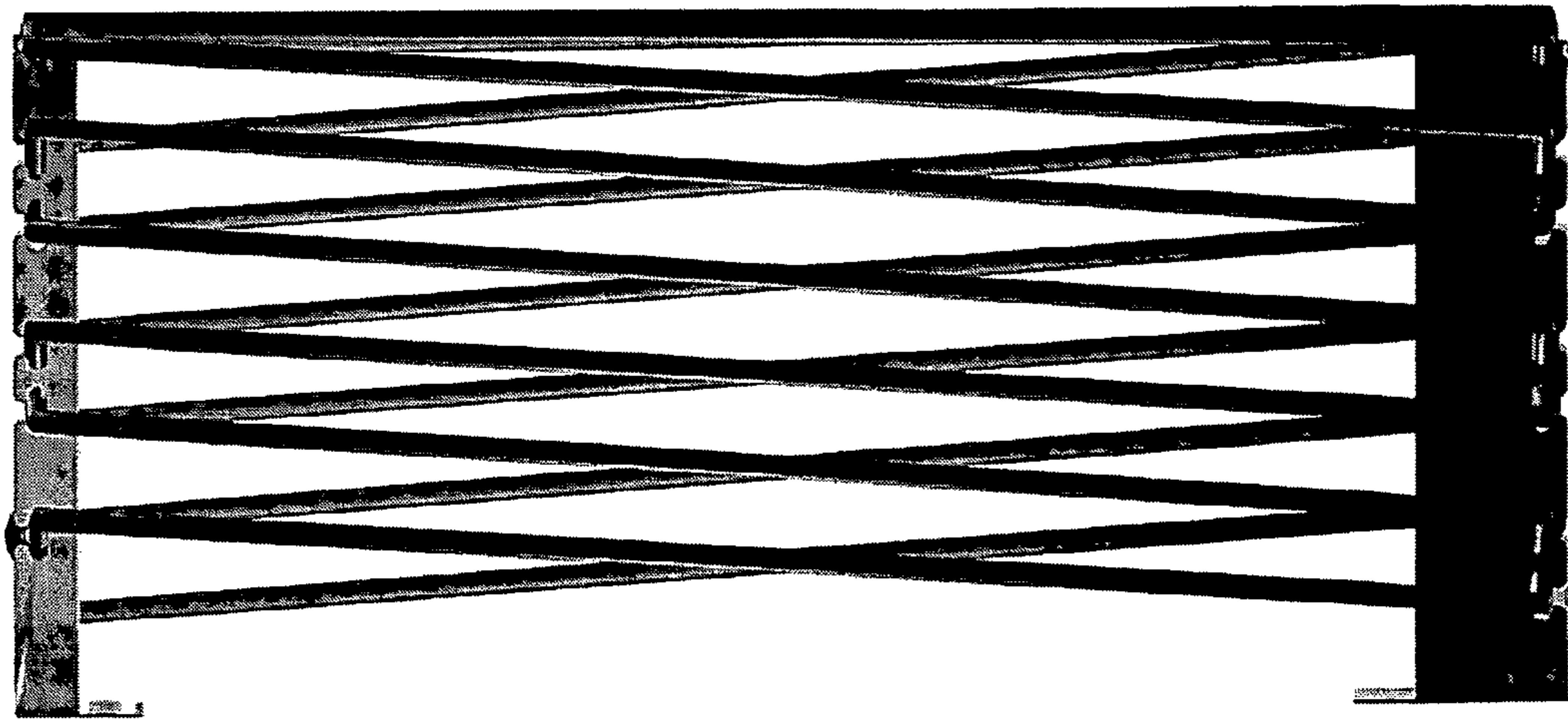

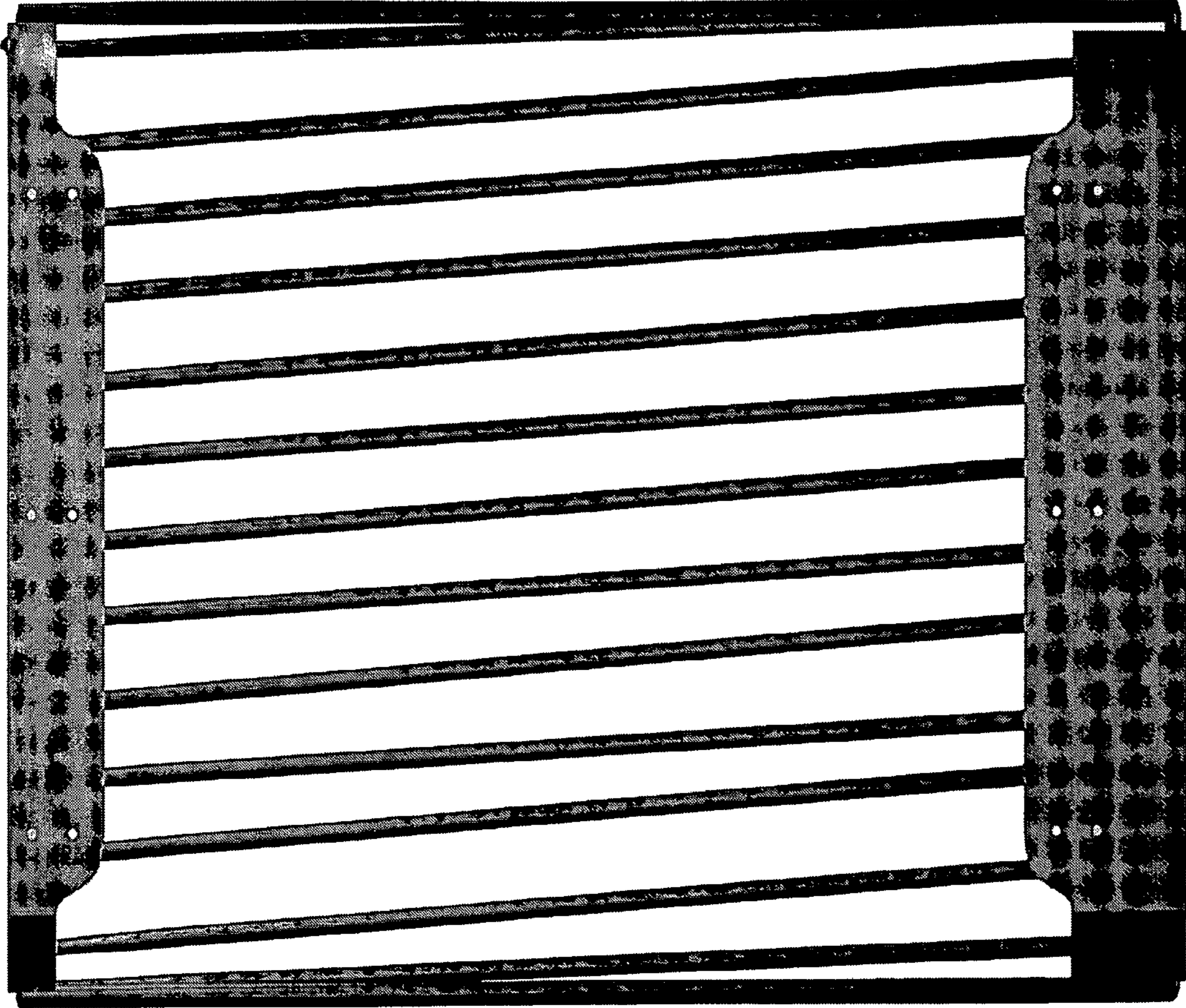

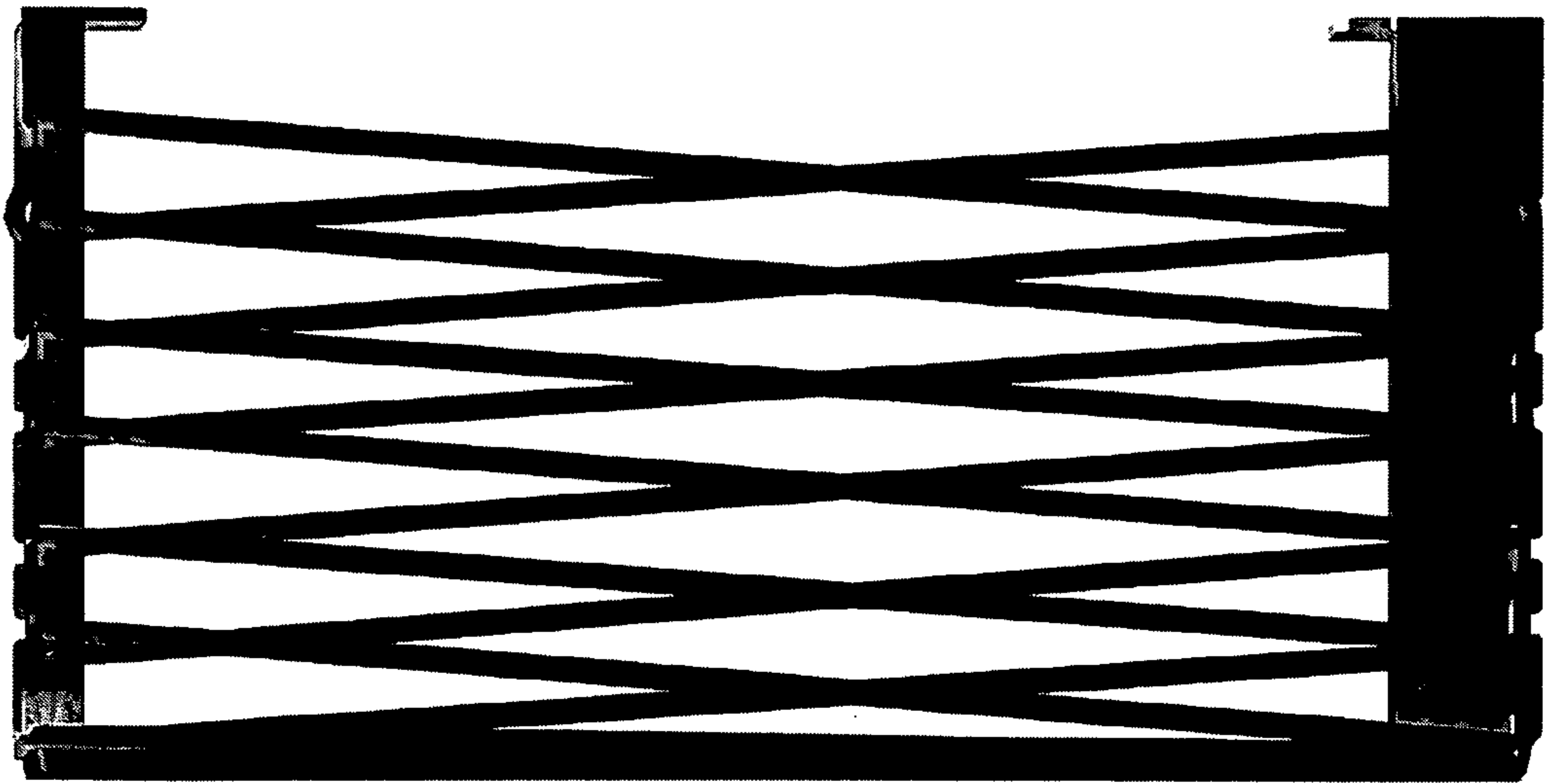

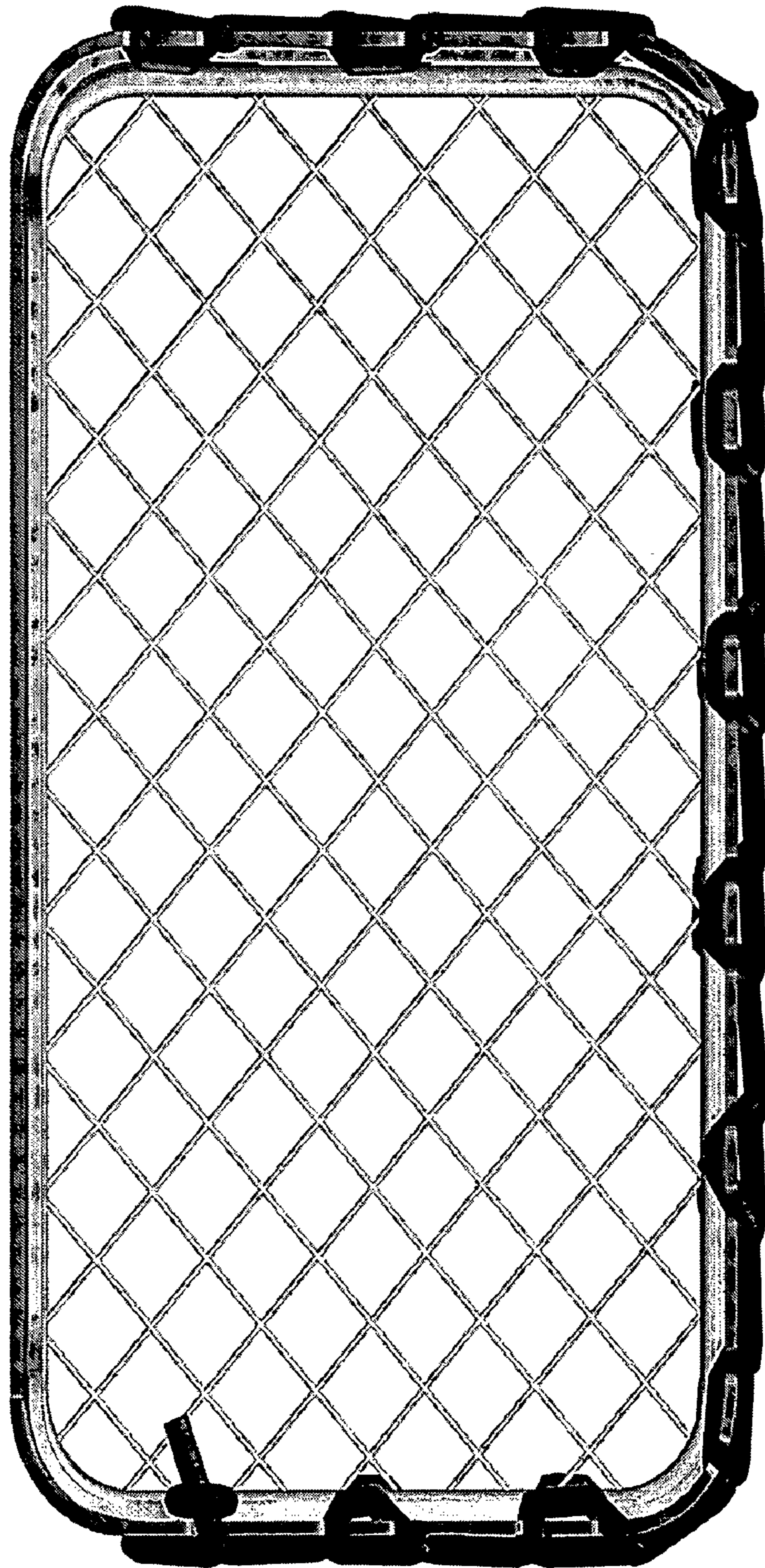

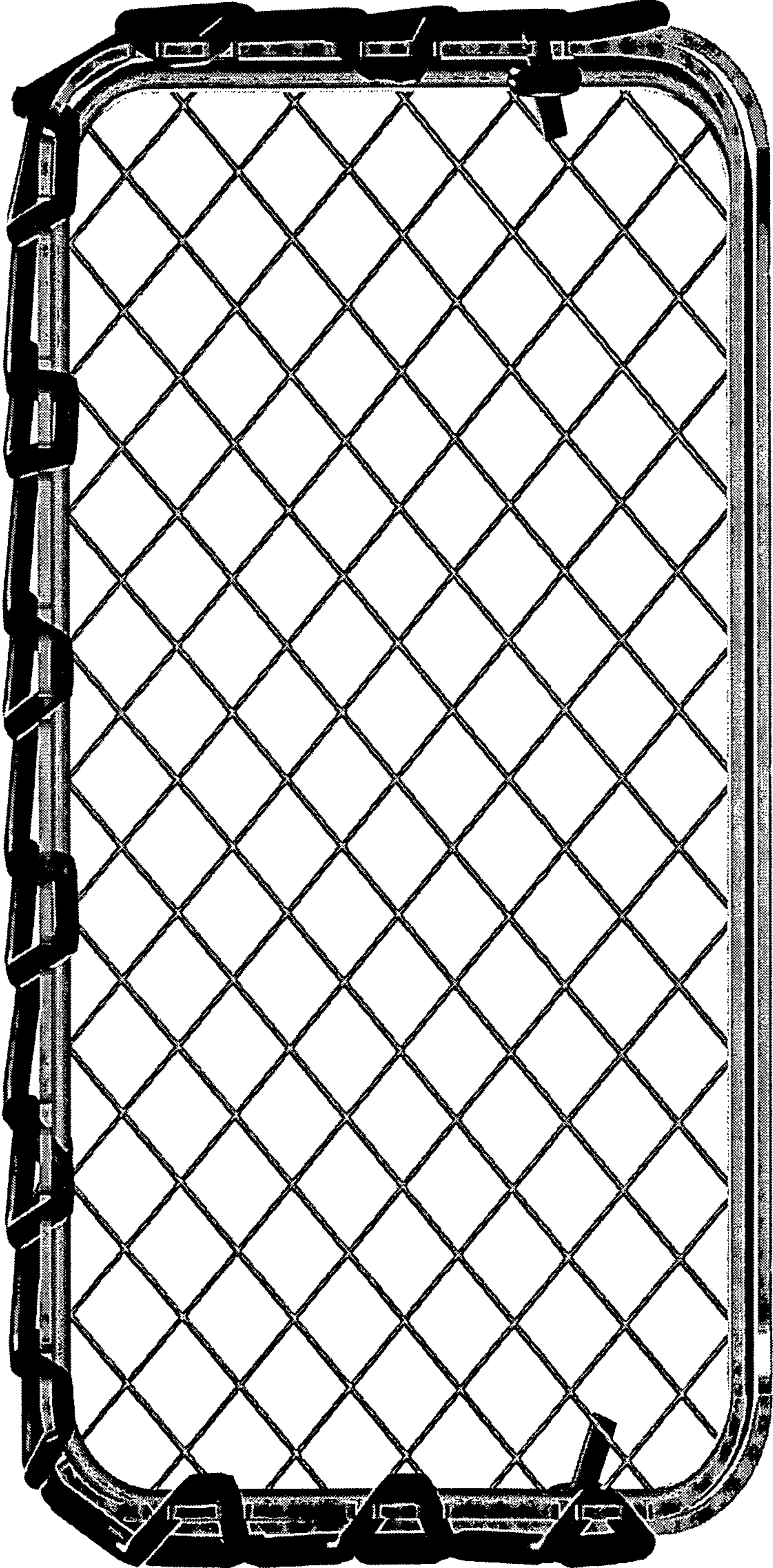

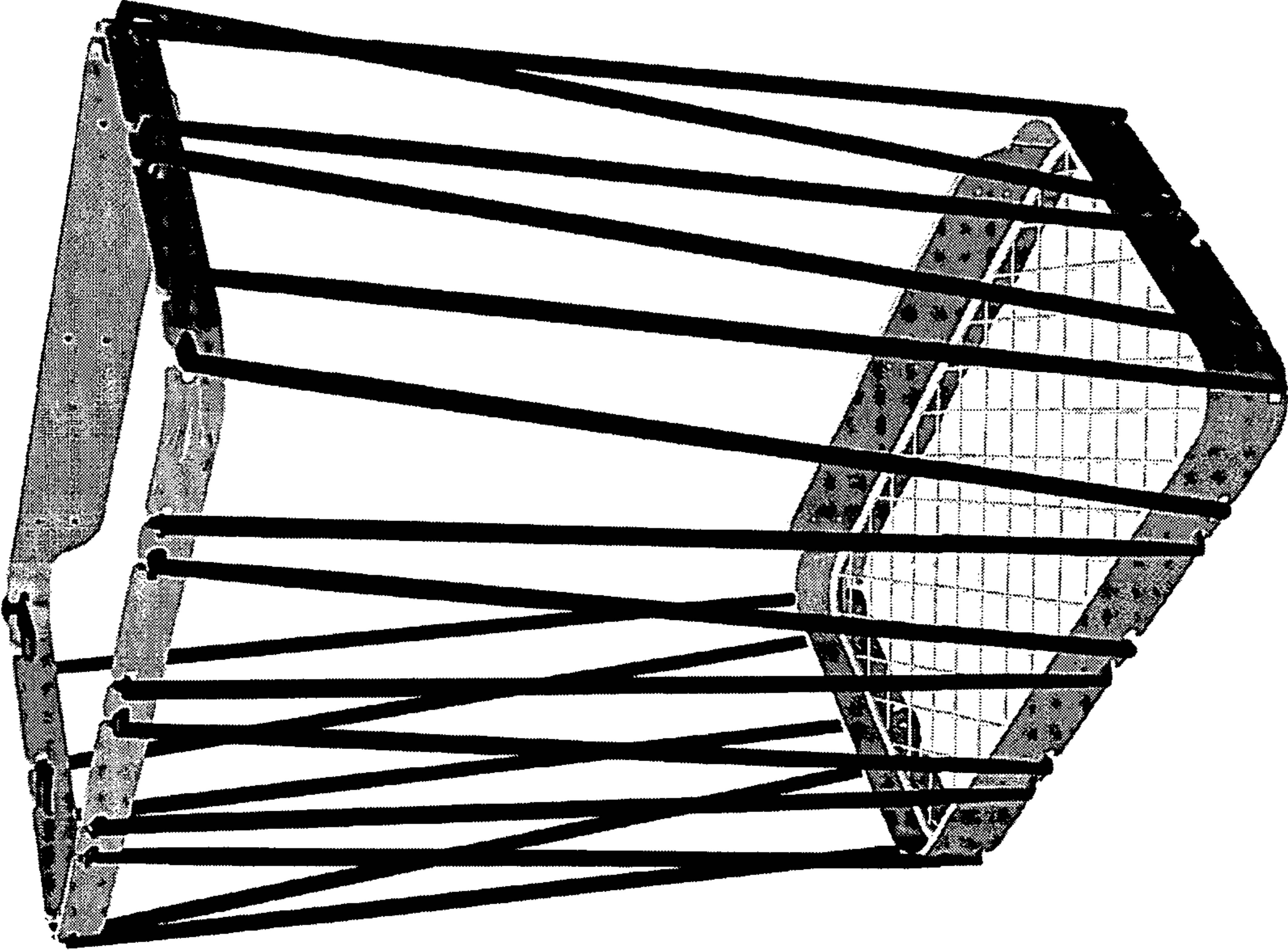

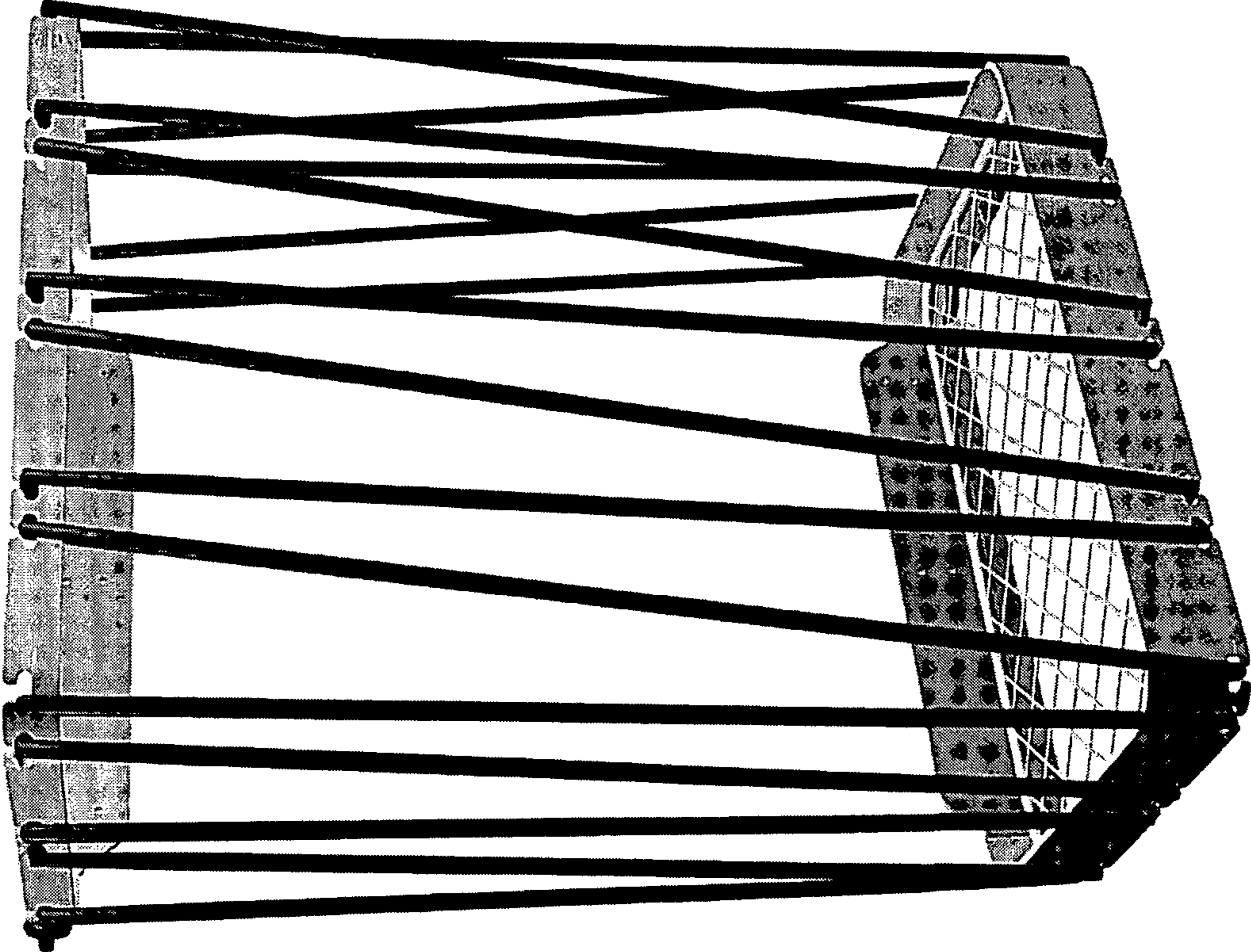

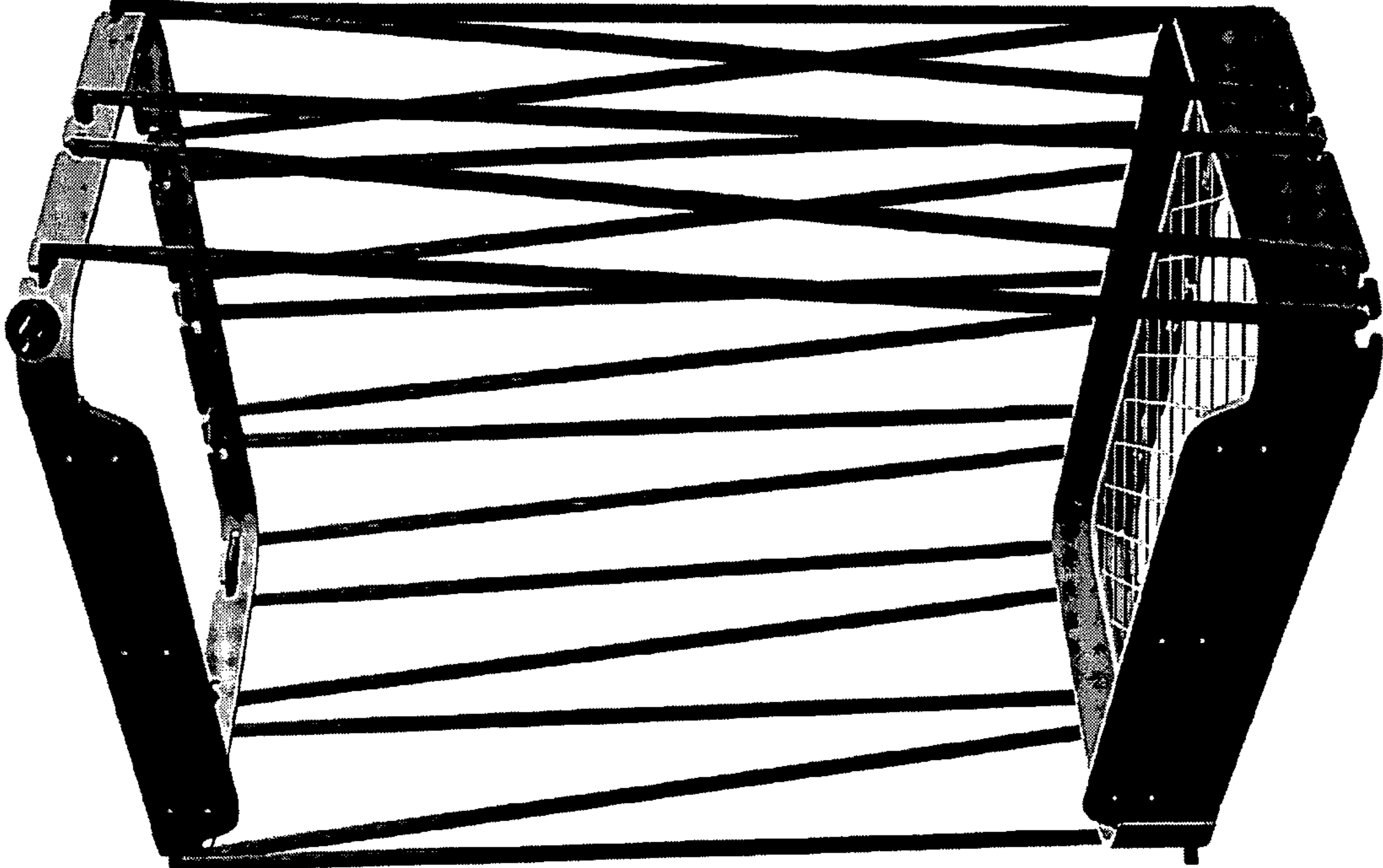

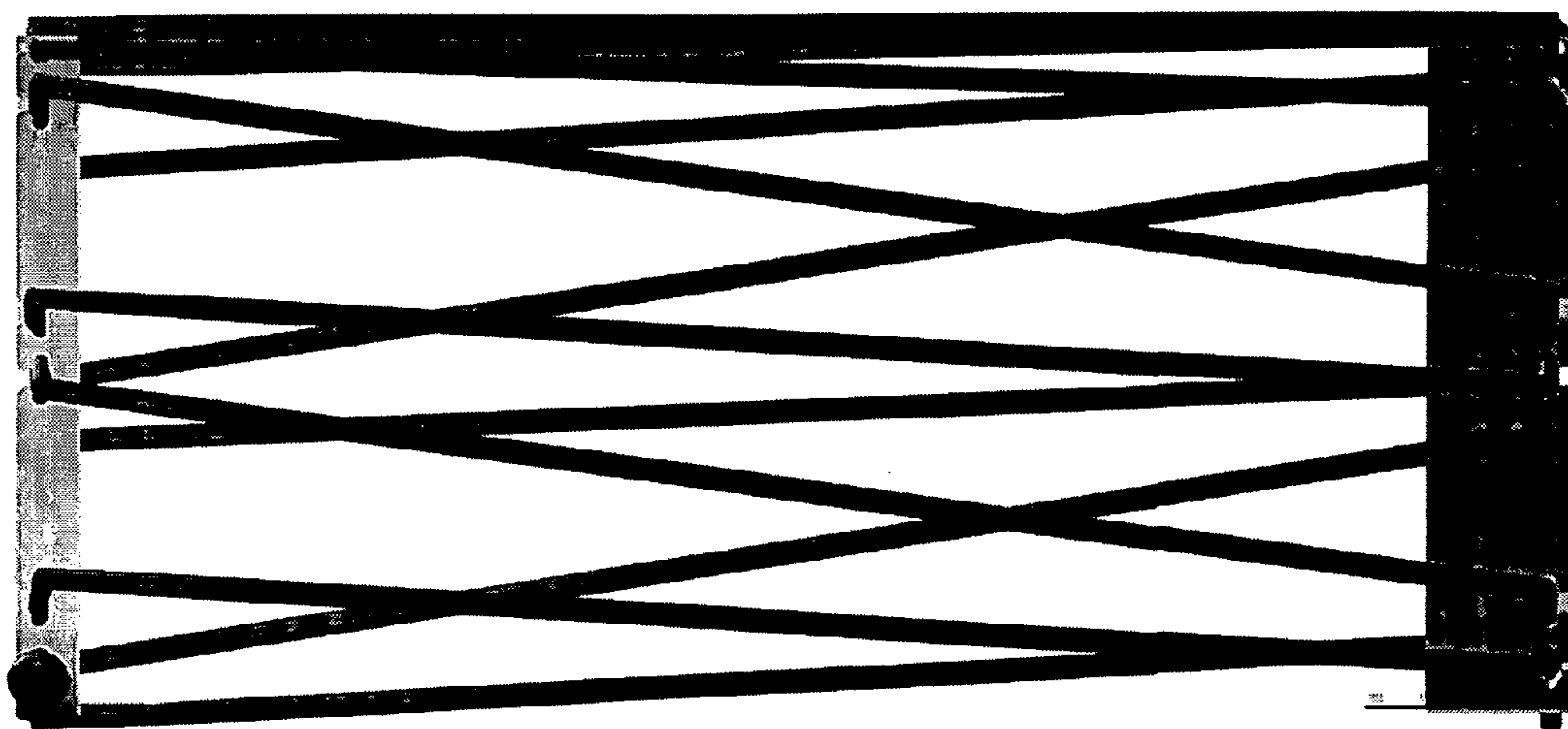

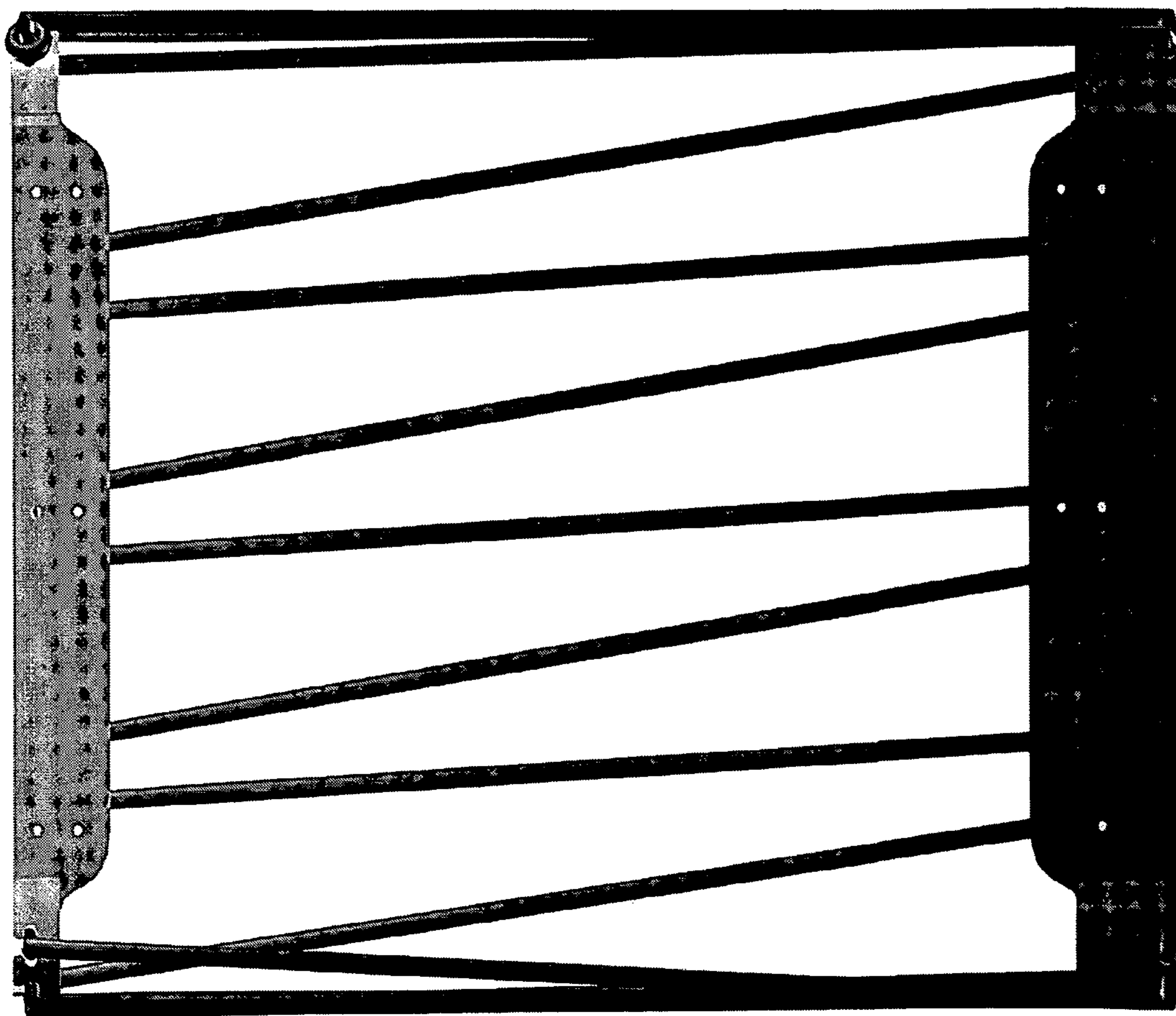

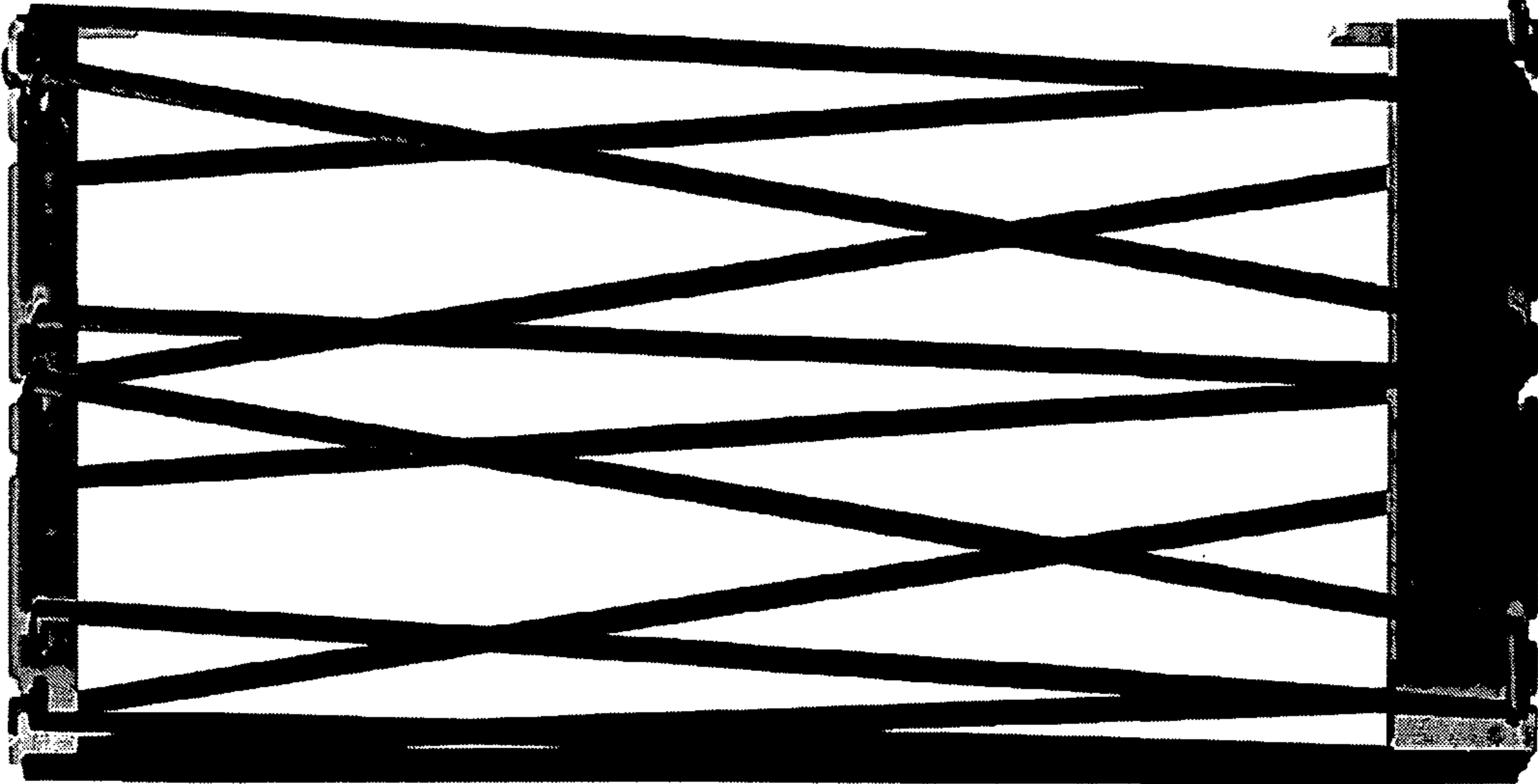

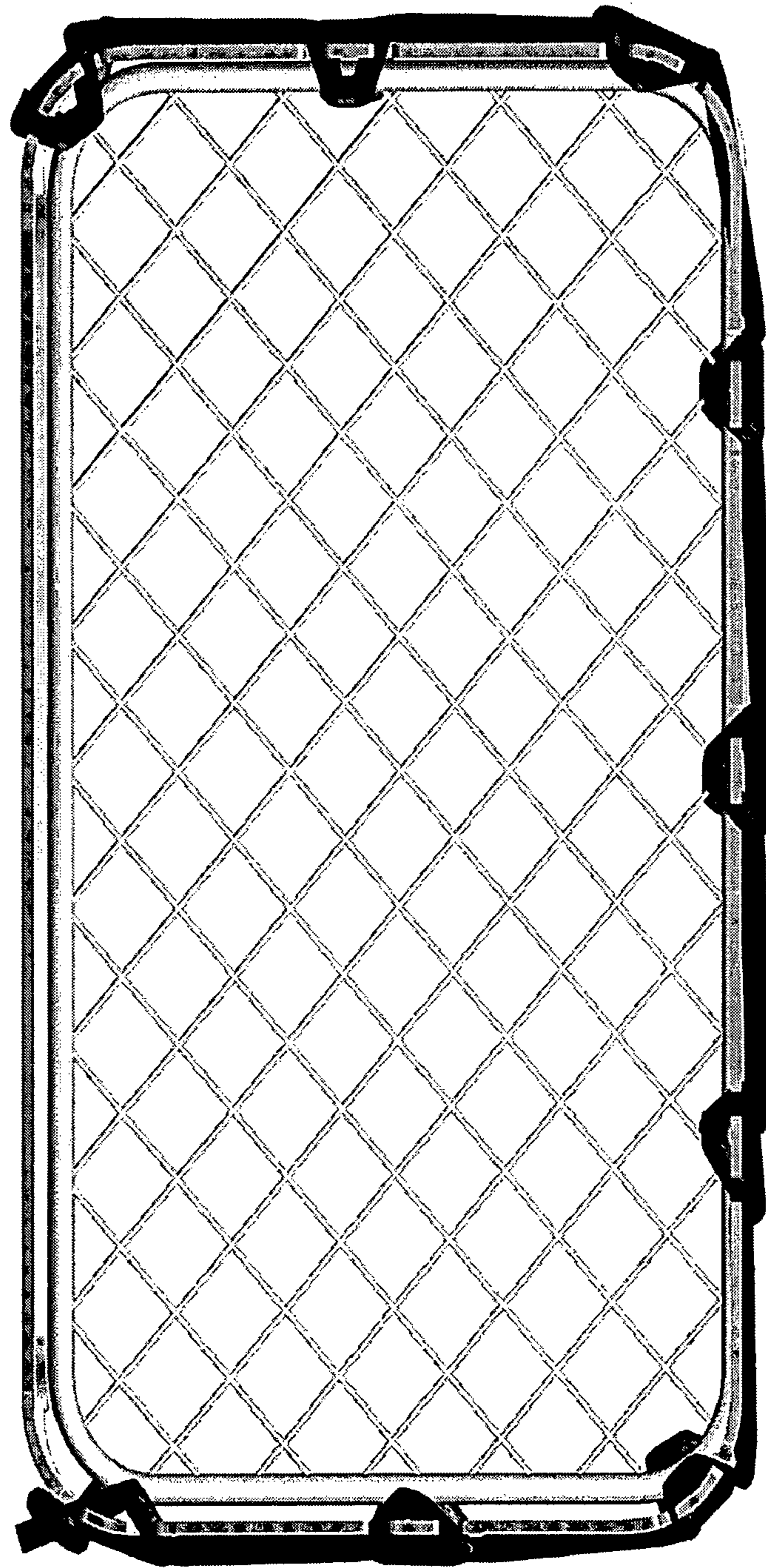

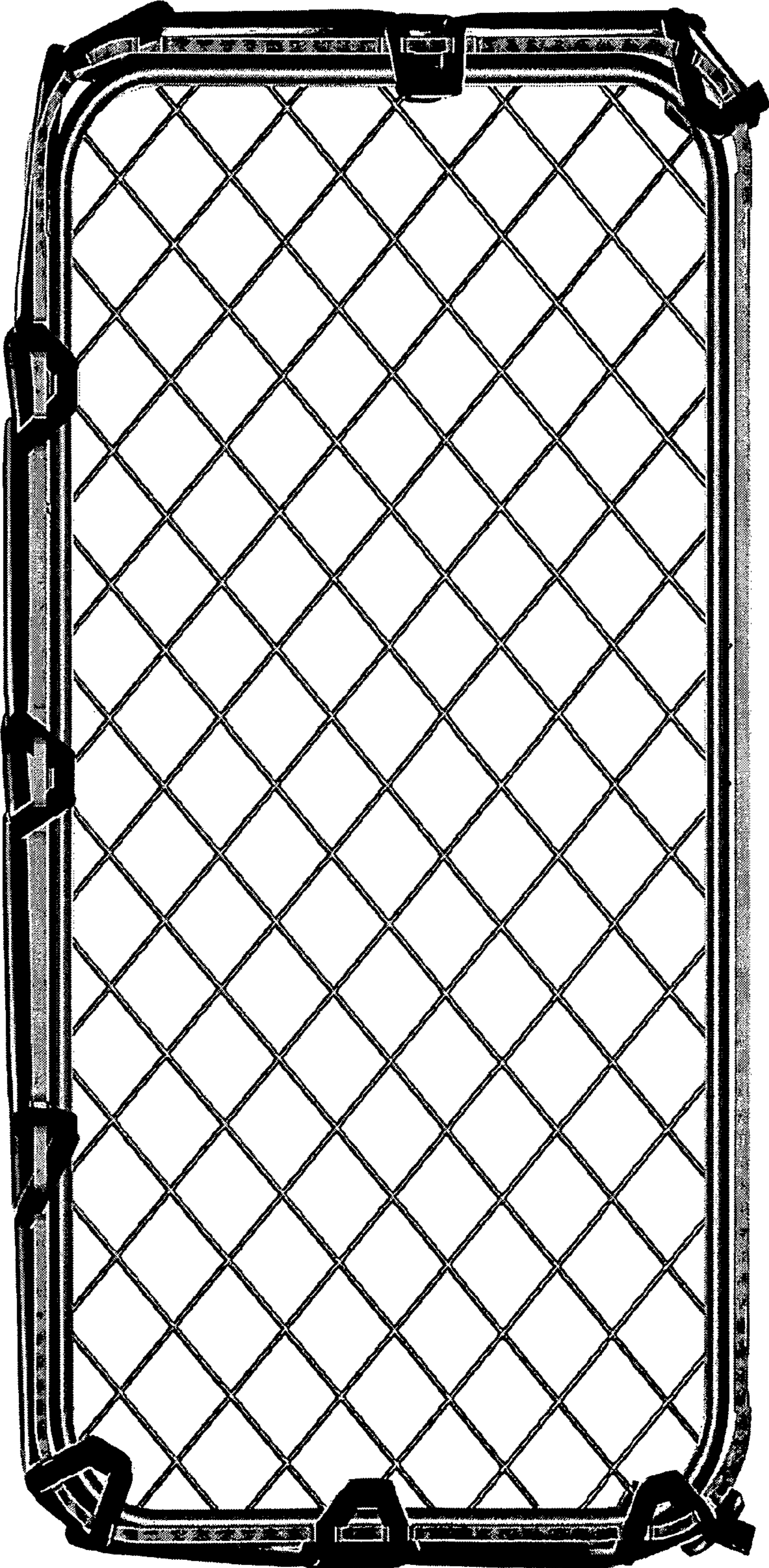
