(57) **CLAIM**

The ornamental design for a pitcher for filtering water, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a pitcher for filtering water showing my new design;

FIG. 2 is an additional perspective view of a pitcher with an open water intake hole, showing the electronic indicator embedded in the latch;

FIG. 3 is a top plan view of a pitcher with a closed water intake hole;

FIG. 4 is a top plan view of a pitcher with an open water intake hole, showing the electronic indicator embedded in the latch;

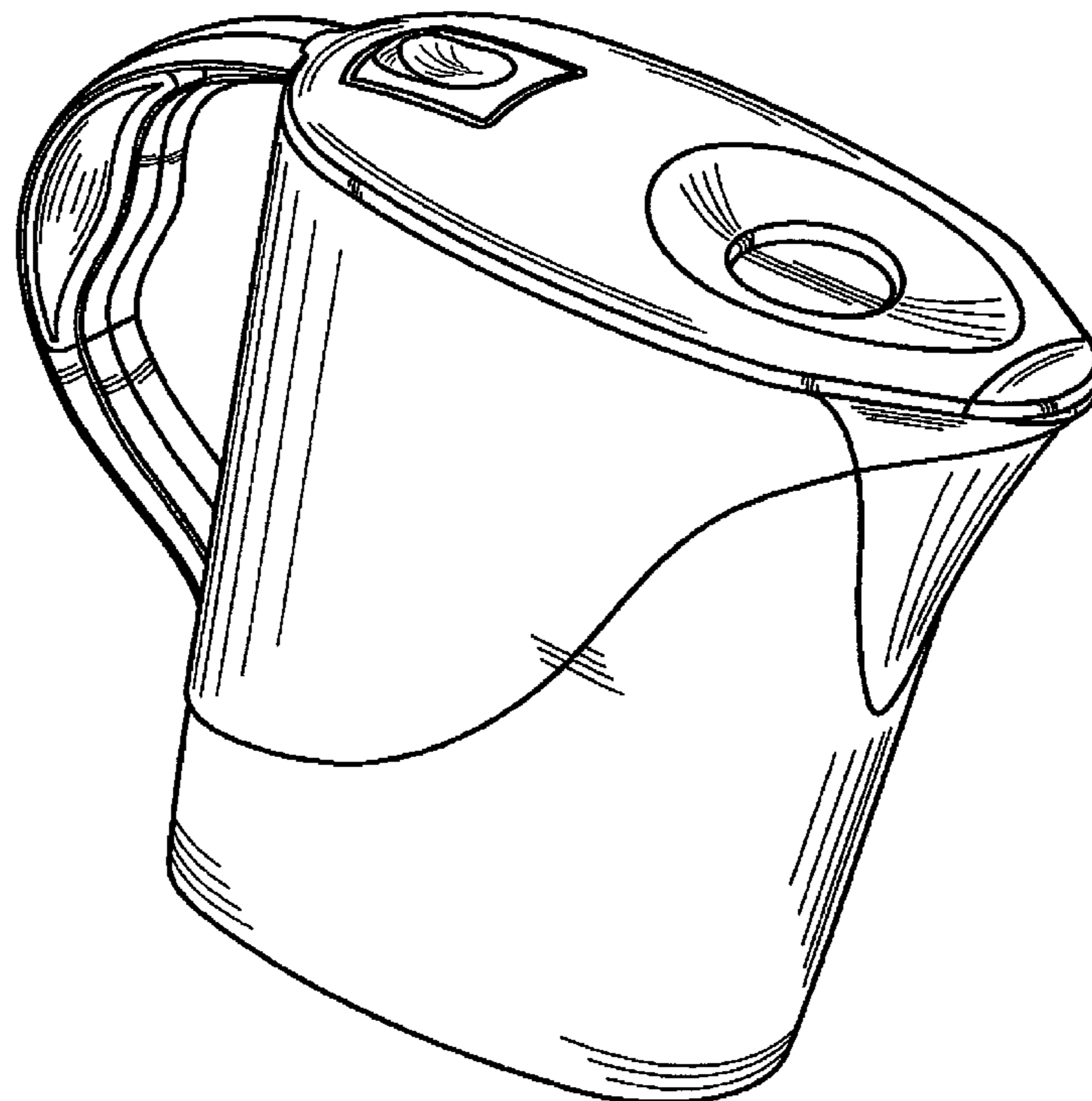
FIG. 5 is a left side elevational view thereof;

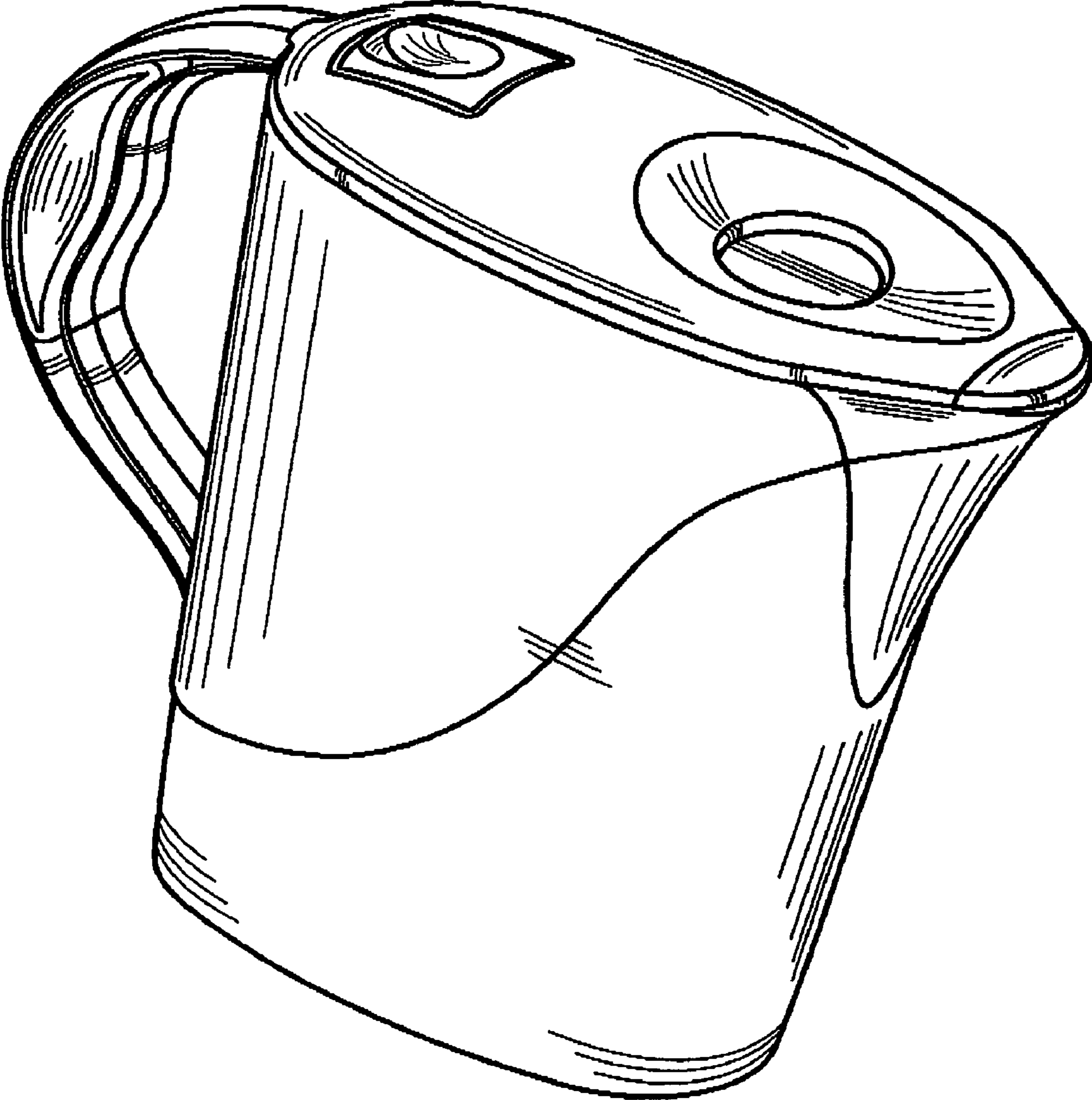

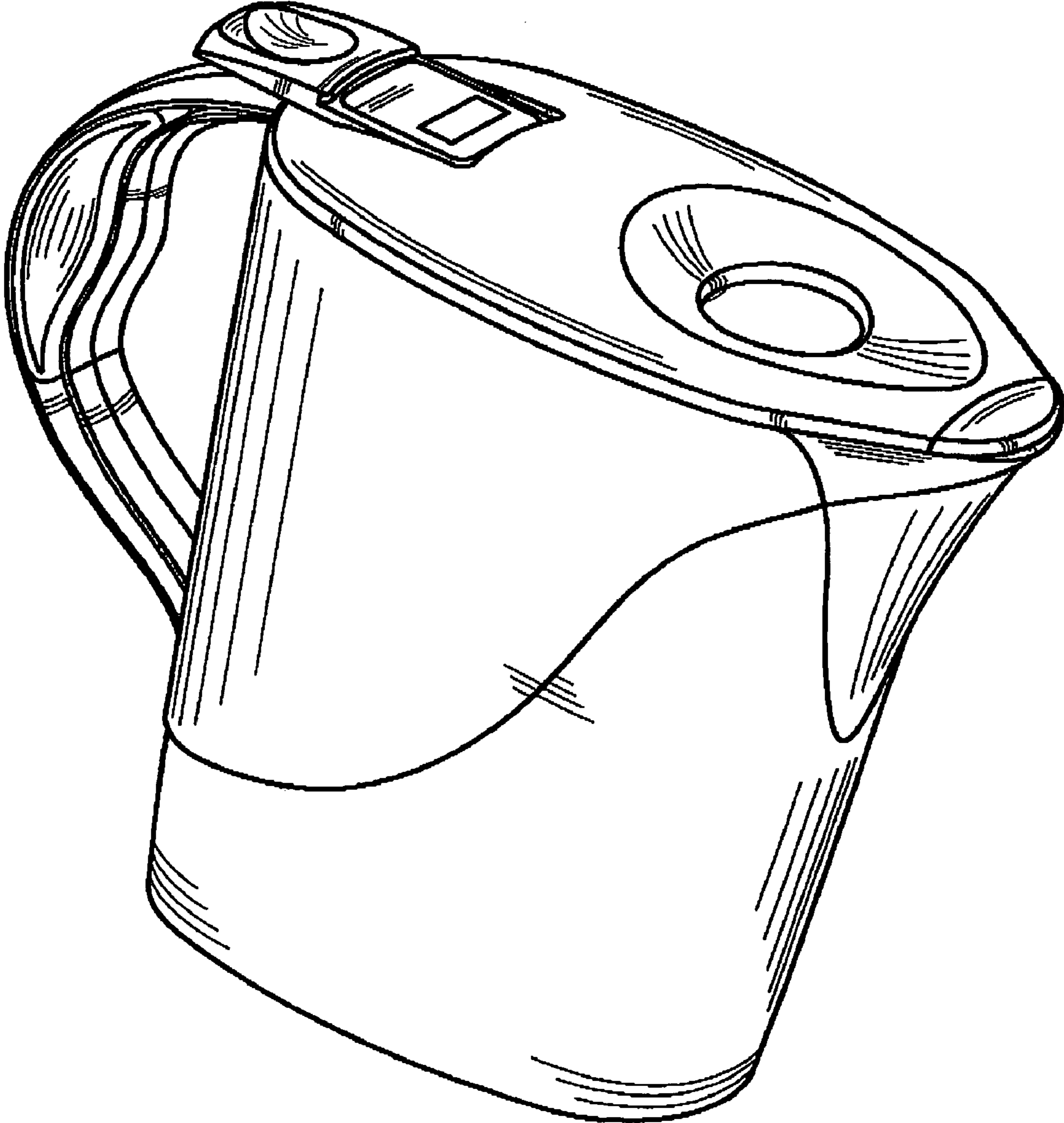

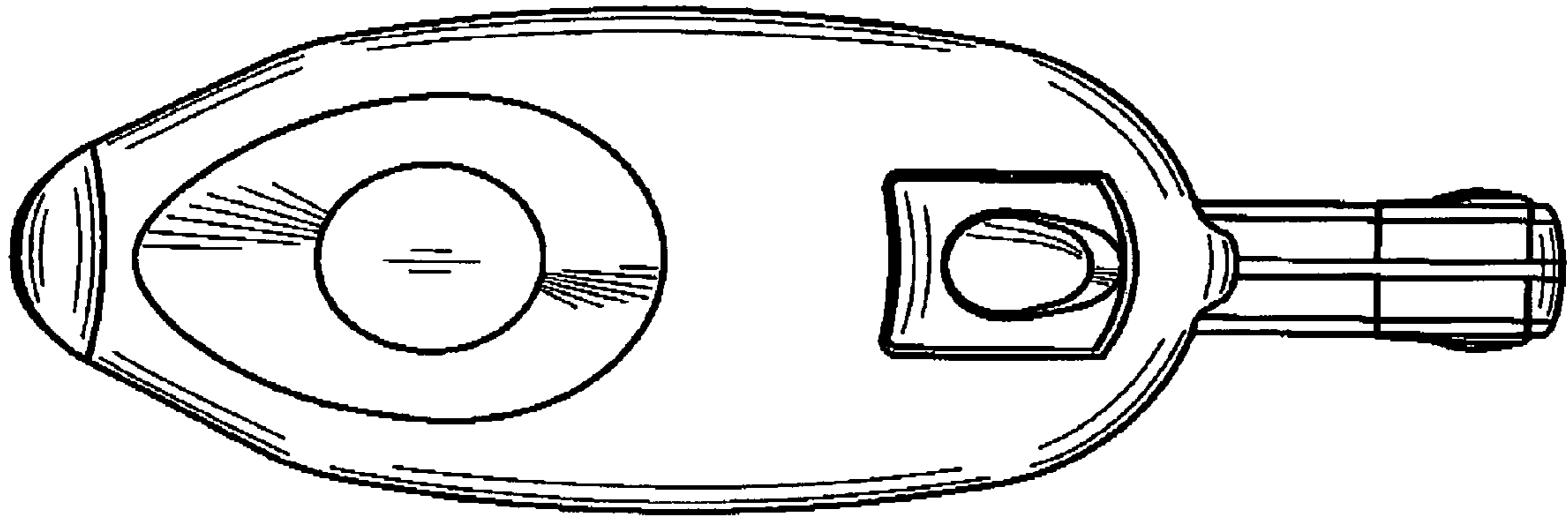

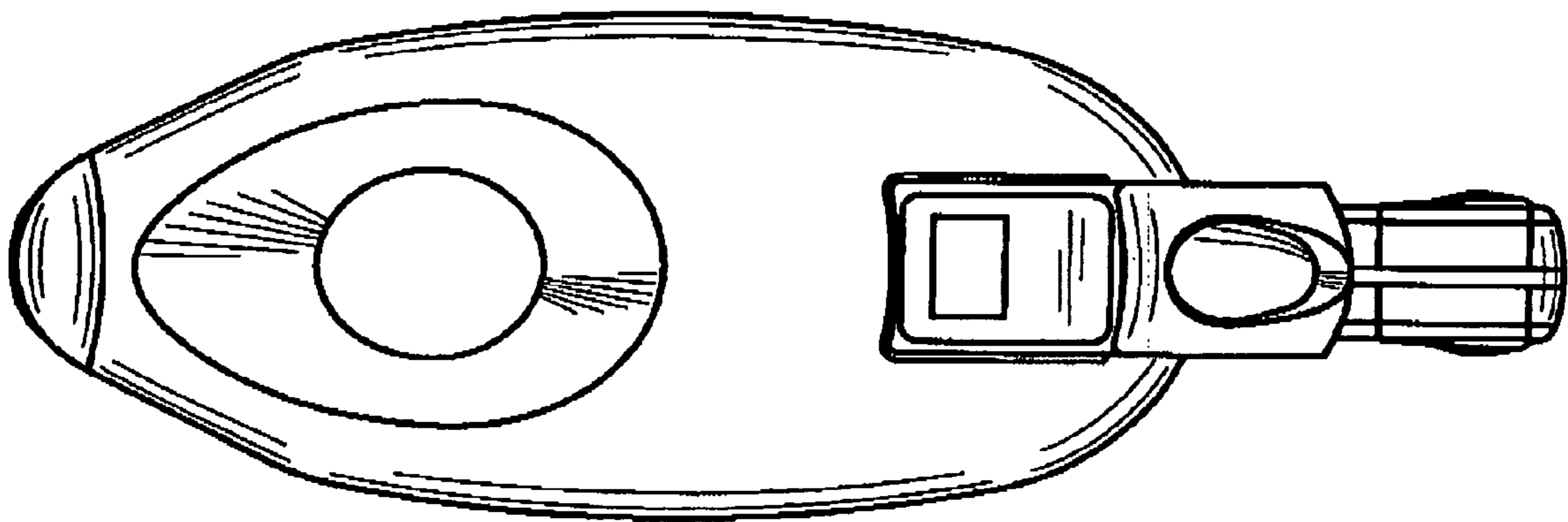

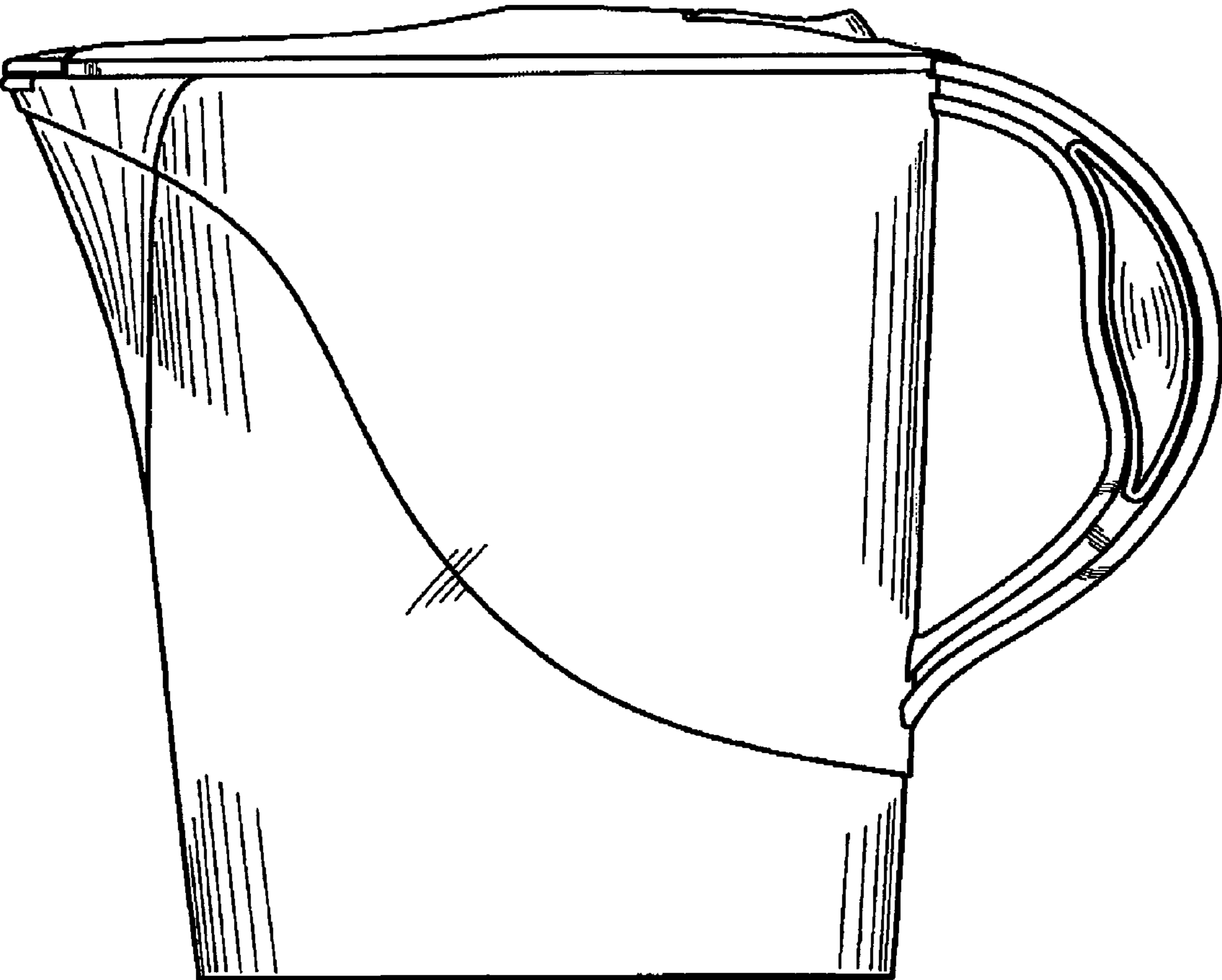

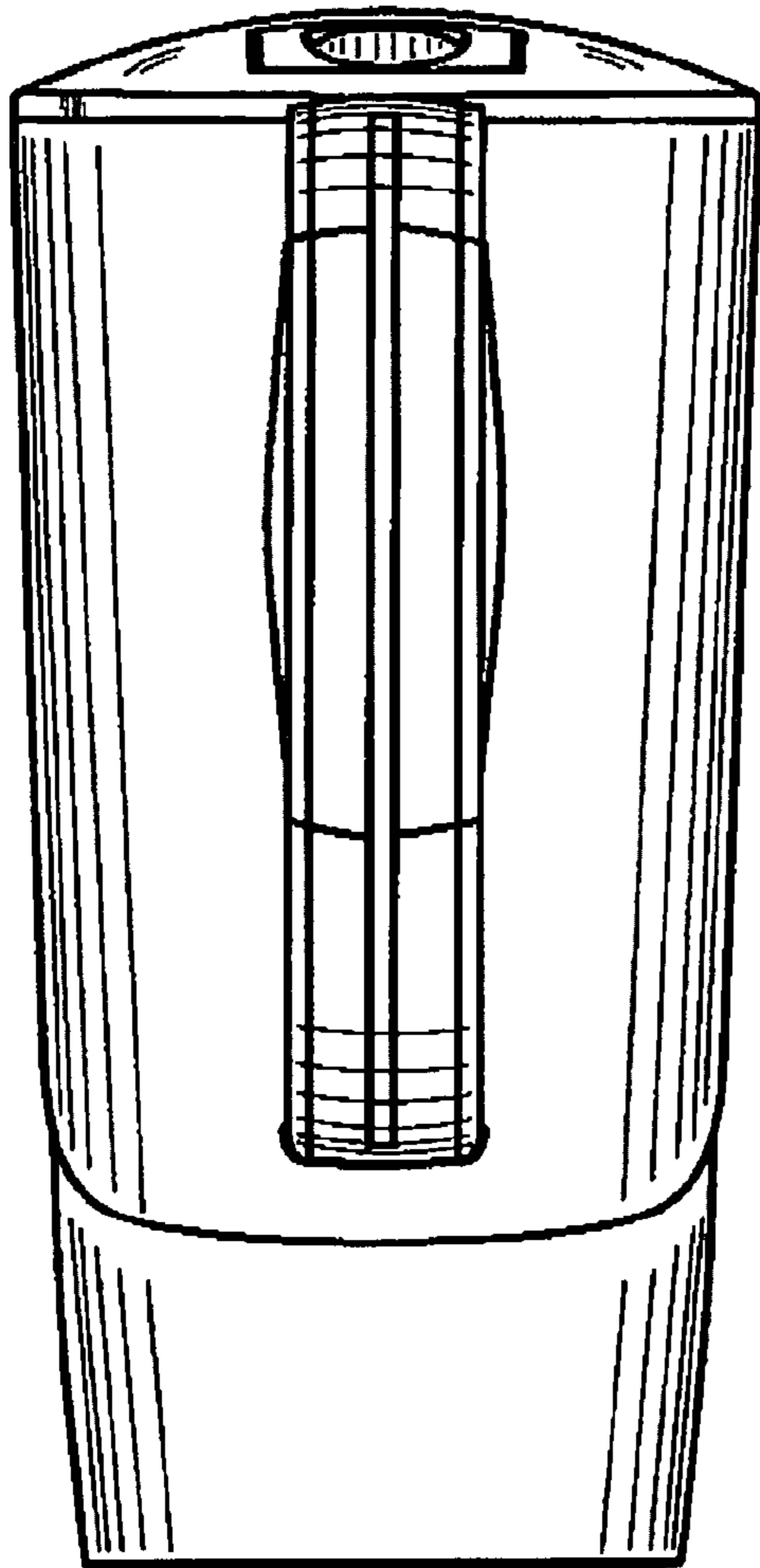

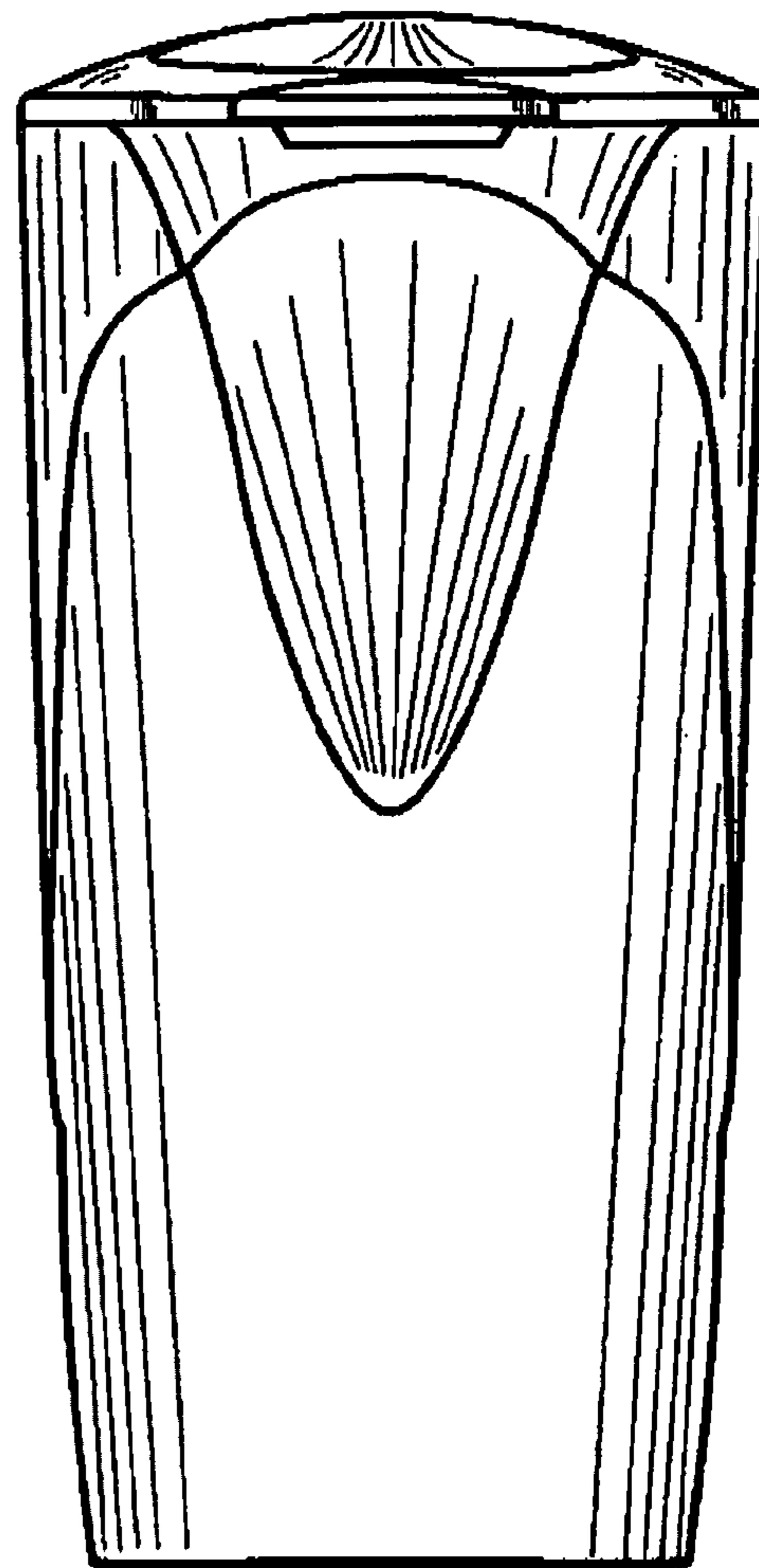

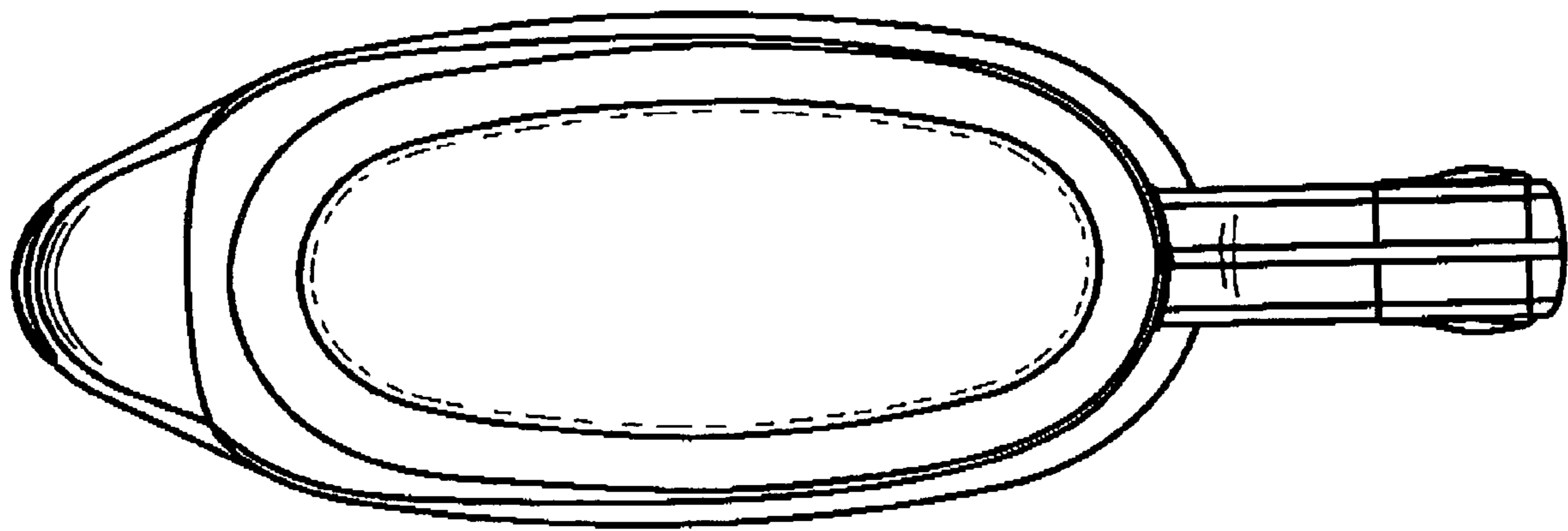
