The ornamental design for a handle for a garden tool, as shown and described.

**DESCRIPTION**

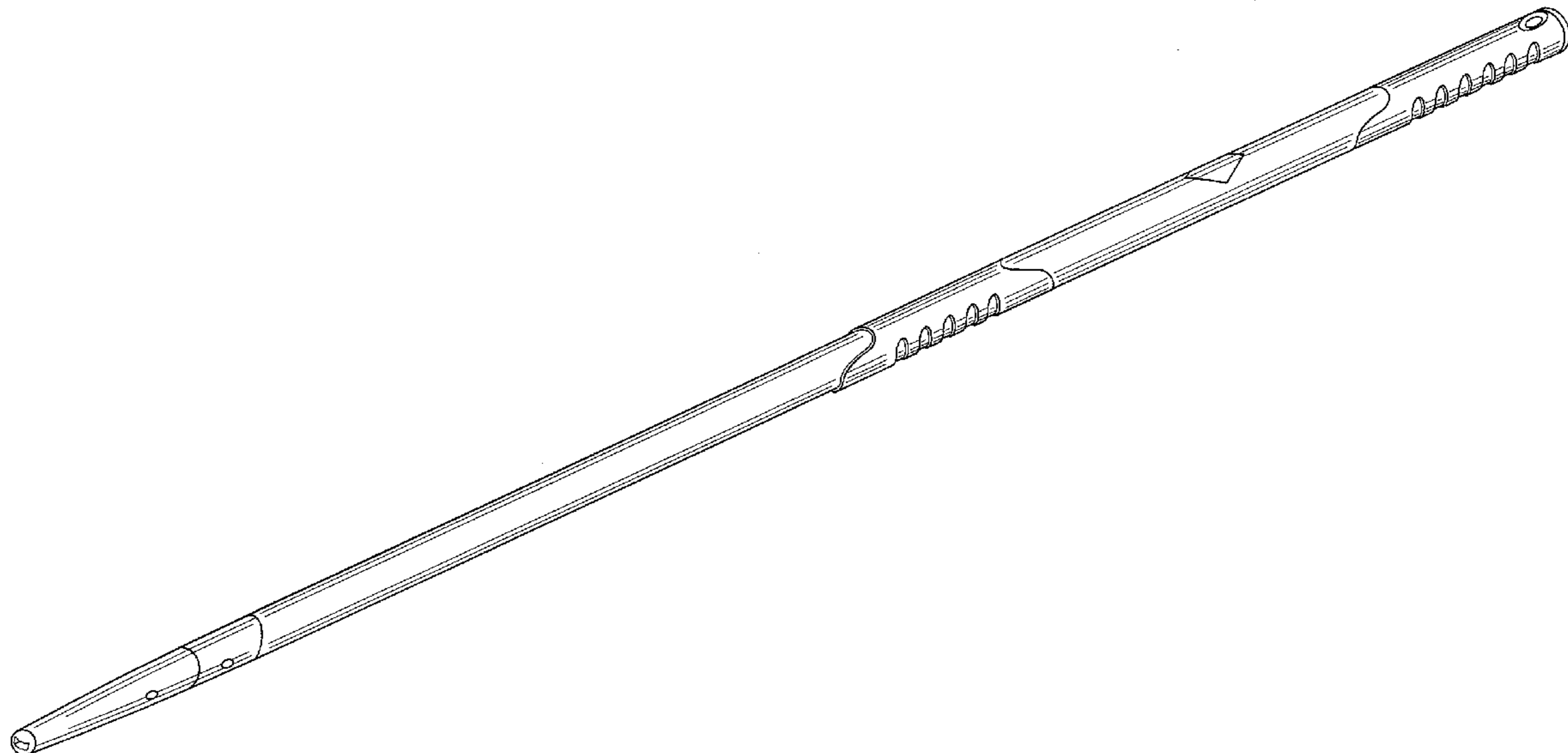

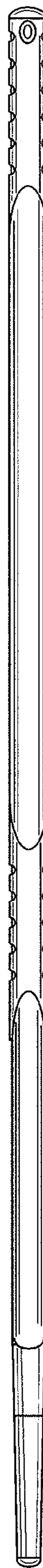

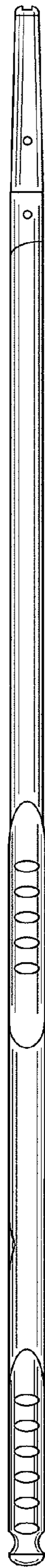
